I claim the ornamental design for a wall hung toilet, as shown and described.

FIG. 11 is a top view of the claimed design shown in FIG. 8;

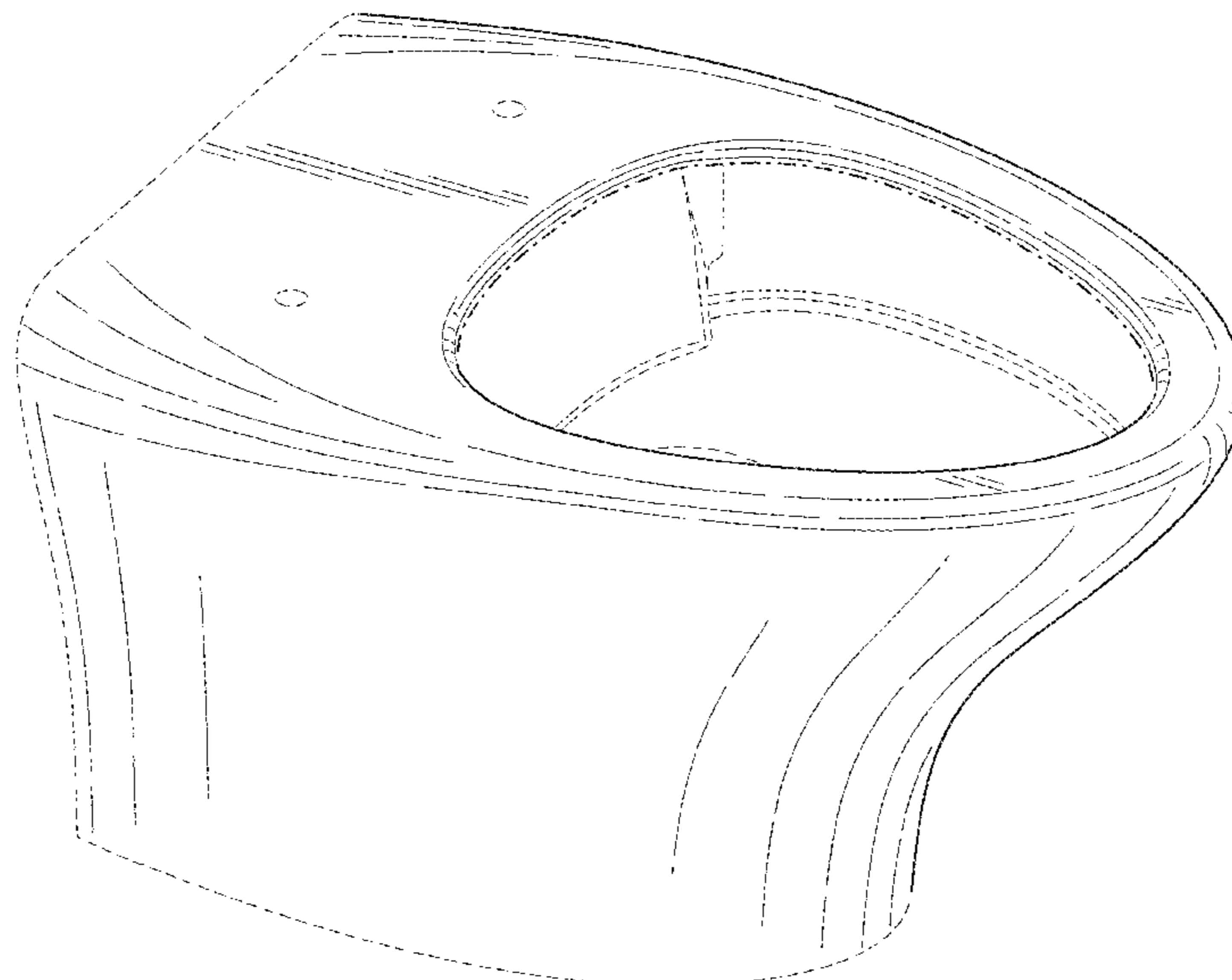
FIG. 12 is a bottom view of the claimed design shown in FIG. 8;

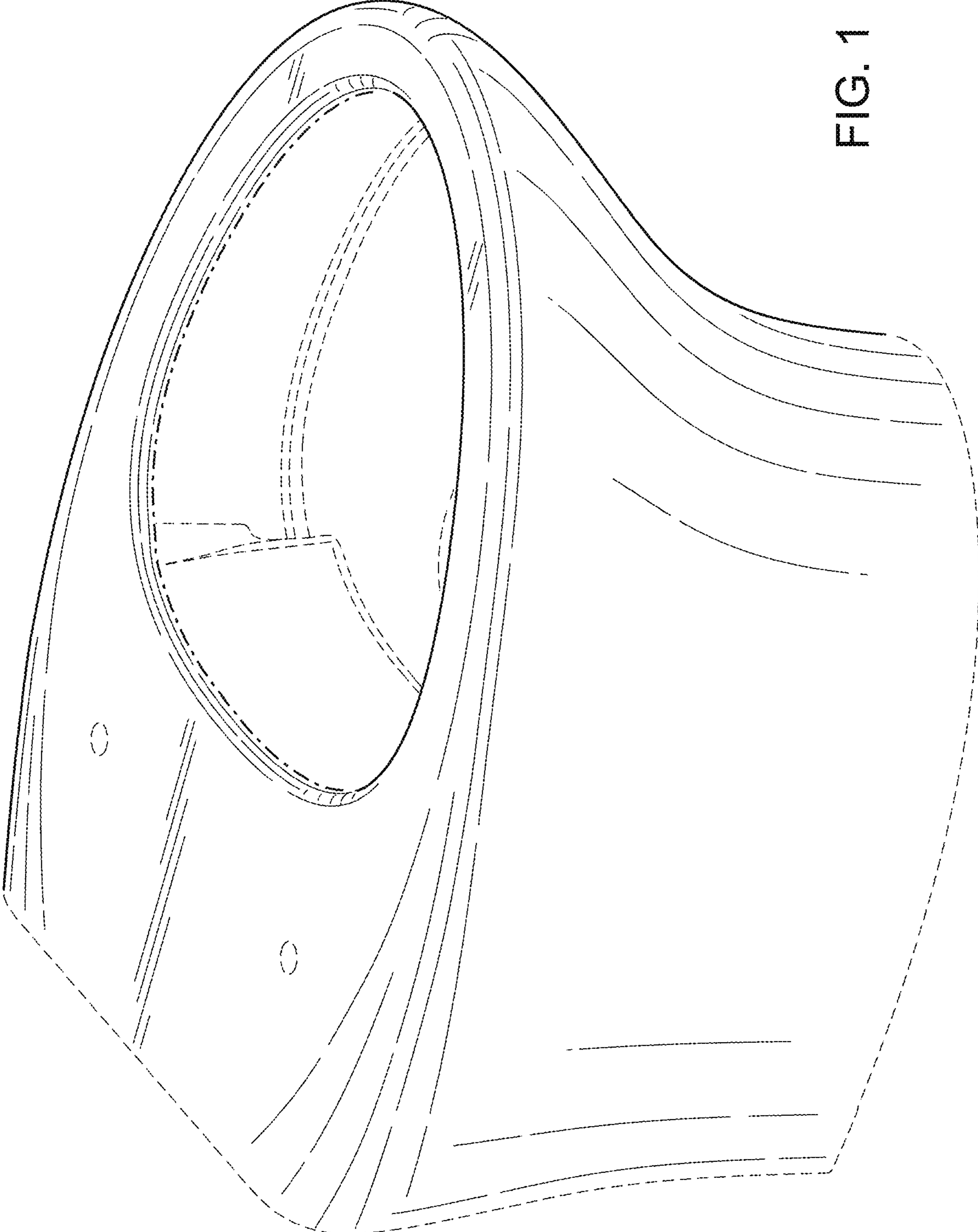

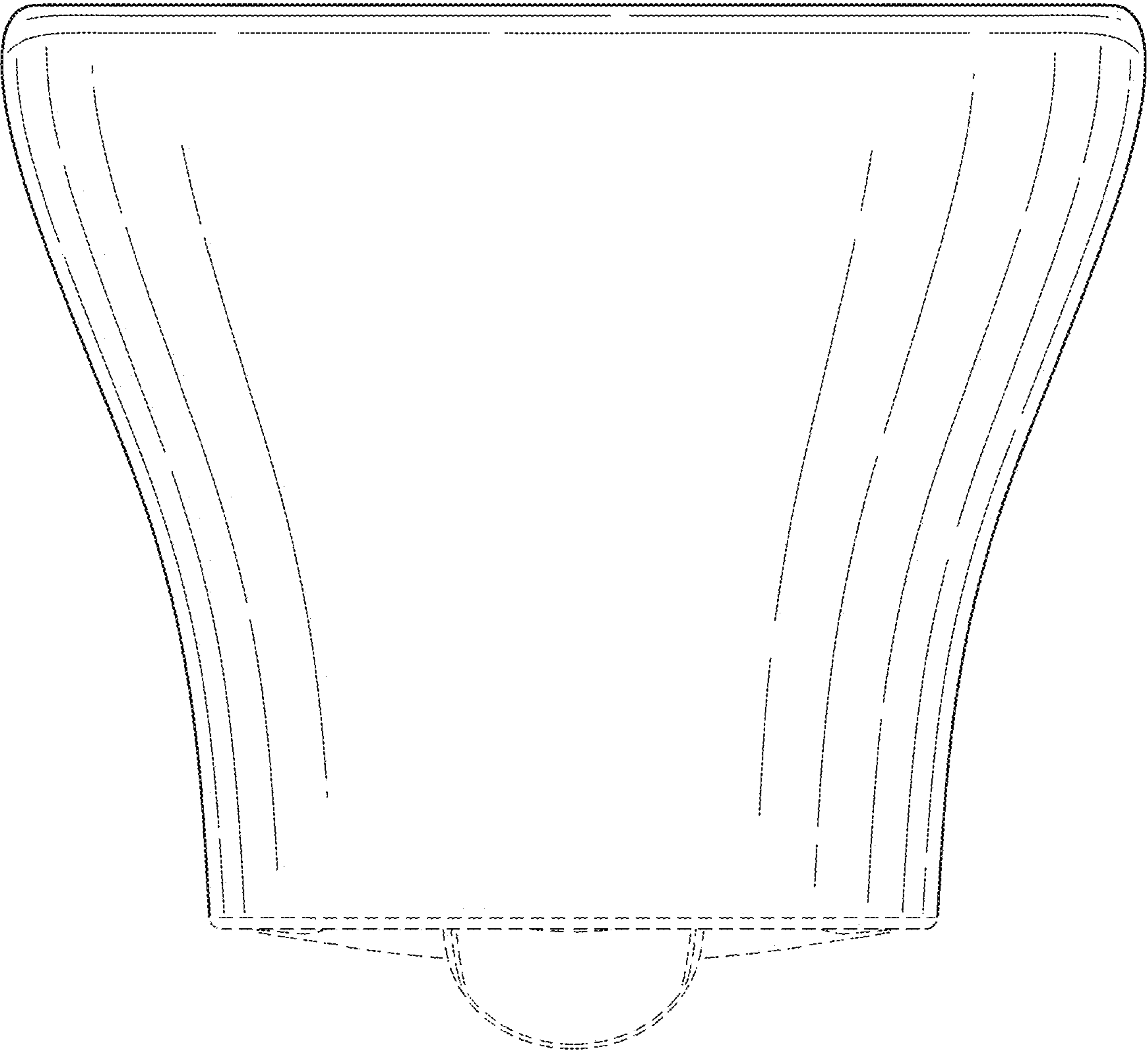

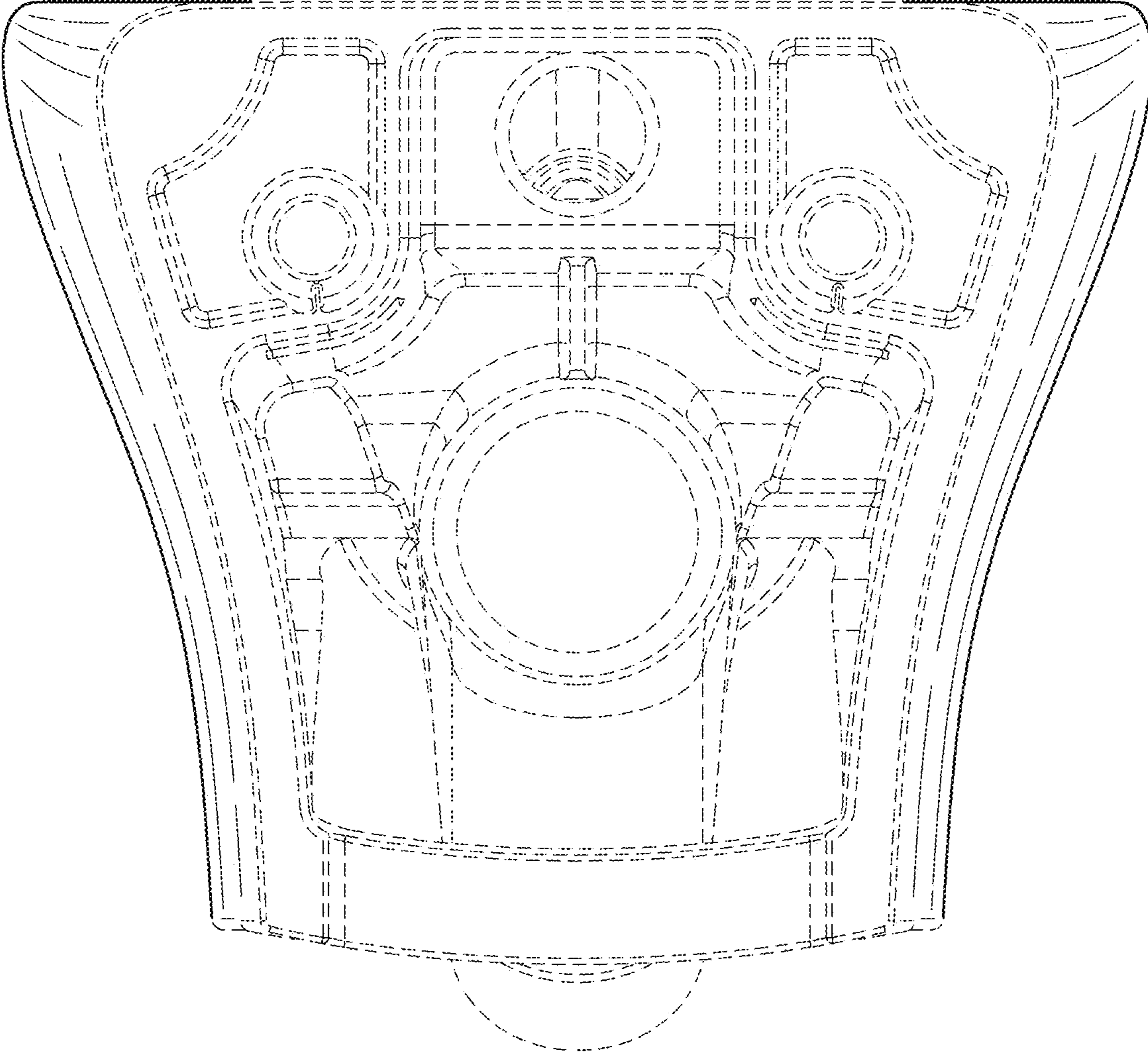

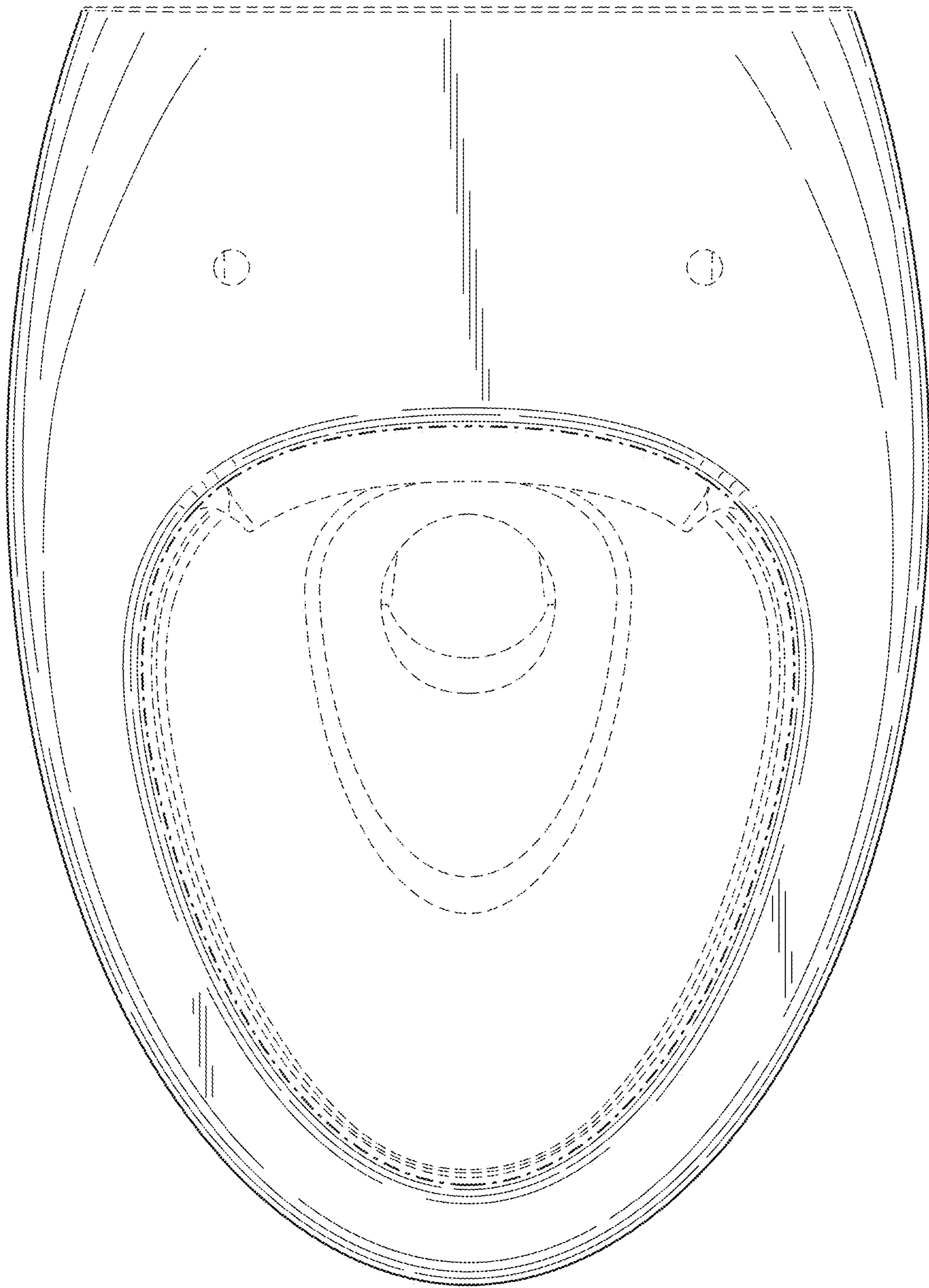

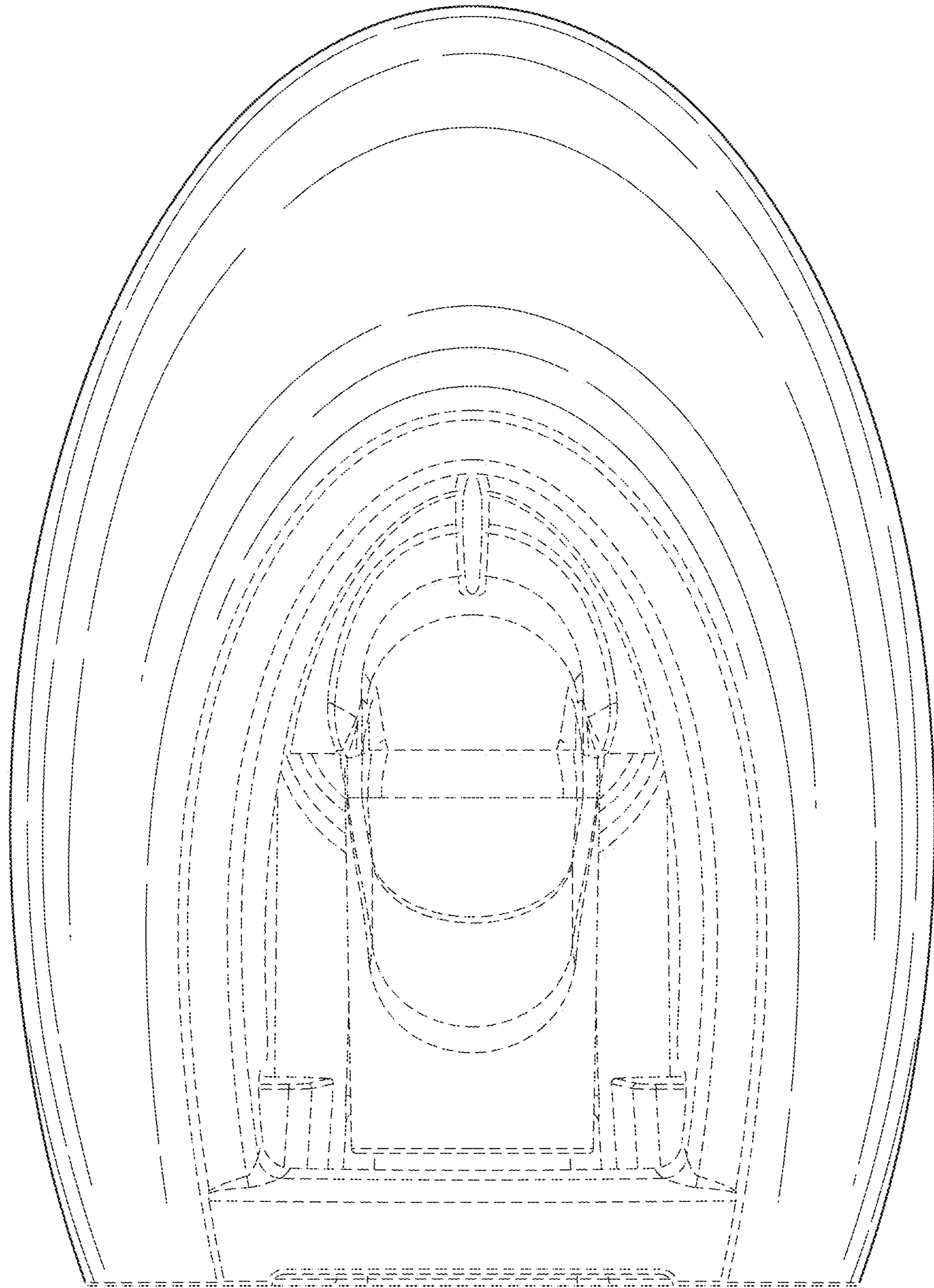

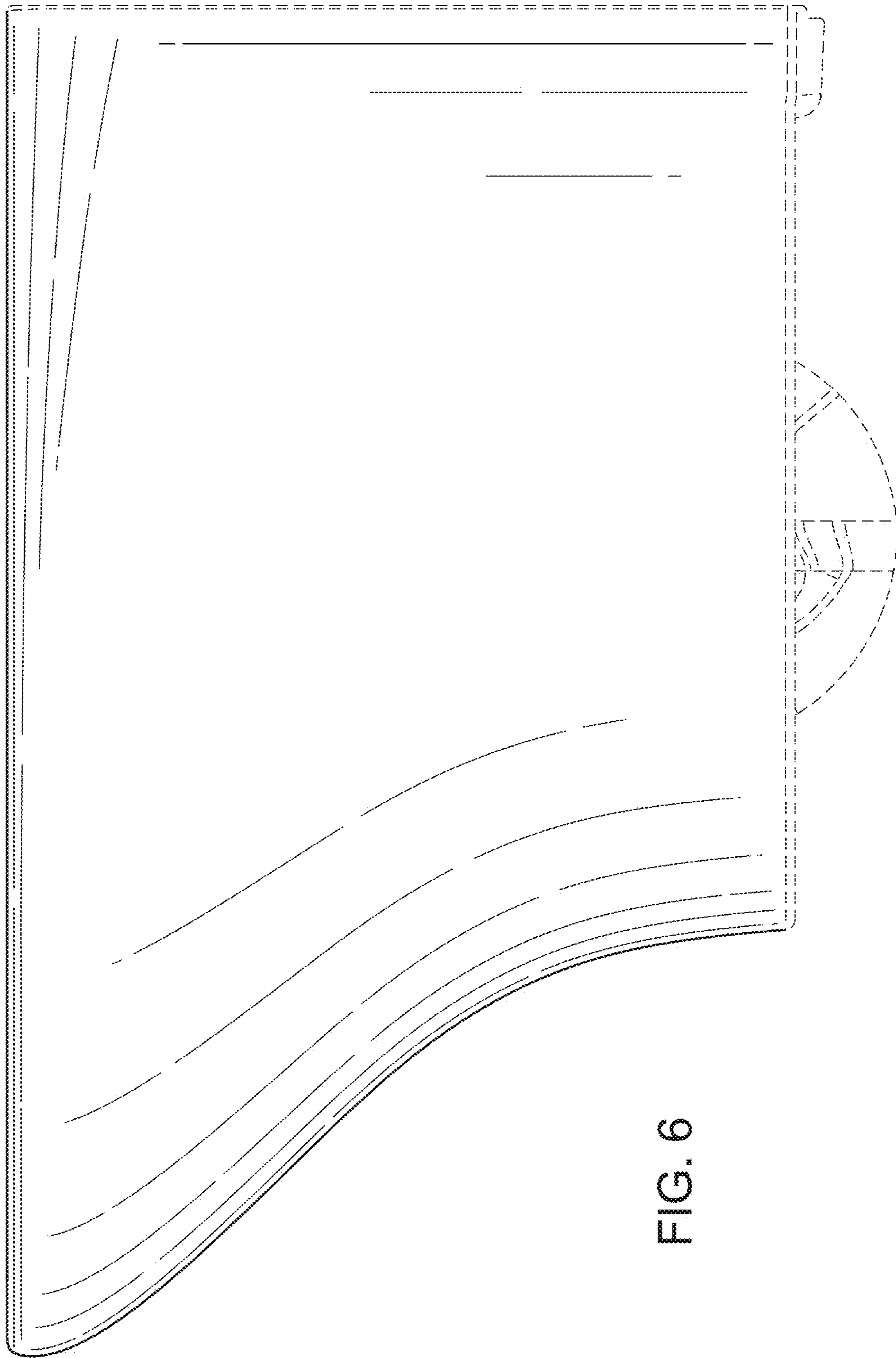

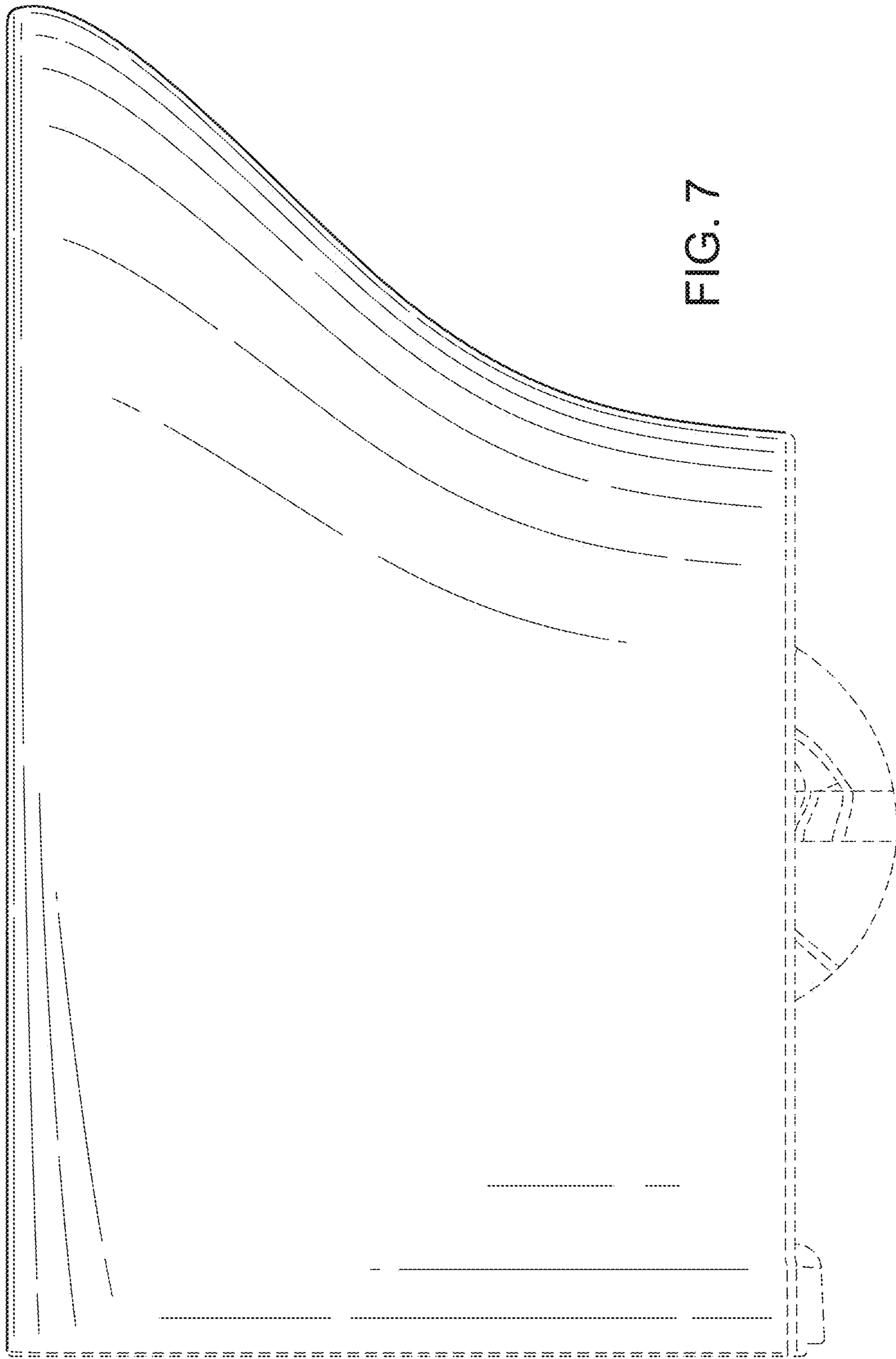

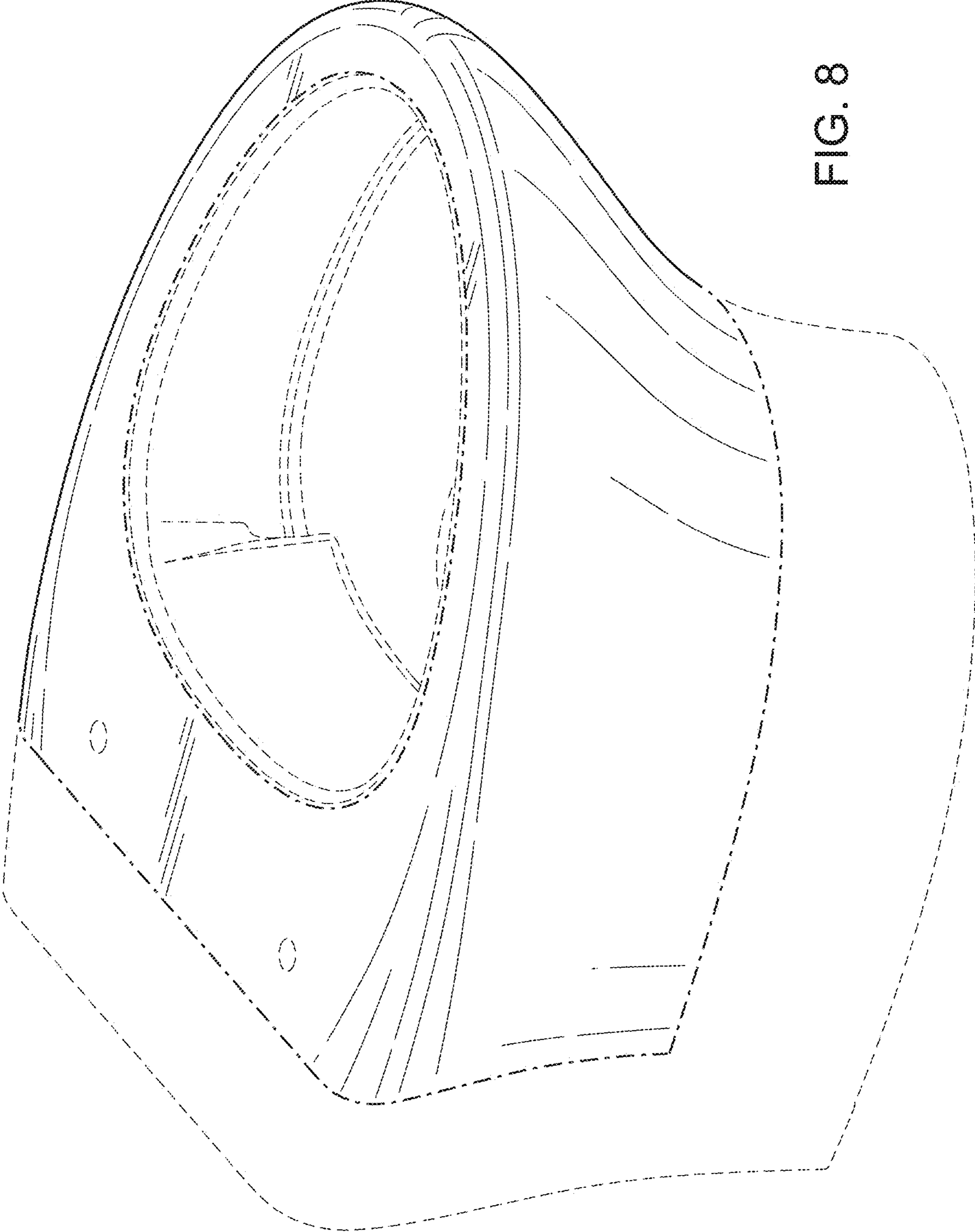

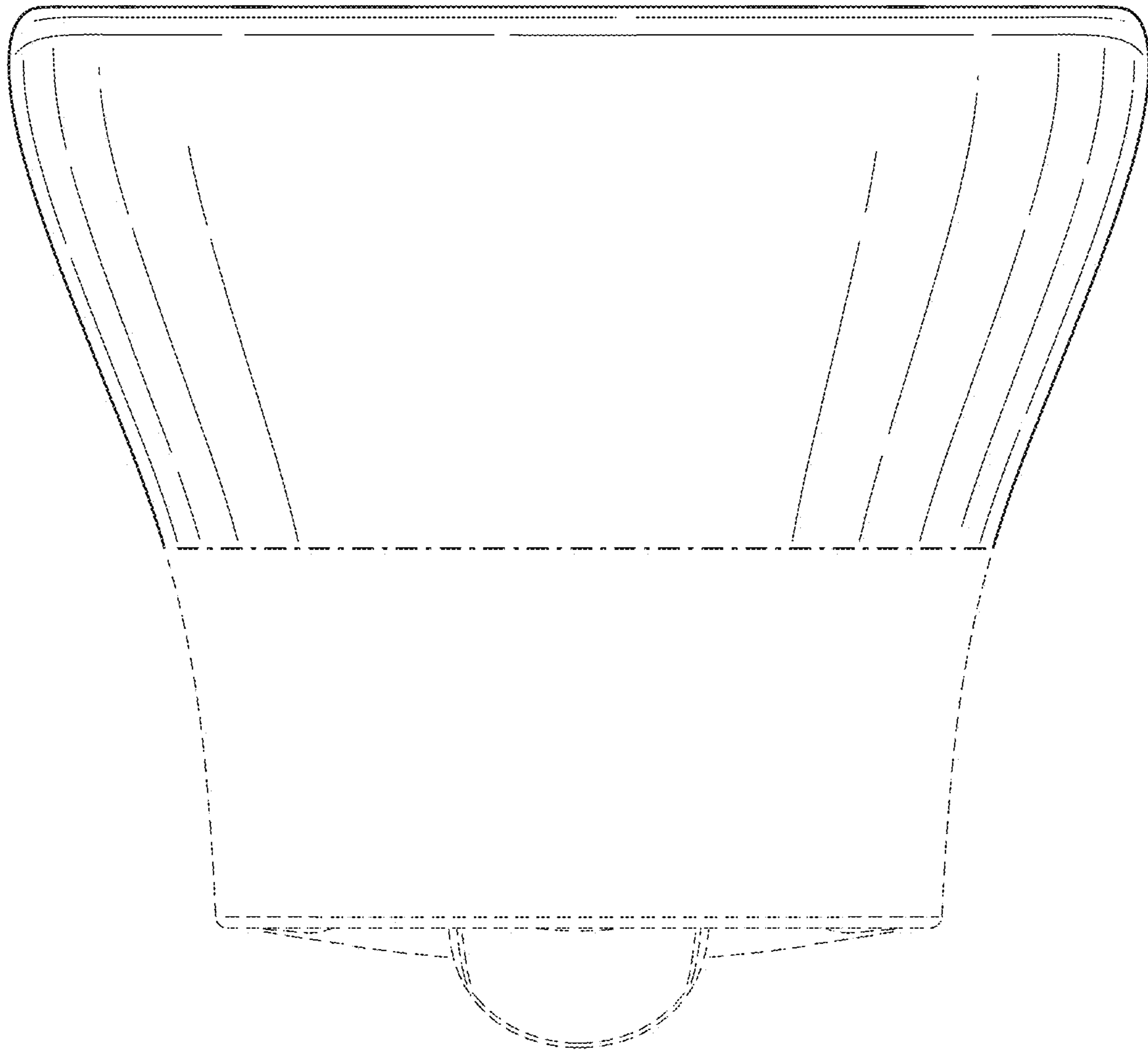

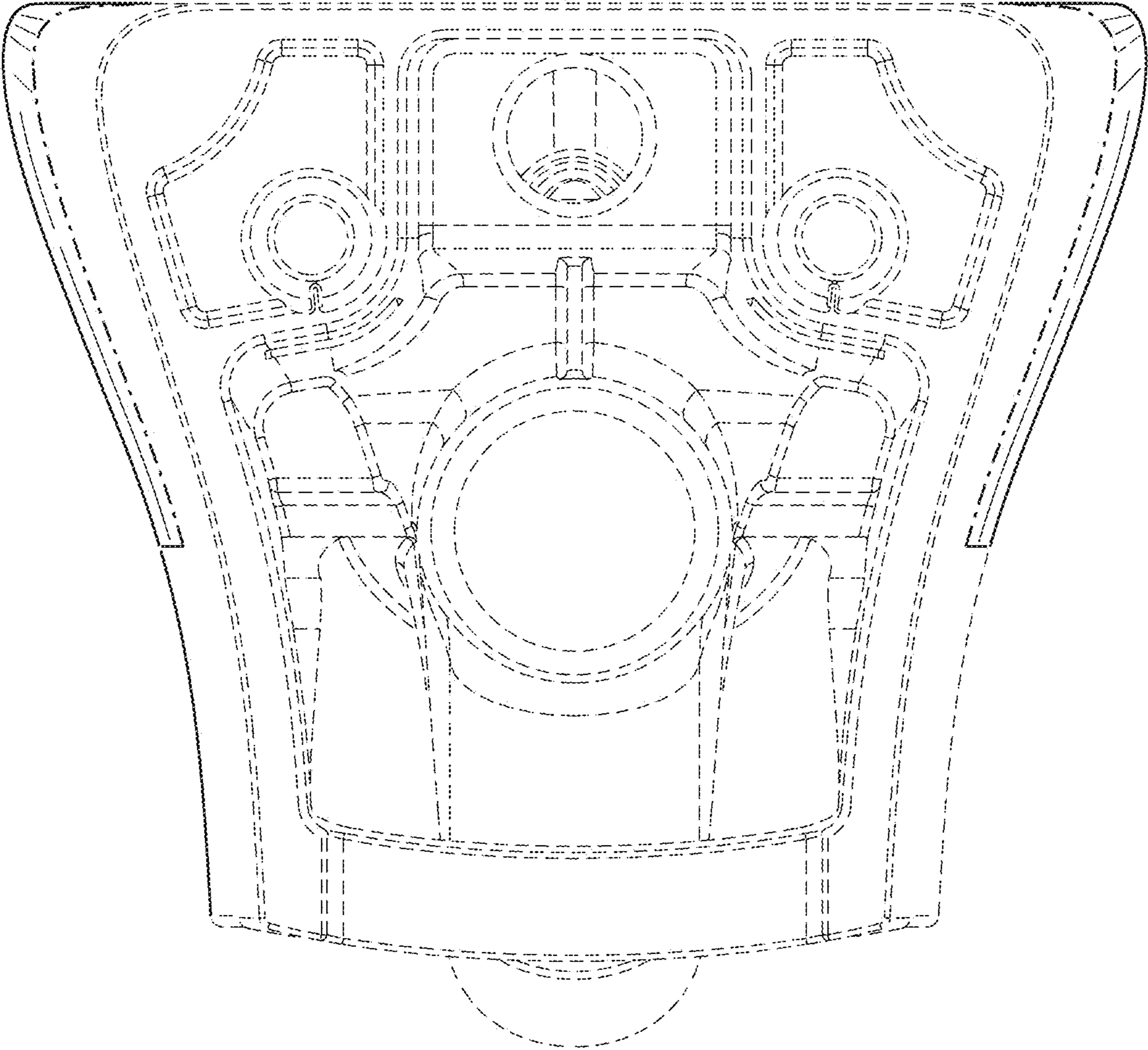

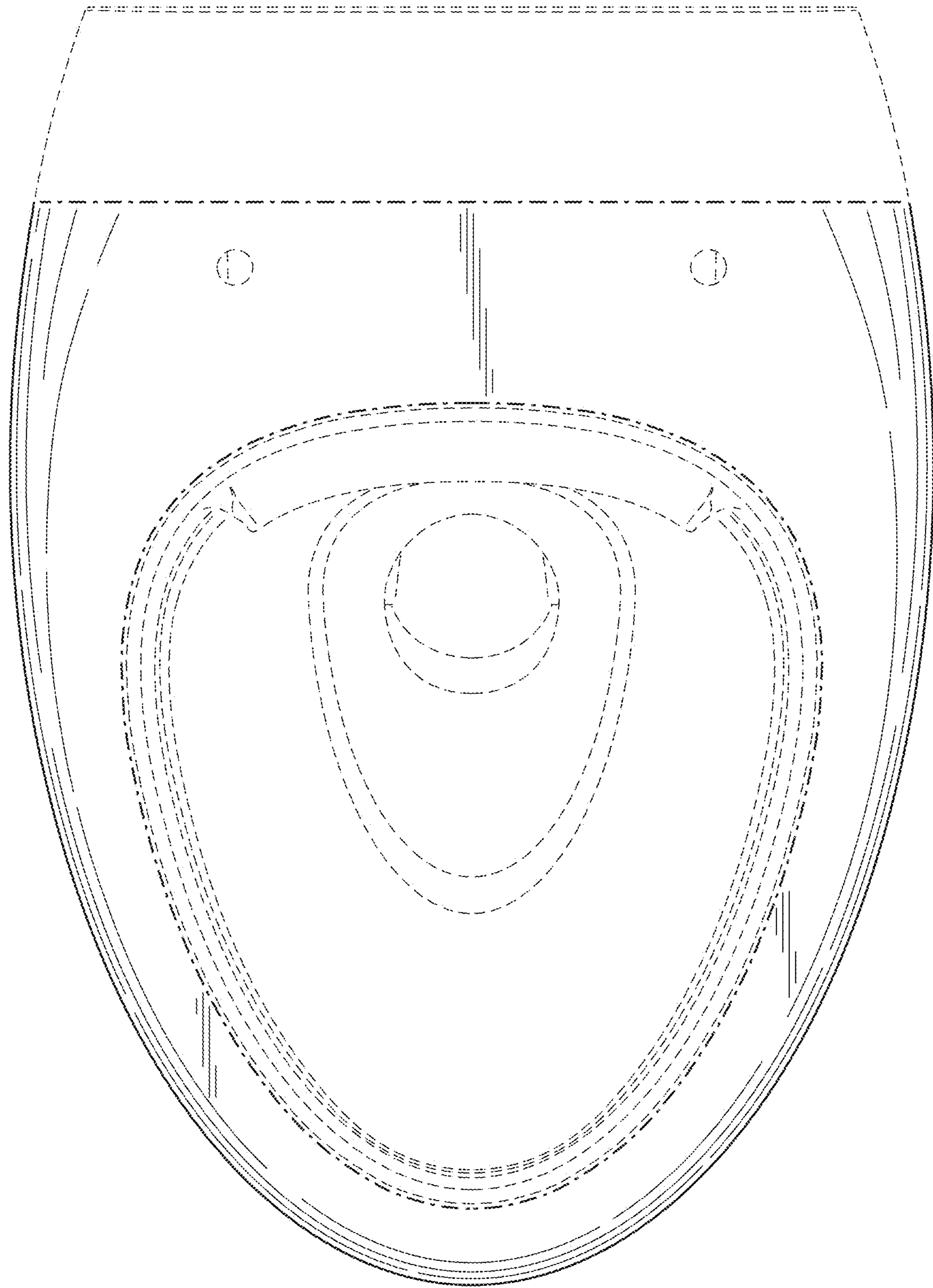

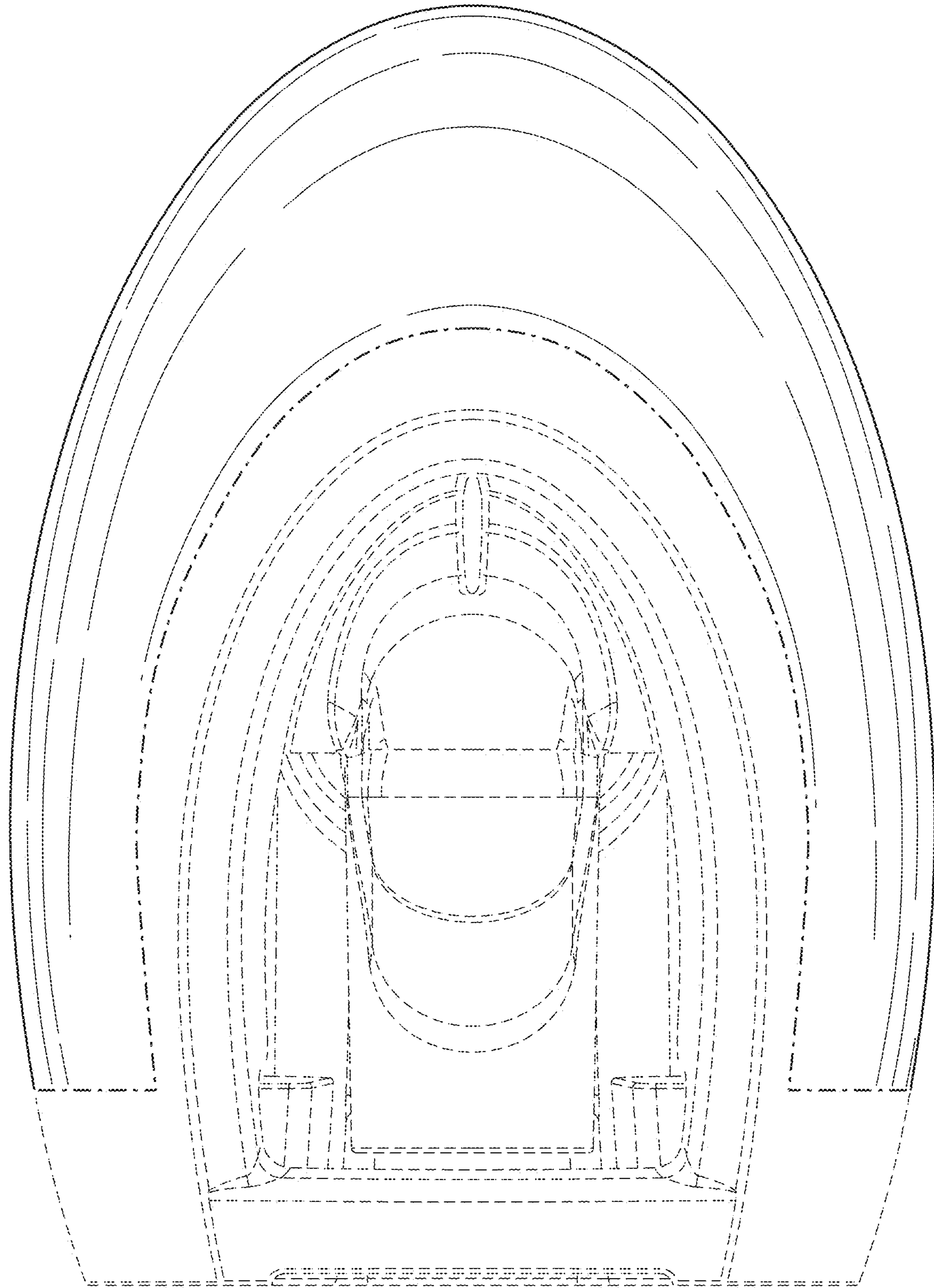

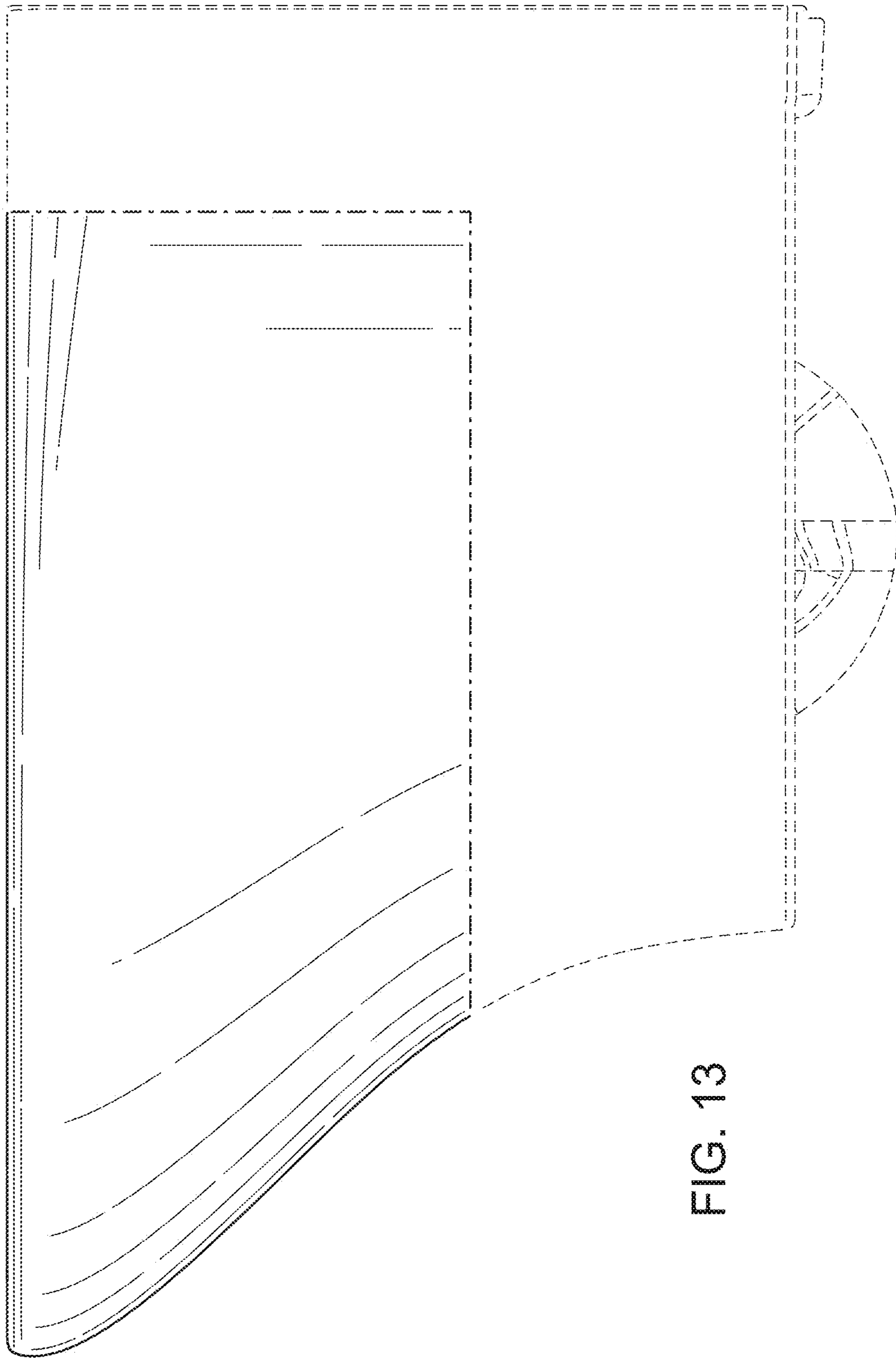

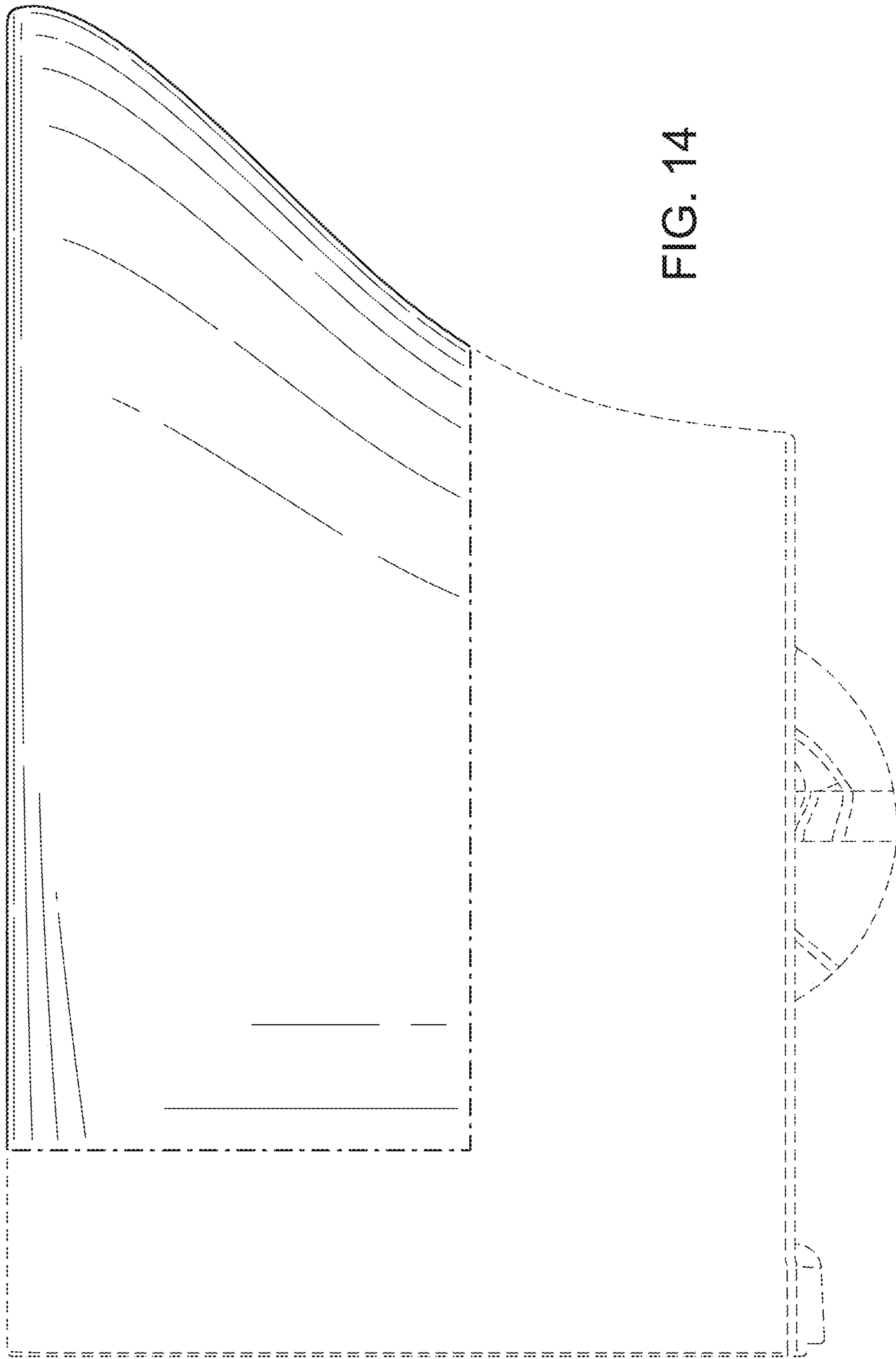
