The ornamental design for a rotation knob for a clip applier, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a rotation knob for a clip applier;

FIG. 2 is a back view of the rotation knob for the clip applier of FIG. 1;

FIG. 3 is a front view of the rotation knob for the clip applier of FIG. 1;

FIG. 4 is a right side view of the rotation knob for the clip applier of FIG. 1;

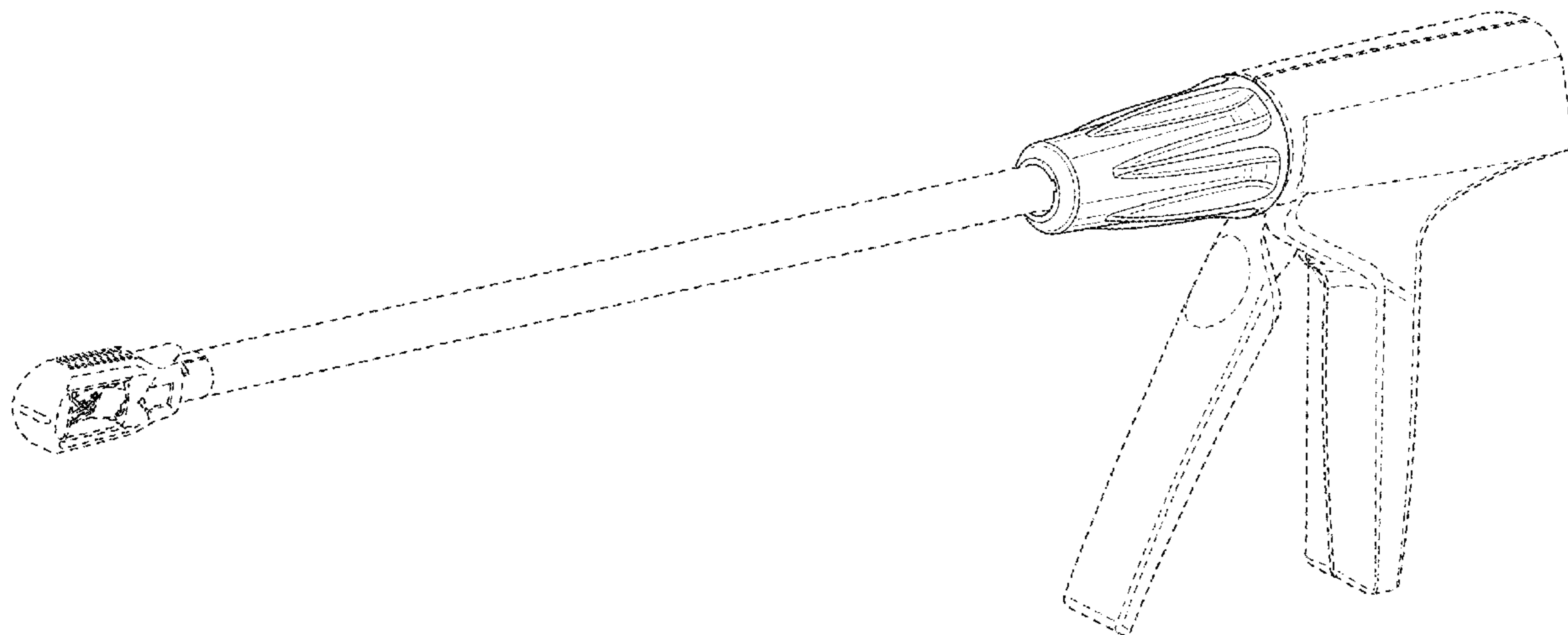
FIG. 5 is a left side view of the rotation knob for the clip applier of FIG. 1;

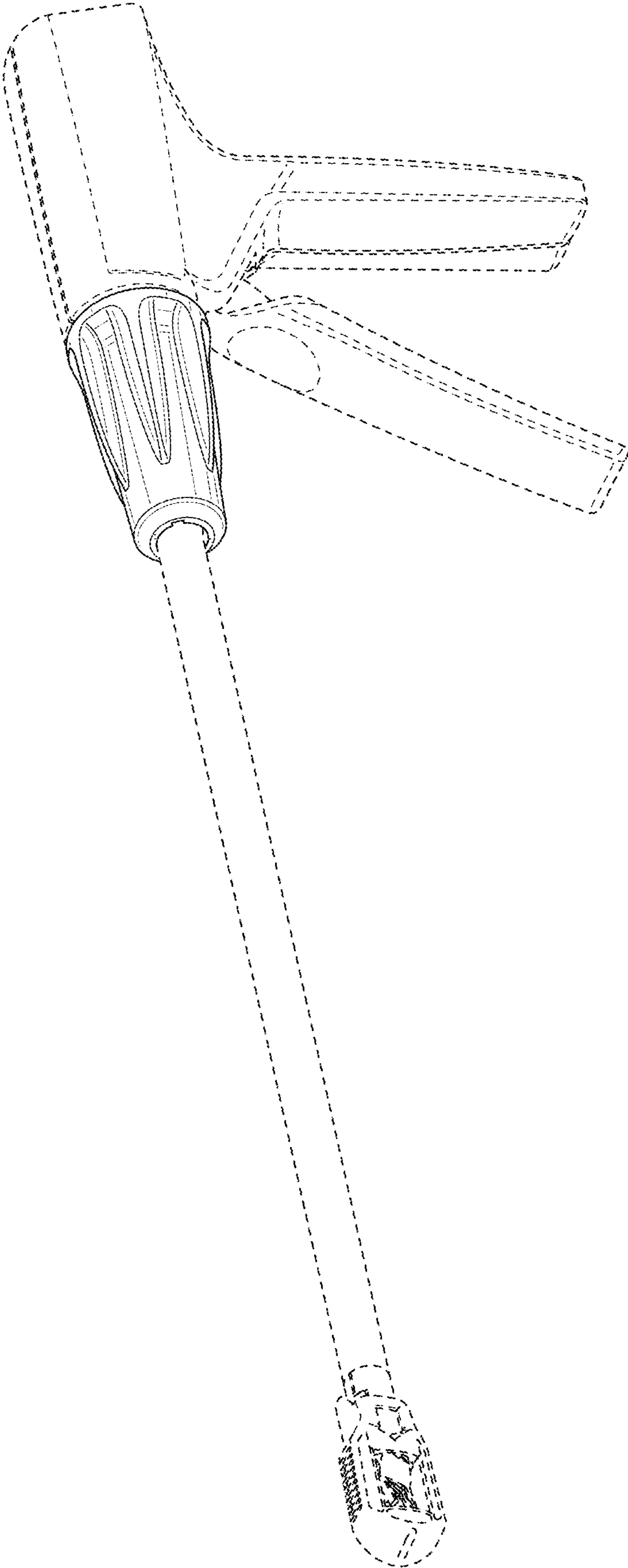

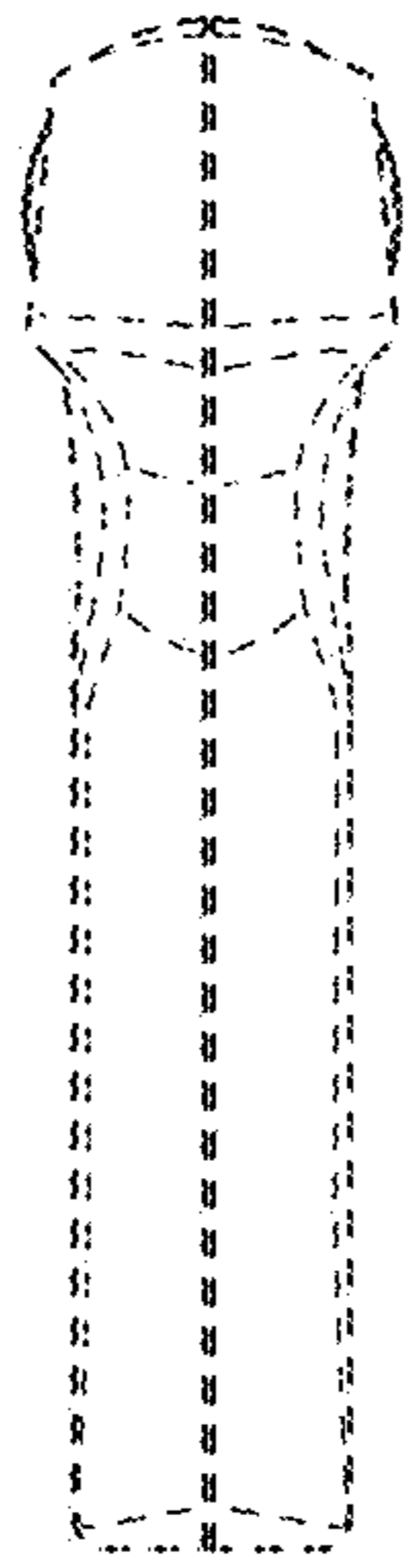

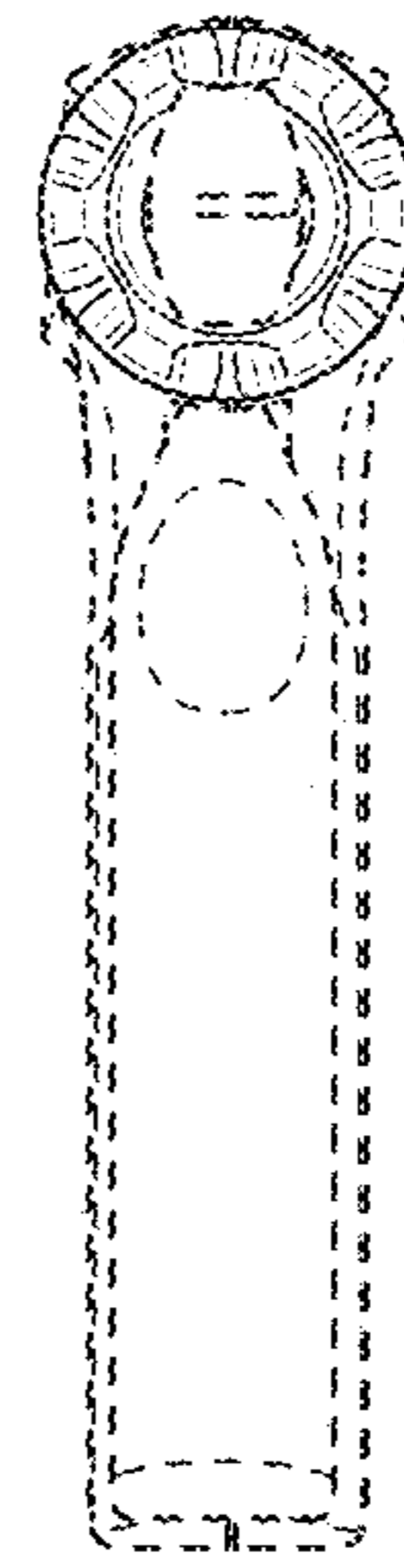

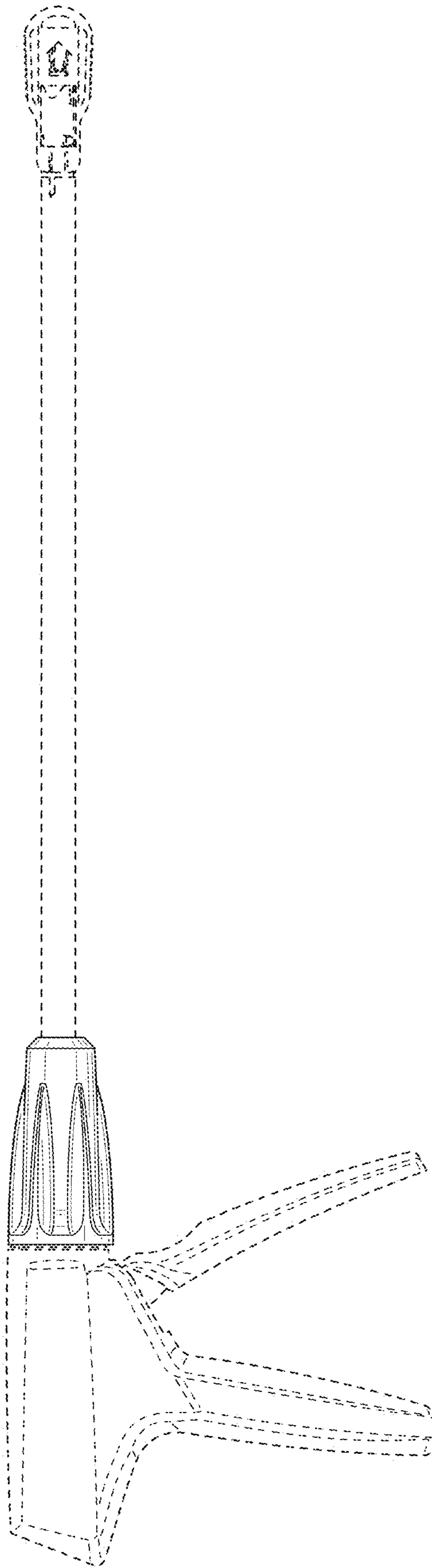

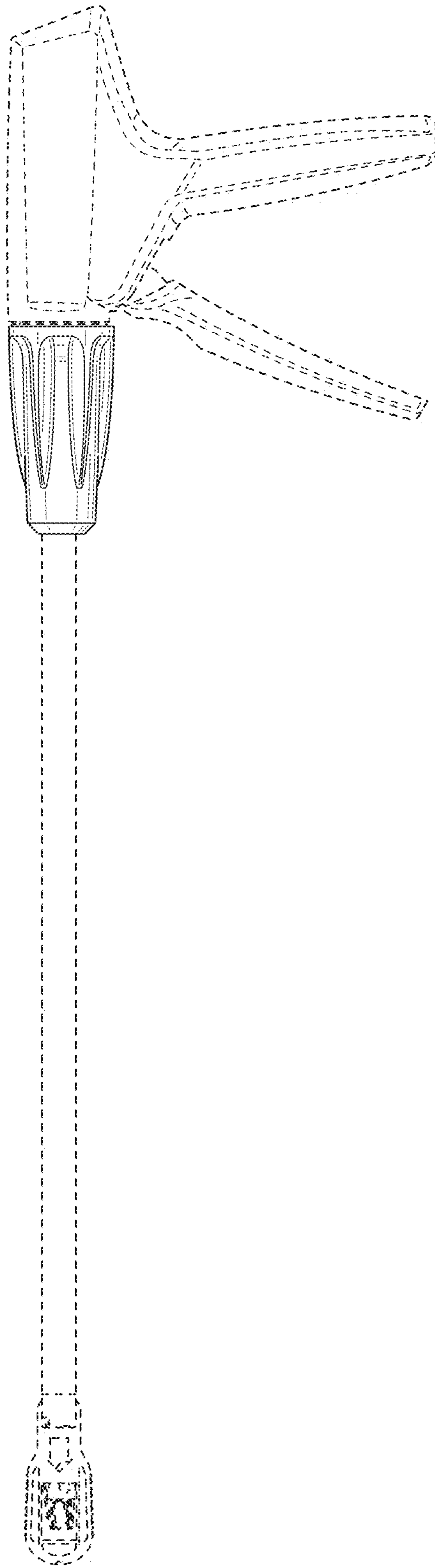

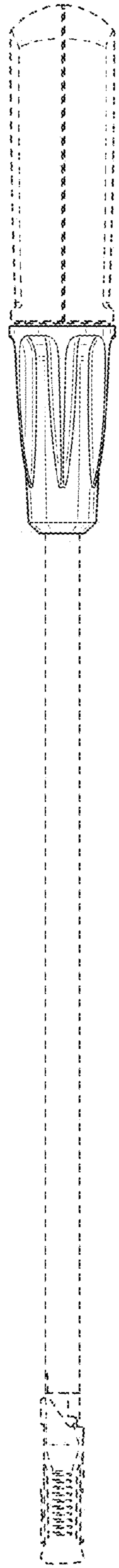

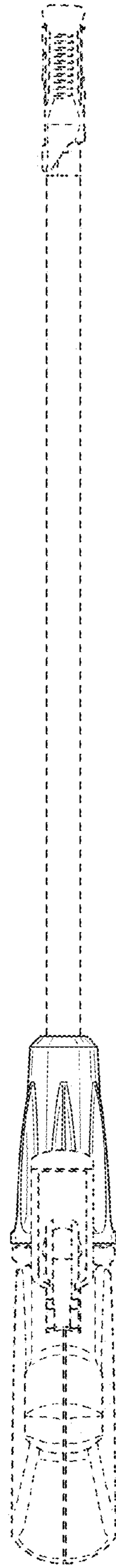
