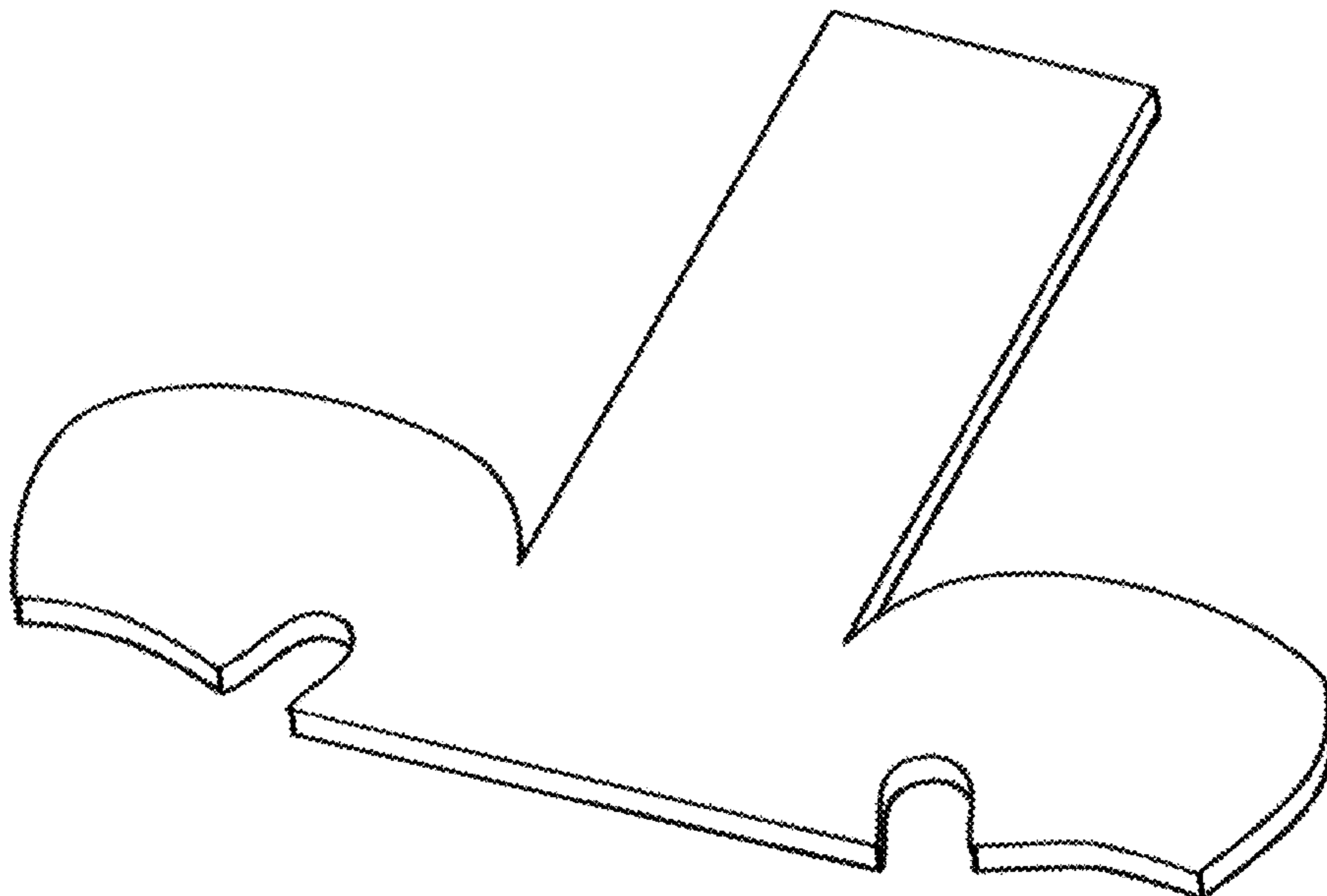
(57) **CLAIM**

The ornamental design for a head wrap, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the head wrap showing my new design; the bottom view is a mirror image;
 FIG. 2 is a front view of the head wrap;
 FIG. 3 is a rear view of the head wrap;
 FIG. 4 is a left side view of the head wrap; the right side view is a mirror image; and,
 FIG. 5 is a view illustrating an isometric view thereof.
 The broken lines that are shown in FIG. 1 illustrate fastening devices that form no part of the claimed design.

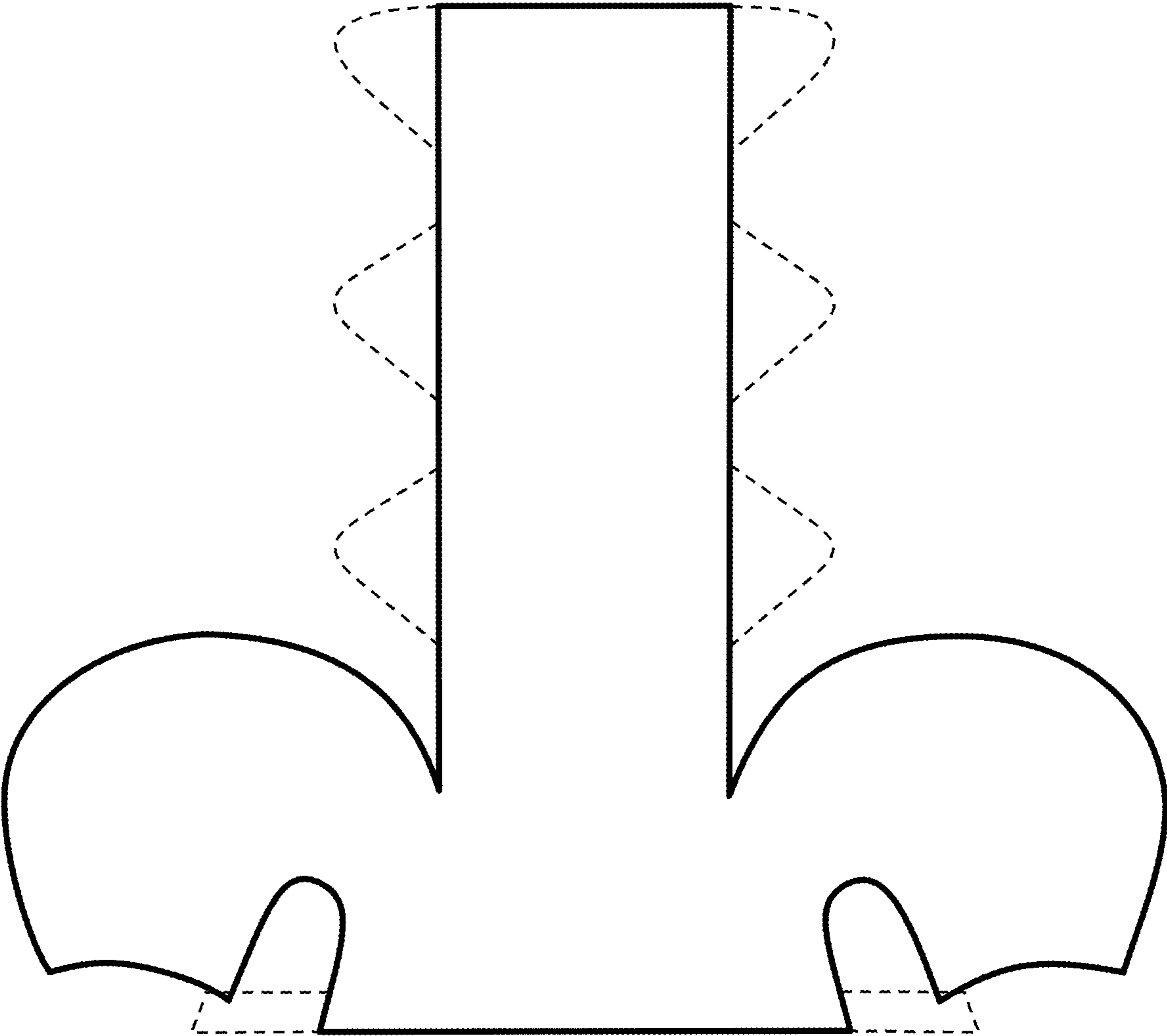

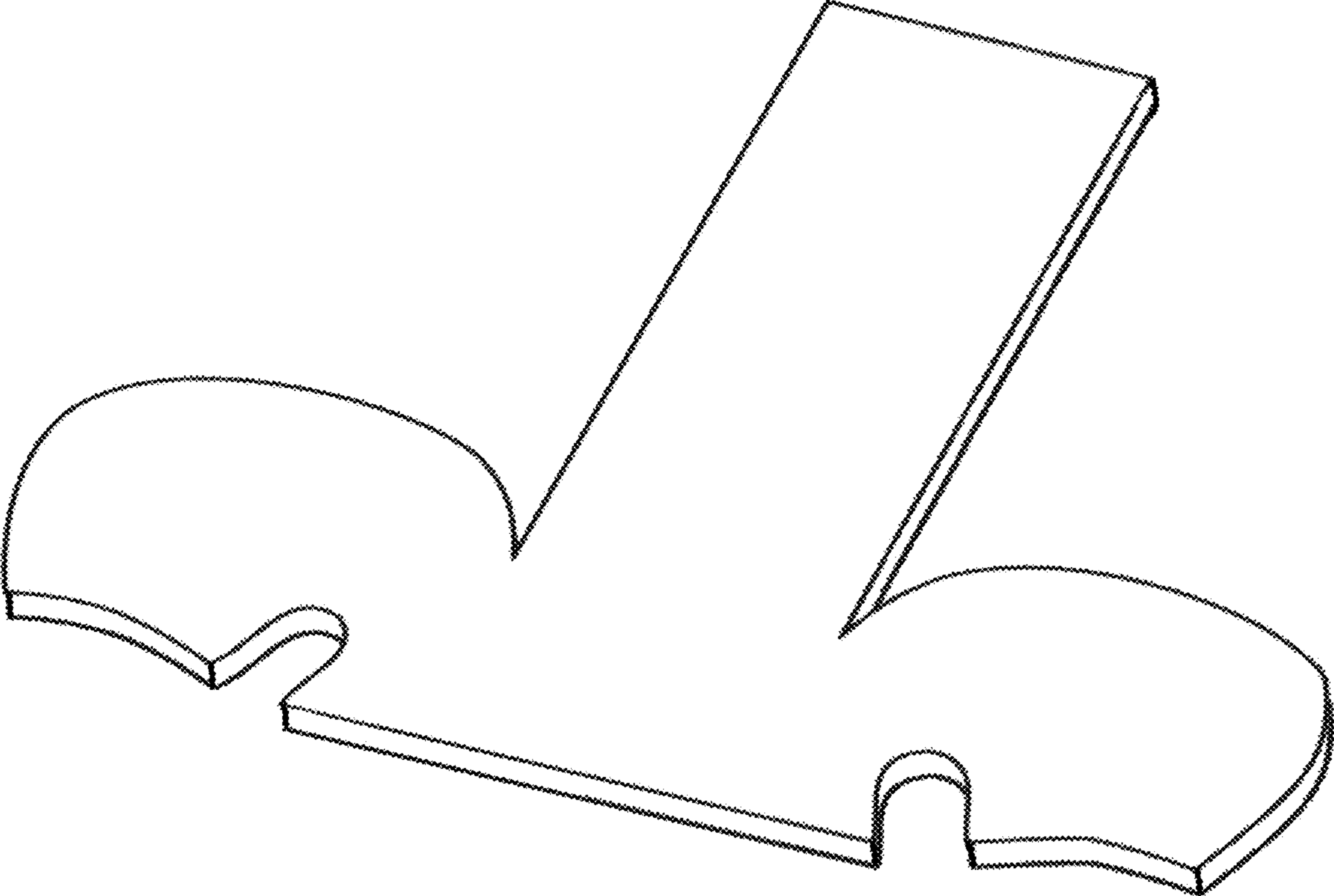
