Figure 1.3 is a back view thereof;

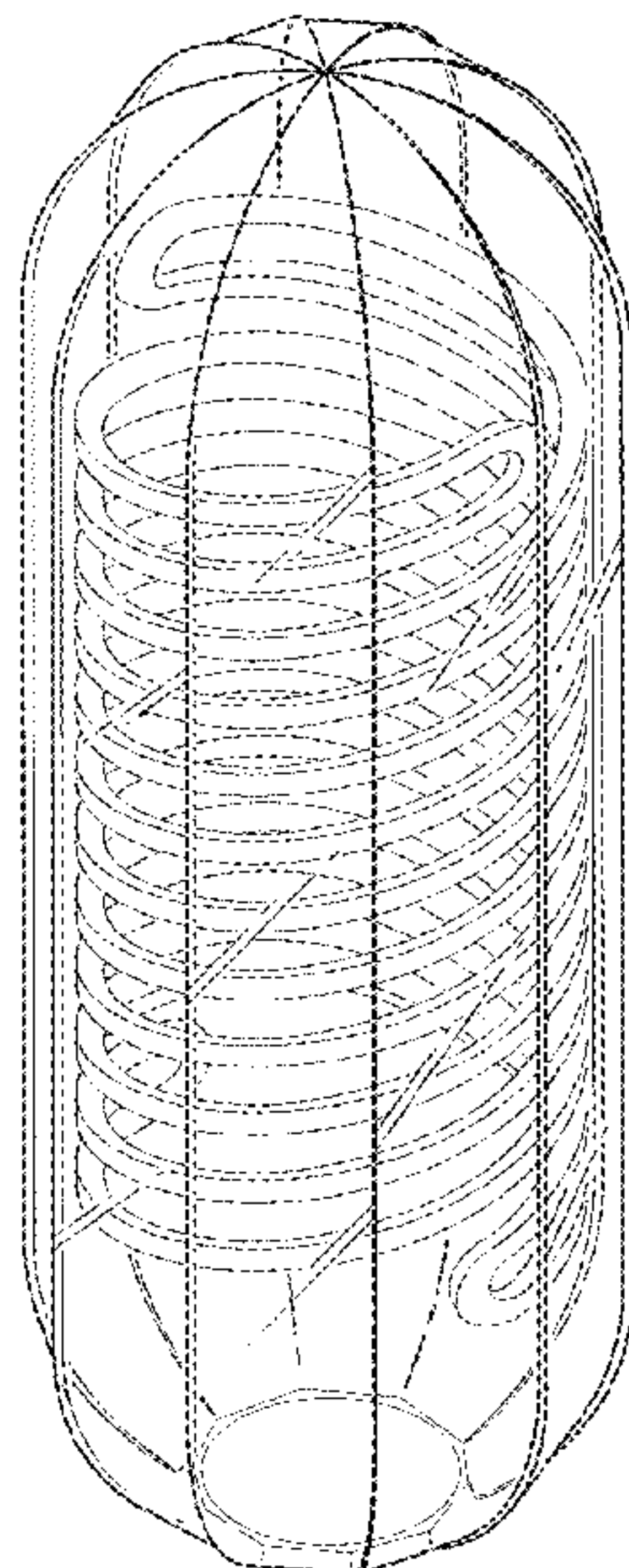
Figure 1.4 is a left side view thereof;

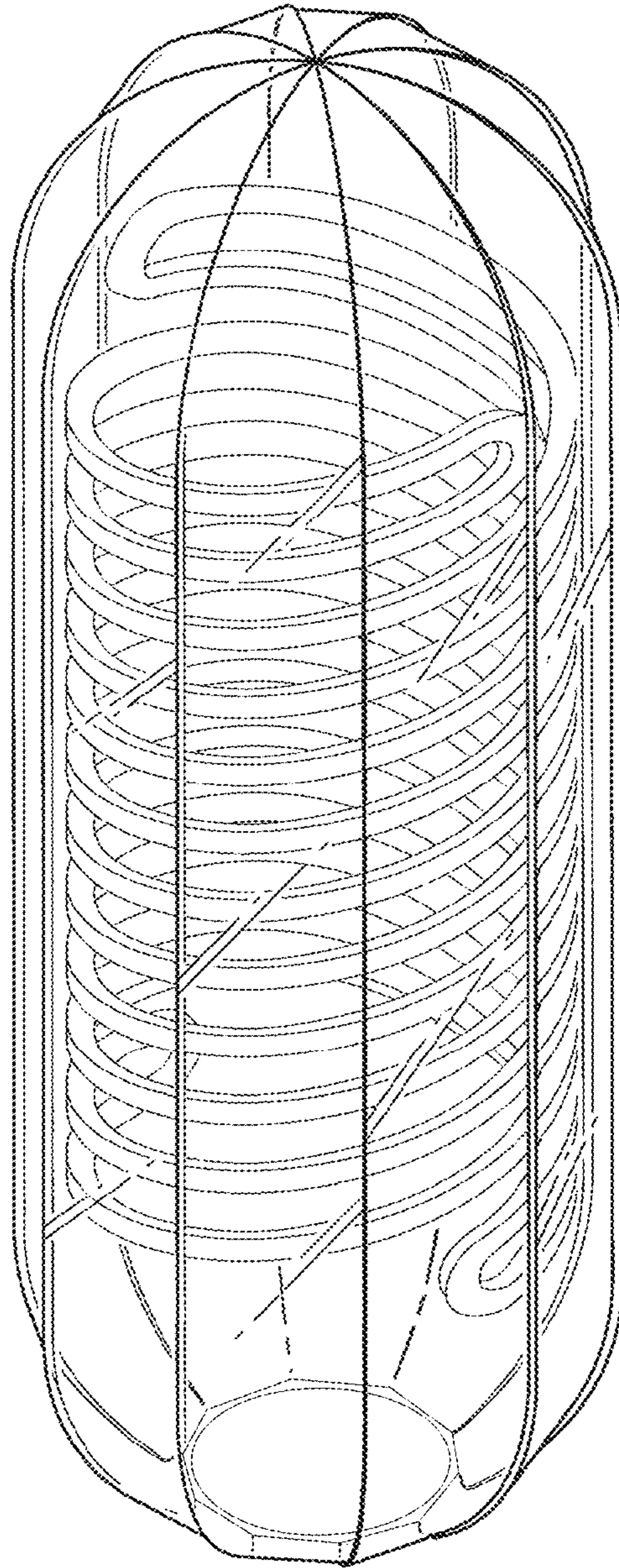

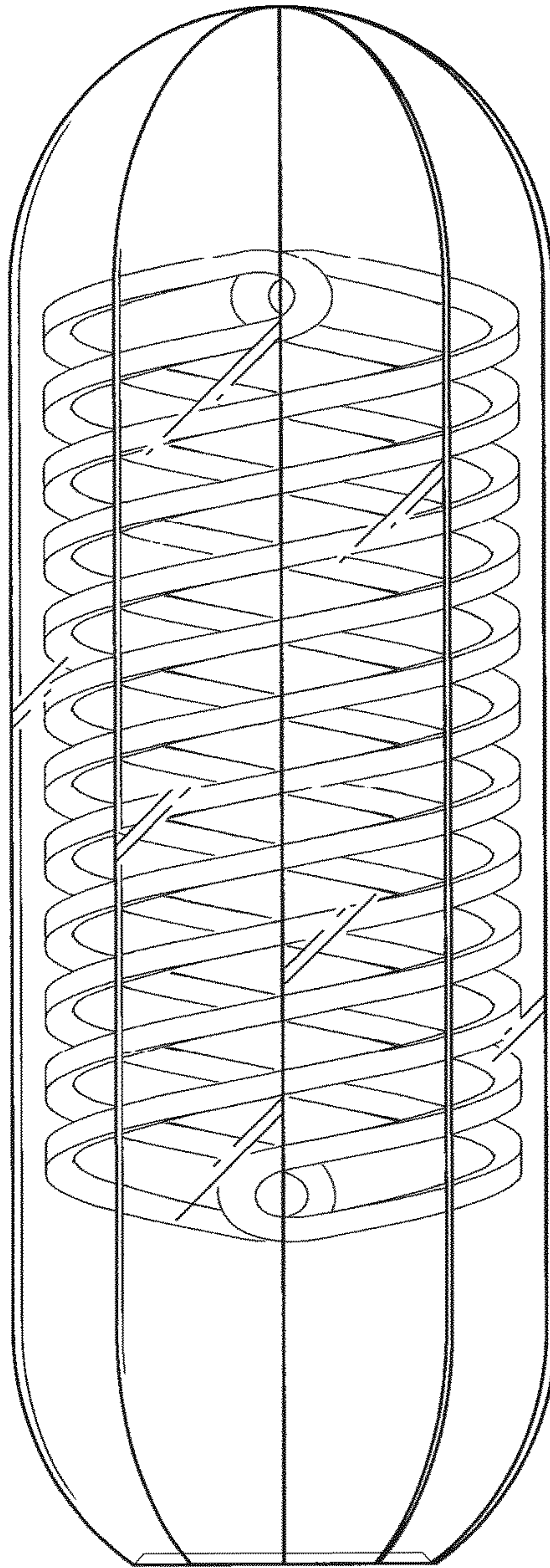

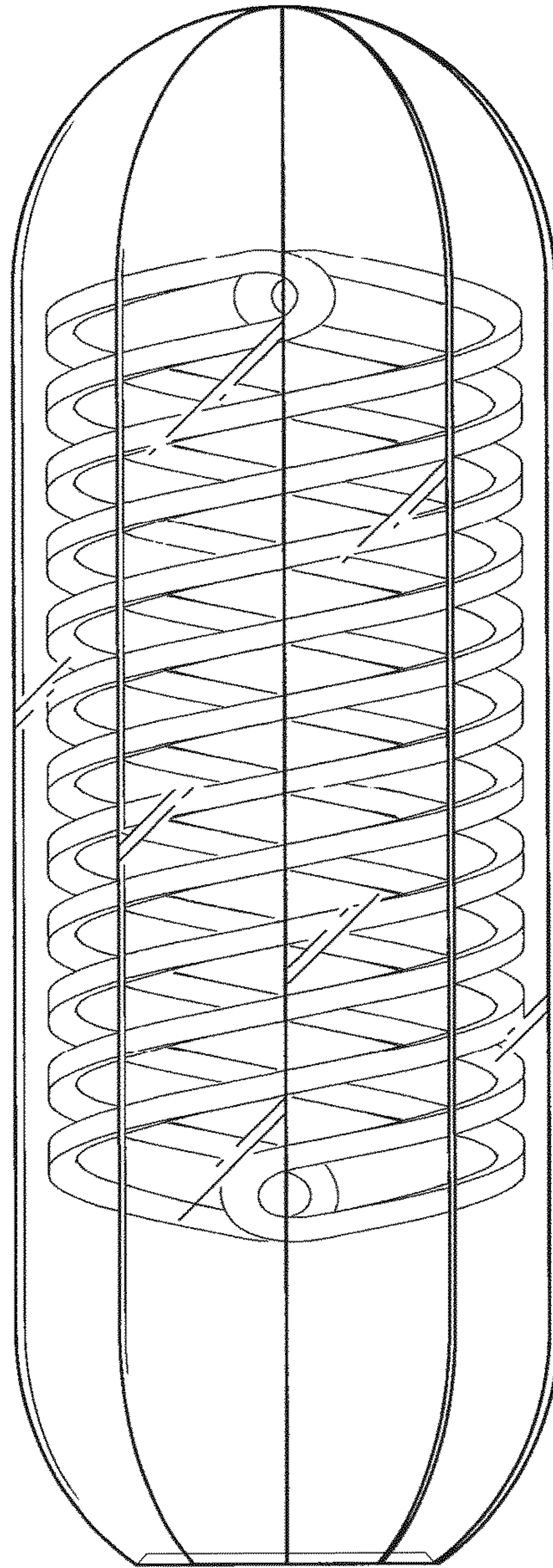

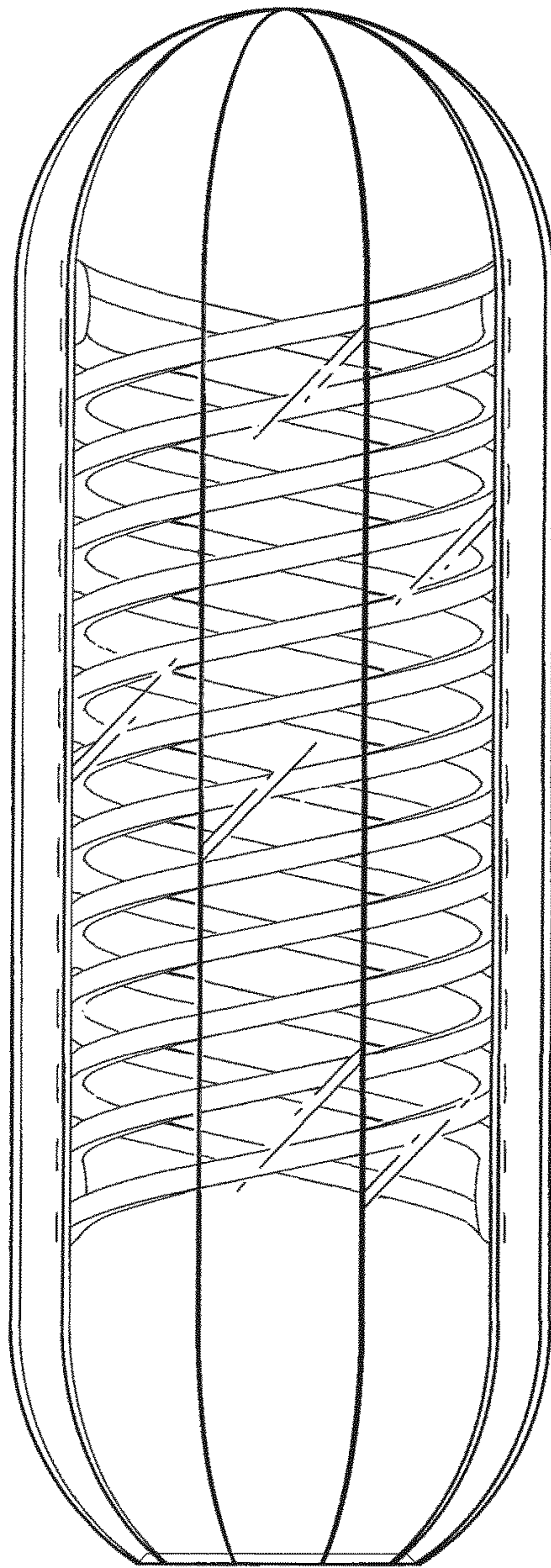

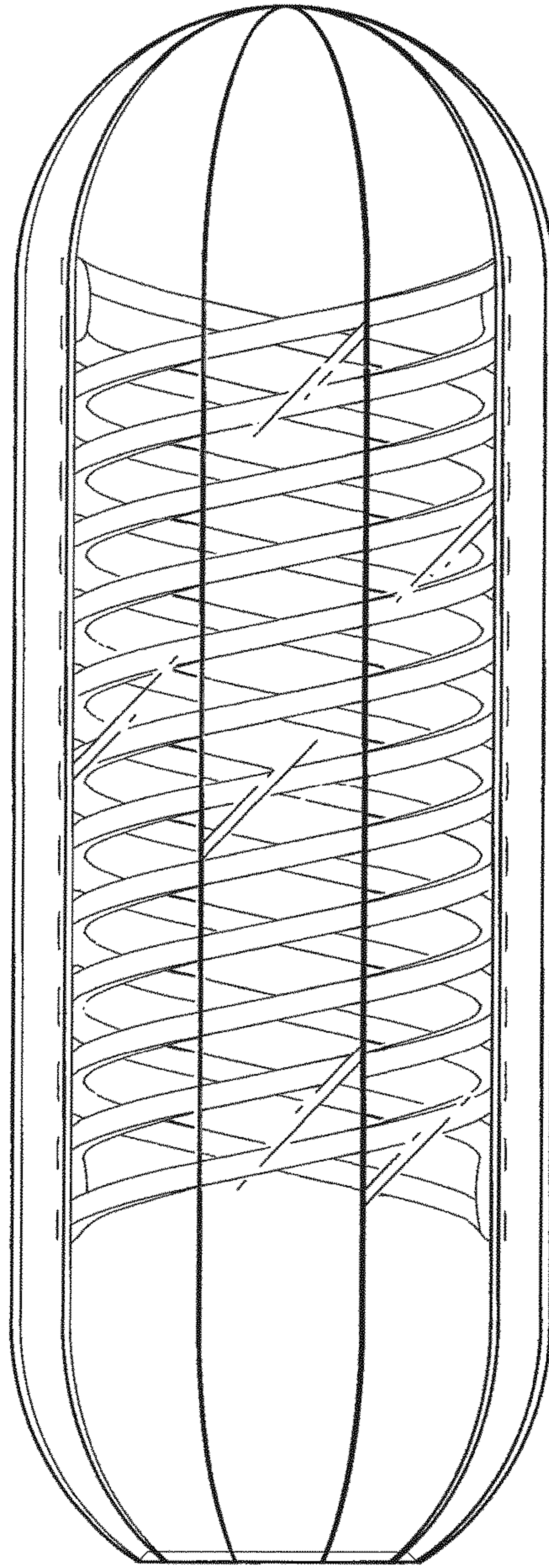

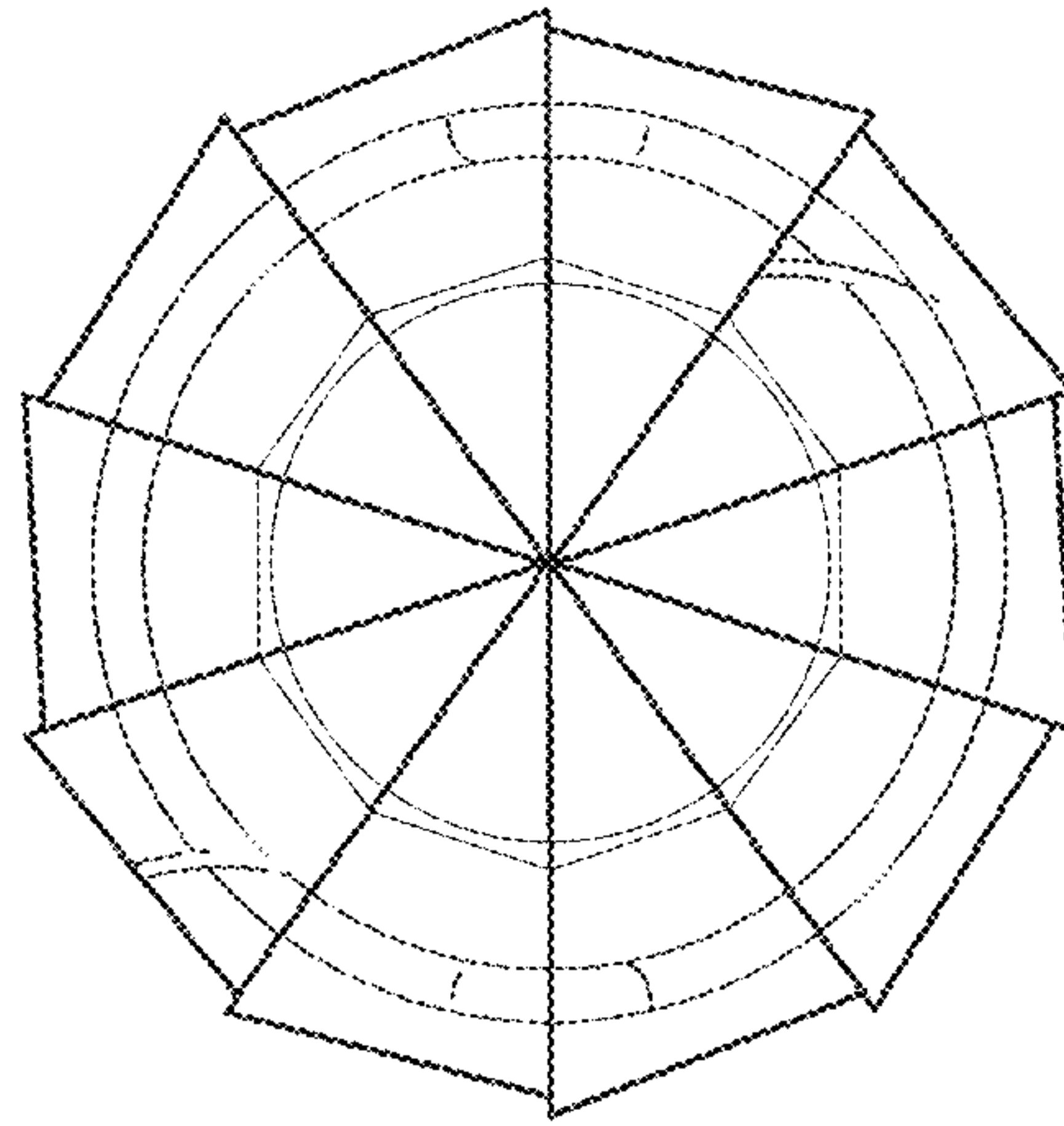

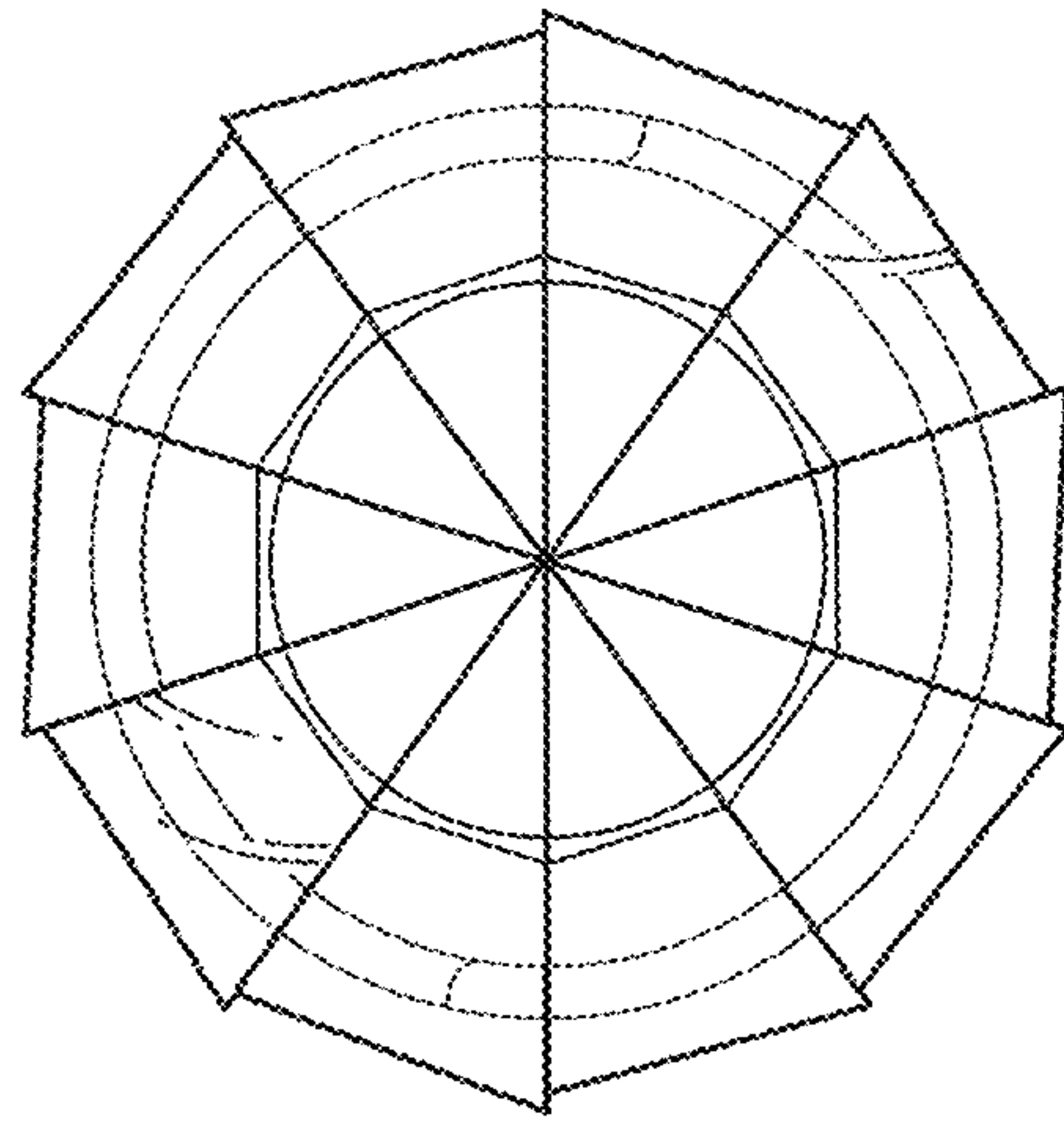
