The ornamental design for an exterior surface configuration of a headlight for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an exterior surface configuration of a headlight for a vehicle according to the novel design;

FIG. 4 is a right side view thereof;

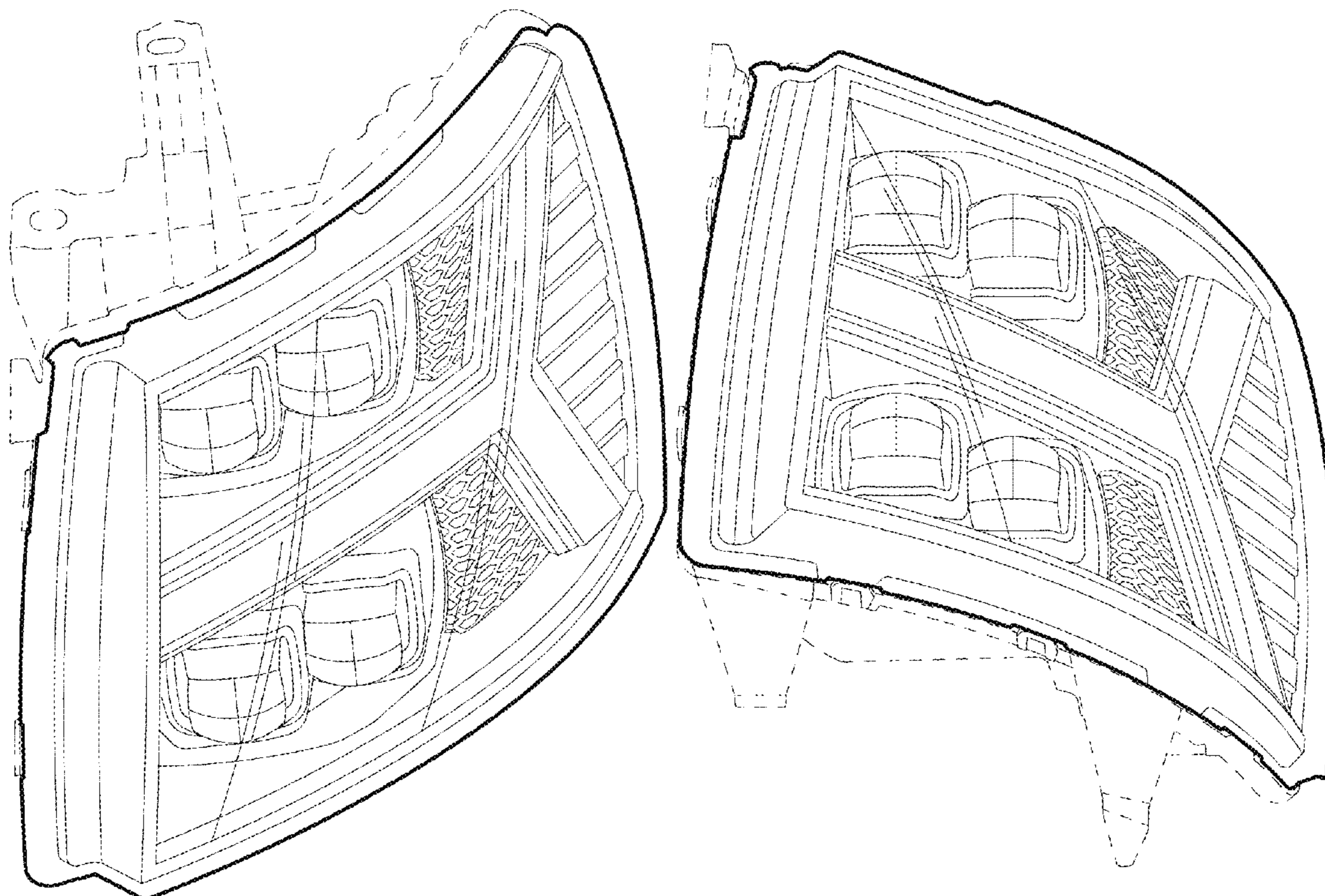
FIG. 5 is a back side view thereof;

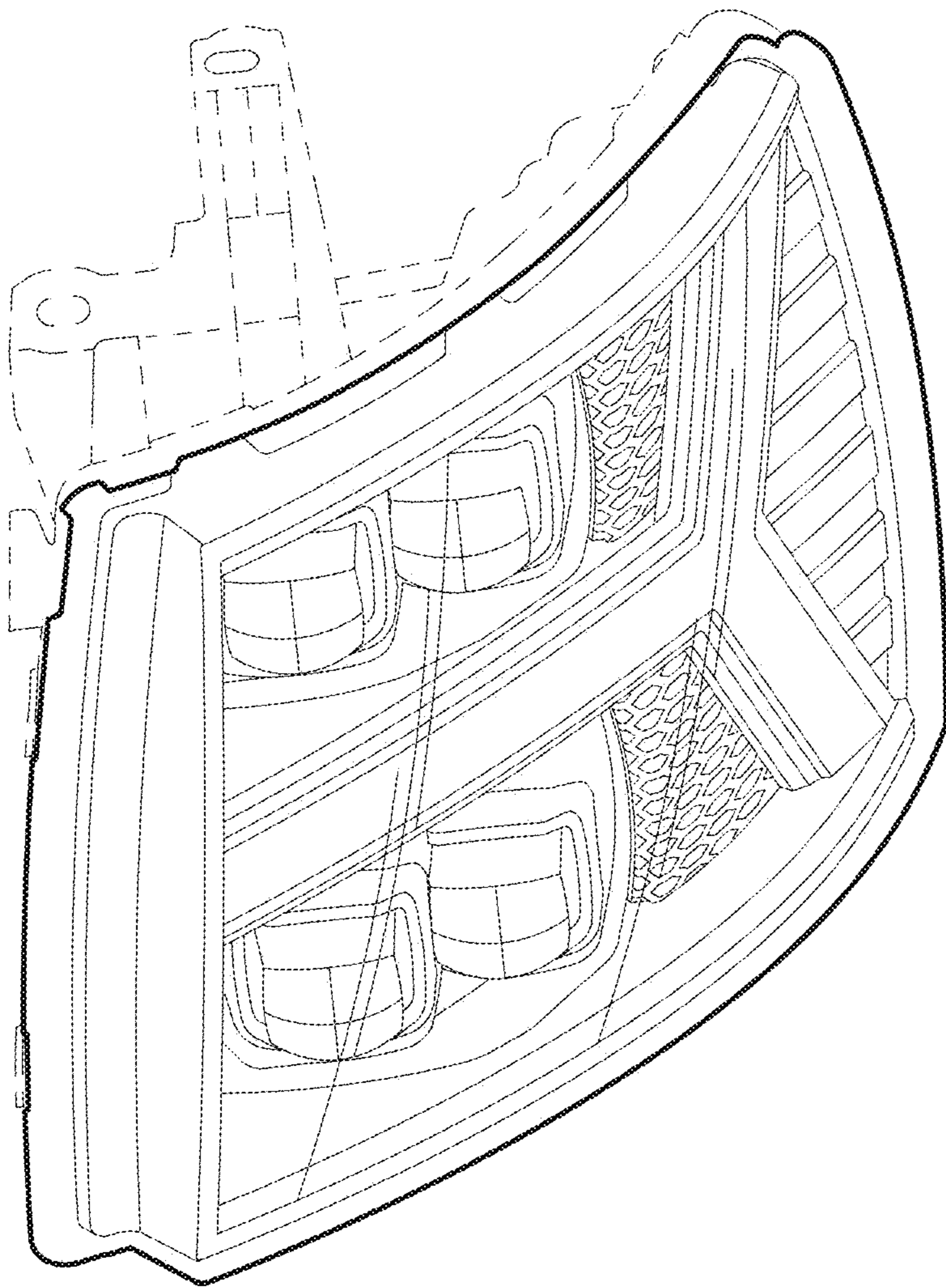

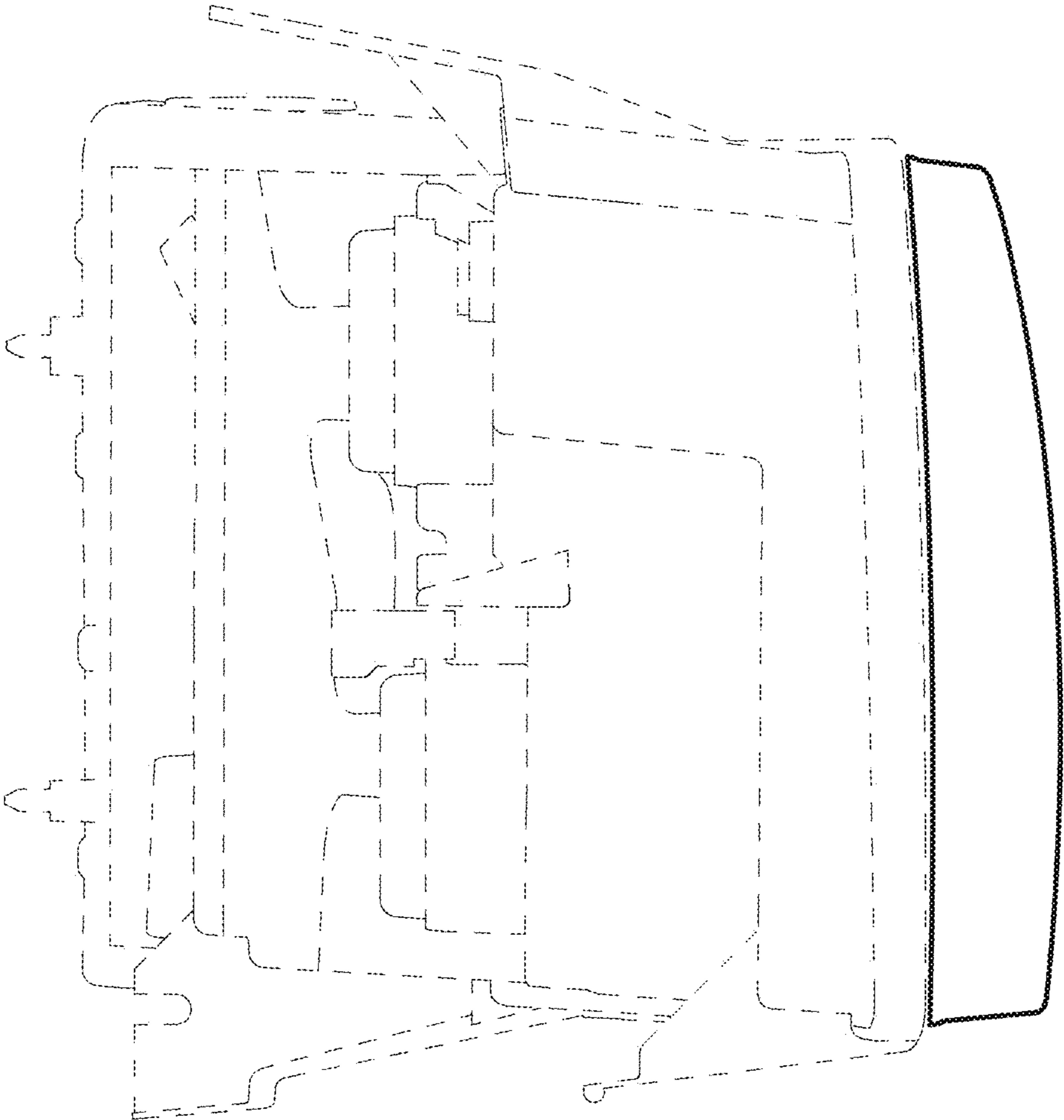

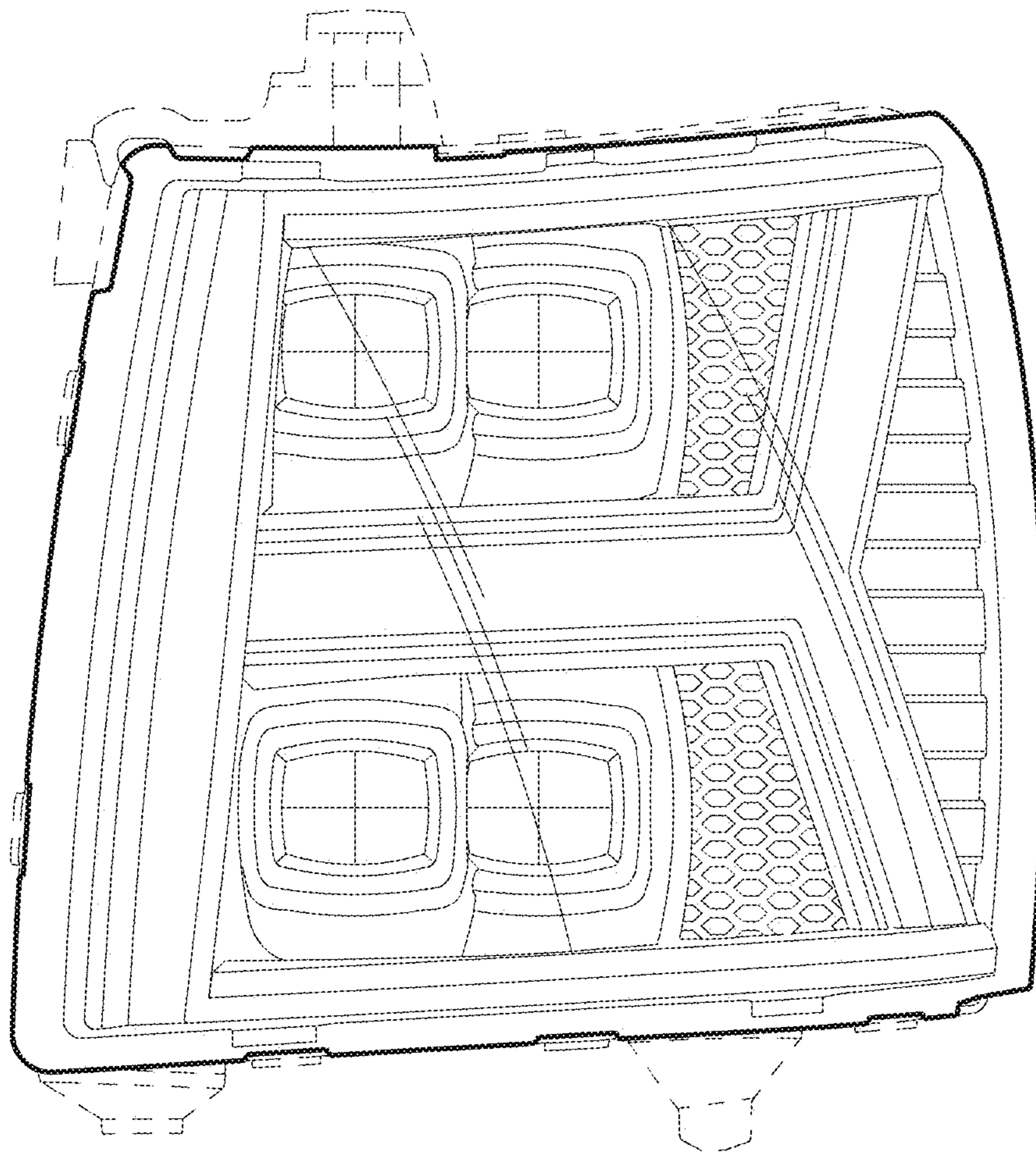

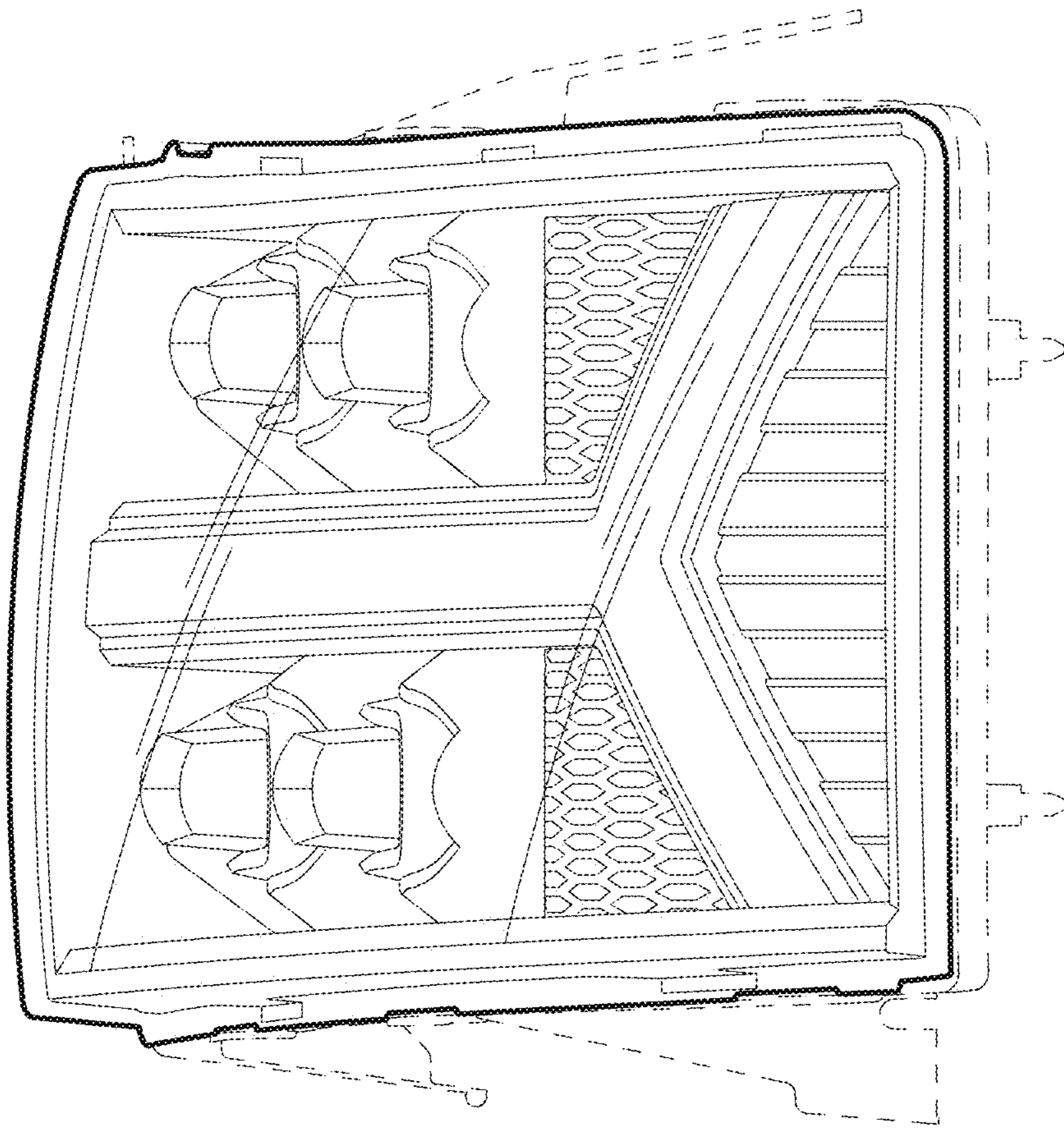

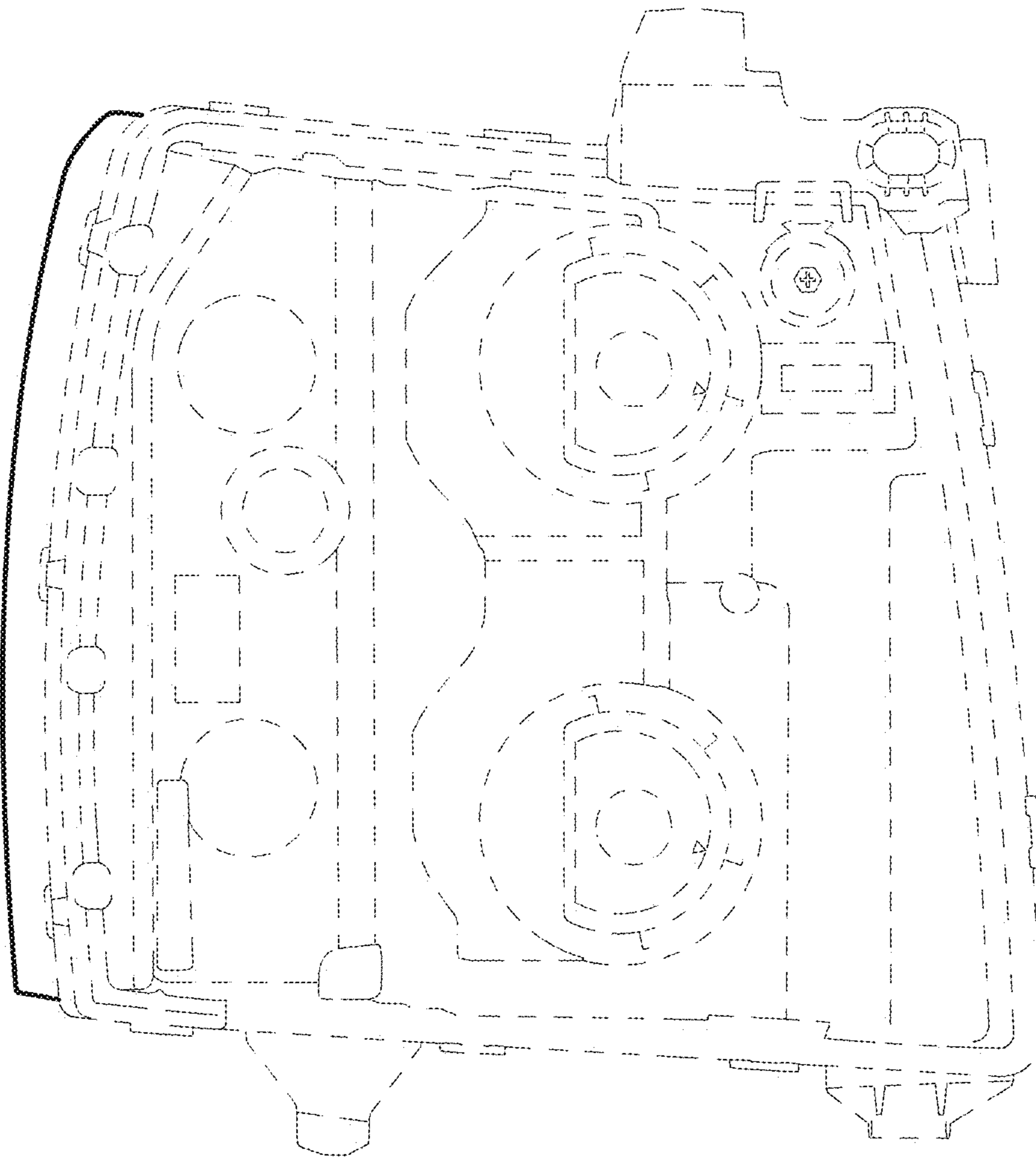

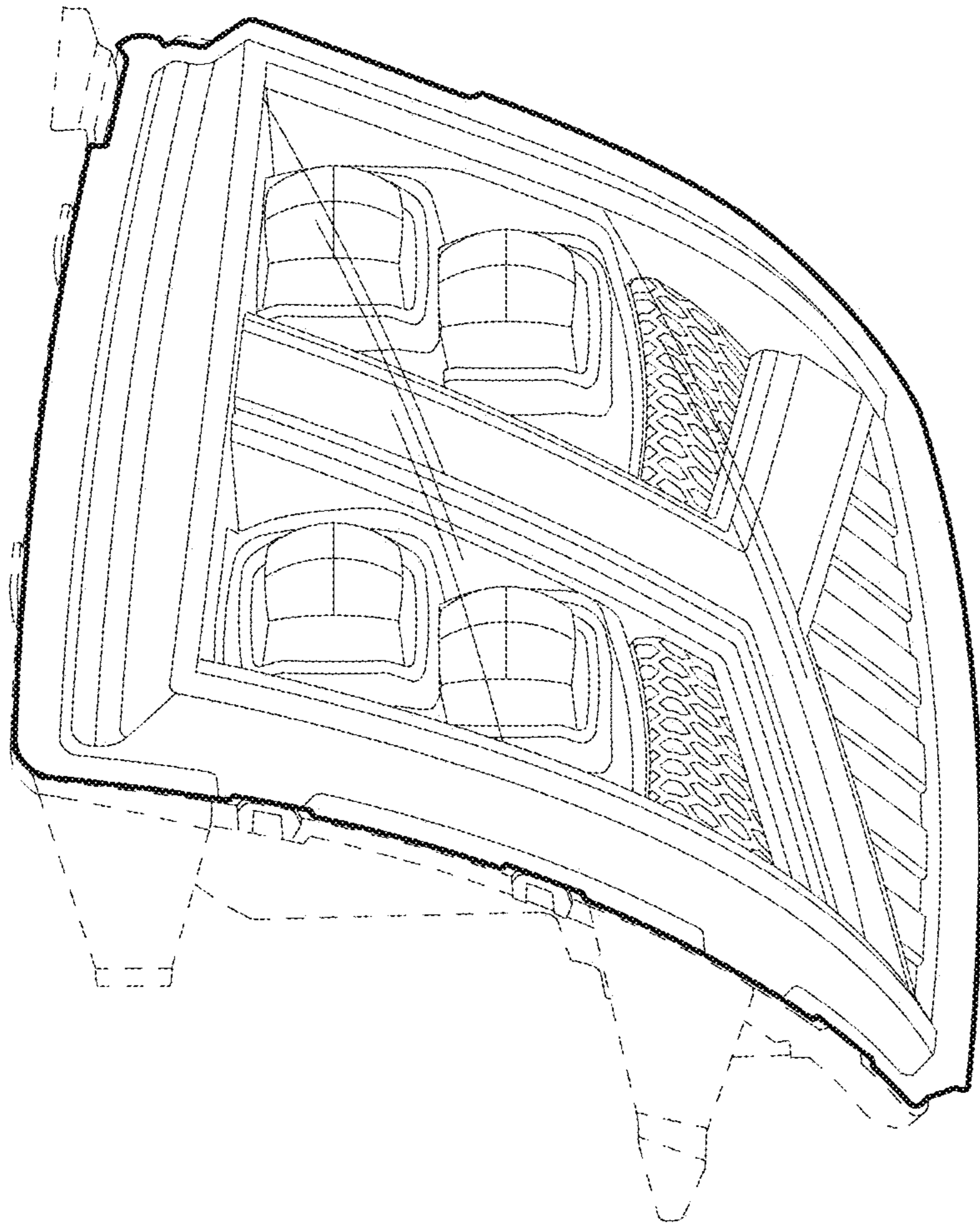

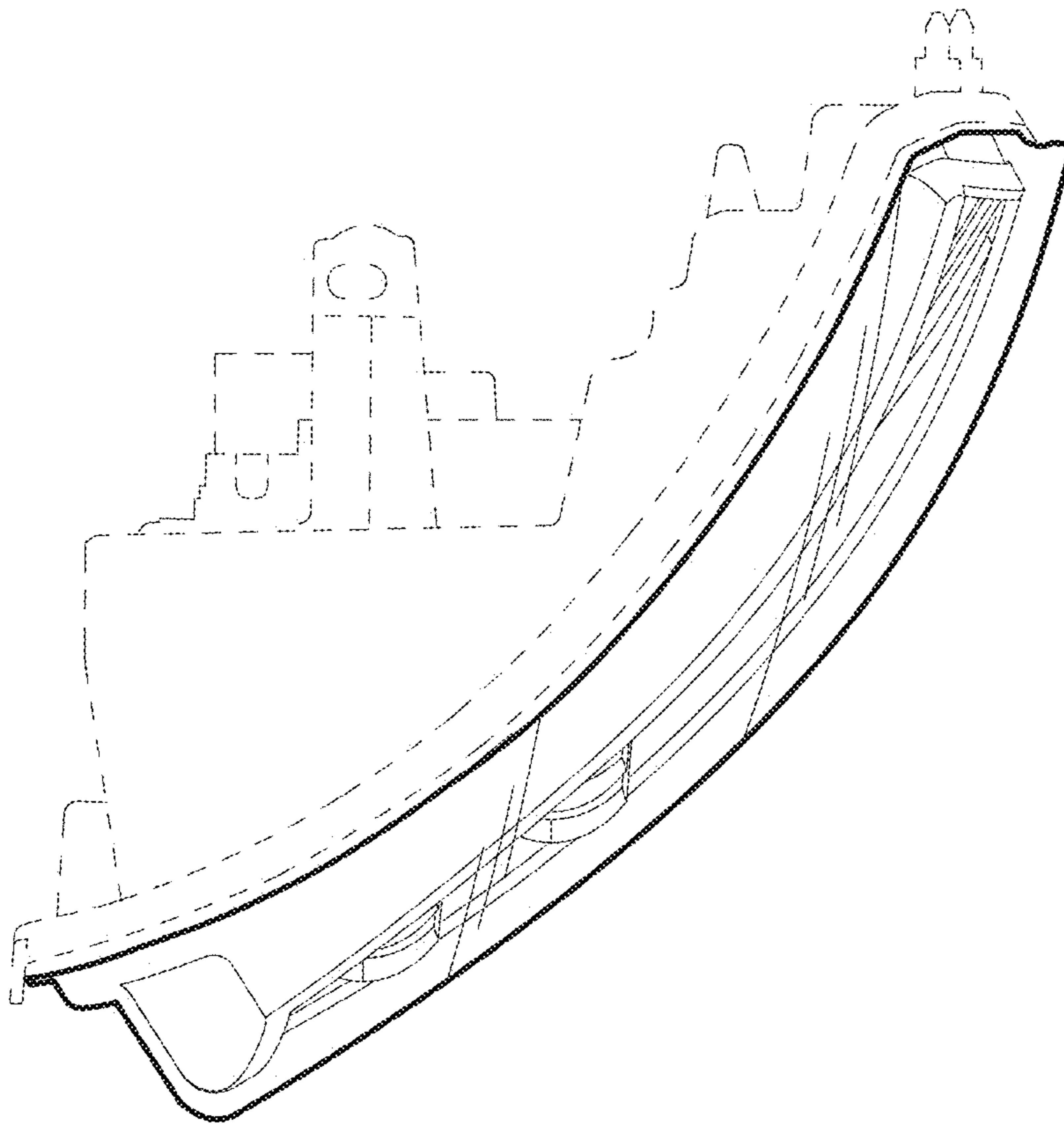
