FIG. 8 is a top view of the hair extension styling apparatus, in accordance with an alternative embodiment of the present invention;

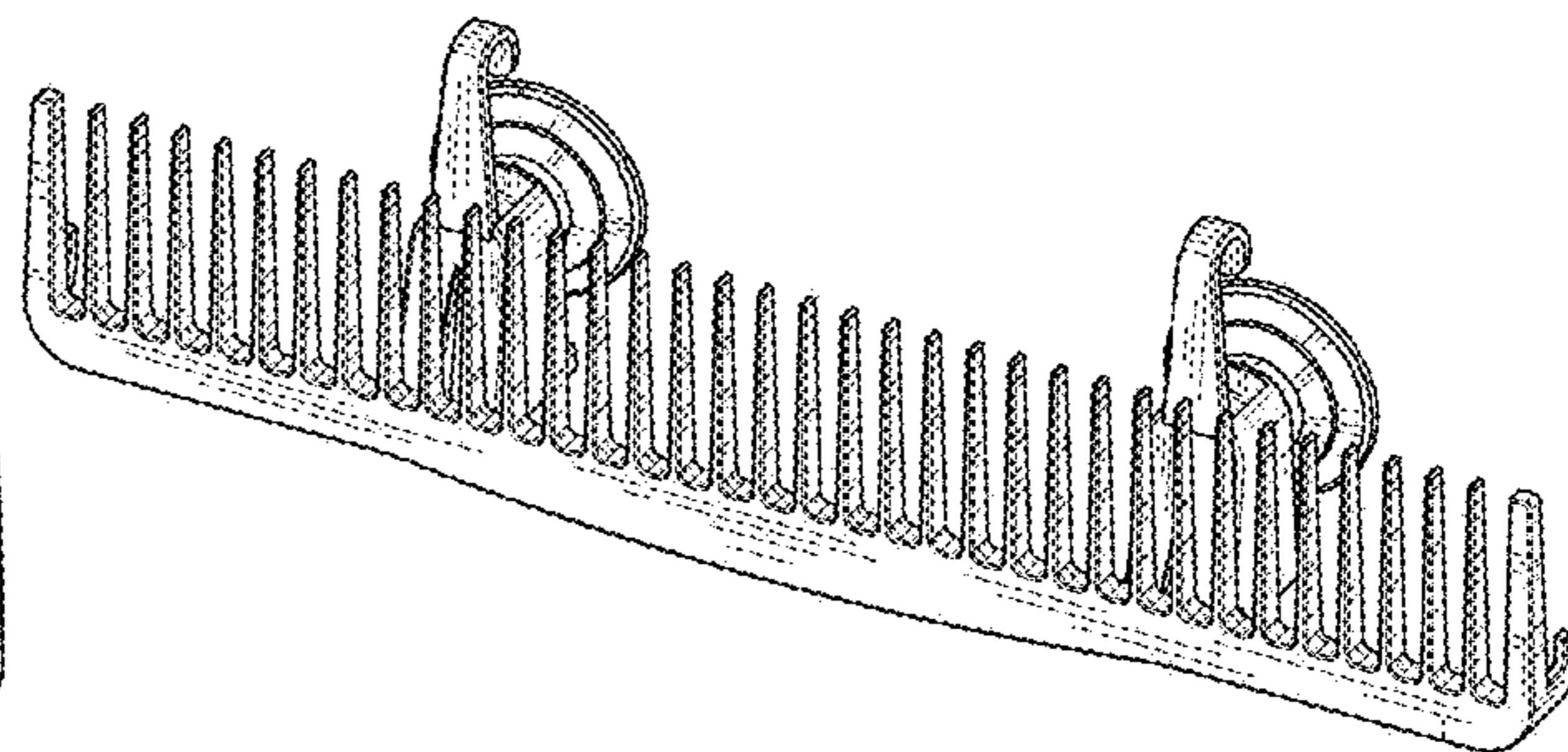
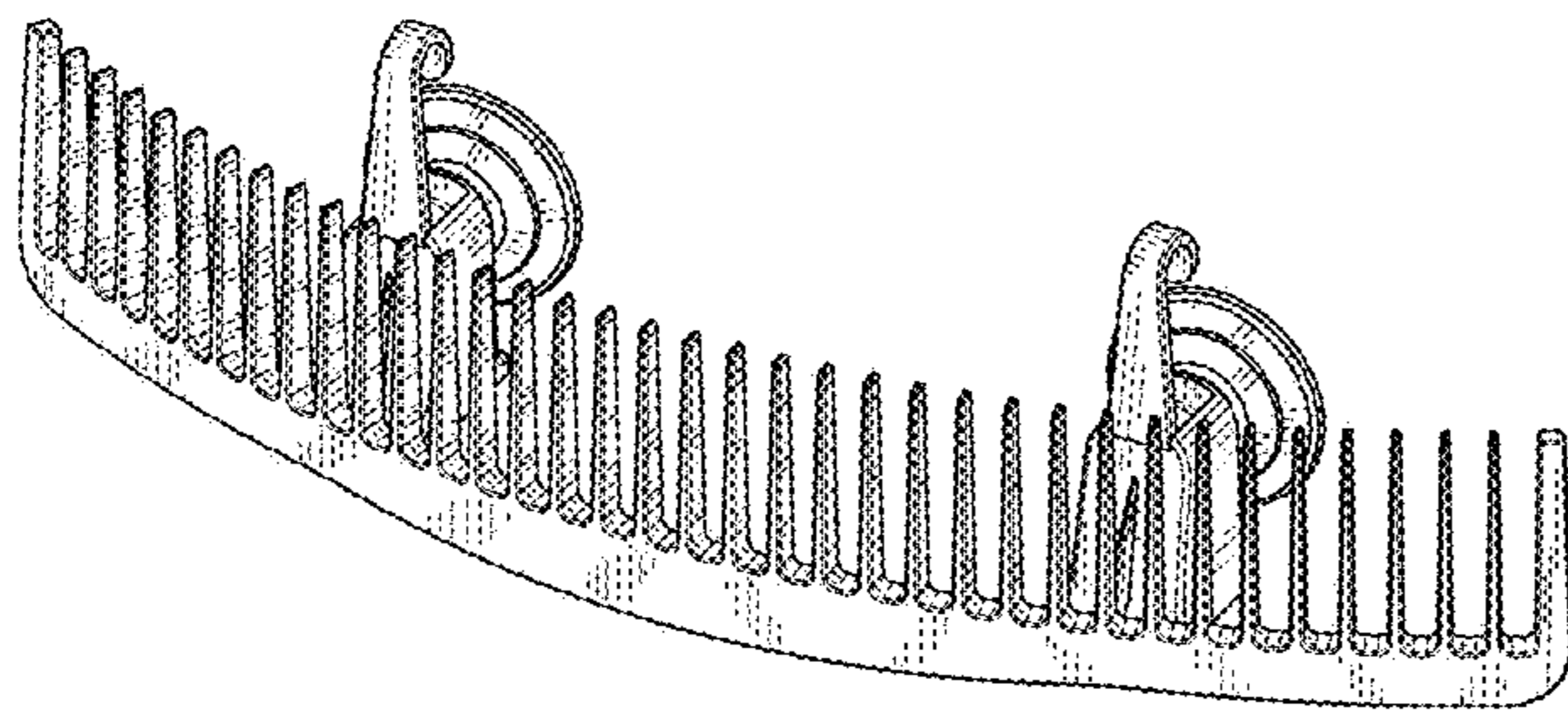
FIG. 9 is a front view of the hair extension styling apparatus, in accordance with an alternative embodiment of the present invention;

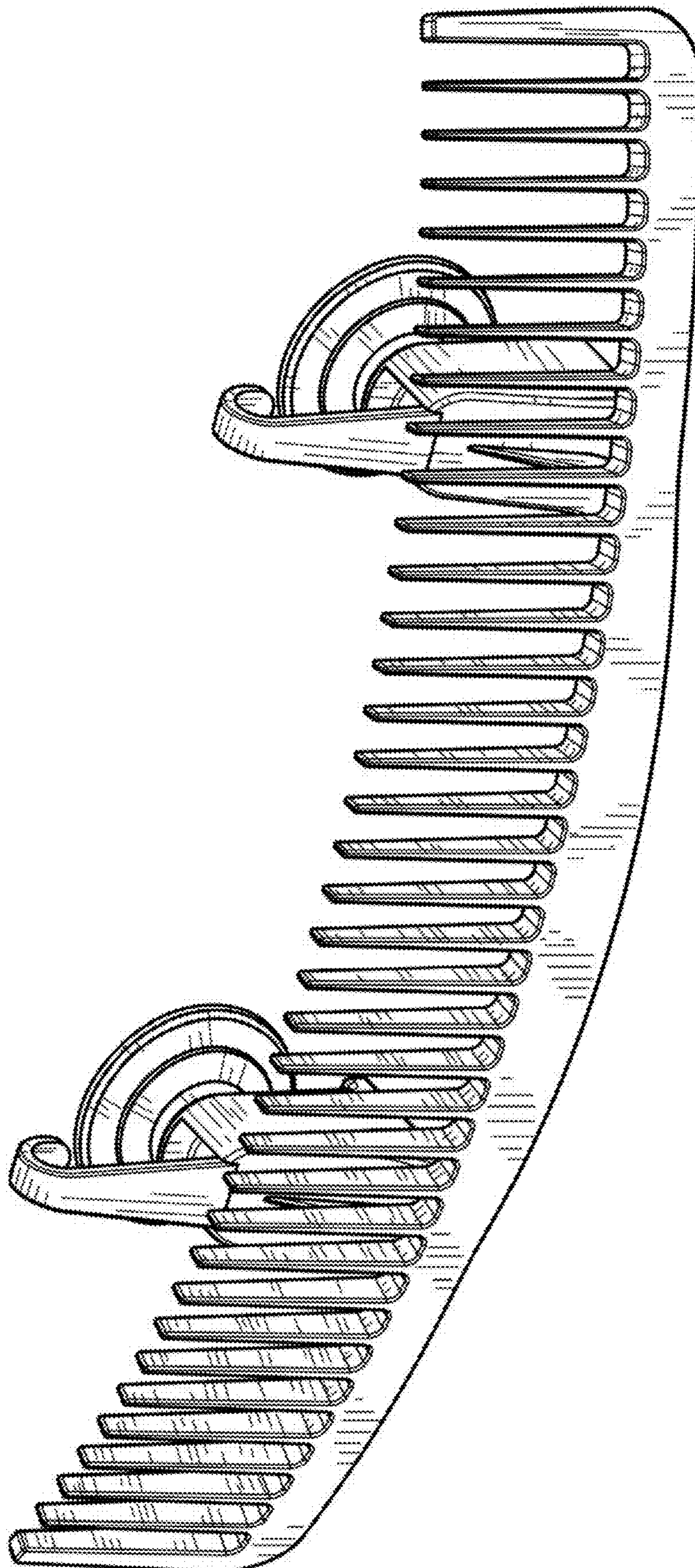

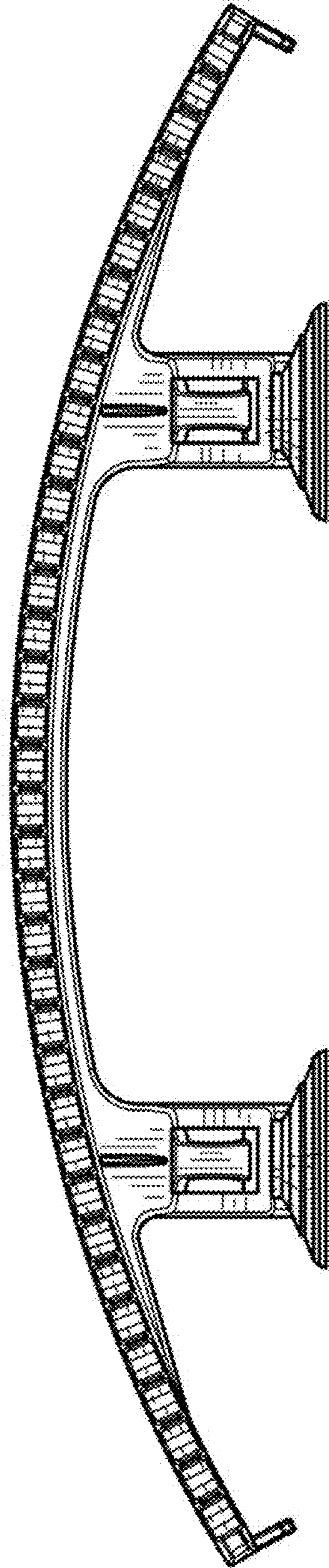

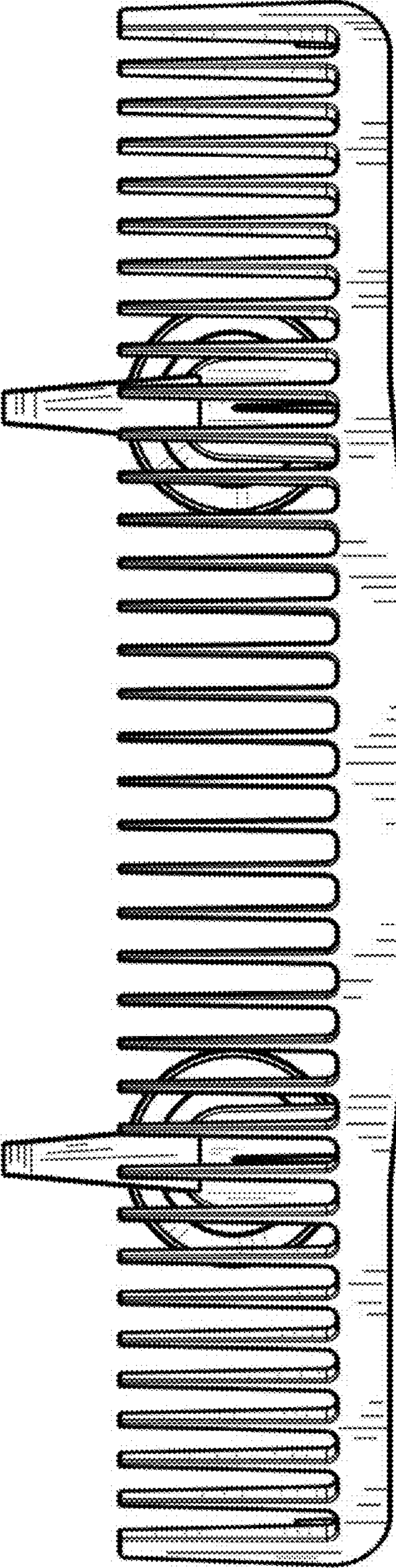

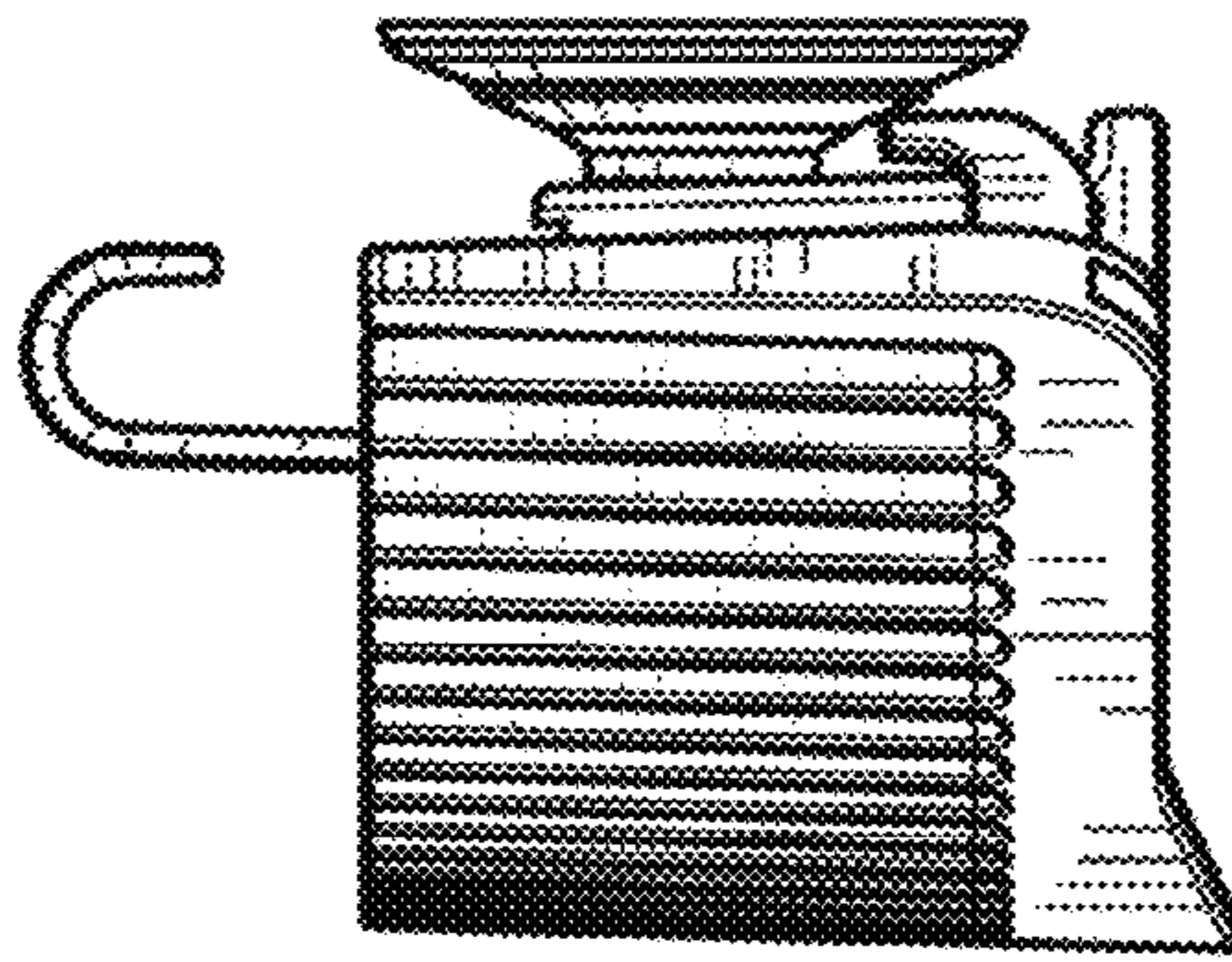

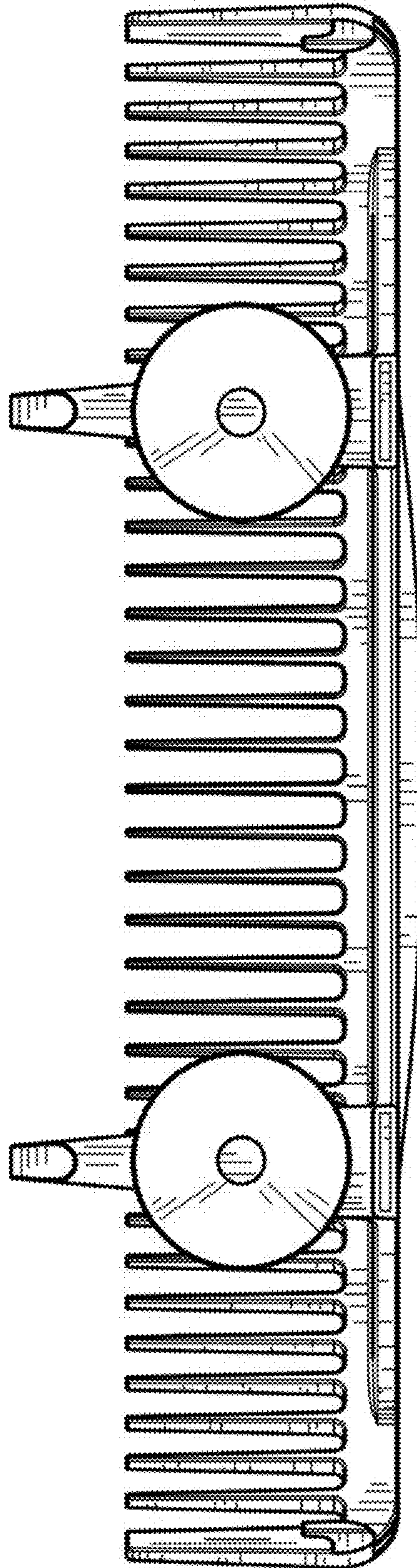

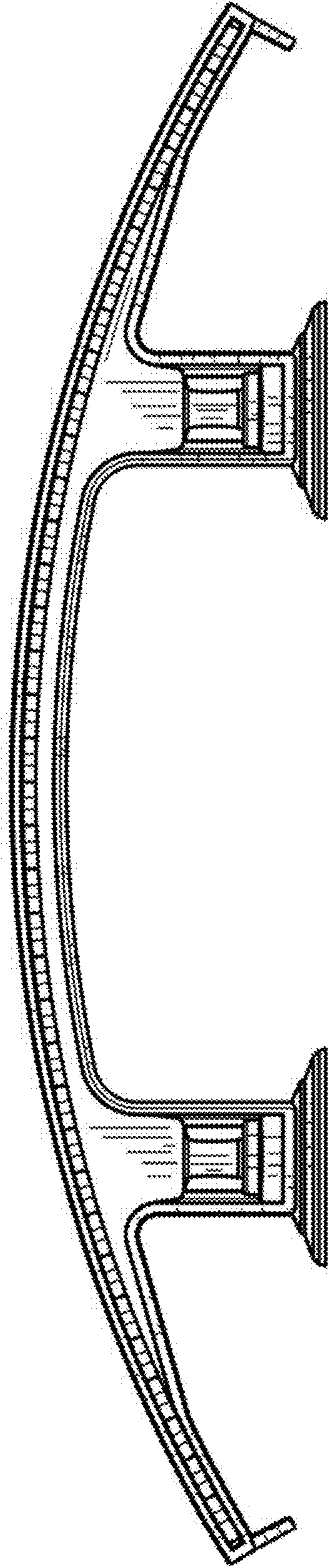

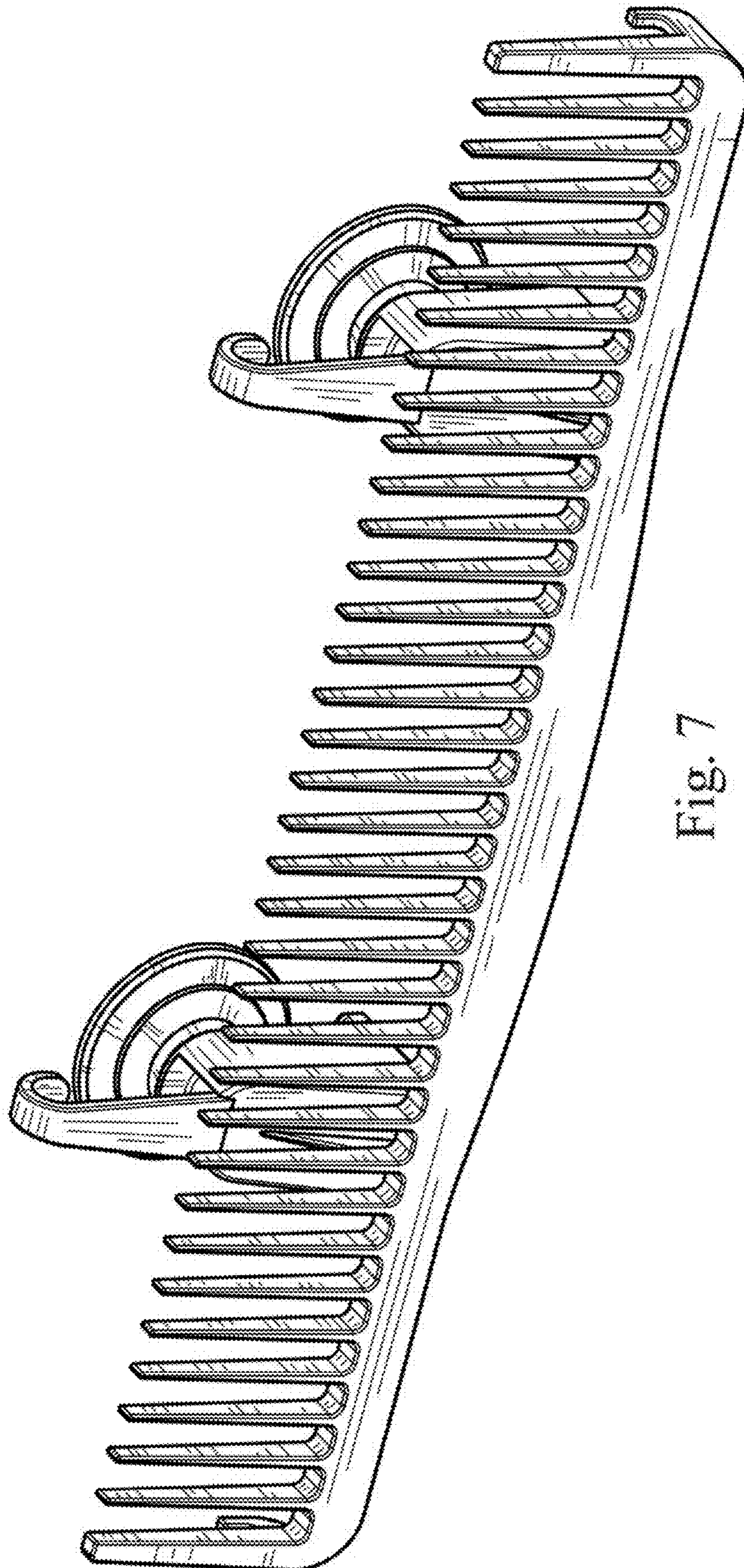

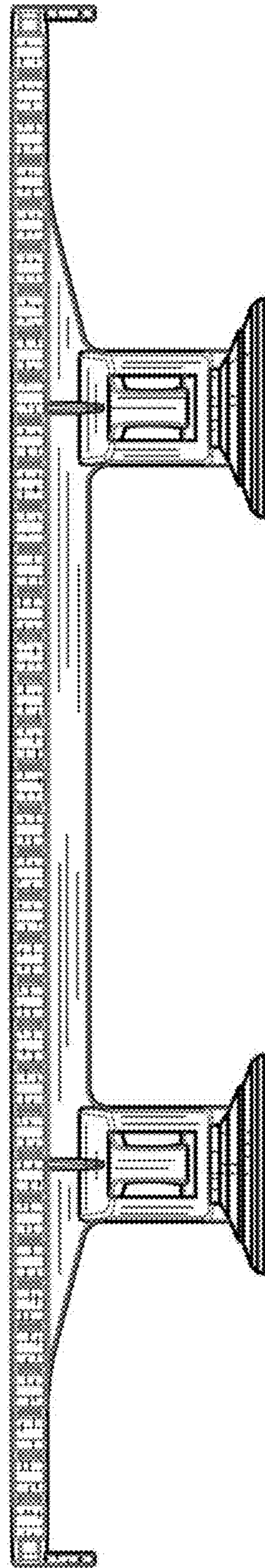

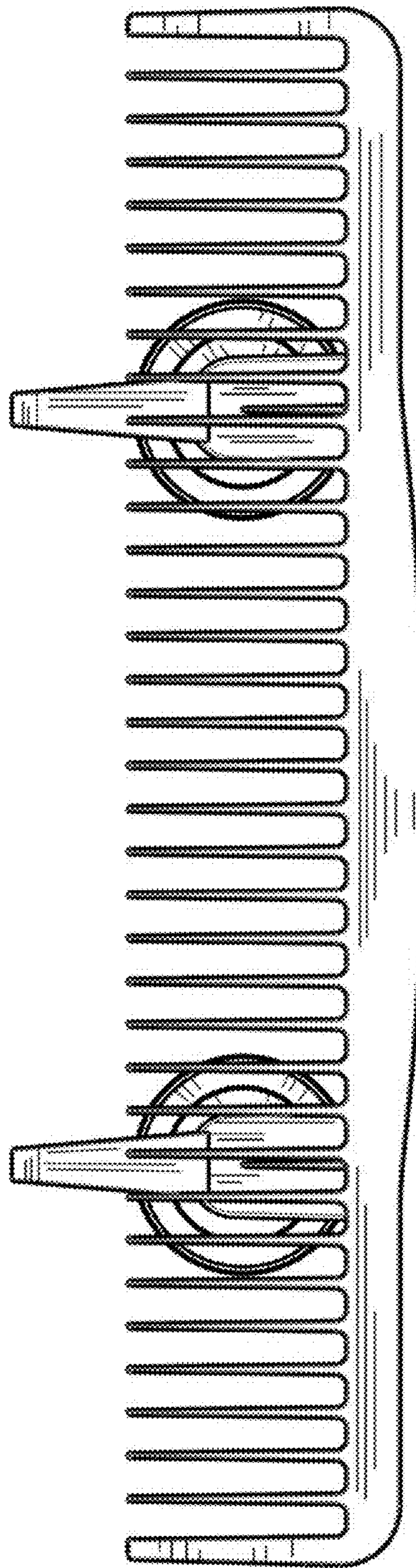

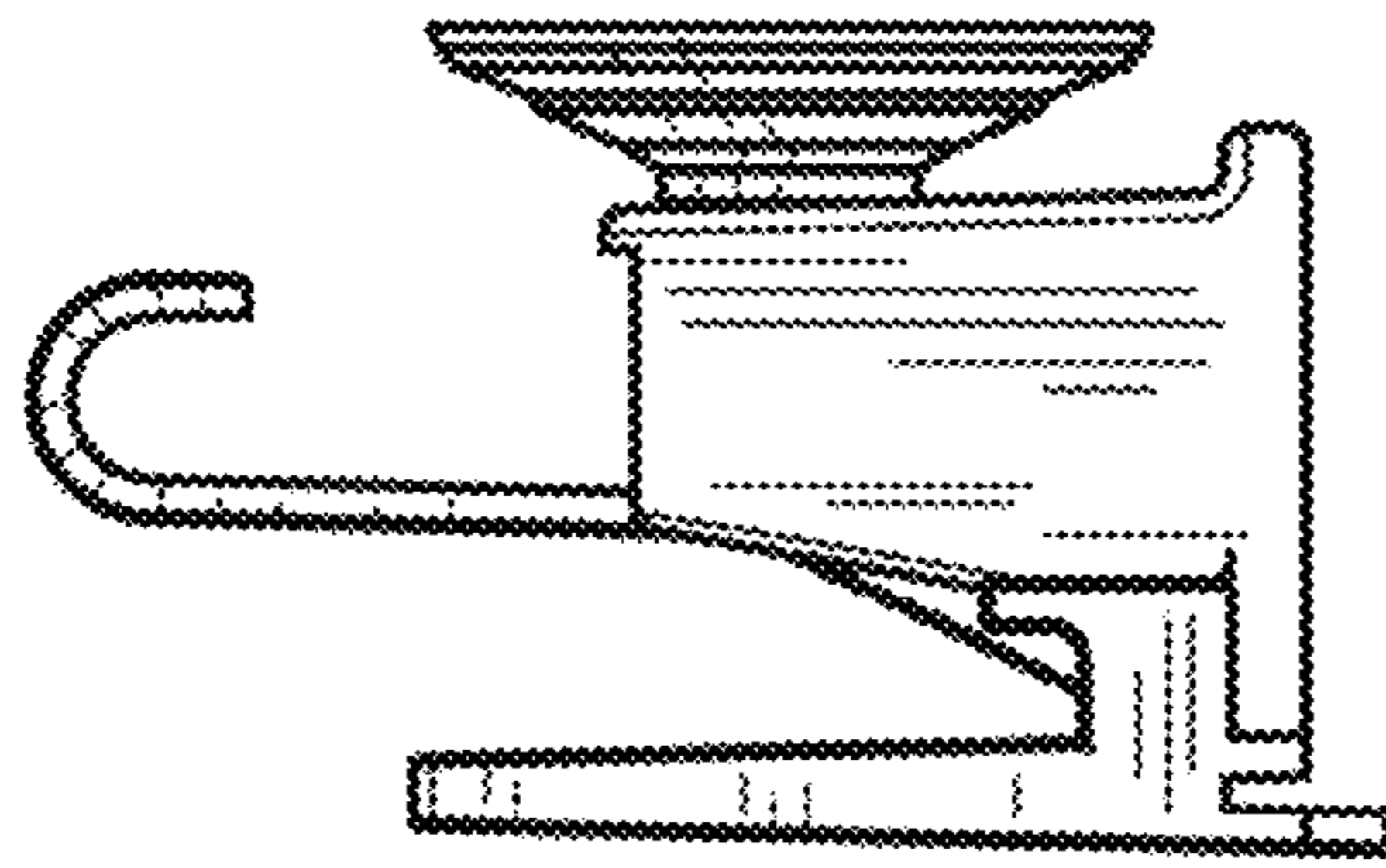

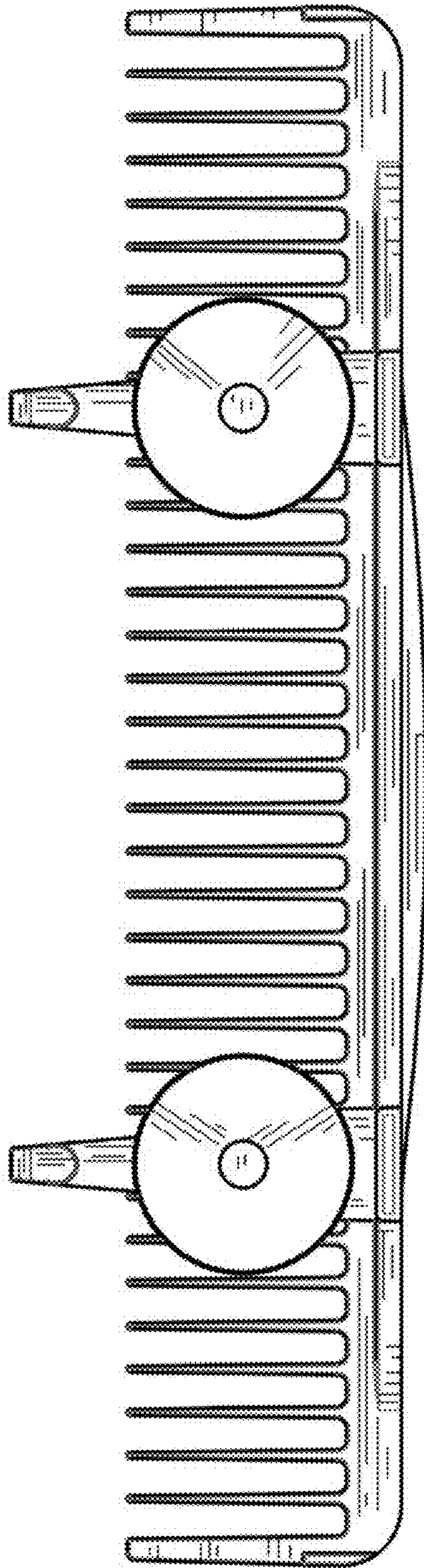

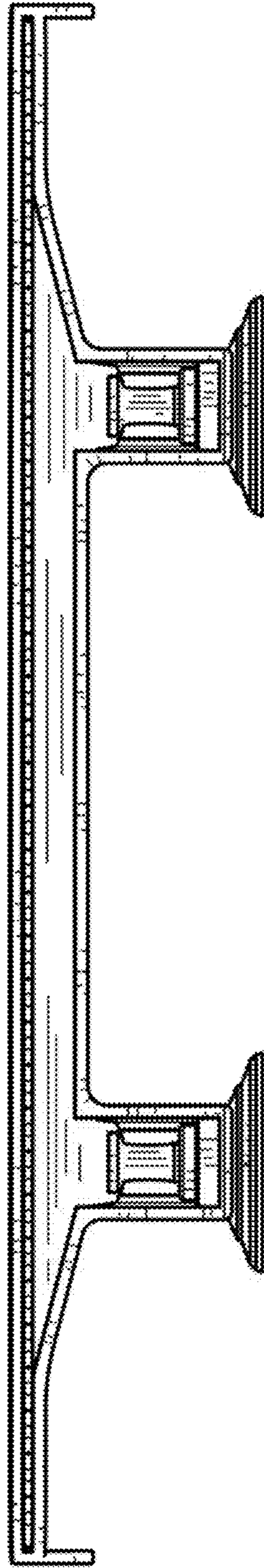
