DESCRIPTION

FIG. 10 is a rear elevation view thereof;

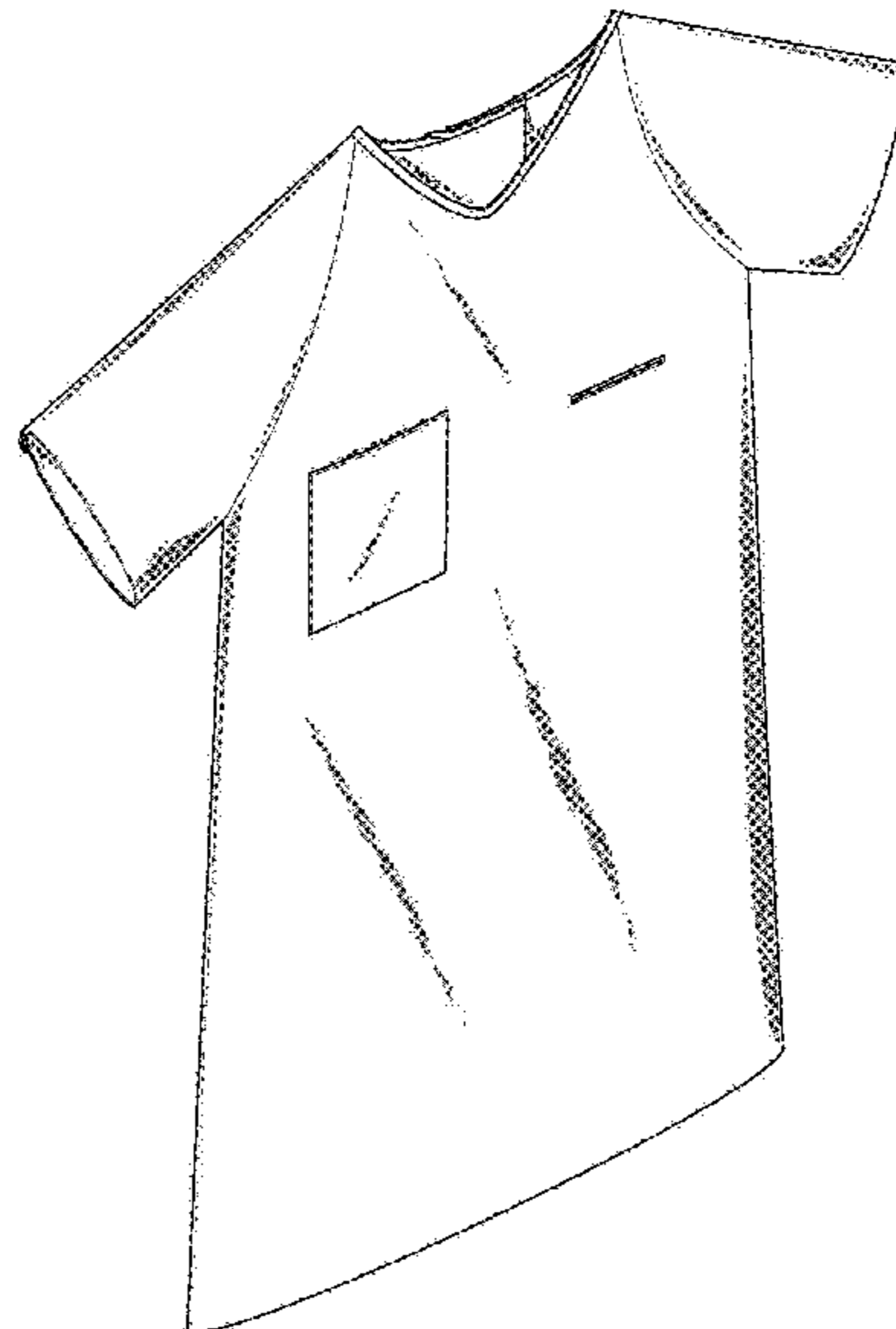
FIG. 11 is a right elevation view thereof;

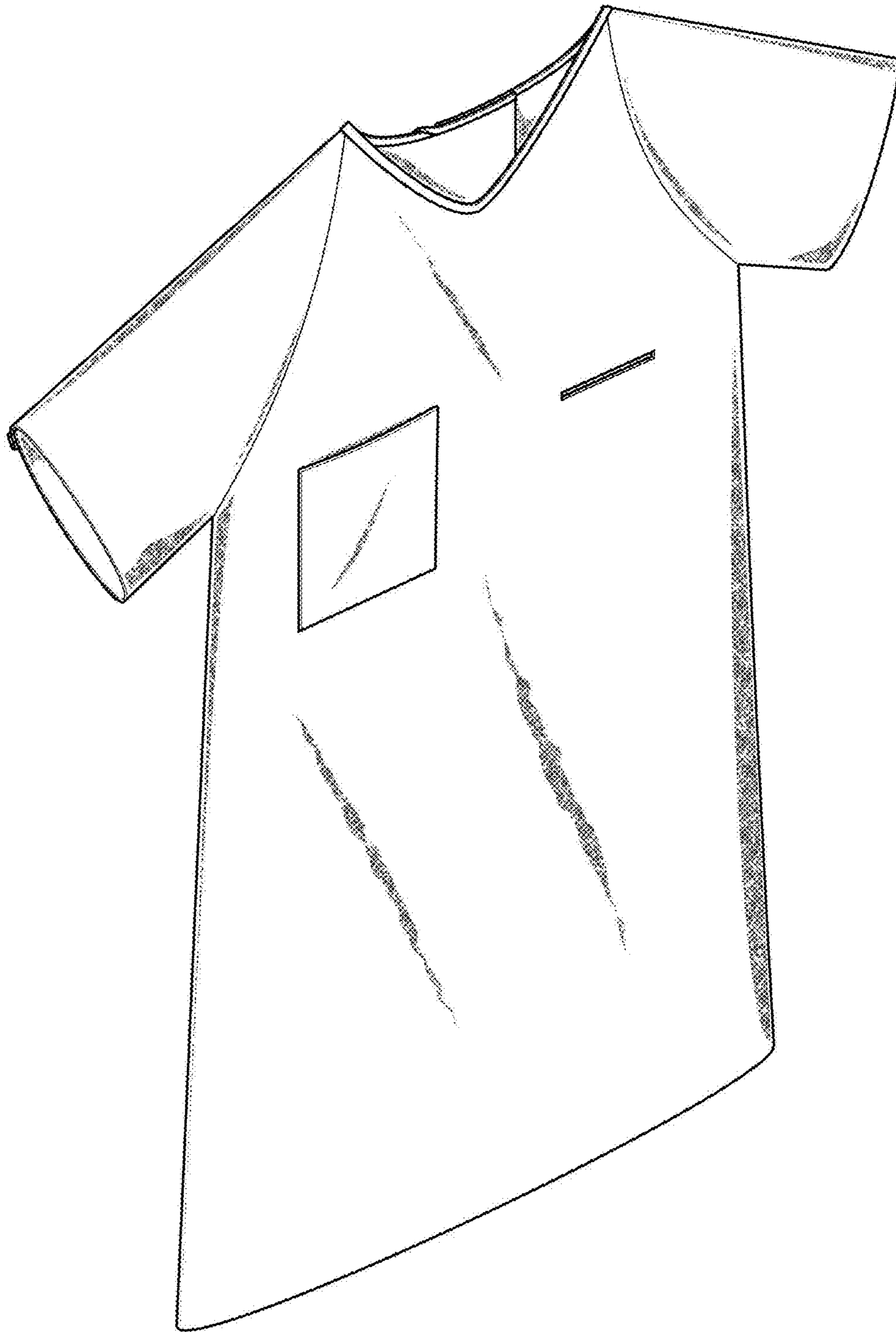

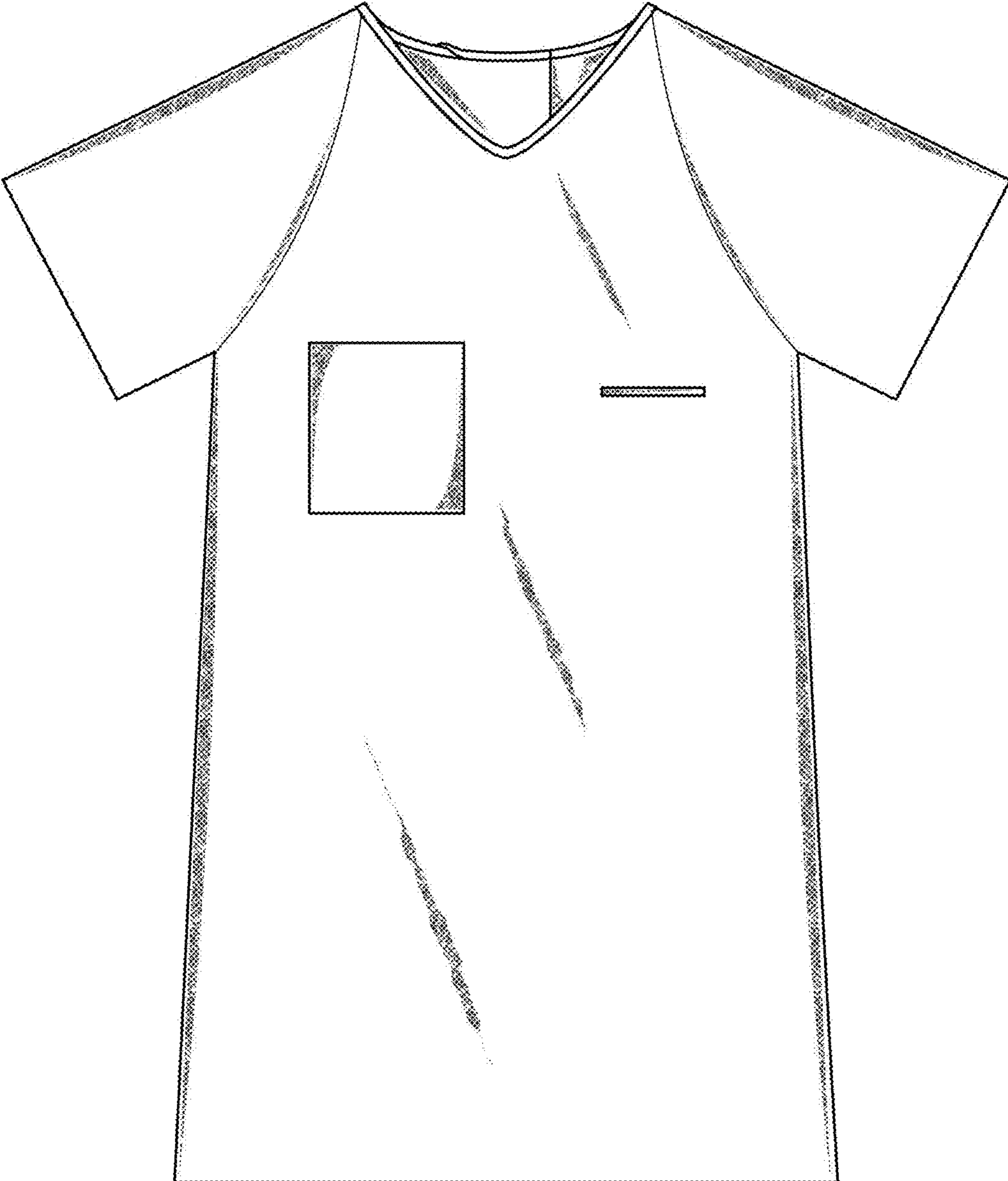

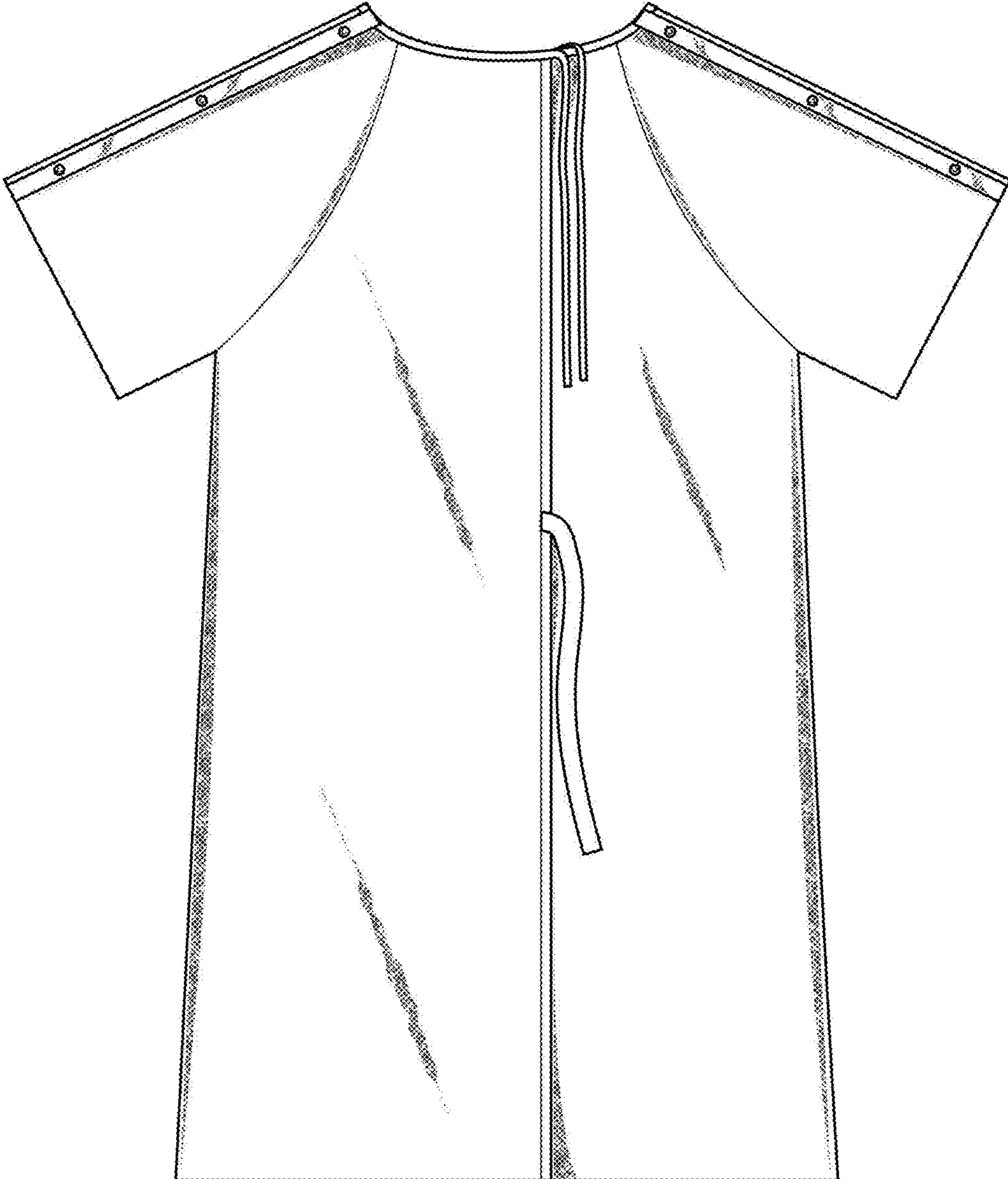

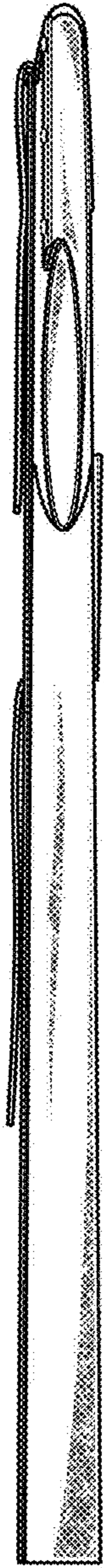

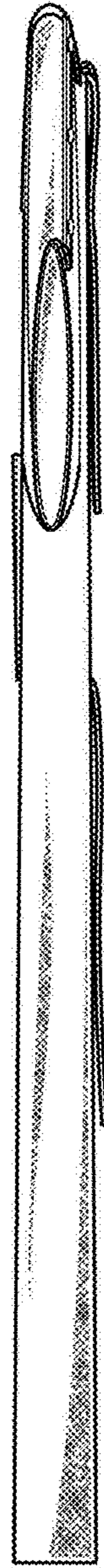

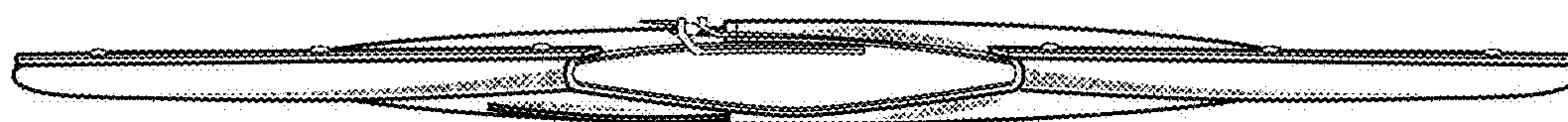

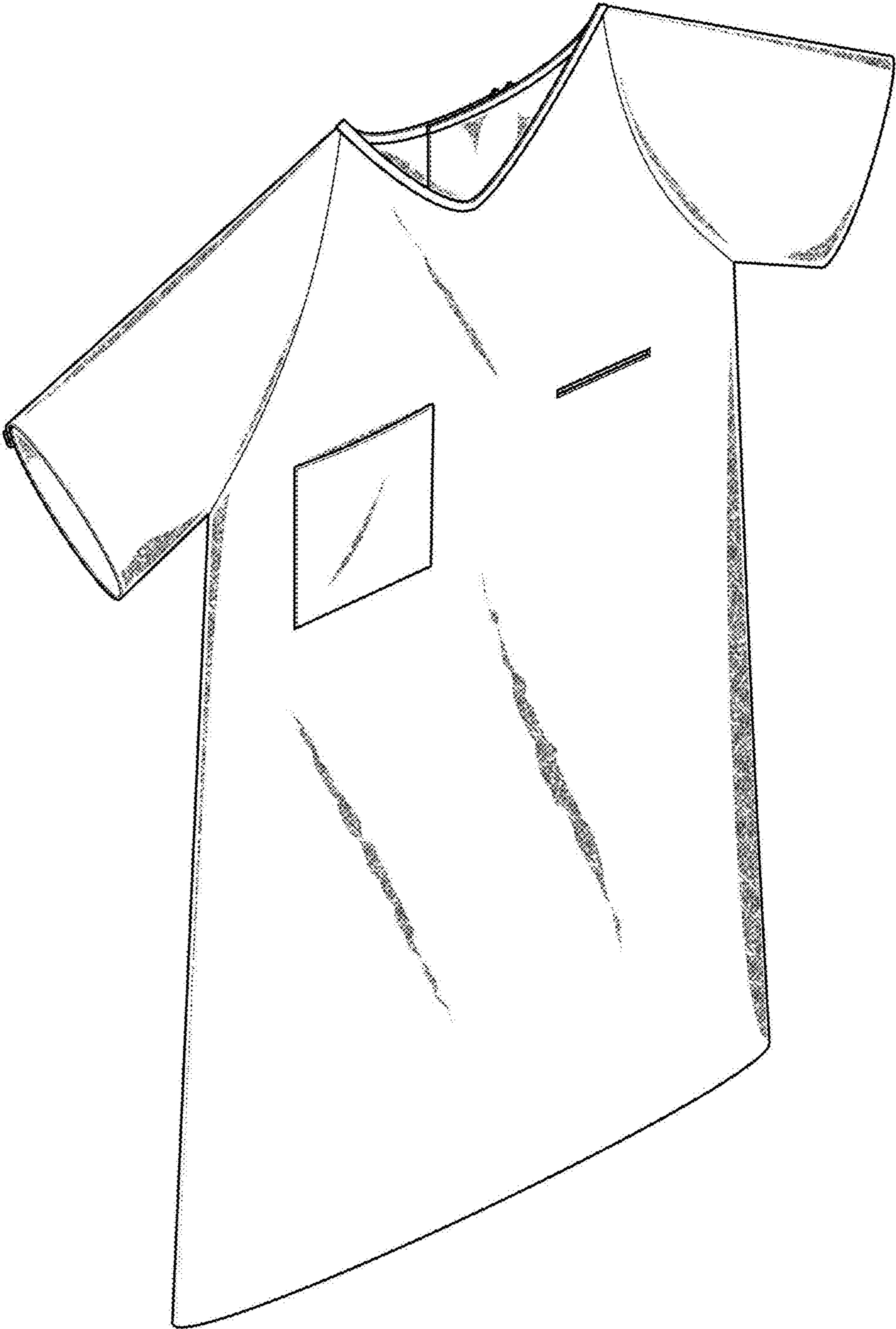

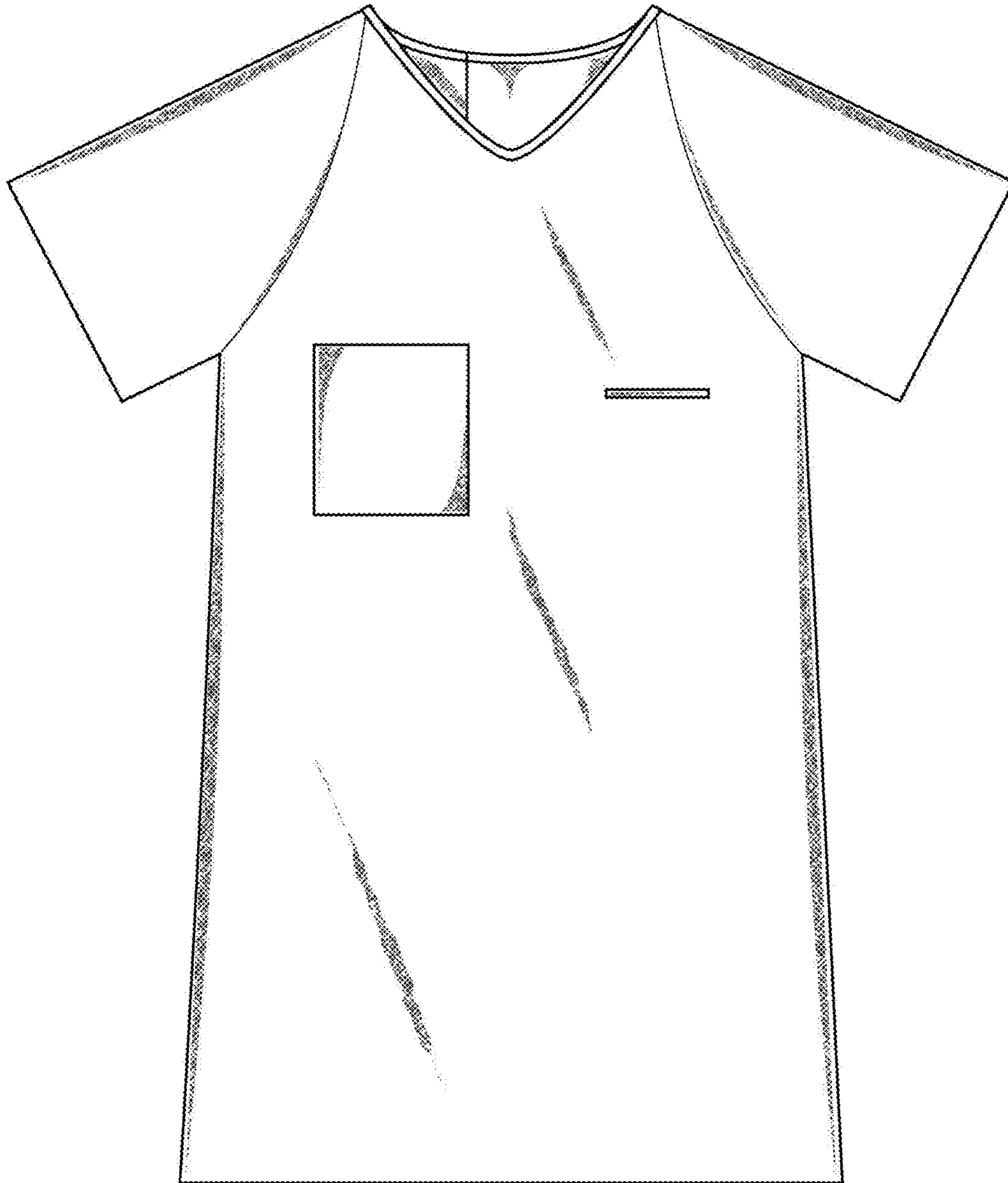

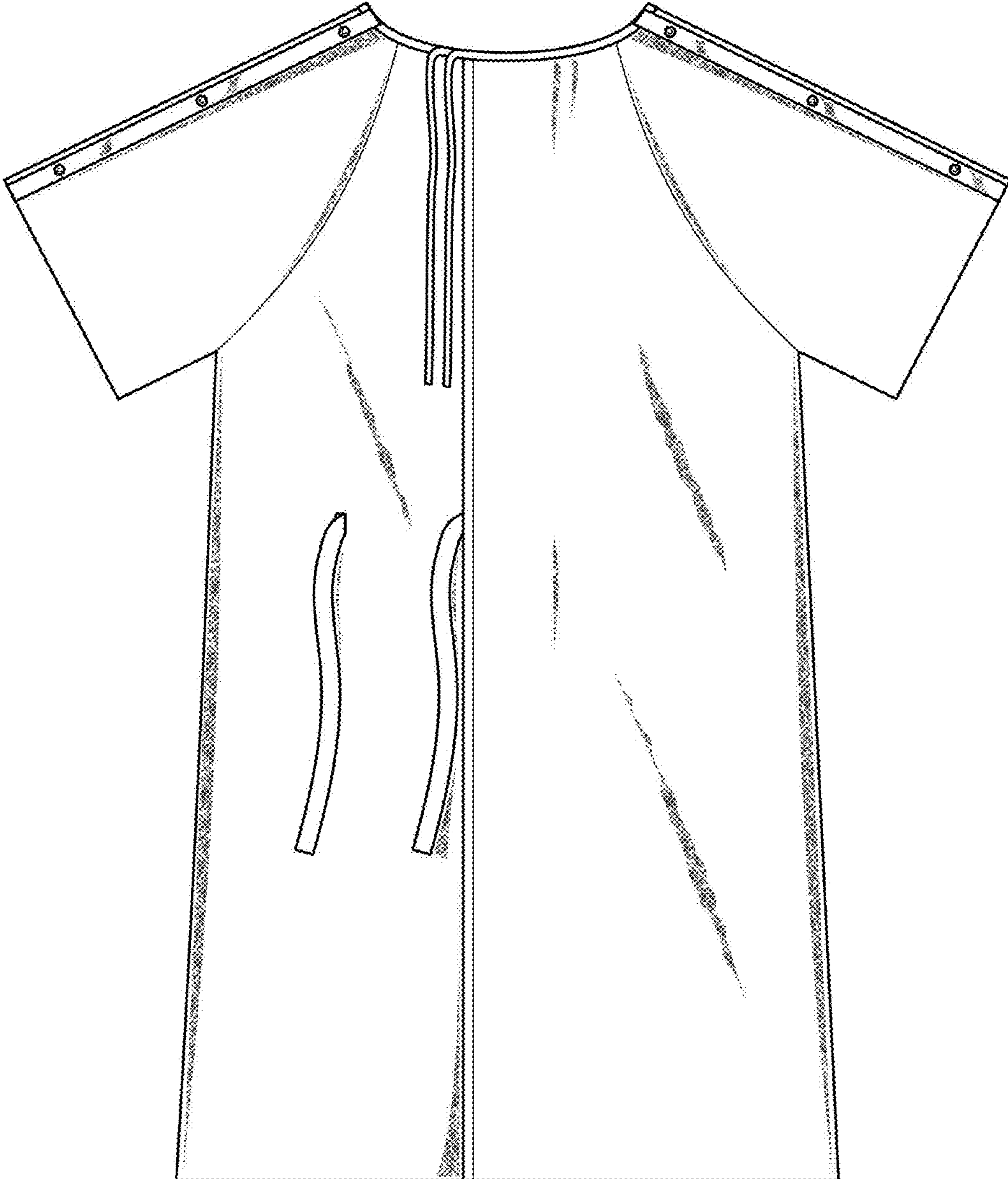

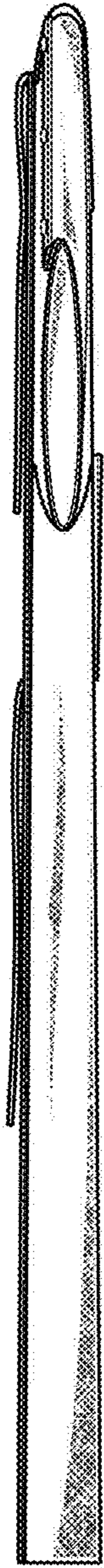

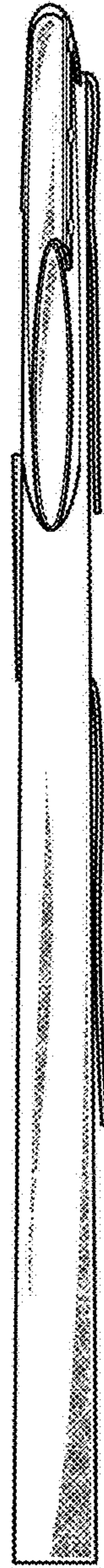

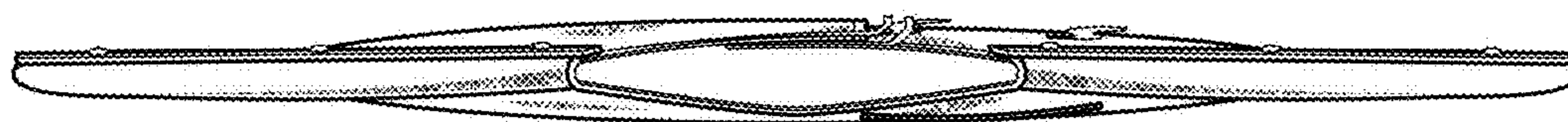
