(57) **CLAIM**

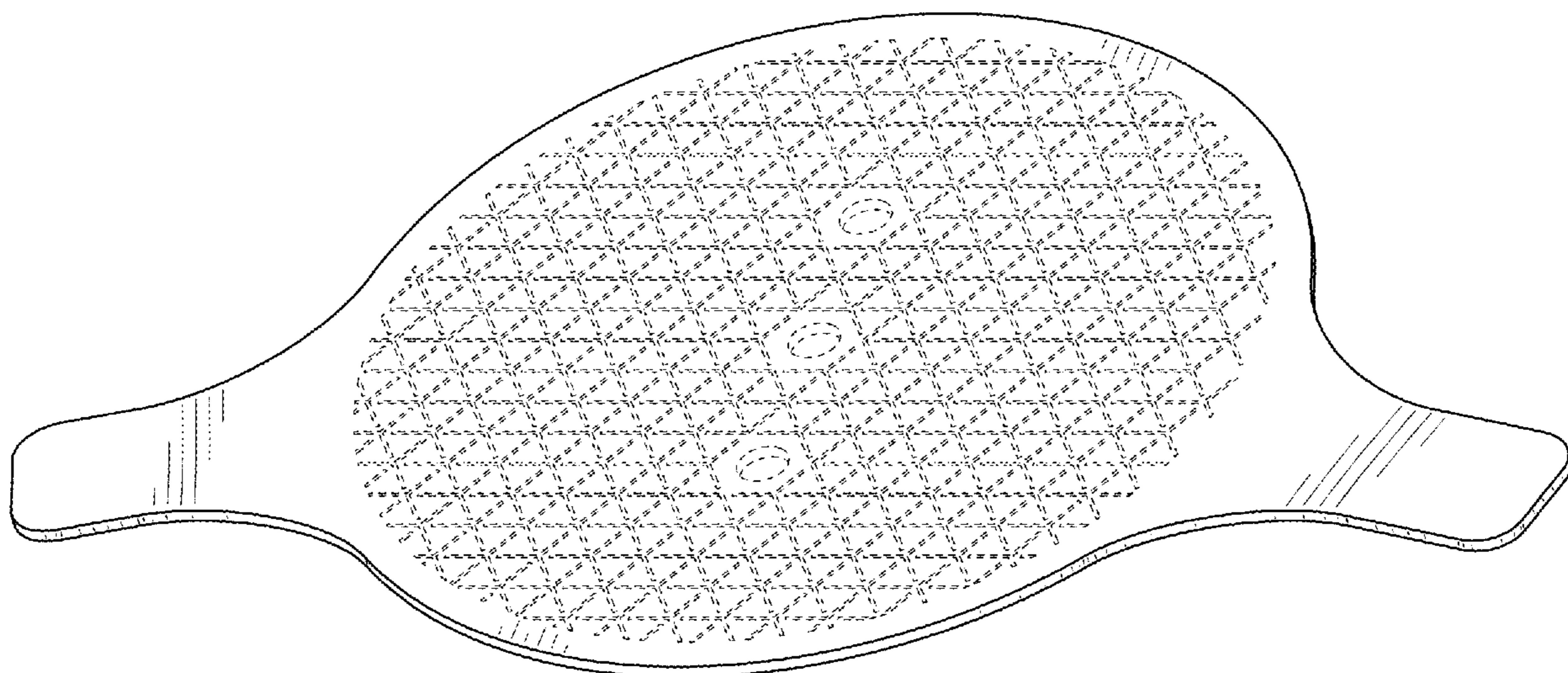
The ornamental design for a disposable head covering, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a disposable head covering. FIG. 2 is a perspective view of the disposable head covering of FIG. 1 as worn with the disposable head covering pulled over a user's head. FIG. 3 is a top view of the disposable head covering of FIG. 1. FIG. 4 is a bottom view of the disposable head covering of FIG. 1. FIG. 5 is a left side view of the disposable head covering of FIG. 1. FIG. 6 is a right side view of the disposable head covering of FIG. 1. FIG. 7 is a front view of the disposable head covering of FIG. 1; and, FIG. 8 is a rear view of the disposable head covering of FIG. 1. In FIG. 2 the disposable head covering is illustrated as being stretched over a user's head. The broken lines along the disposable head covering and the areas within the broken lines define features of the disposable head covering that form no part of the claimed design. The partial human figure outlined by broken lines in FIG. 2 assists to illustrate how the disposable head covering may appear when worn and forms no part of the claimed design.

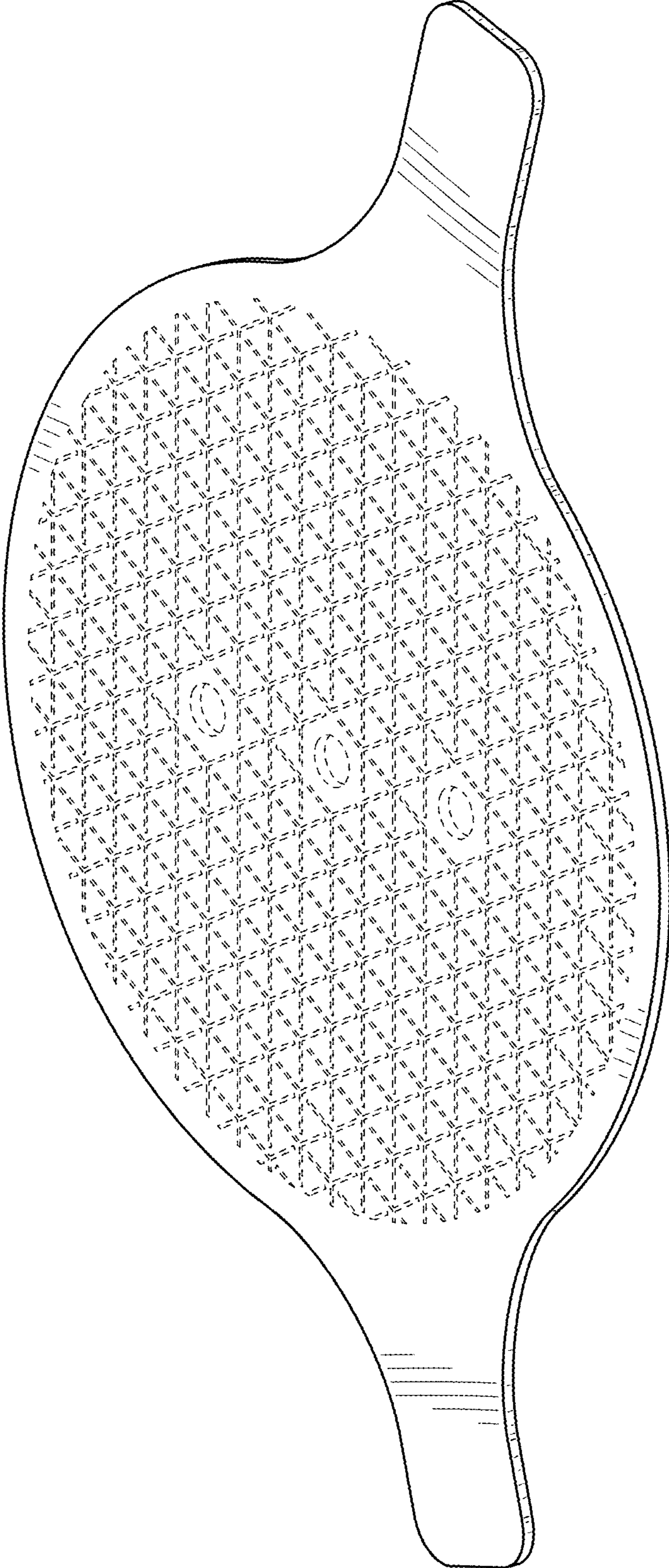

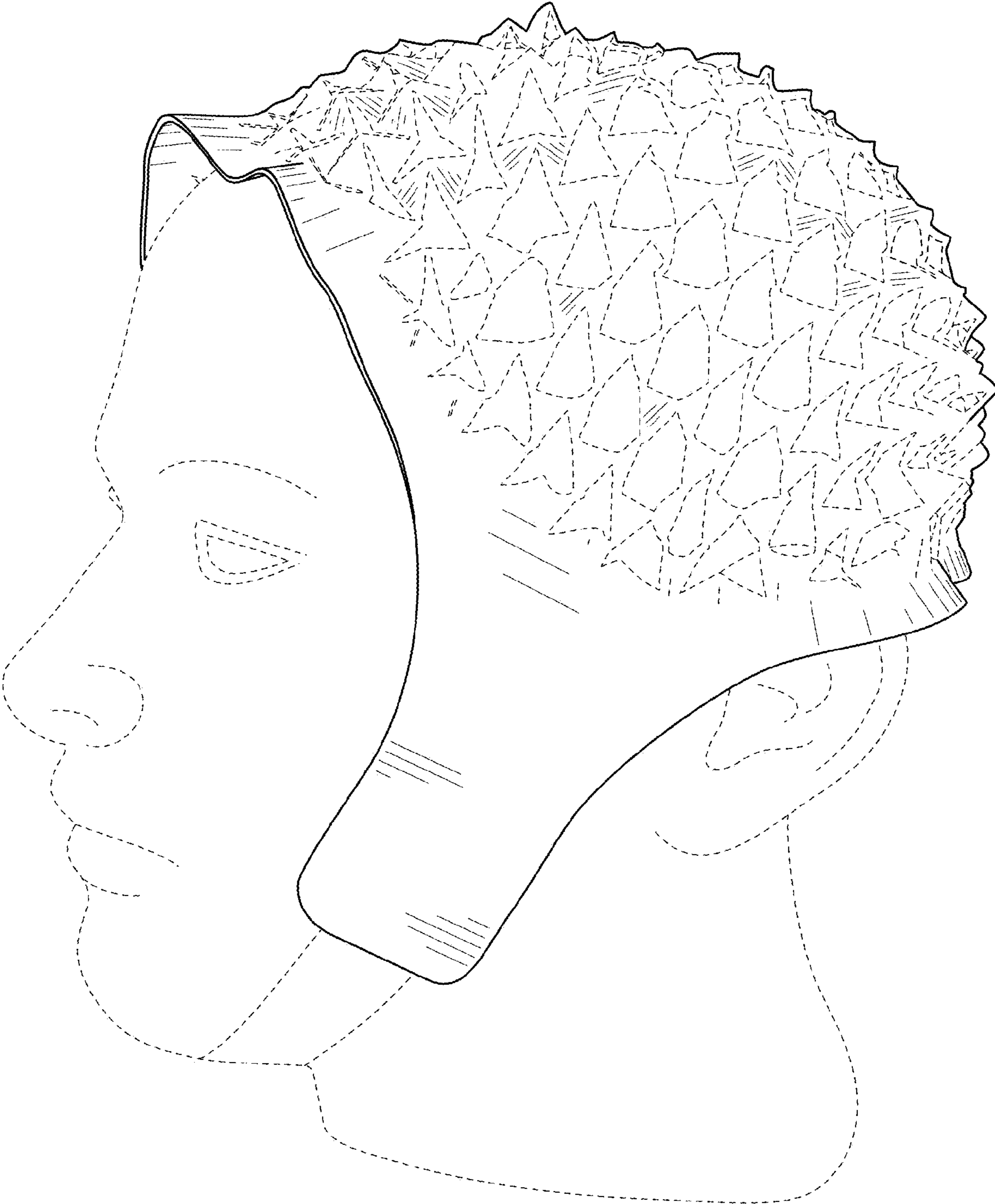

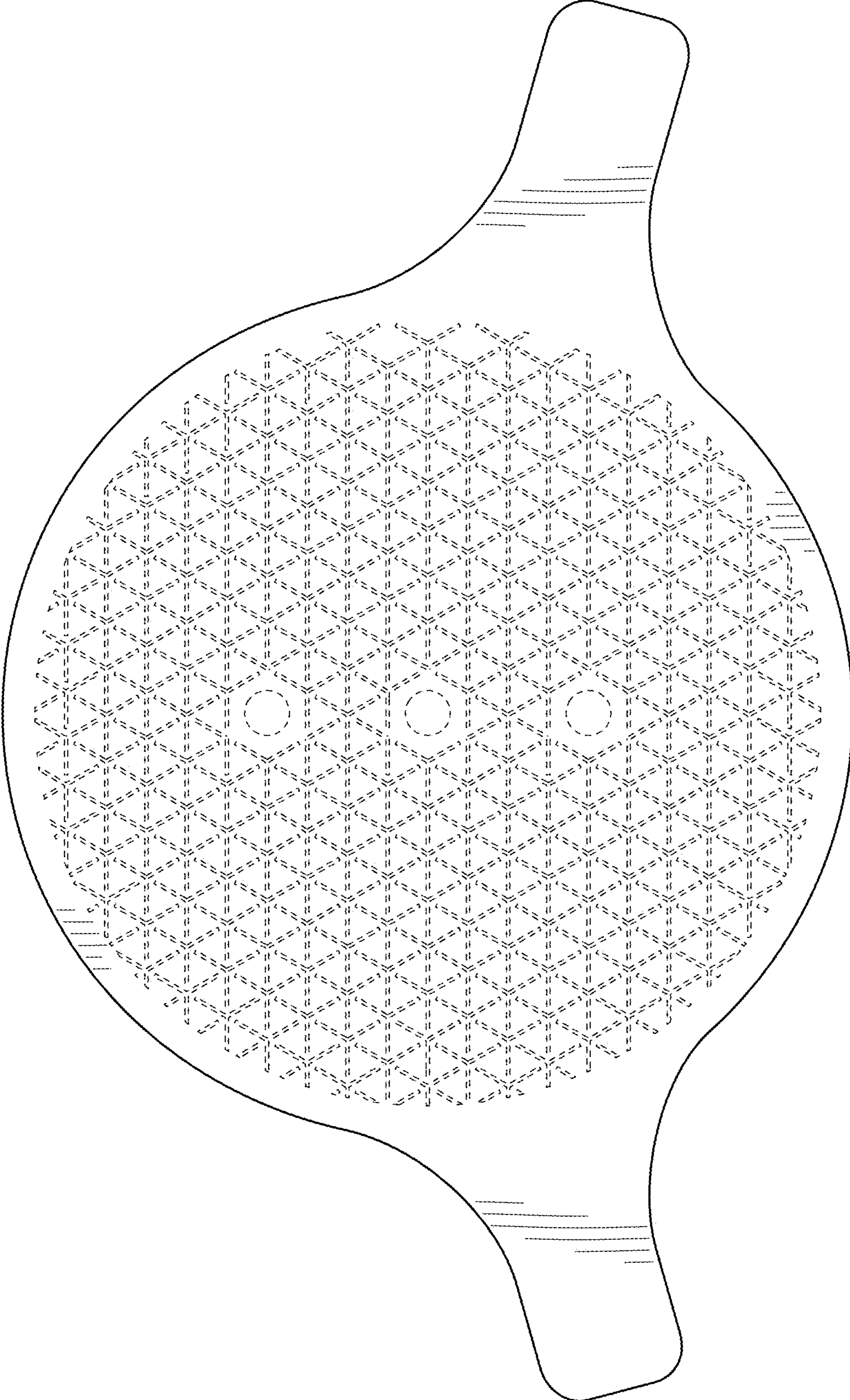

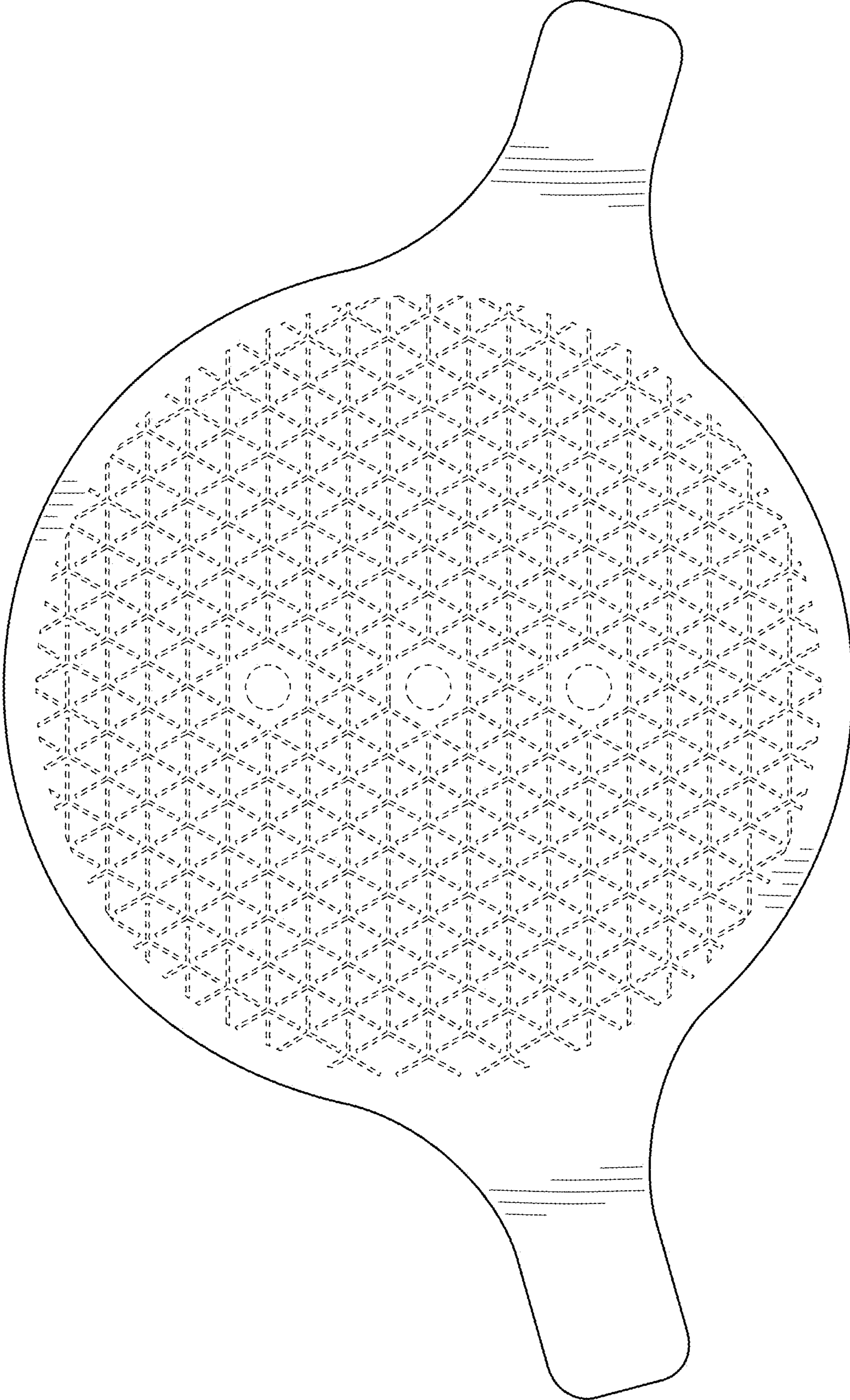

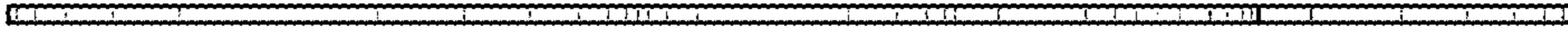

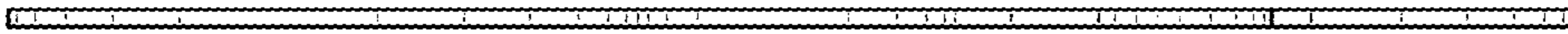
