The ornamental design for a pair of sandals, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a right sandal of the pair of sandals;
FIG. 2 is a right side view of the right sandal of the pair of sandals;
FIG. 3 is a left side view of the right sandal of the pair of sandals;
FIG. 4 is a perspective view of a left sandal of the pair of sandals;

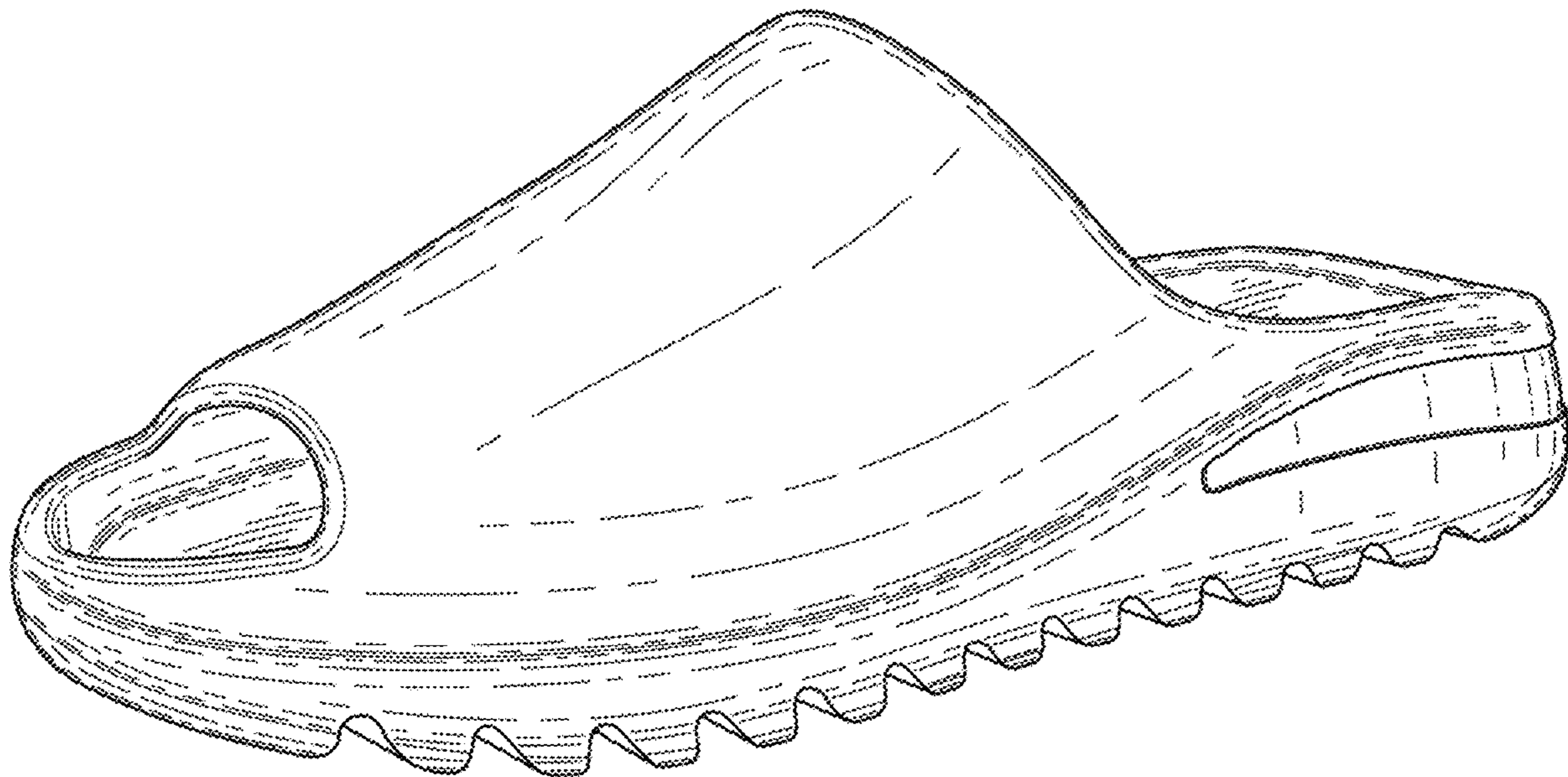

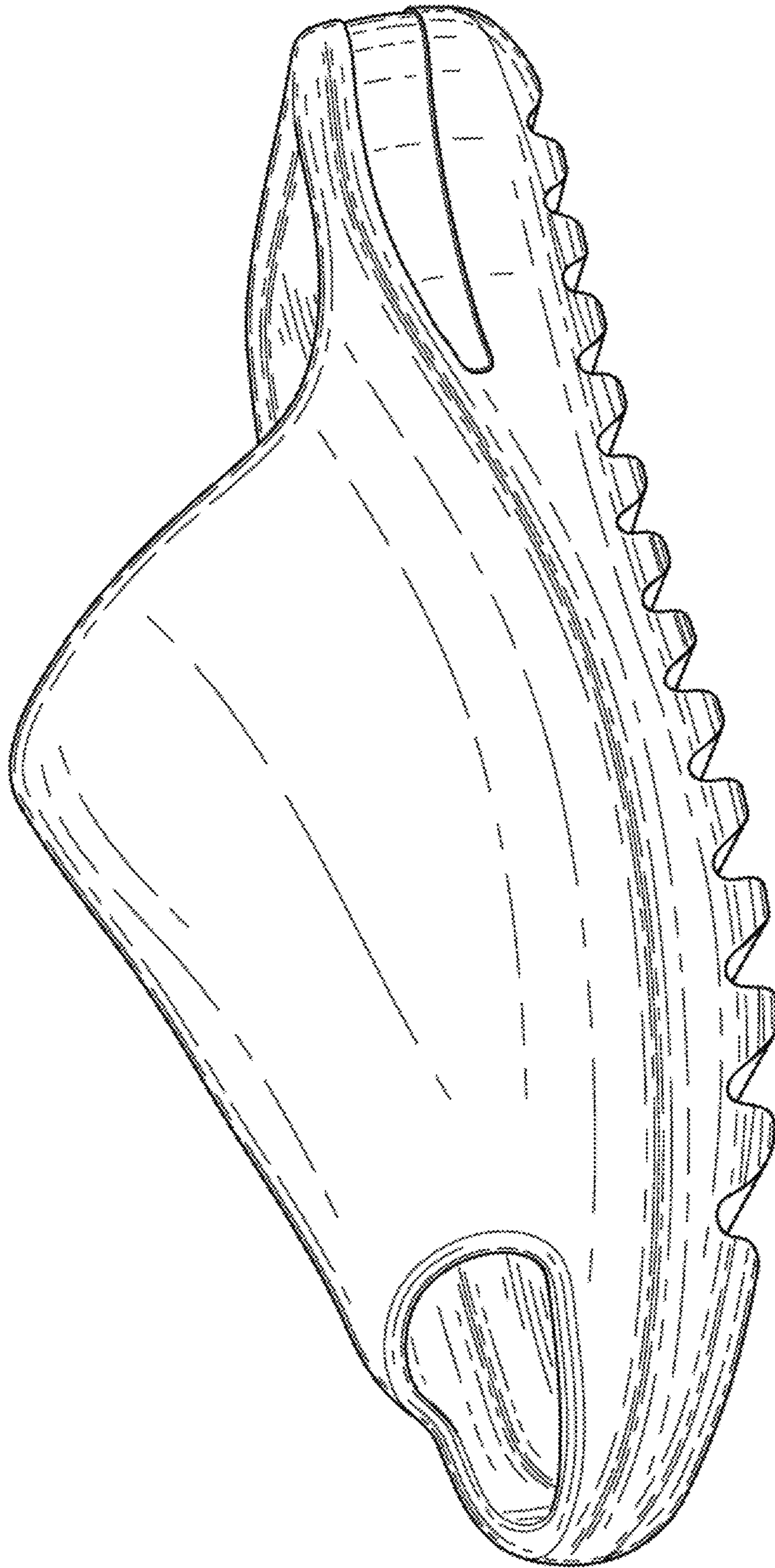

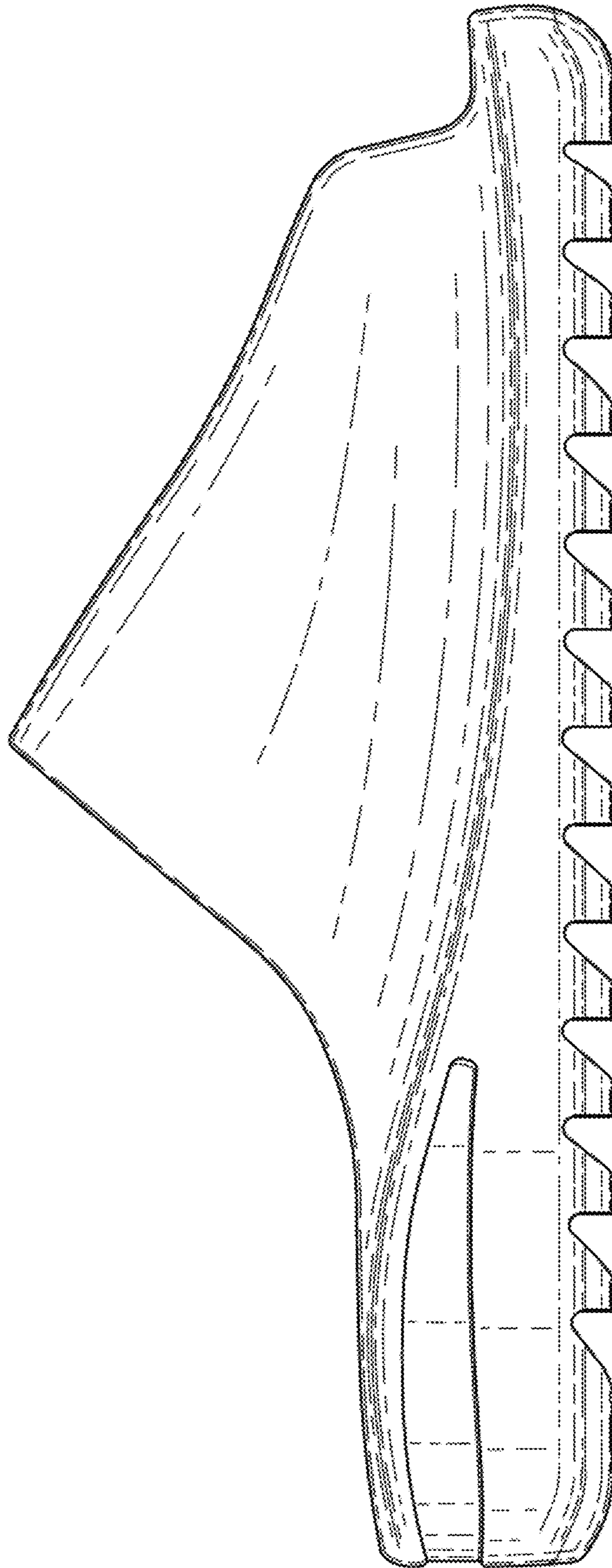

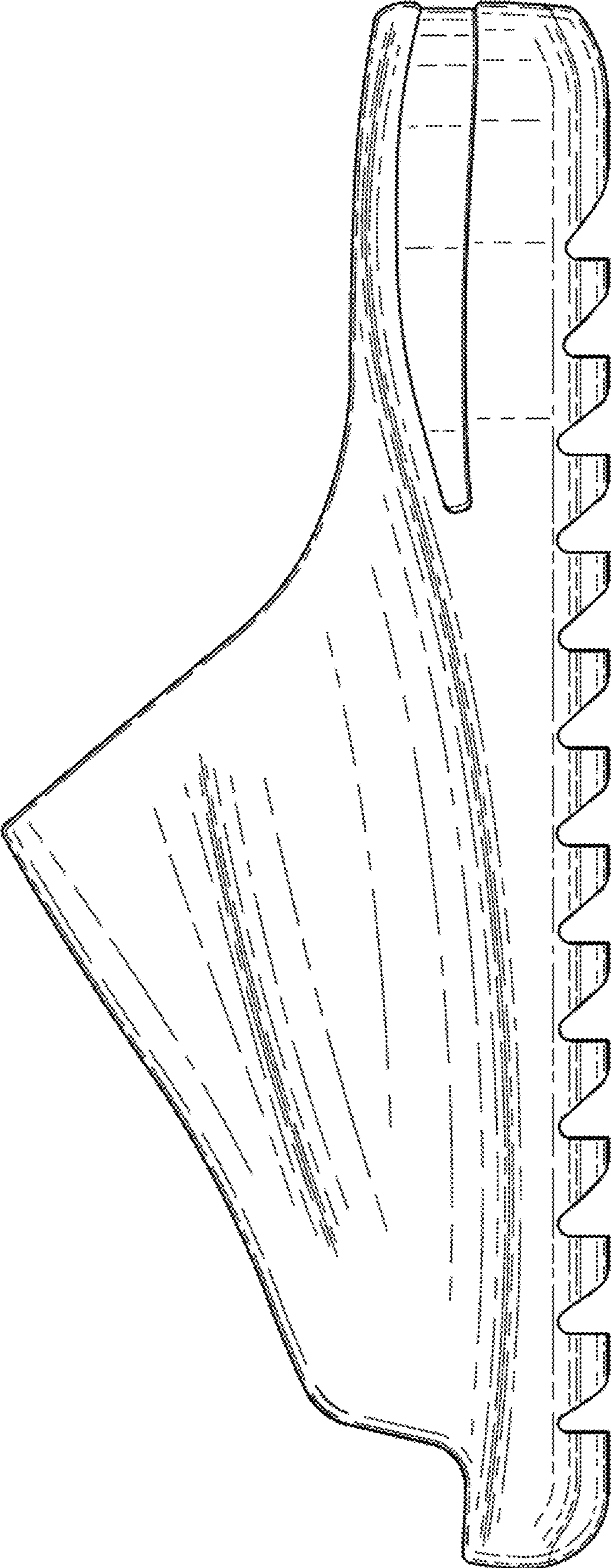

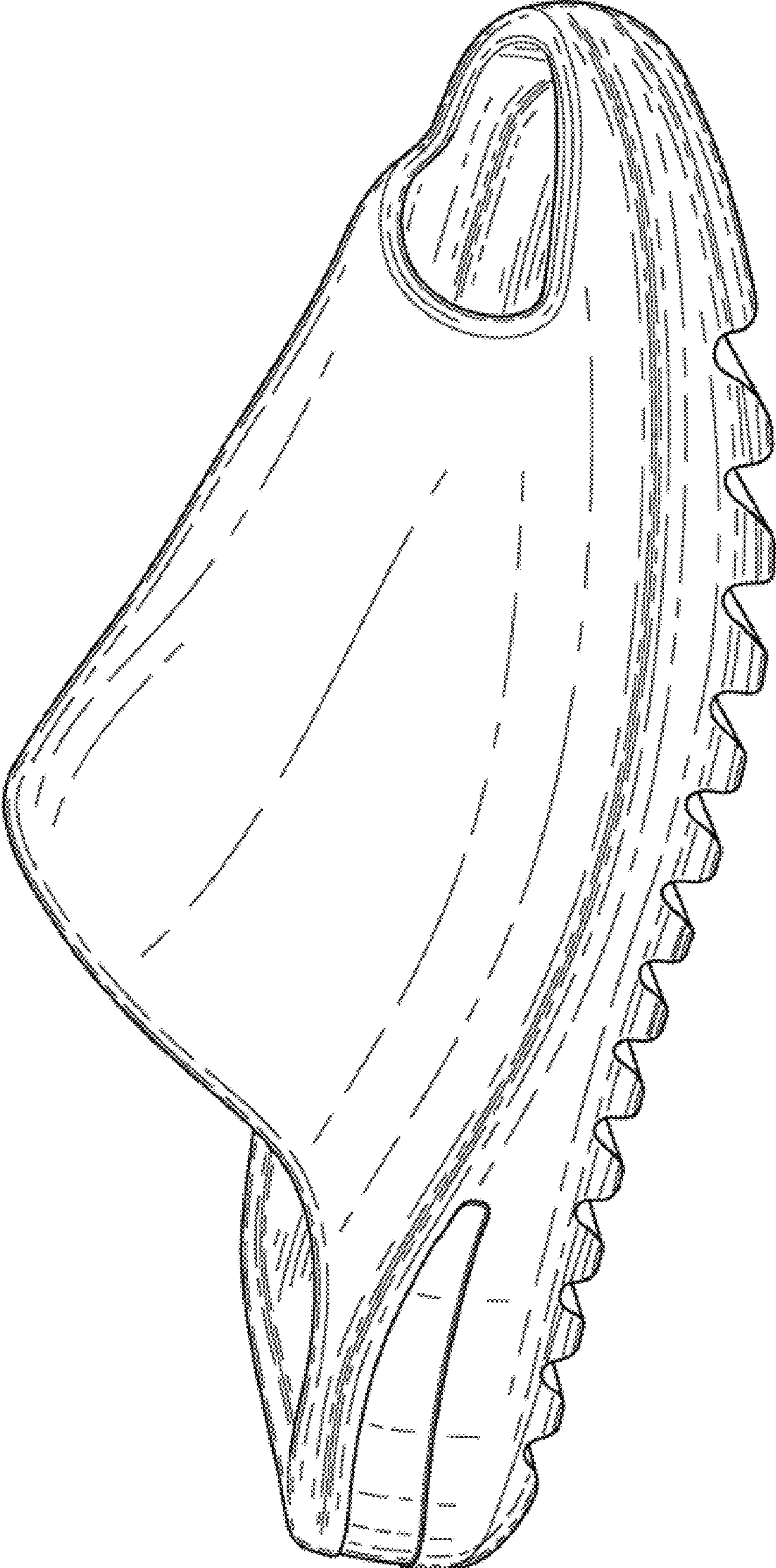

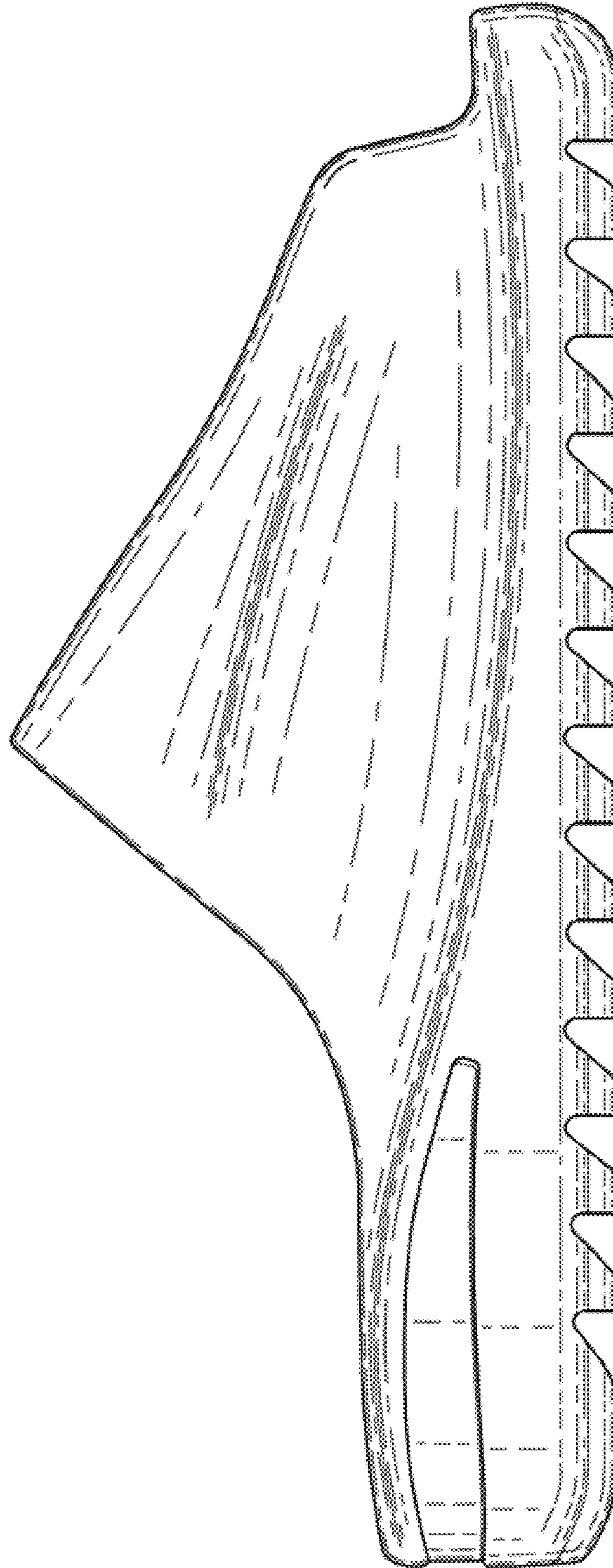
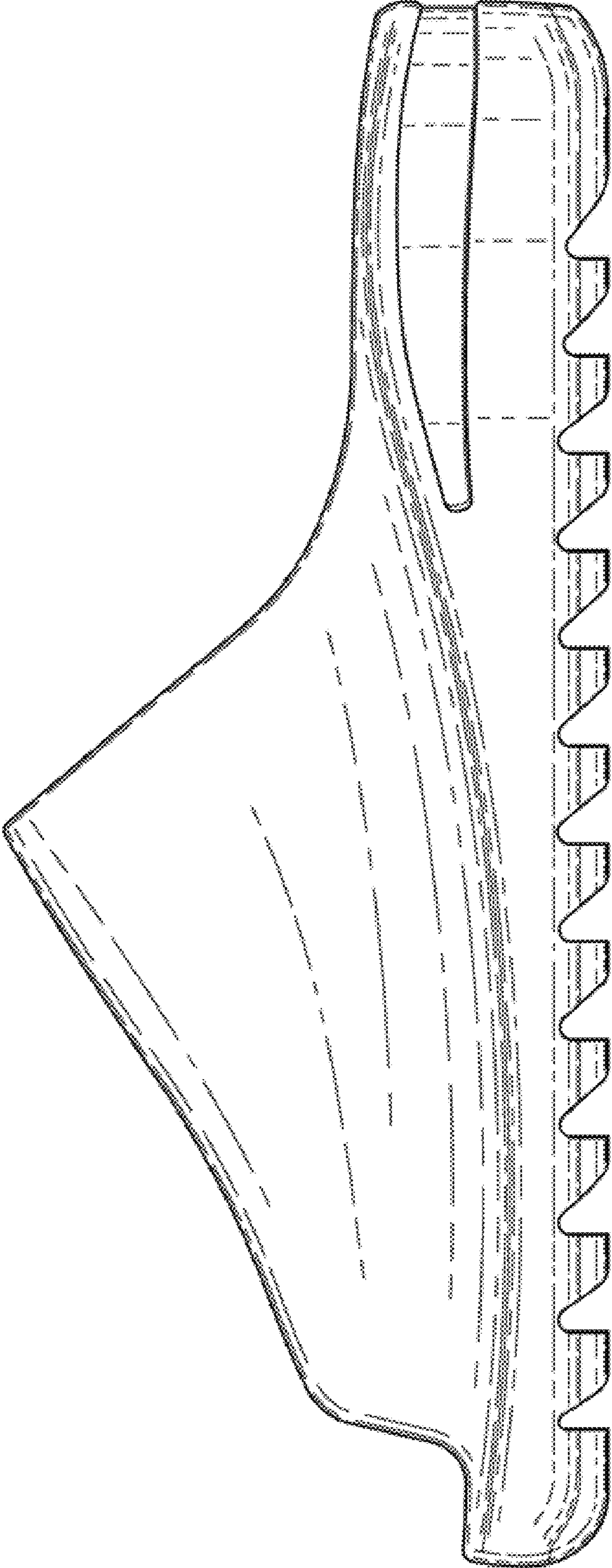

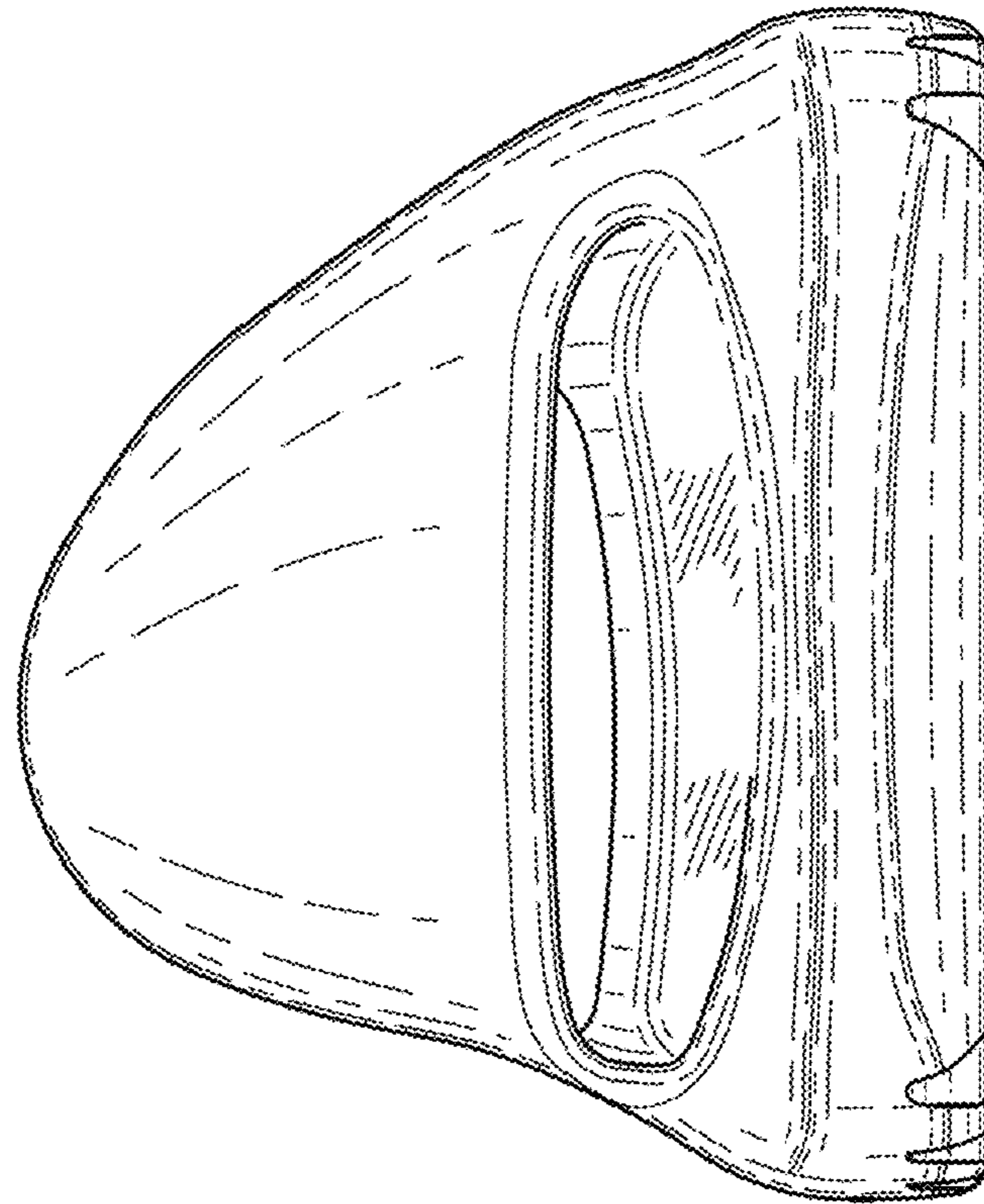
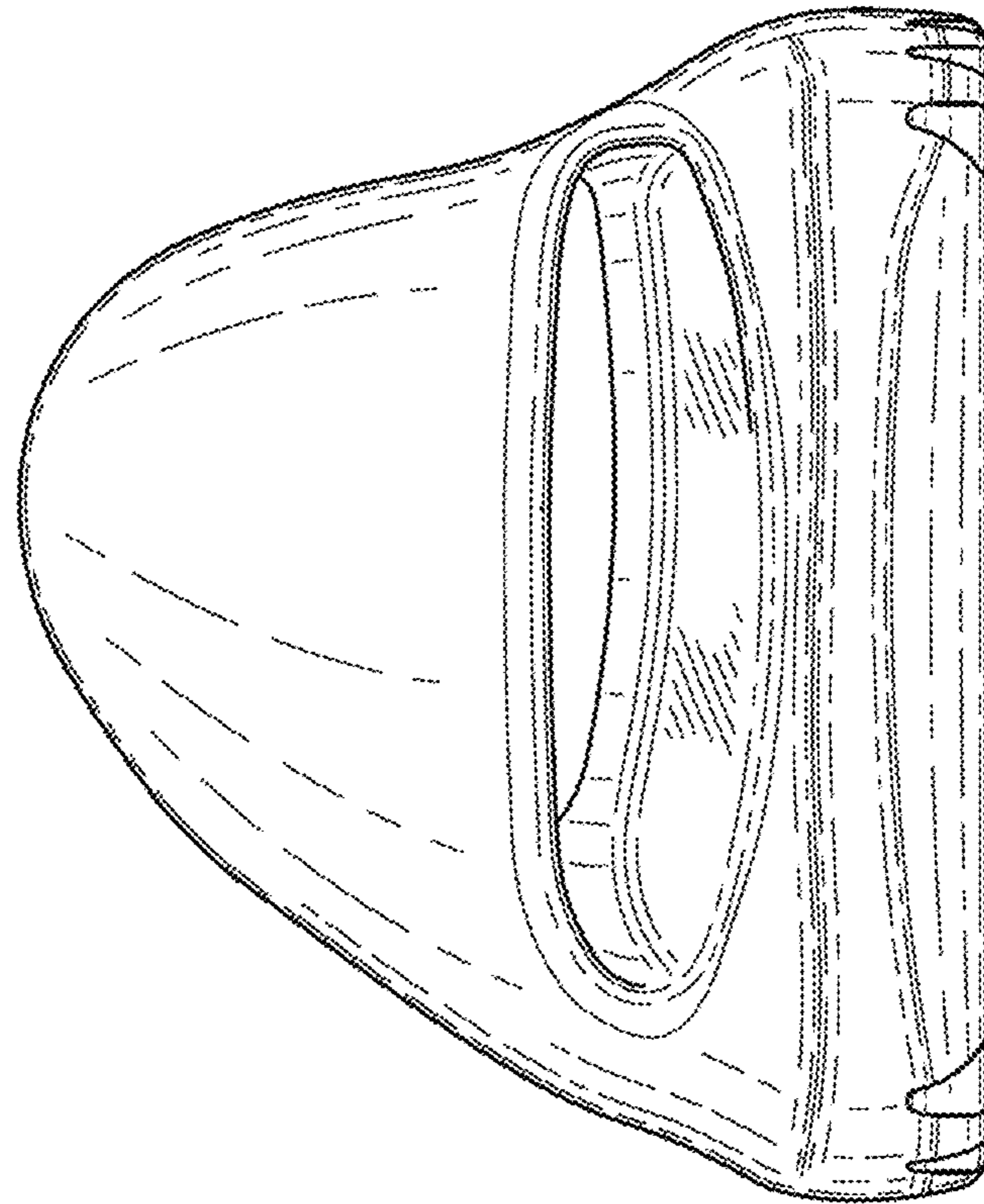

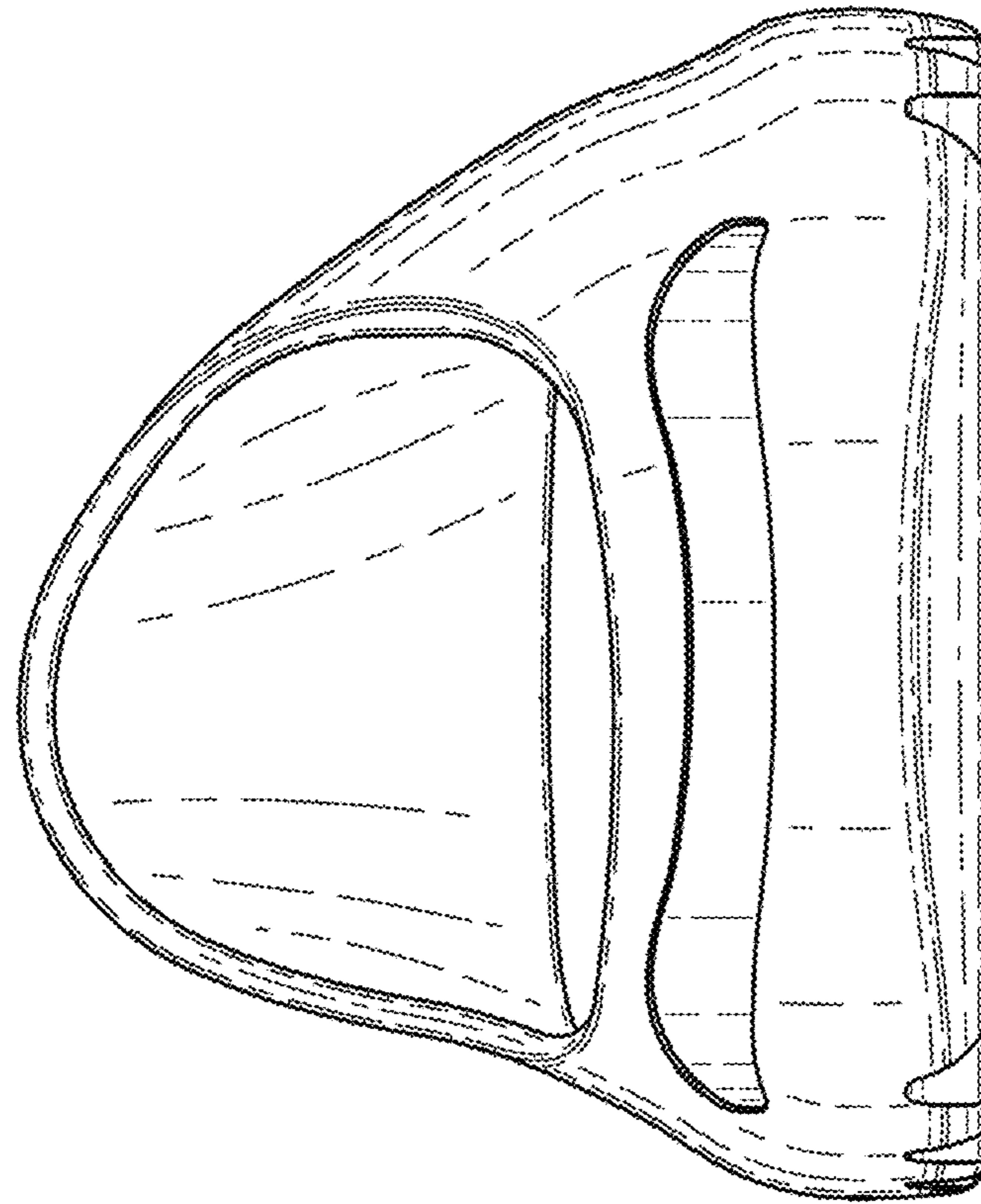
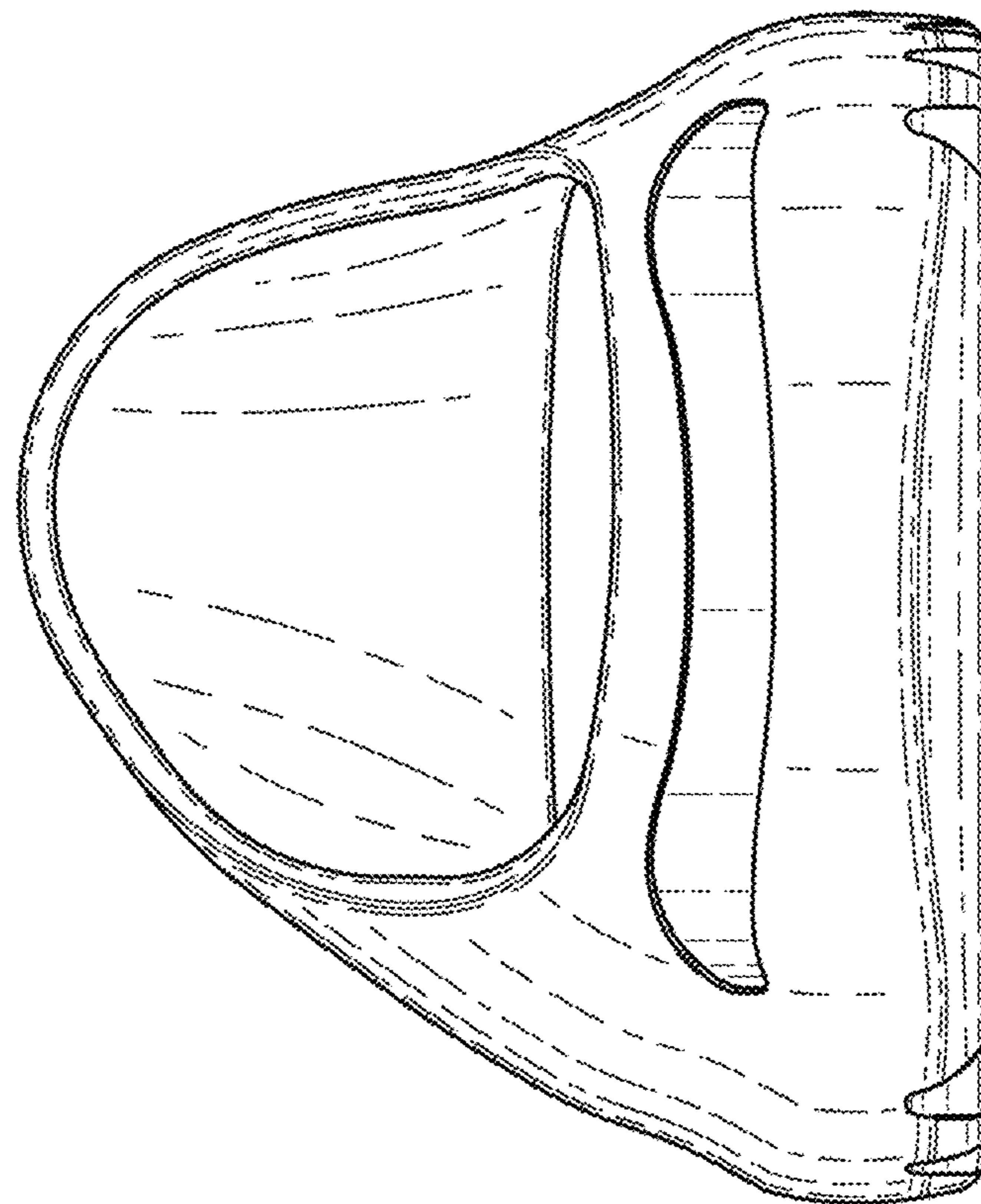

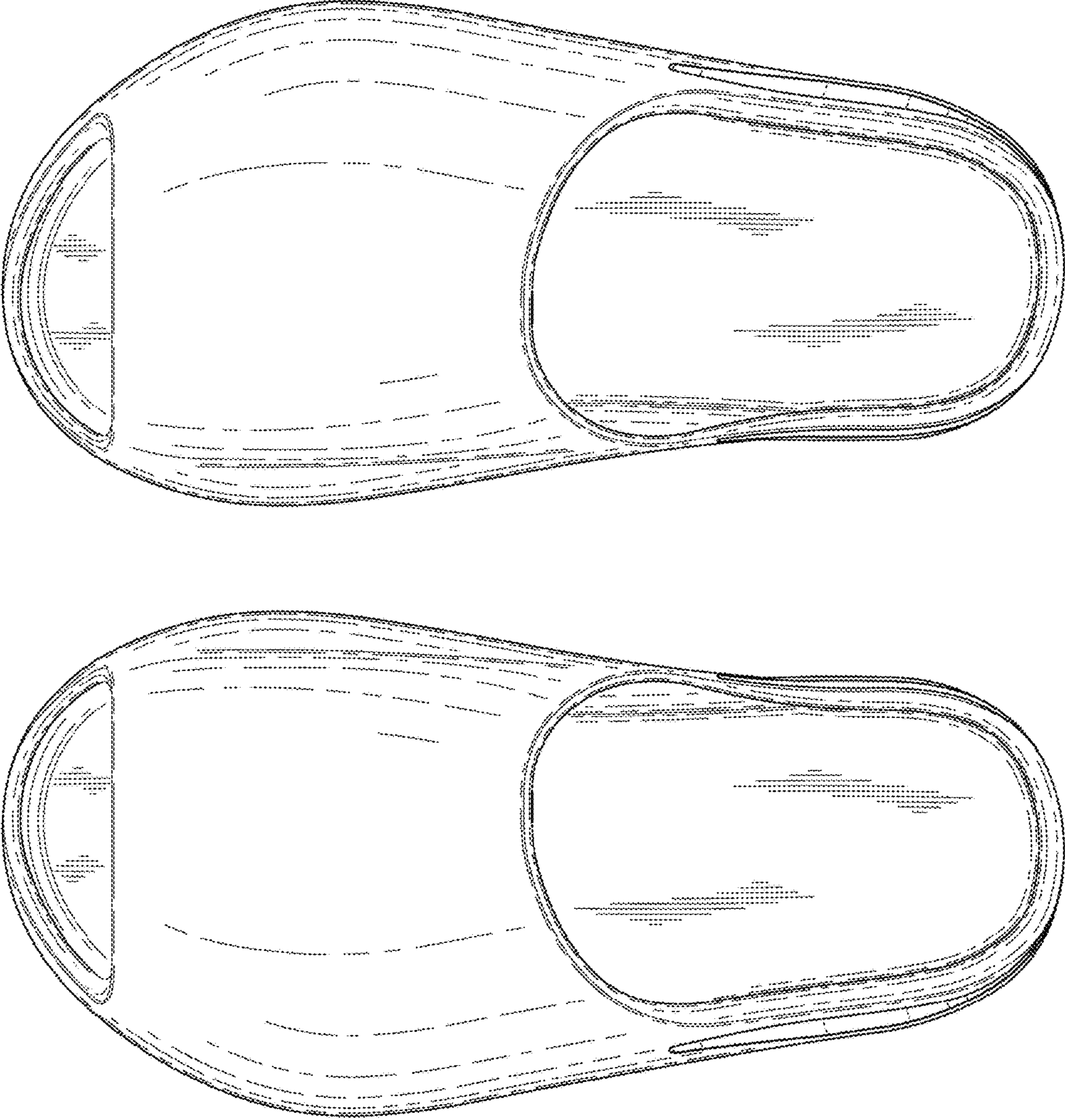

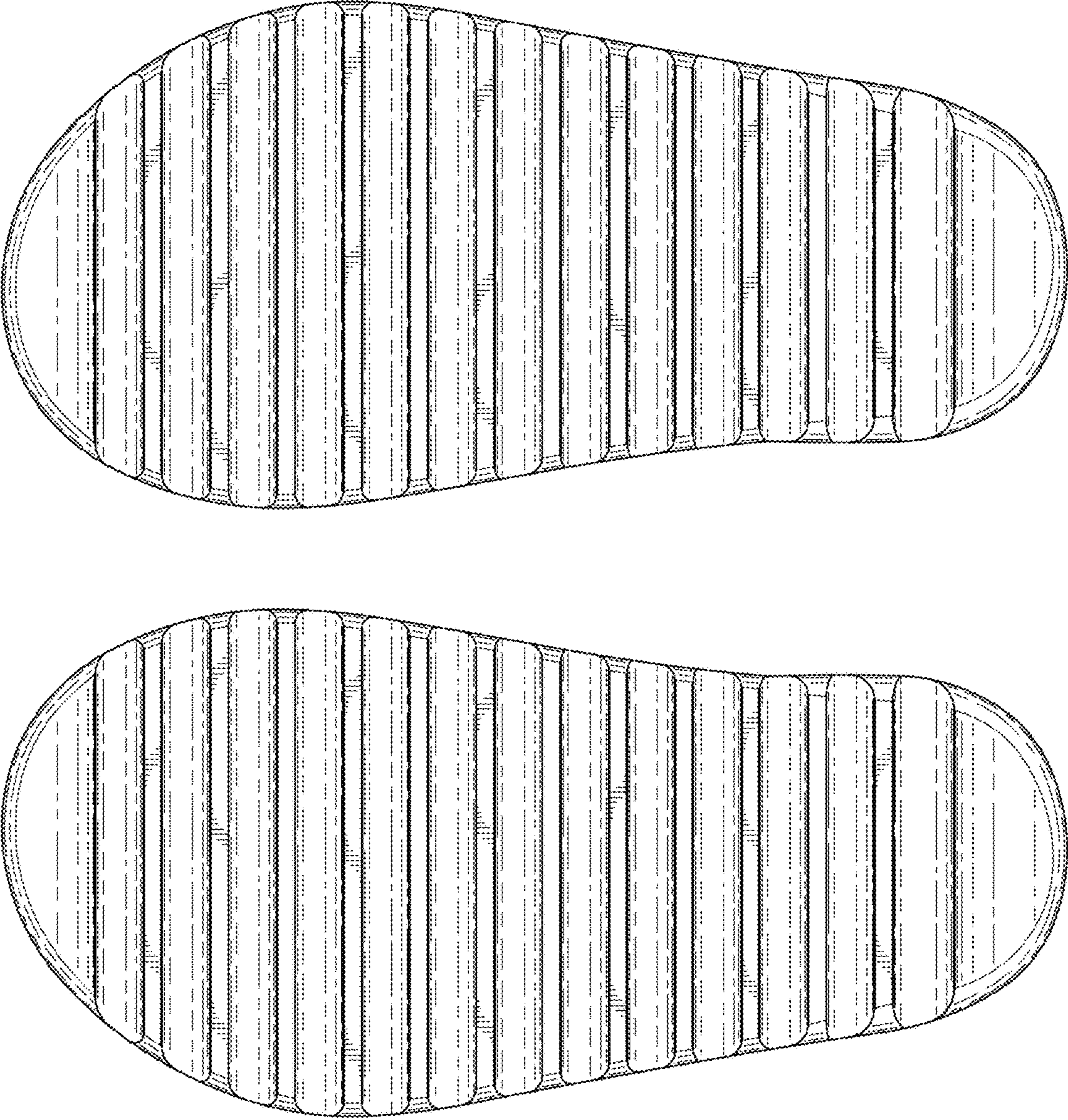
