(57) **CLAIM**

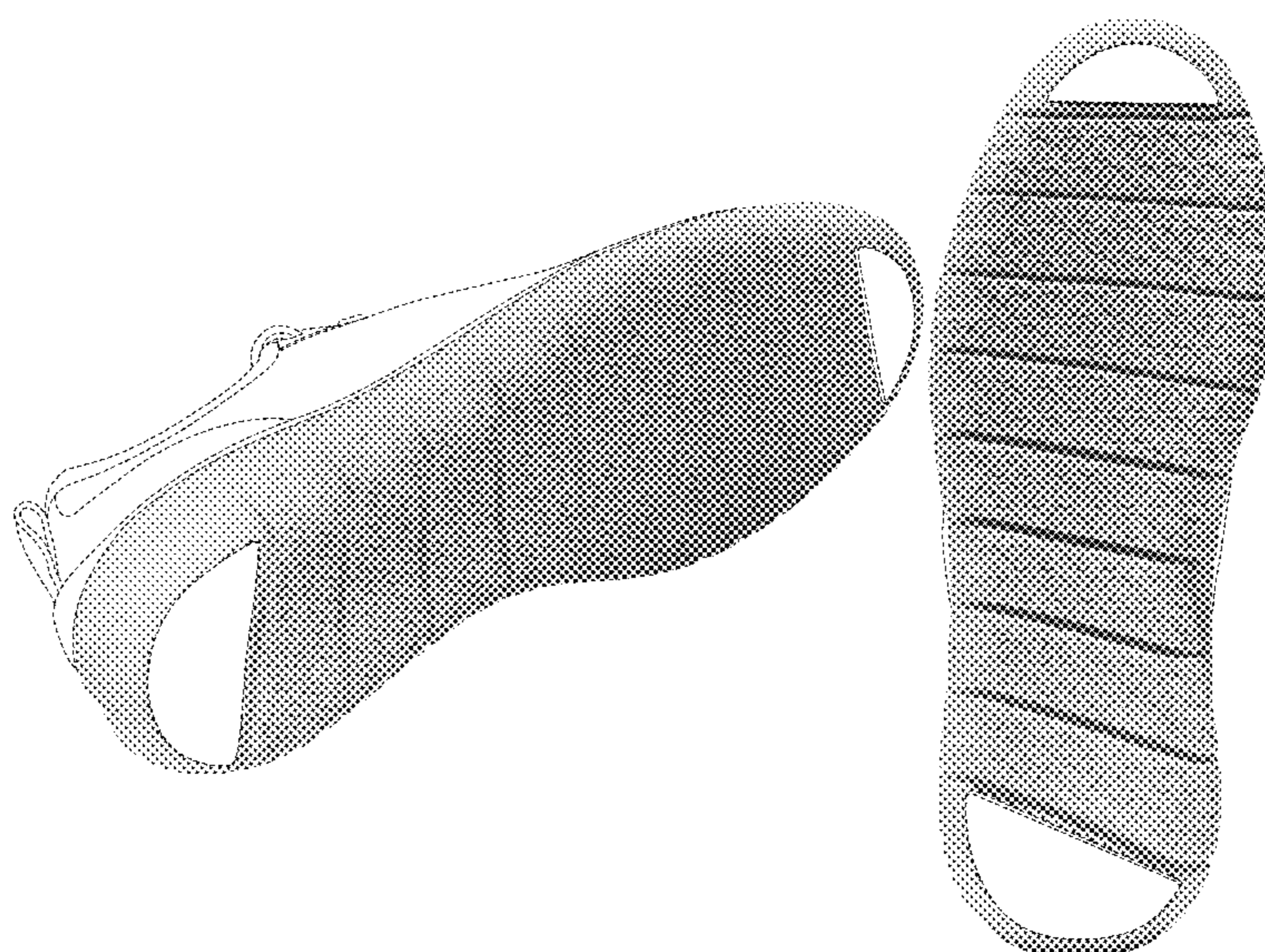
The ornamental design for a shoe sole, as shown and described.

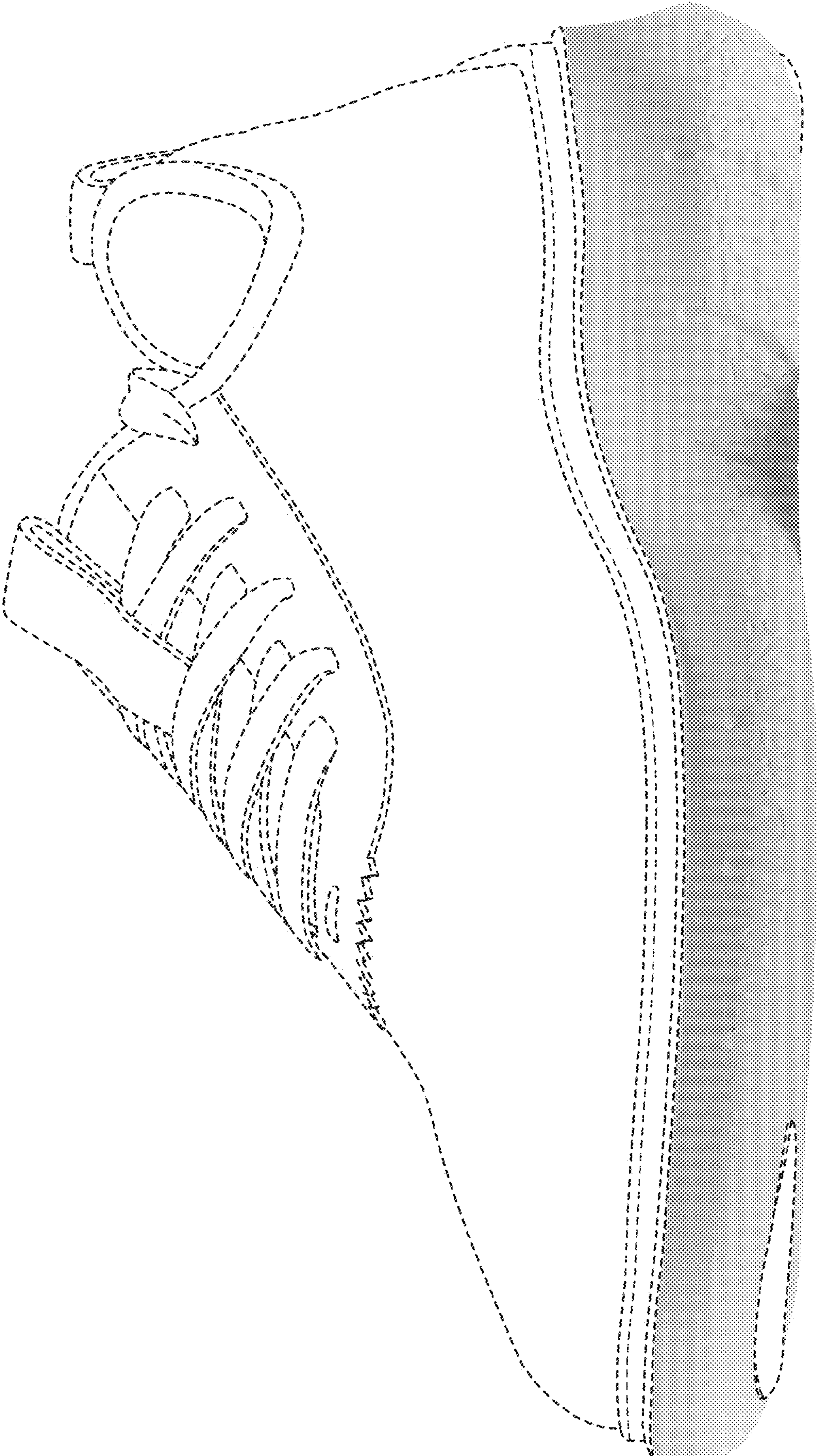

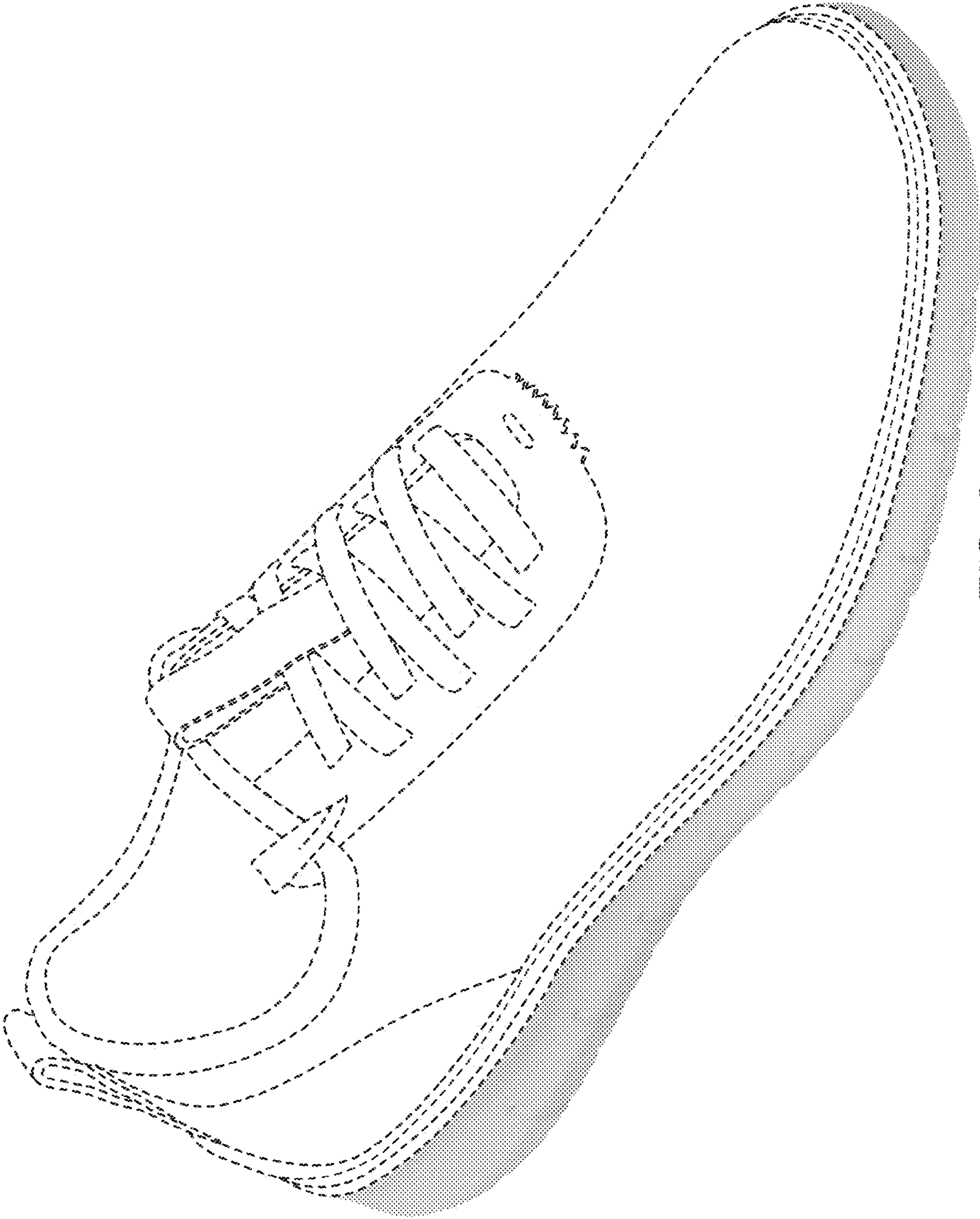

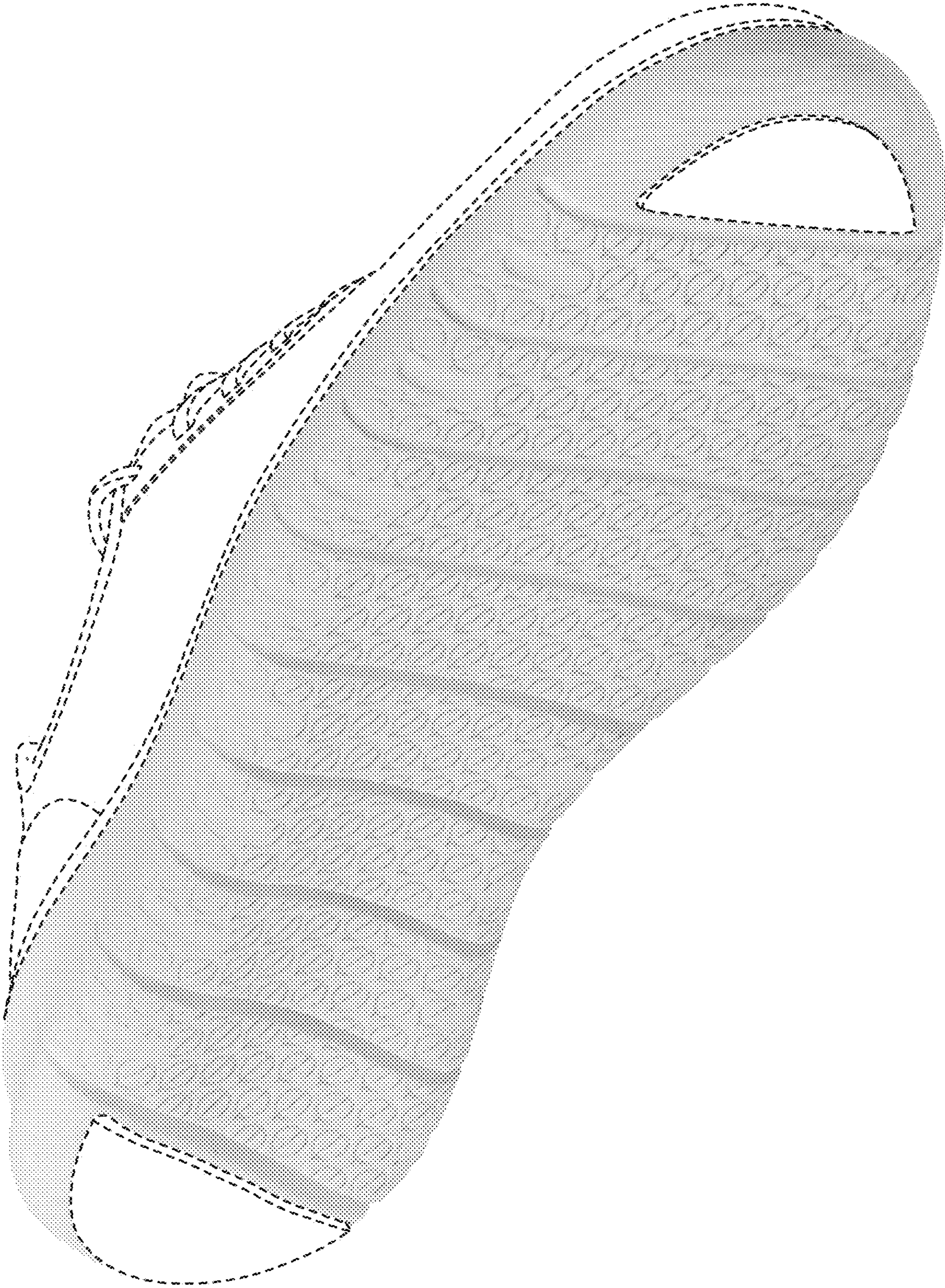

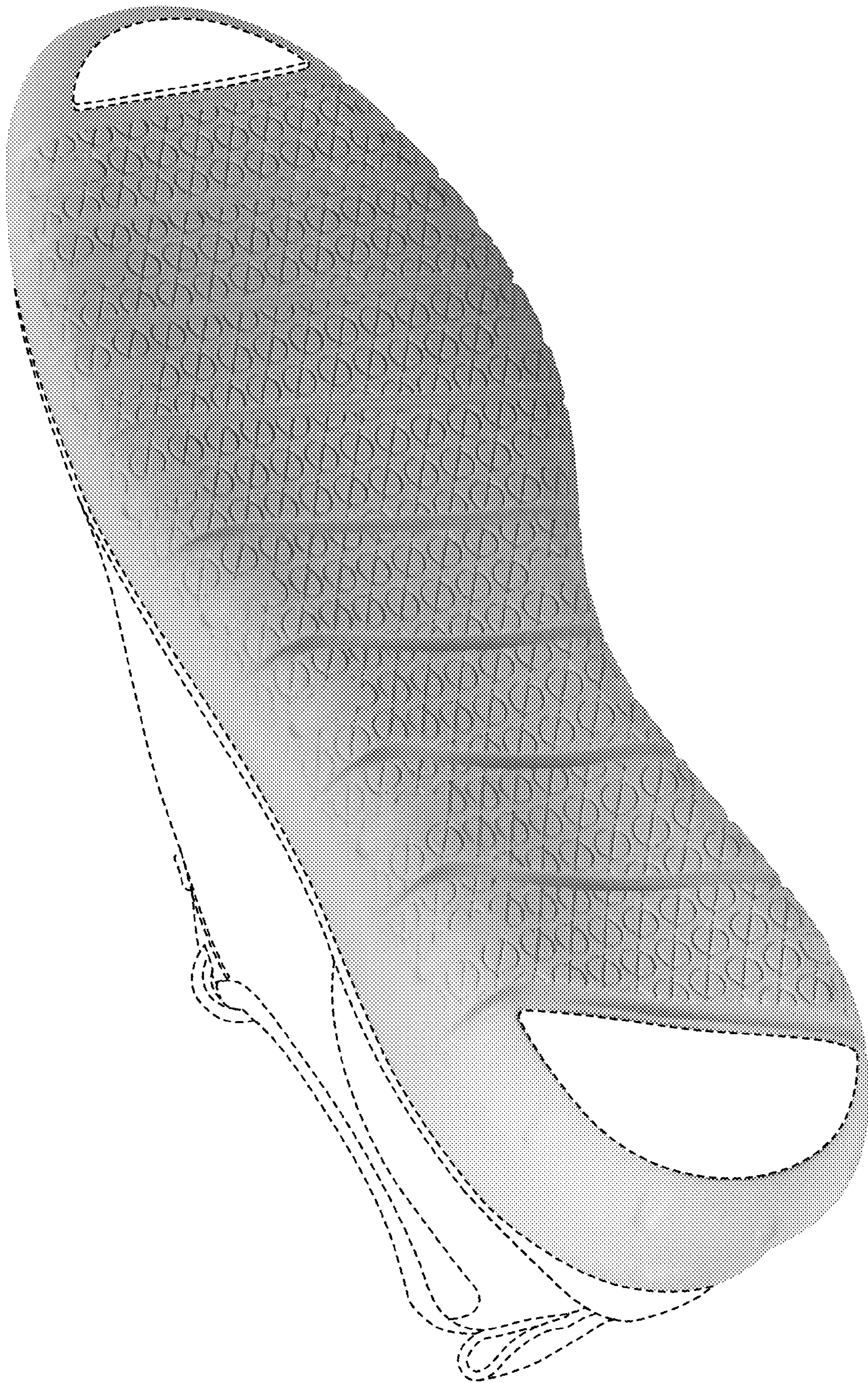

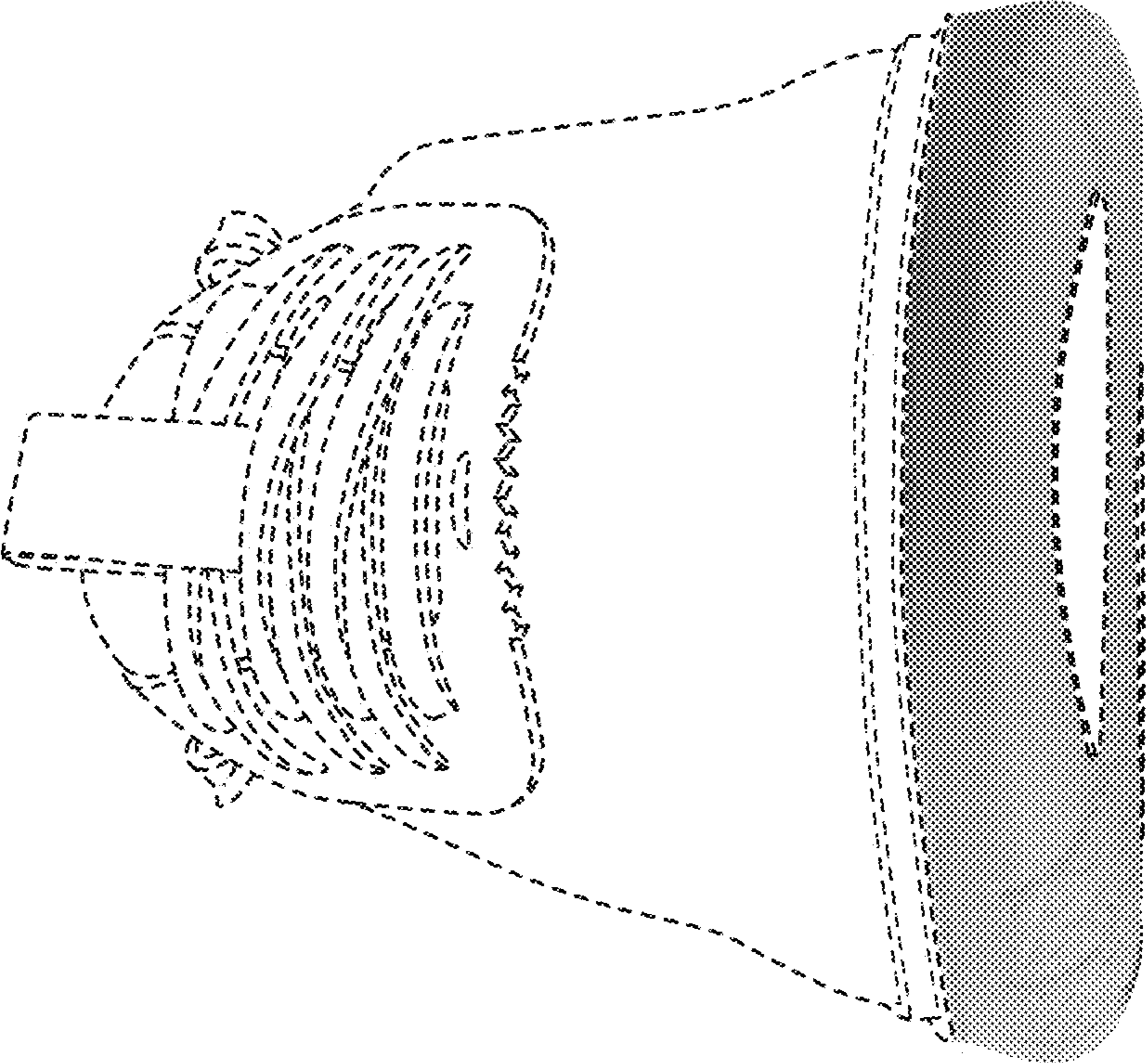

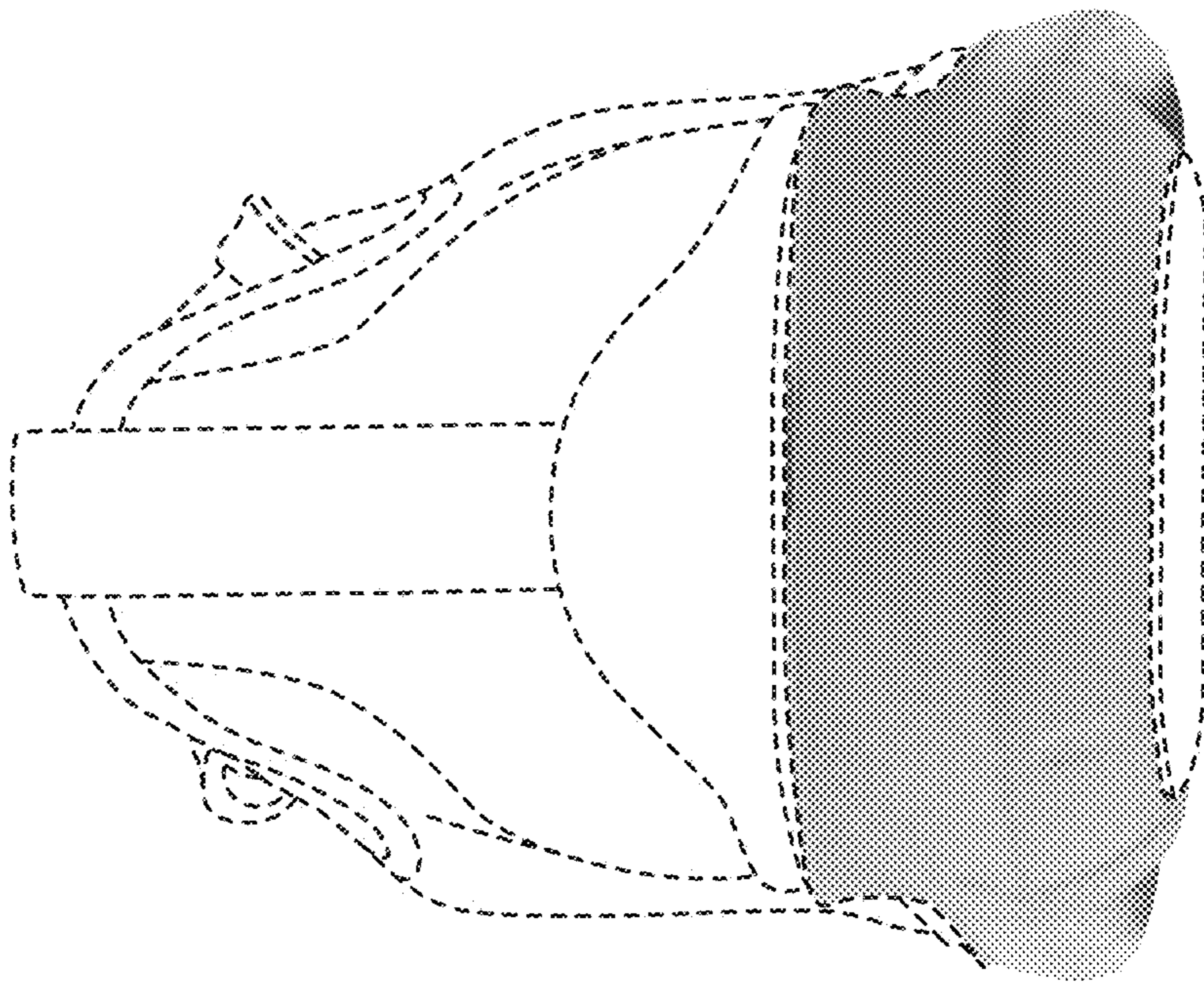

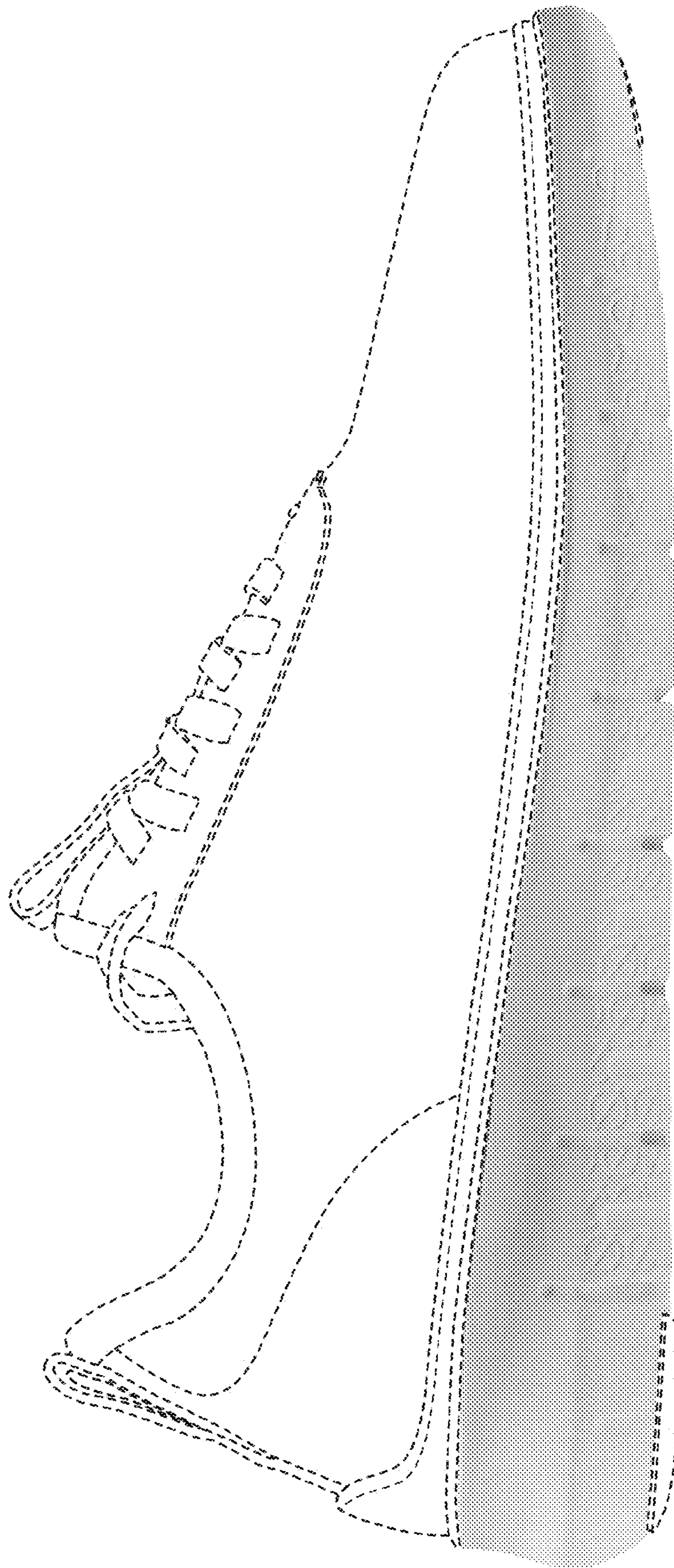

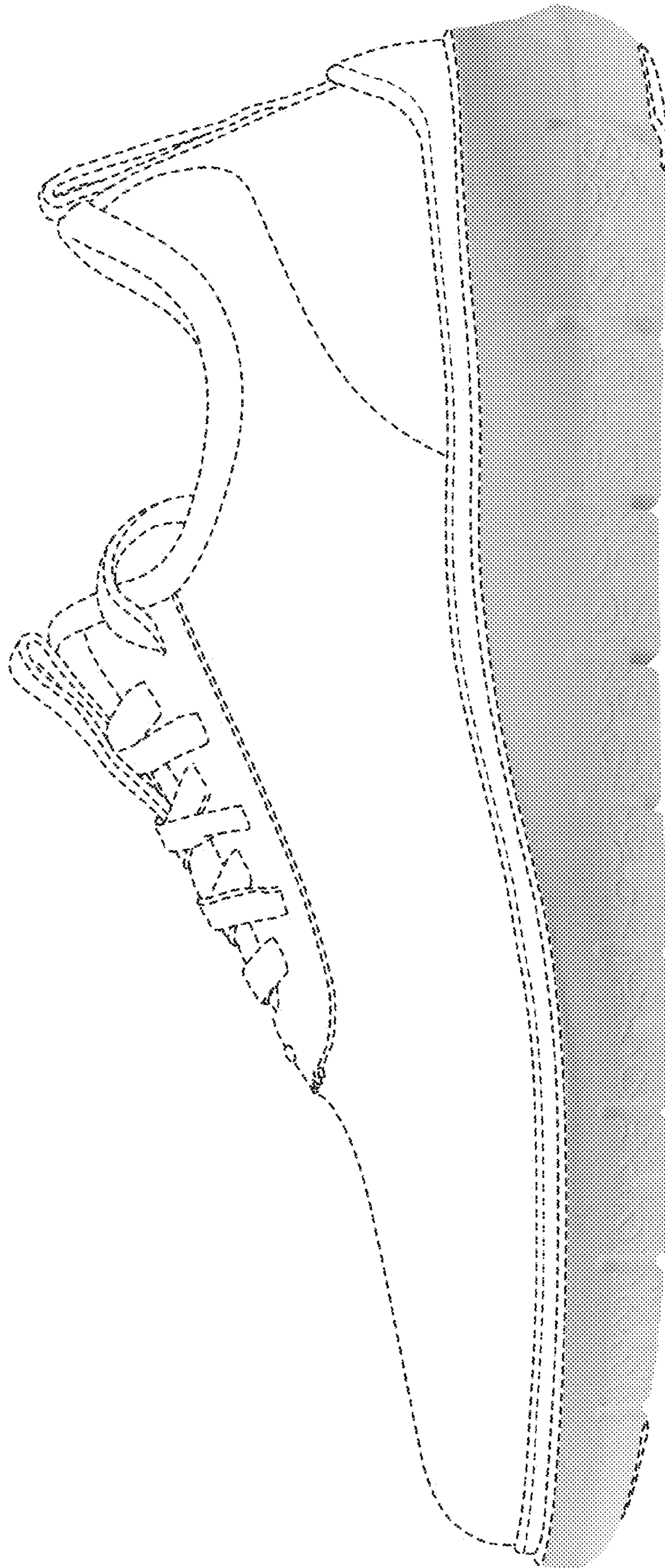

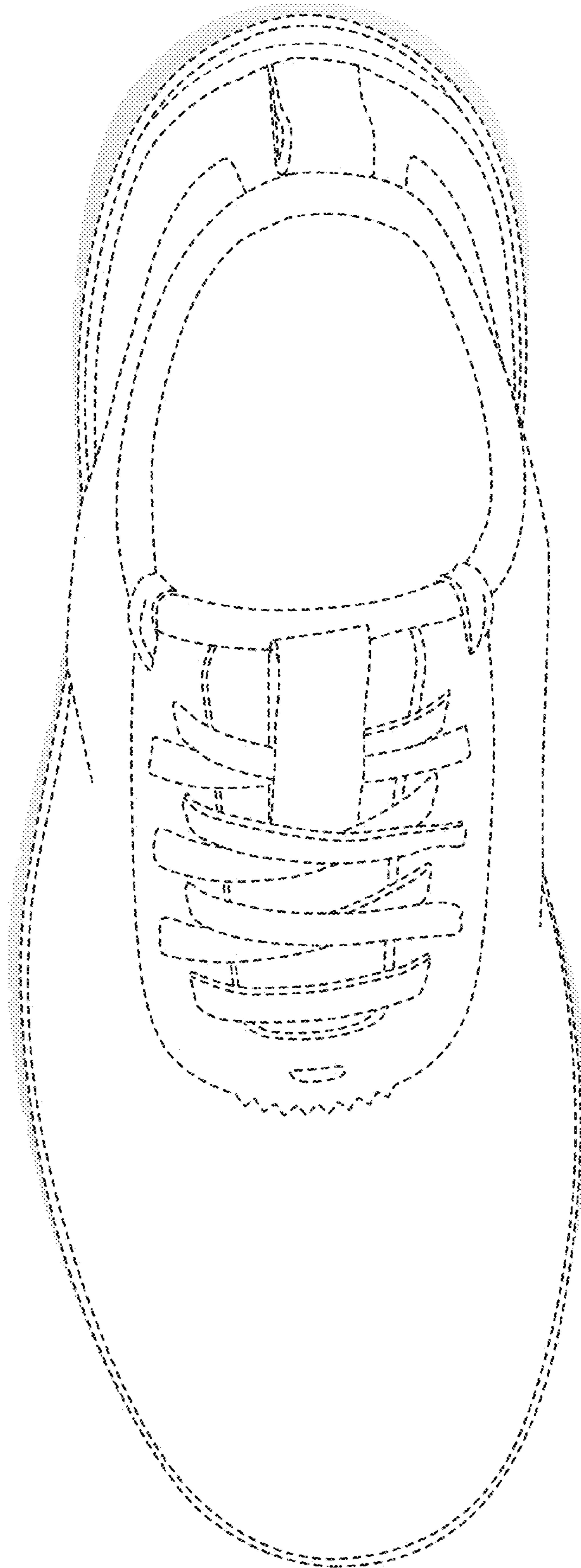

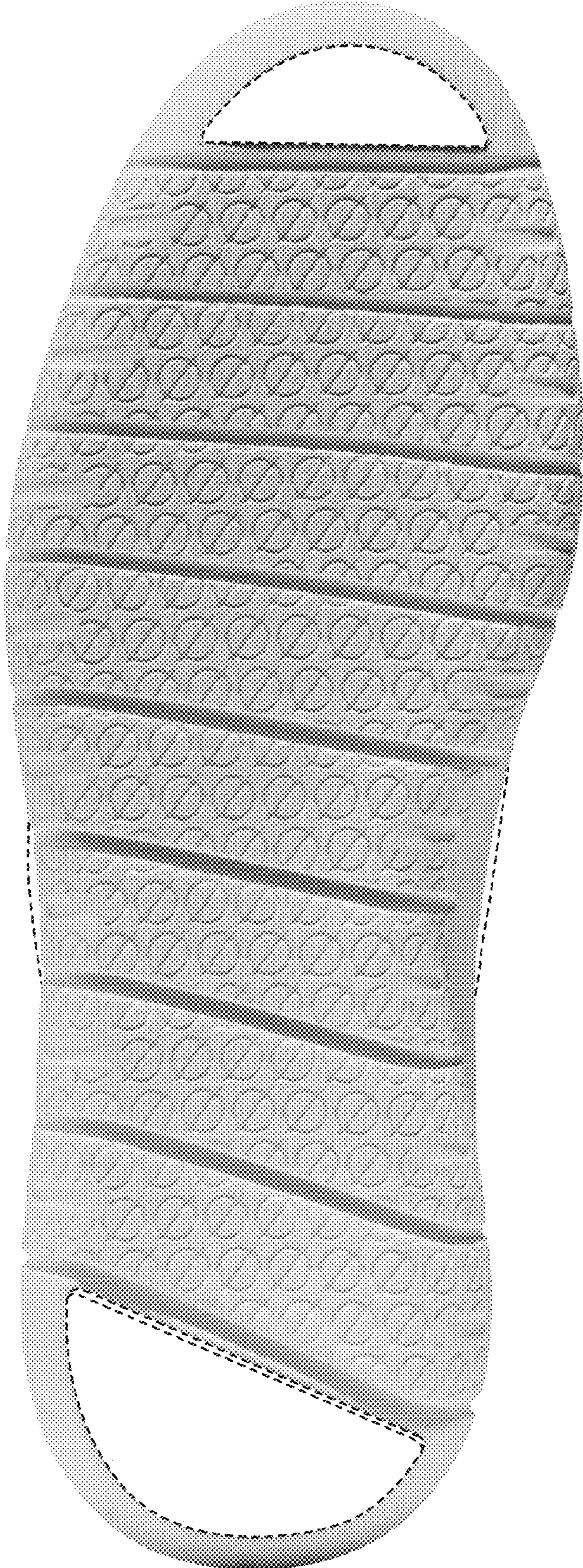
