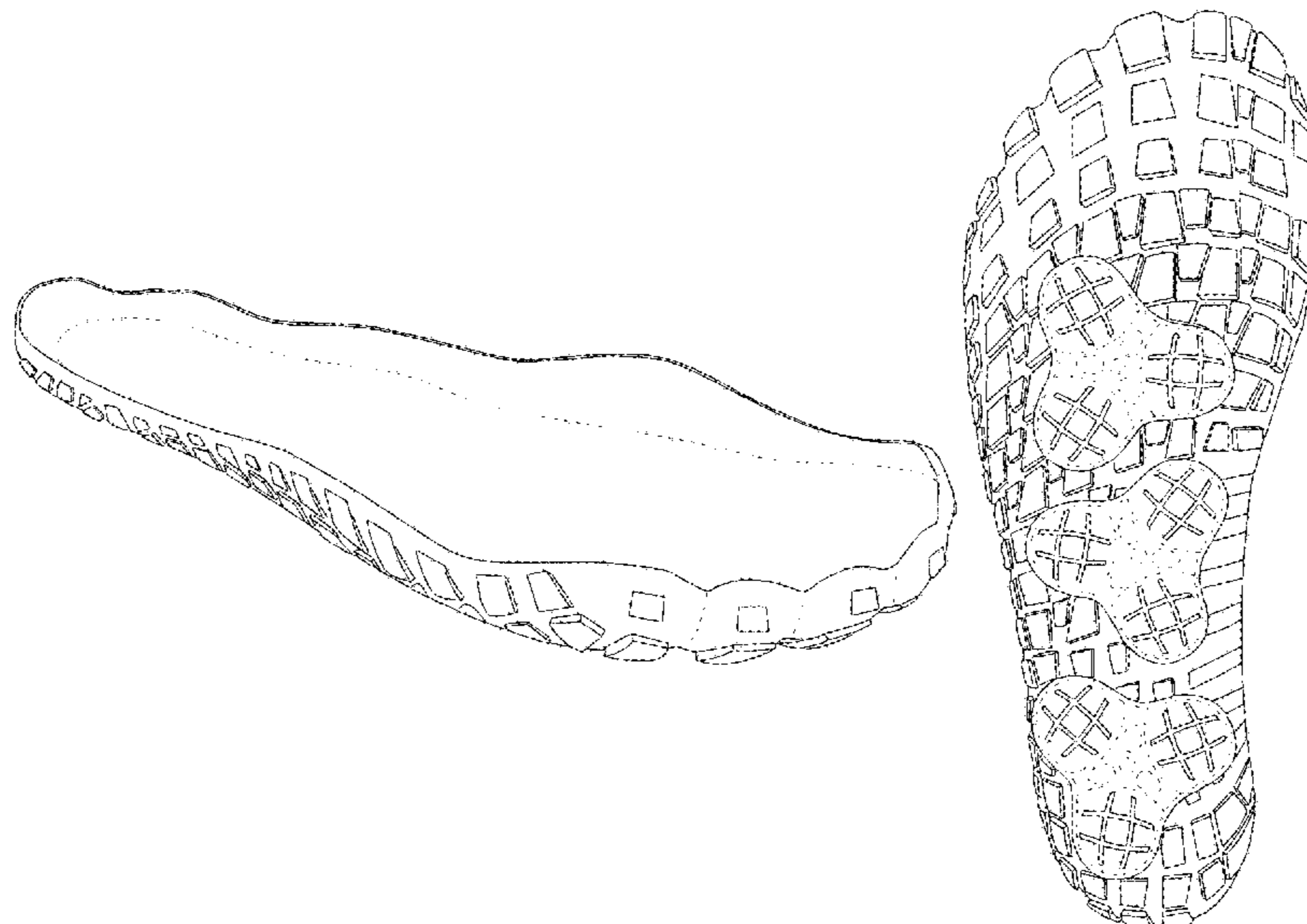
(57) **CLAIM**

I claim the ornamental design for an outsole, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged rear view of the outsole, showing my new design;
FIG. 2 is an enlarged front view thereof;
FIG. 3 is a top perspective view of the outsole seen in FIG. 1;
FIG. 4 is a right side view of FIG. 1;
FIG. 5 is a left side view of FIG. 1;
FIG. 6 is a top view of FIG. 1; and
FIG. 7 is a bottom view of FIG. 1.
The broken lines in the drawing are used to illustrate portion of the outsole that form no part of the claimed design.

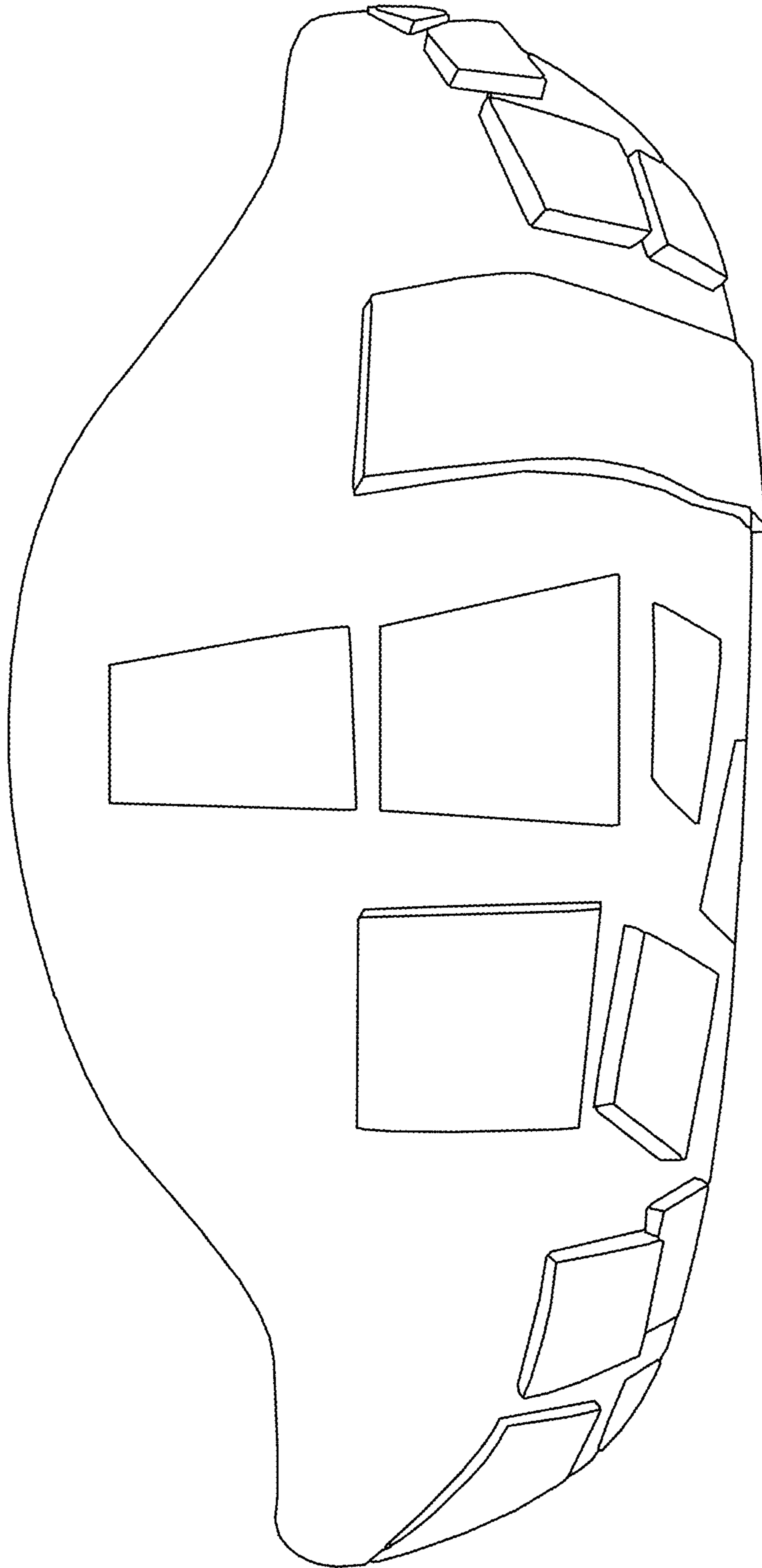

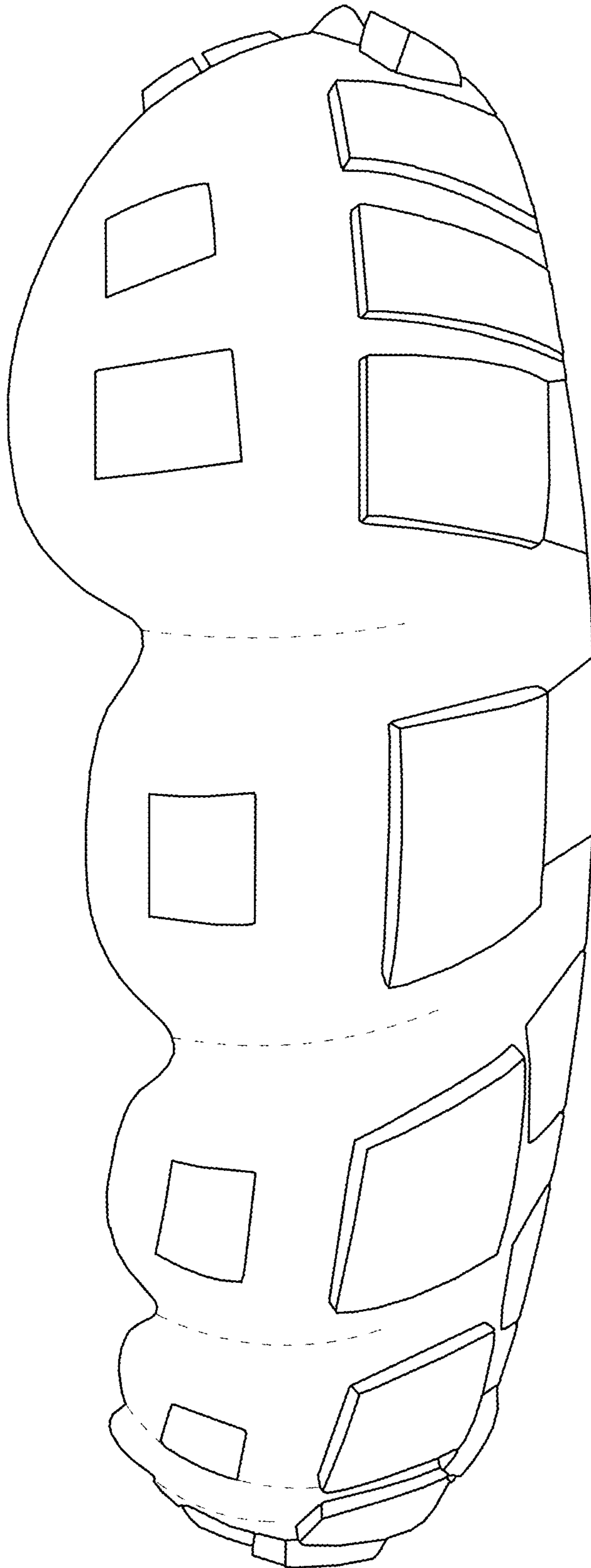

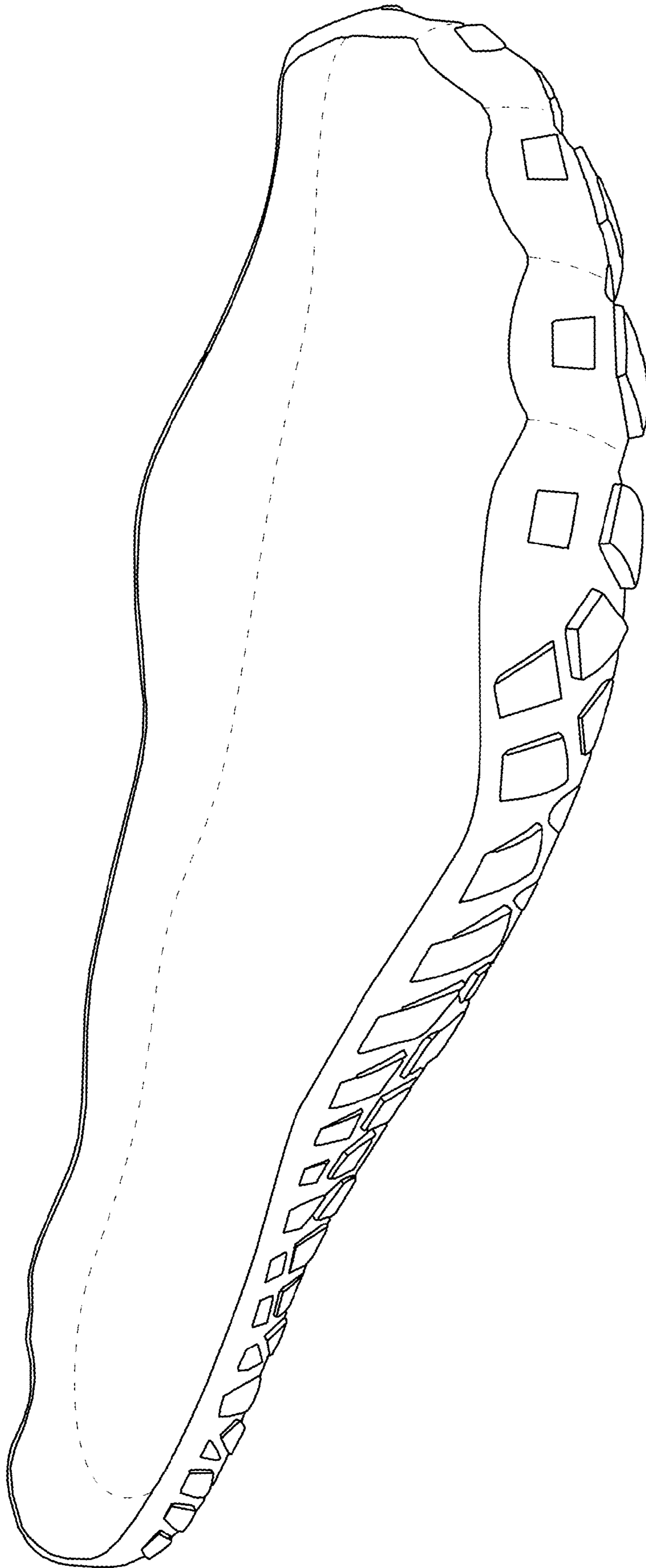

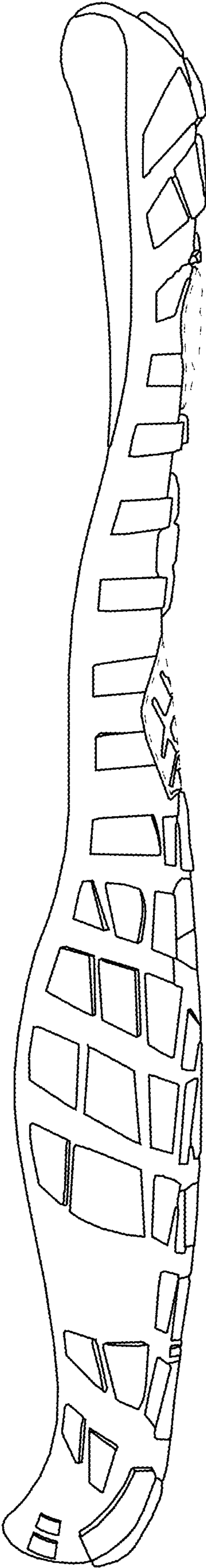

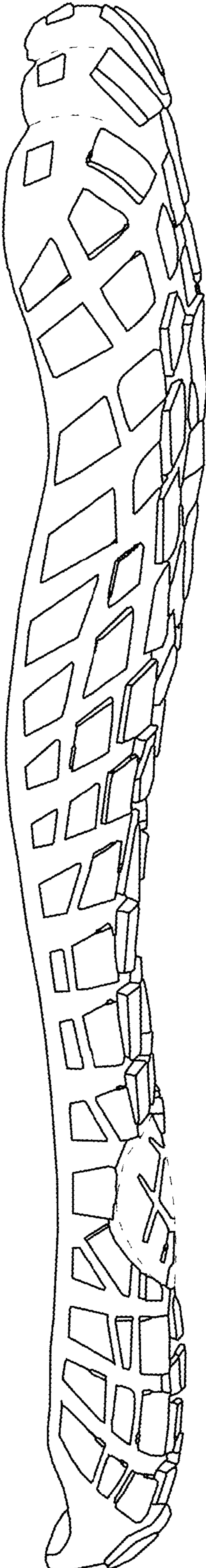

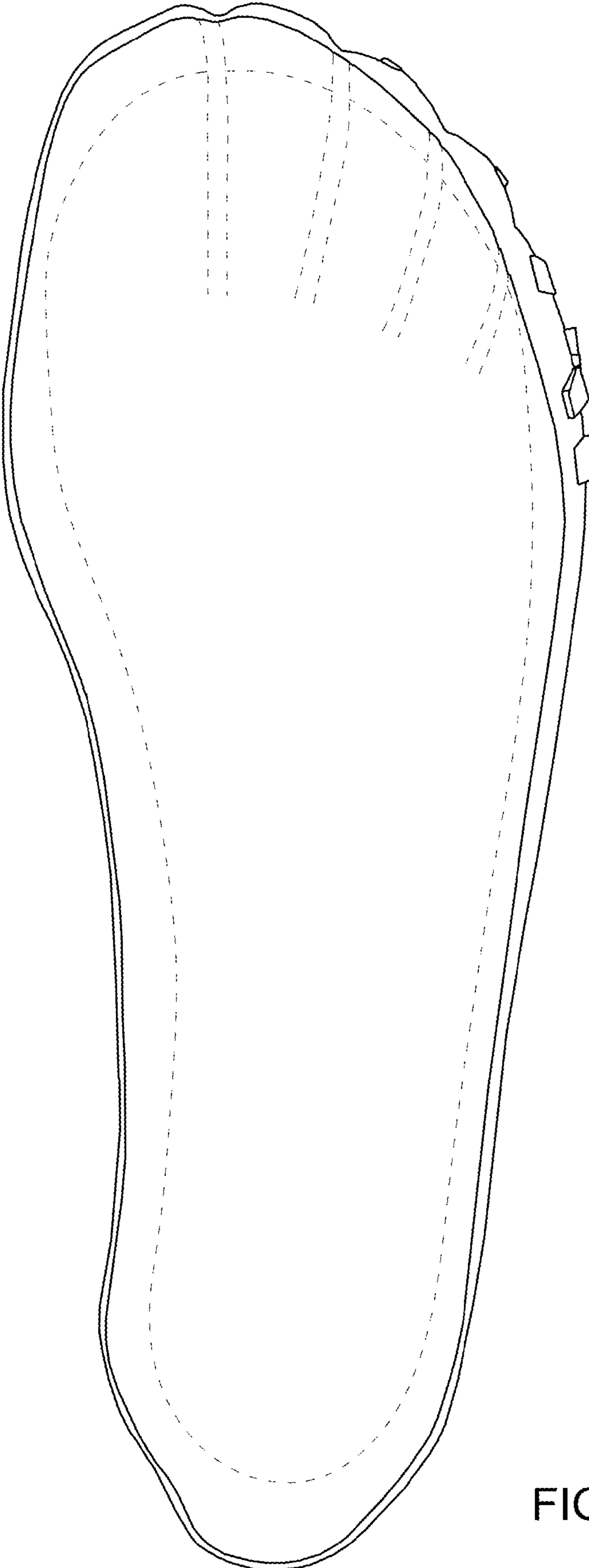

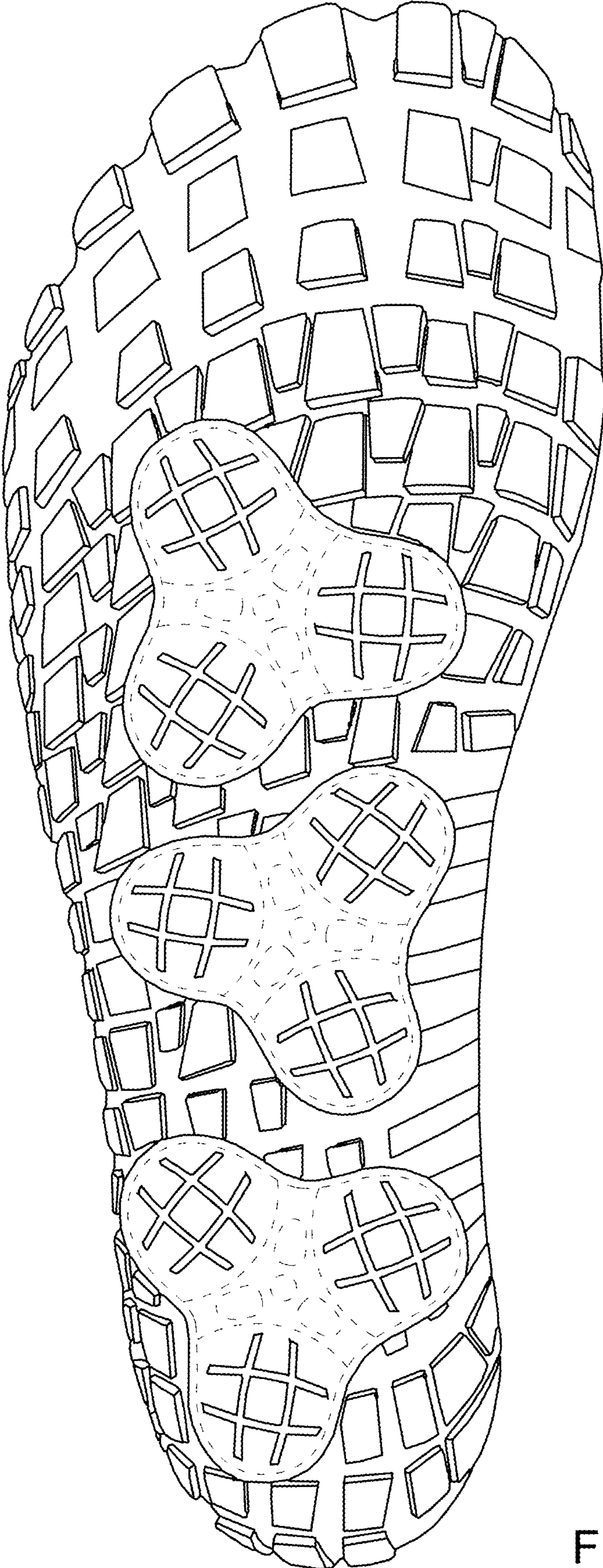
