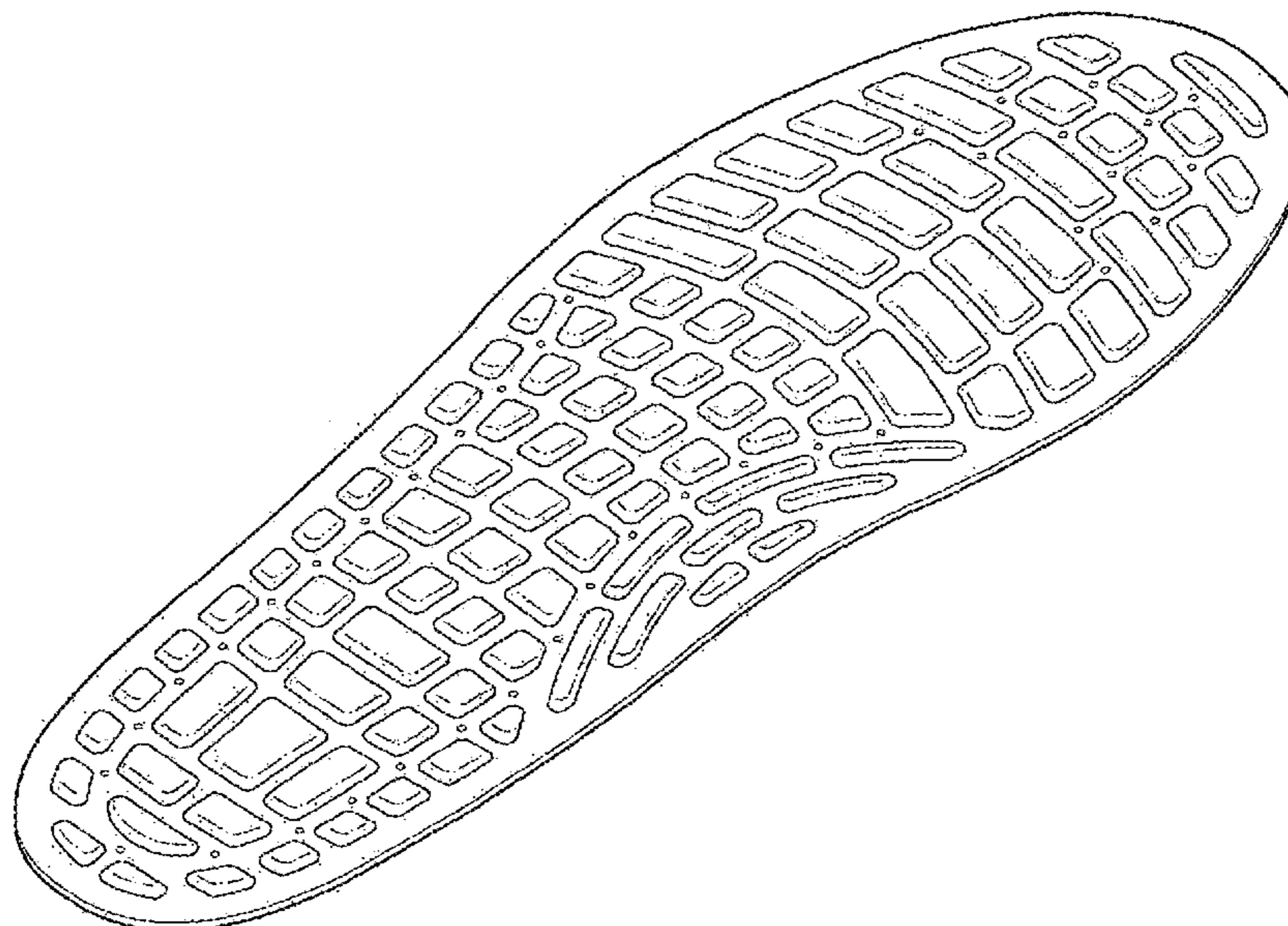
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of an insole showing my new design;
FIG. 2 is a top plan view thereof, the bottom plan view being a mirror image;

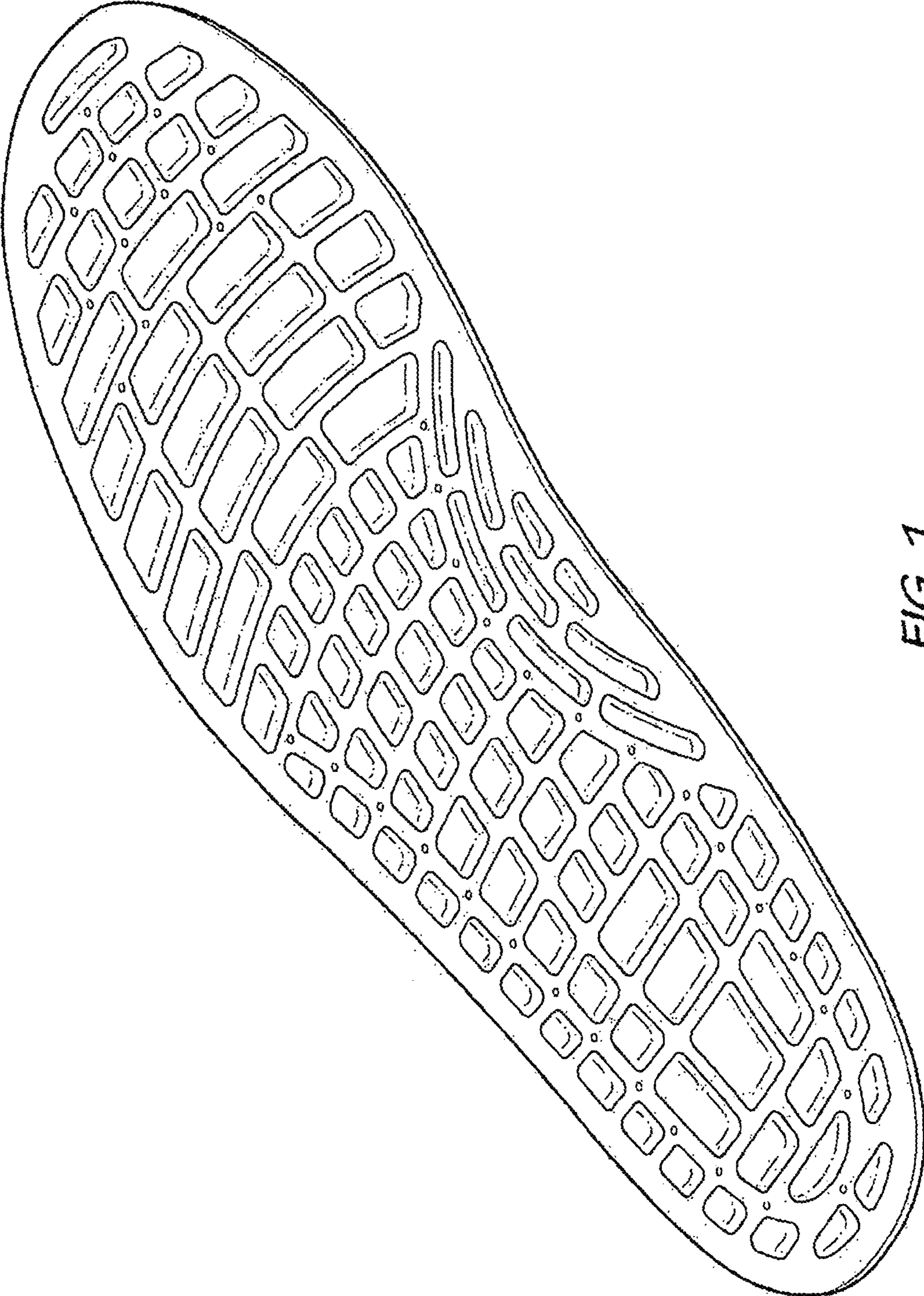

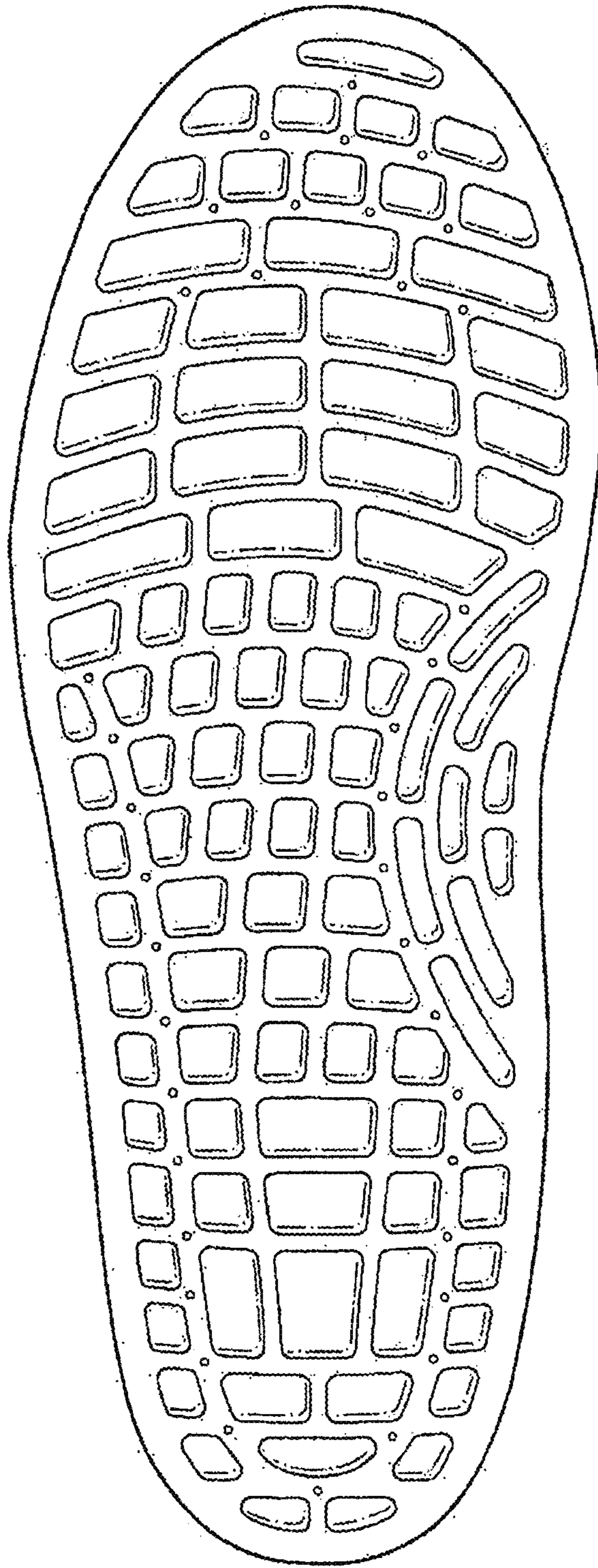

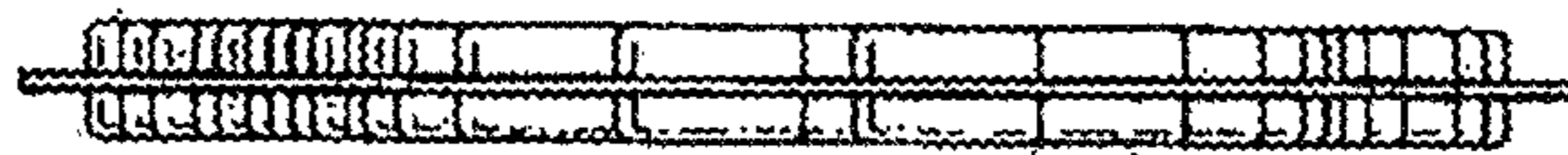
