DESCRIPTION

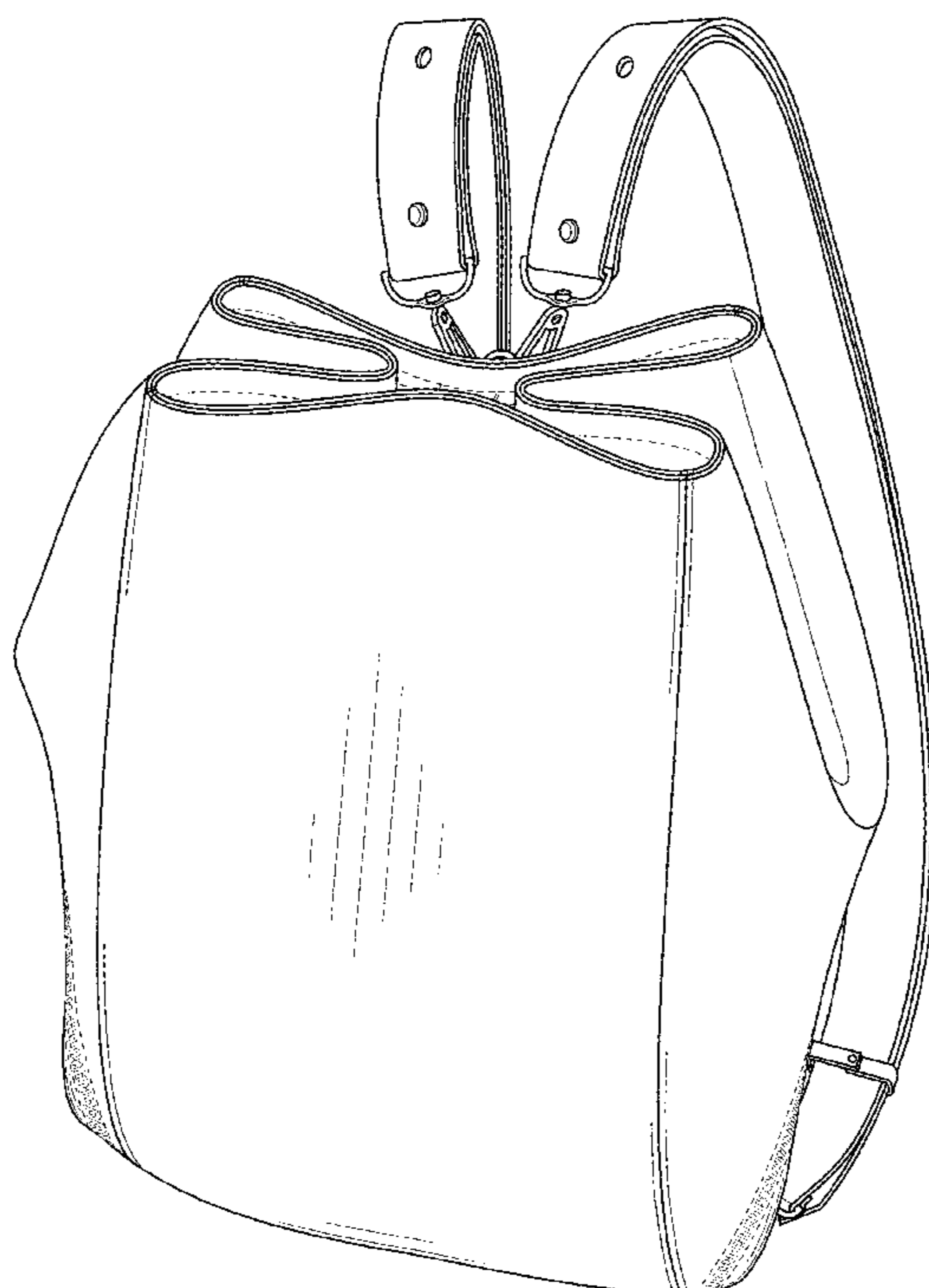
FIG. 1 is a front perspective view of the convertible backpack showing our new design.

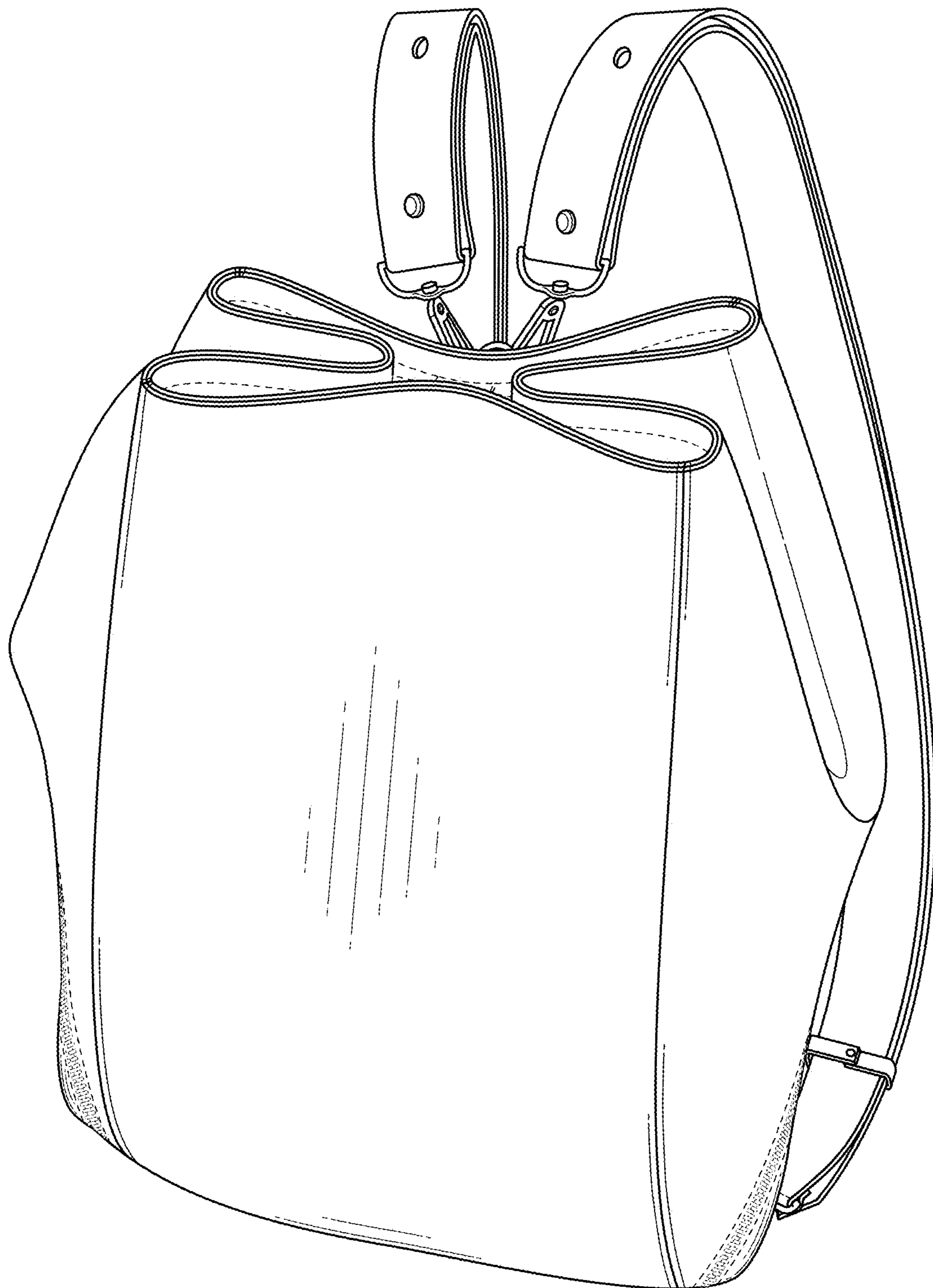

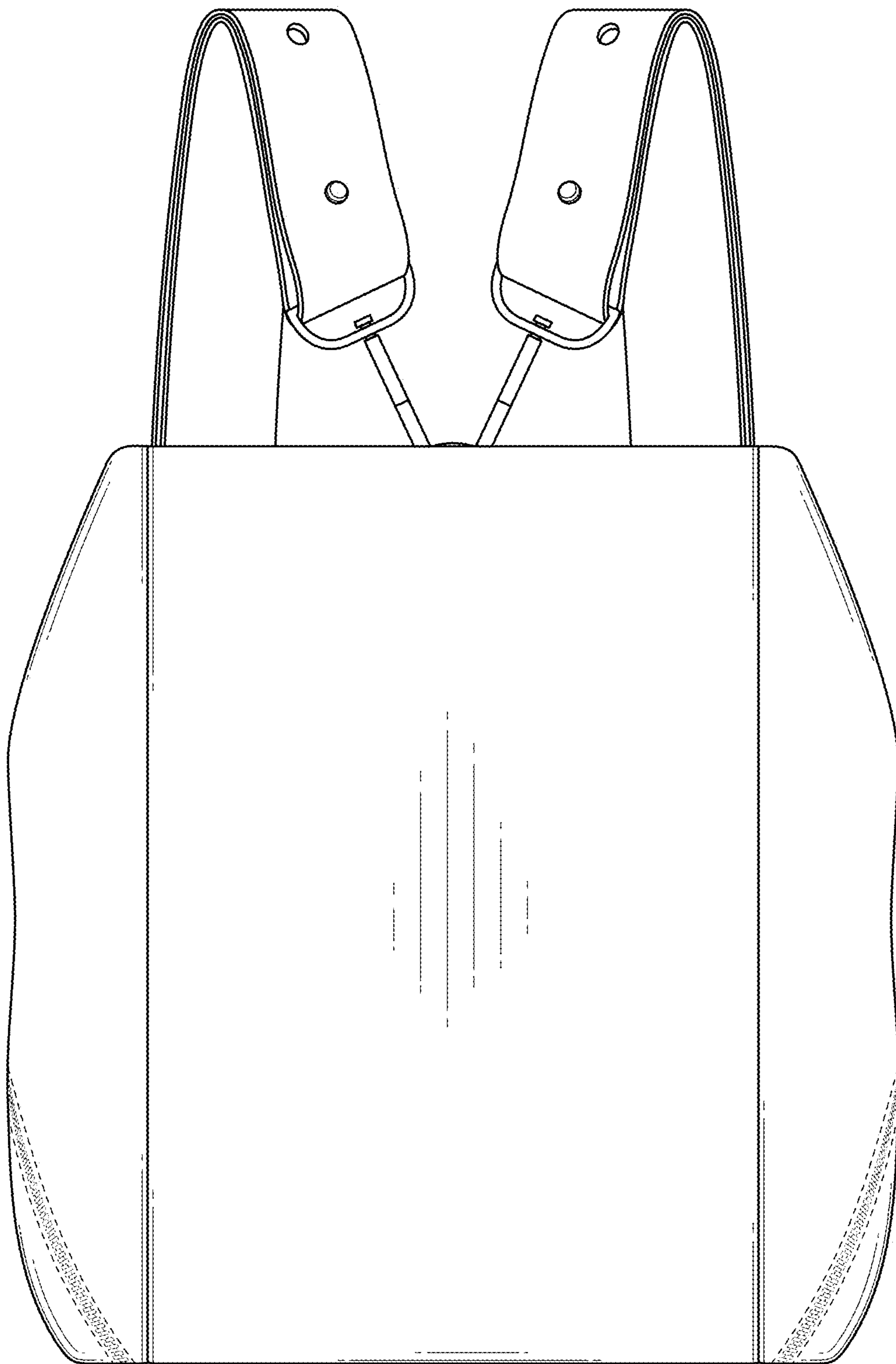

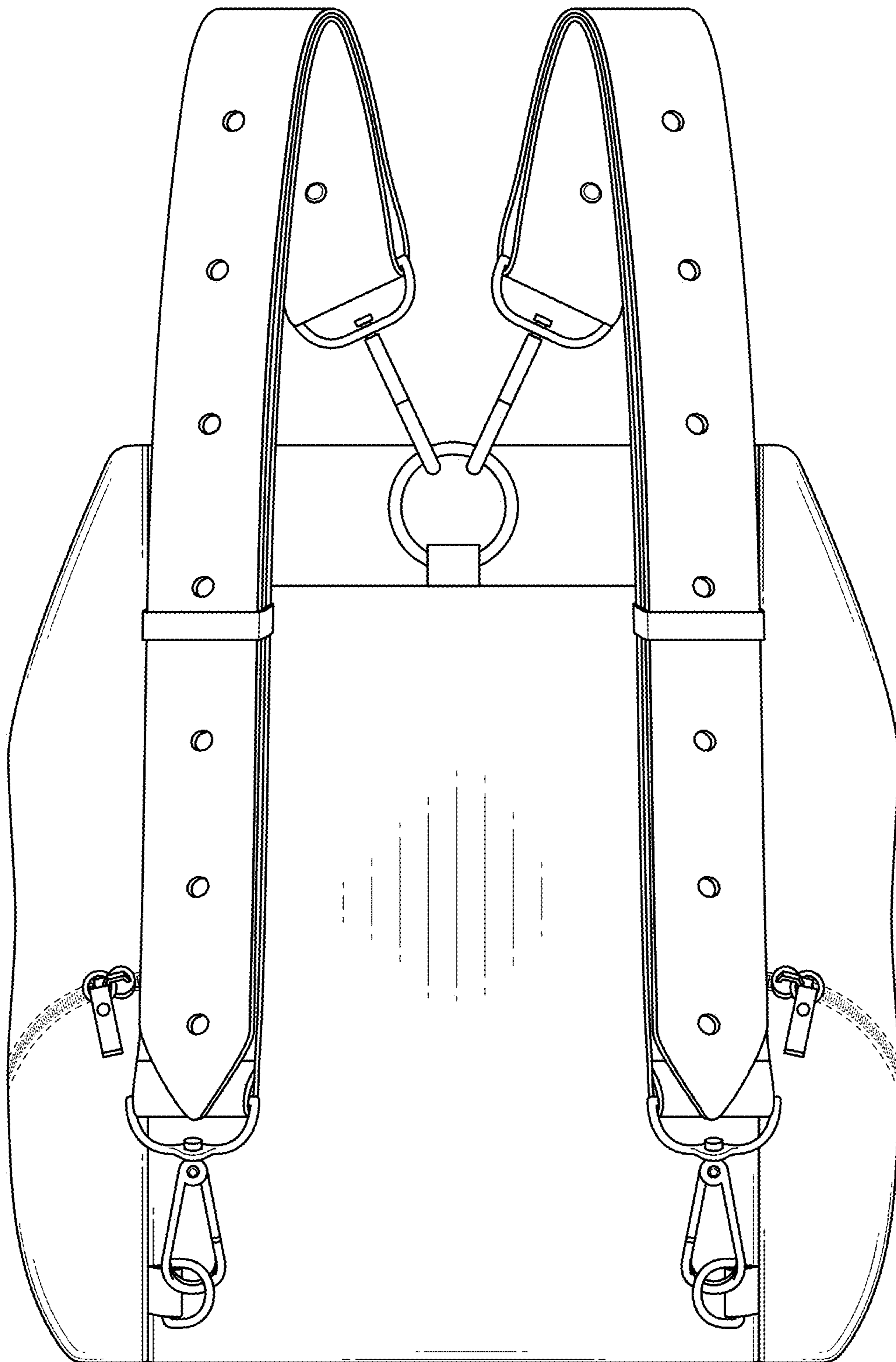

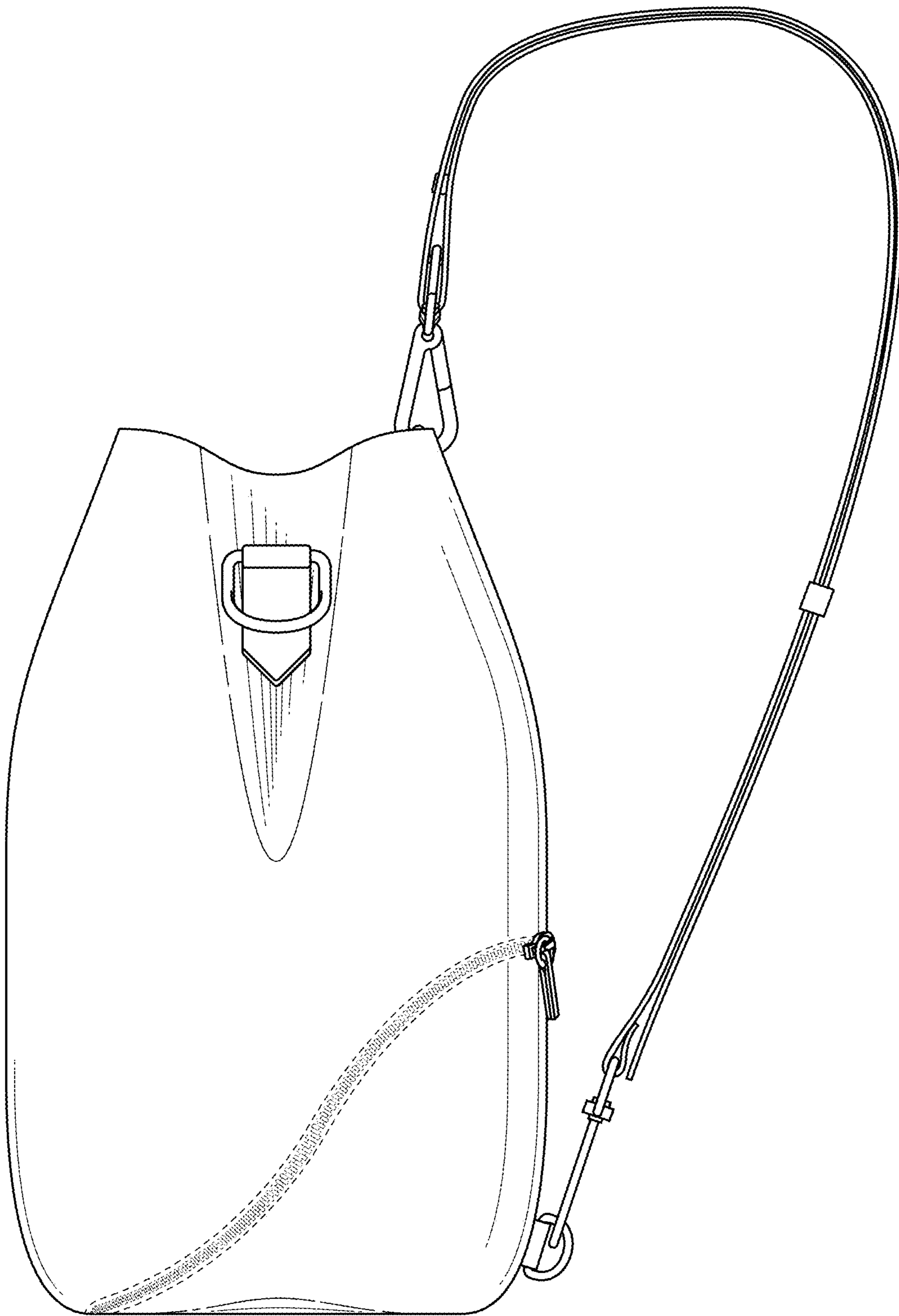

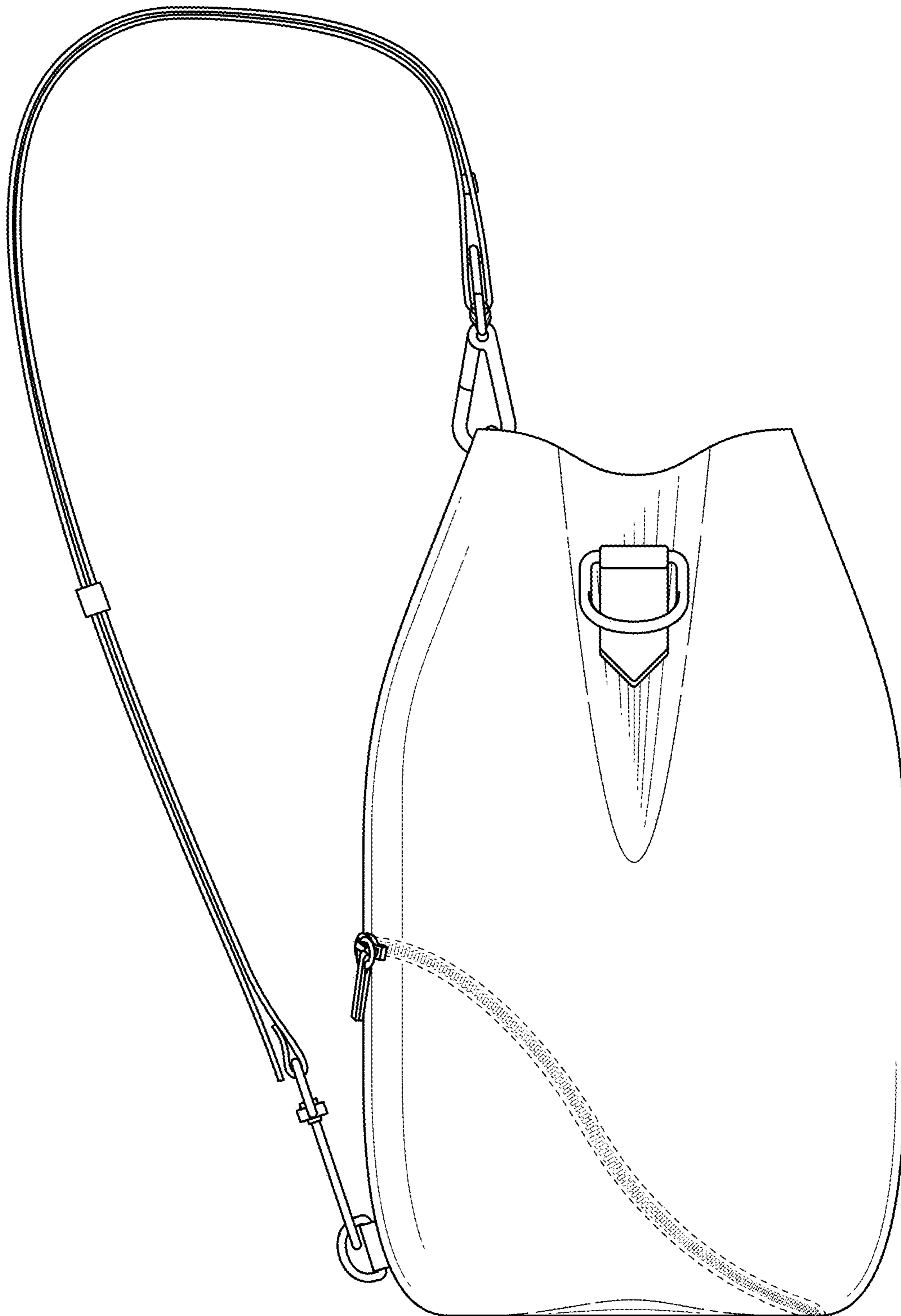

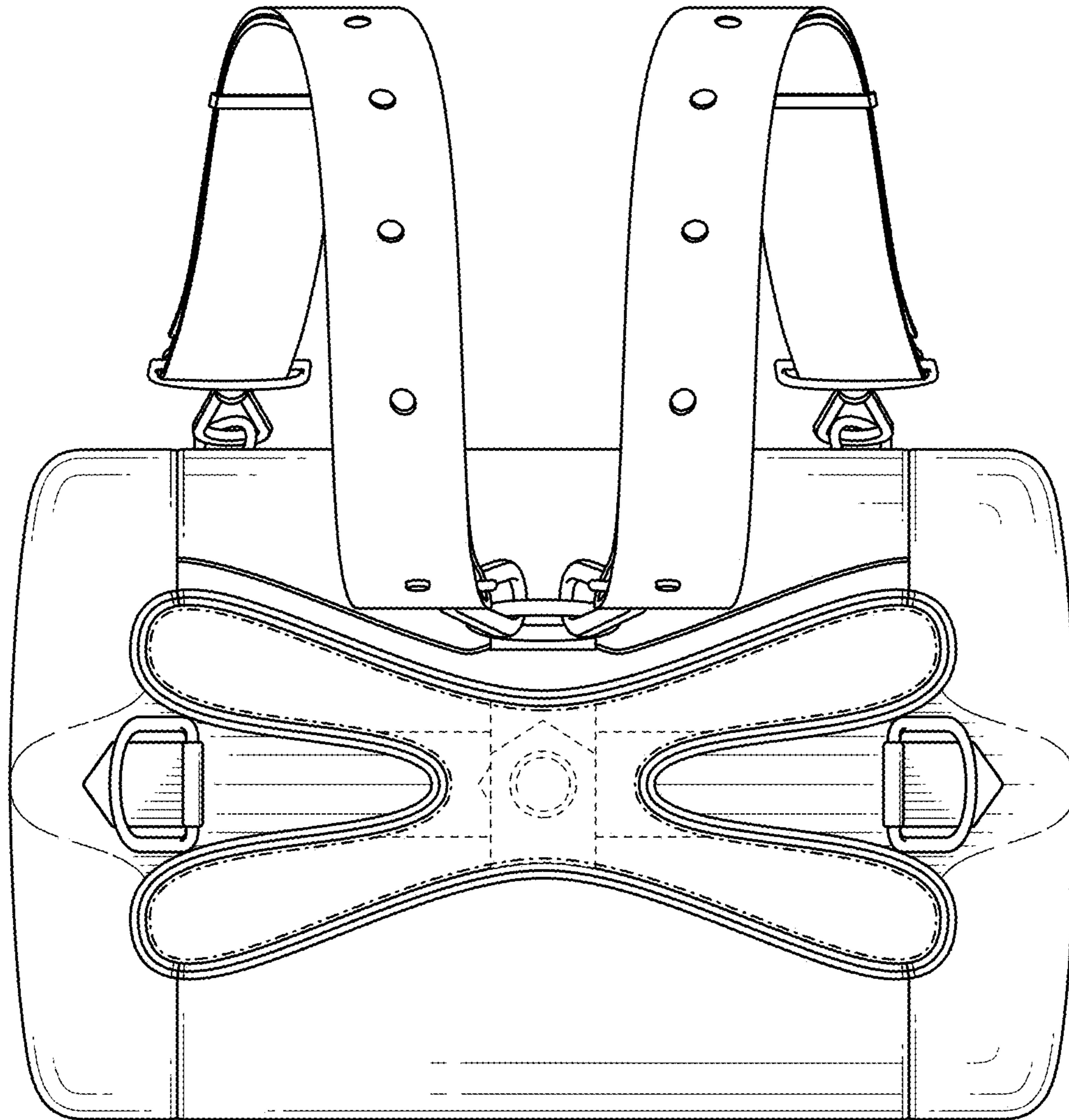

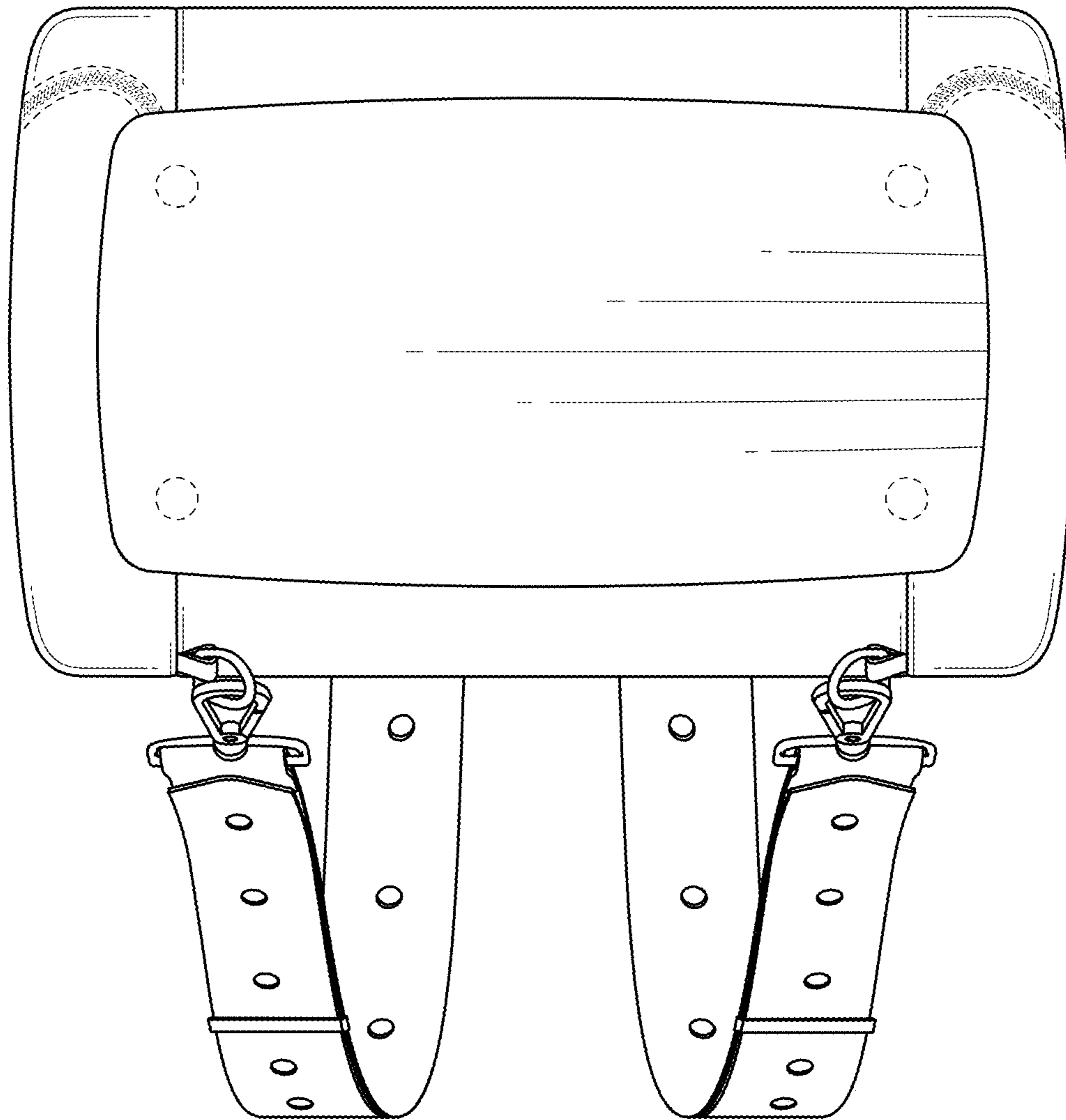
