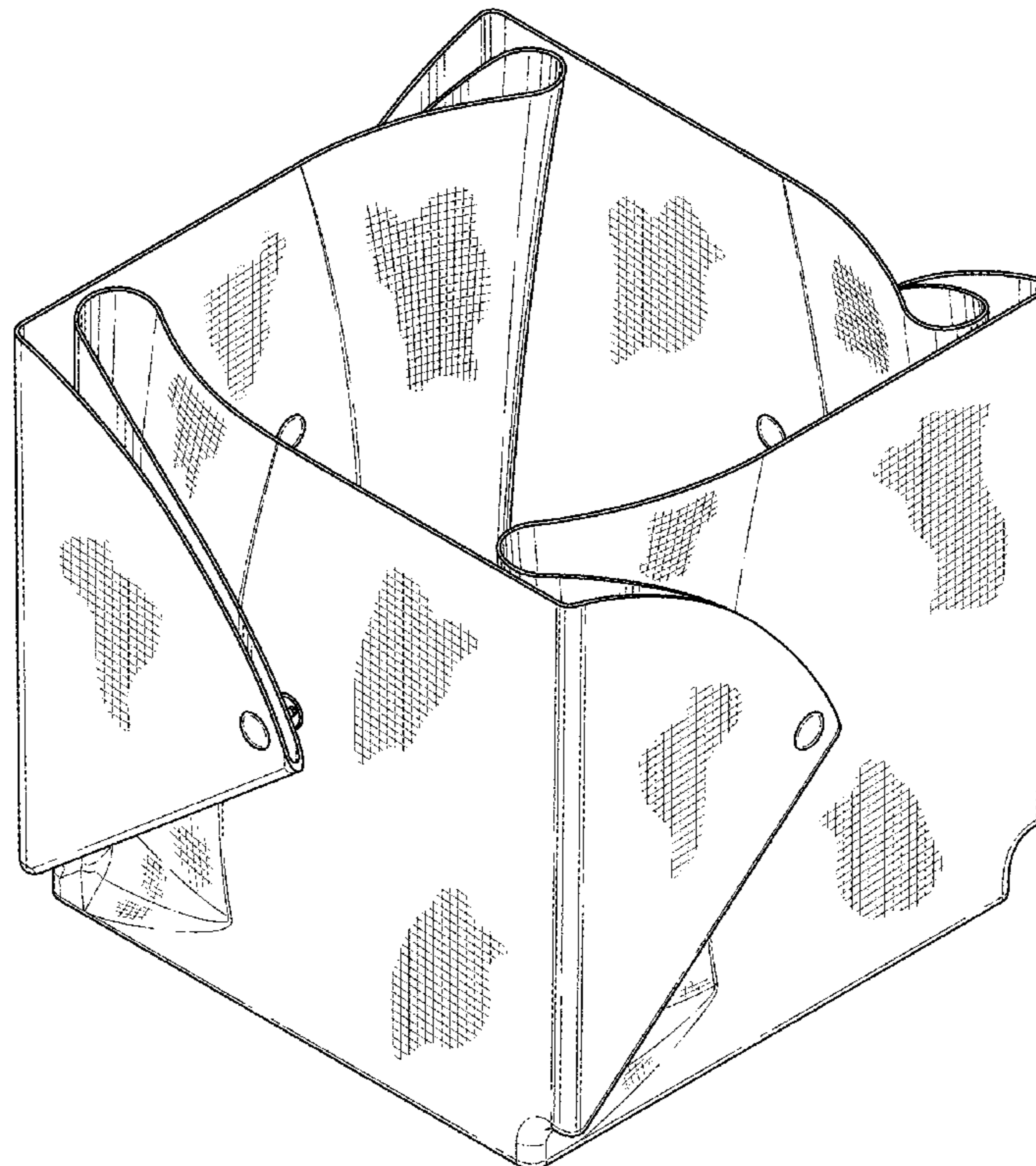
(57) **CLAIM**

The ornamental design for a plant holder, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of the plant holder of the present invention;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right side view thereof; and,
FIG. 6 is a top plan view thereof.
The dot-dashed broken lines represent boundaries to disclaim the bottom of the plant holder.
The cross hatching shown indicates a fabric material only and does not represent any particular color, texture, pattern, or finish of fabric.

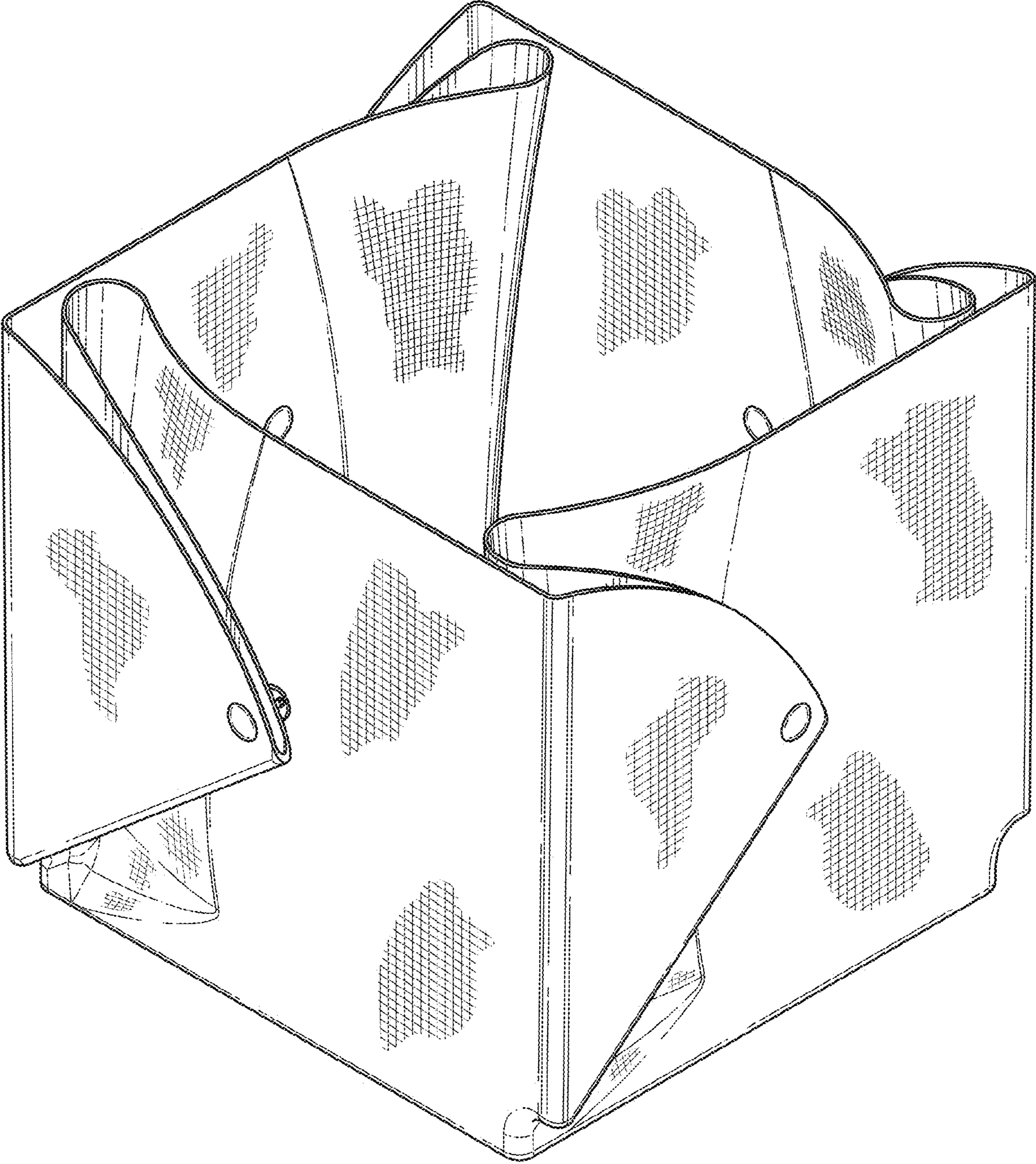

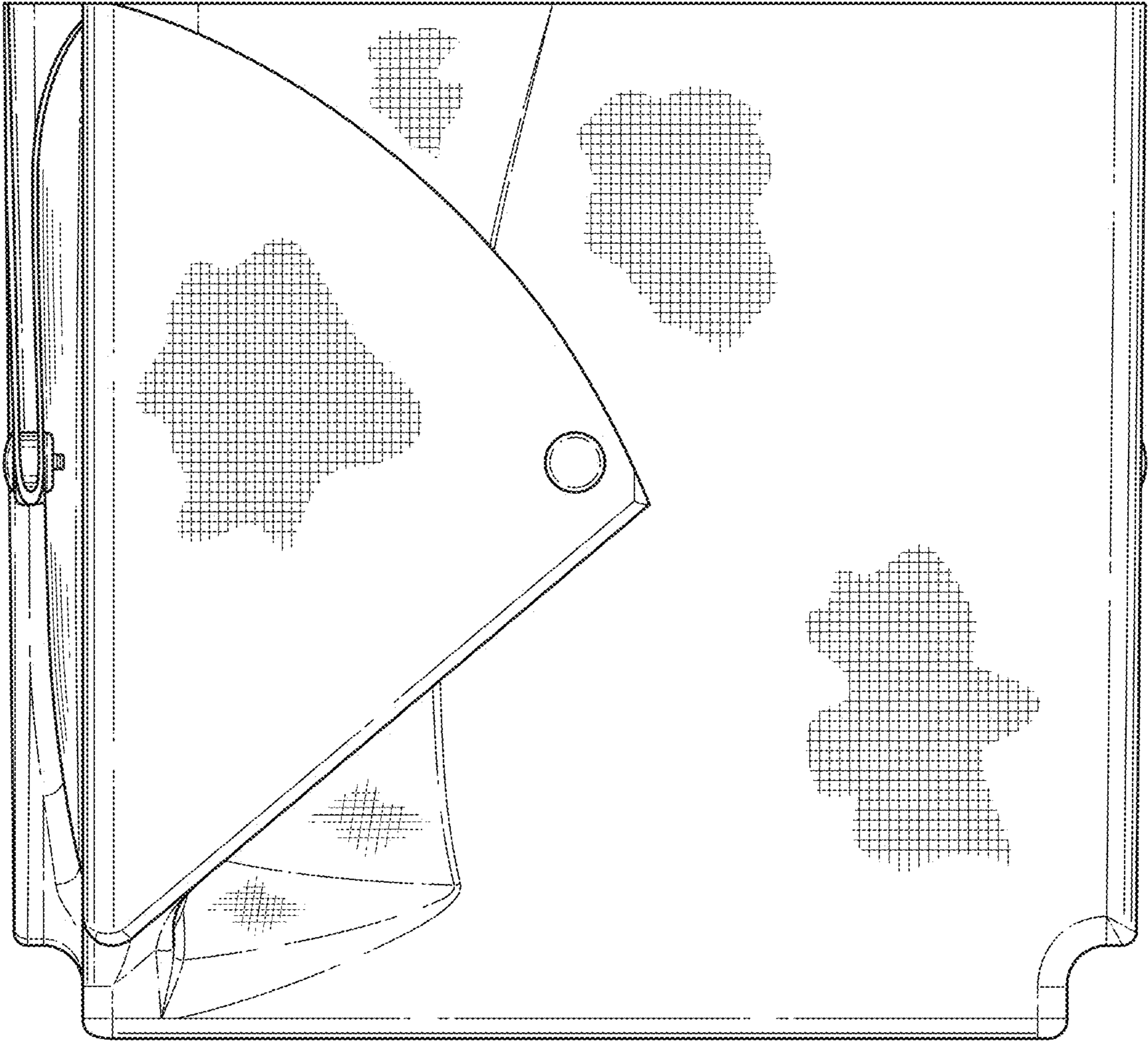

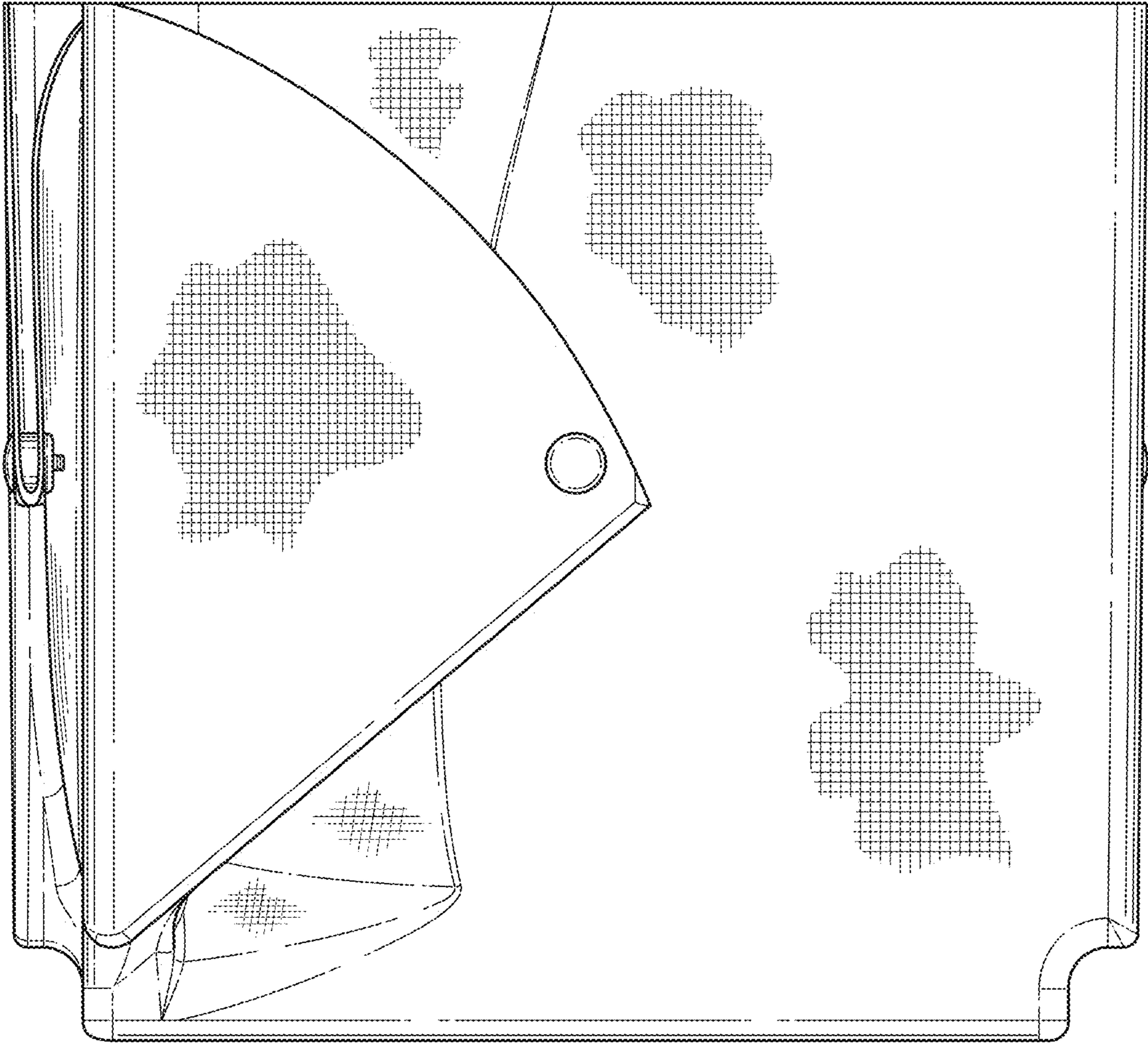

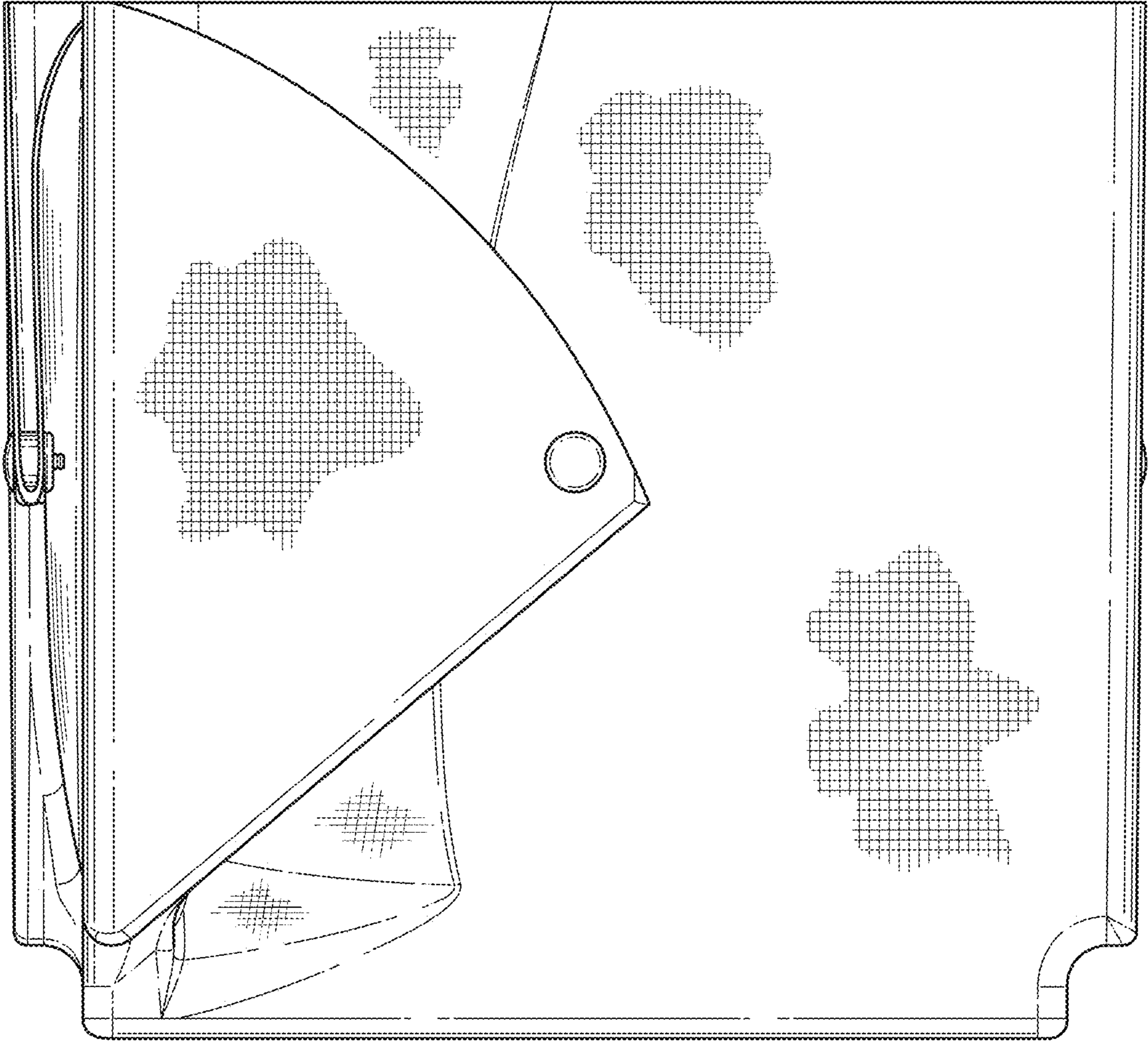

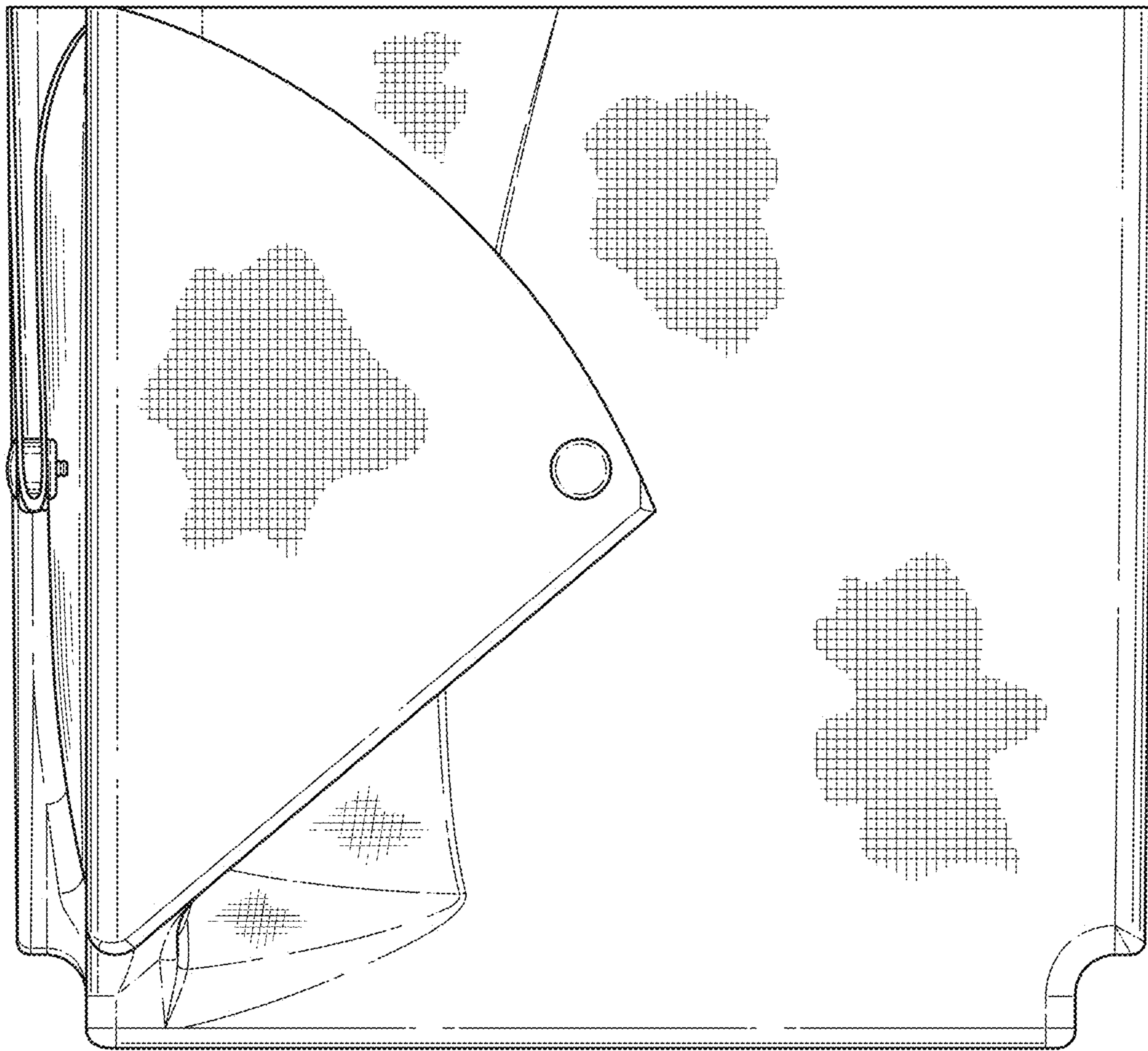

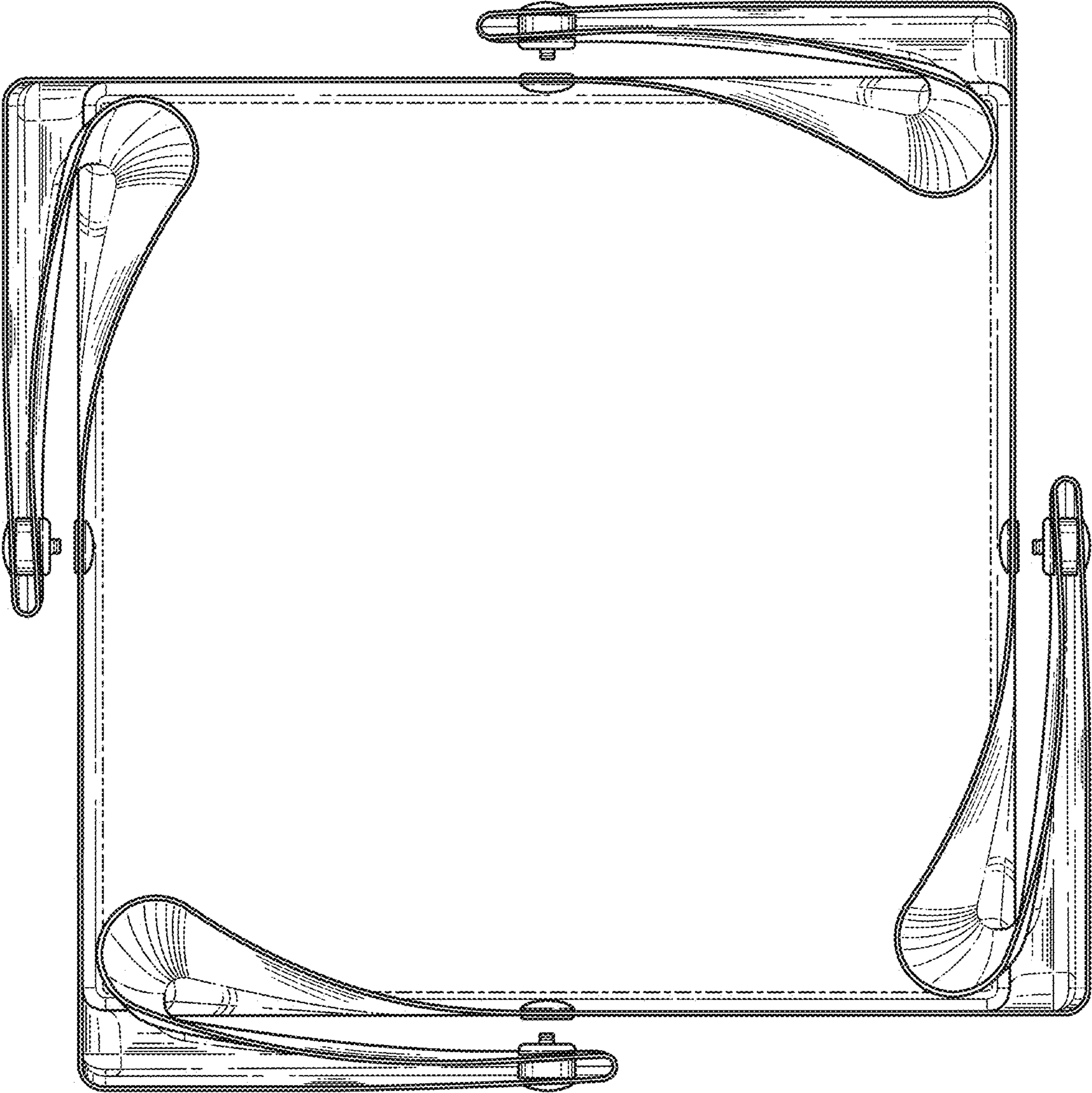
