DESCRIPTION

FIG. 1 is a front view of an oven according to an embodiment showing our new design; and, FIG. 2 is a front perspective view thereof. One or more views (e.g., bottom, rear) may not be shown as those views are unornamented or simply not claimed. The broken lines represent environmental structure or unclaimed portions of the climbing aid and do not form a portion of the claimed design.

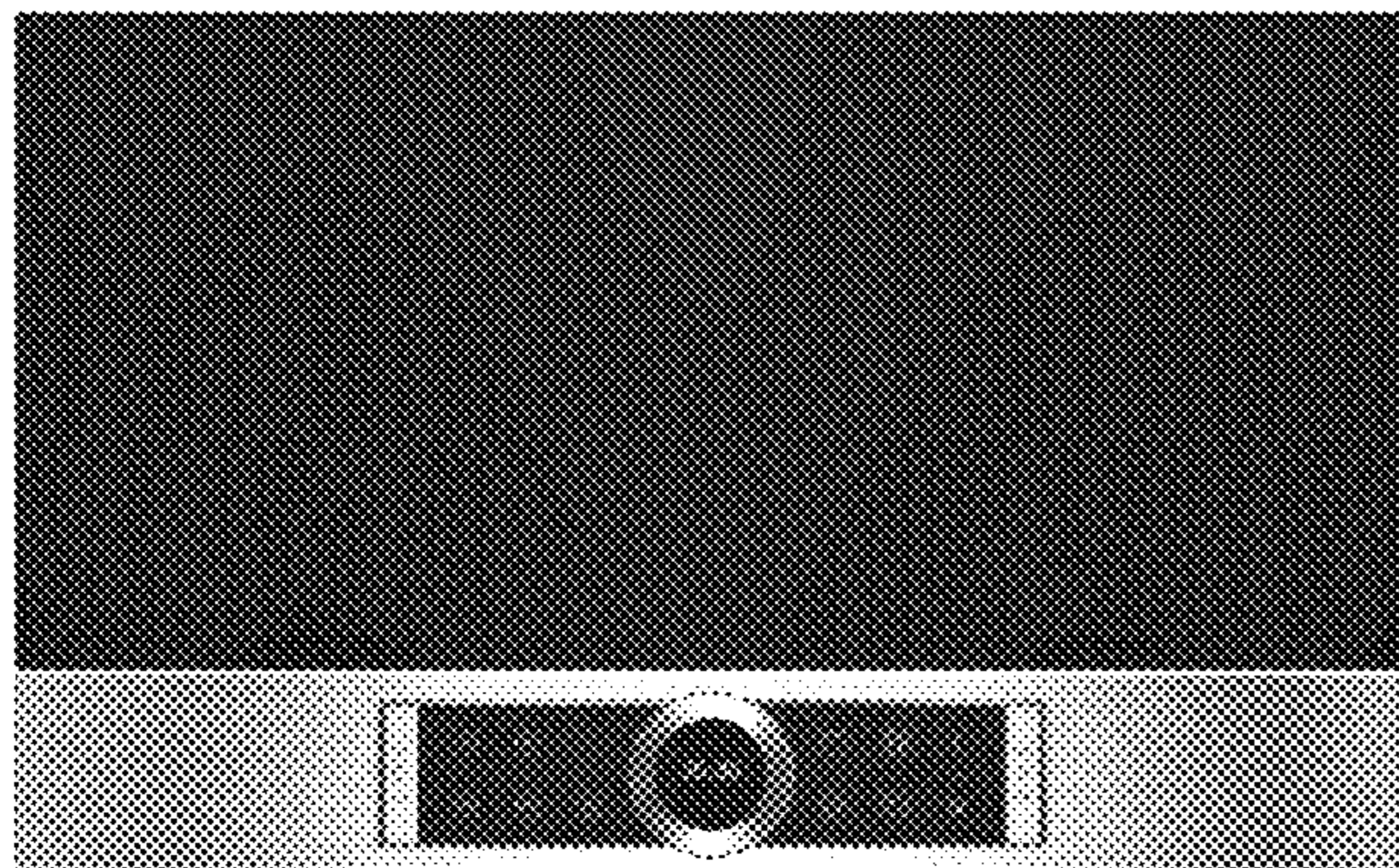
