(57) **CLAIM**

We claim the ornamental design for a dual access fluid dispensing lid, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of the dual access fluid dispensing lid of the present invention, in a closed configuration with the pivoting handle in a retracted position.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a right side elevational view thereof.

FIG. 4 is a rear elevational view thereof.

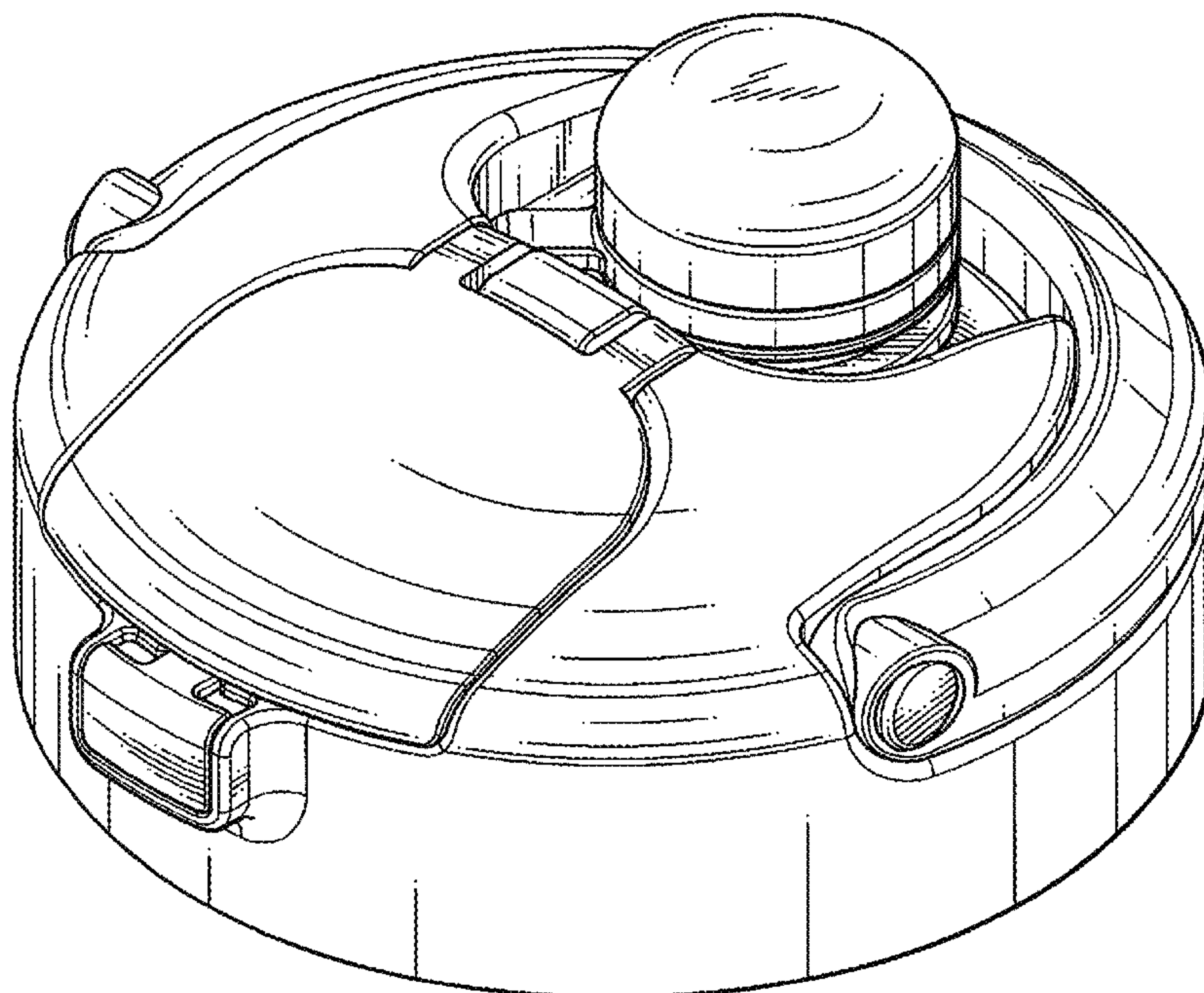
FIG. 5 is a top, plan view thereof.

FIG. 6 is a bottom, plan view thereof; and,

FIG. 7 is a right side elevational view of the dual access fluid dispensing lid of FIG. 3, in a first open configuration.

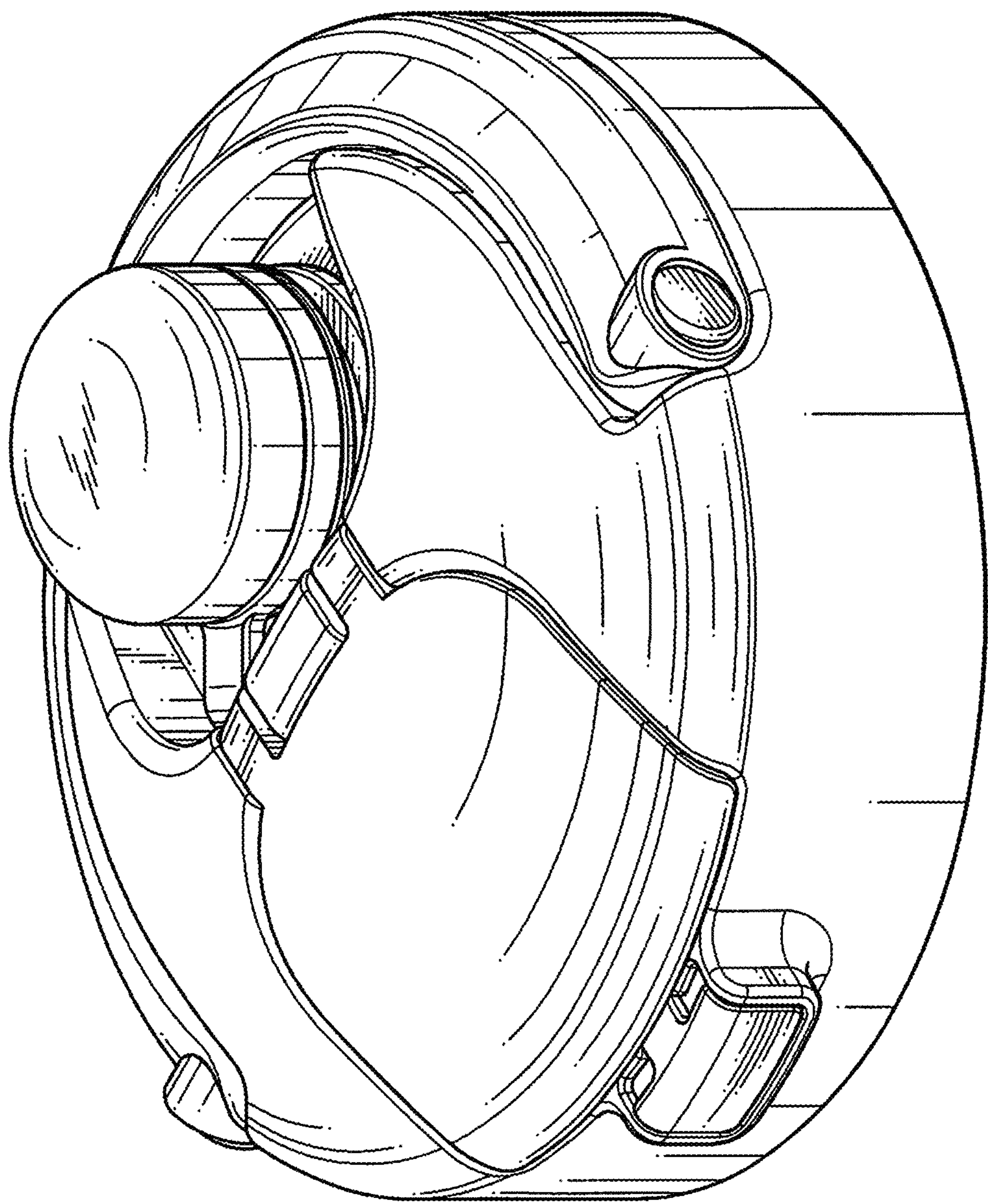

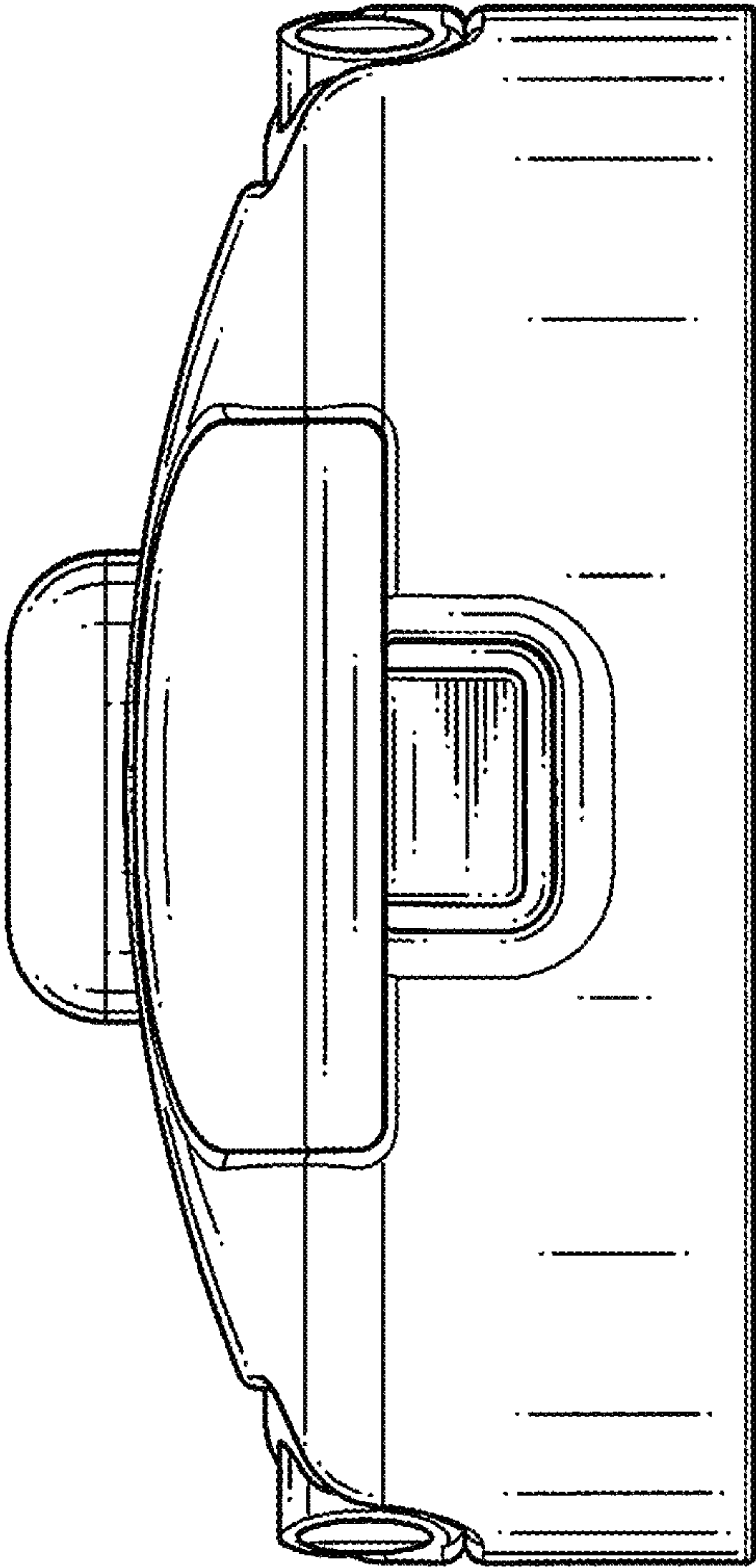

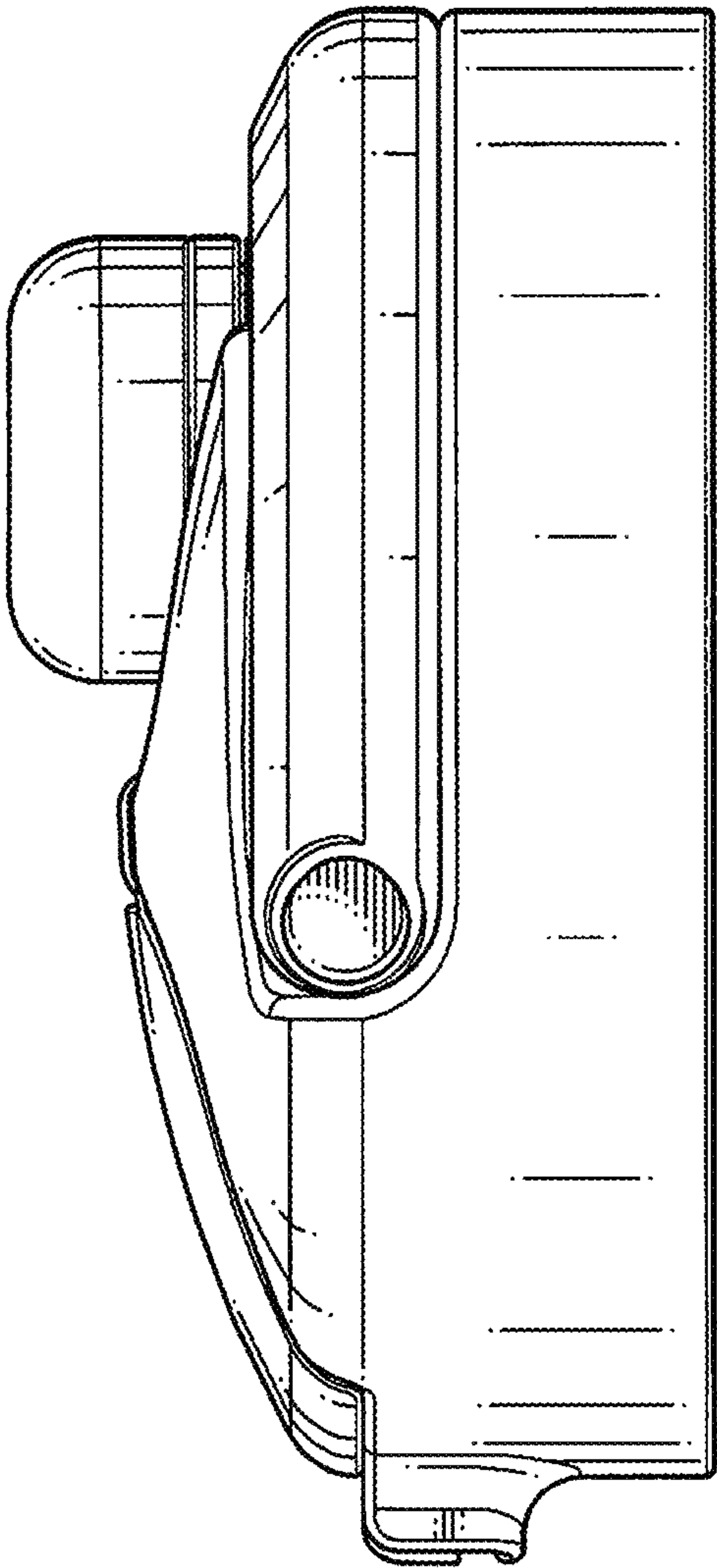

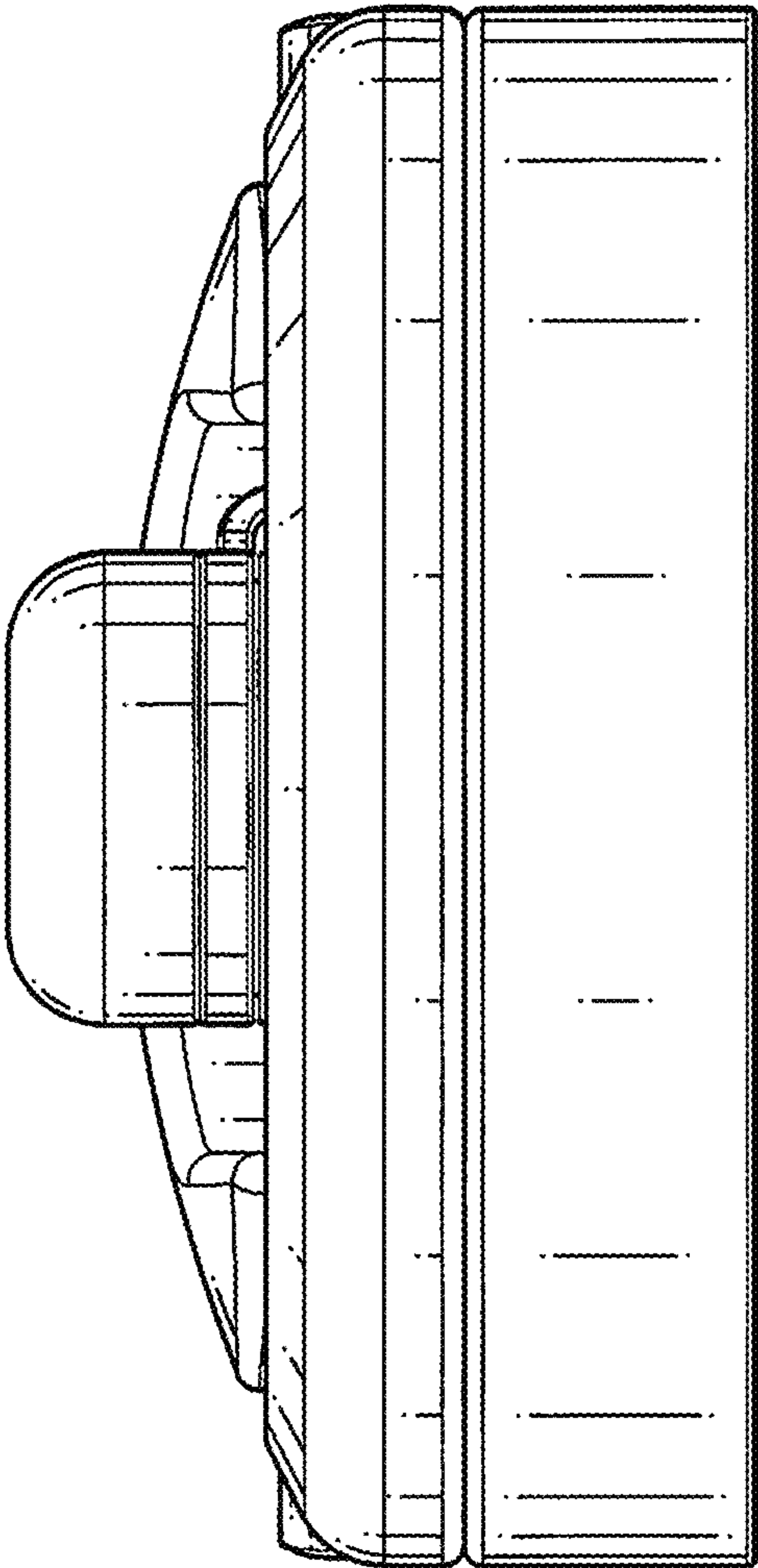

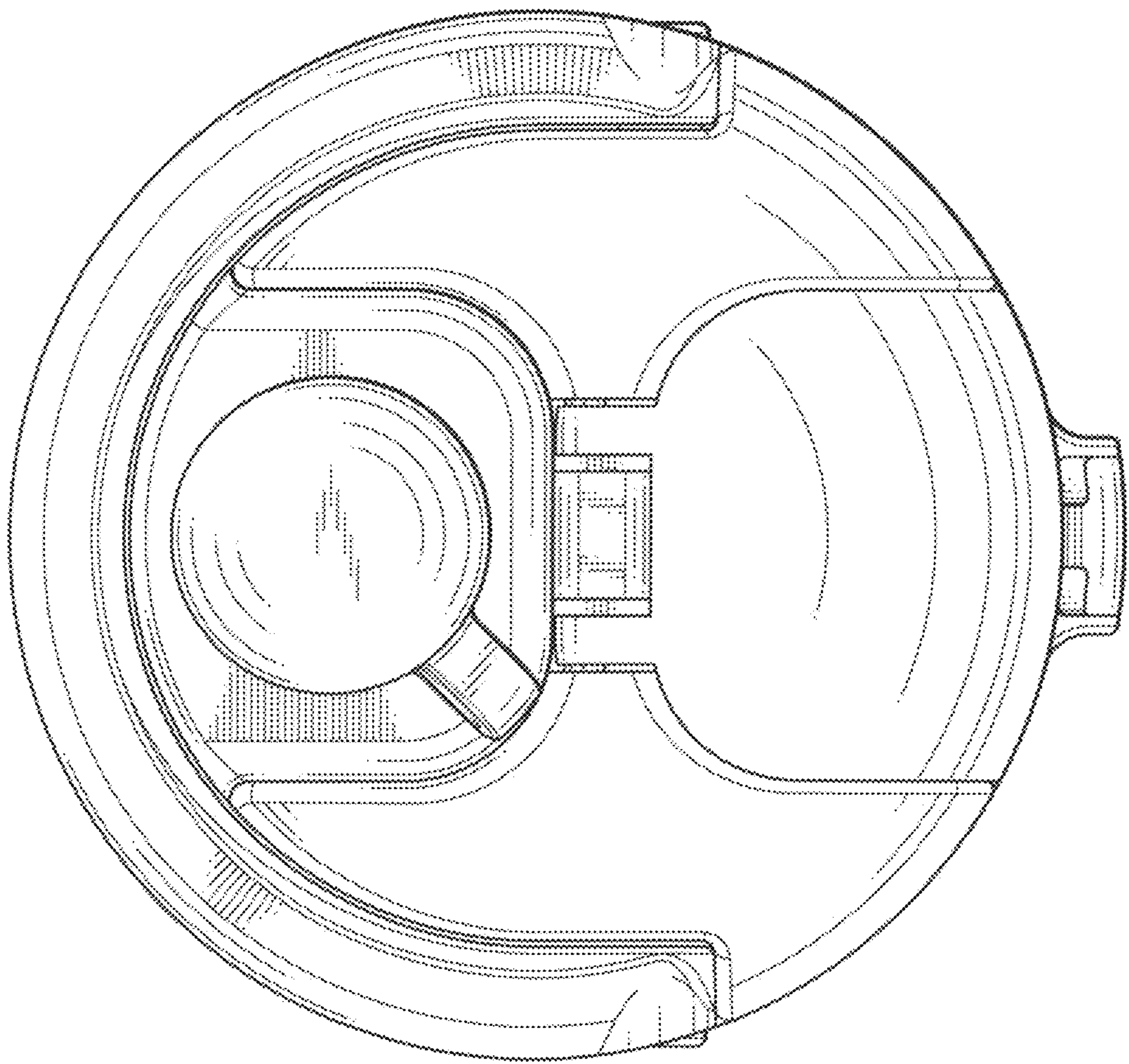

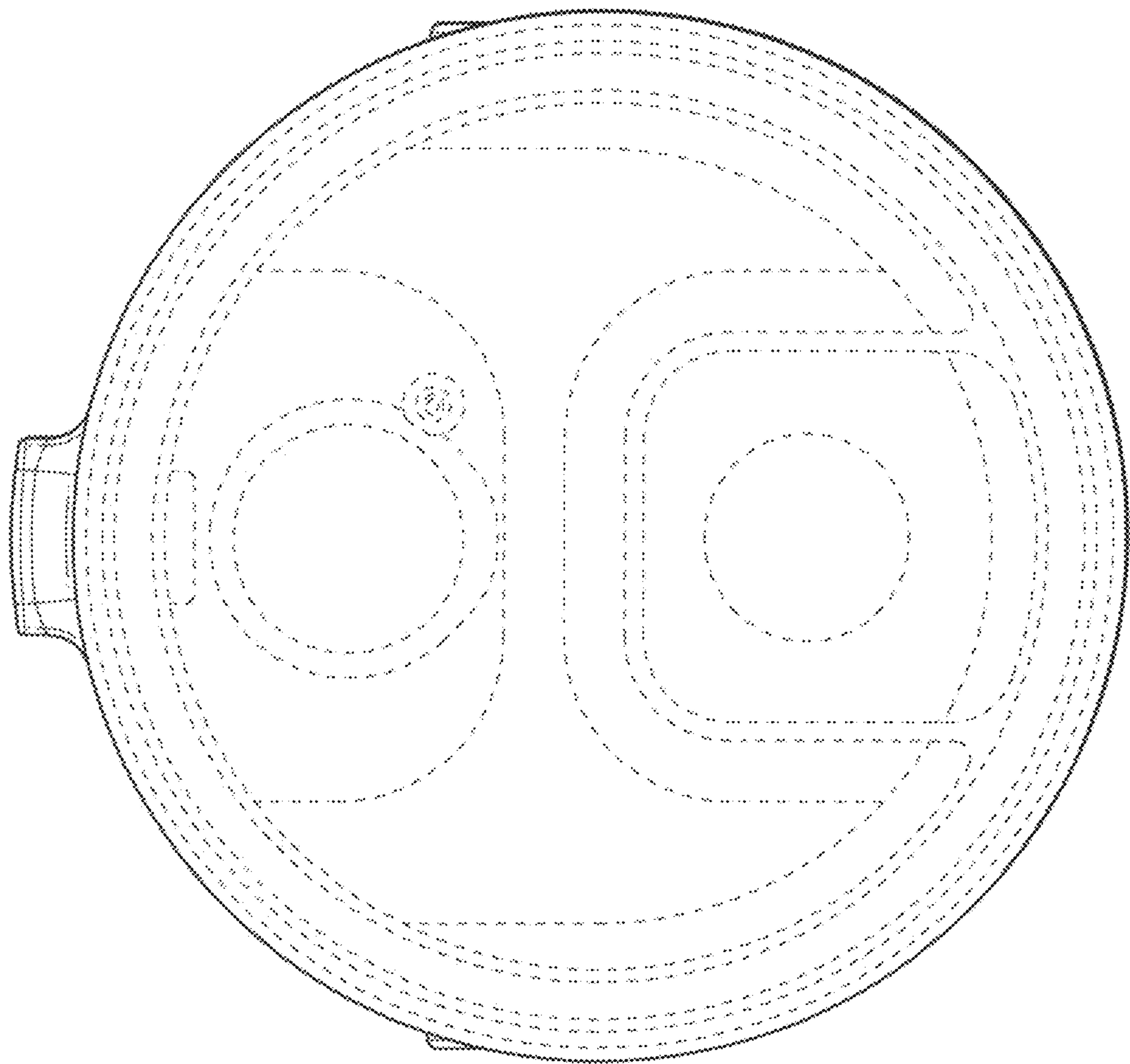

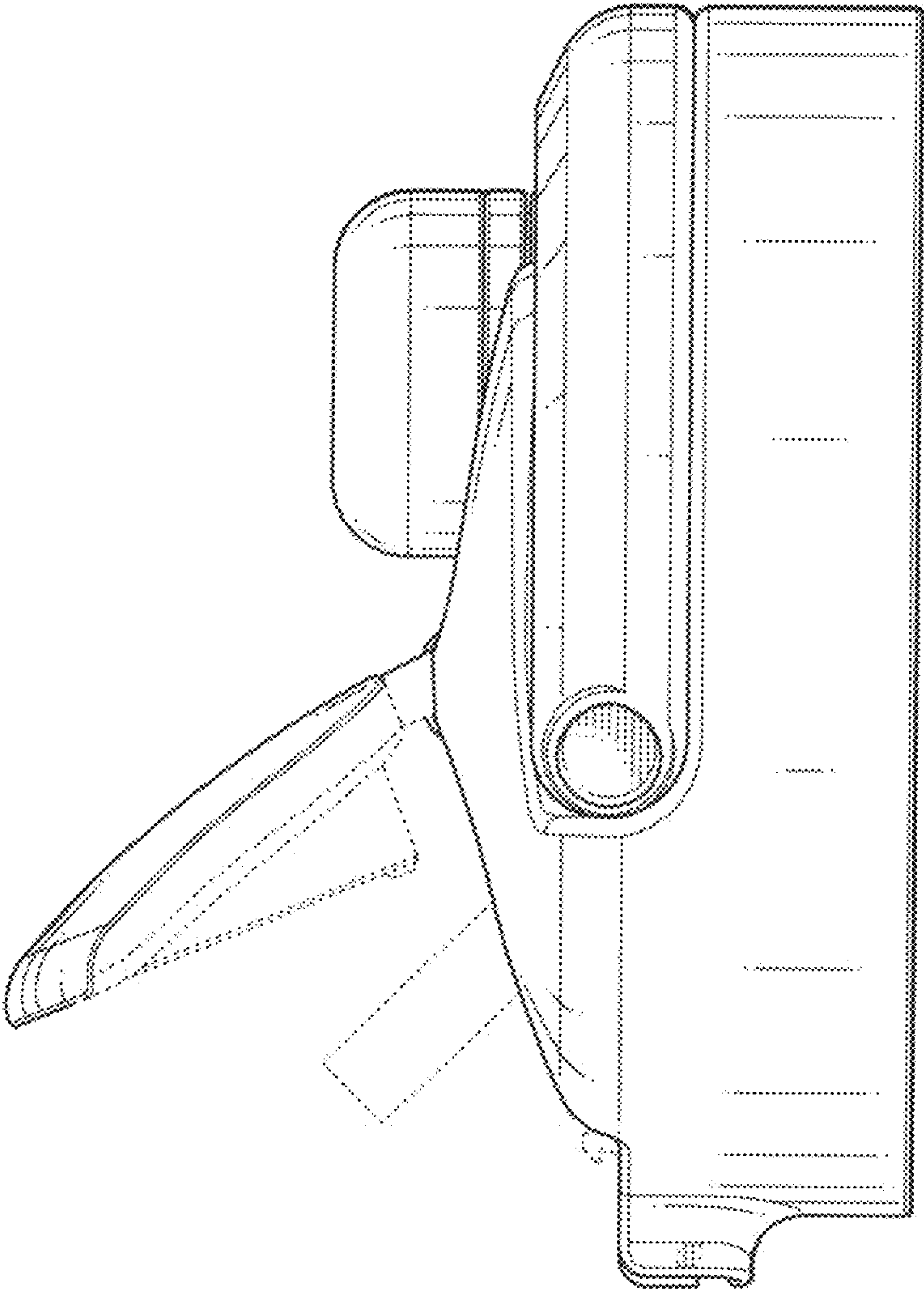
