(57) **CLAIM**

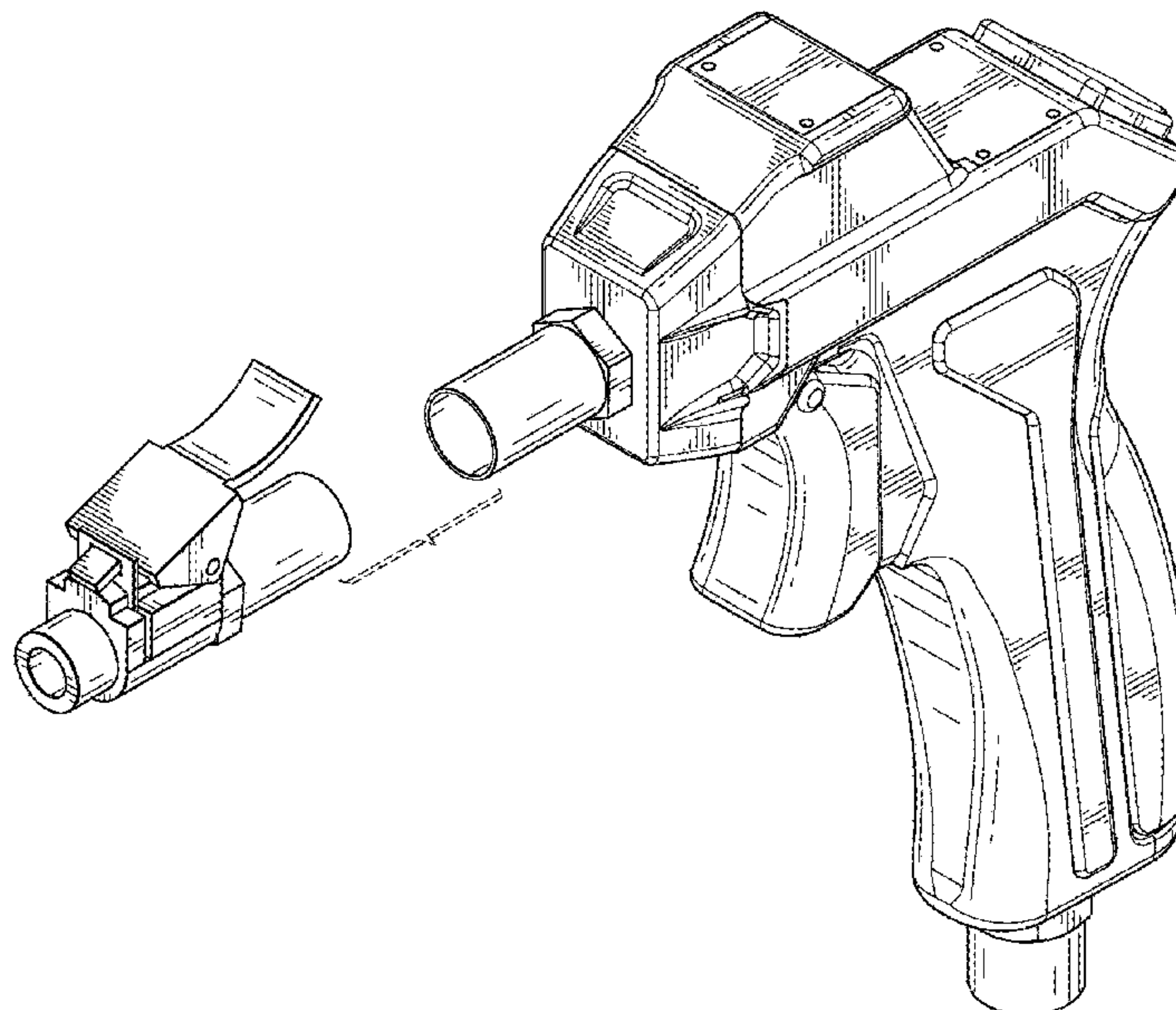
The ornamental design for an inflation gun, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of an inflation gun showing our new design;
FIG. 2 is a top, front, and left side perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a top plan view thereof.

The inflation gun is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

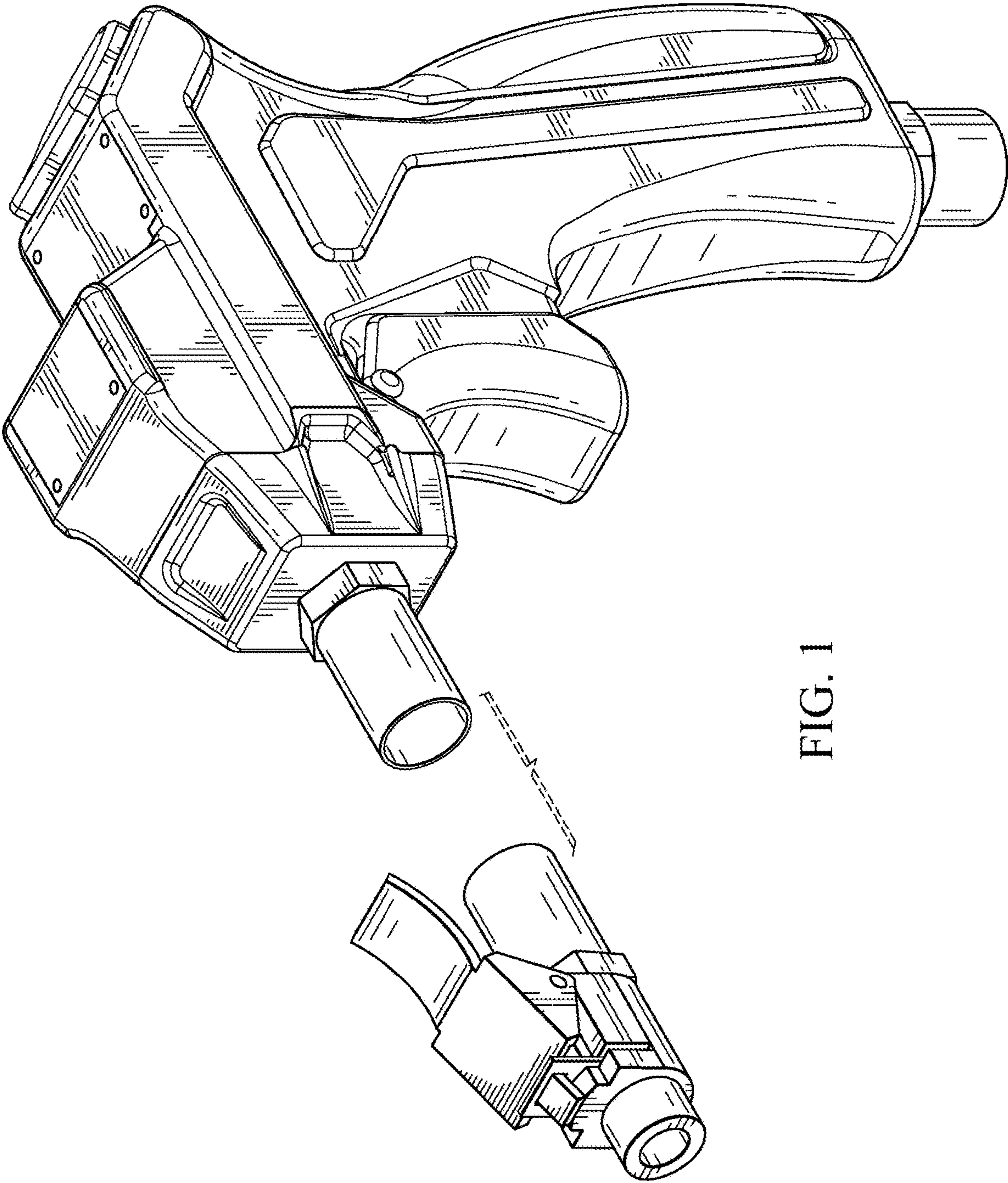

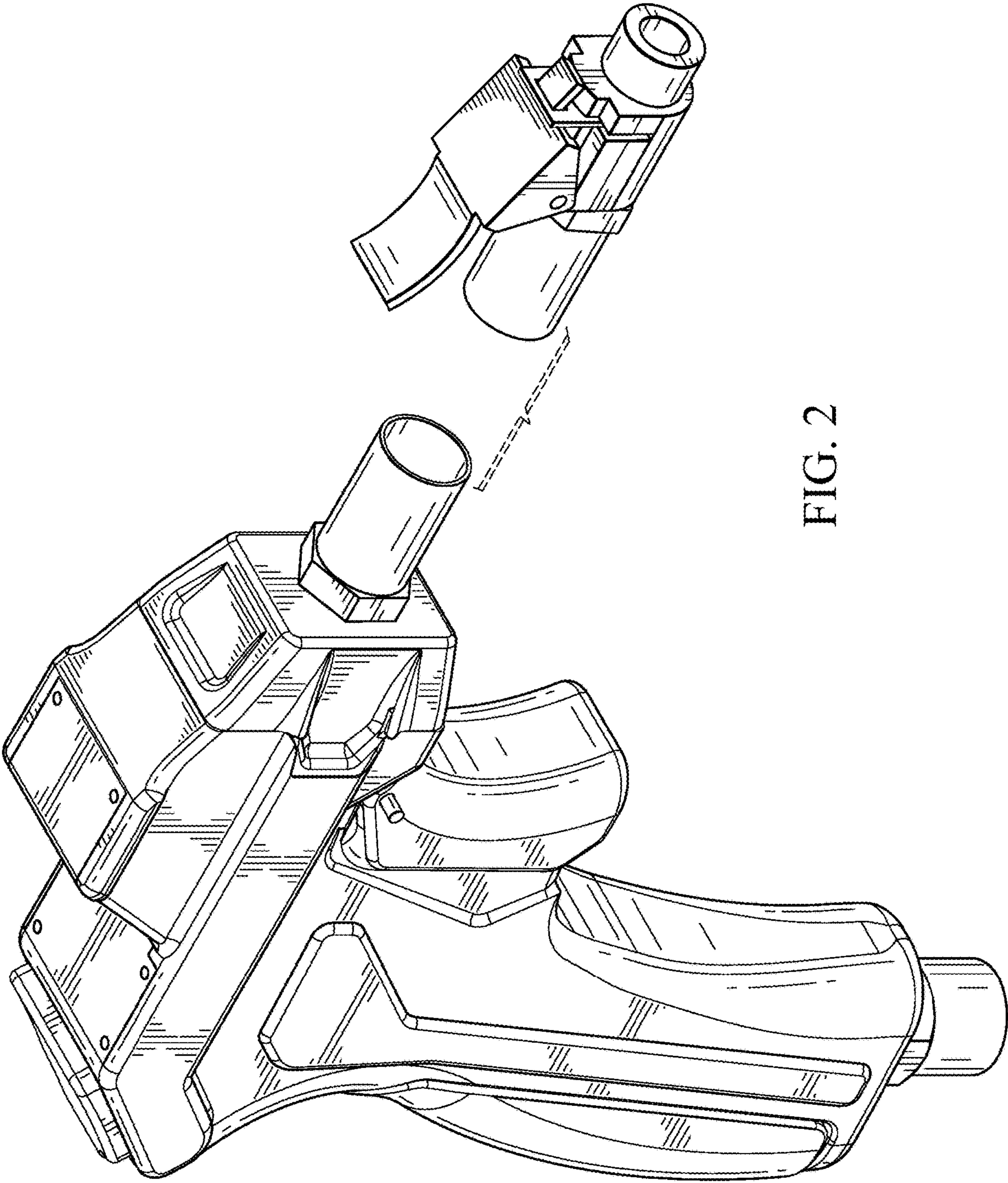

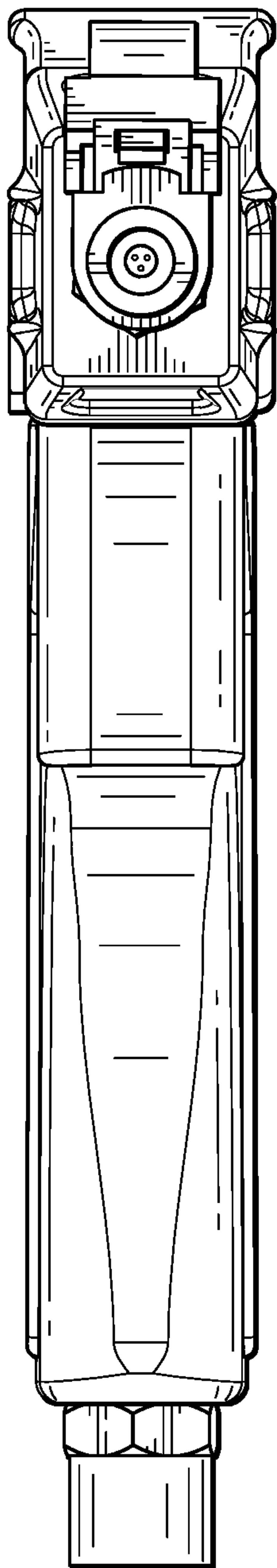

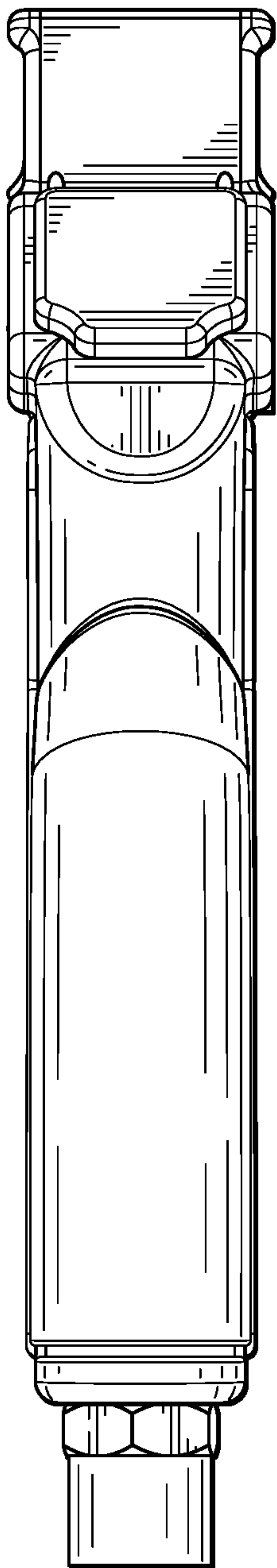

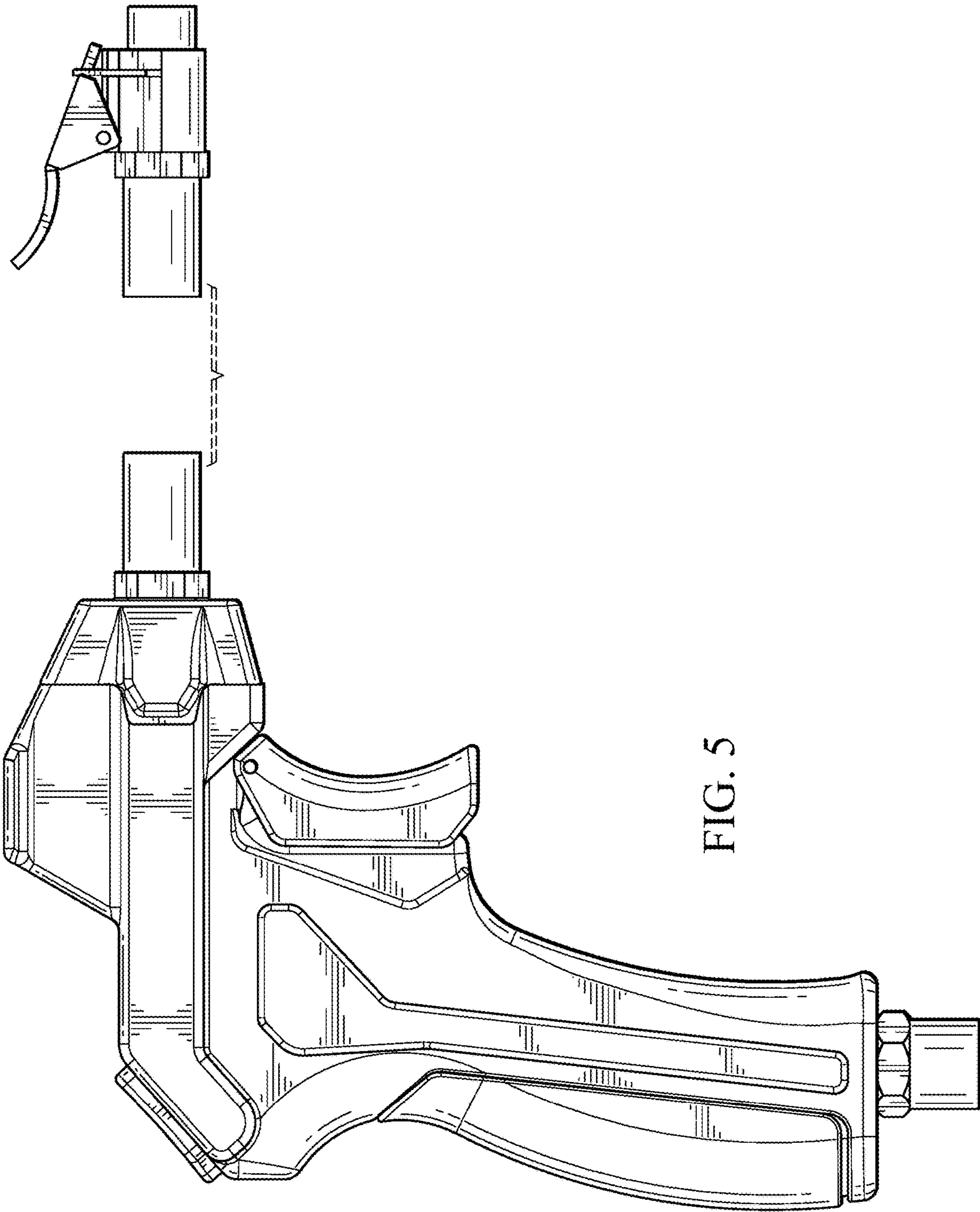

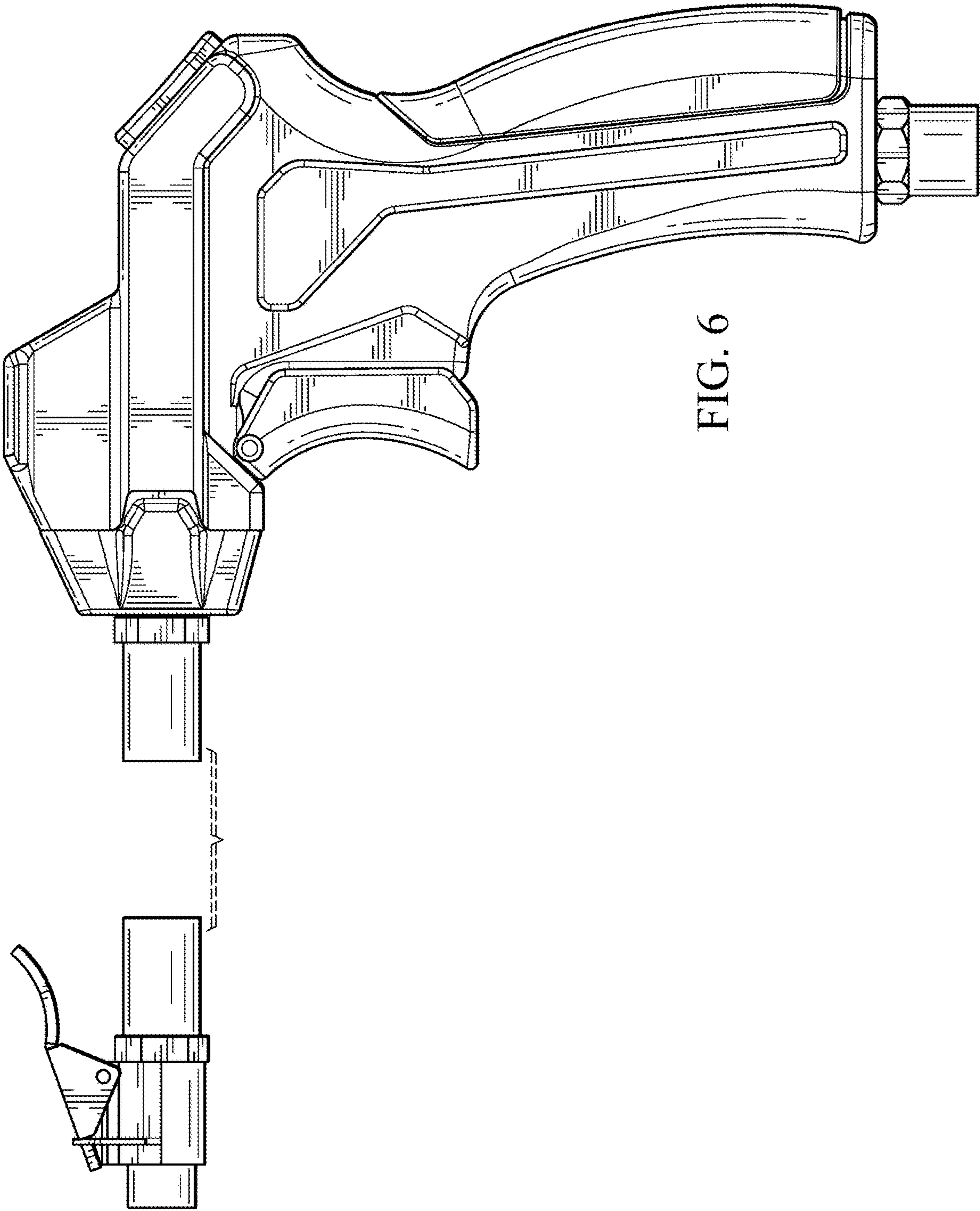

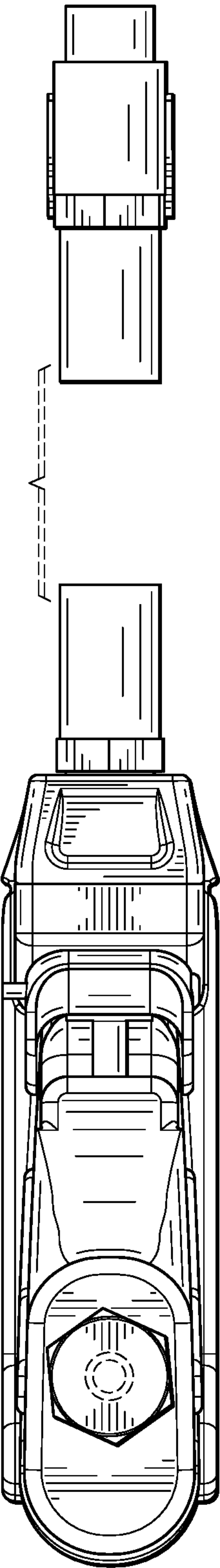

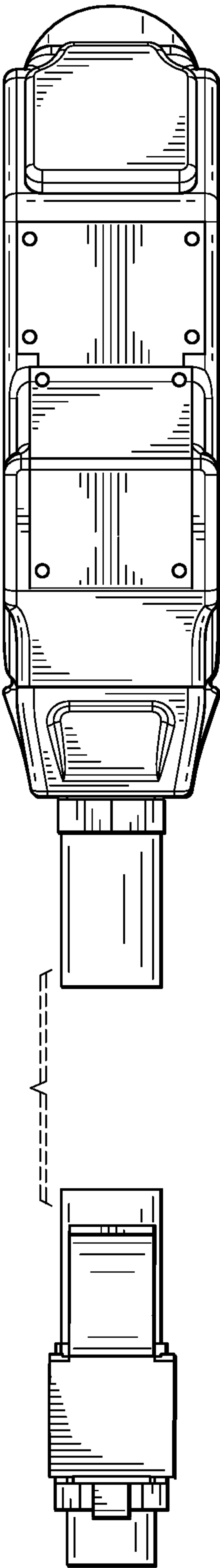
