bracelet that form no part of the claimed design.  
The bracelet is shown with a symbolic break in its length.  
The appearance of any portion of the bracelet between the  
break lines forms no part of the claimed design.

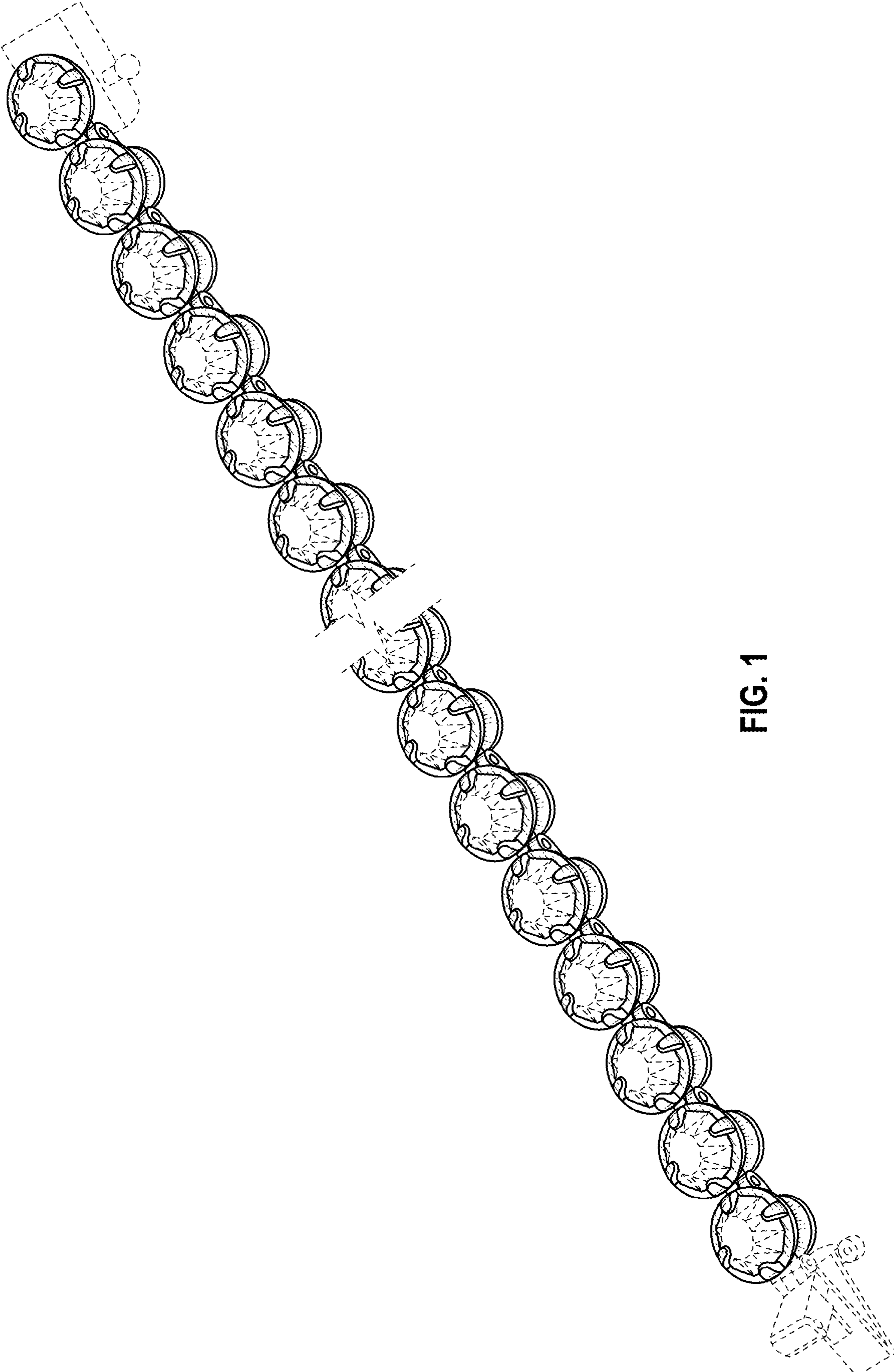
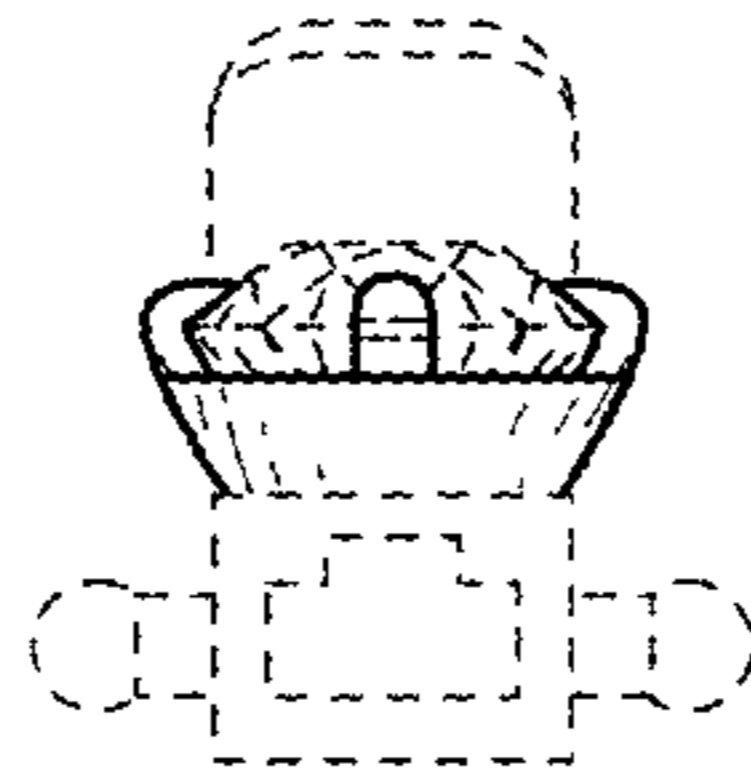
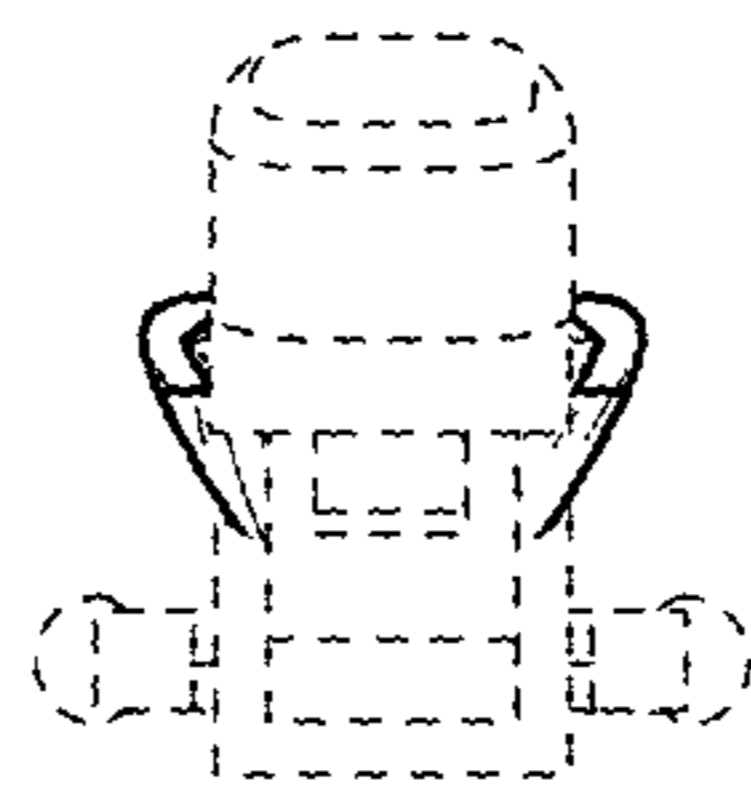

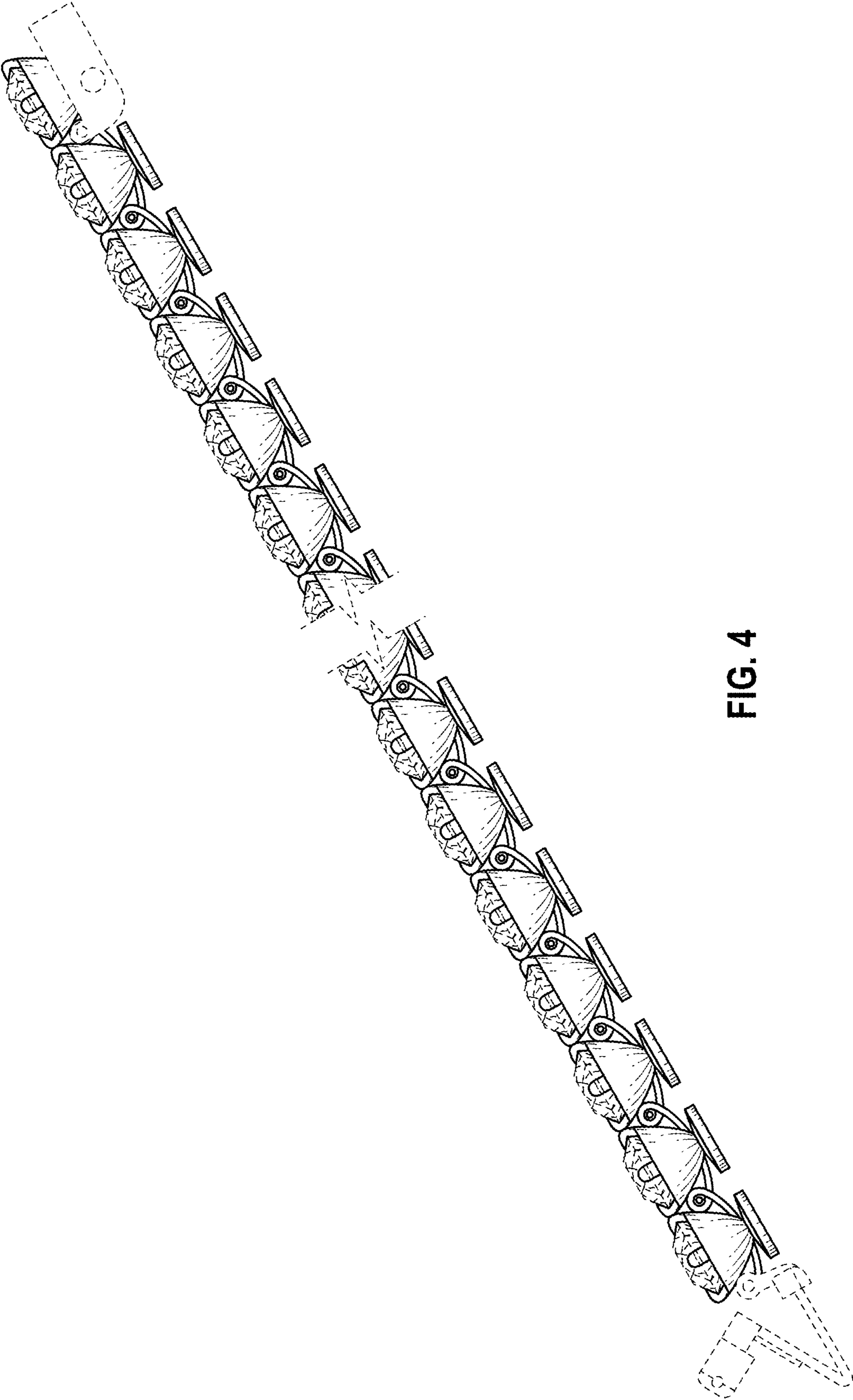

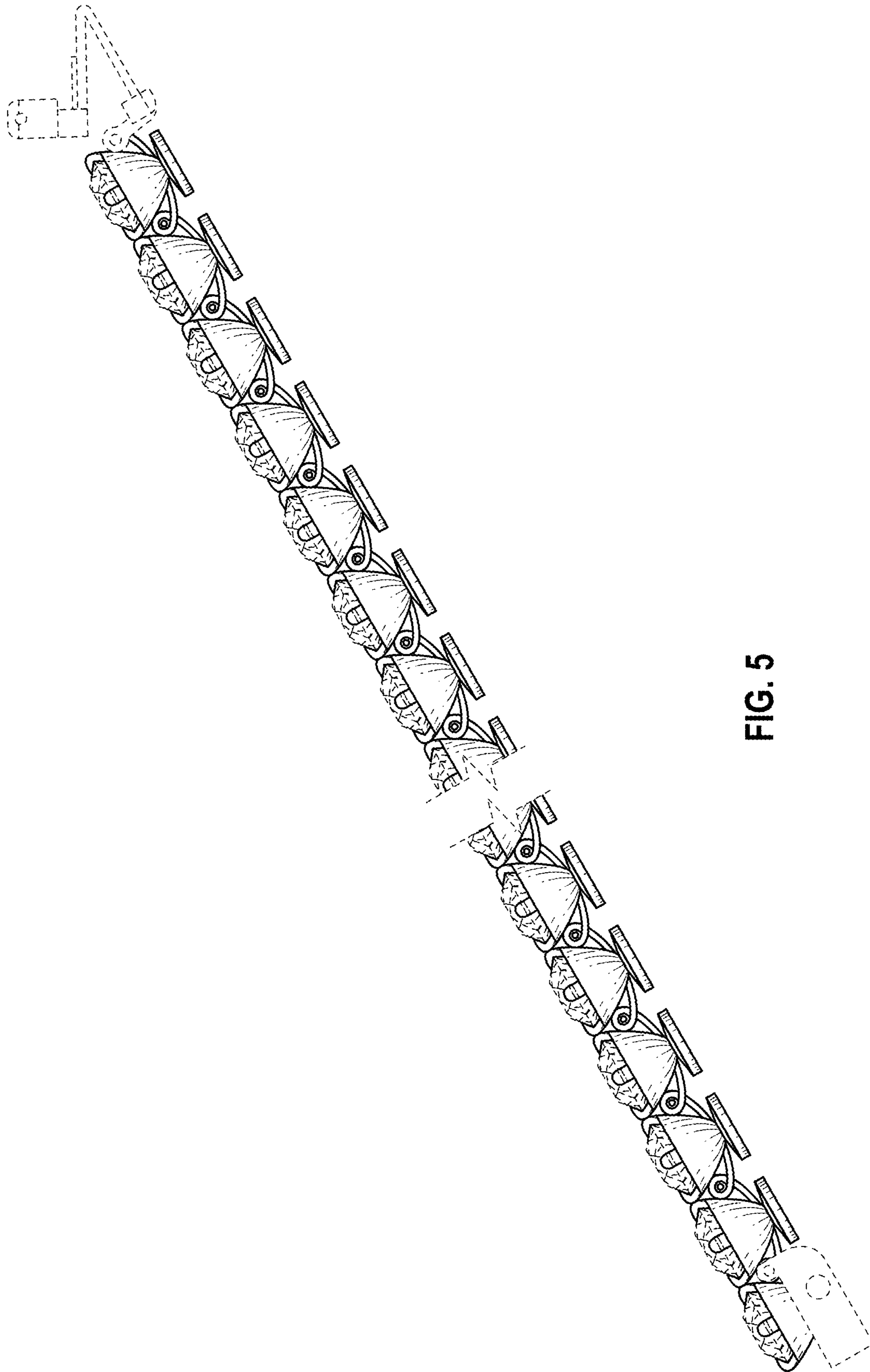

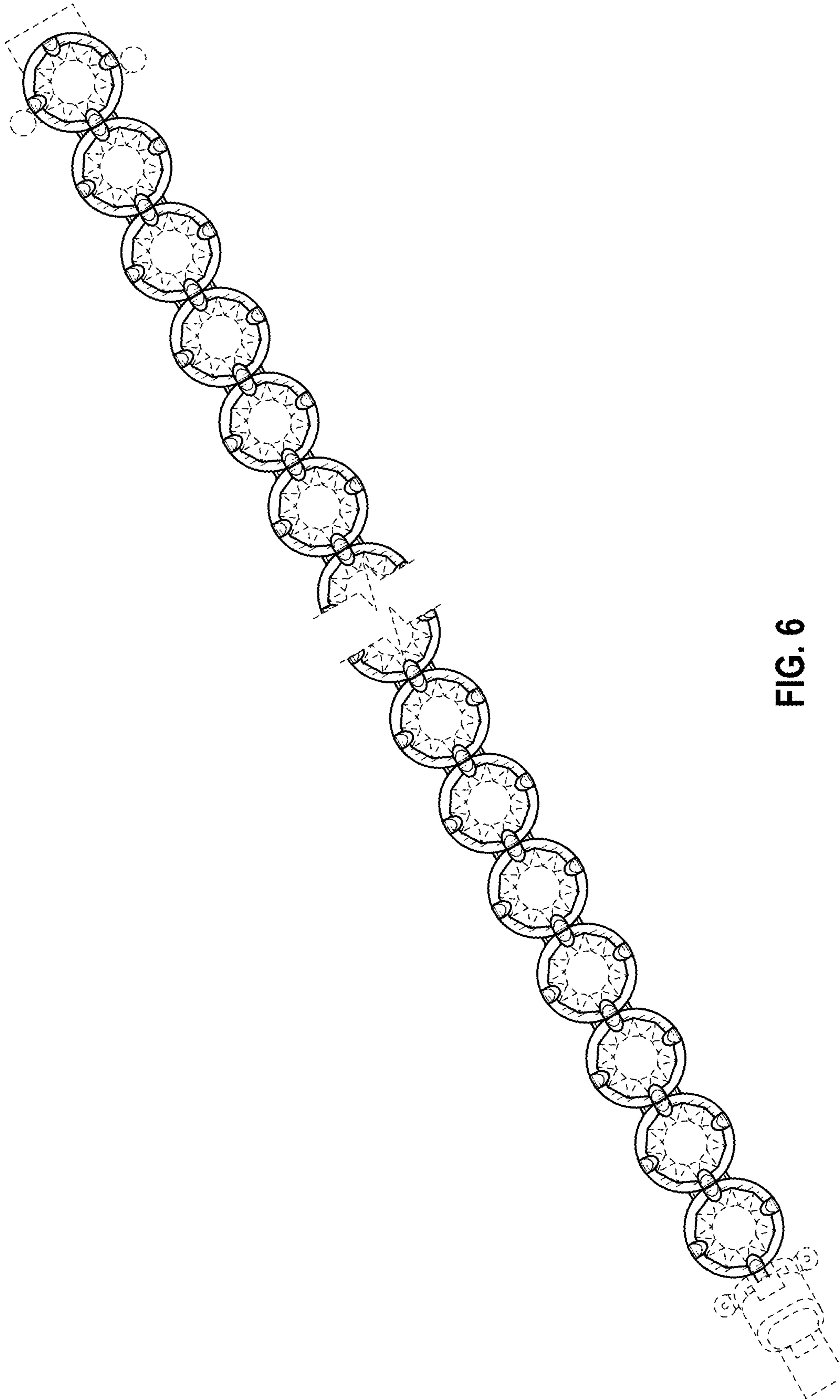

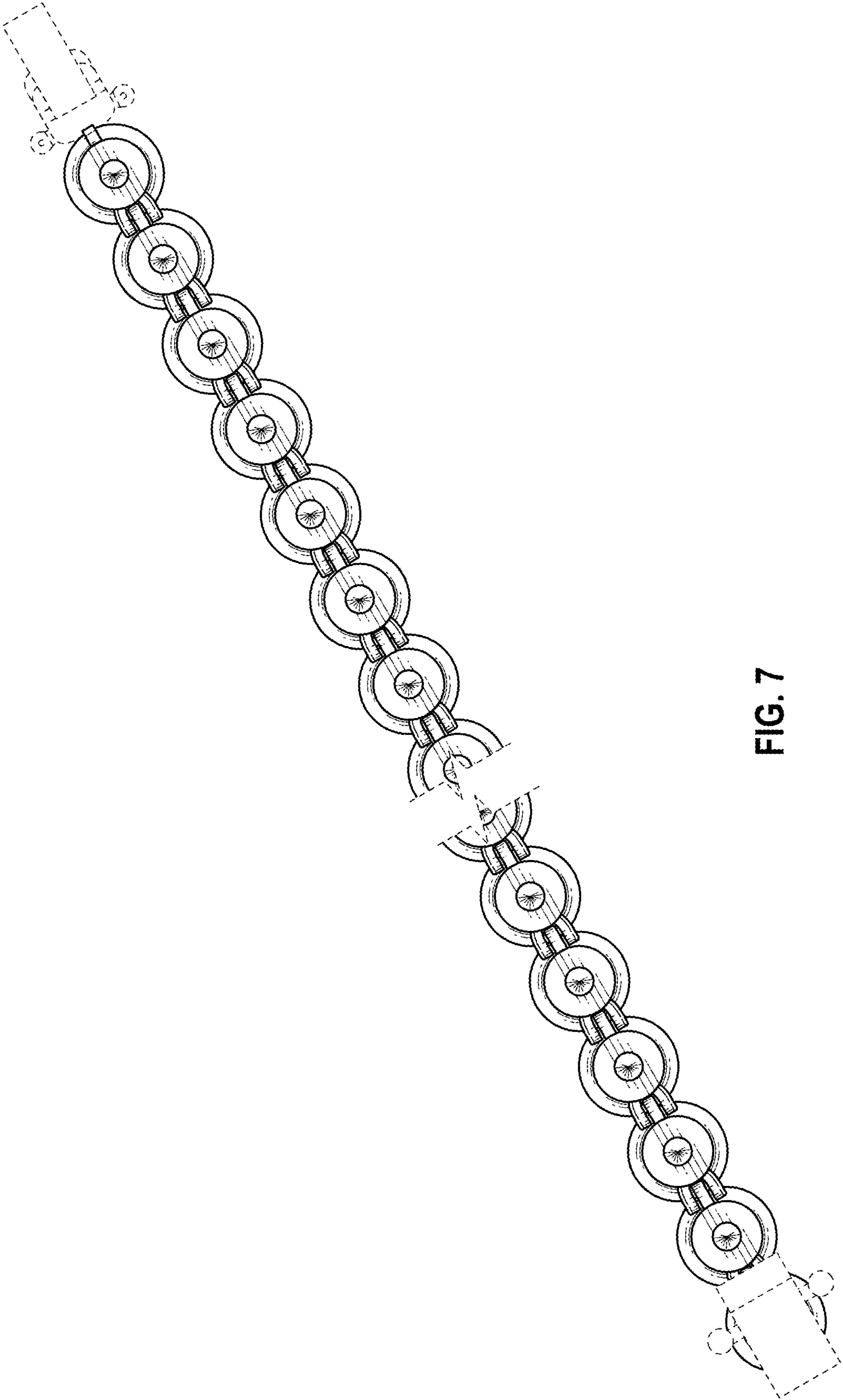

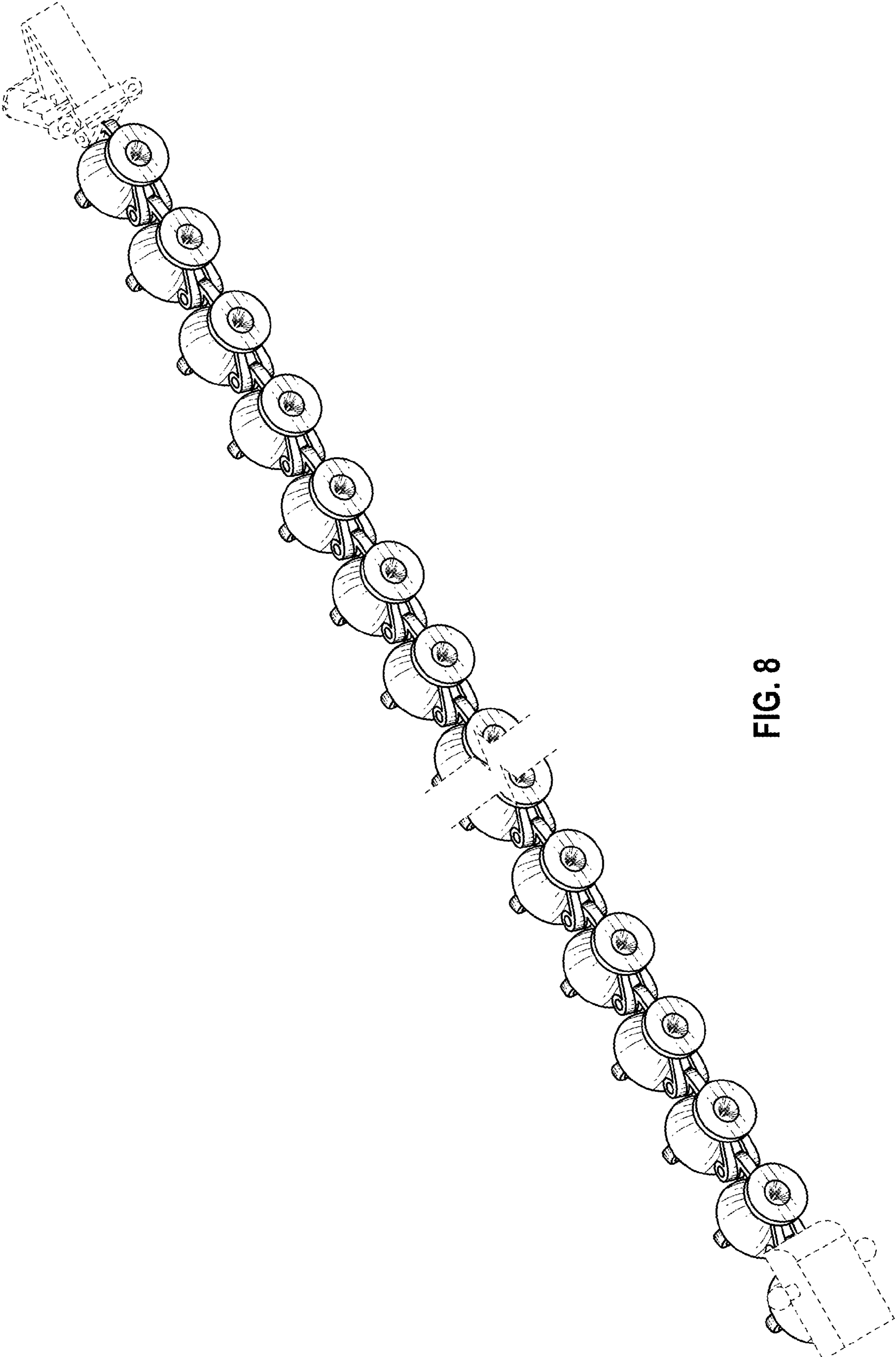
