FIG. 4 is a bottom view of FIG. 1;

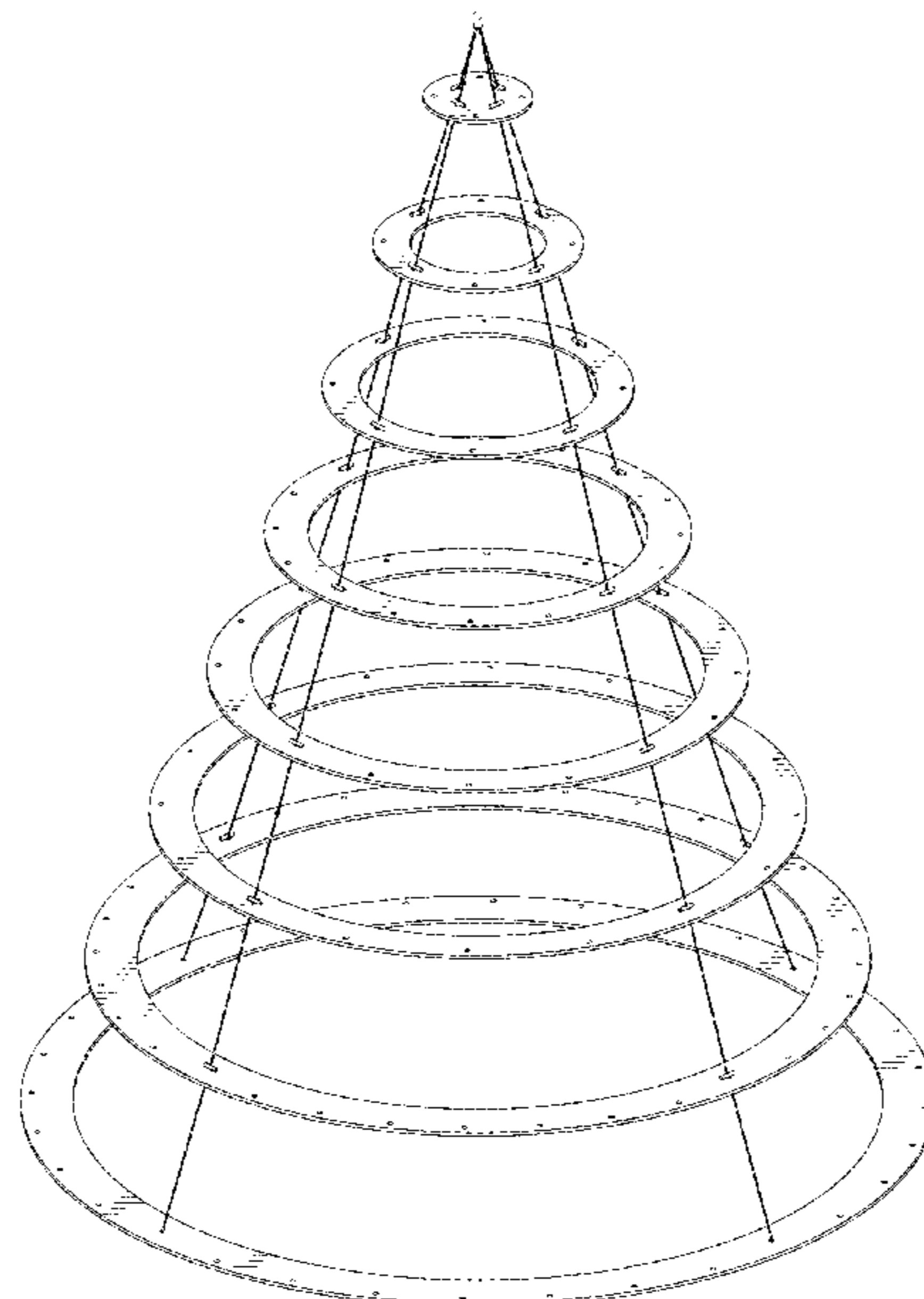
FIG. 5 is a perspective view of a second embodiment of a reusable Christmas tree, showing my new design;

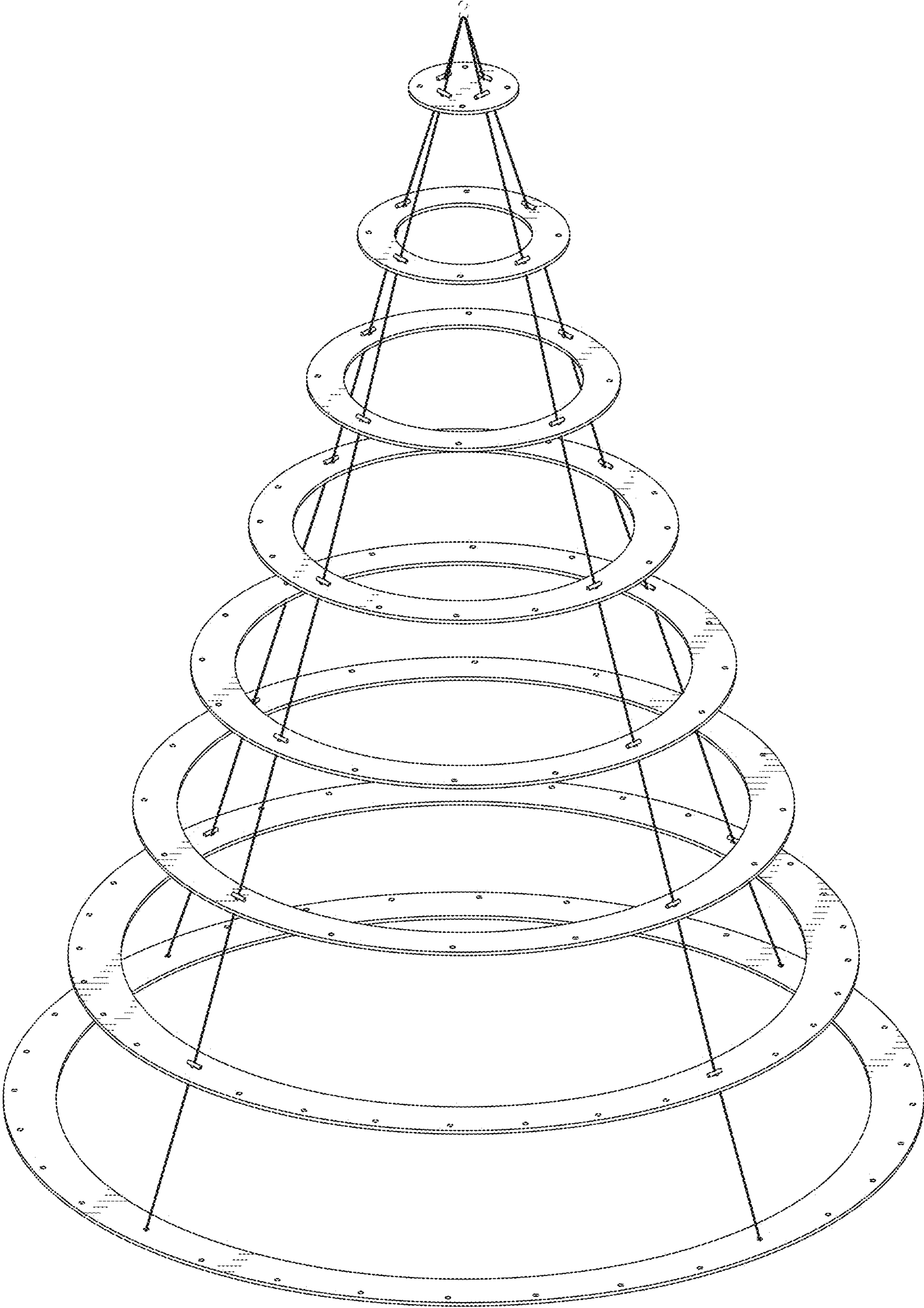

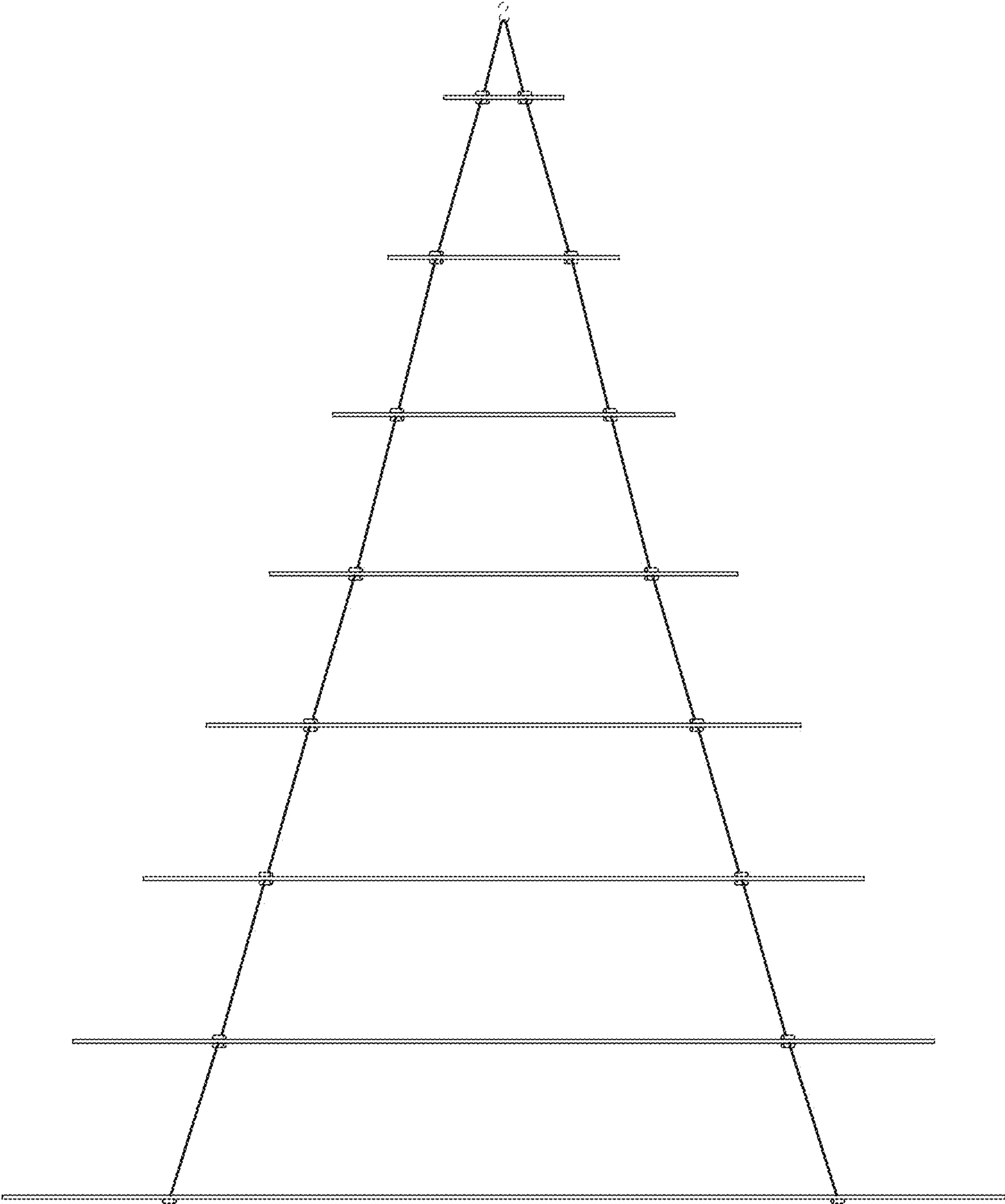

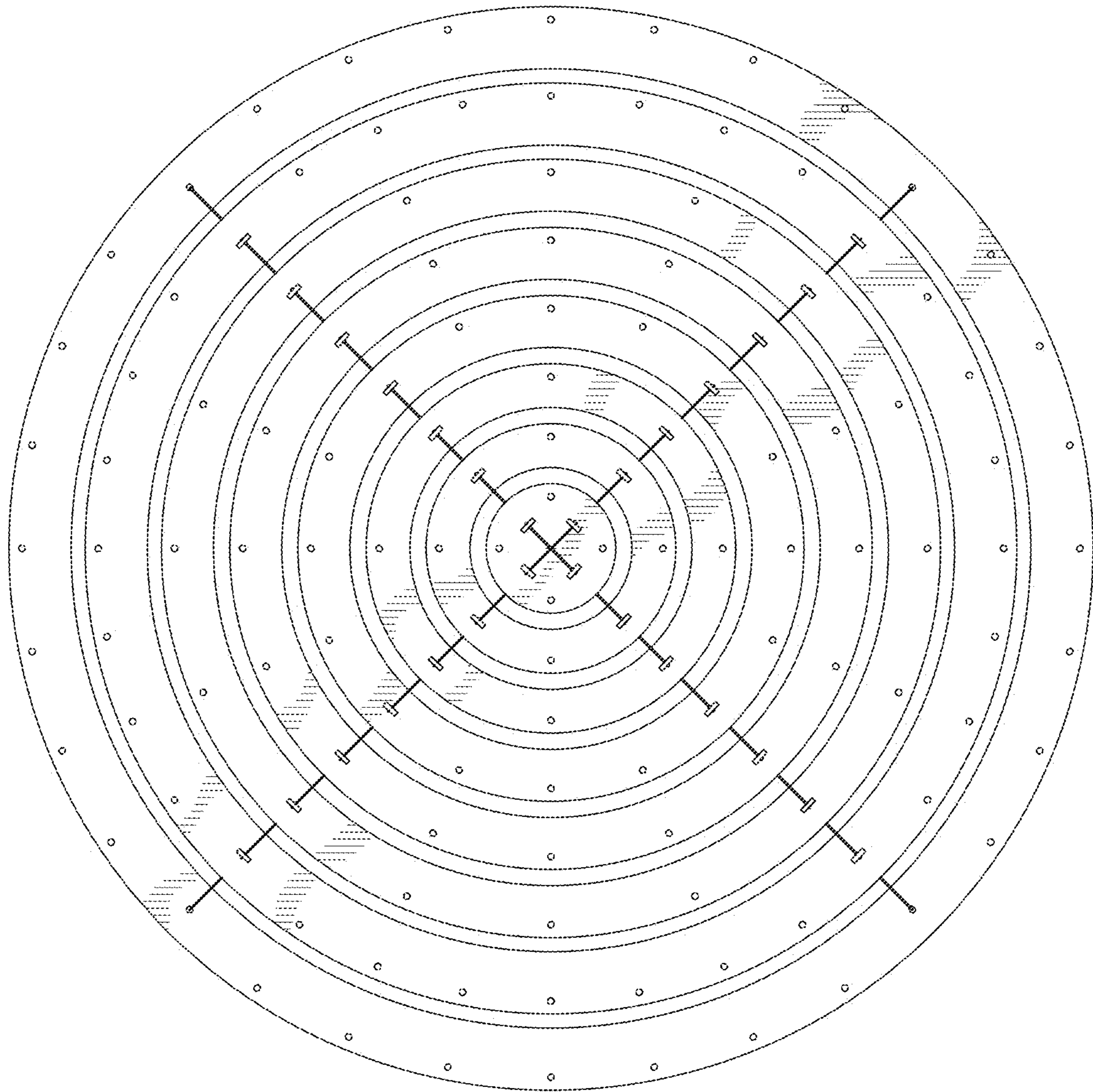

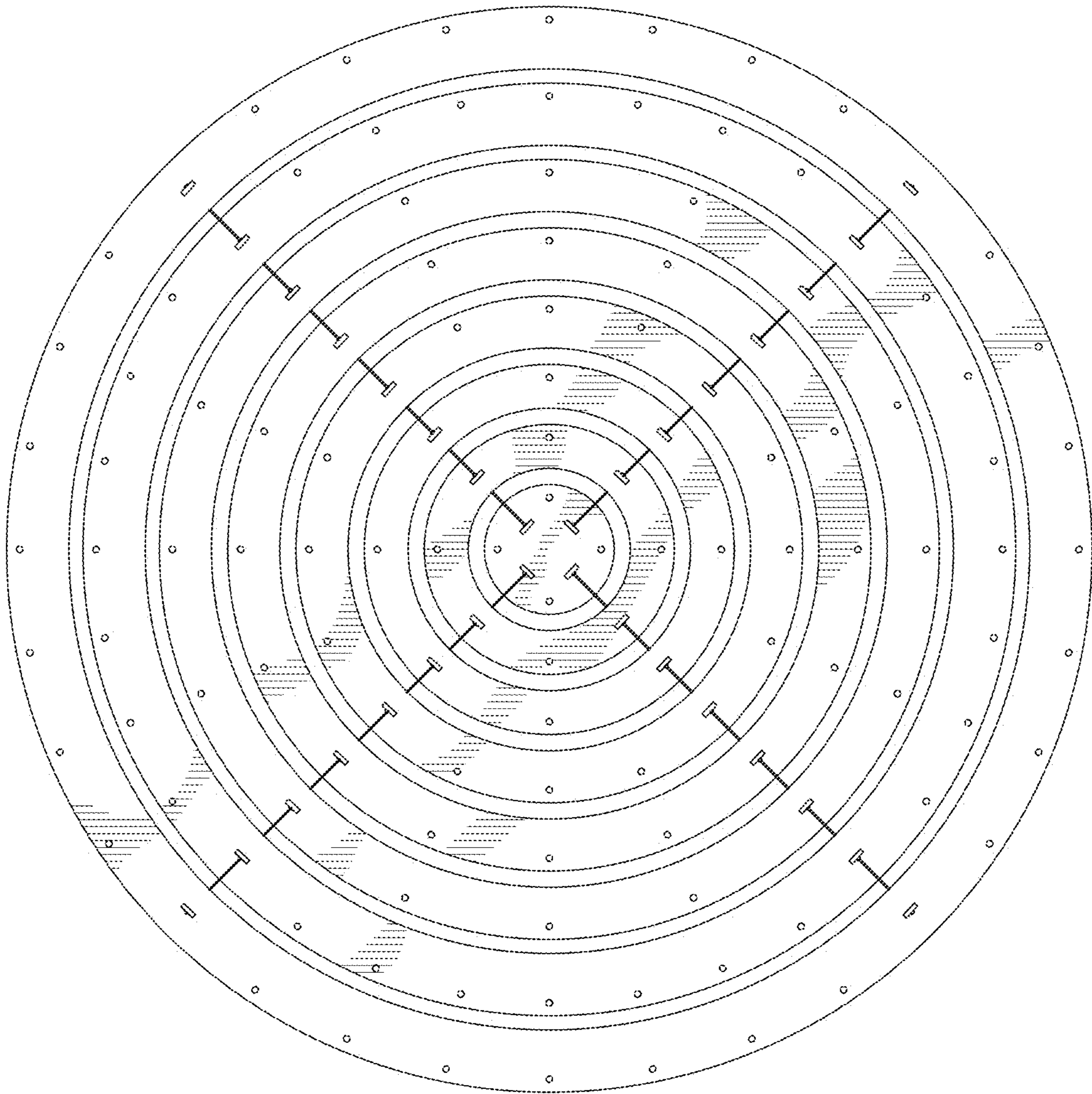

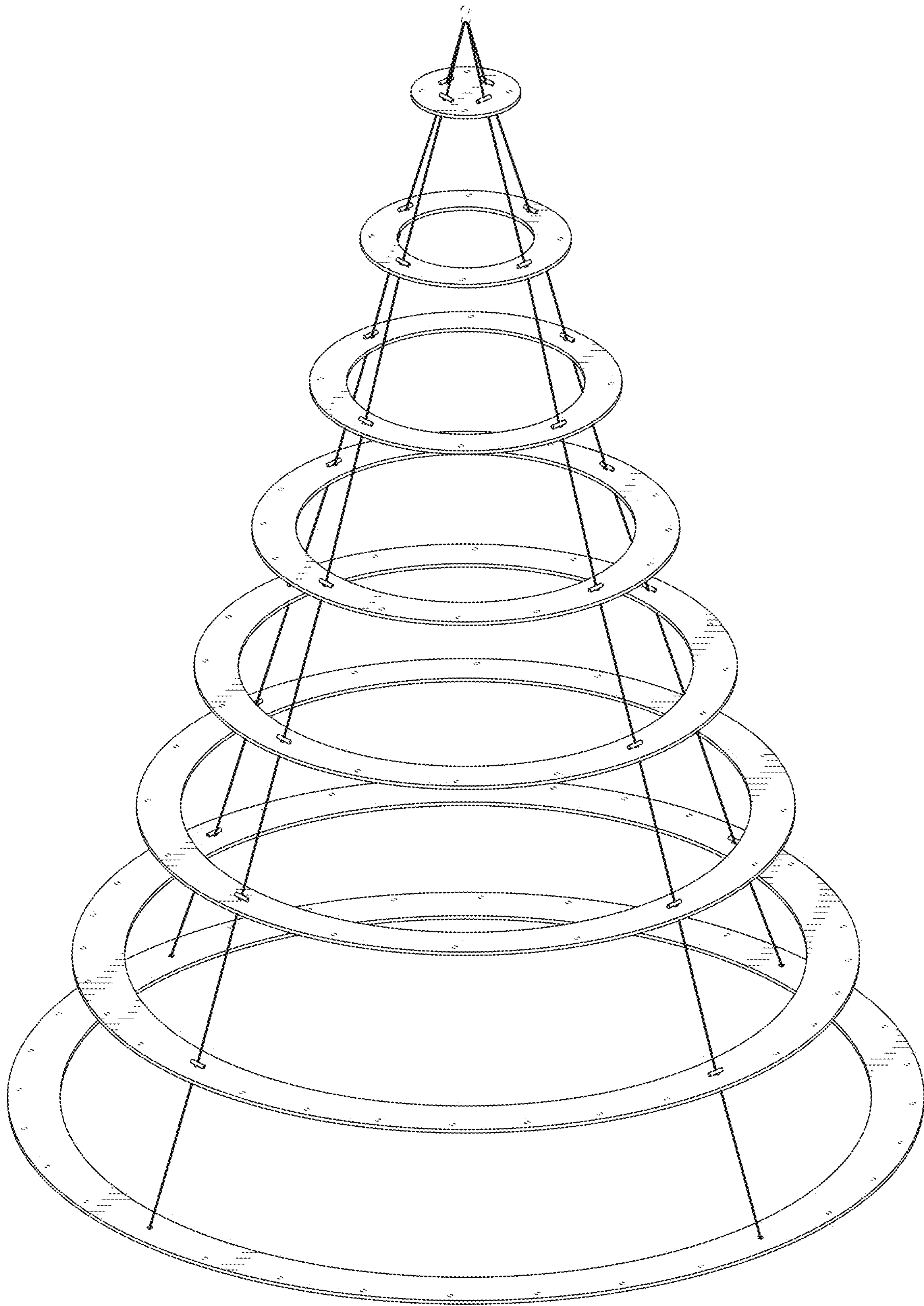

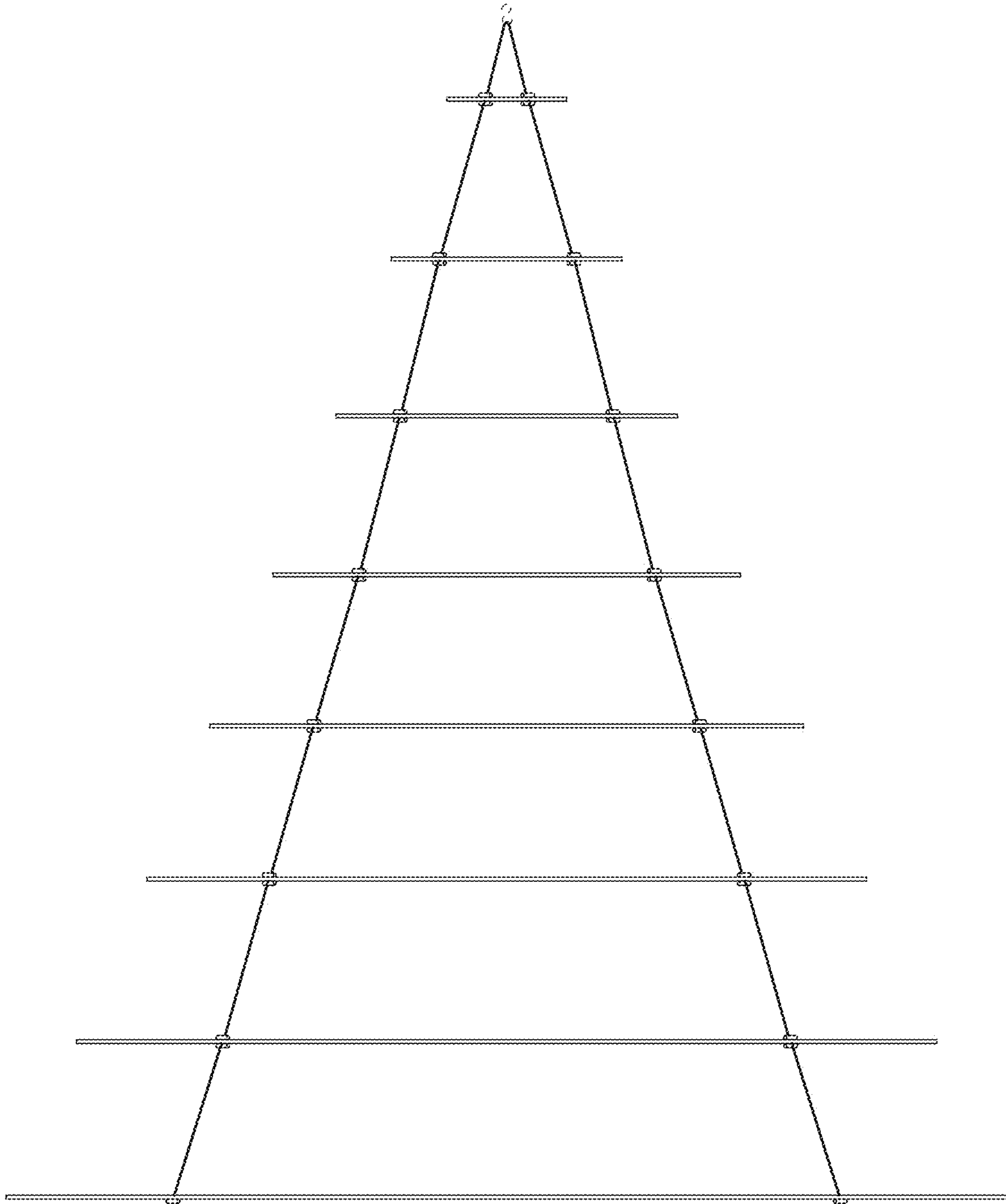

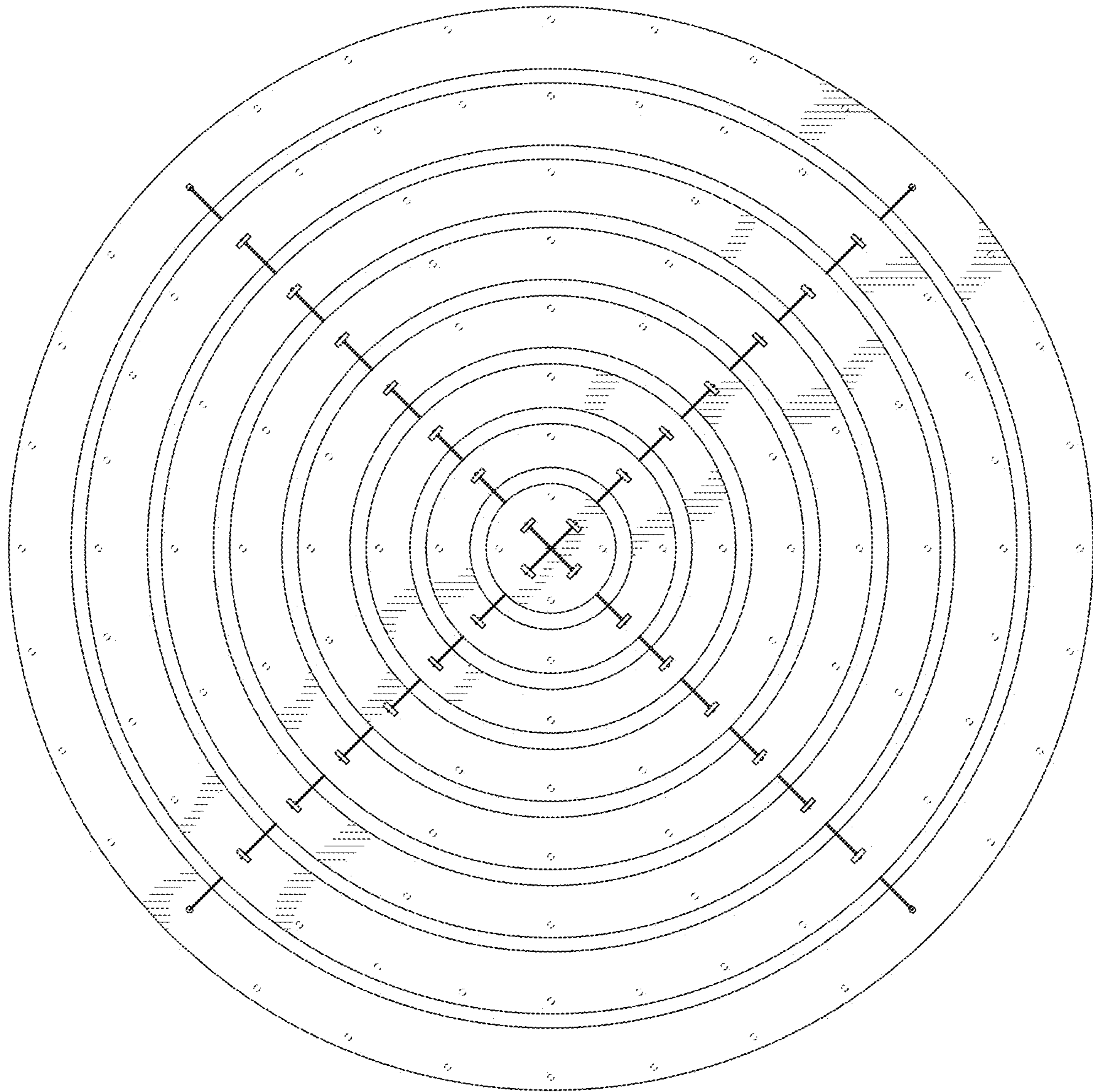

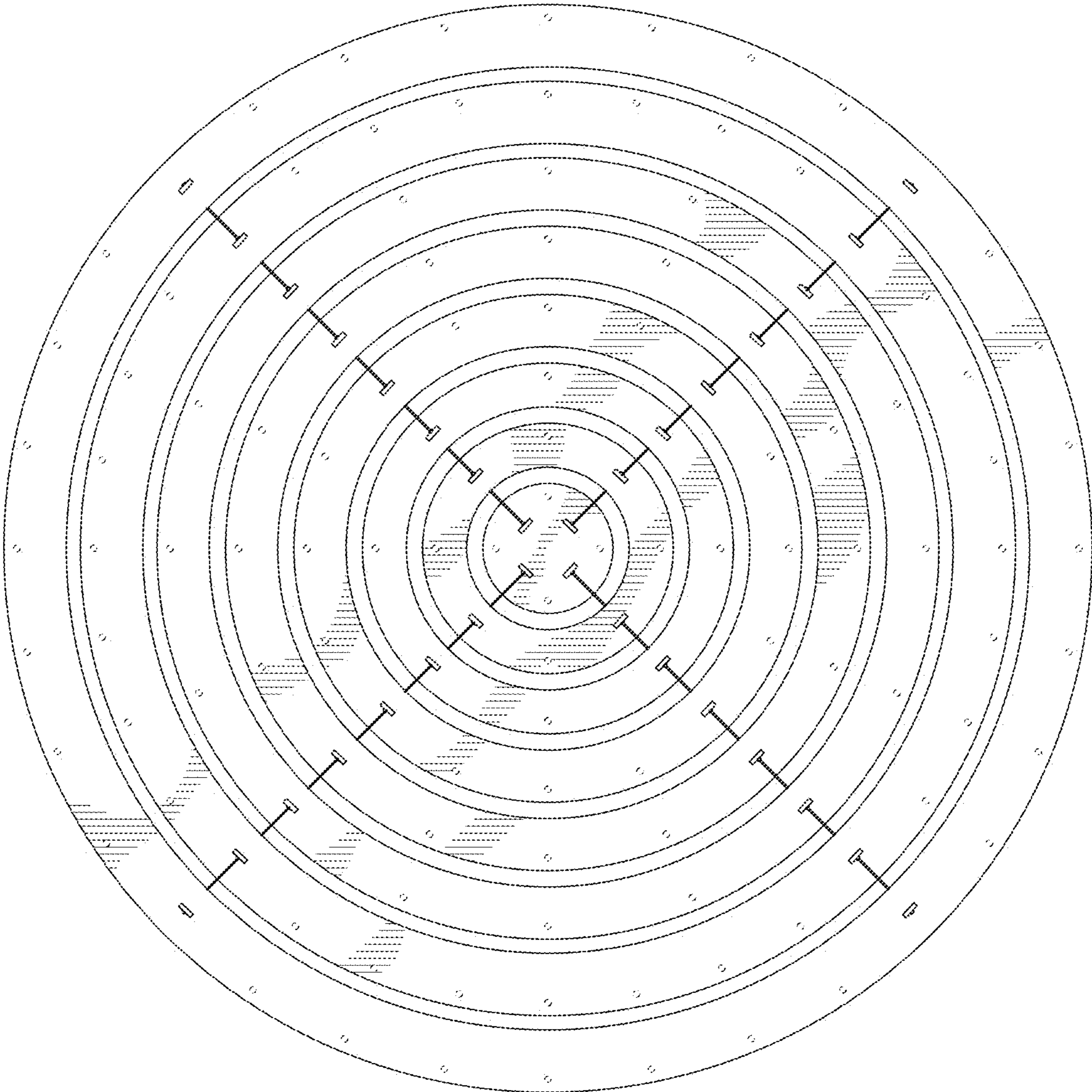
