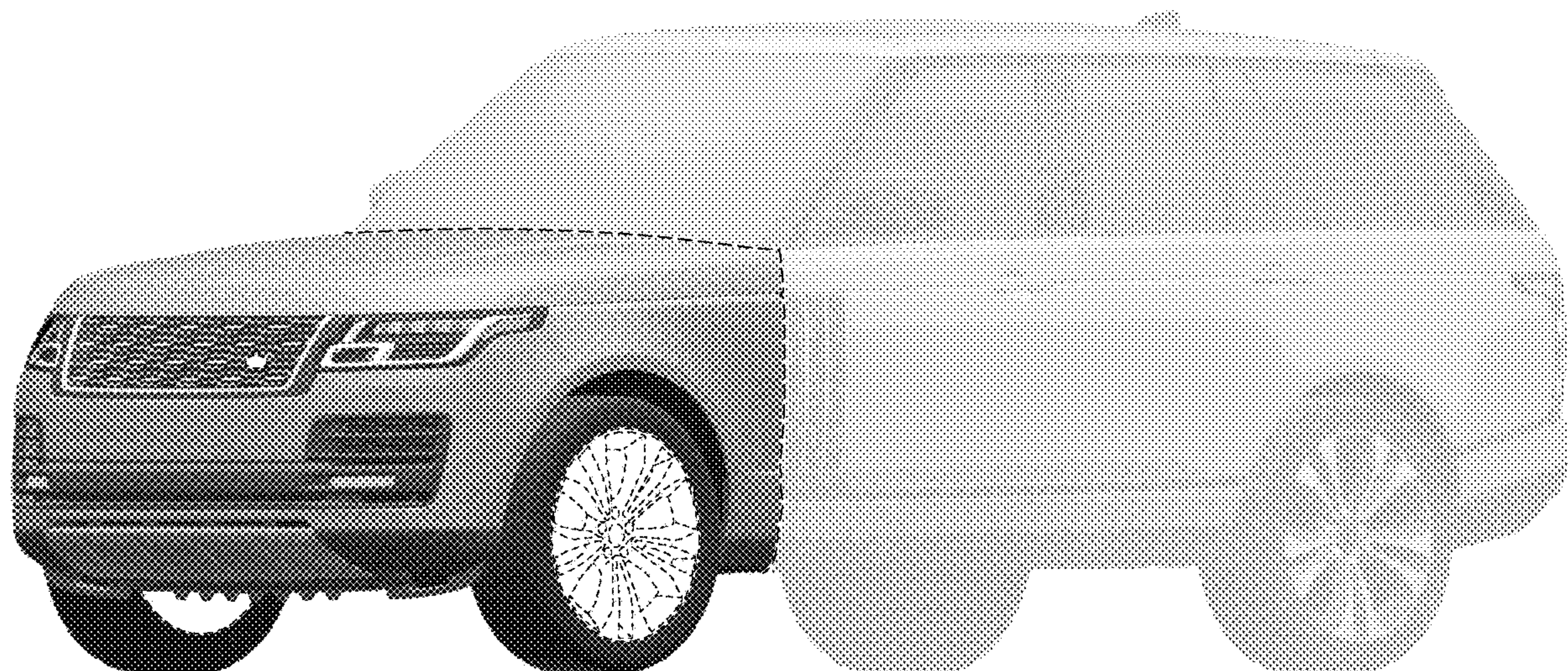
FIG. 1 is a right, front perspective view of a front end of a vehicle showing our new design;

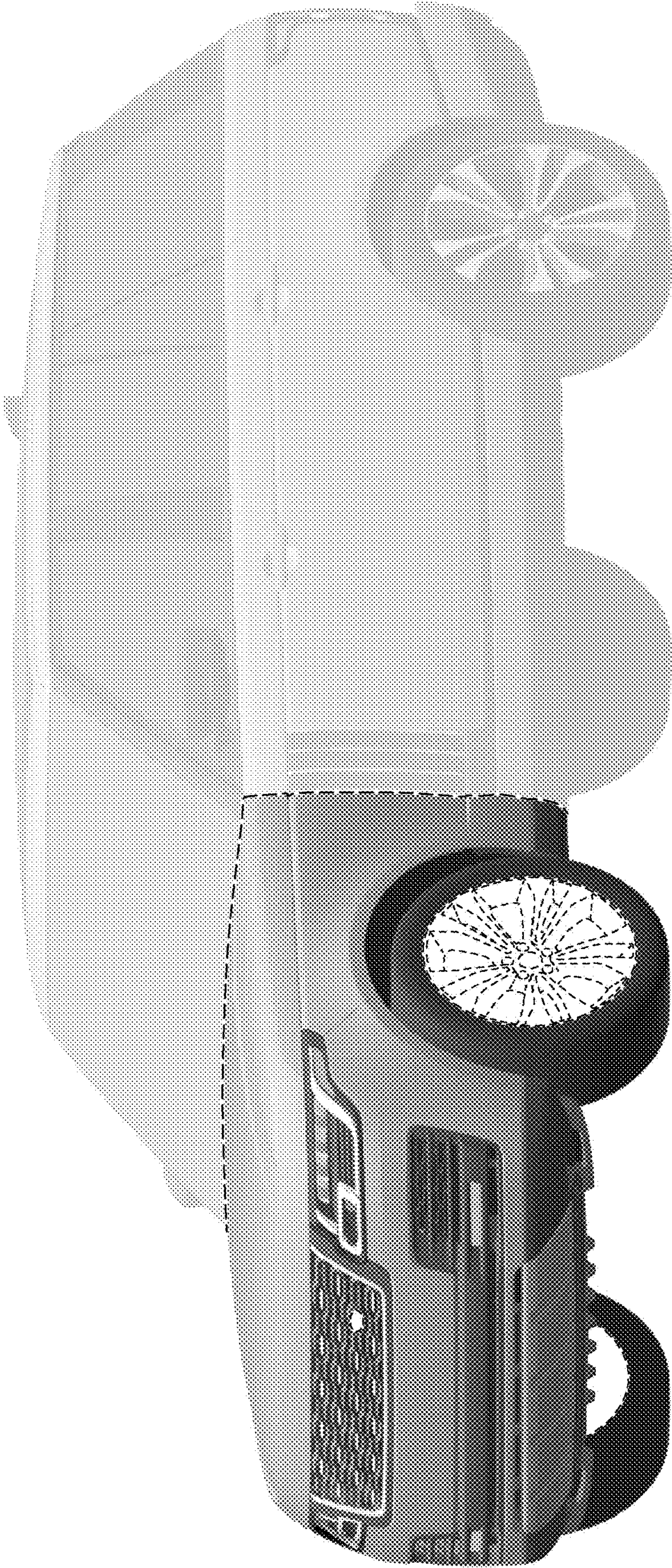

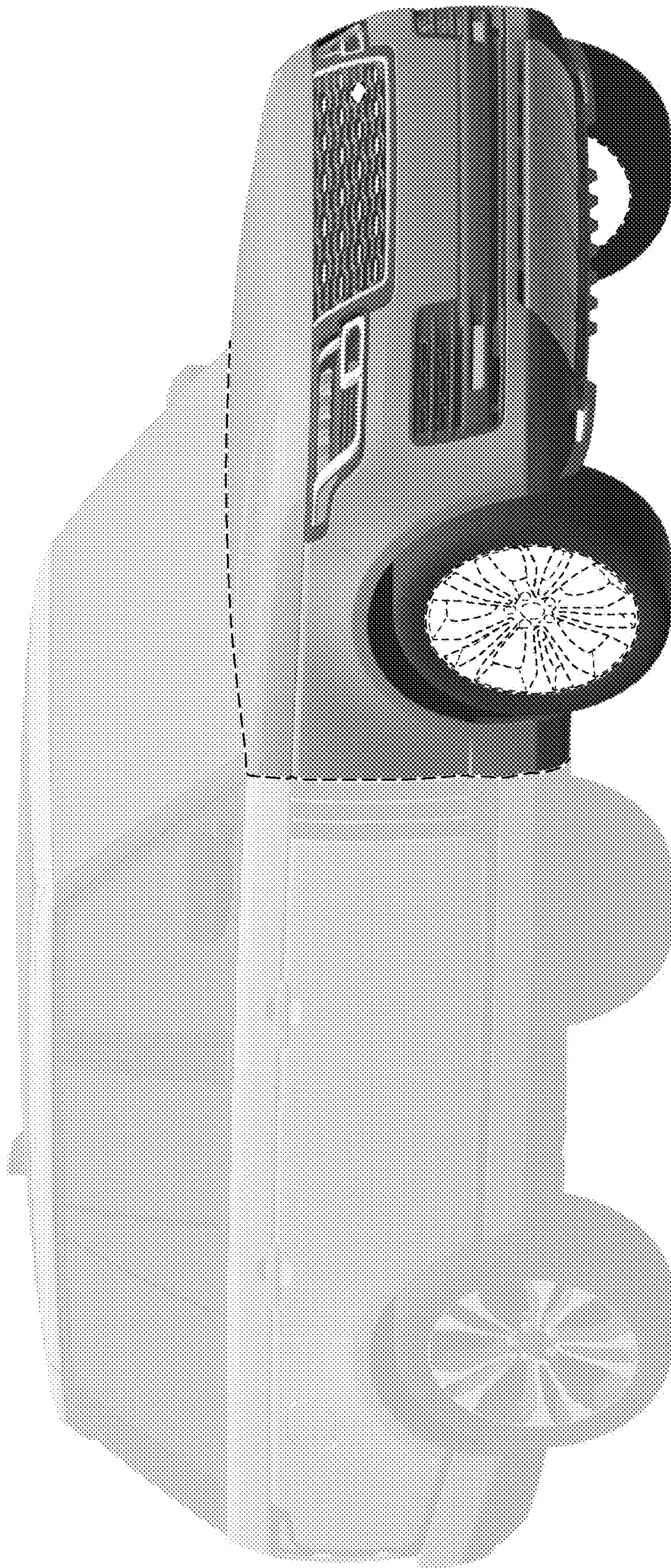

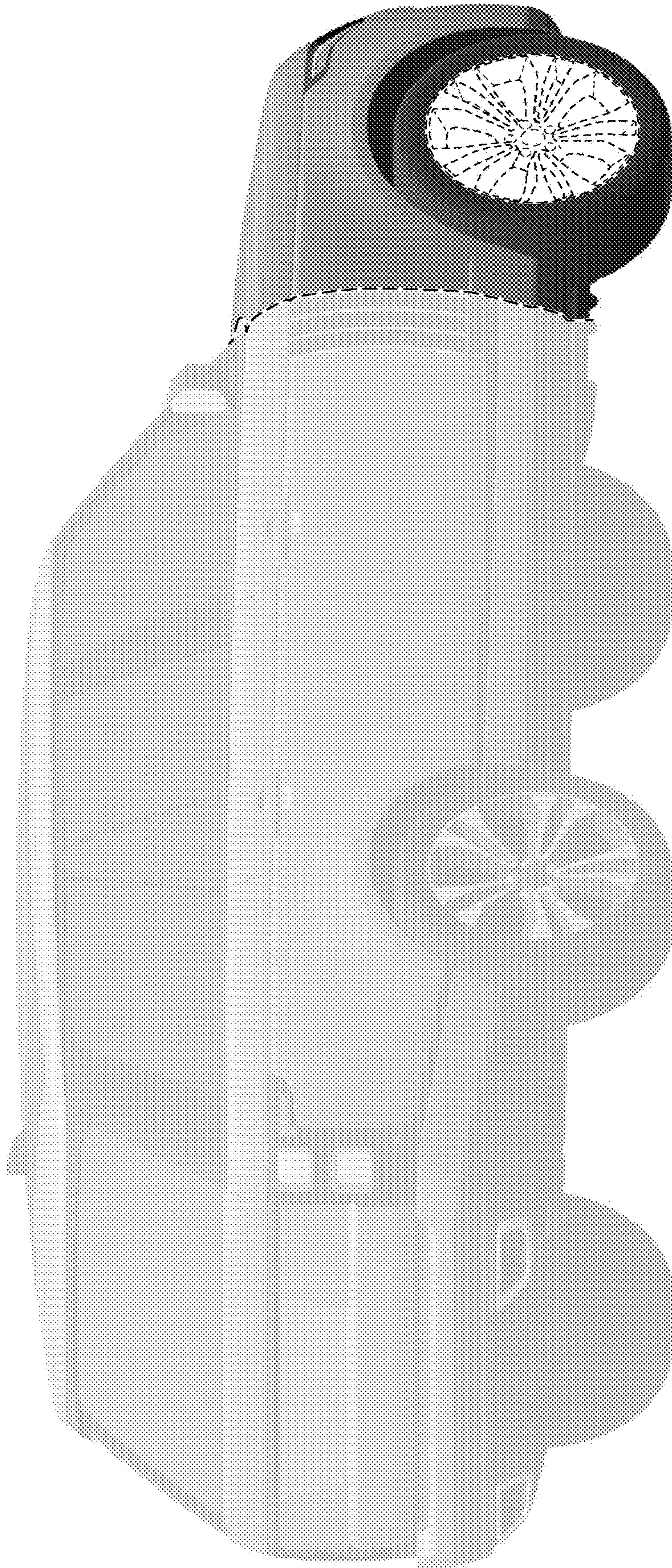

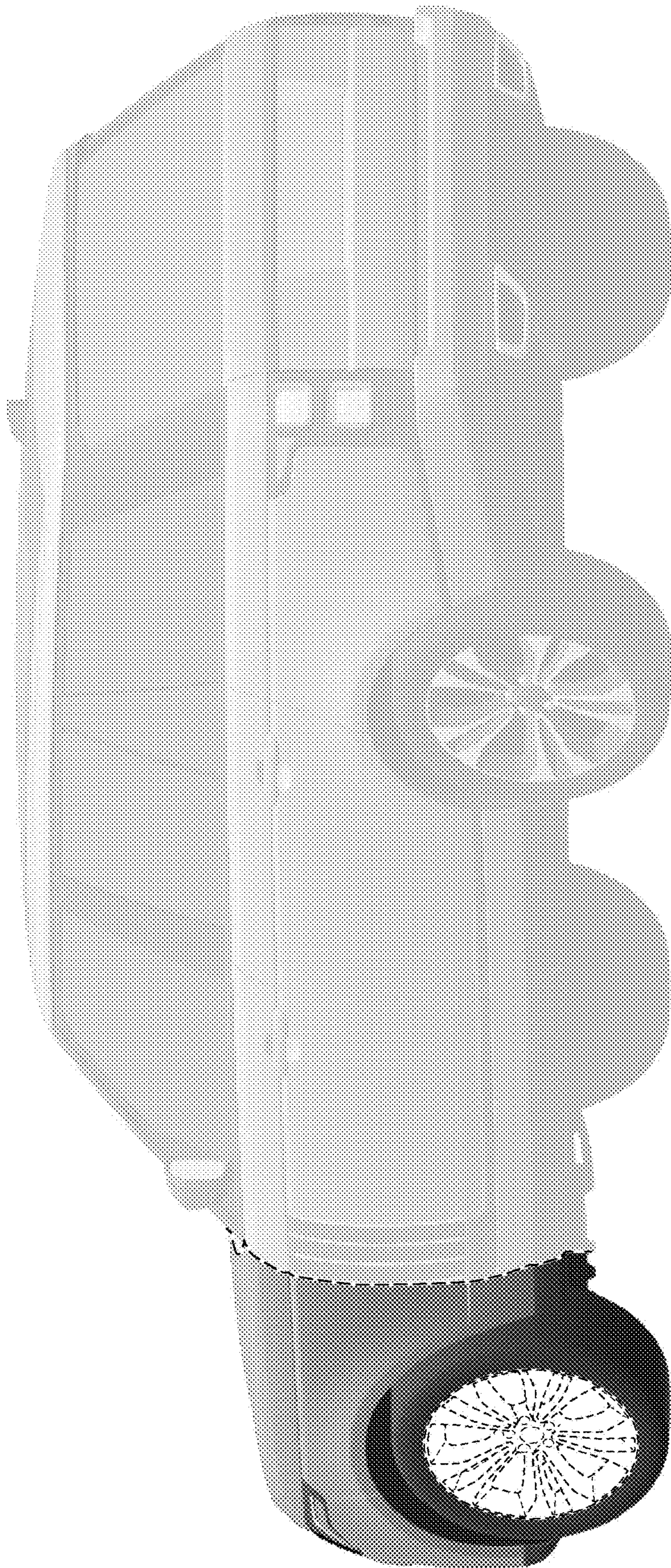

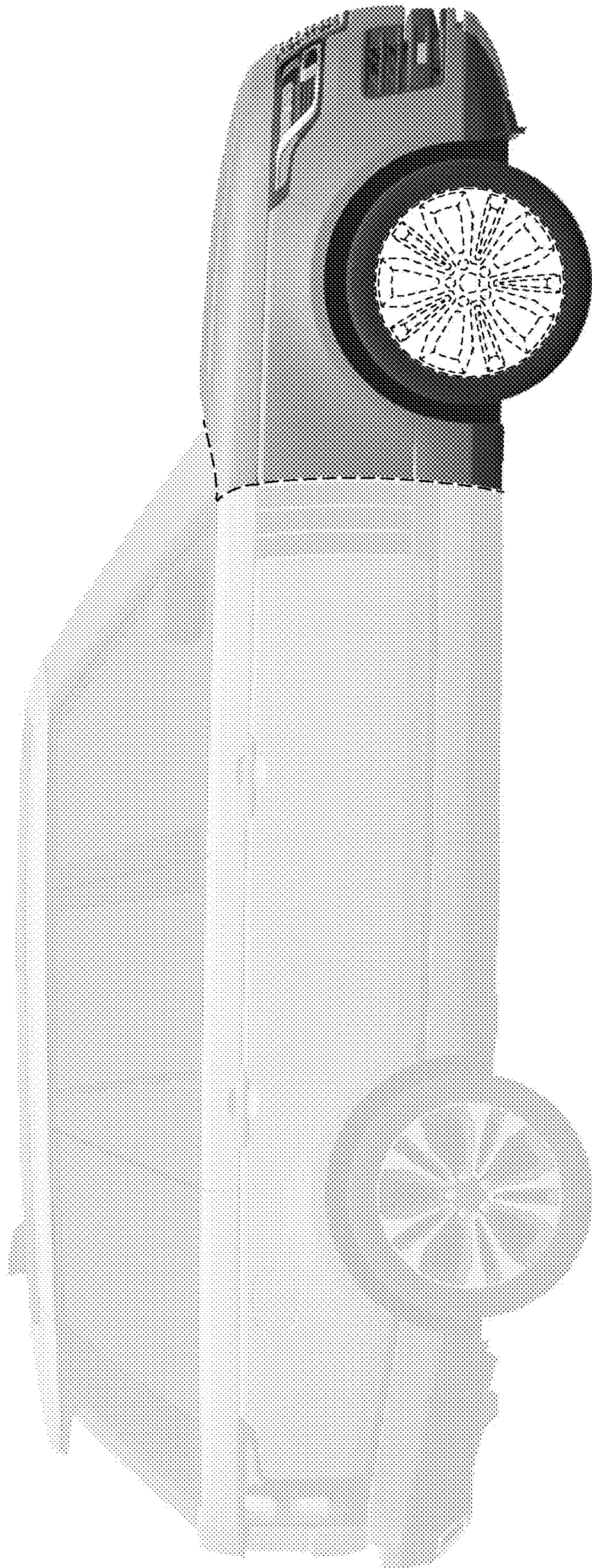

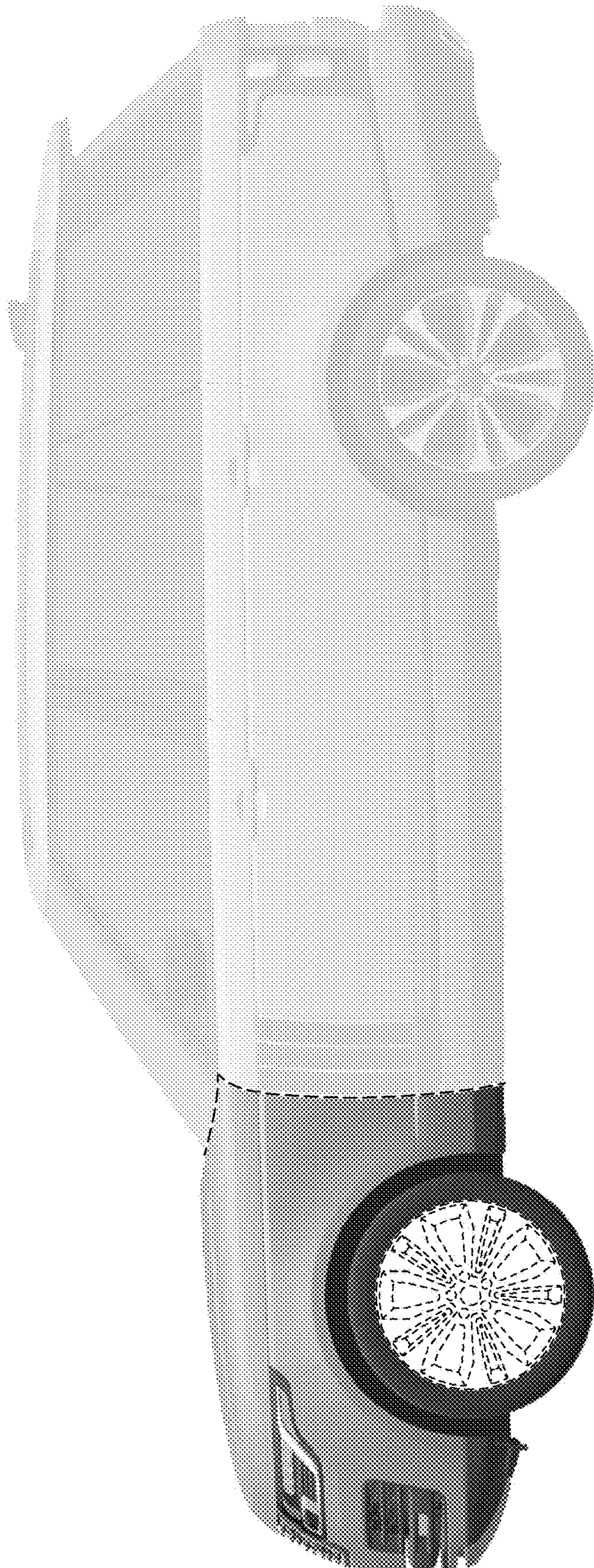
