In the drawings the broken lines depict environmental subject matter and form no part of the claimed design.

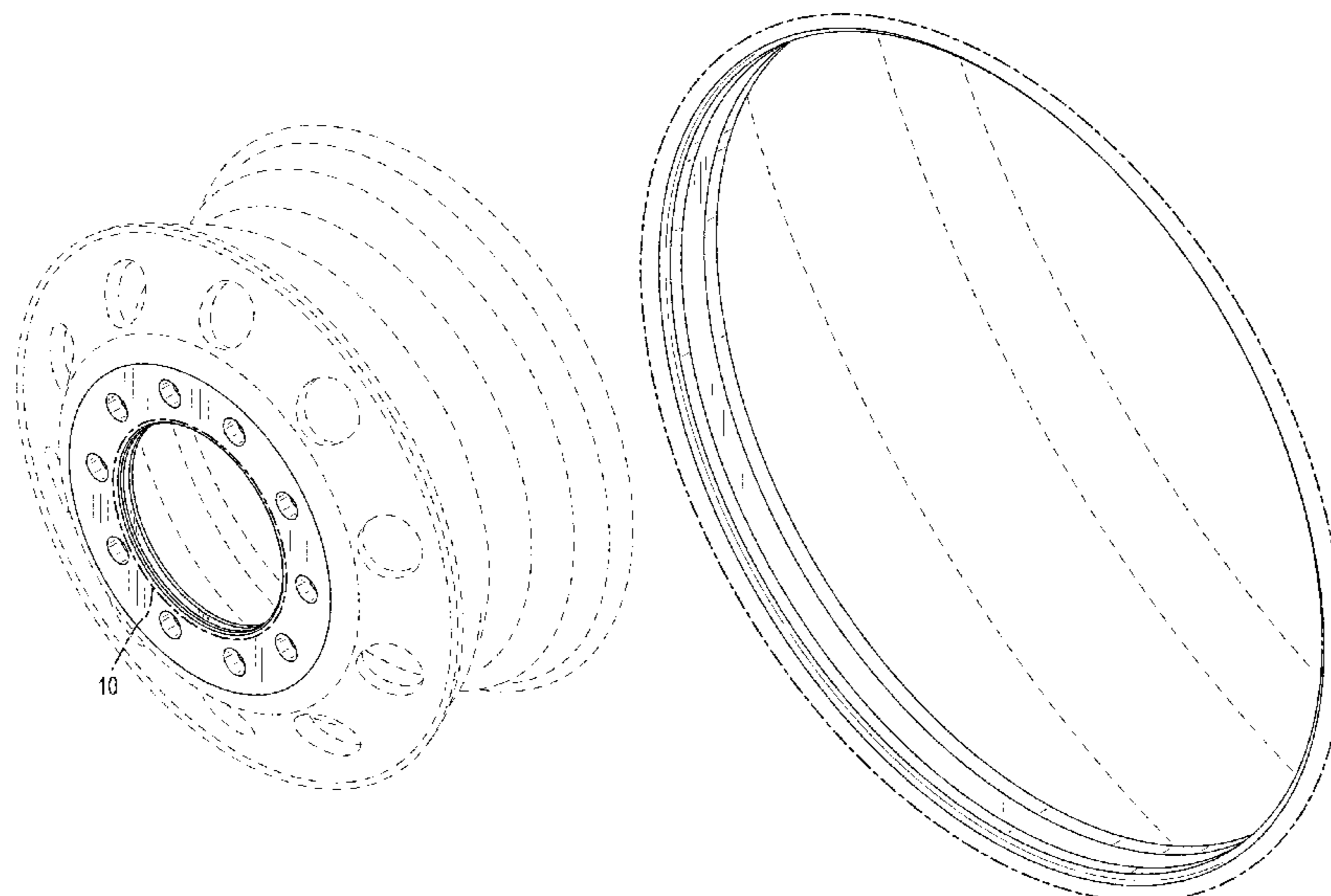

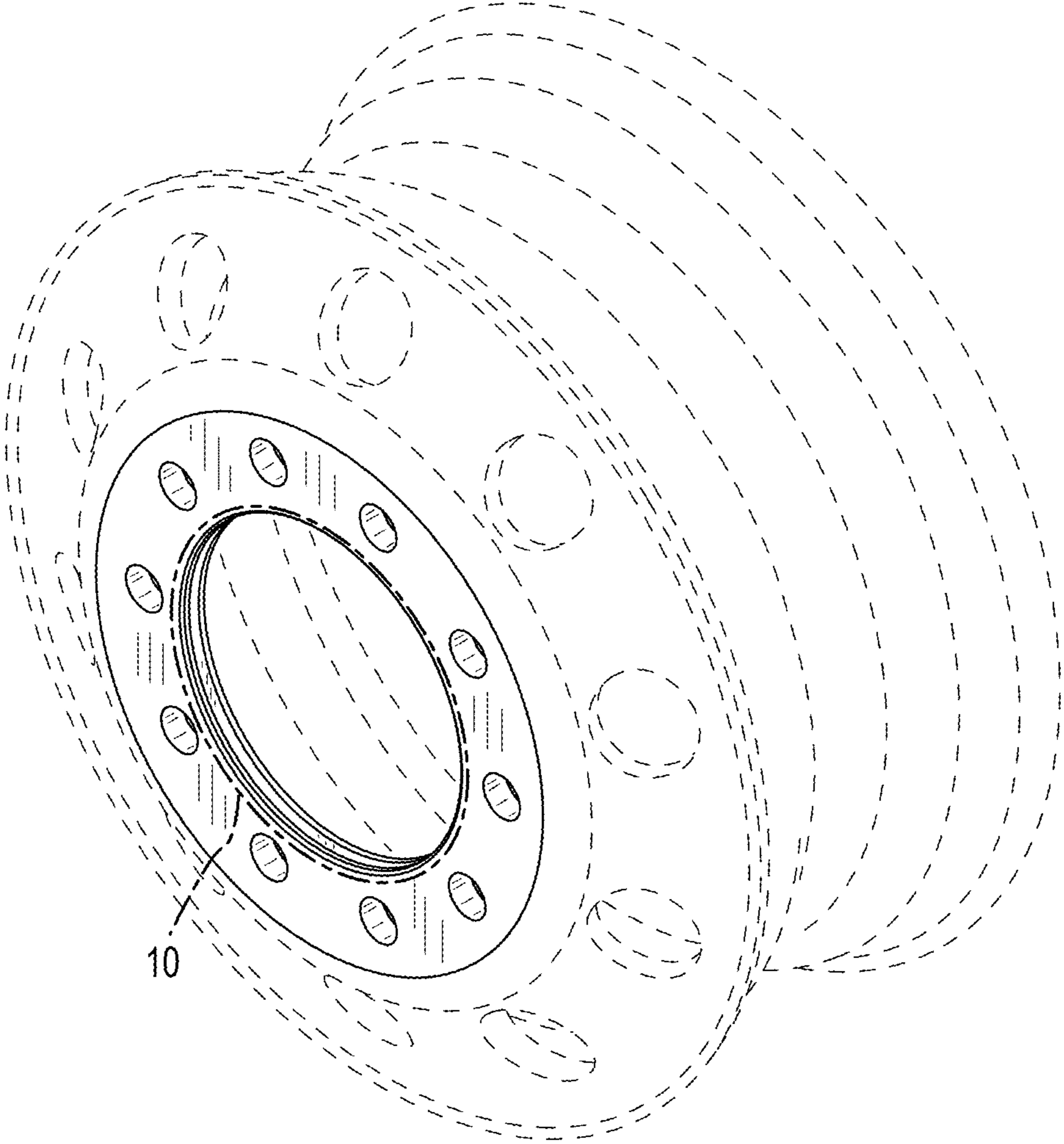

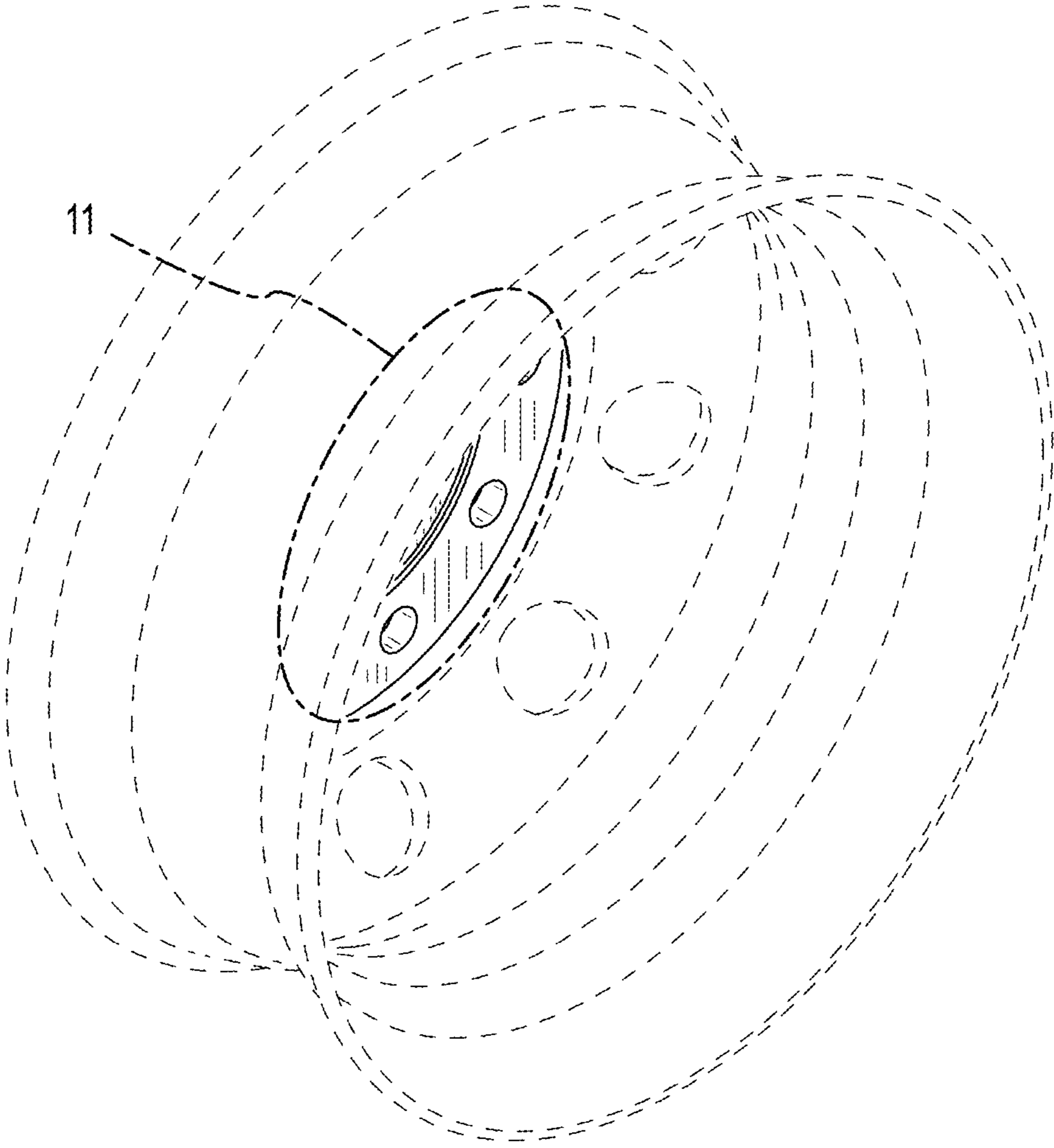

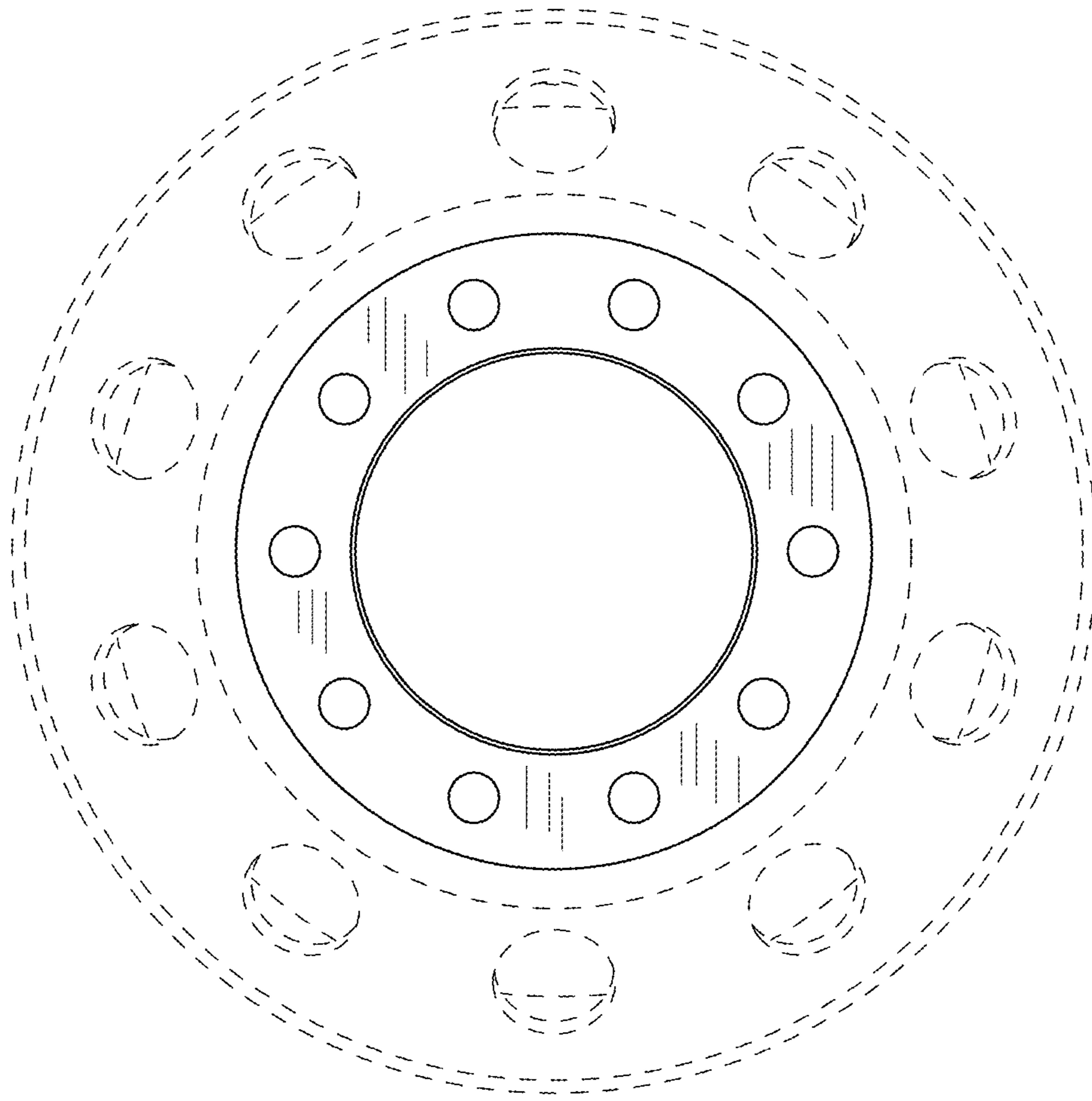

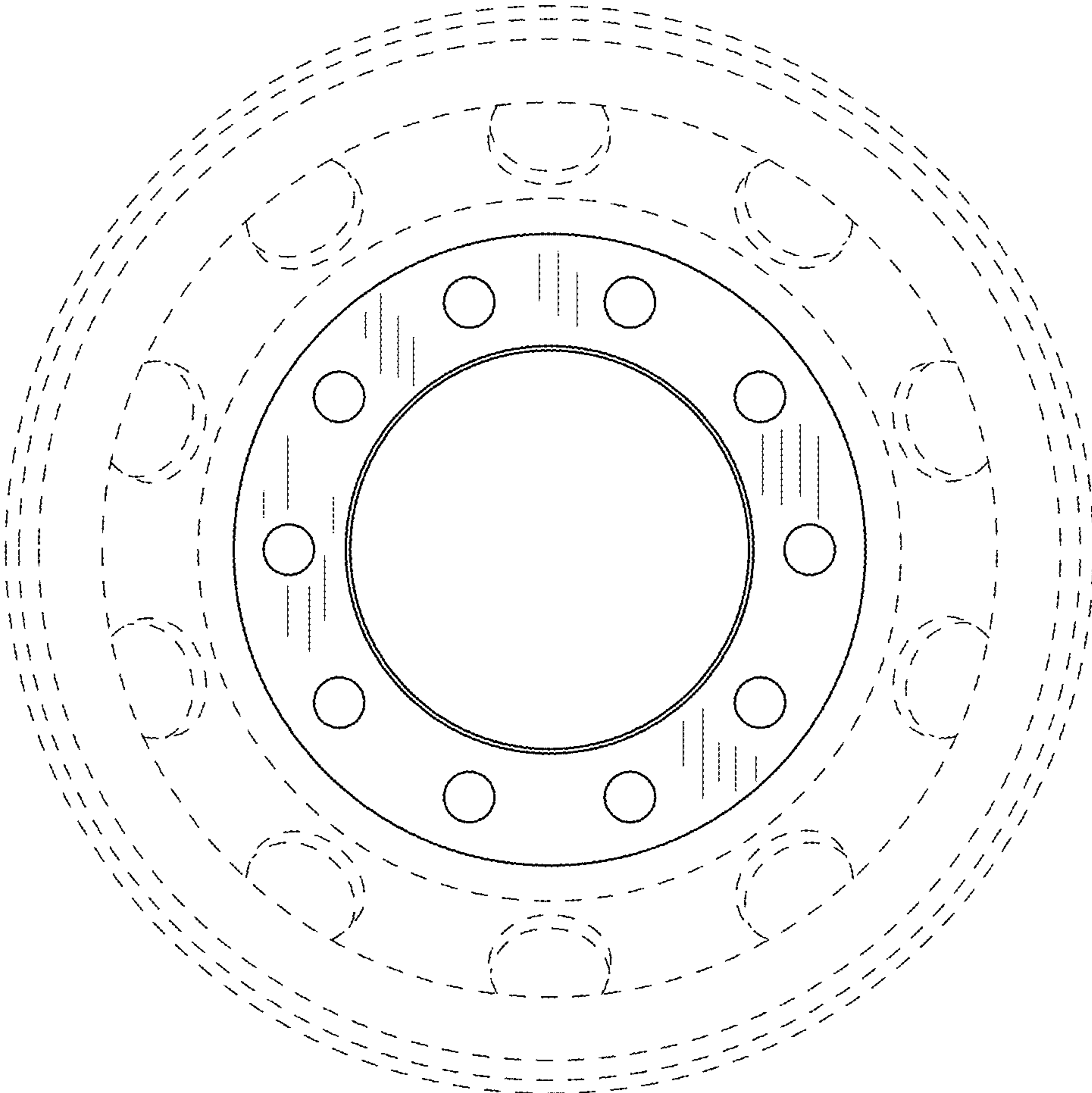

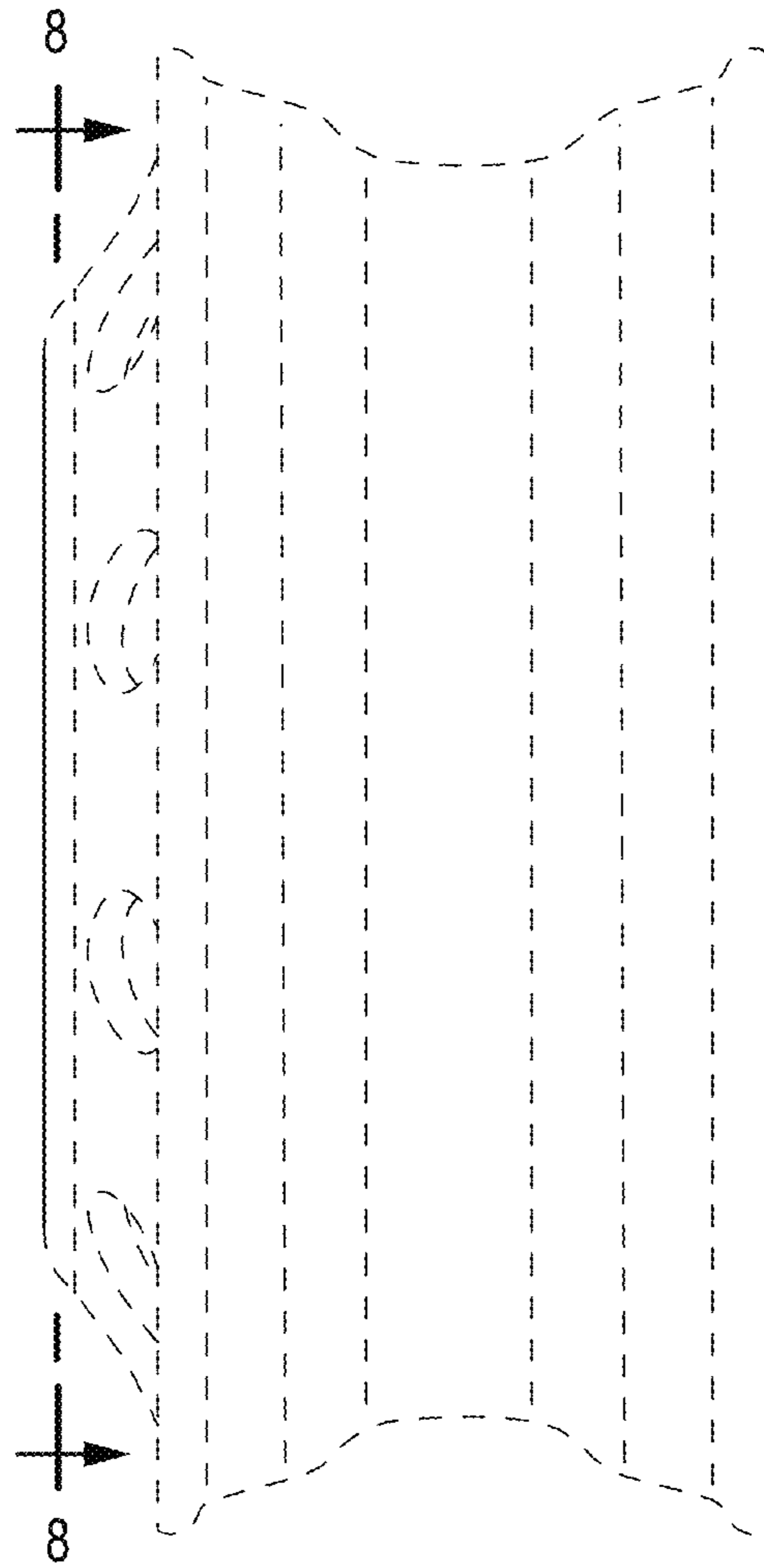

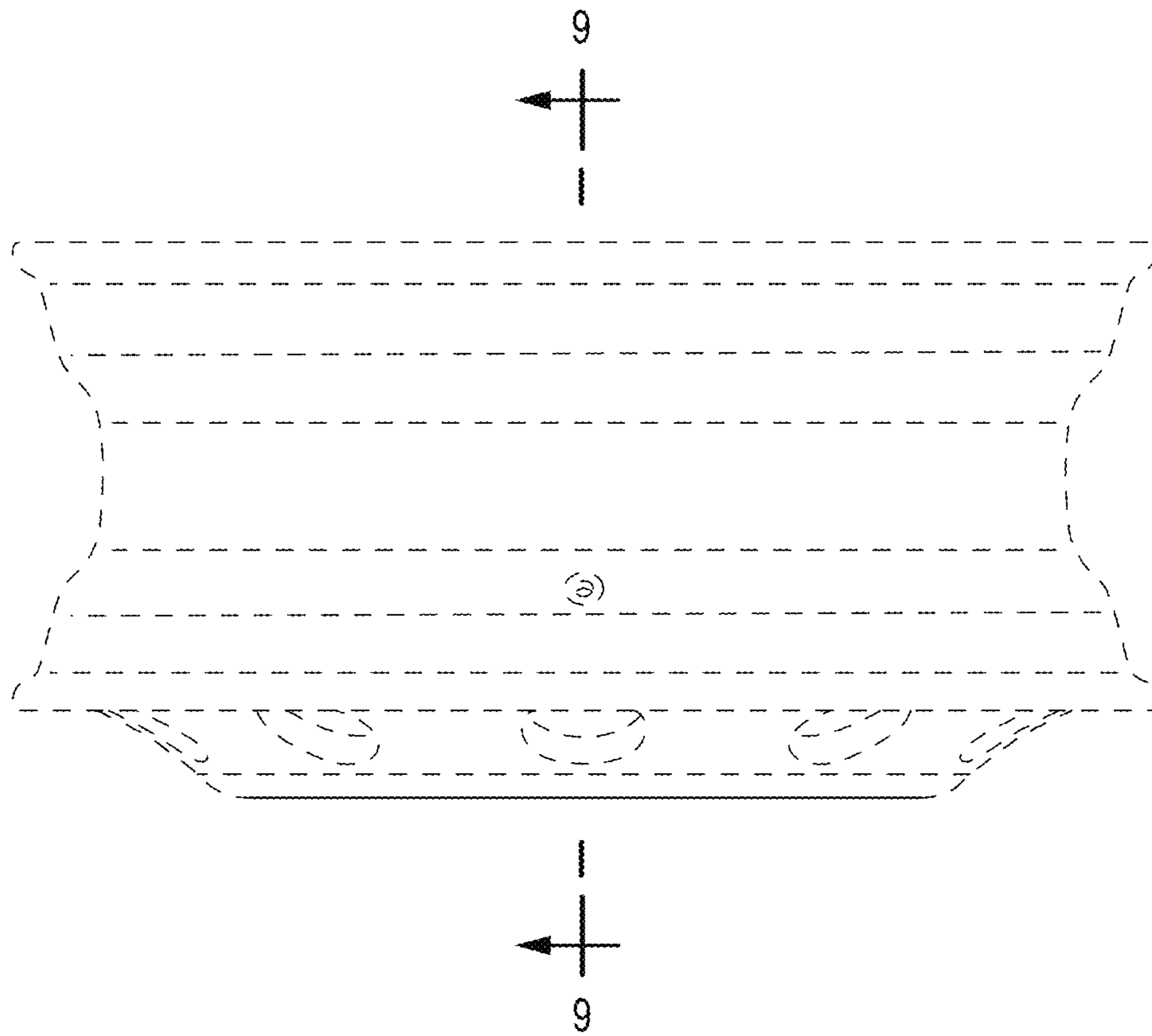

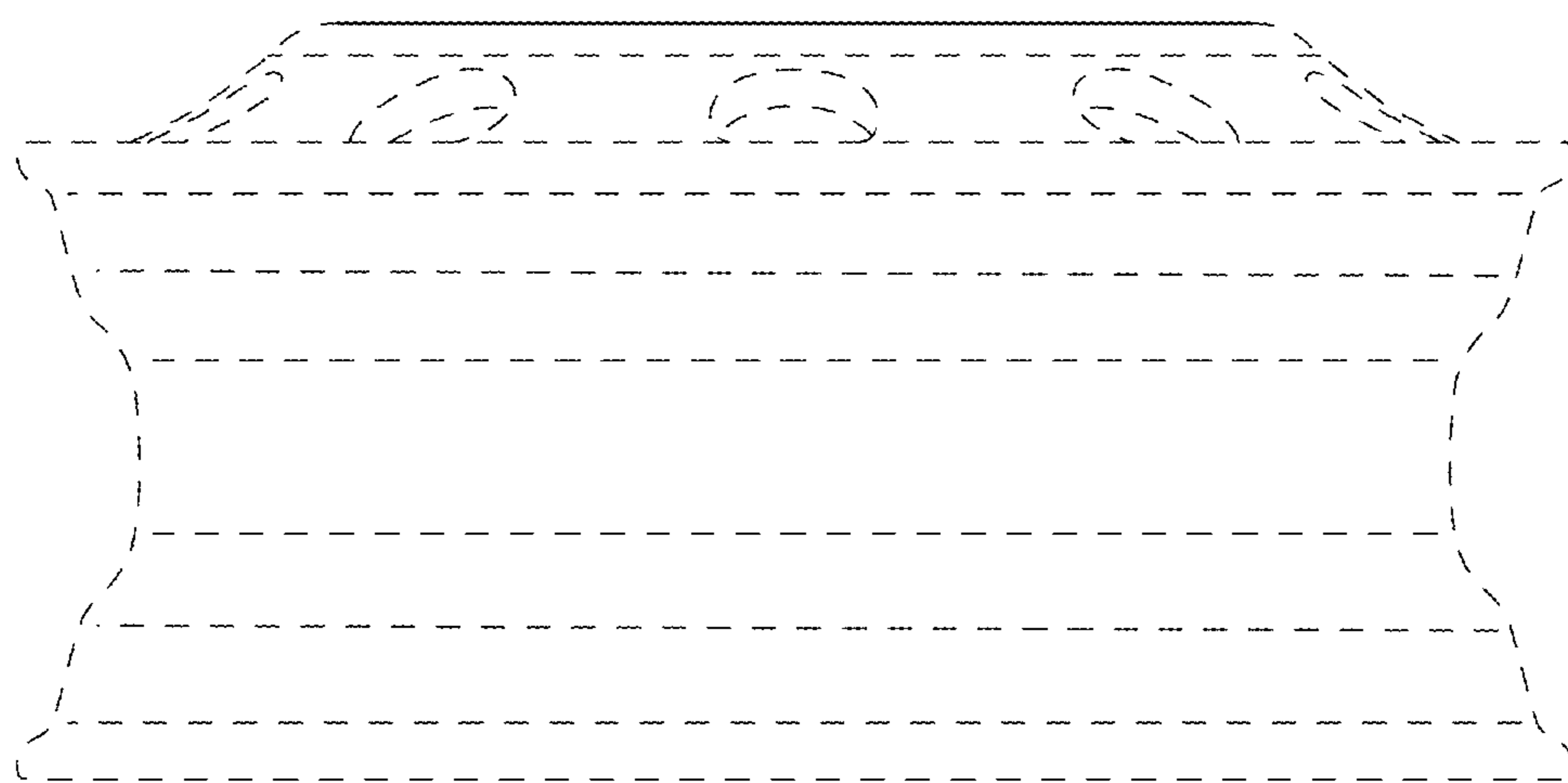

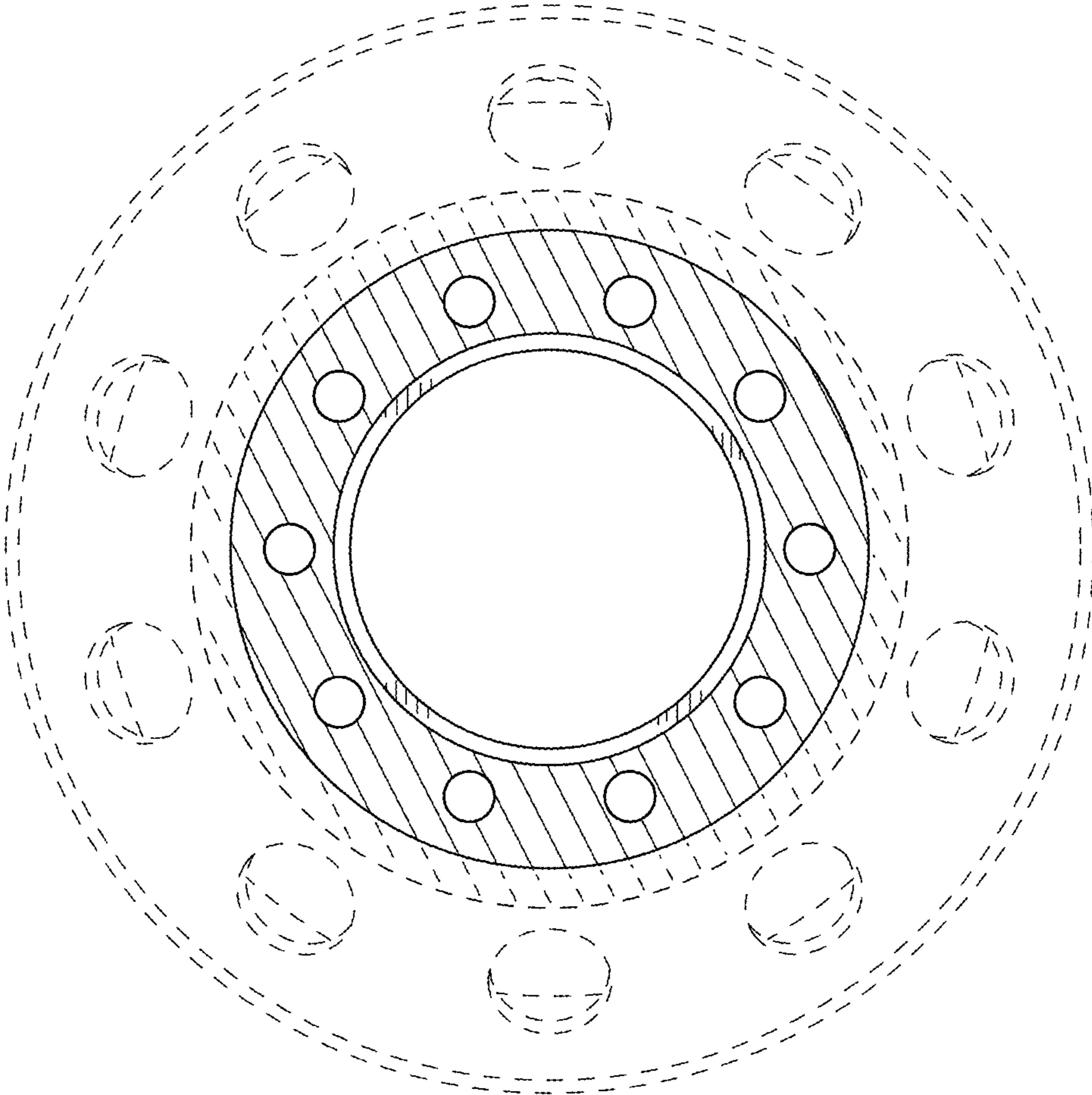

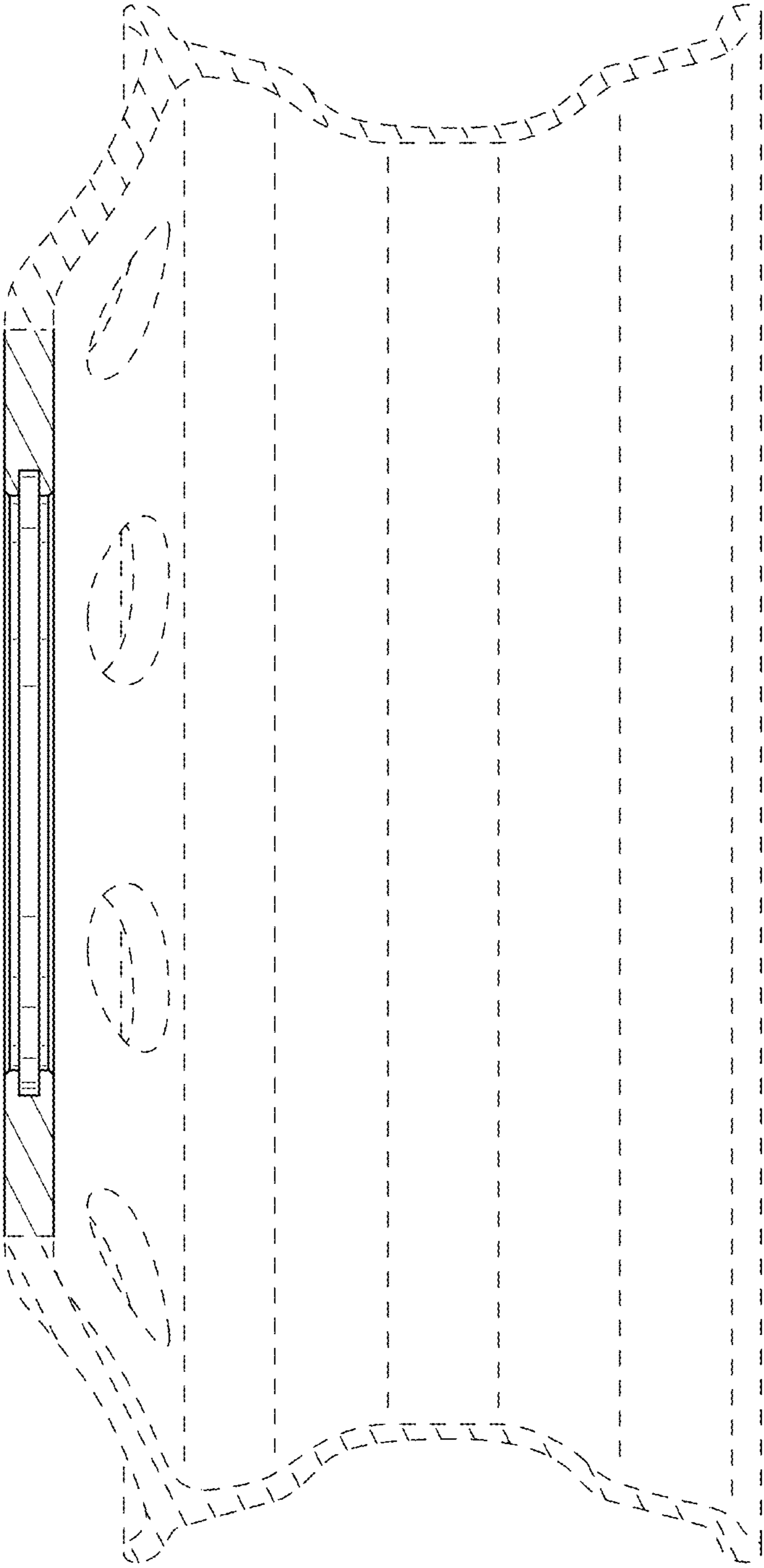

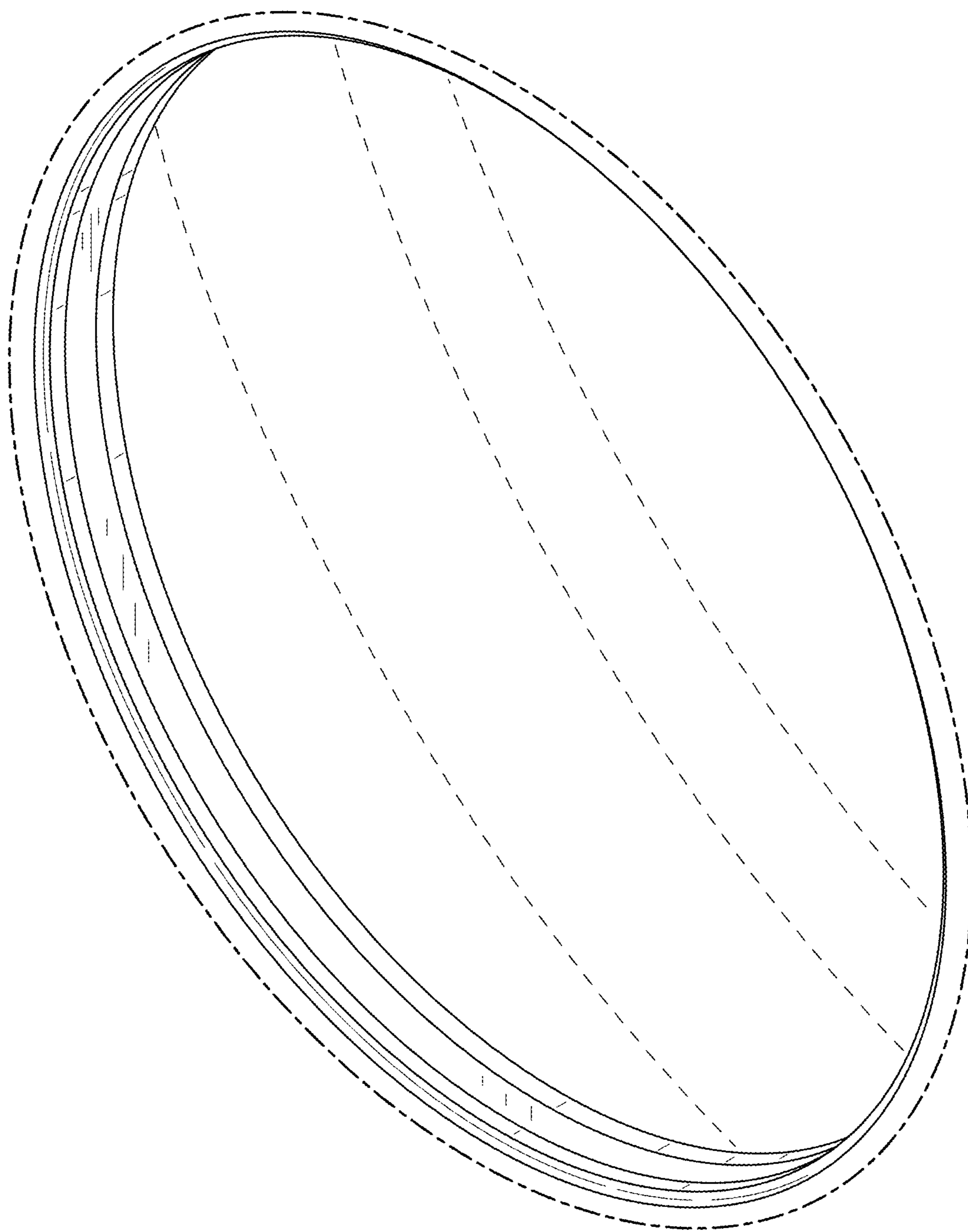

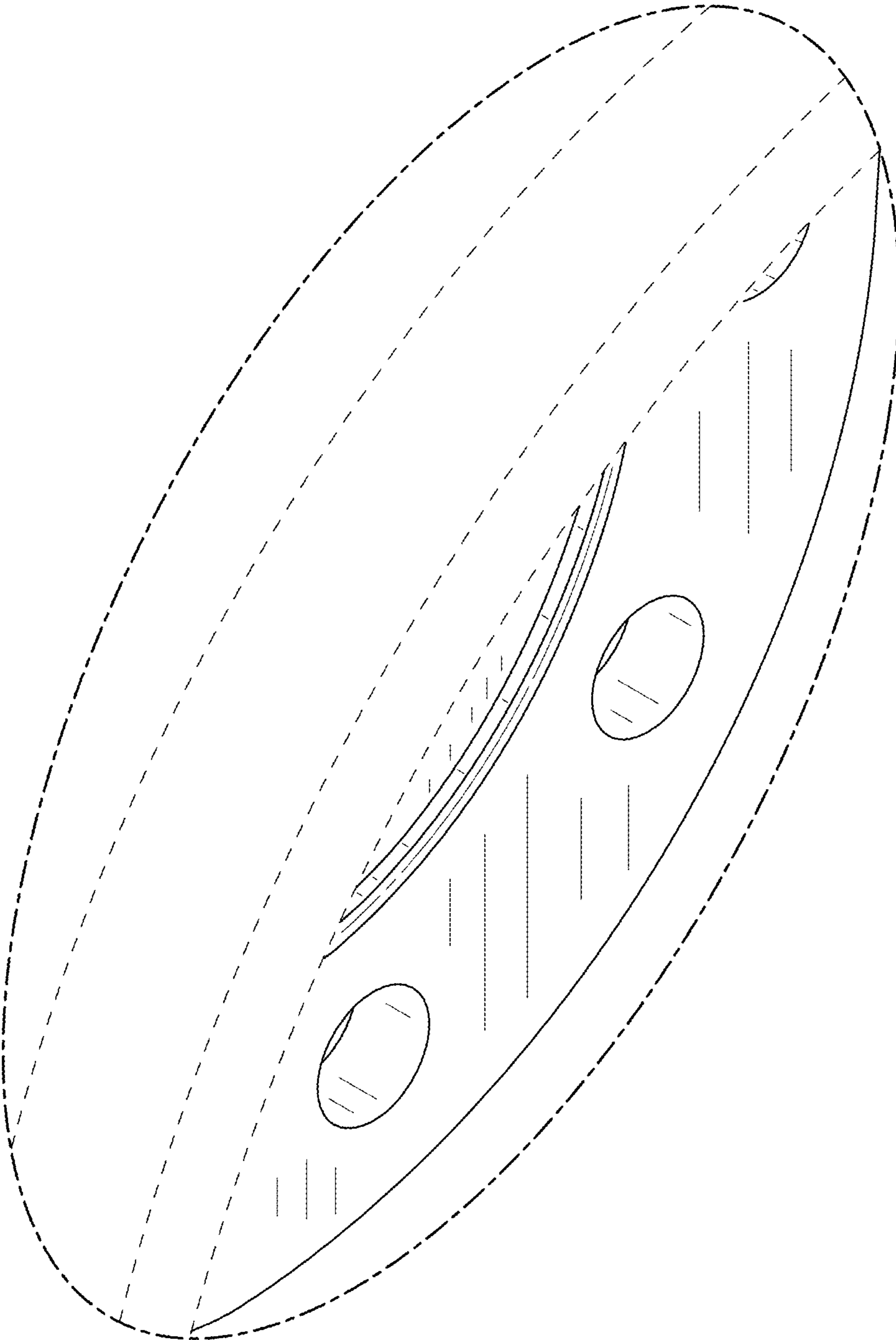
