(57) **CLAIM**

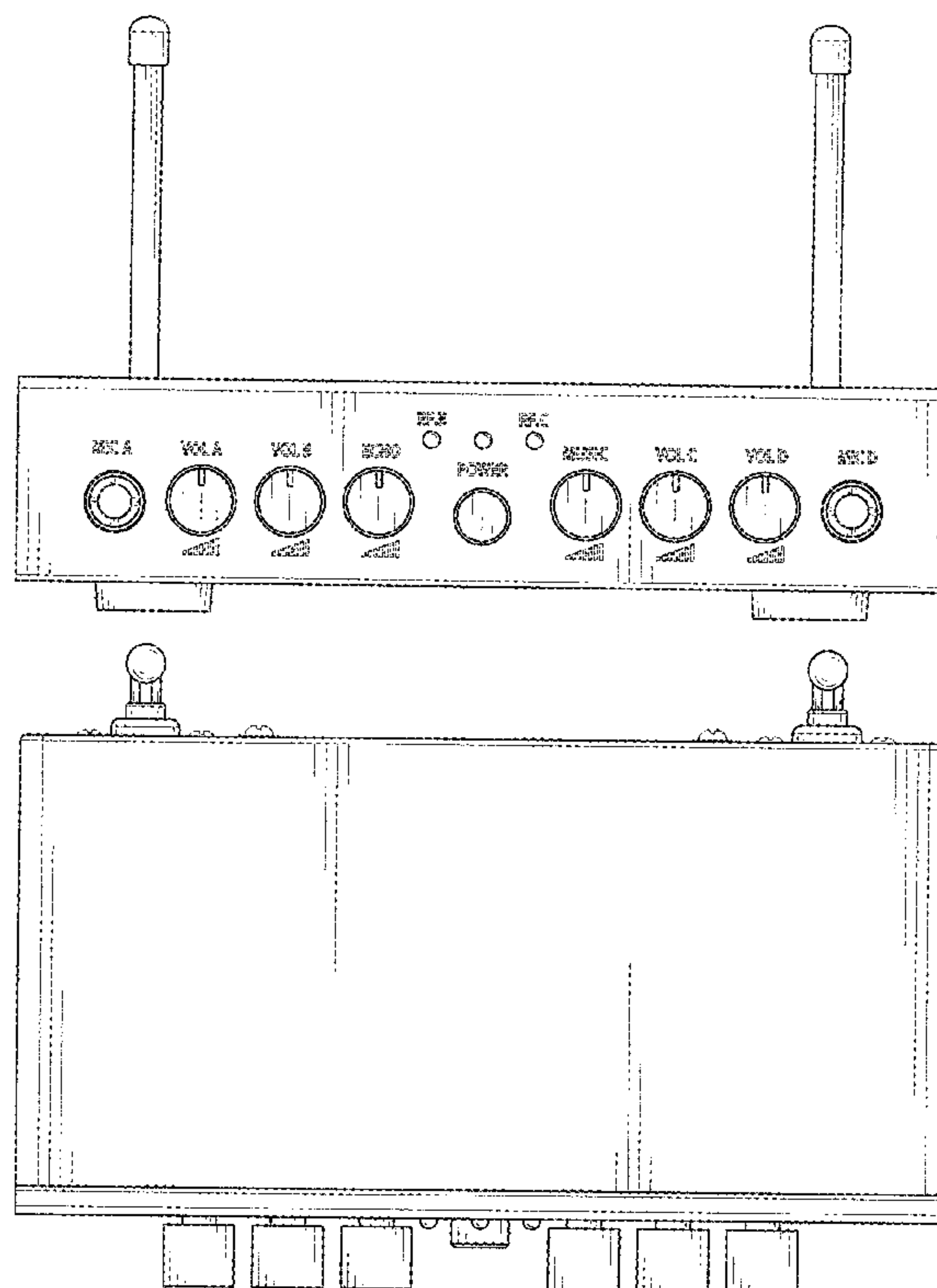
The ornamental design for a wireless signal receiver, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of a wireless signal receiver showing my new design;
FIG. 2 is a rear, right side, bottom perspective view thereof;

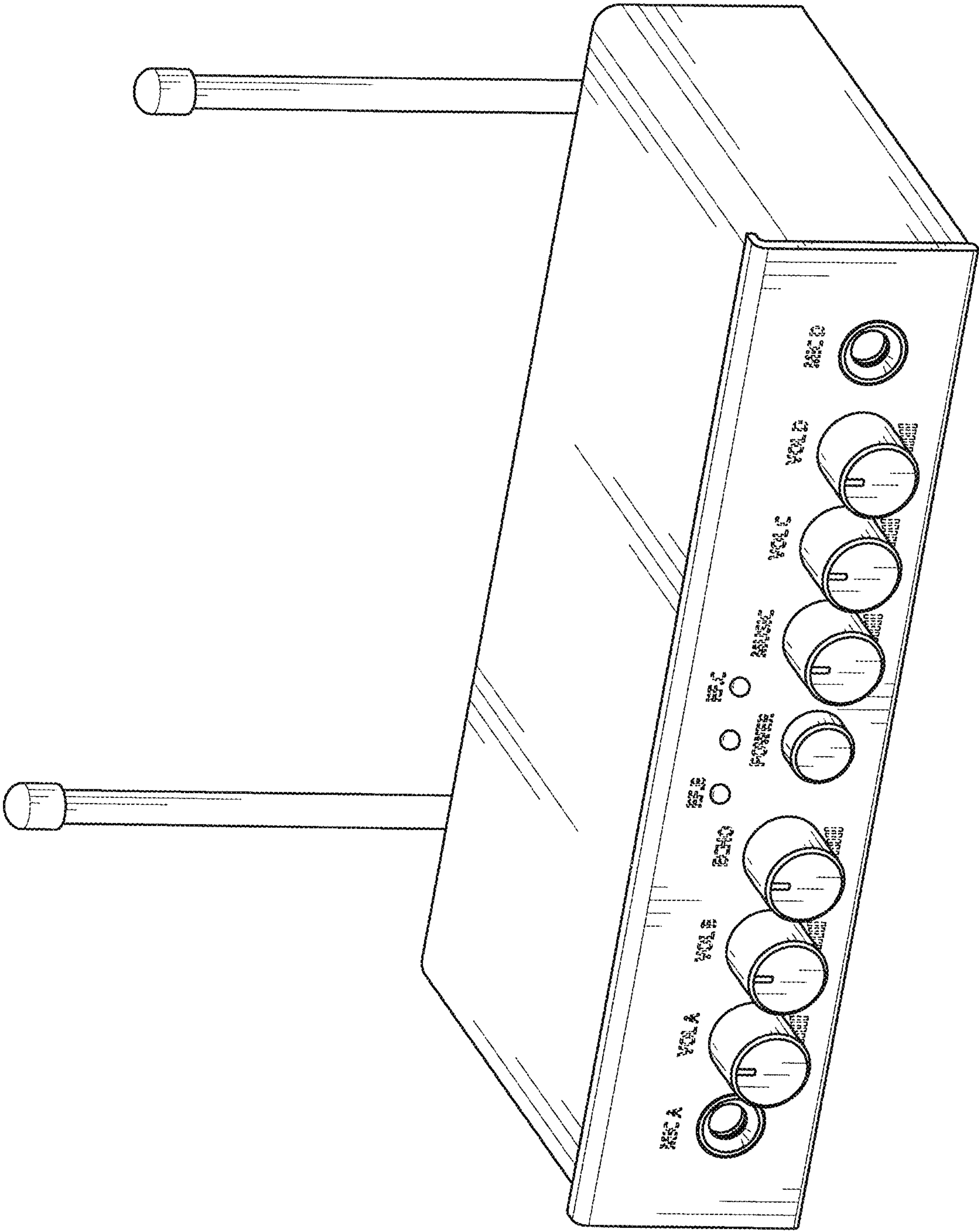

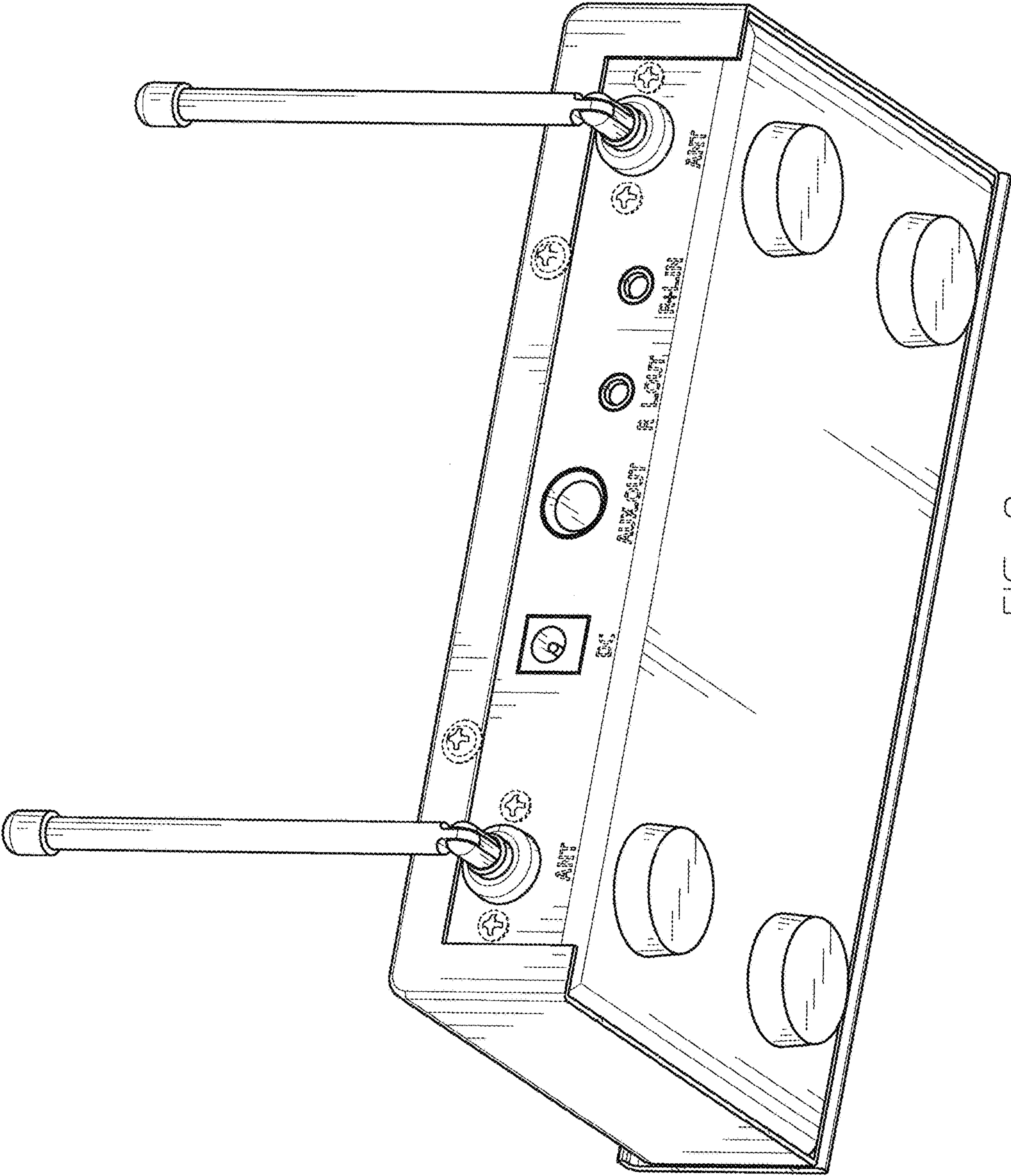

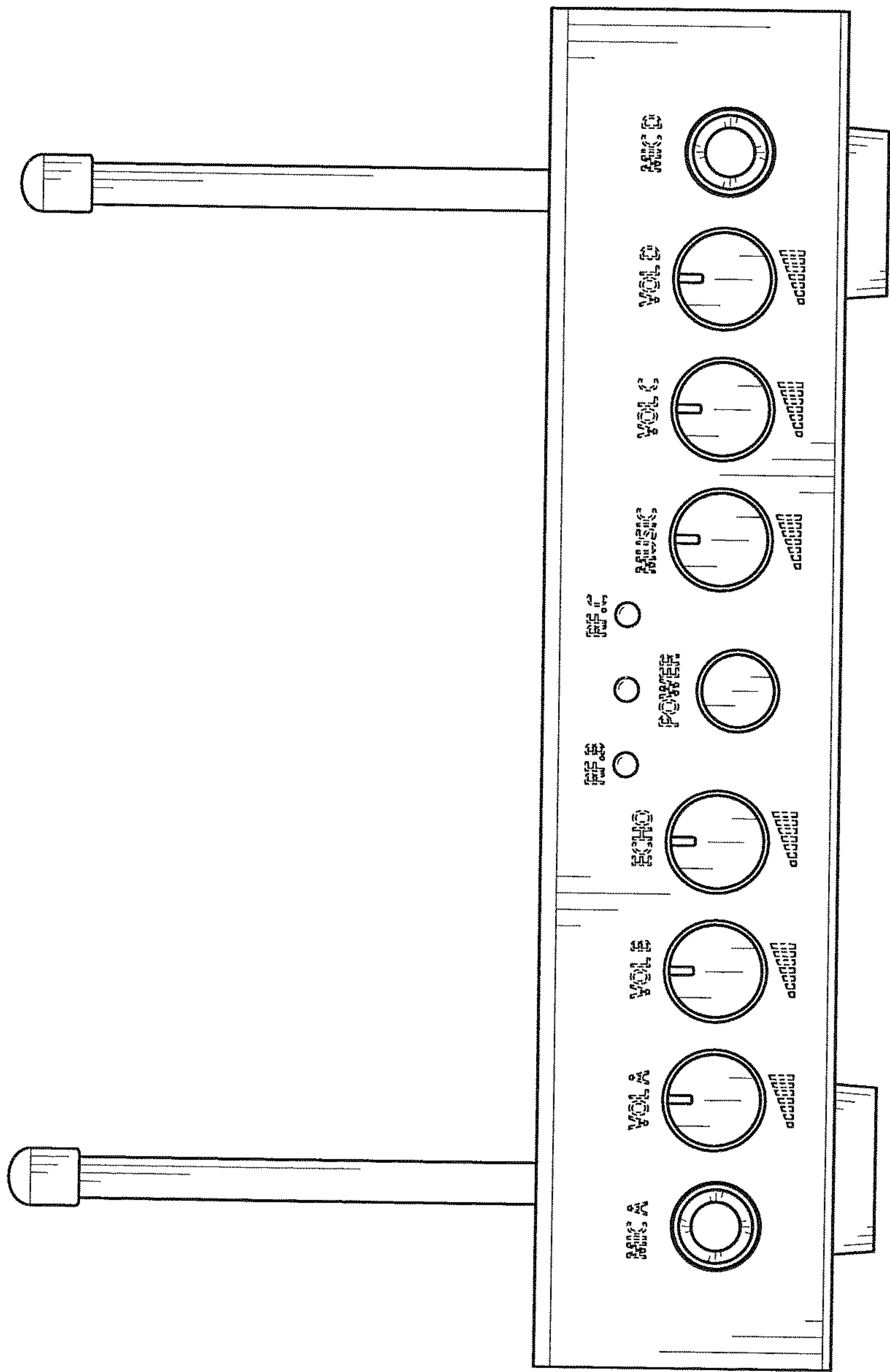

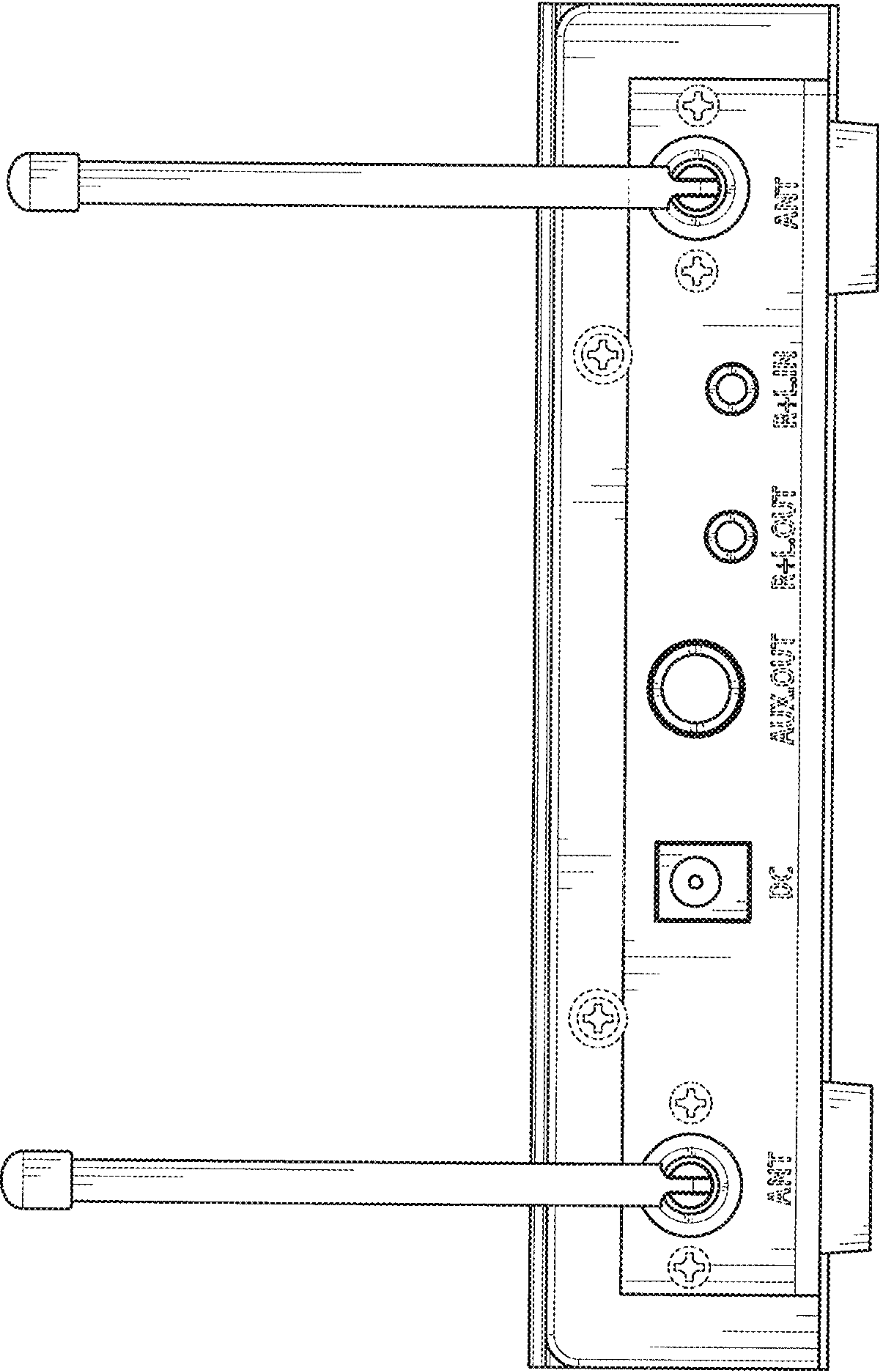

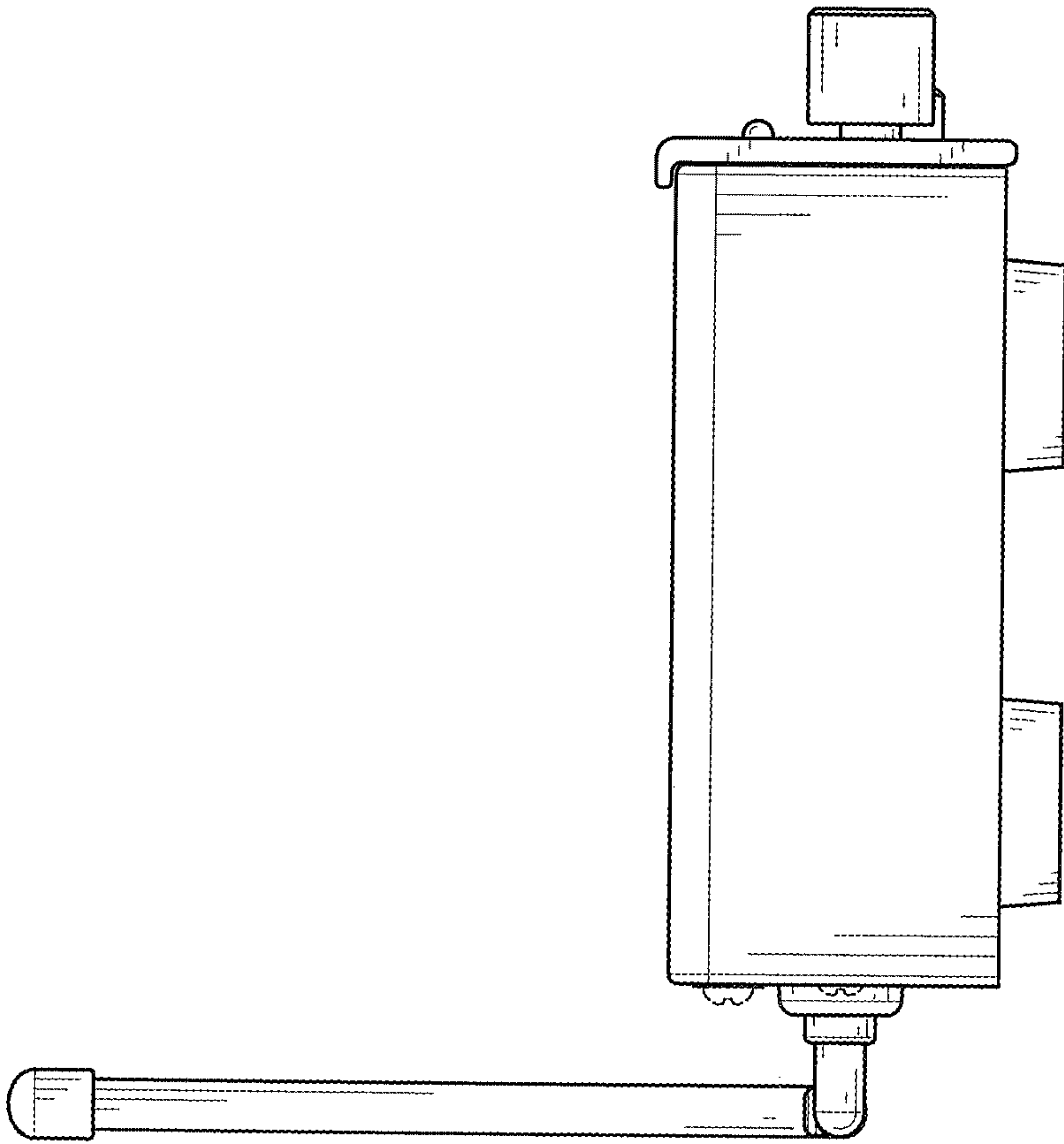

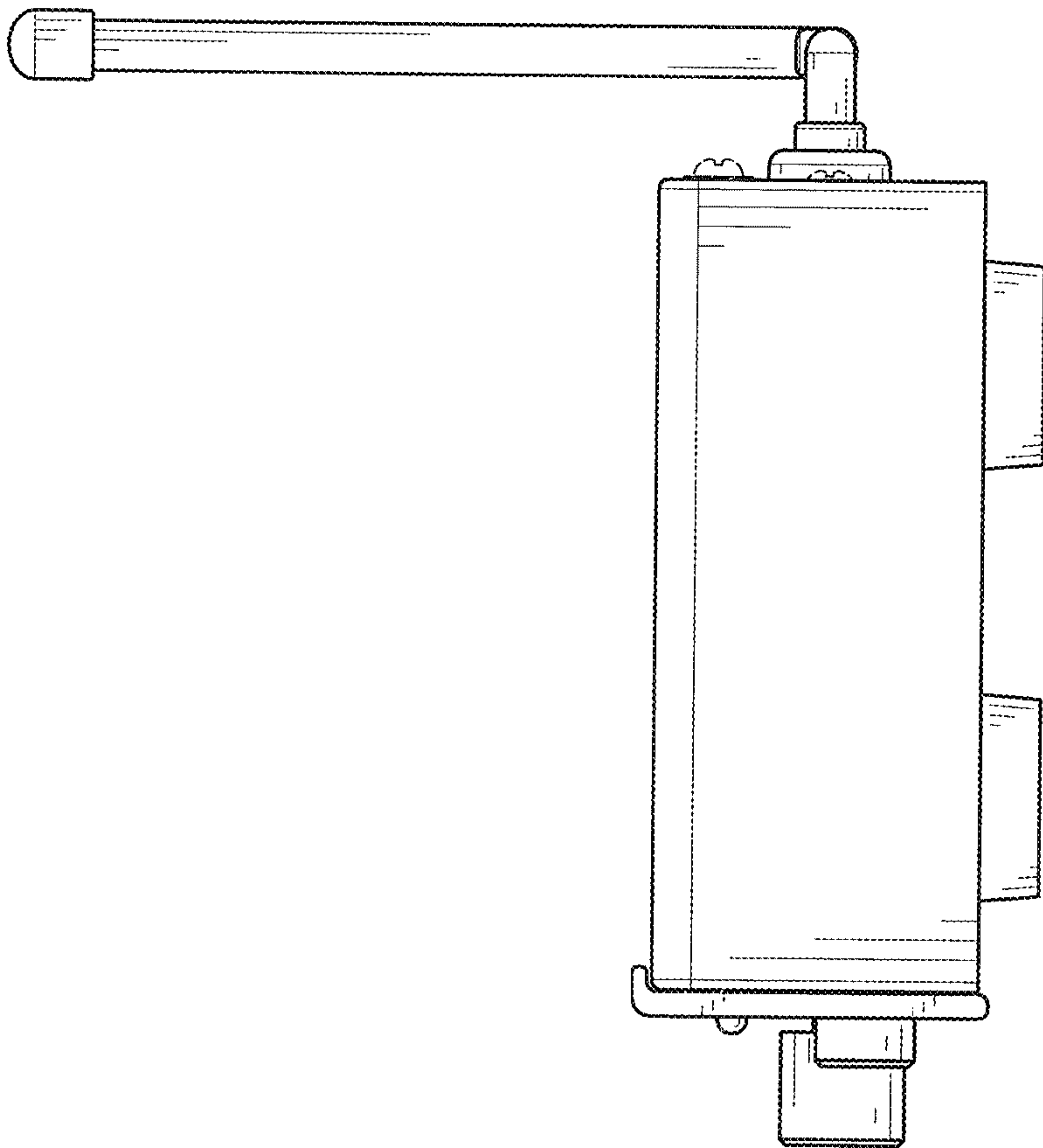

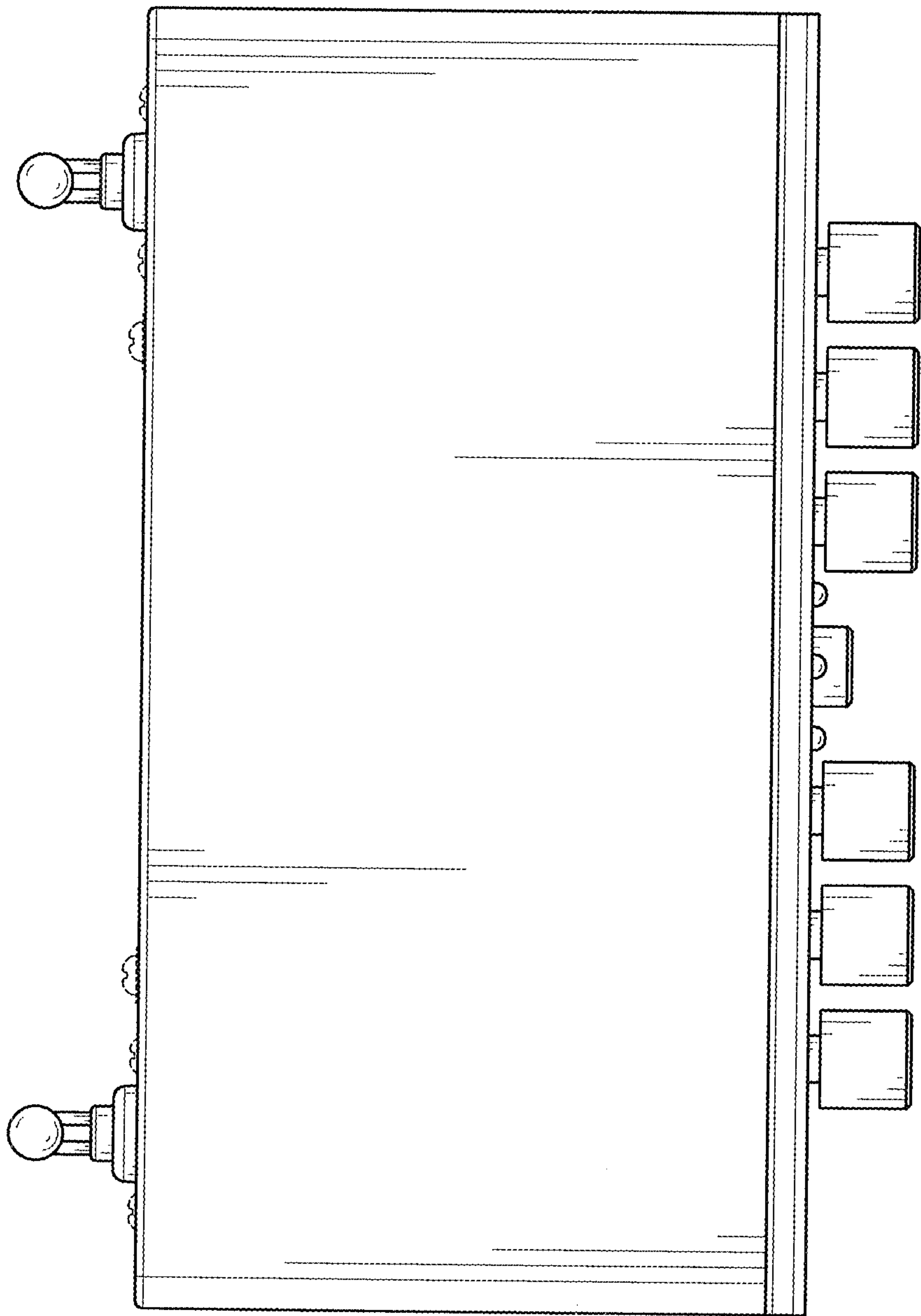

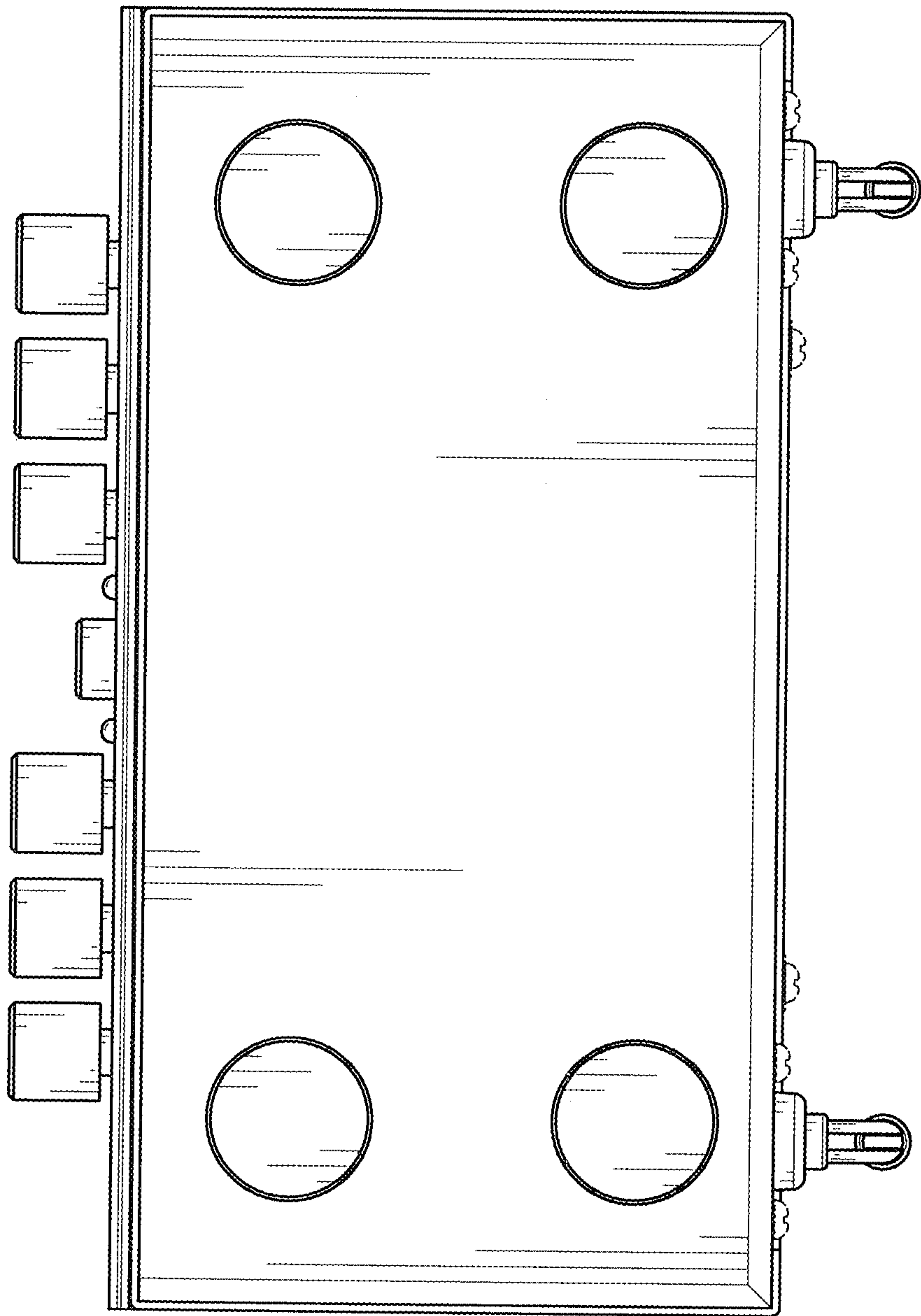
