FIG. 5 is a front view of a display screen or portion thereof with a graphical user interface according to another embodiment;

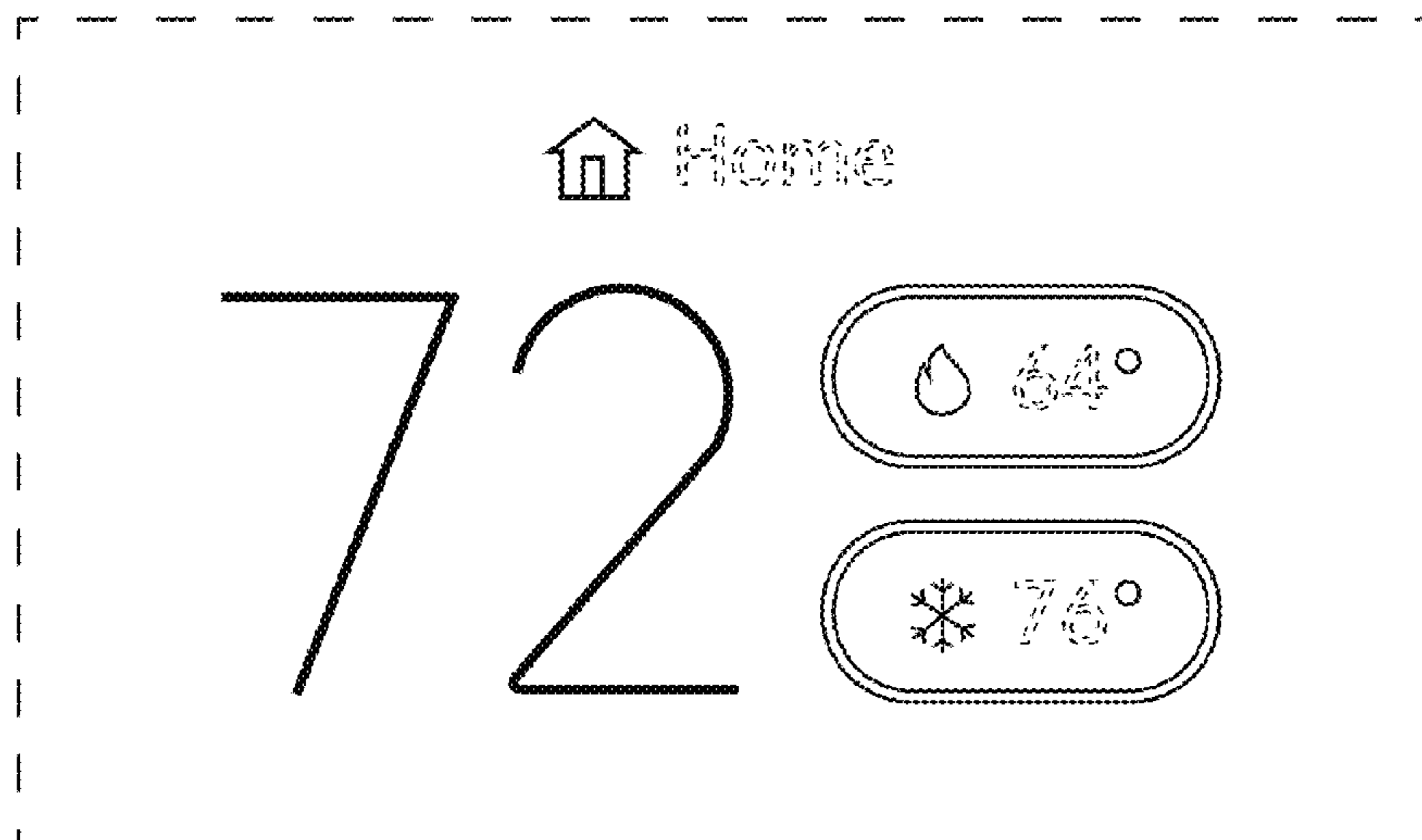
FIG. 6 is a front view of a display screen or portion thereof with a graphical user interface according to another embodiment;

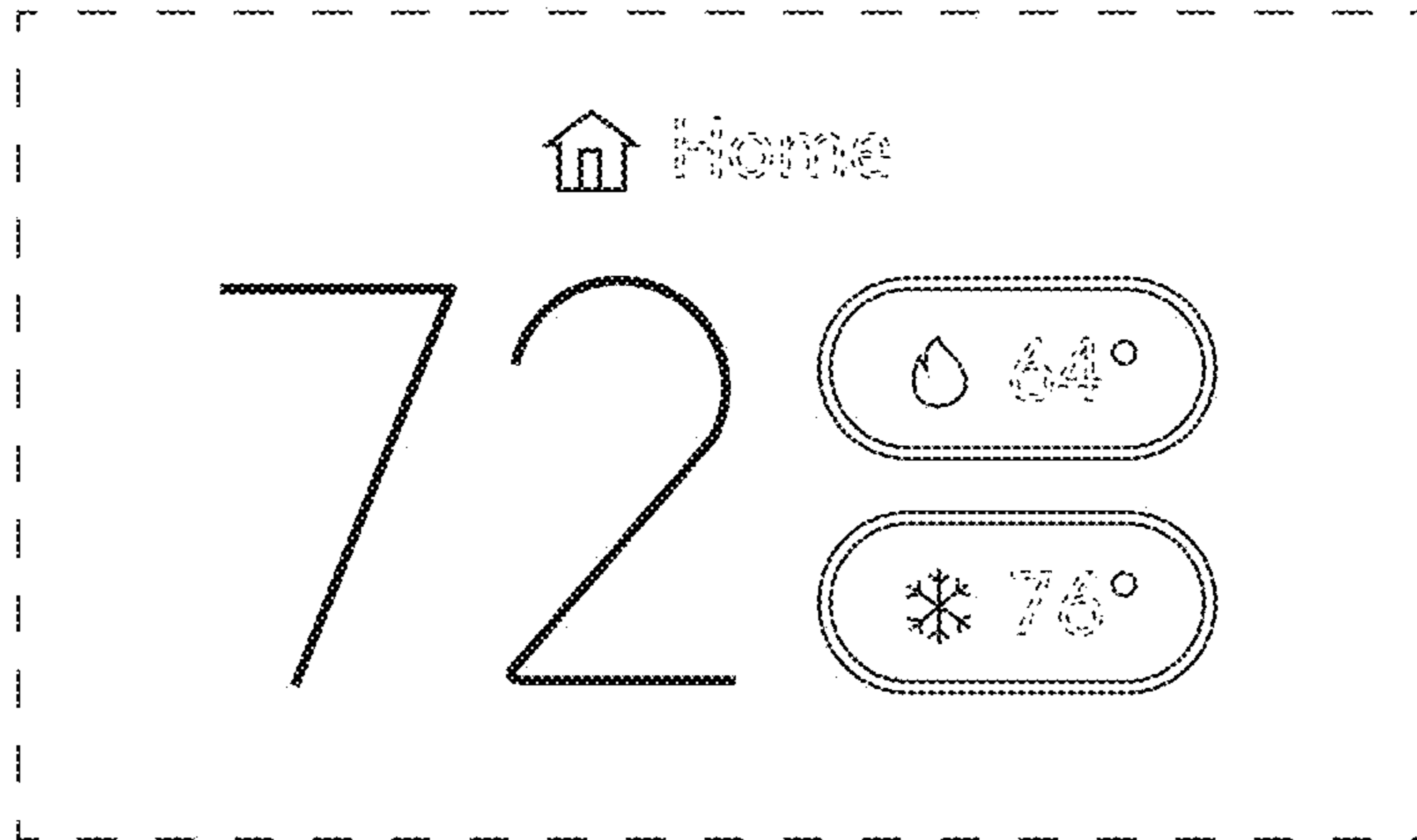

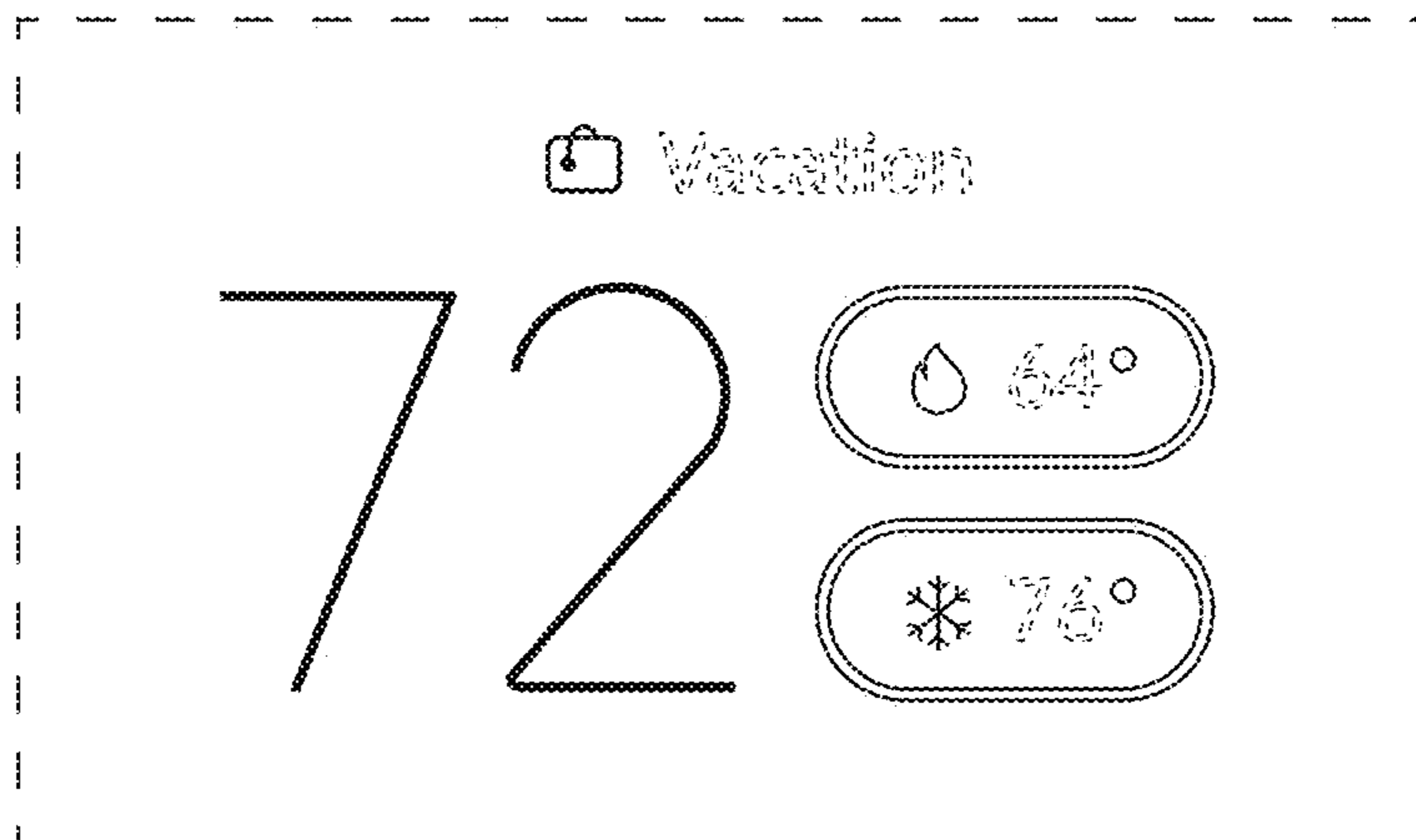

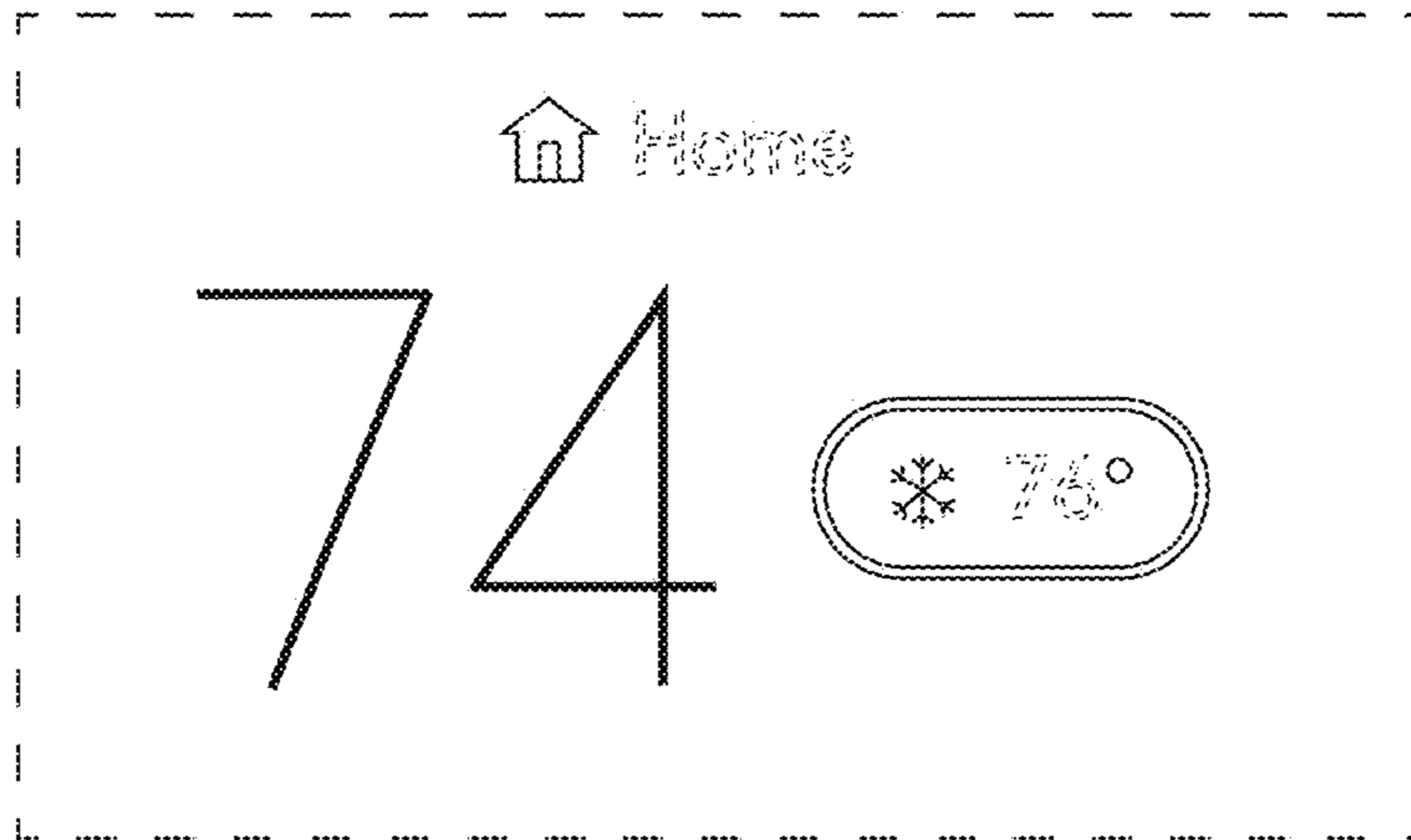

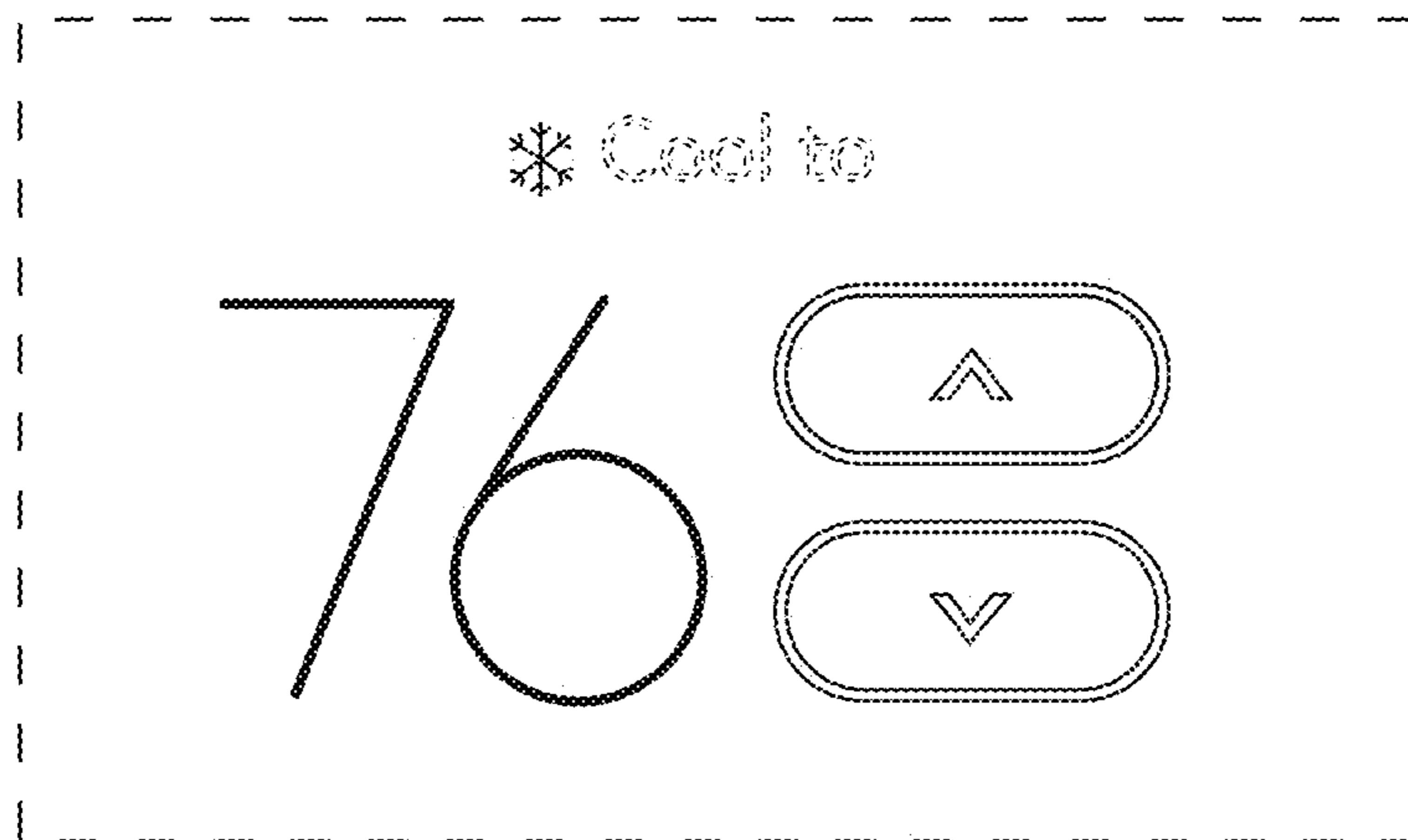

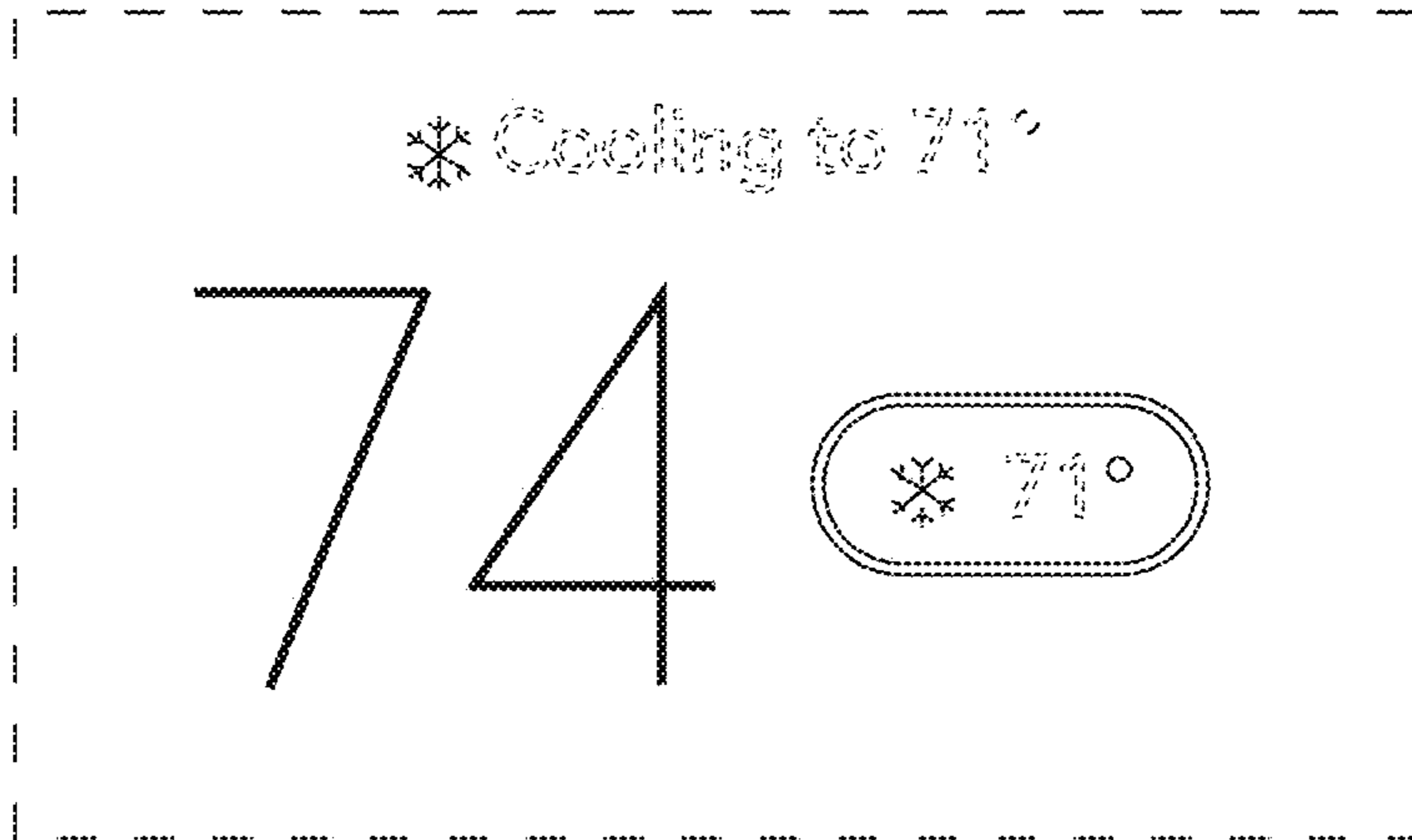

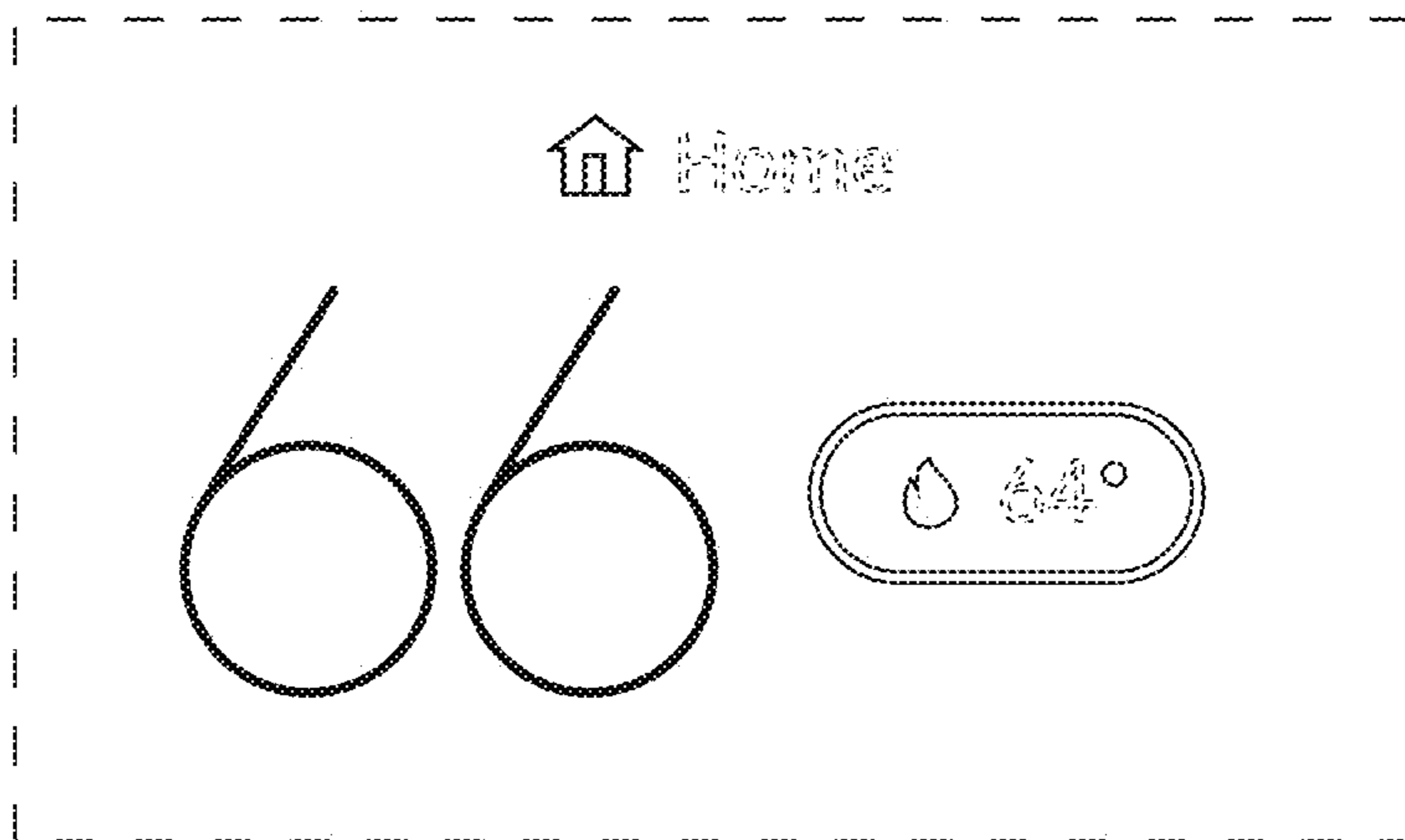

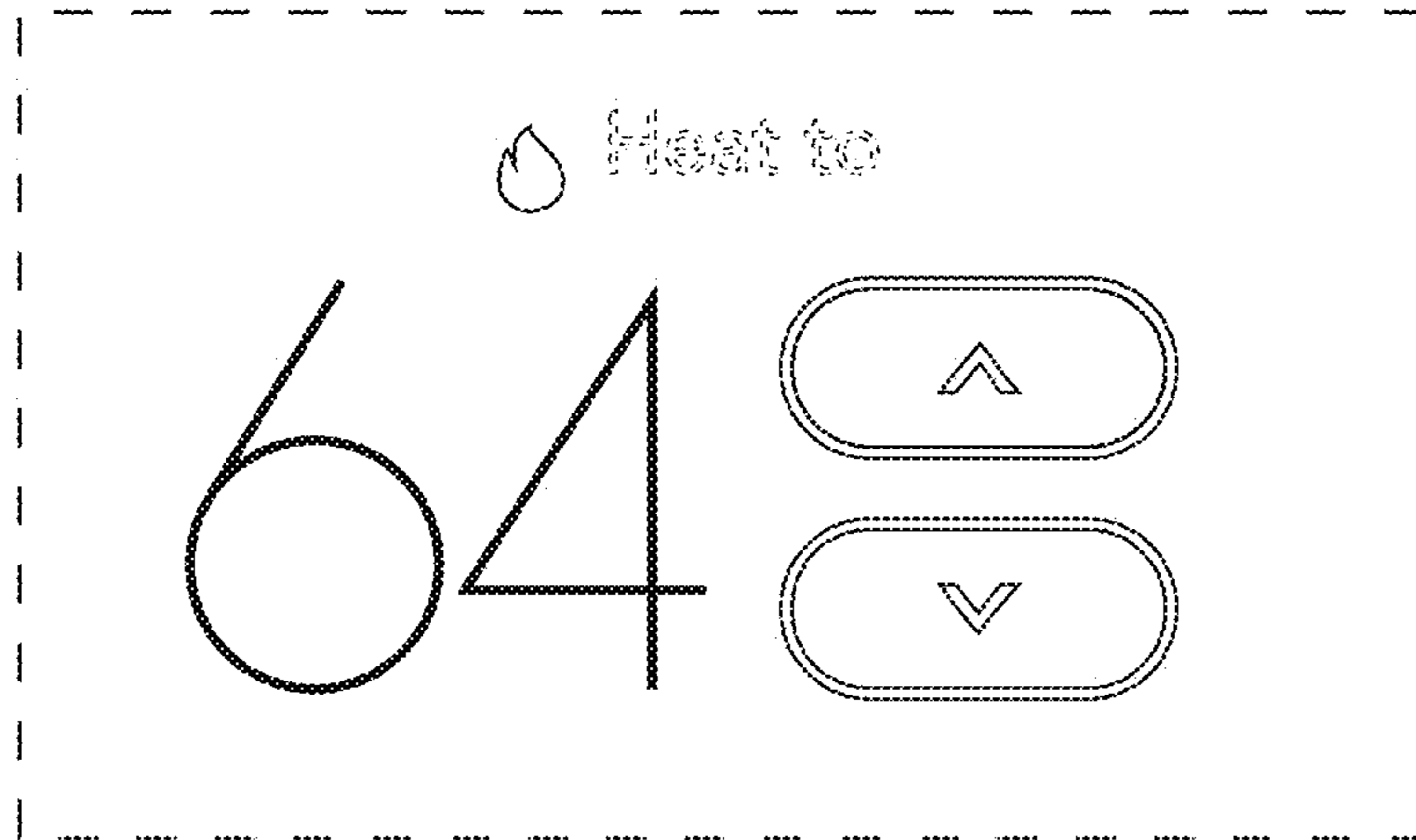

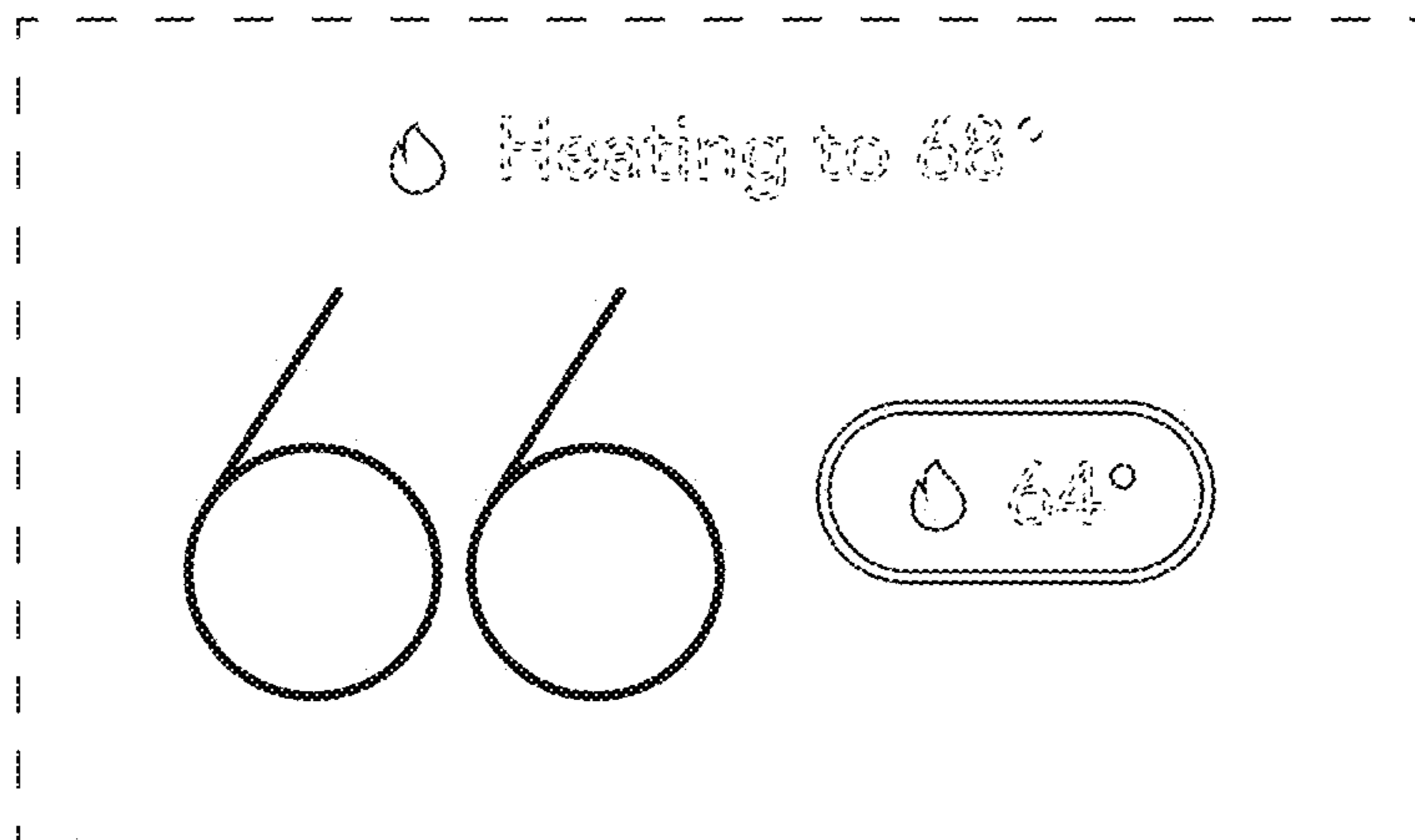
