**DESCRIPTION**

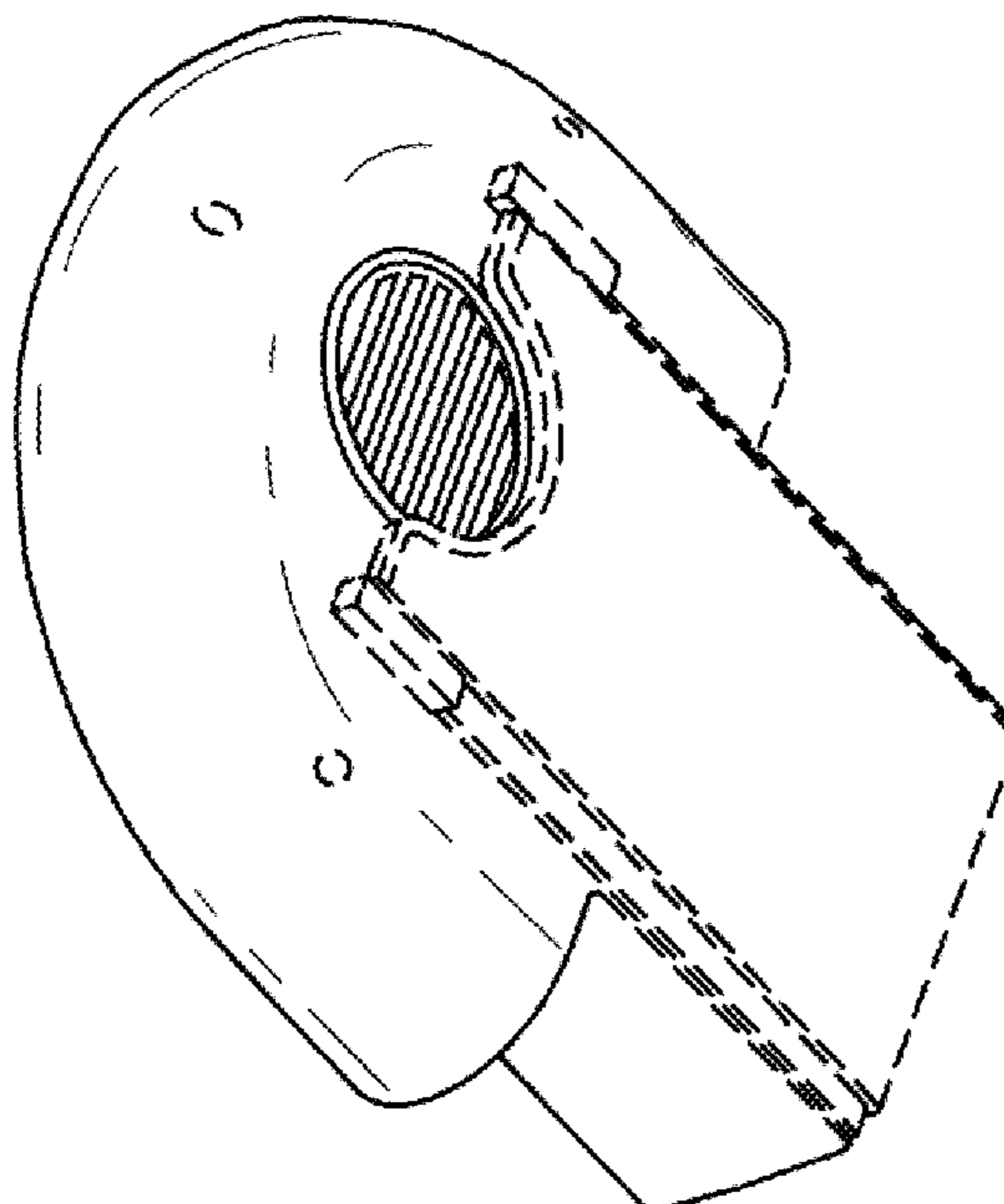
FIG. 1 is a front view of a wall mountable essential oil diffuser;

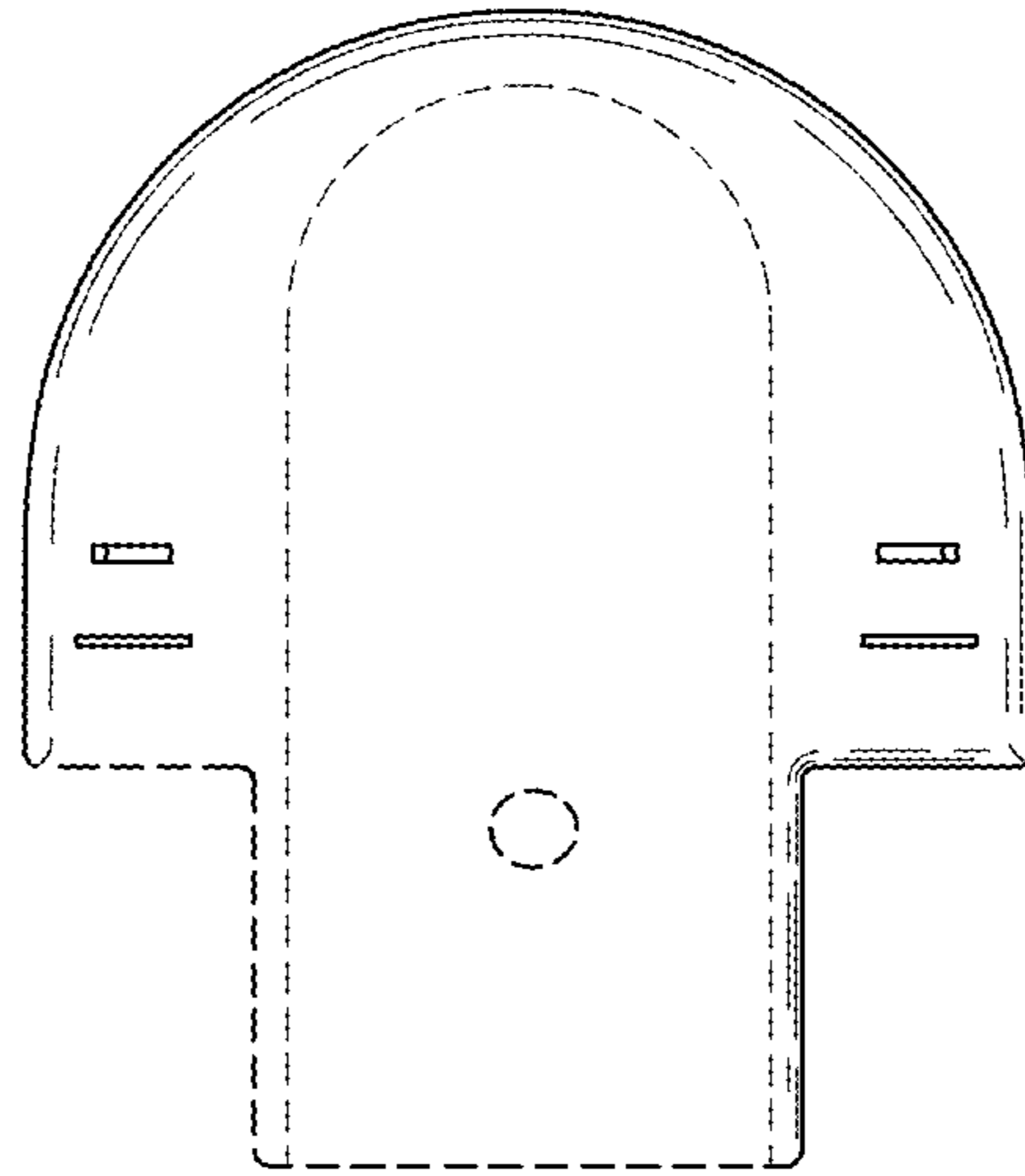

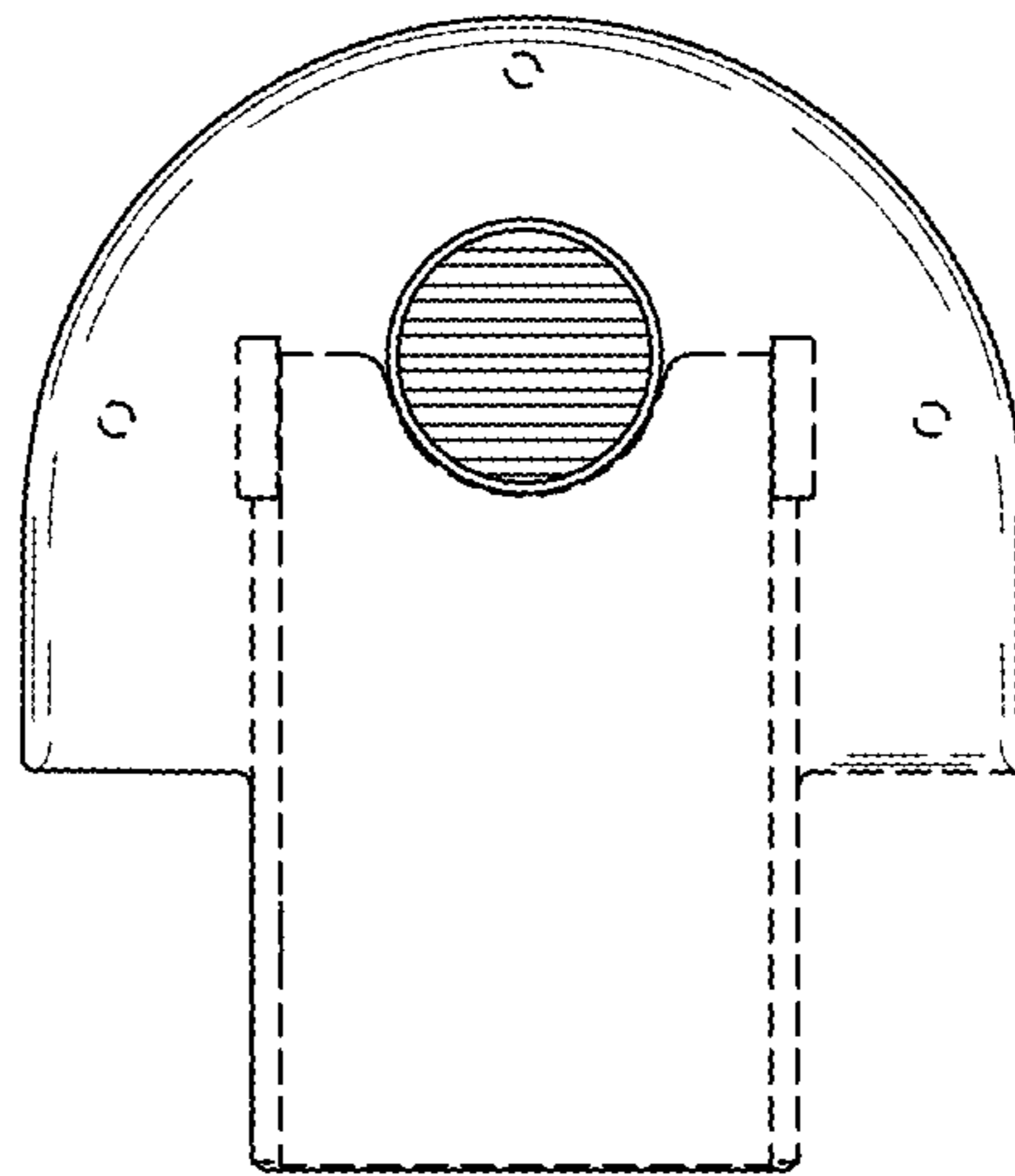

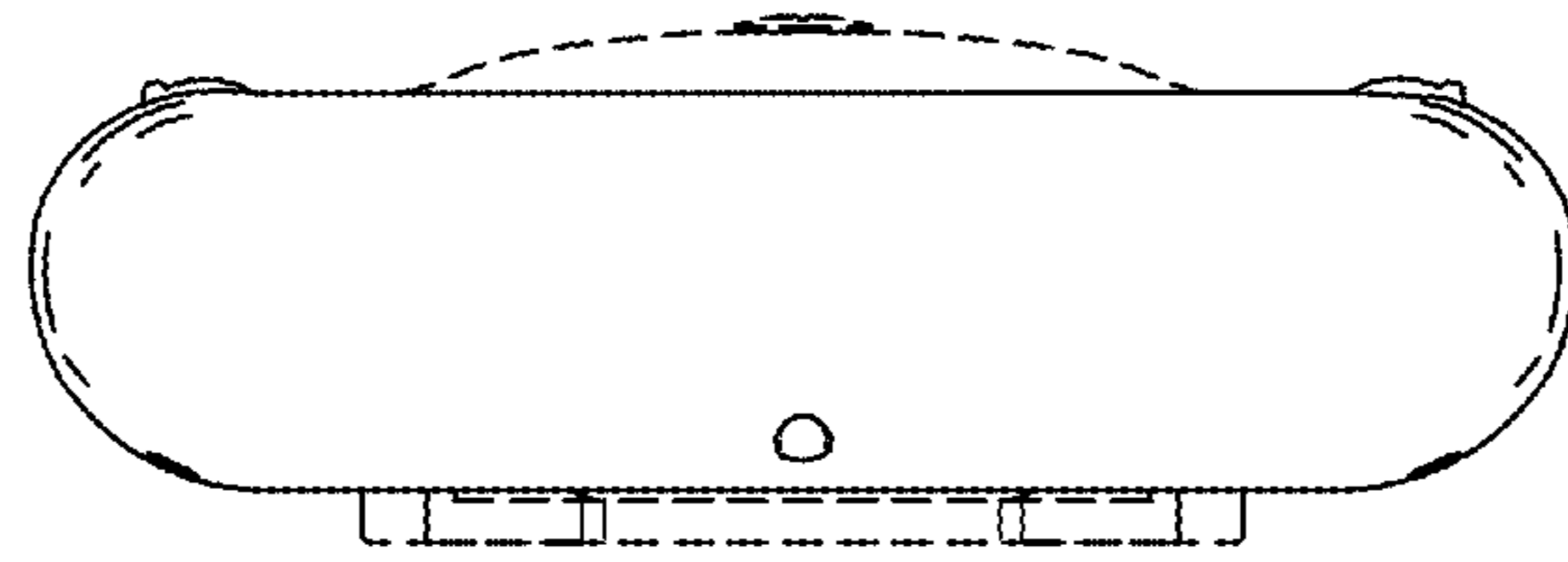

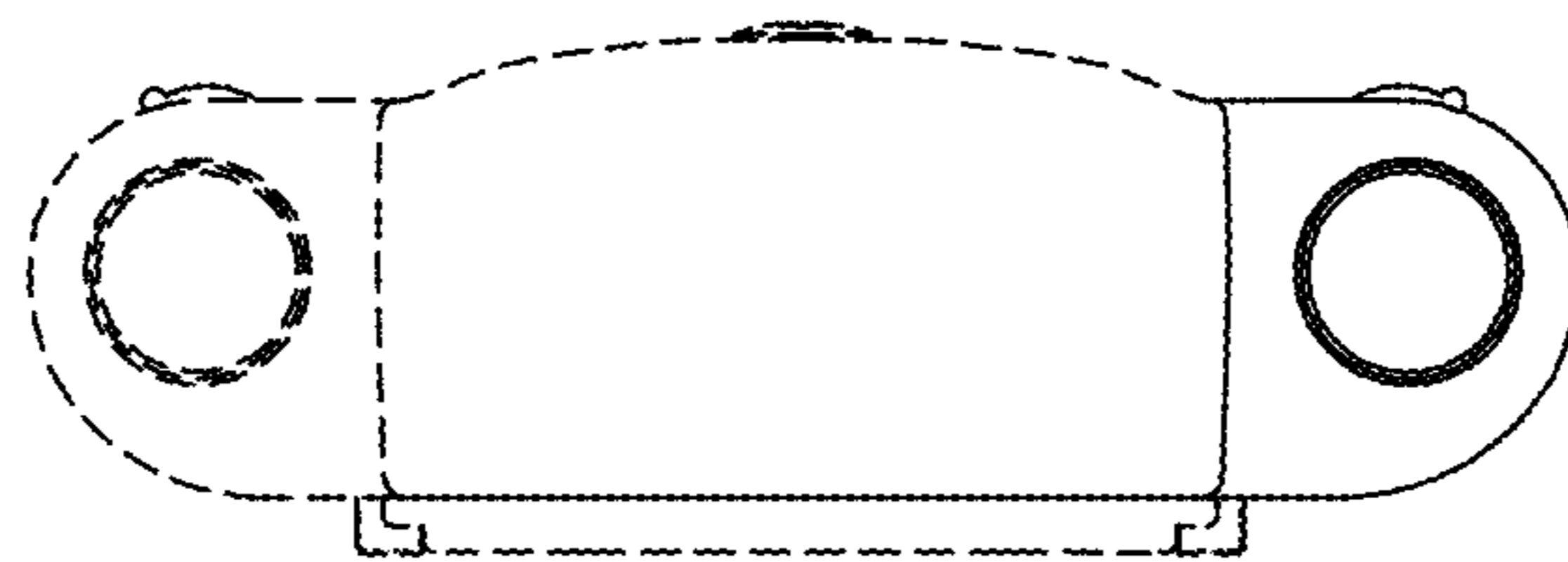

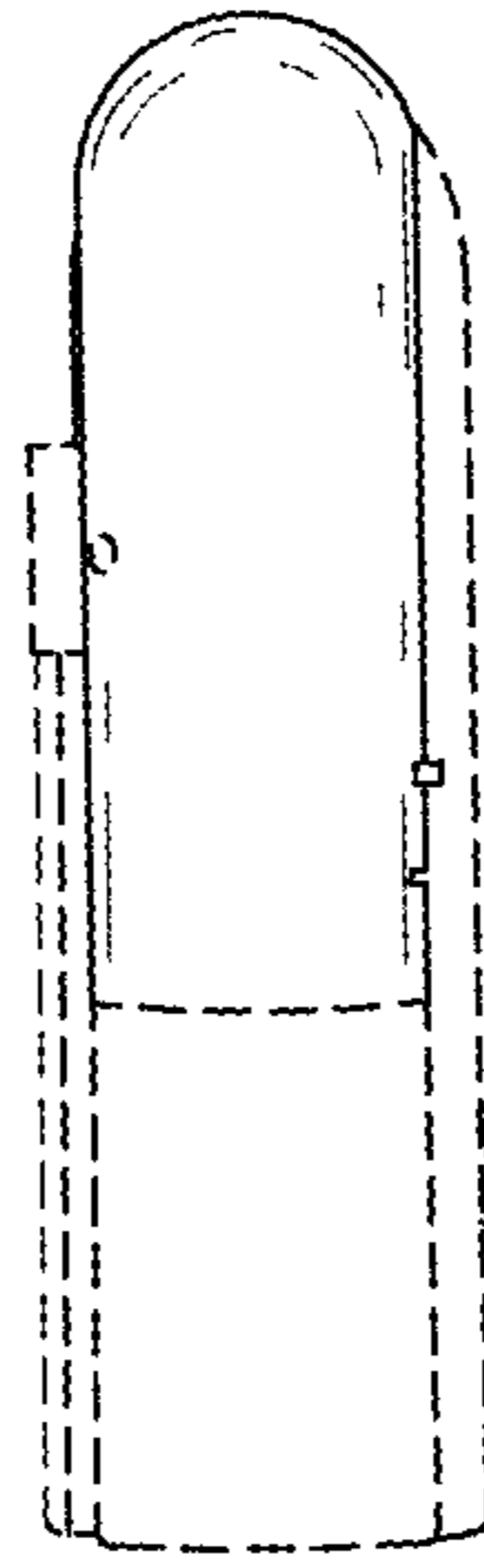

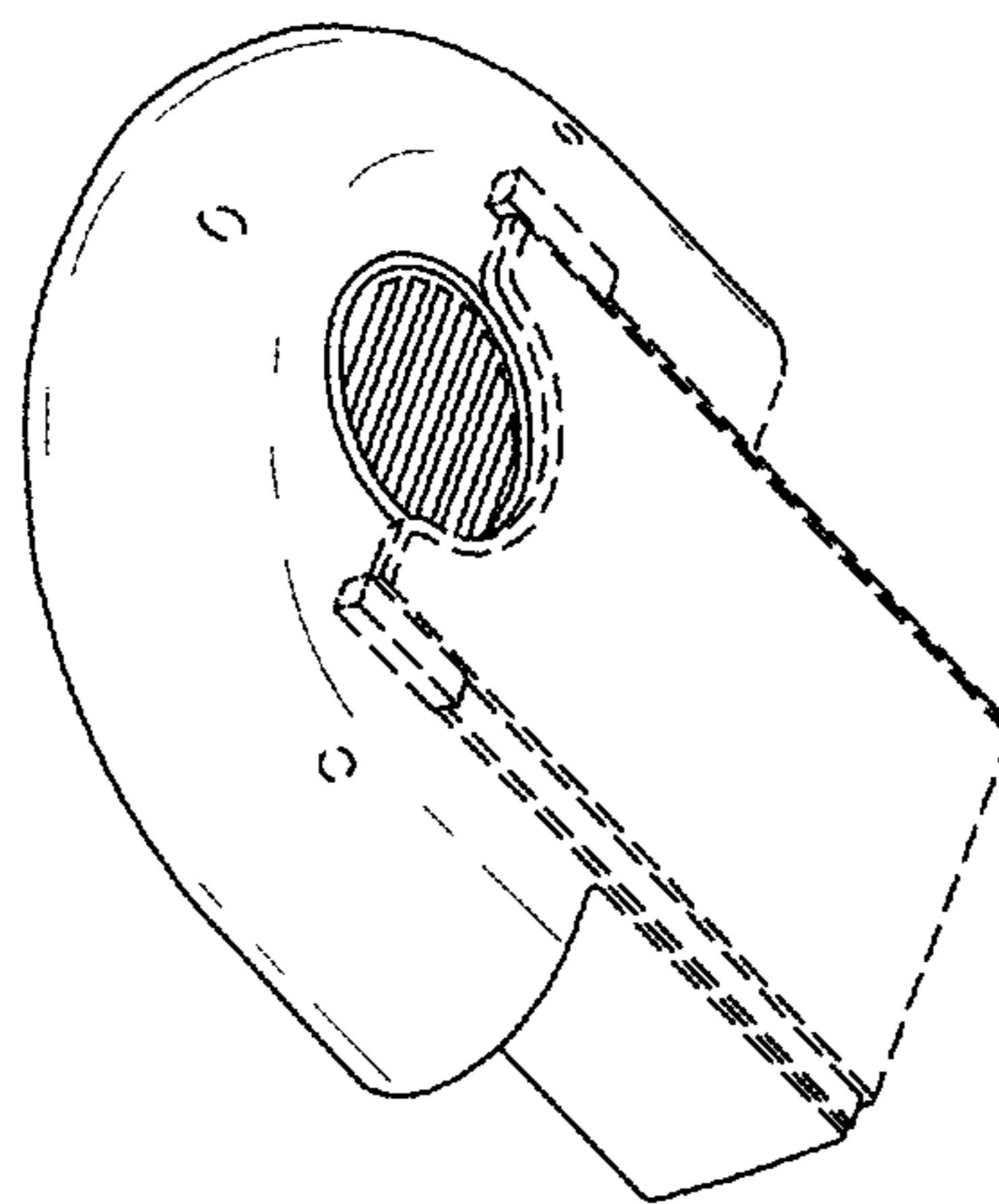

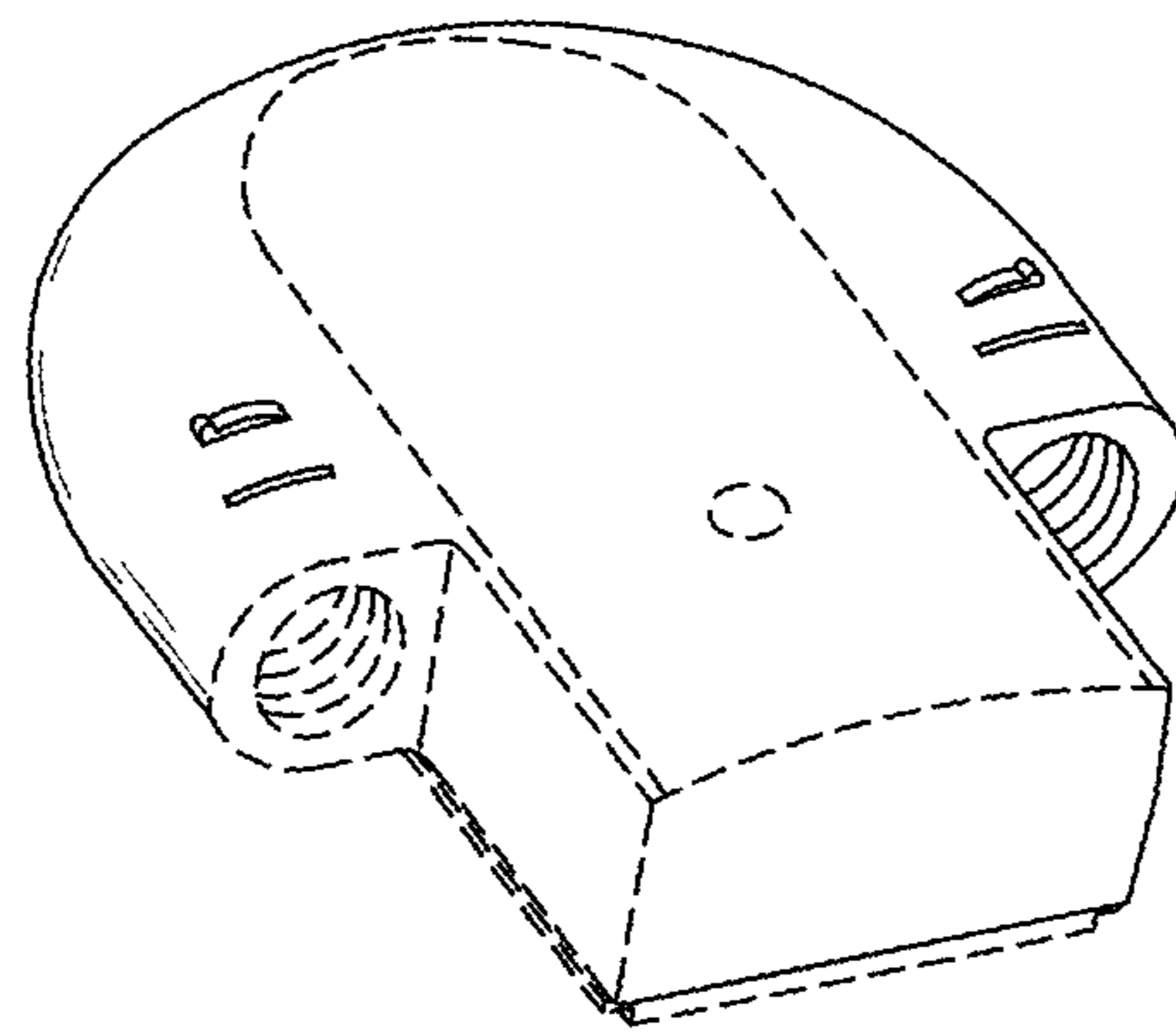

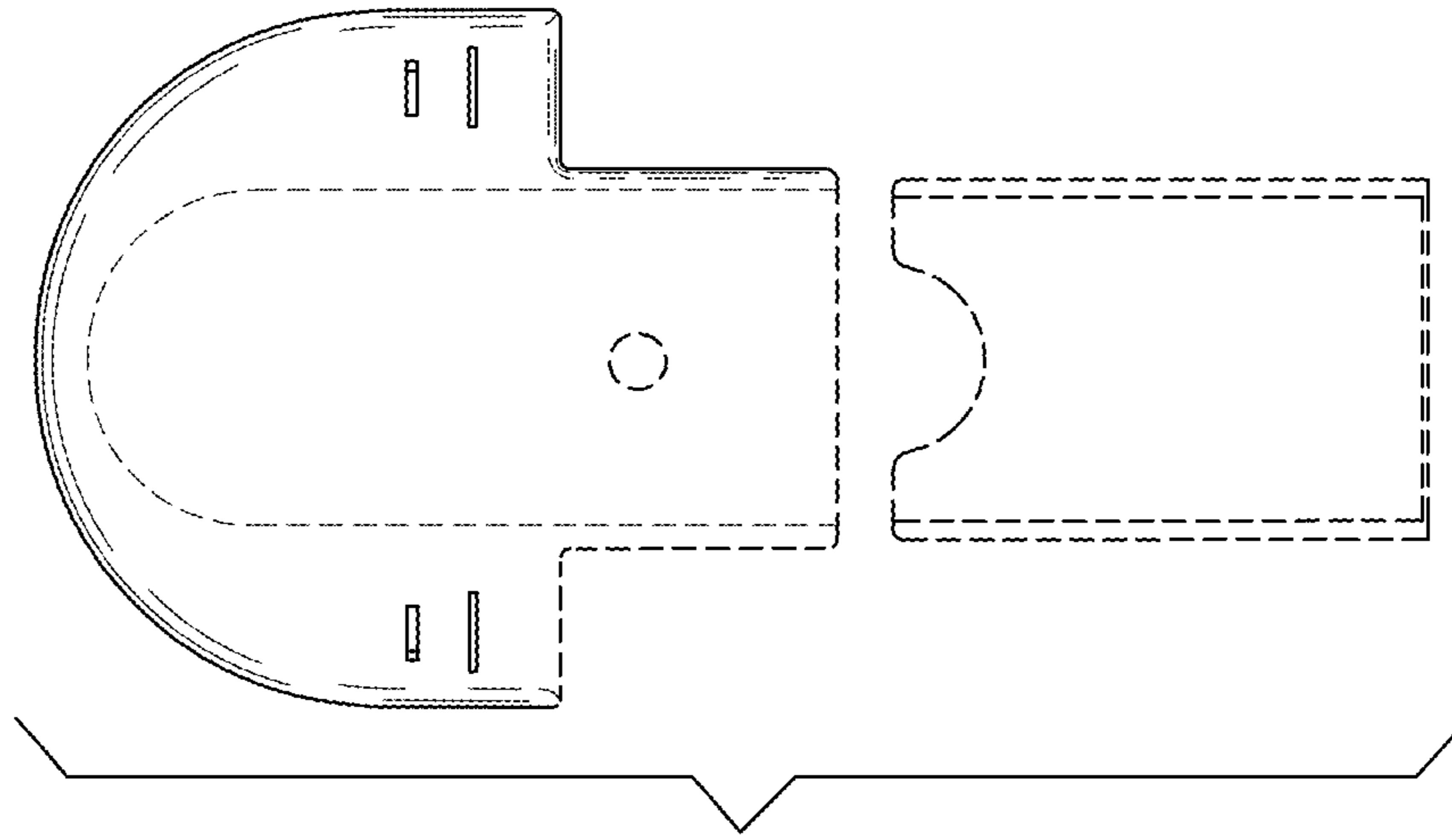

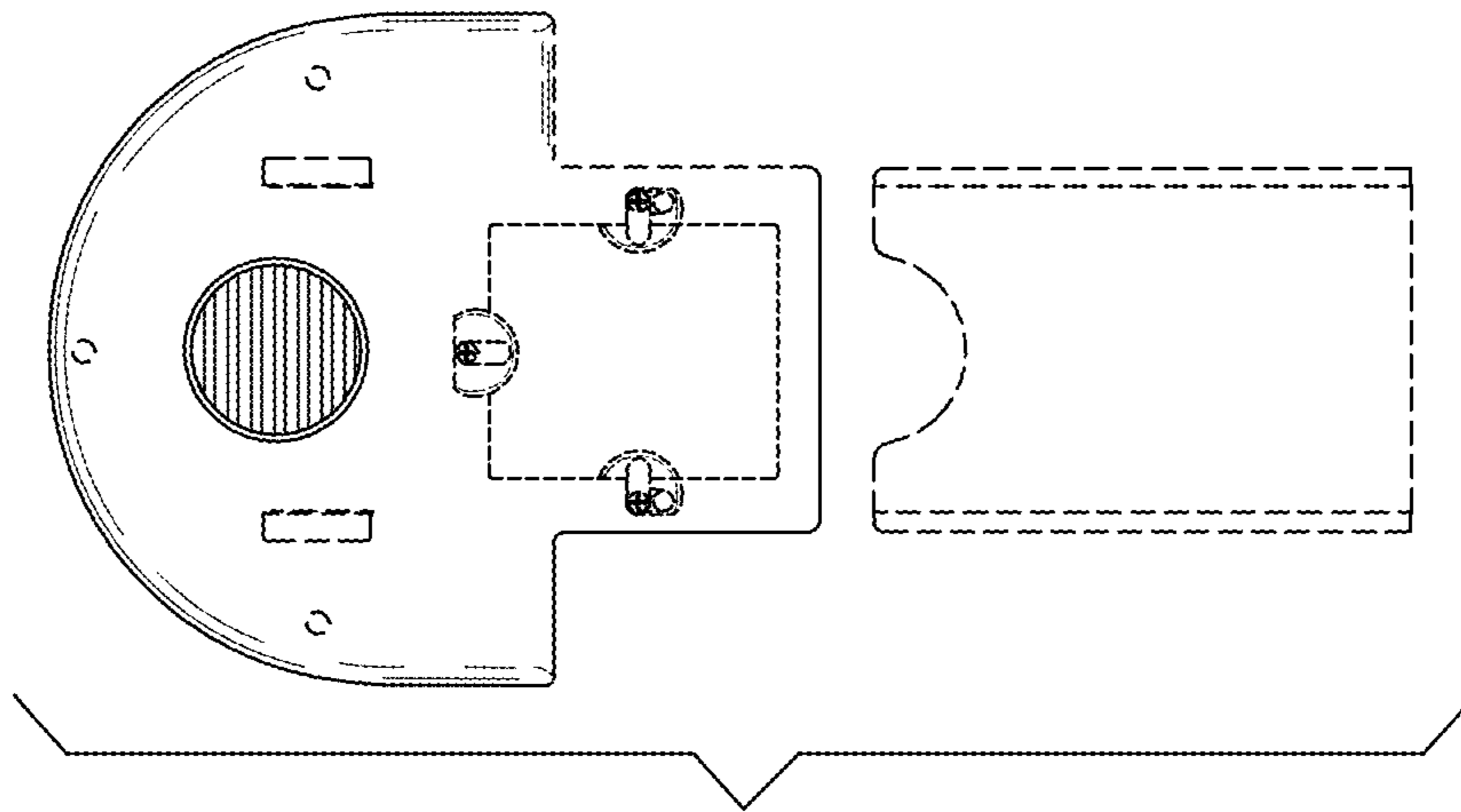
