**DESCRIPTION**

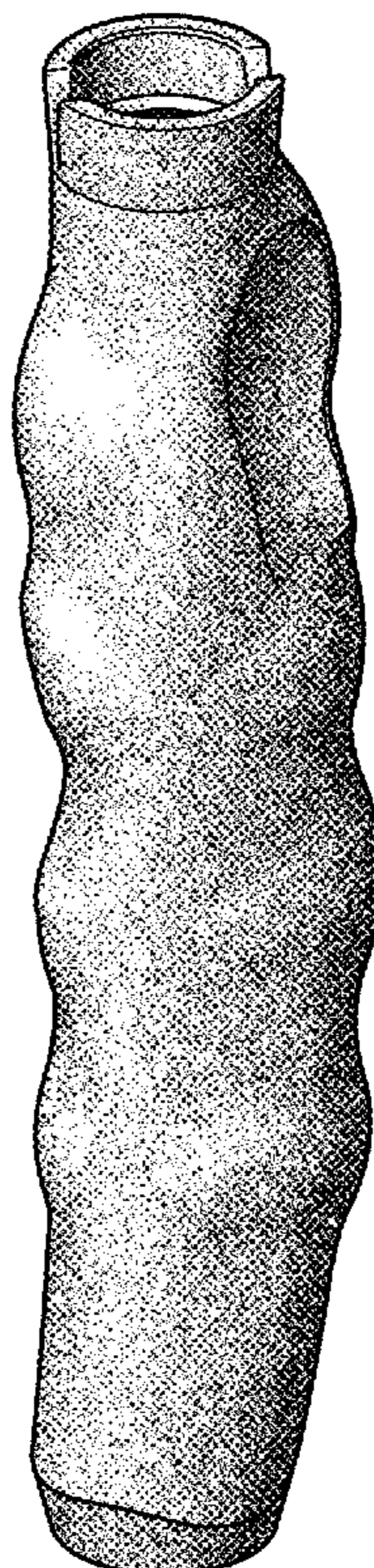

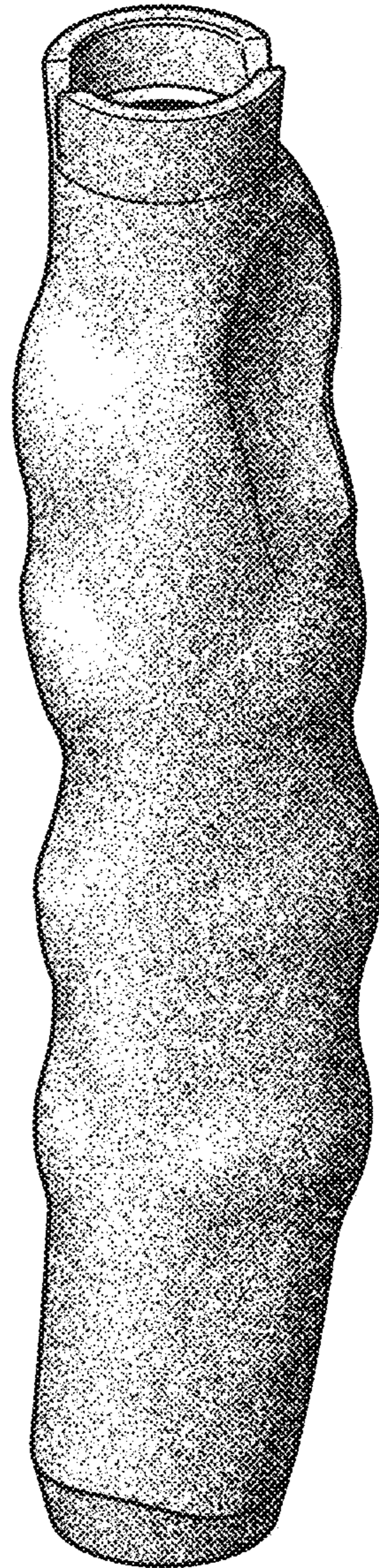

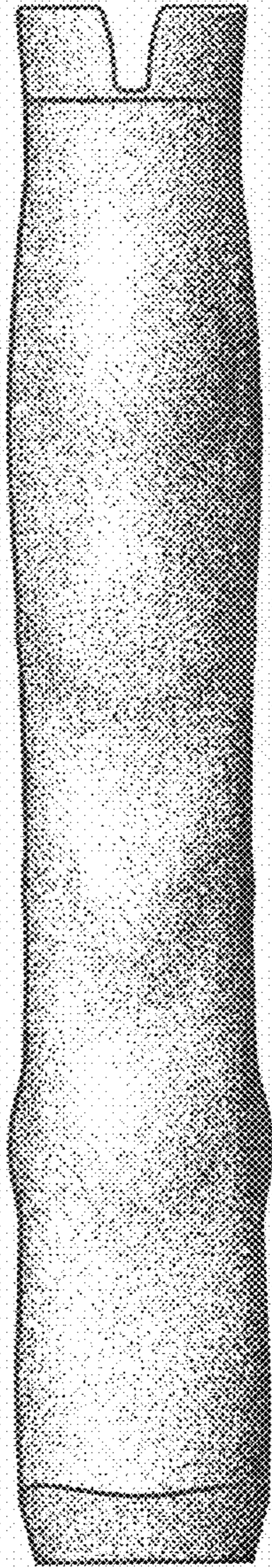

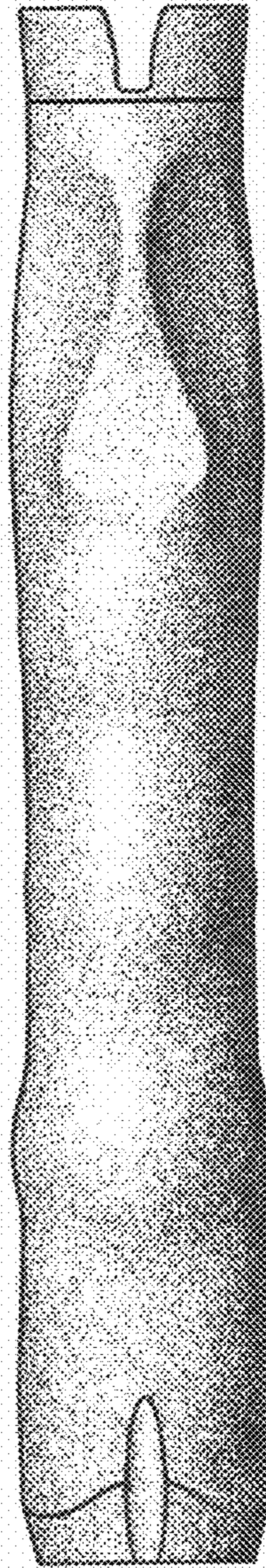
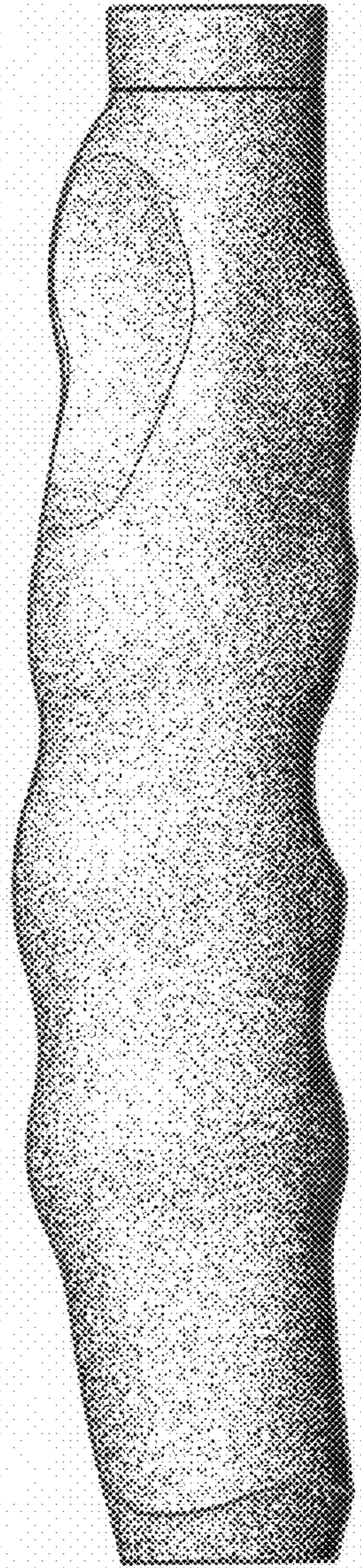
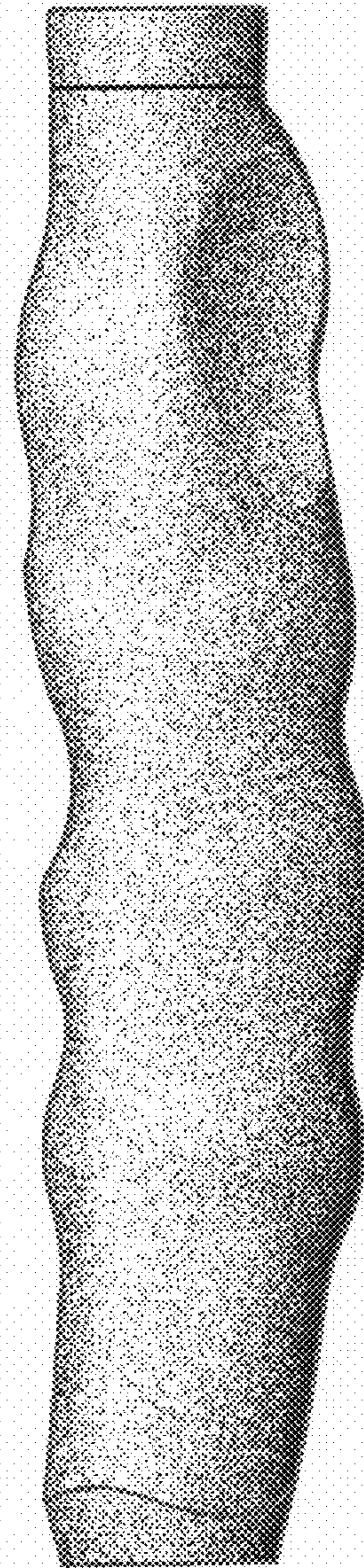


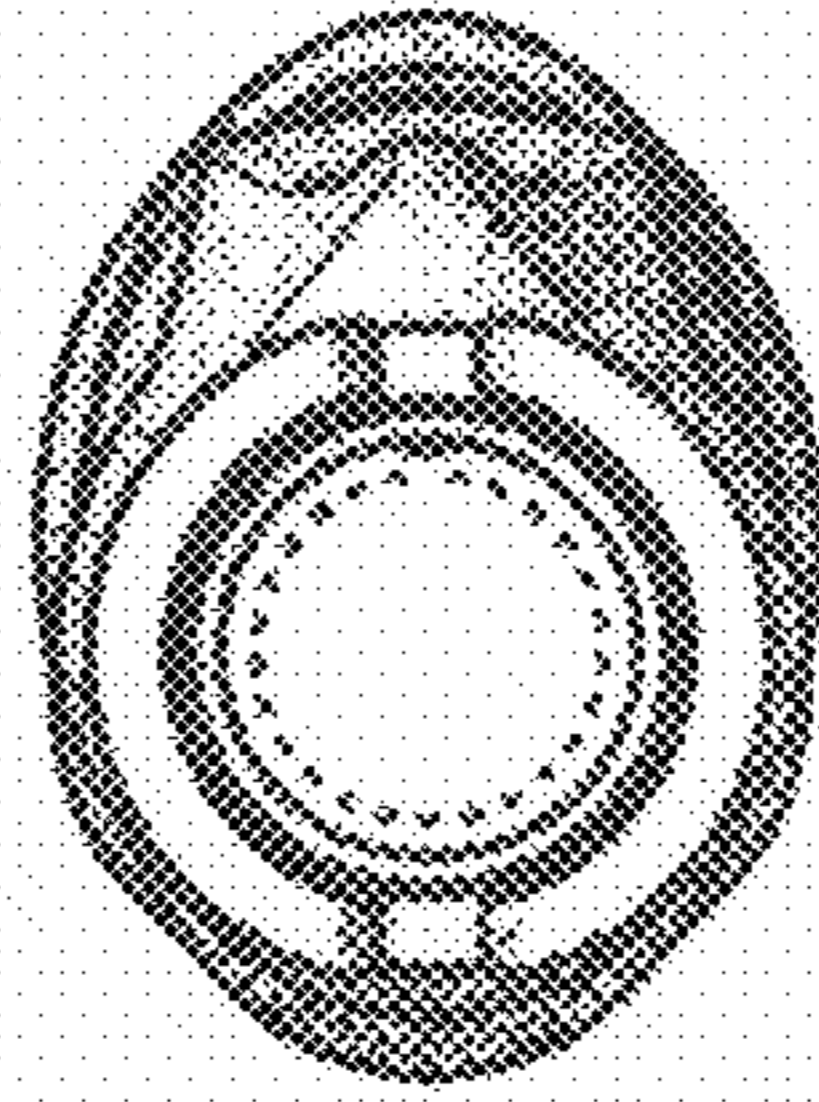

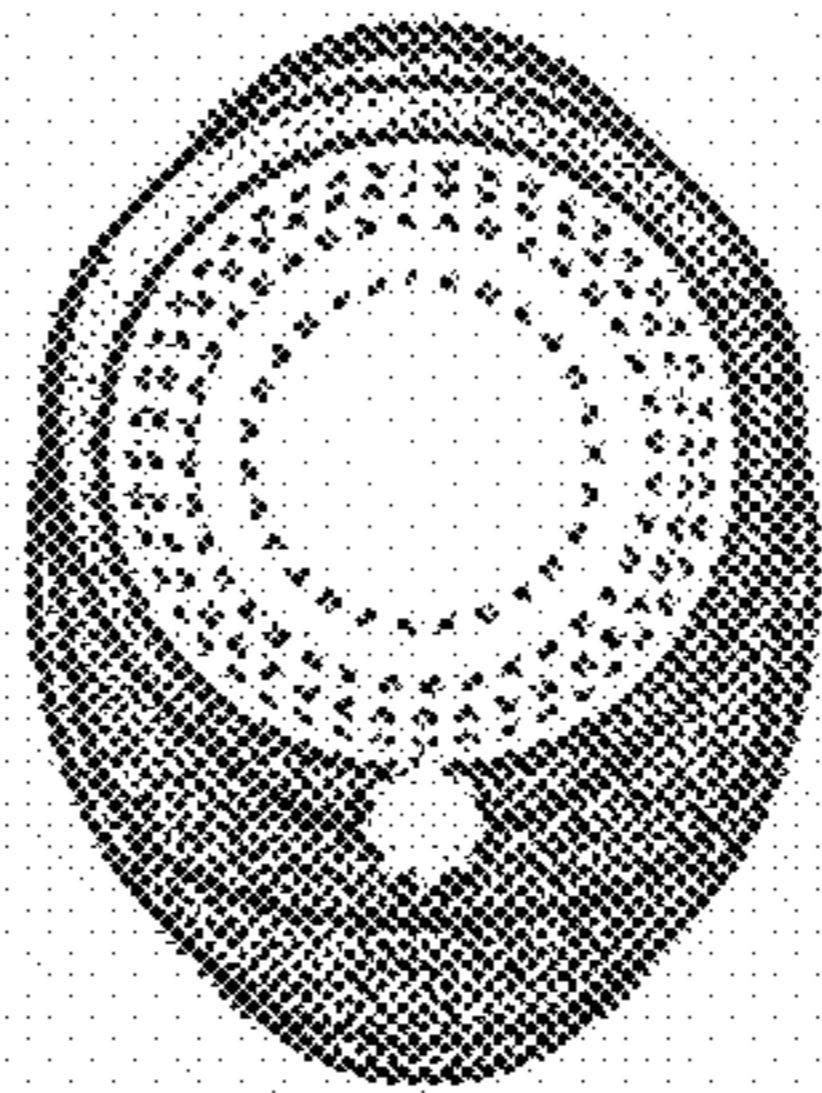
