DESCRIPTION

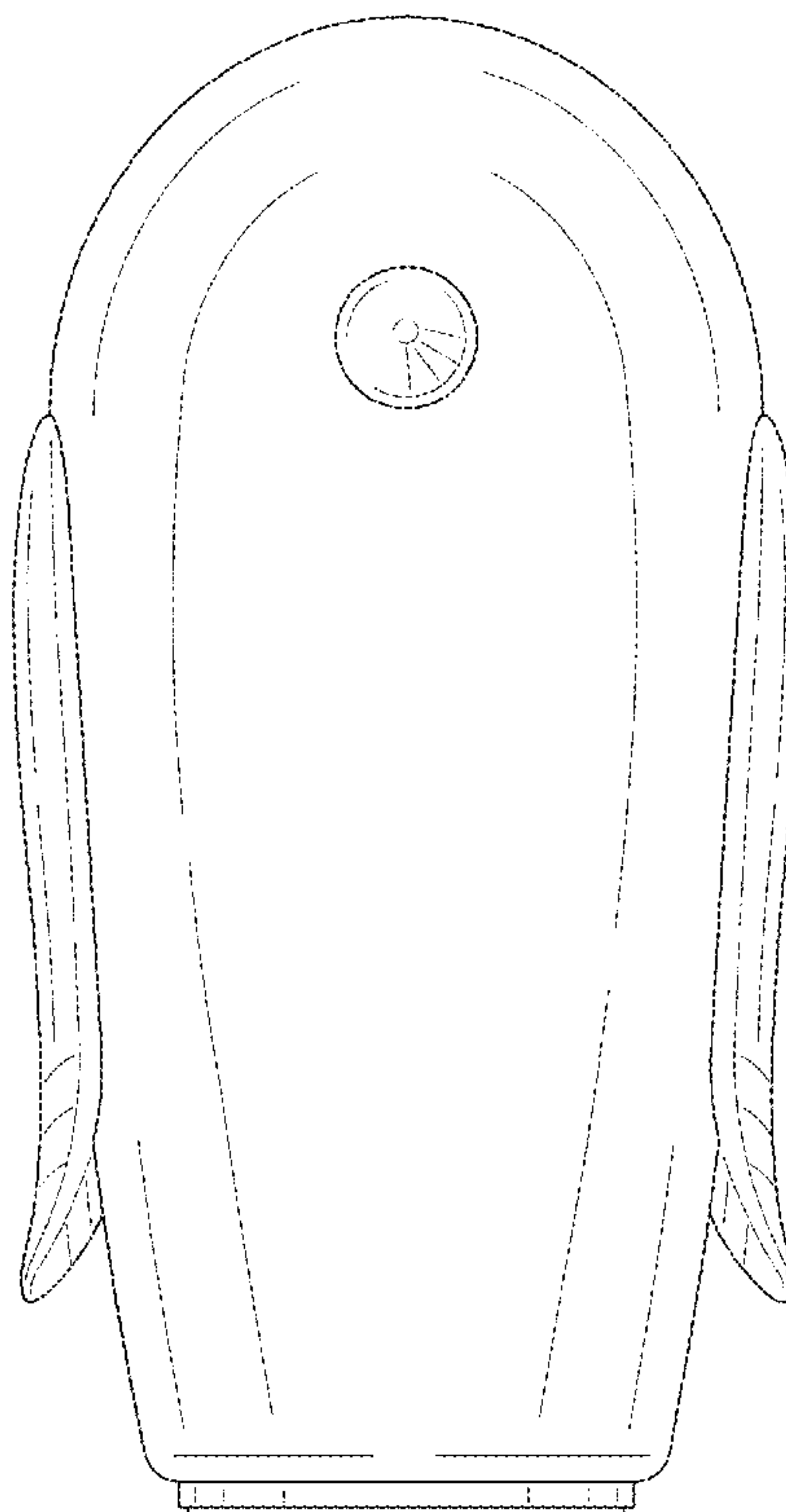
FIG. 1 is a front view of a petlight penguin in accordance with the present new design;

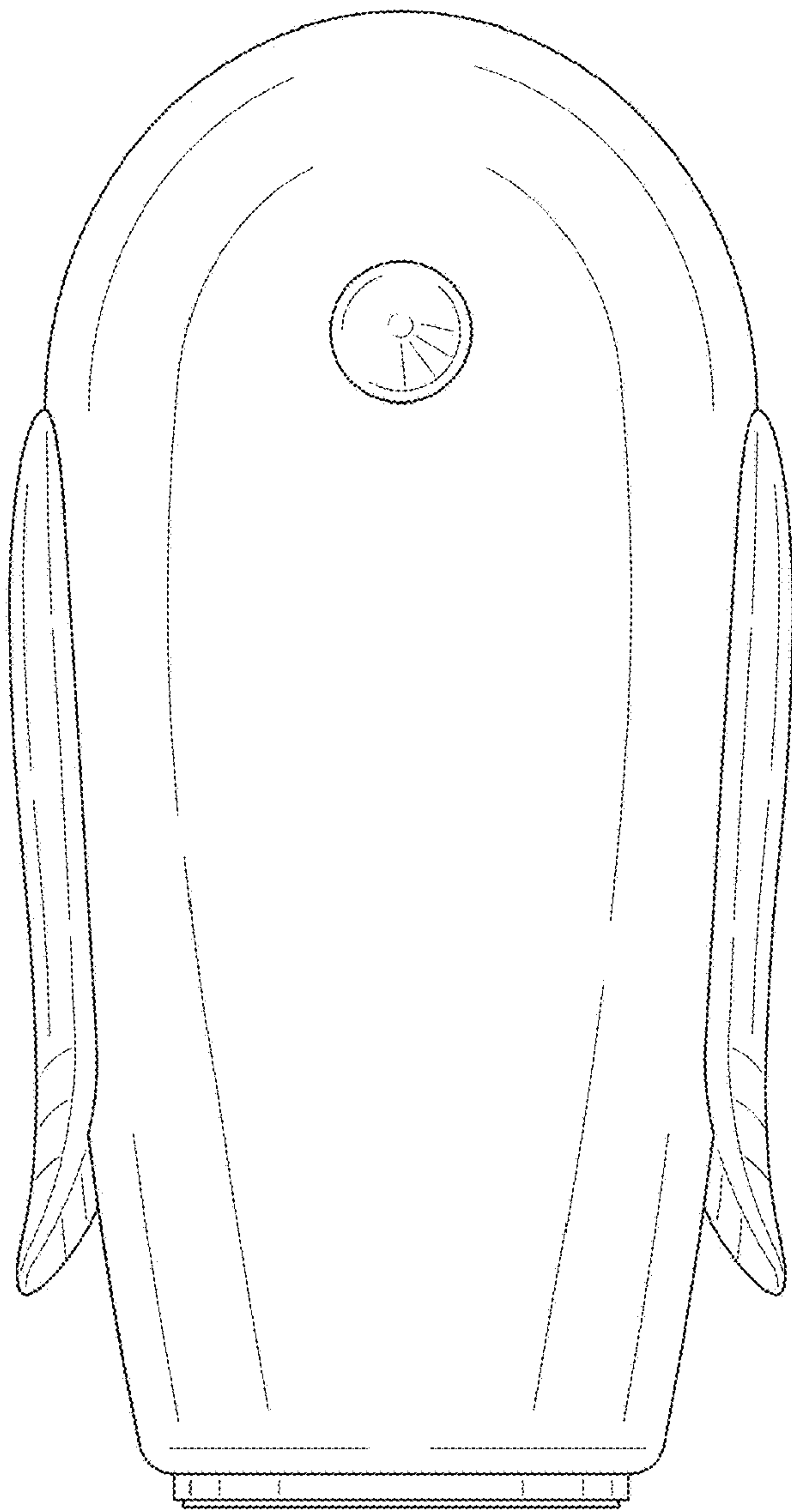
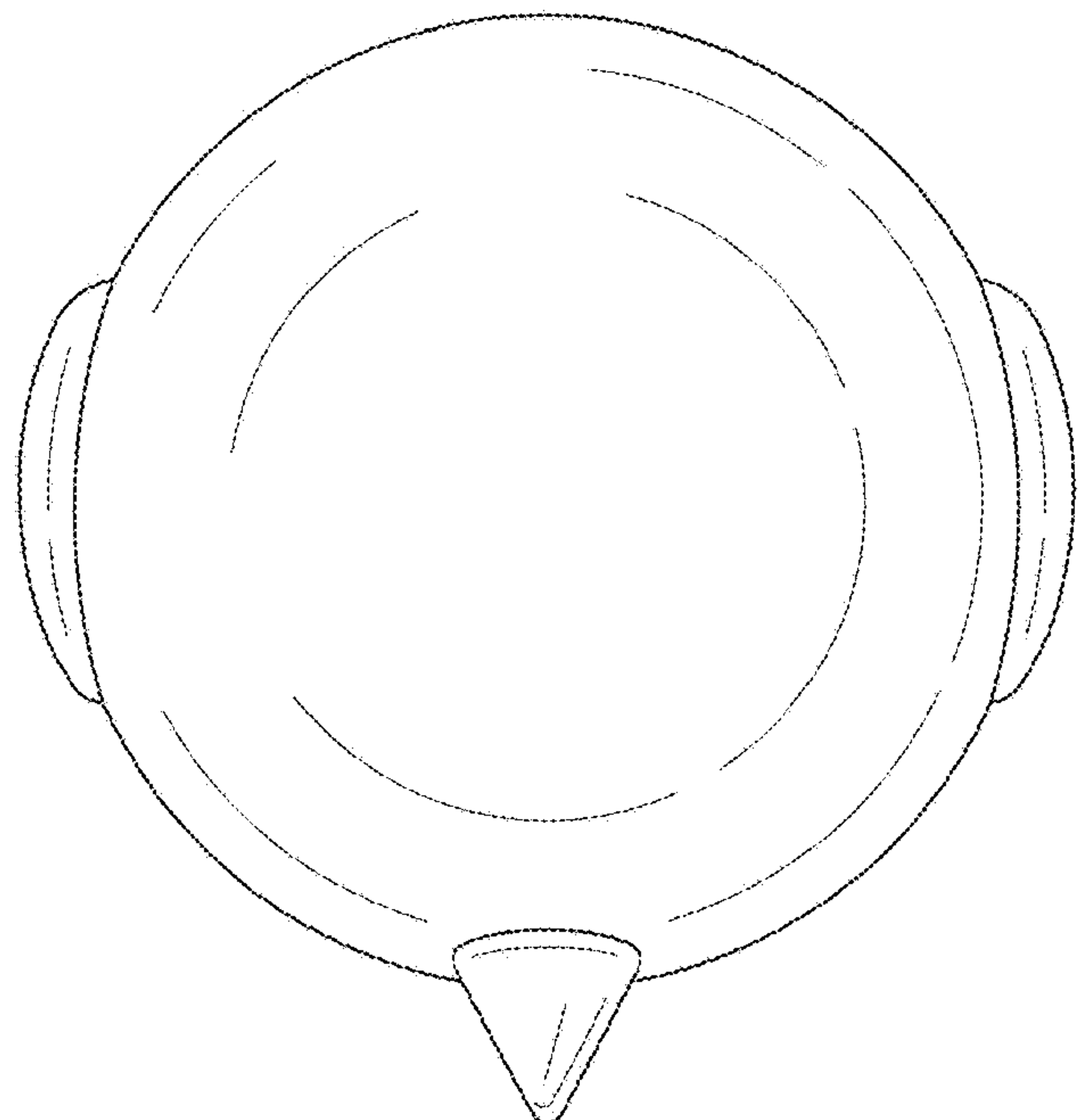

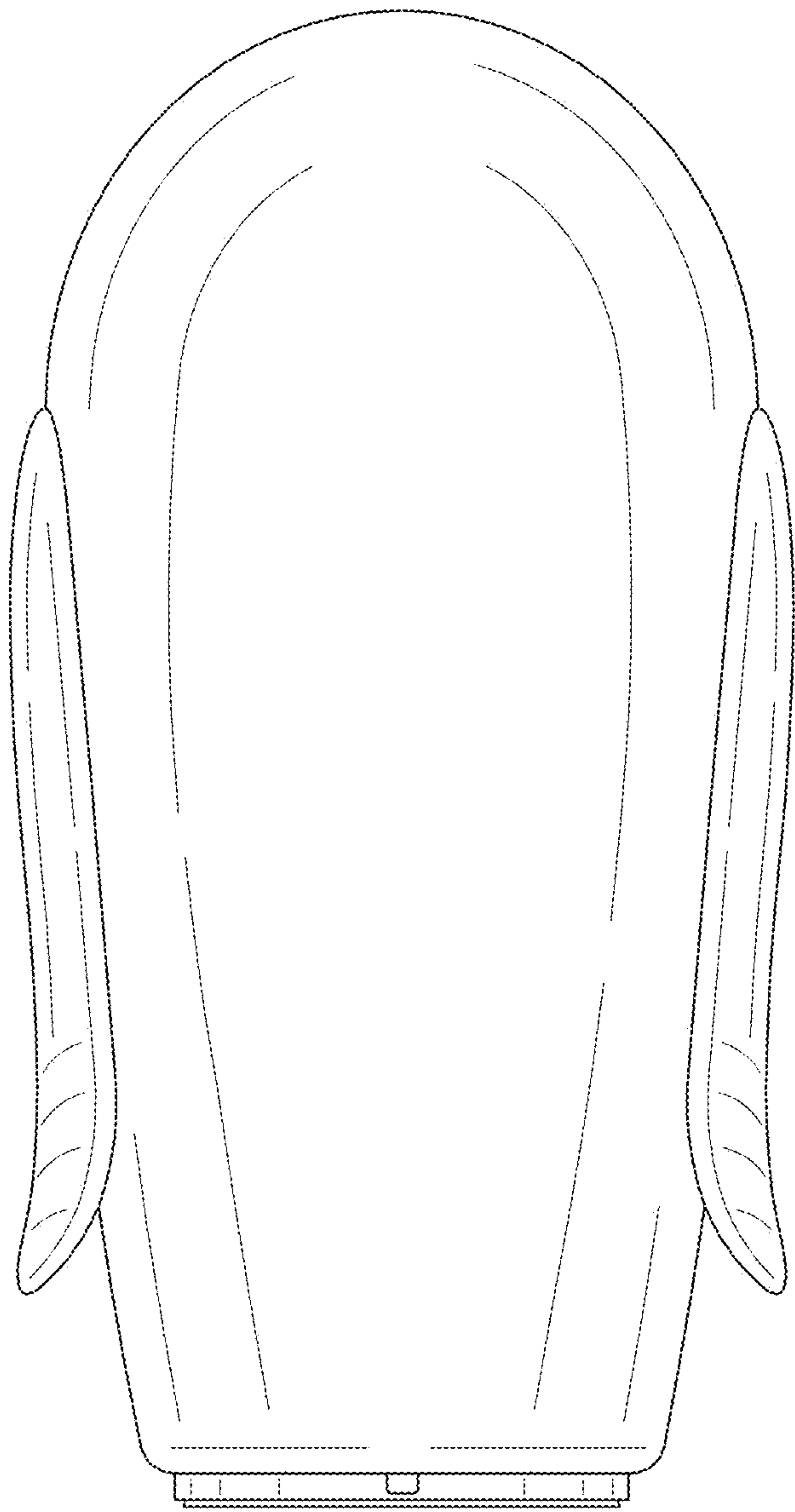

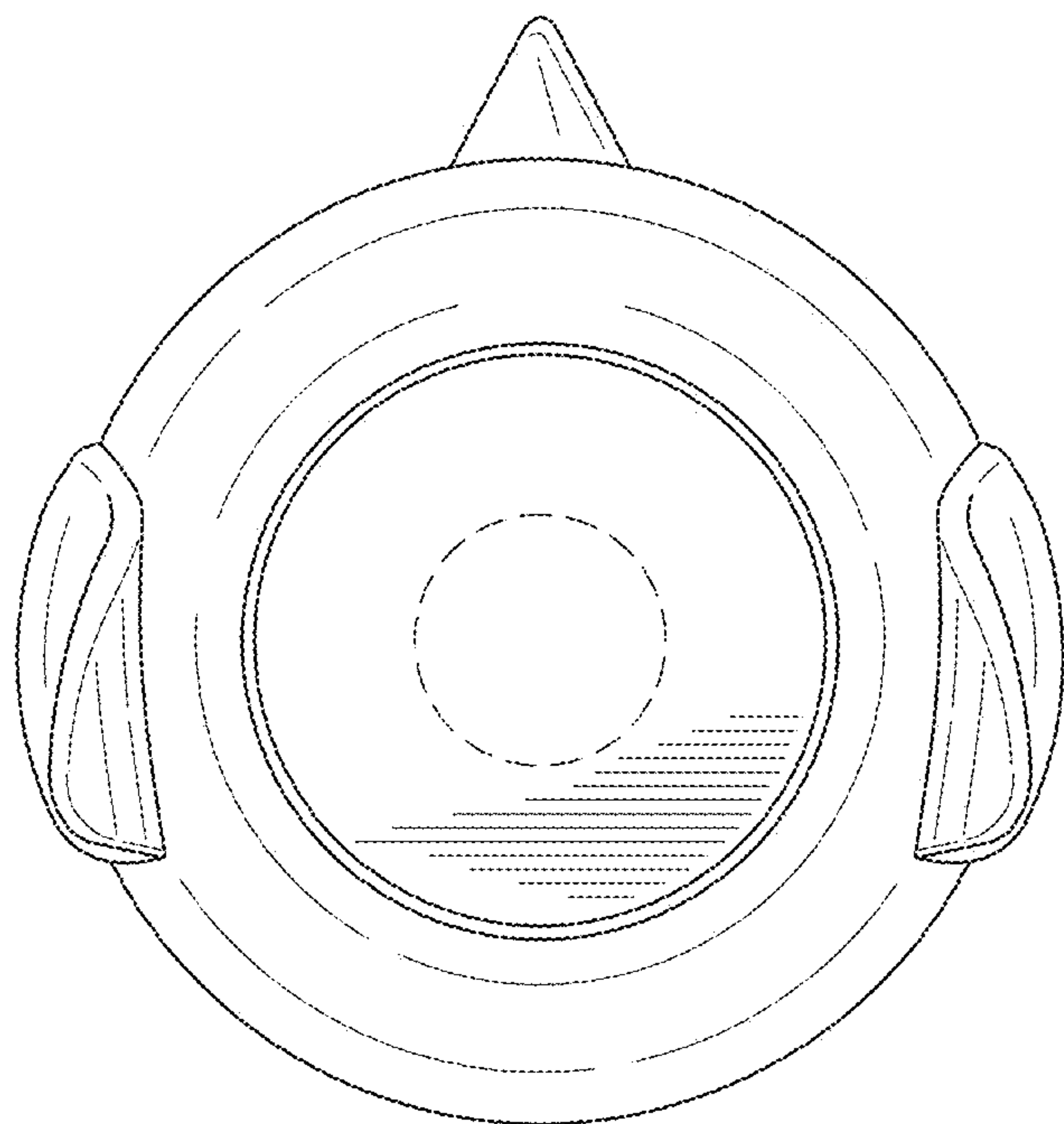

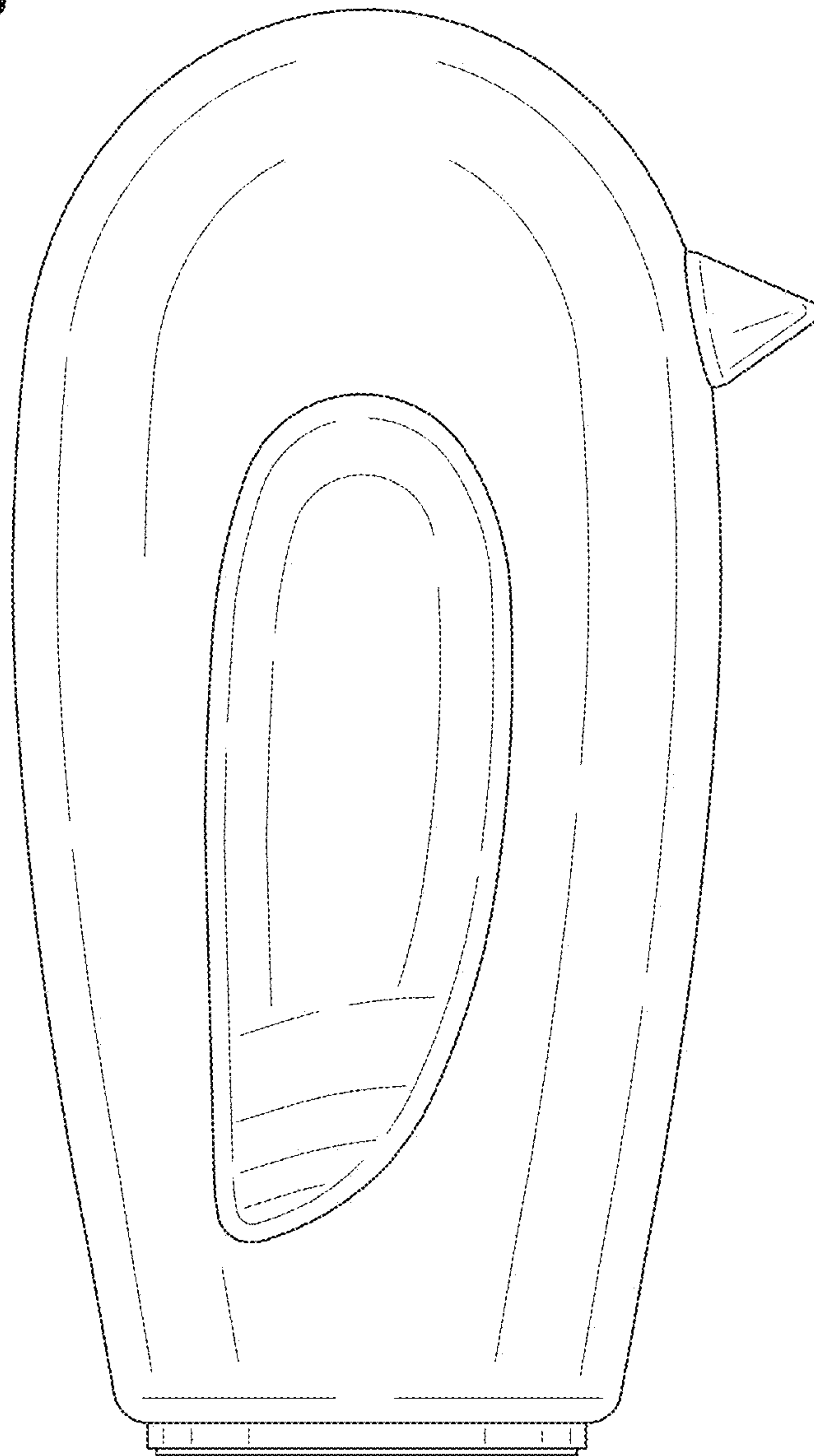
