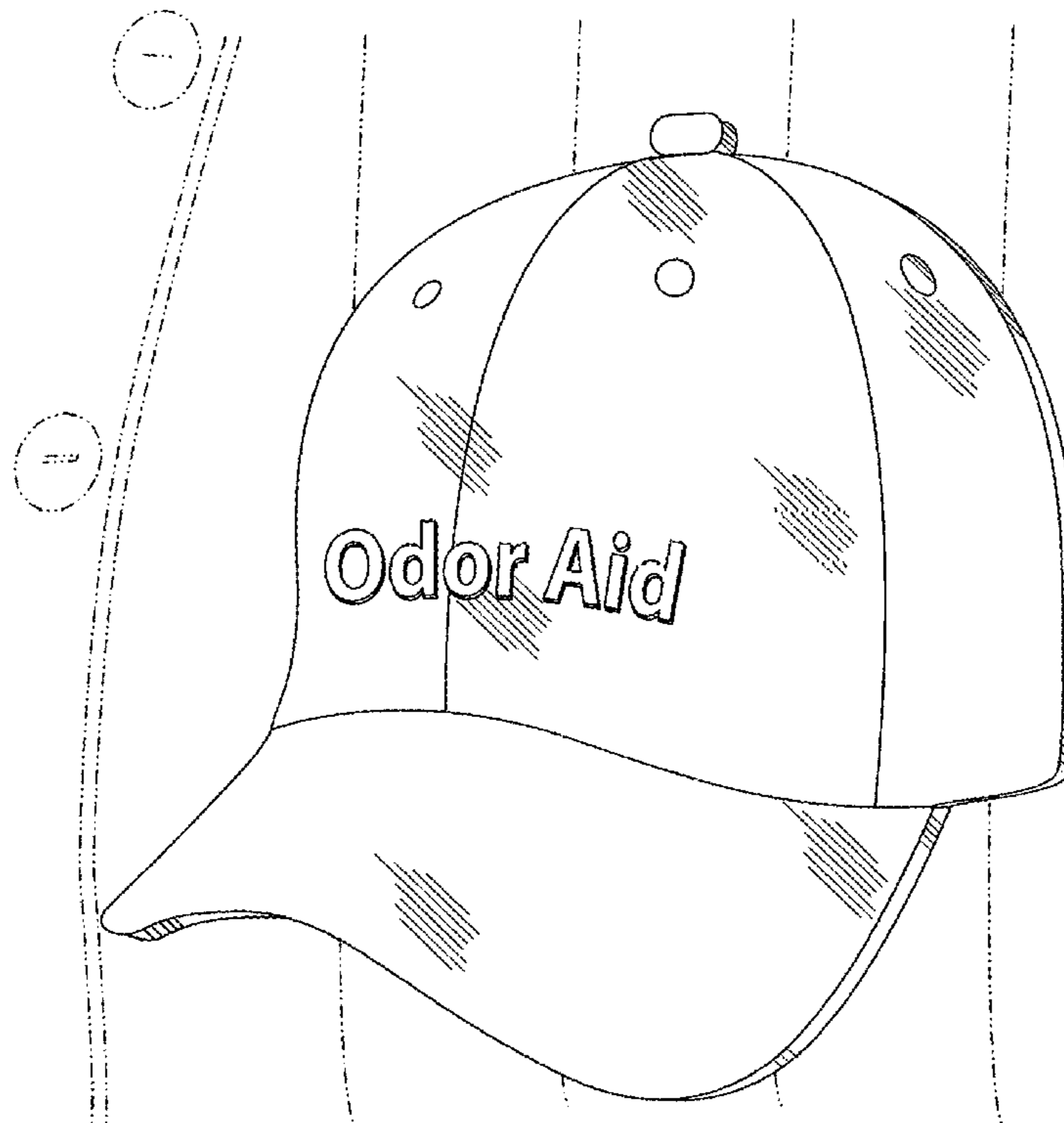
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the odor reducing patch of my new design.

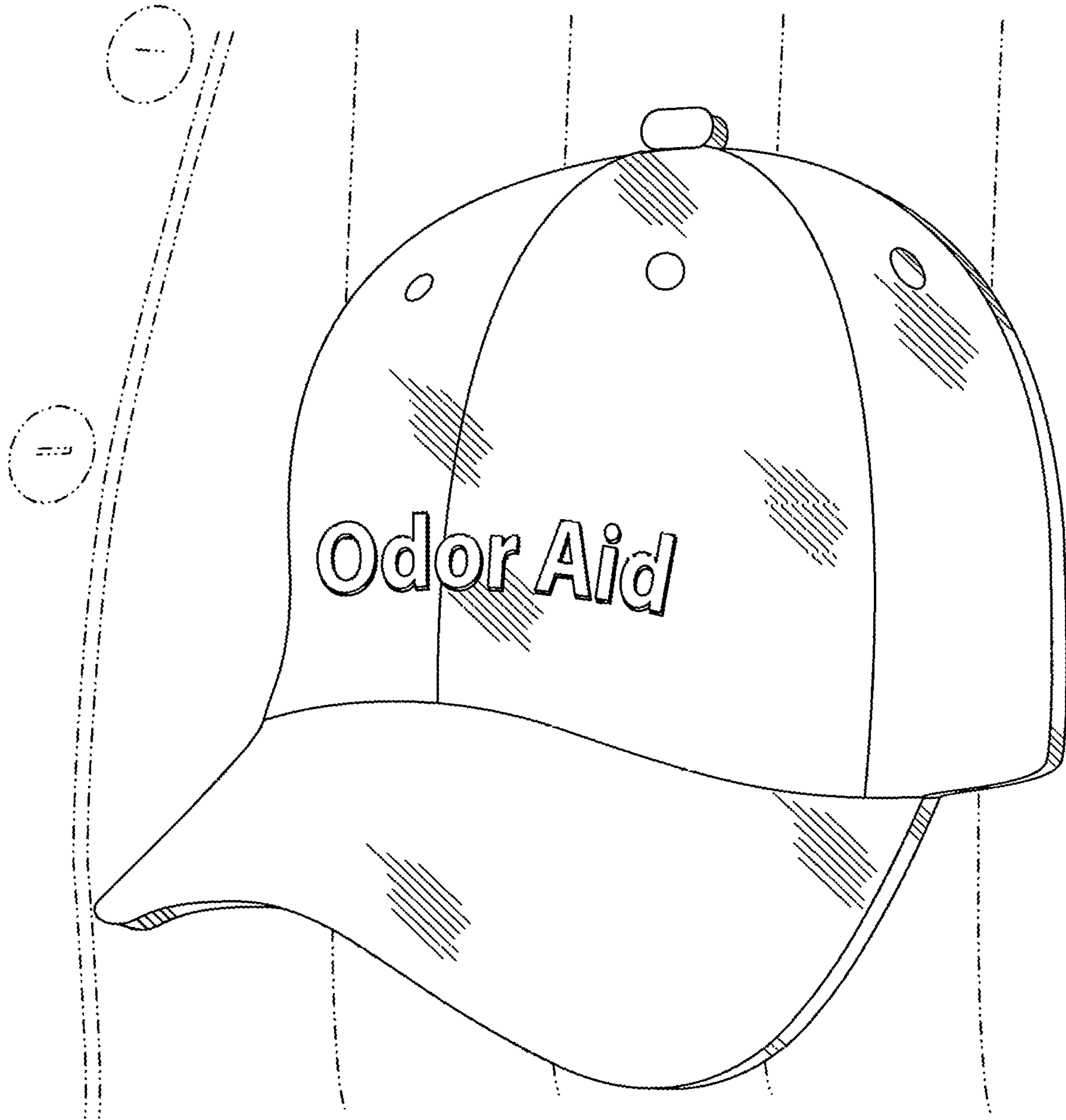

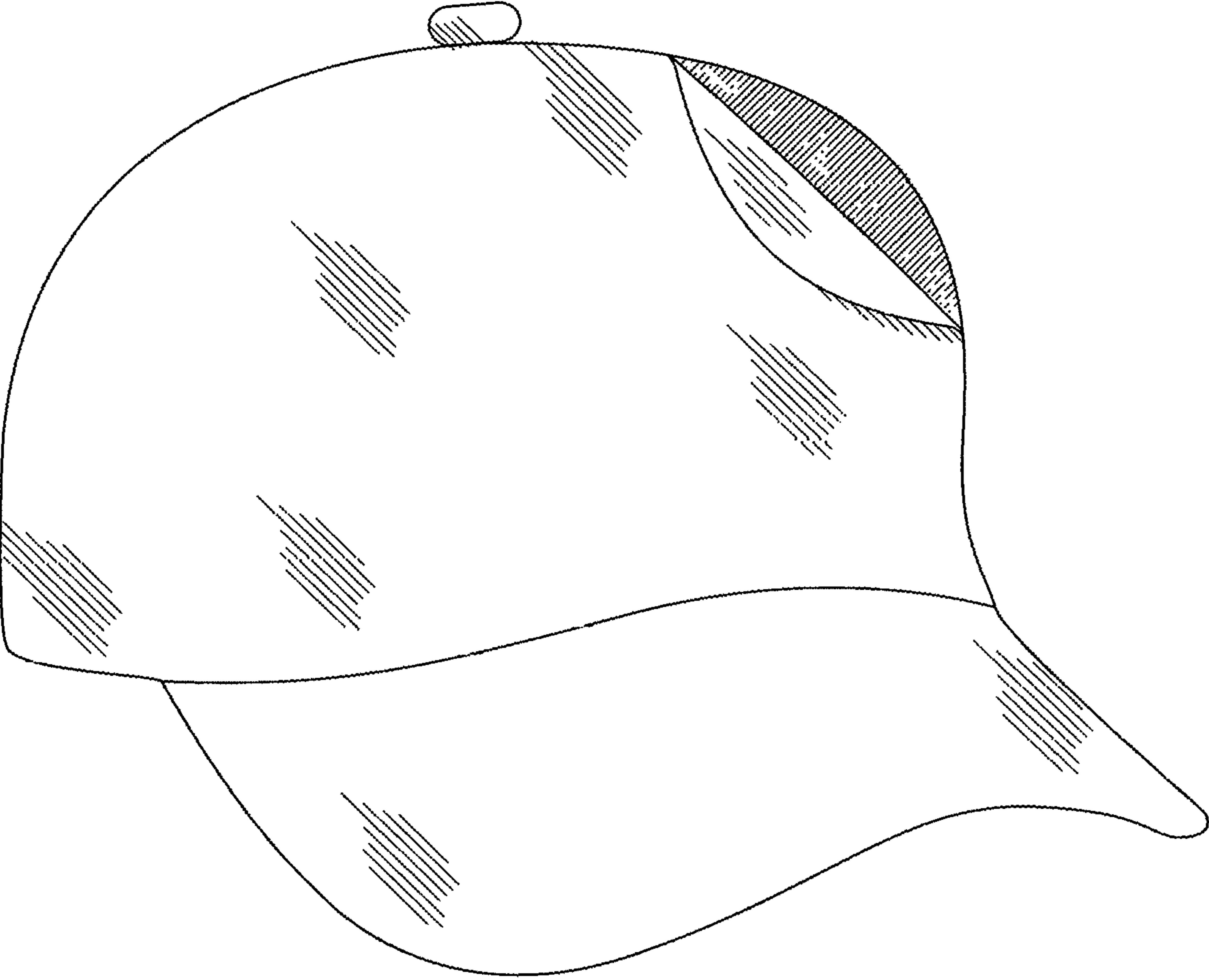

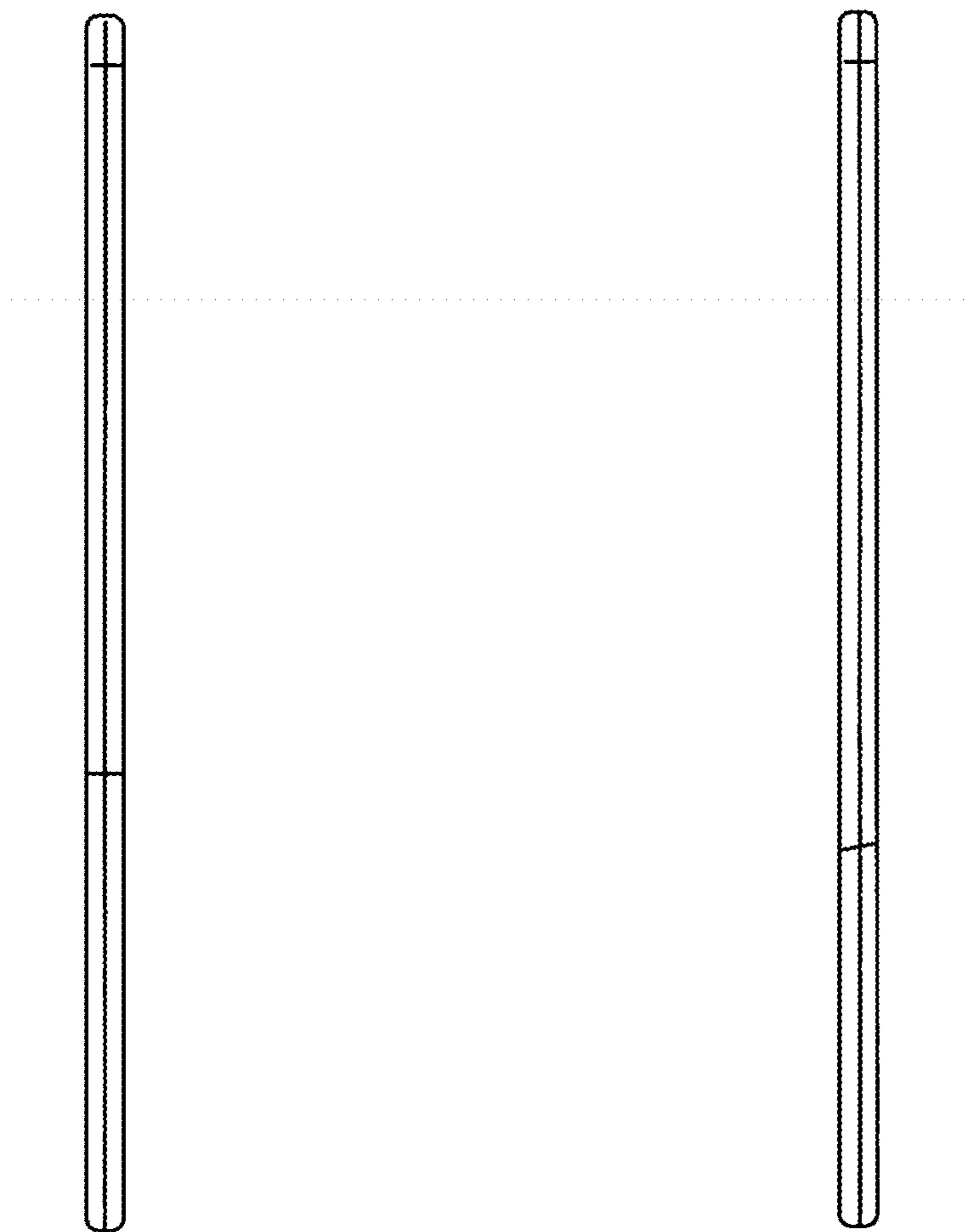

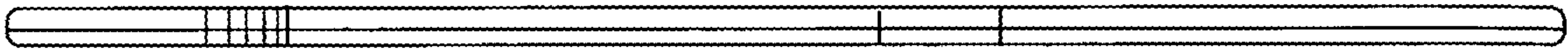

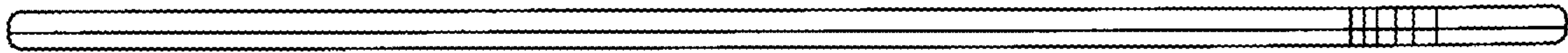
