FIG. 3 is a Rear elevational view thereof

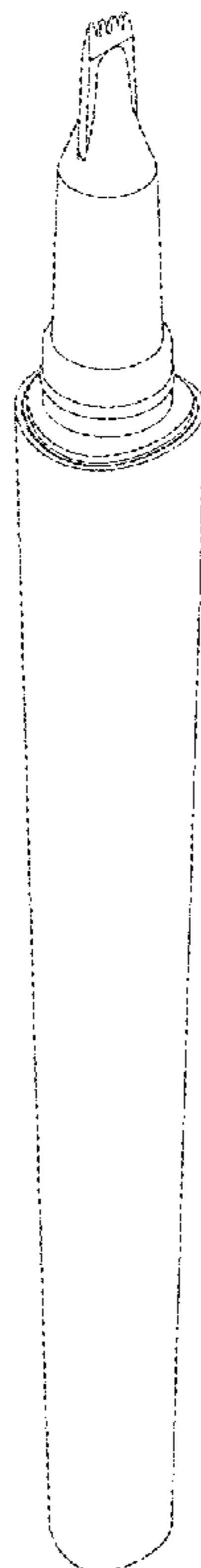
FIG. 4 is a Right side view thereof;

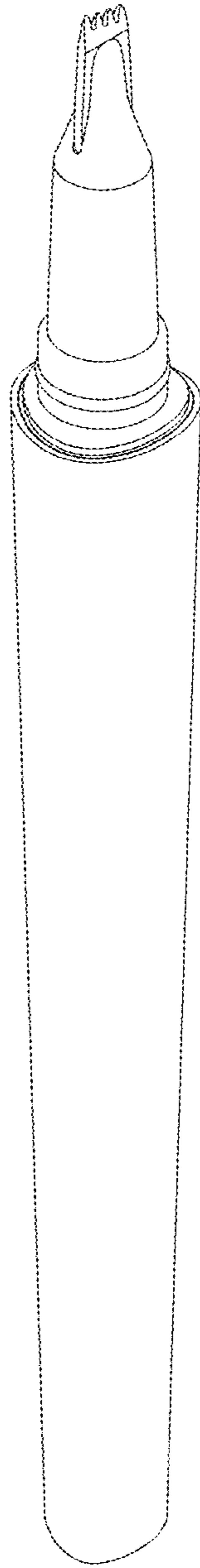

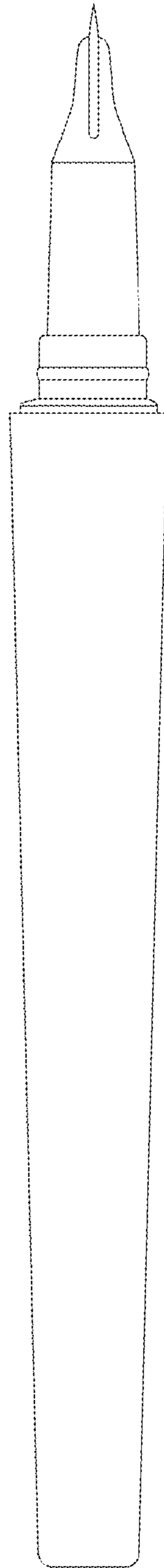

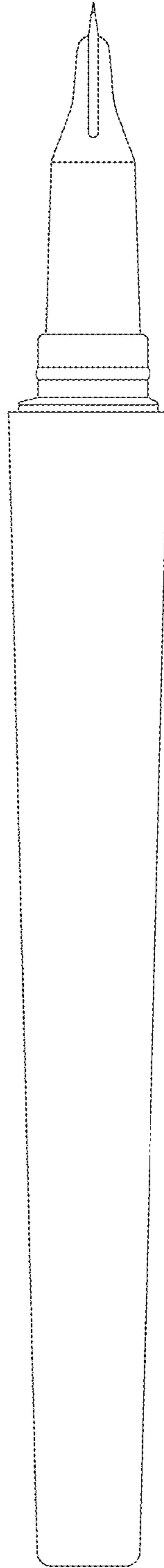

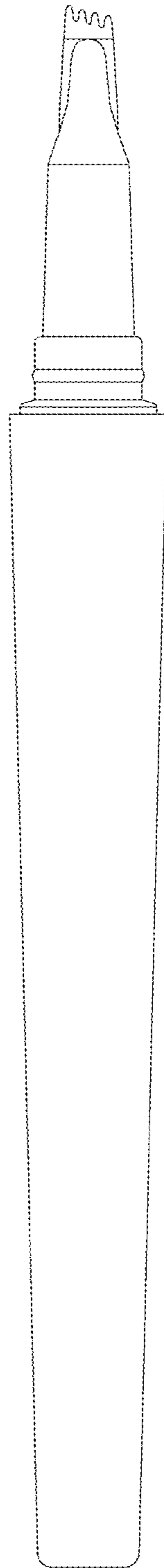

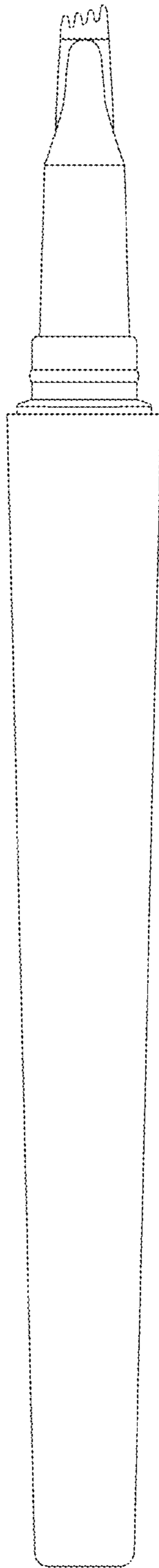

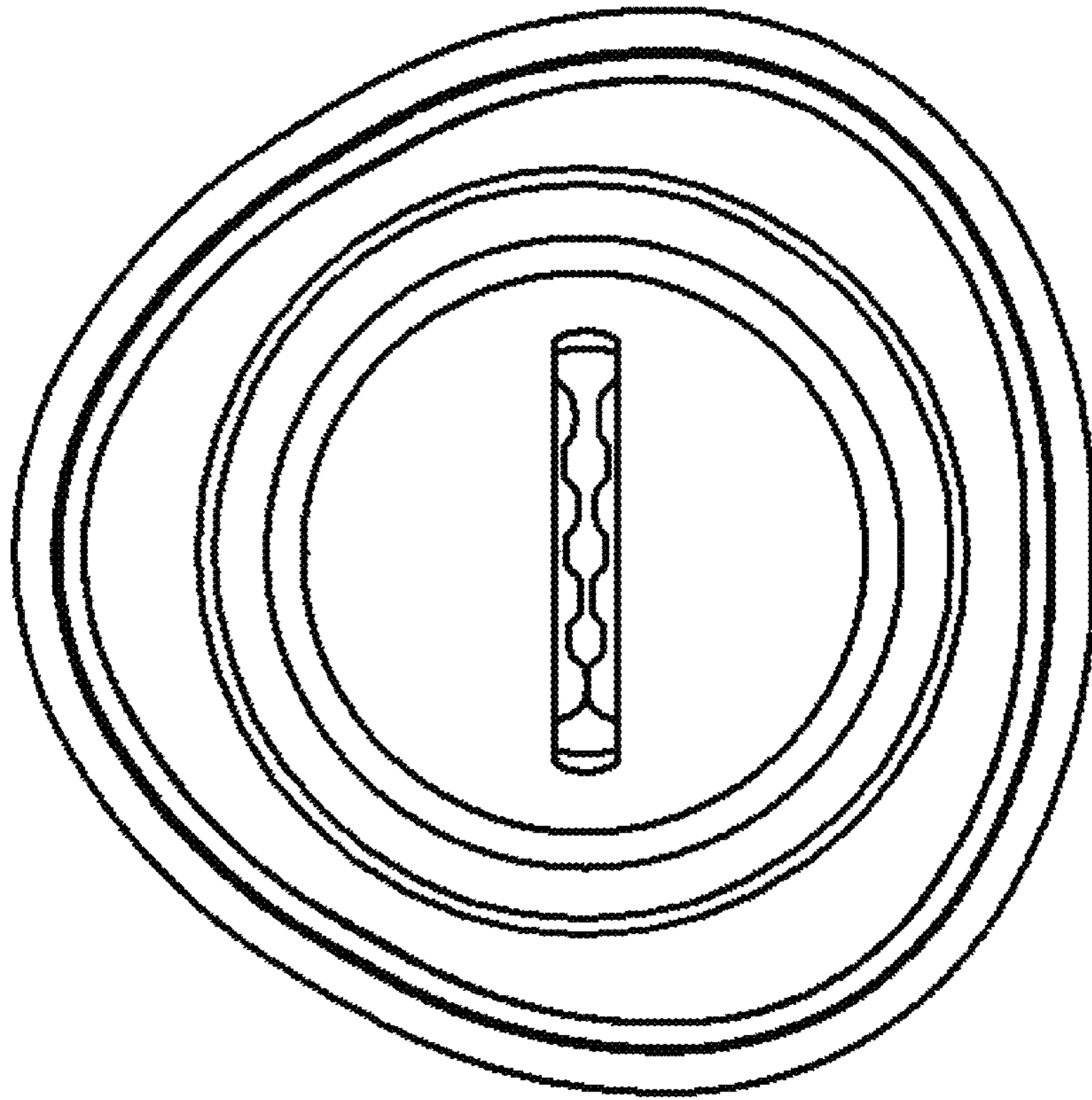

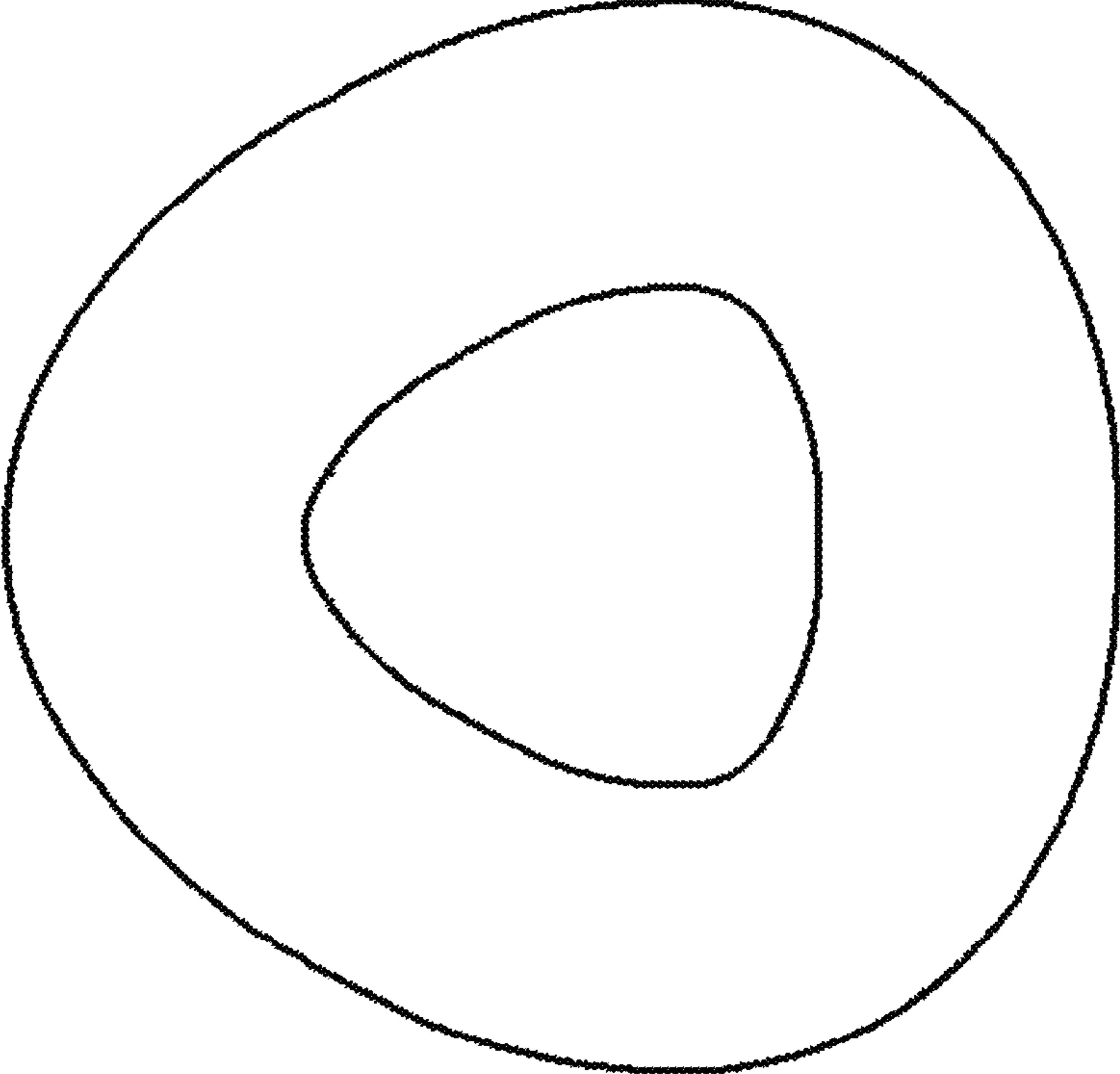
