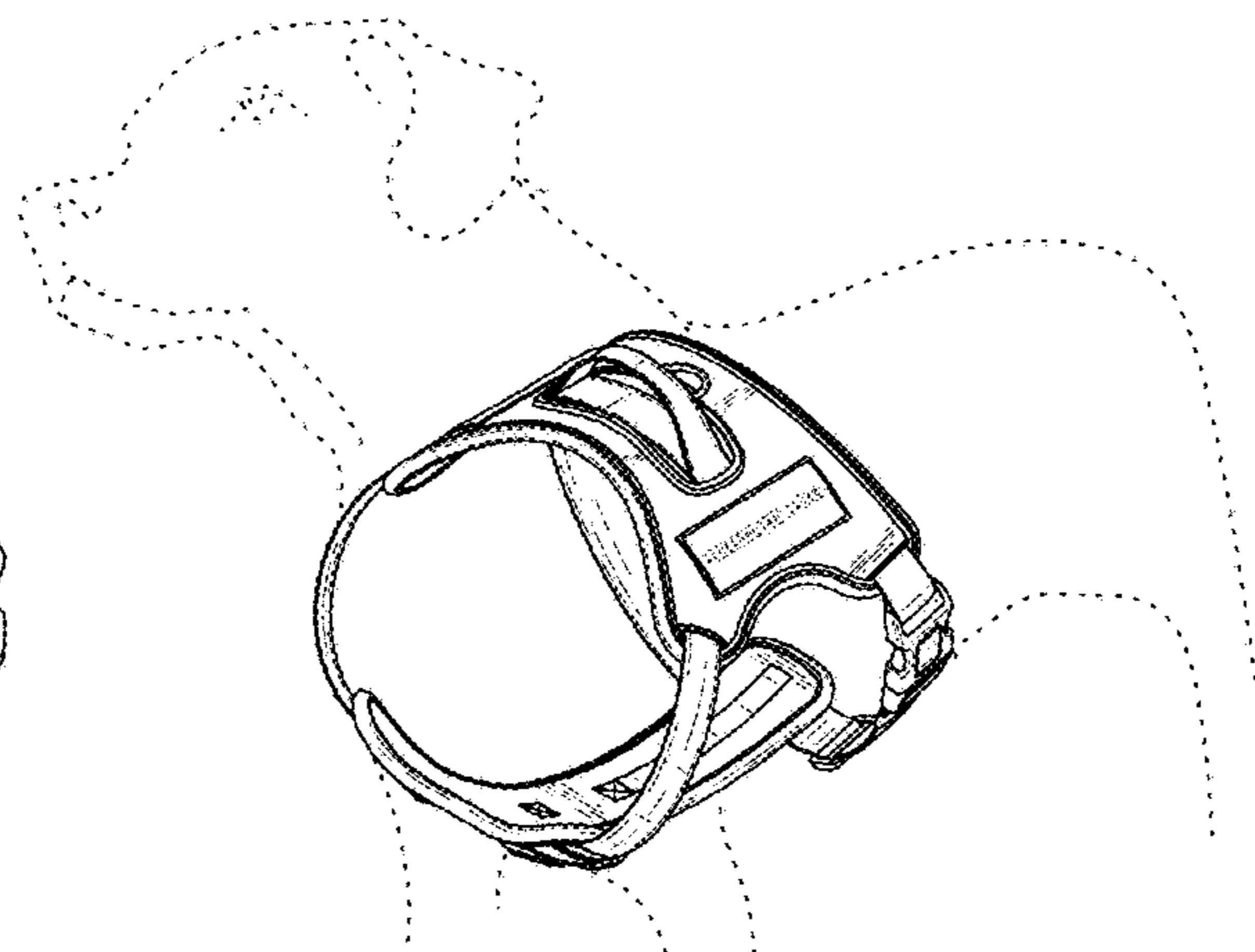
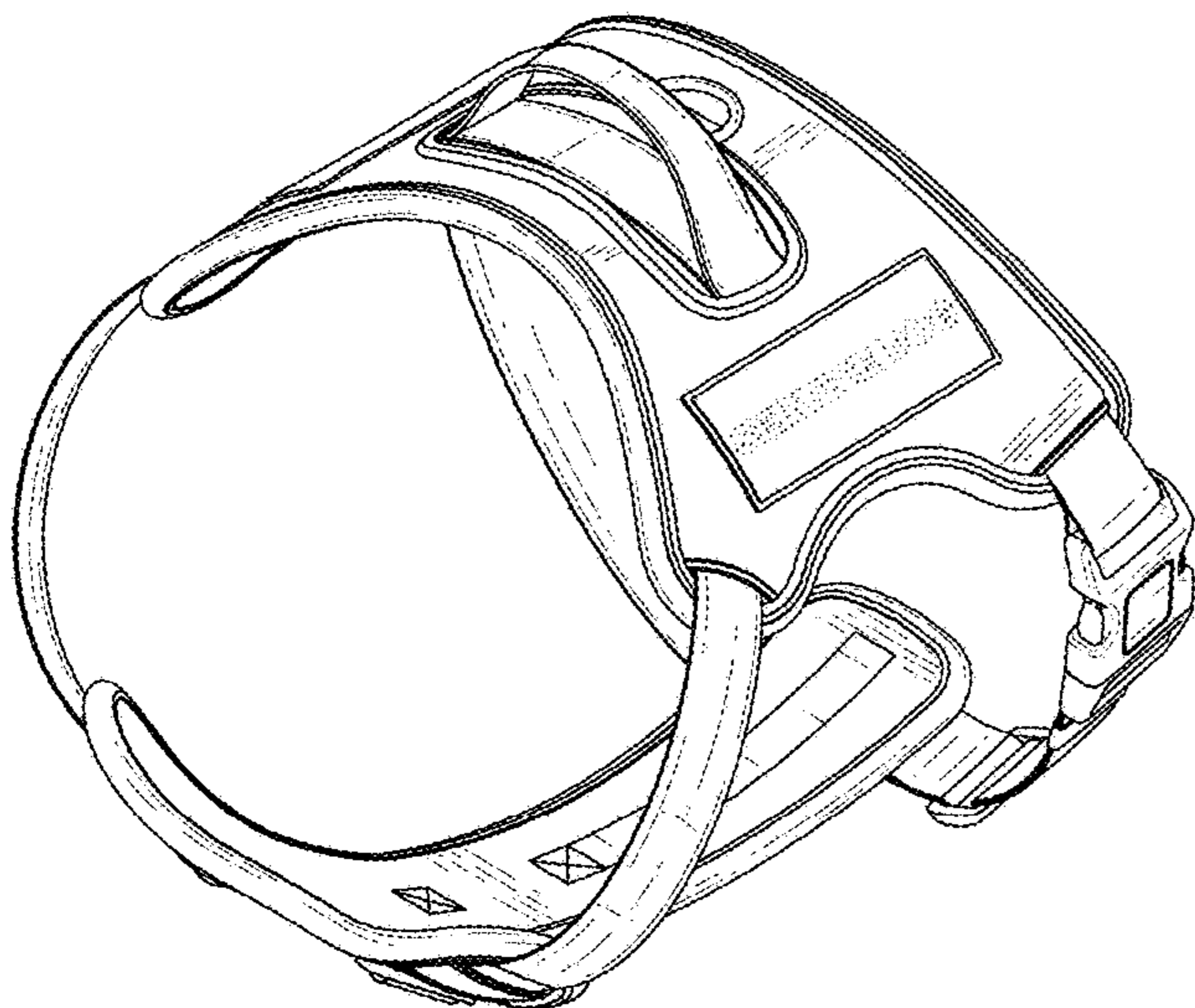
The ornamental design for a dog harness, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a dog harness, showing our new design;
FIG. 2 is a bottom, rear, left side perspective view of the dog harness depicted in FIG. 1;
FIG. 3 is bottom, rear, left side perspective view of the dog harness depicted in FIG. 1;
FIG. 4 is a bottom, front, left side perspective view of the dog harness depicted in FIG. 1;
FIG. 5 is a rear elevation view of the dog harness depicted in FIG. 1;
FIG. 6 is a front elevation view of the dog harness depicted in FIG. 1;
FIG. 7 is a left side elevation view of the dog harness depicted in FIG. 1;
FIG. 8 is a right side elevation view of the dog harness depicted in FIG. 1;
FIG. 9 is a top plan view of the dog harness depicted in FIG. 1;
FIG. 10 is a bottom plan view of the dog harness depicted in FIG. 1;
FIG. 11 is a top, front, left side perspective view of the dog harness, shown within an environment of use;
FIG. 12 is a top, rear, left side perspective view thereof; and,
FIG. 13 is a top, front, left side perspective view of the dog harness depicted in FIG. 1, shown in an alternate condition of use.

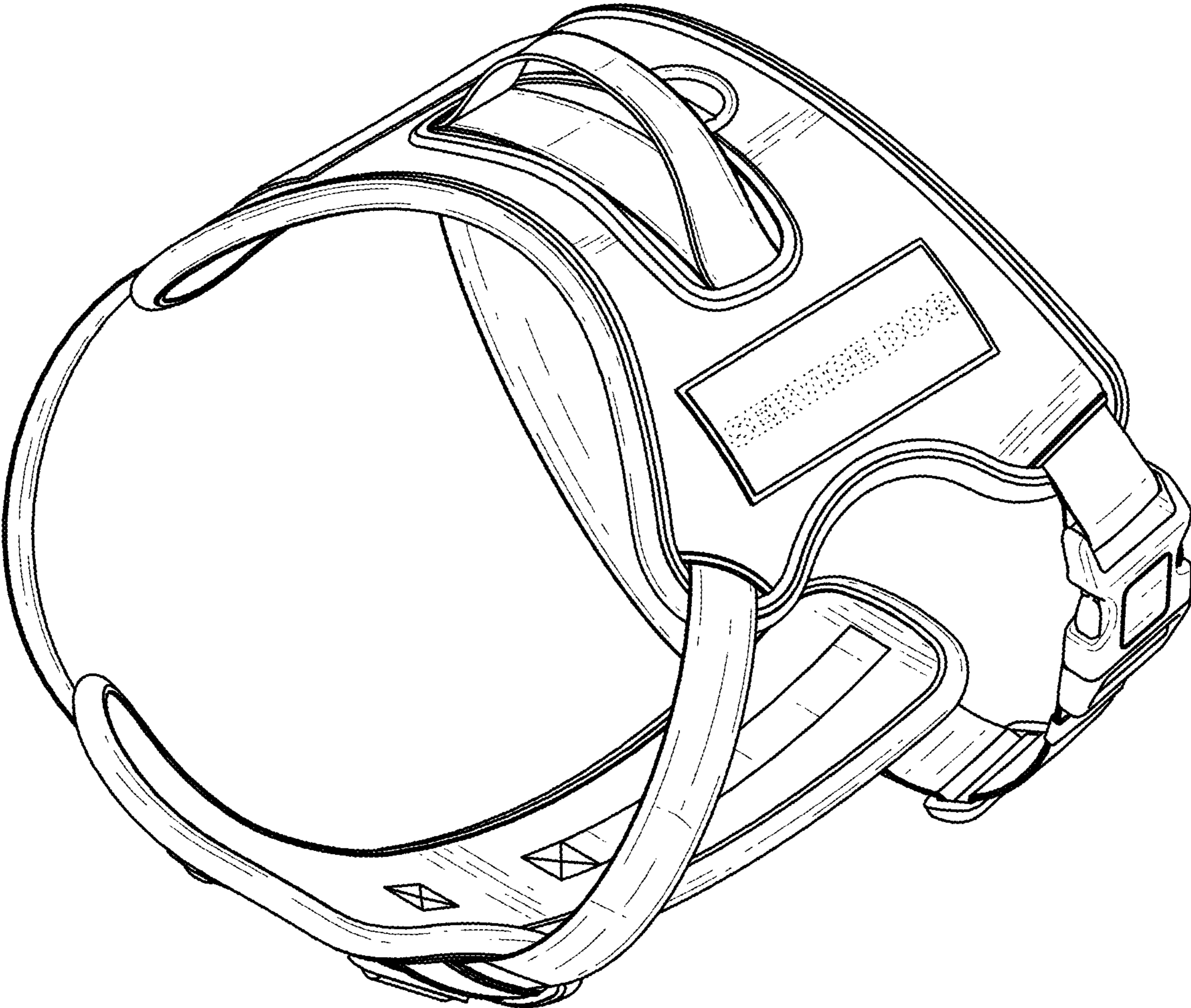

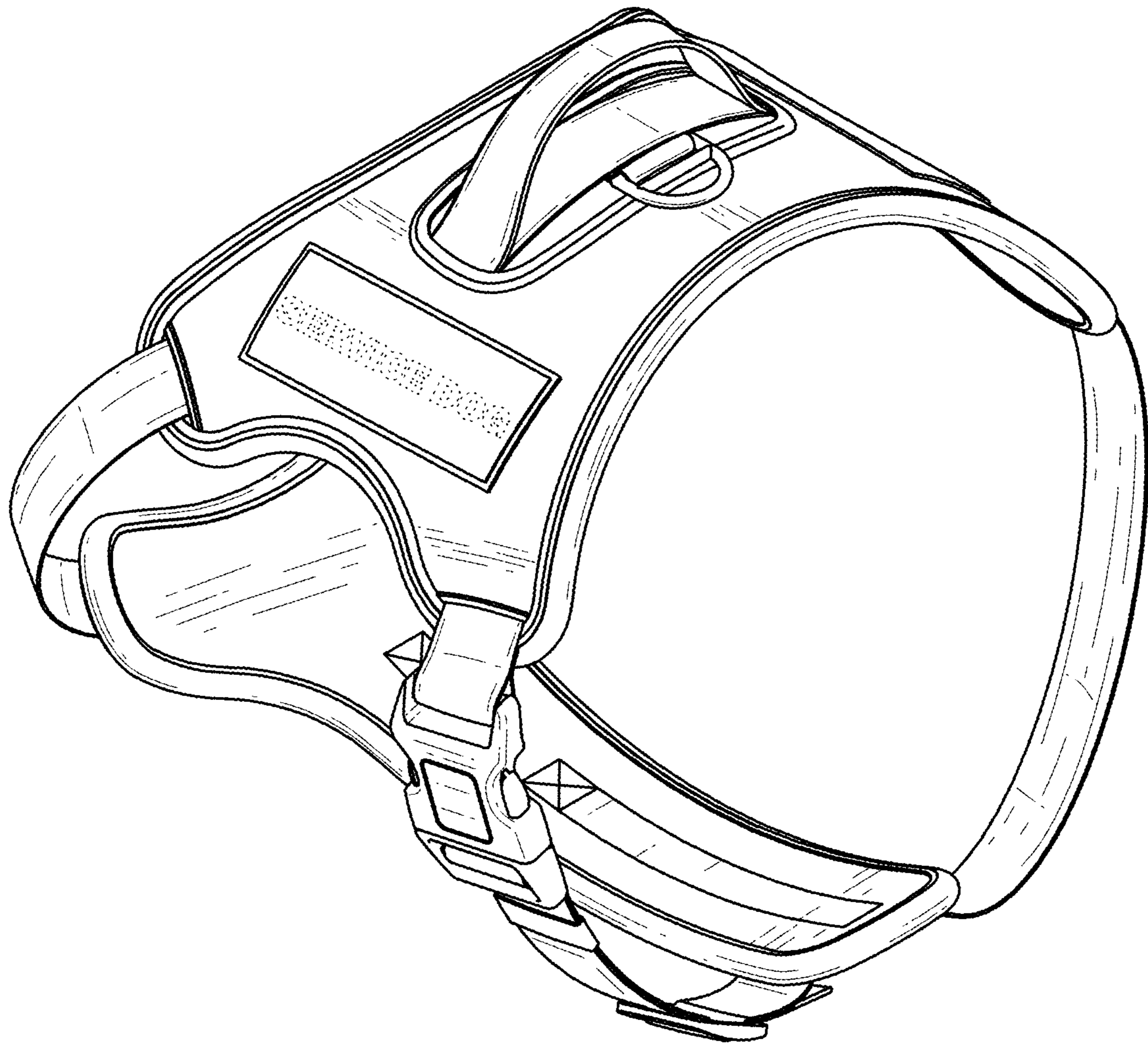

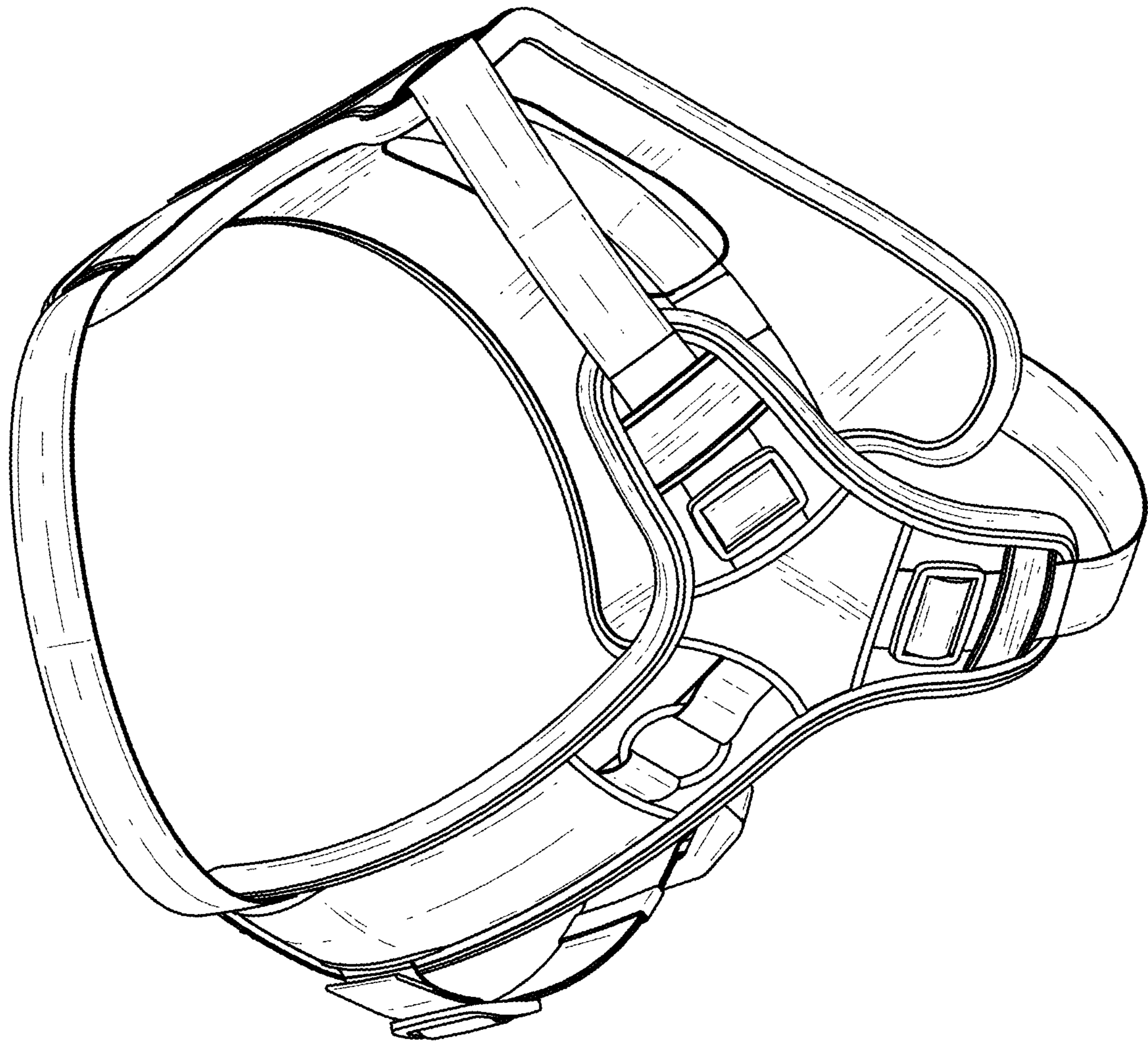

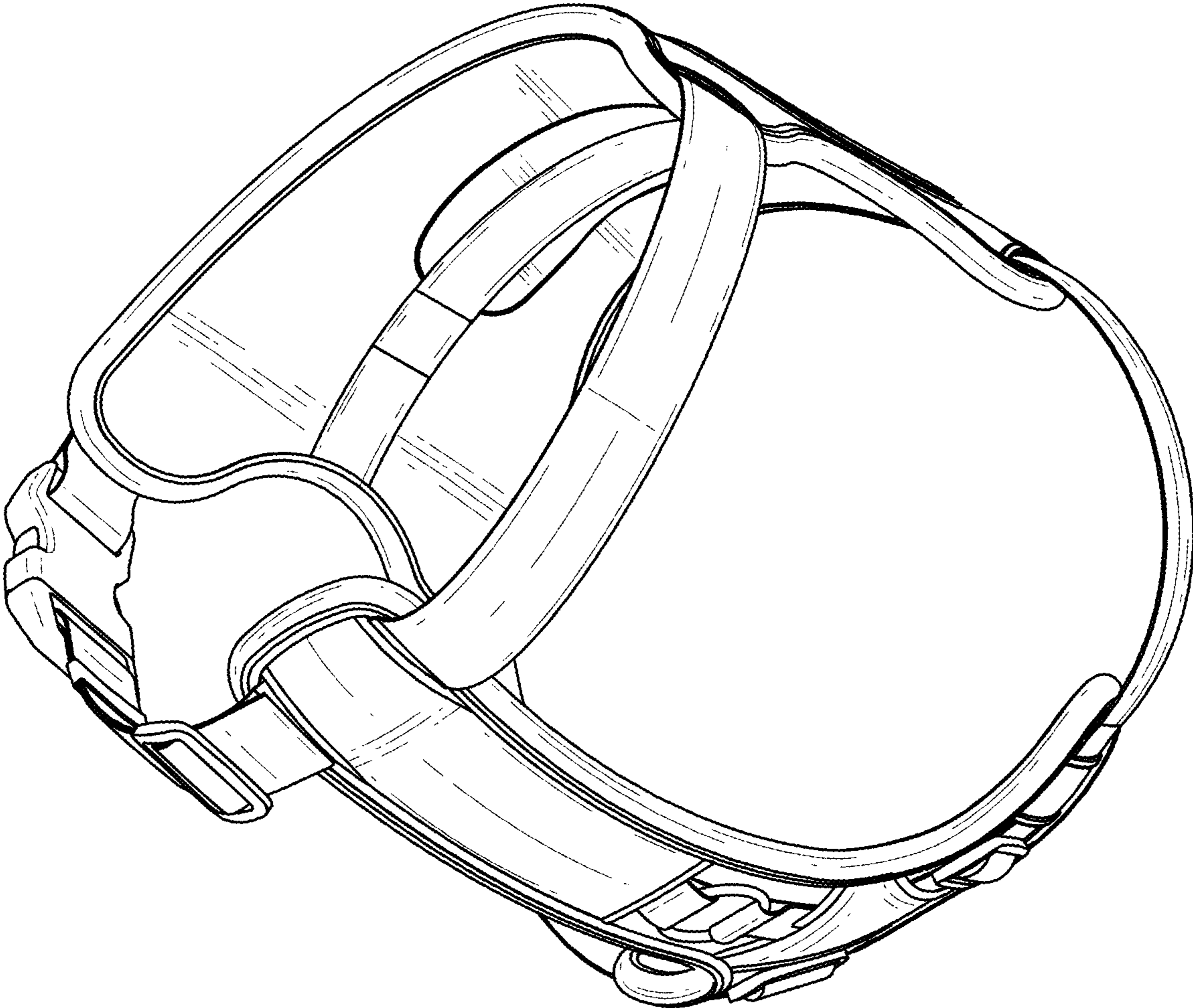

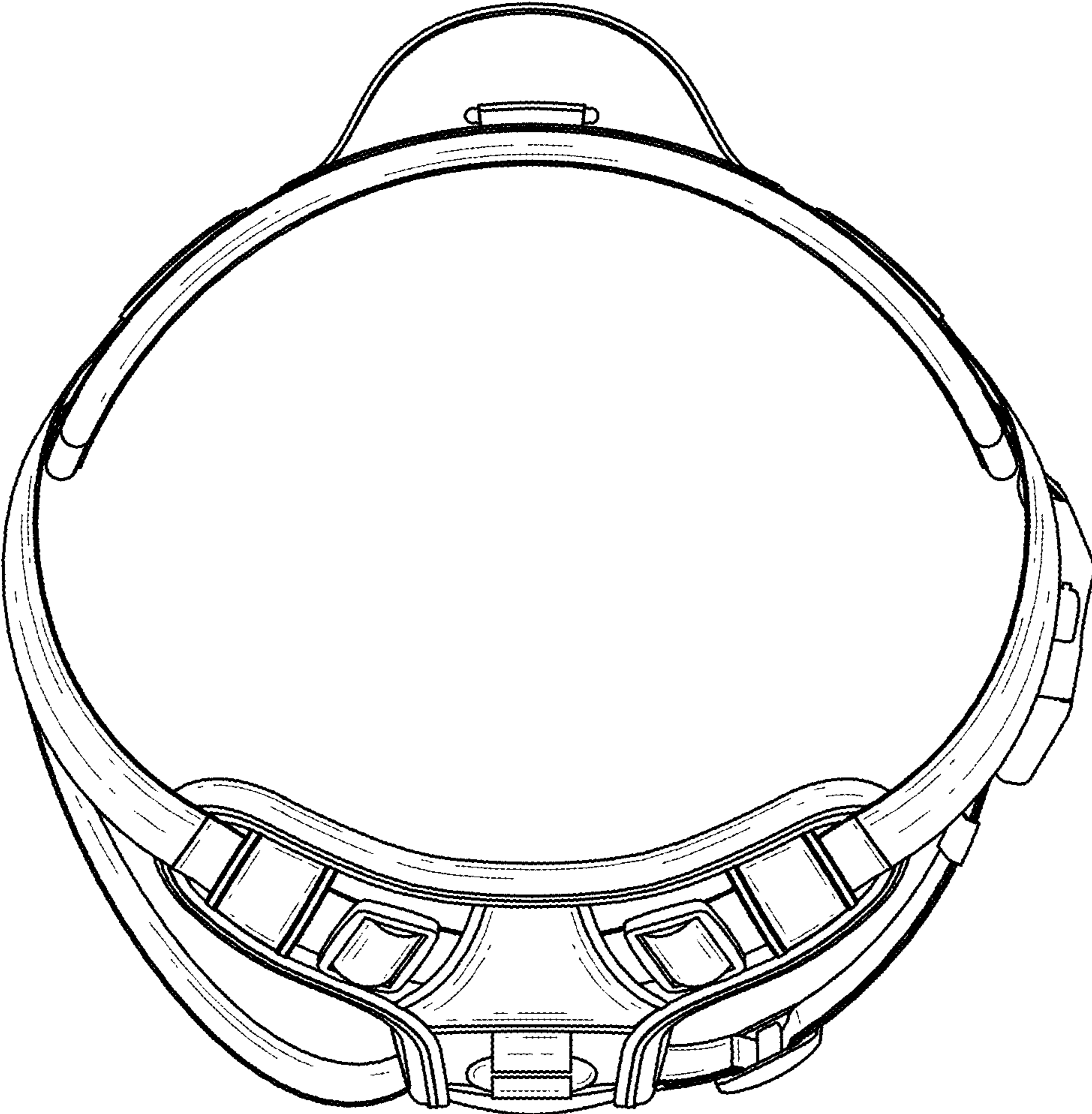

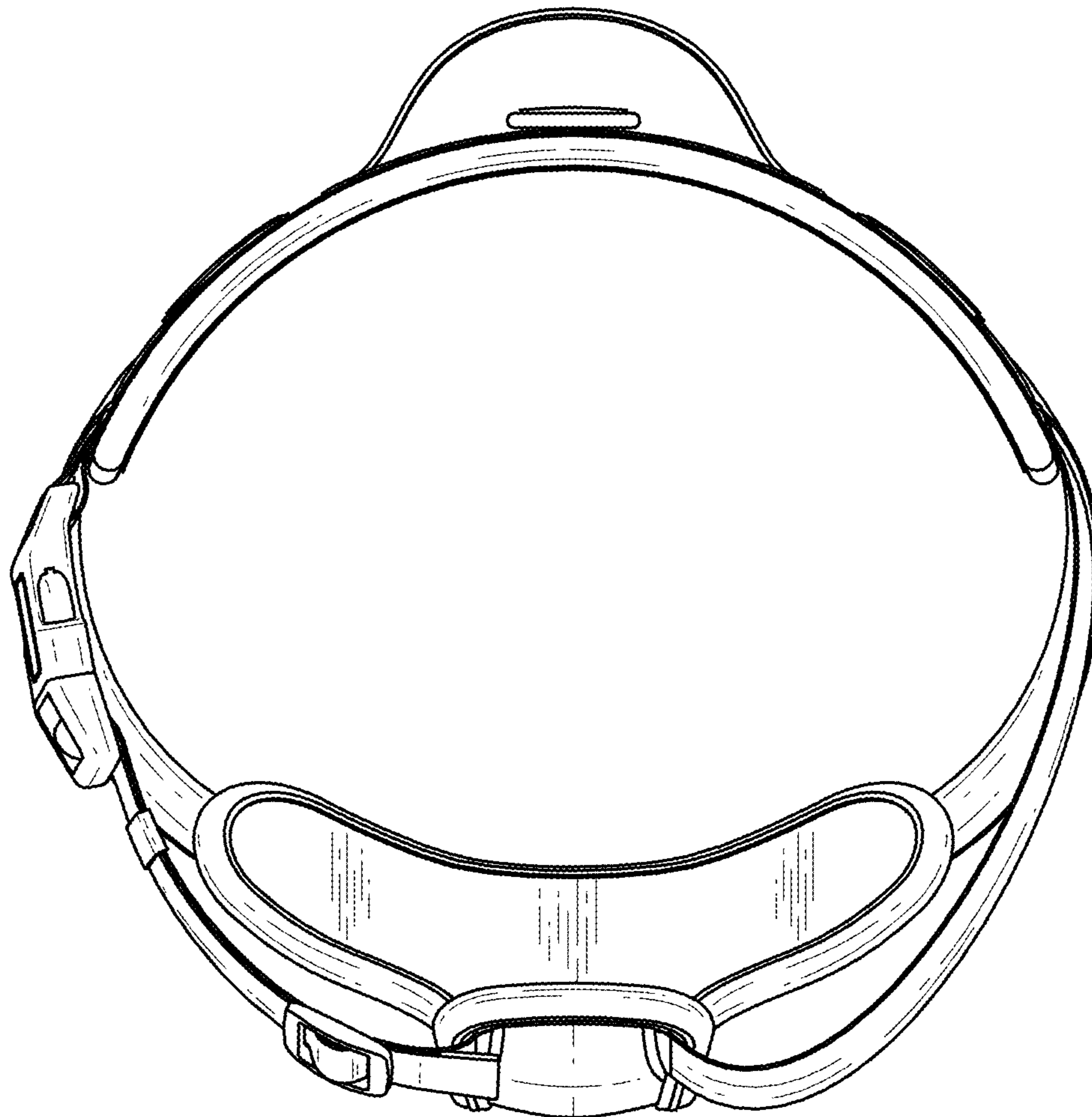

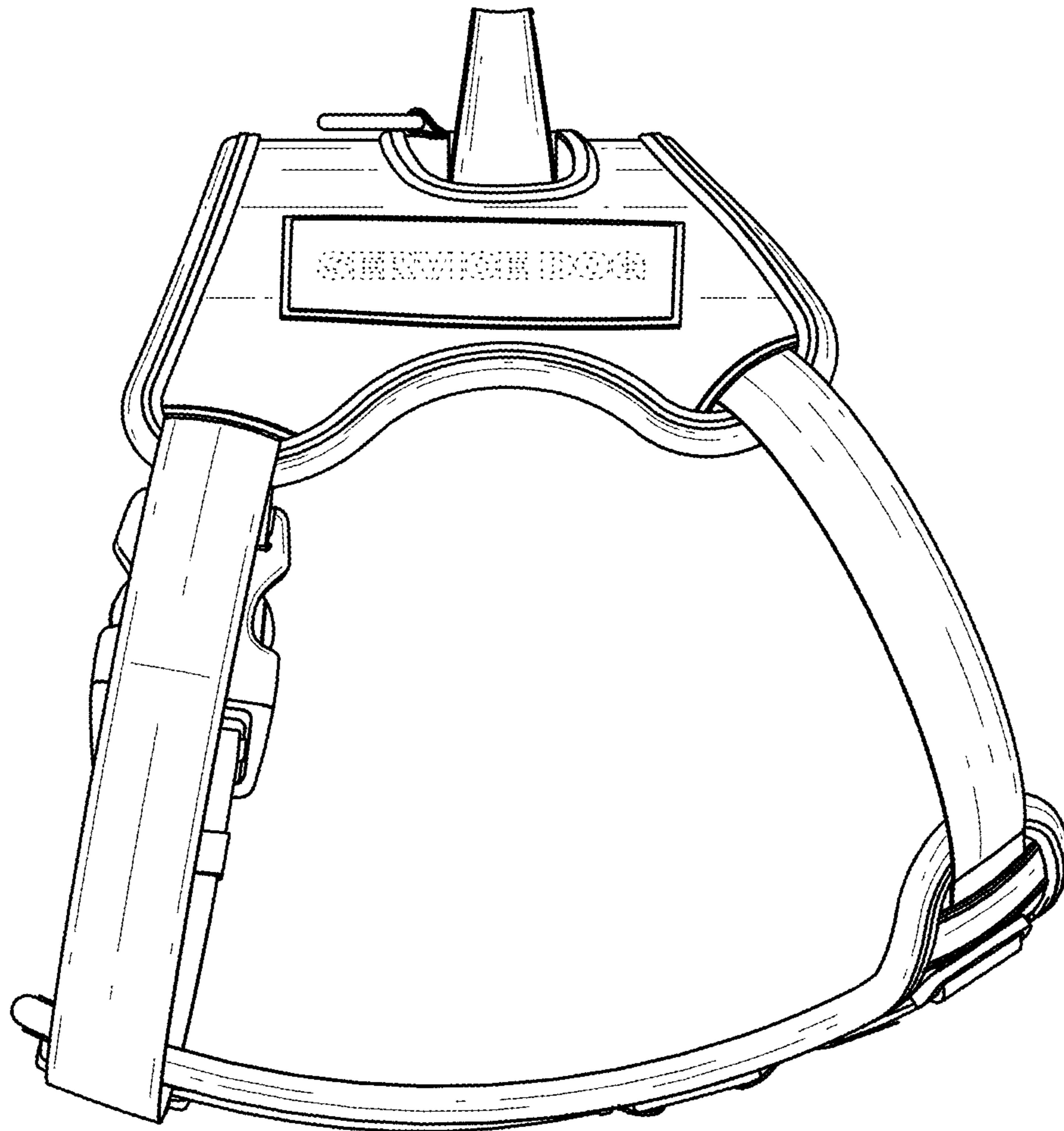

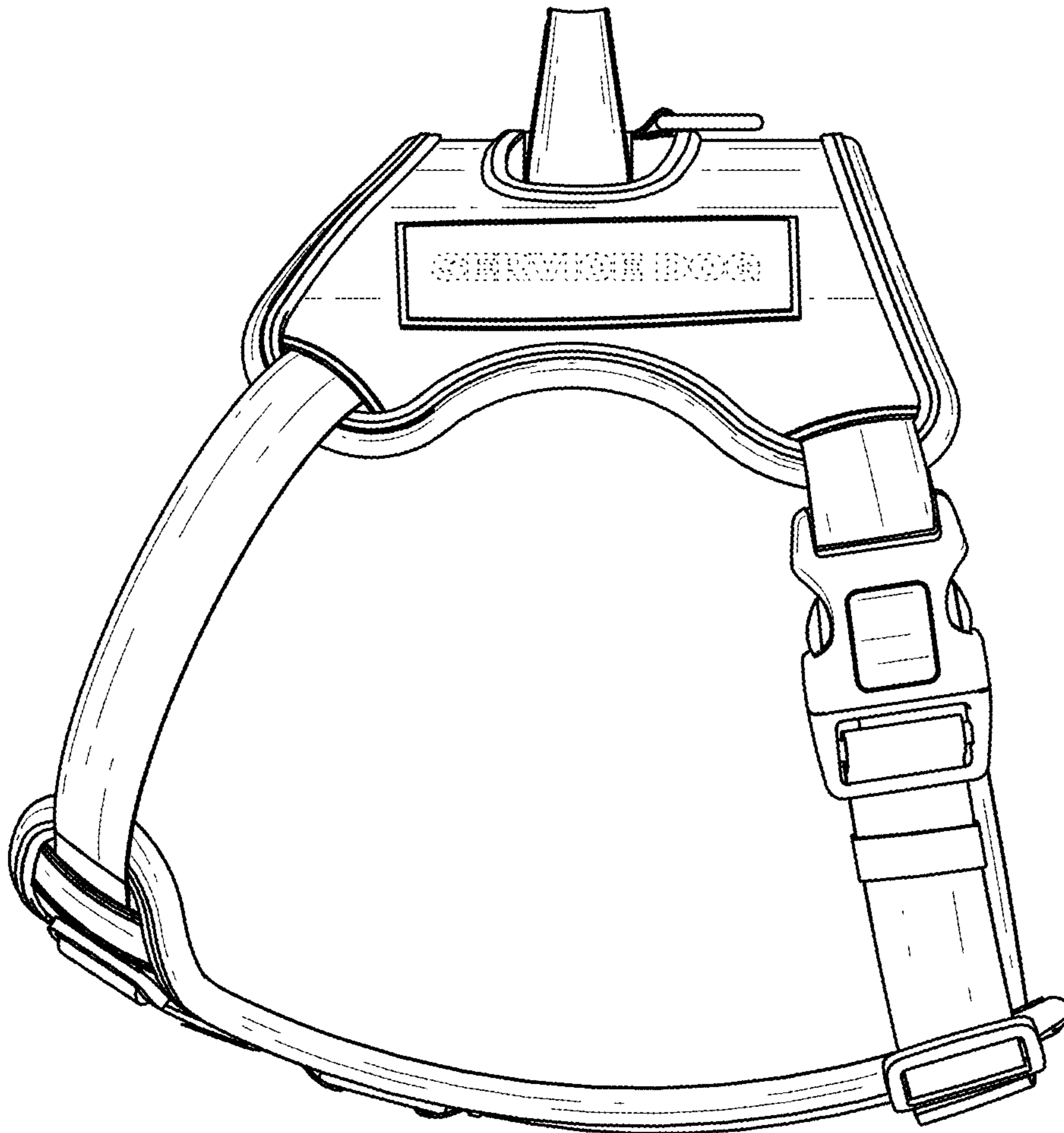

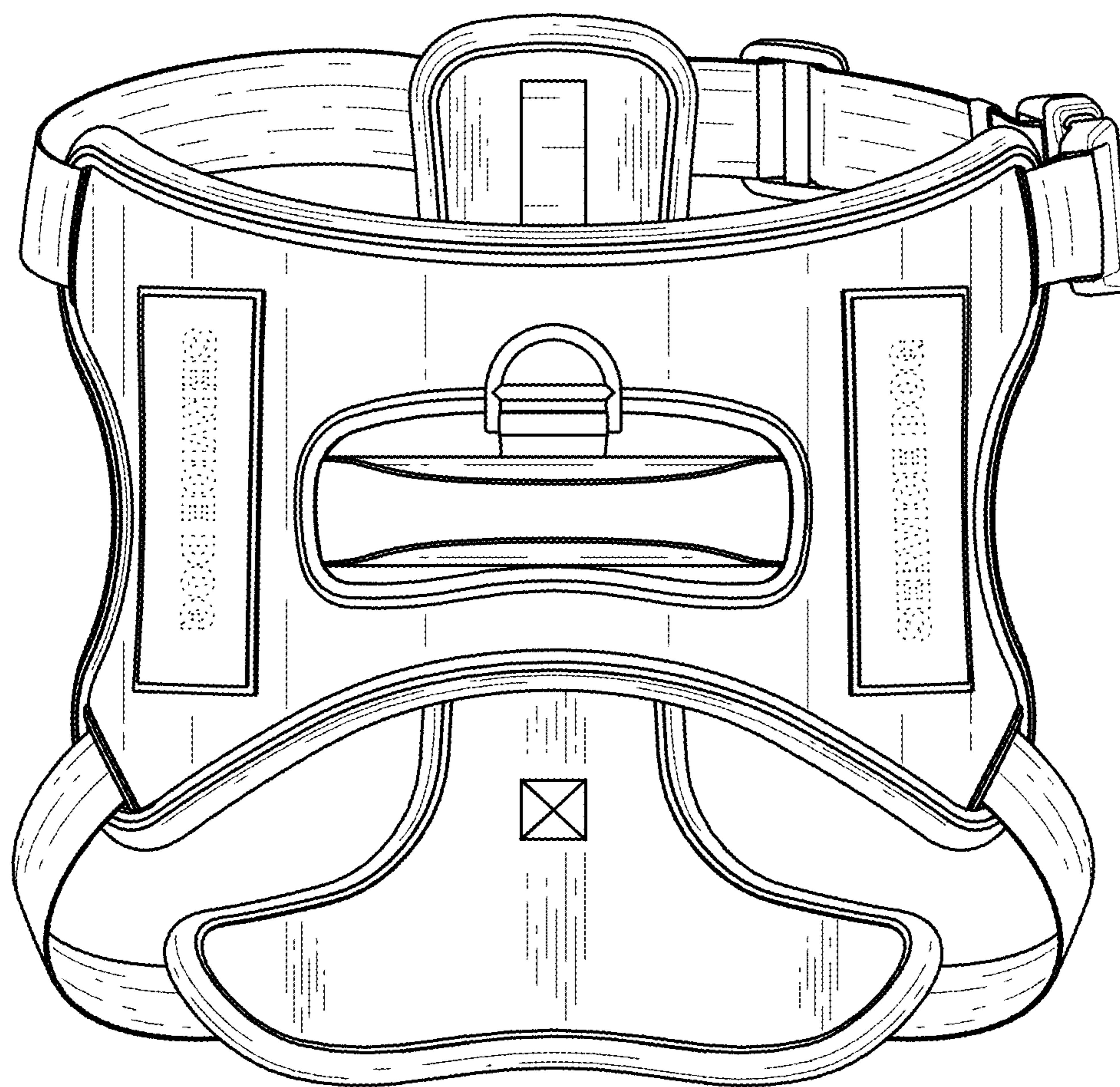

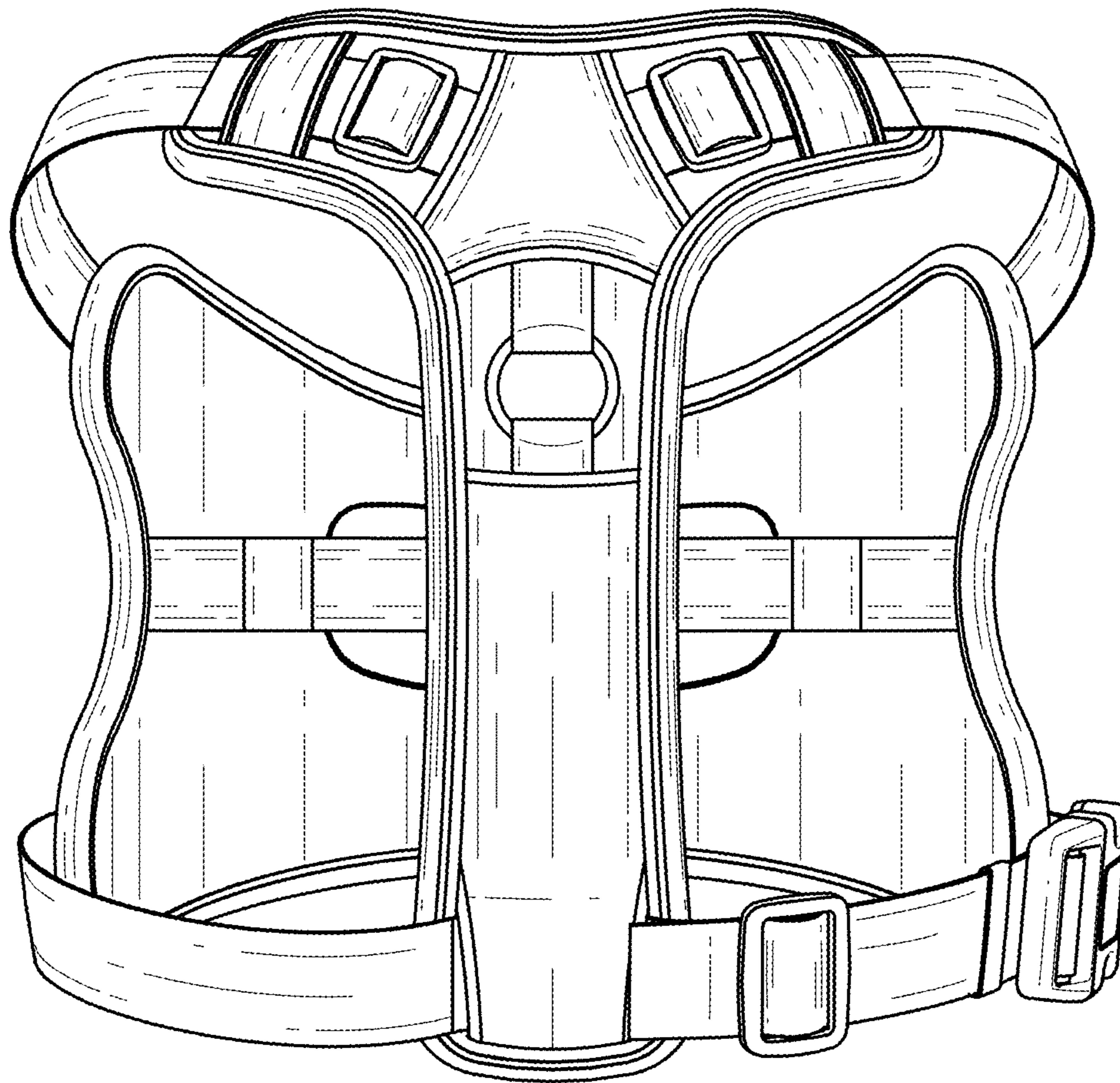

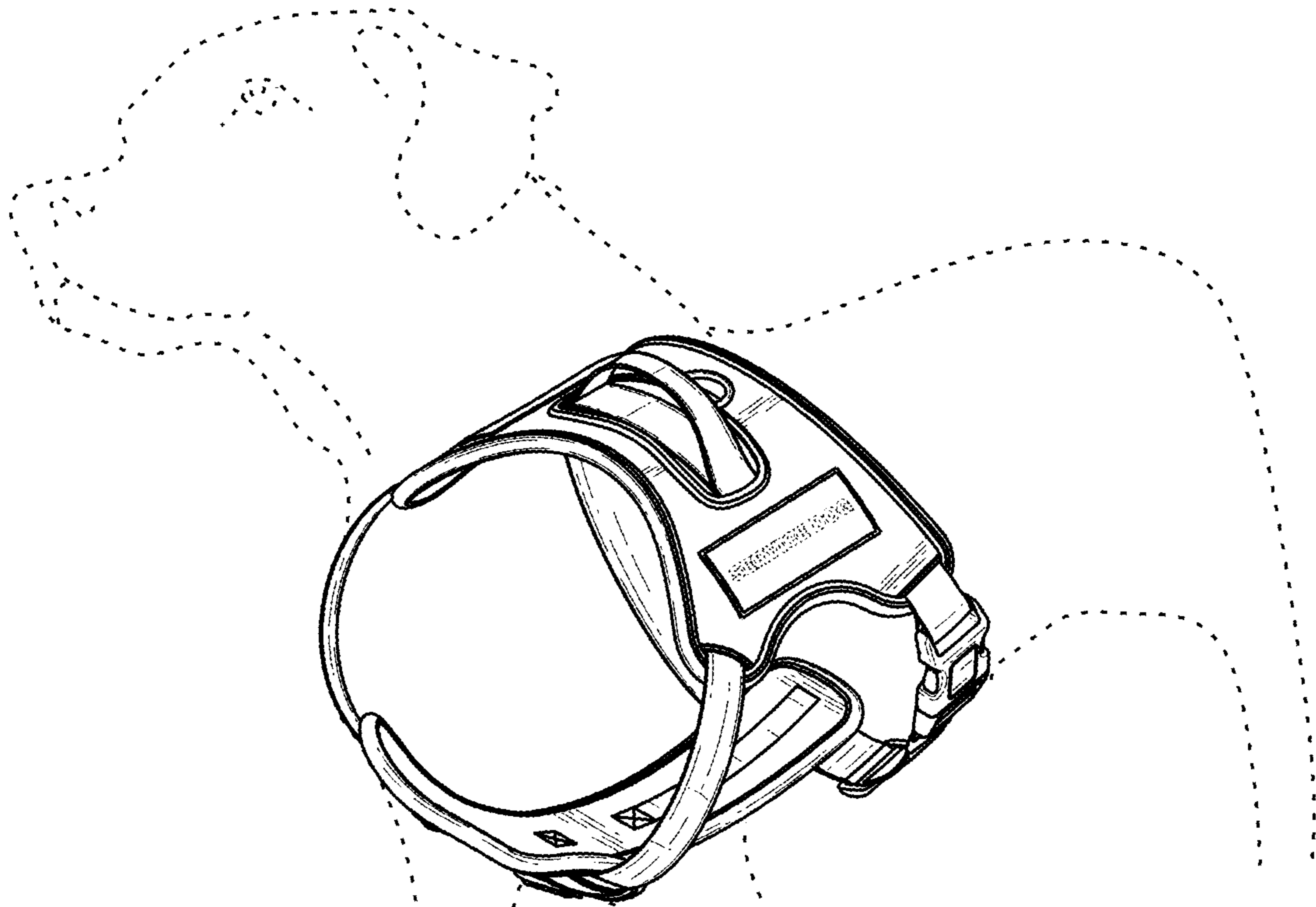

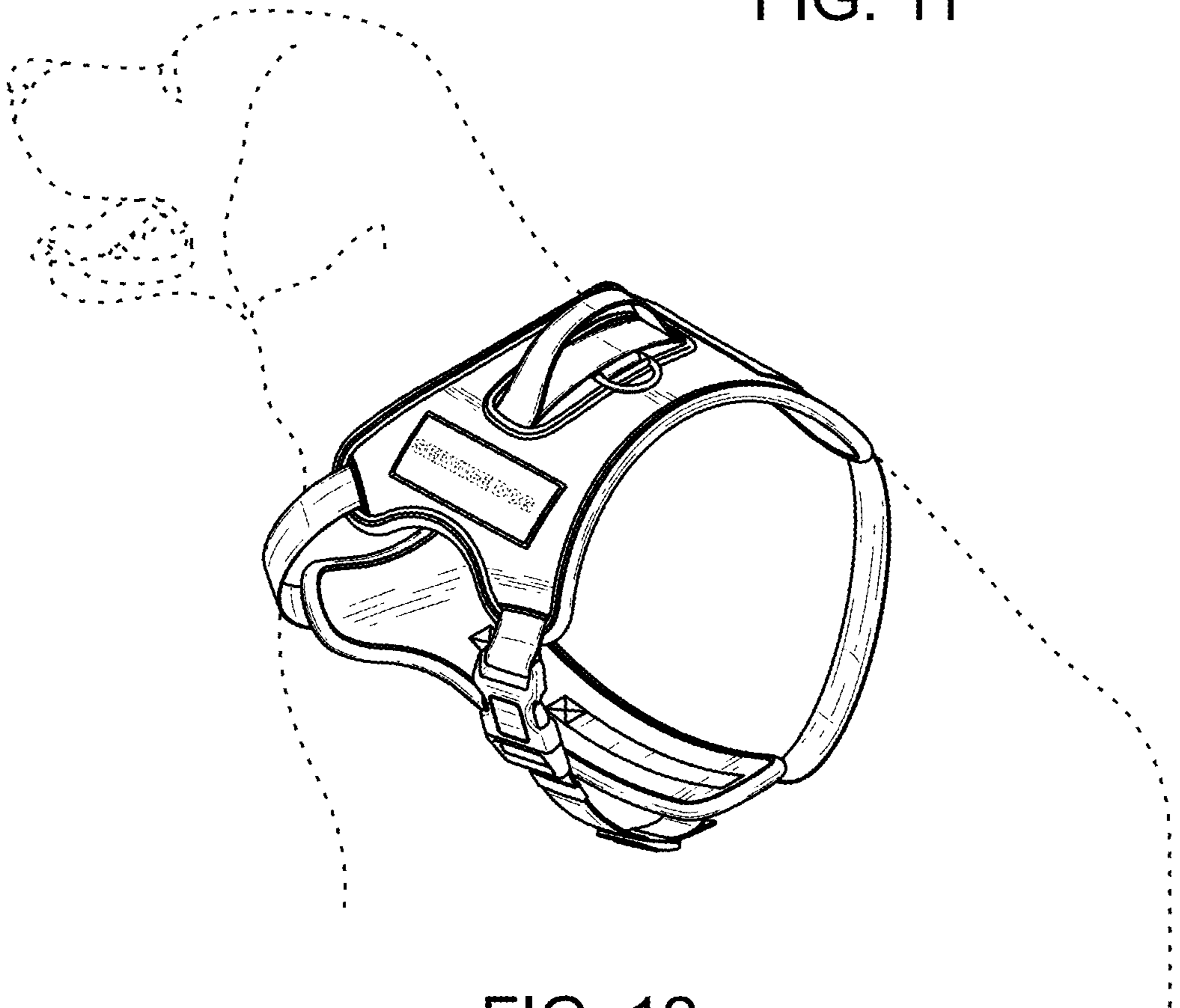

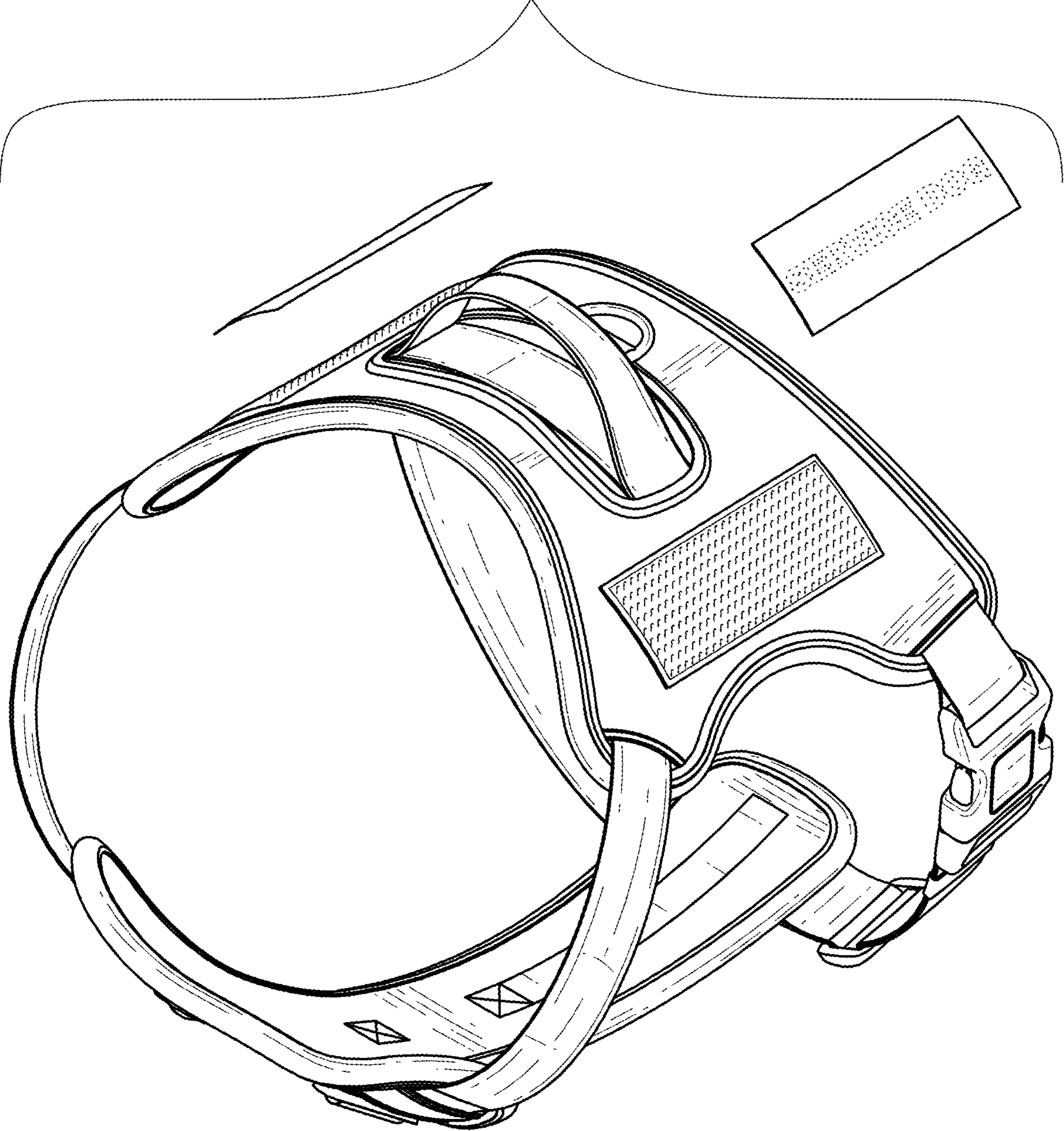
