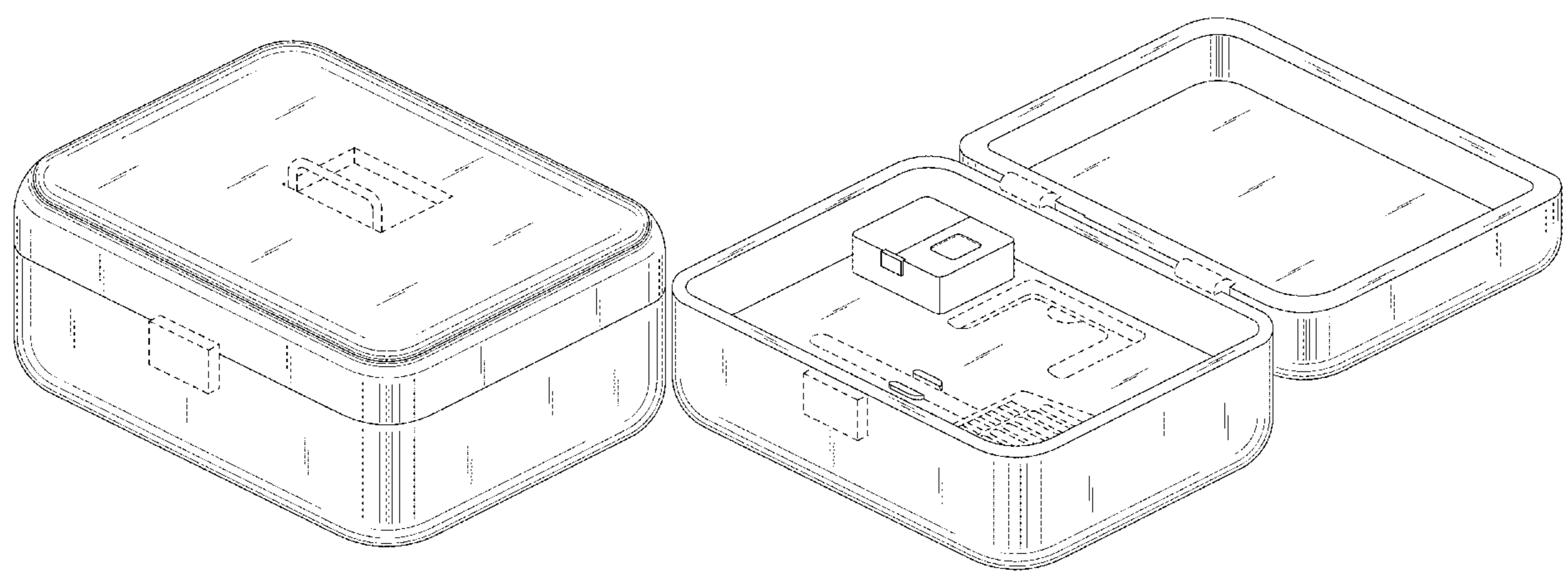

(57) **CLAIM**
The ornamental design for a pet litter box for travel, as shown and described.

DESCRIPTION
FIG. 1 is an isometric view of the pet litter box for travel; FIG. 2 is a front view of the pet litter box for travel of FIG. 1; FIG. 3 is a rear view of the pet litter box for travel of FIG. 1; FIG. 4 is a right side view of the pet litter box for travel of FIG. 1; FIG. 5 is a left side view of the pet litter box for travel of FIG. 1; FIG. 6 is a top view of the pet litter box for travel of FIG. 1; FIG. 7 is a bottom view of the pet litter box for travel of FIG. 1; FIG. 8 is a top view of the pet litter box for travel of FIG. 1 in an open configuration; and, FIG. 9 is a perspective view of the pet litter box for travel of FIG. 1 in an open configuration. 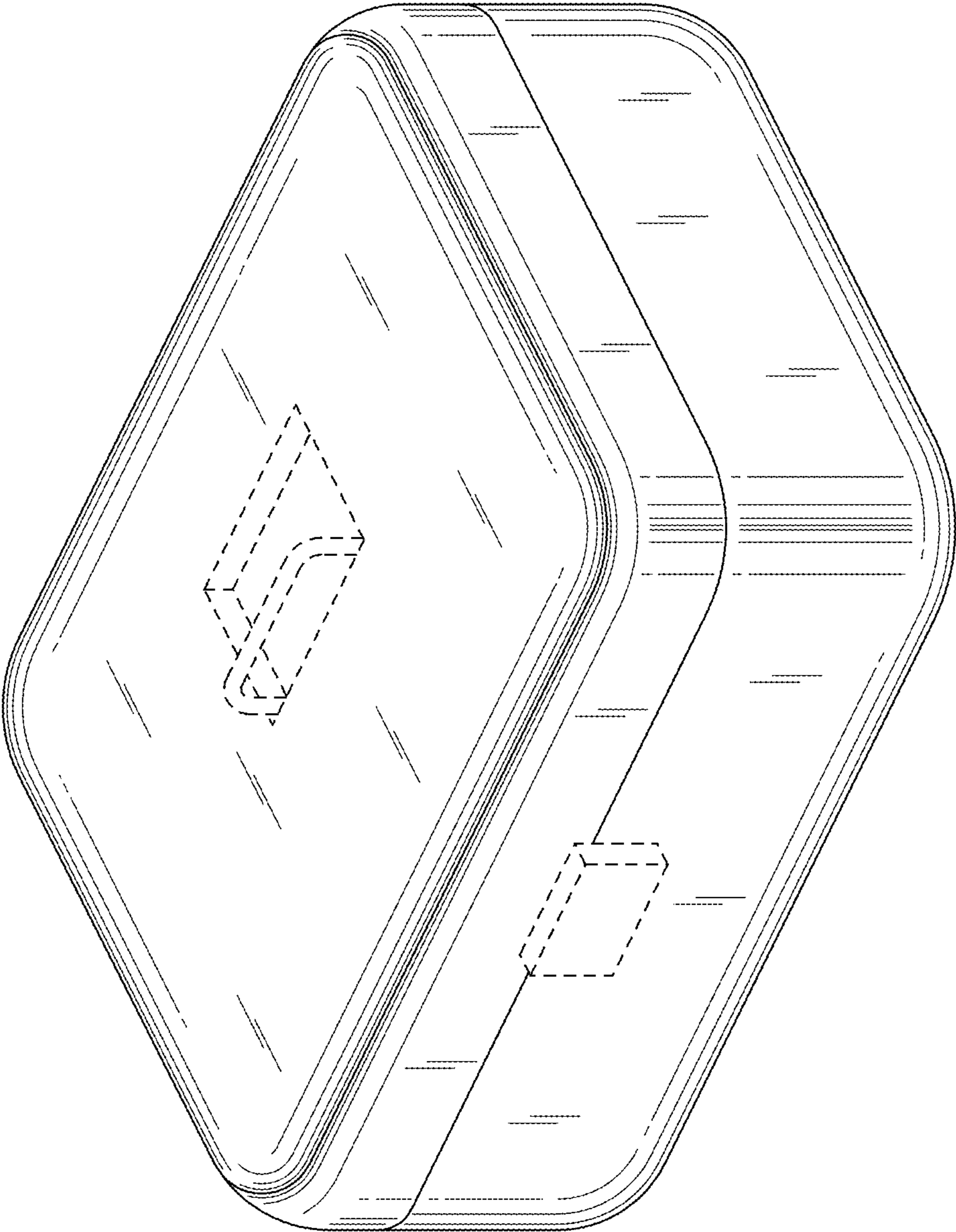

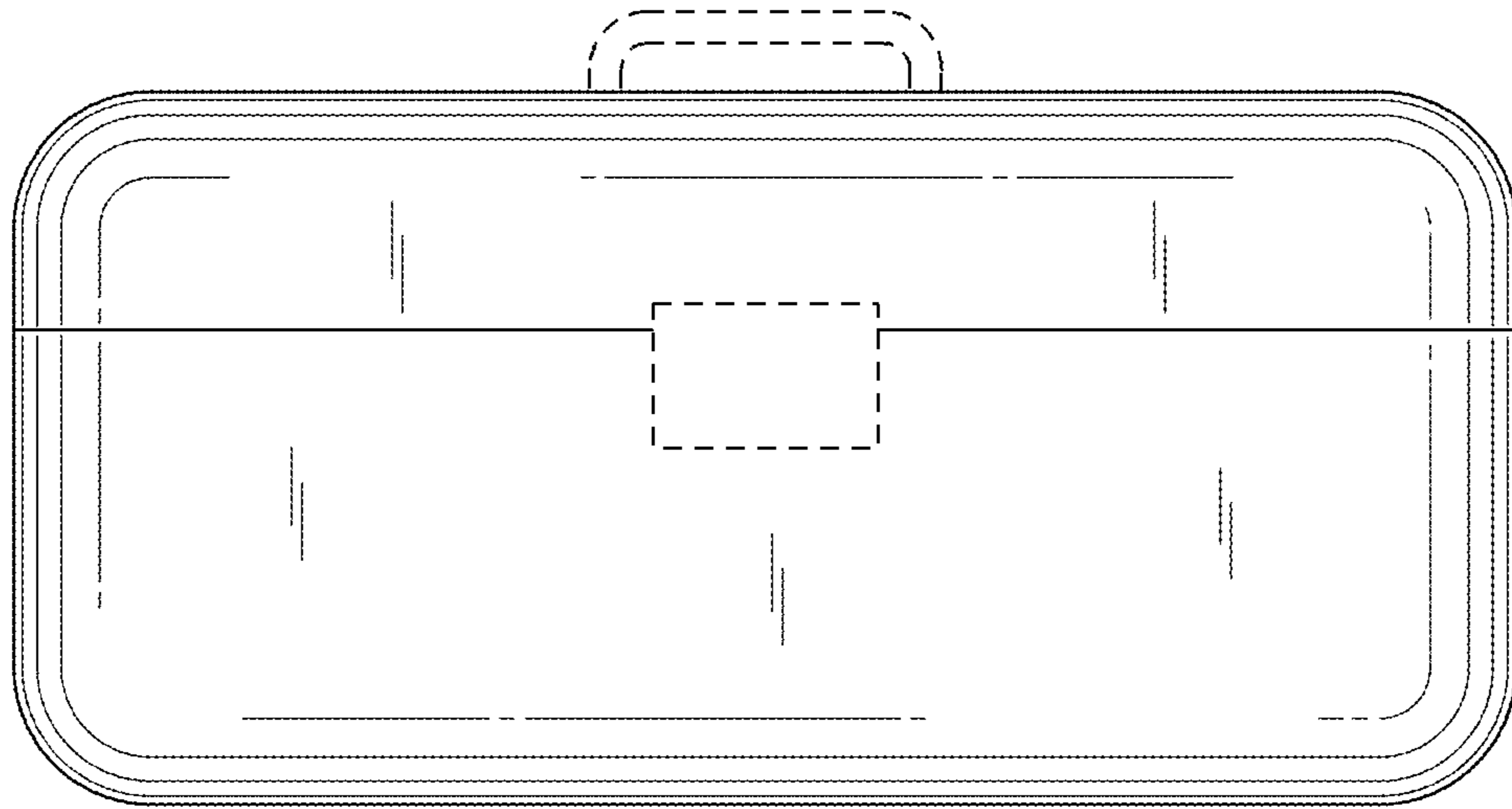

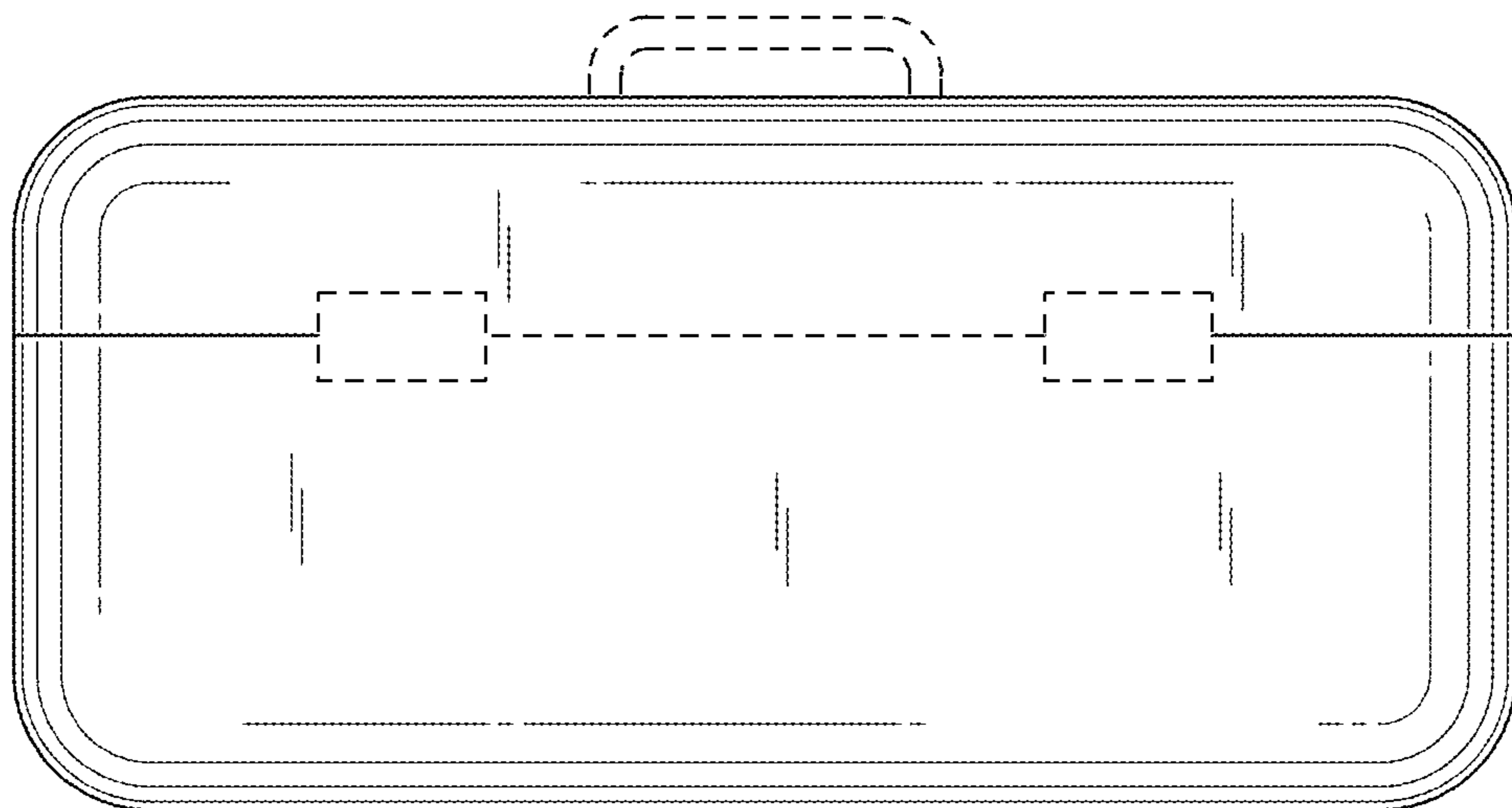

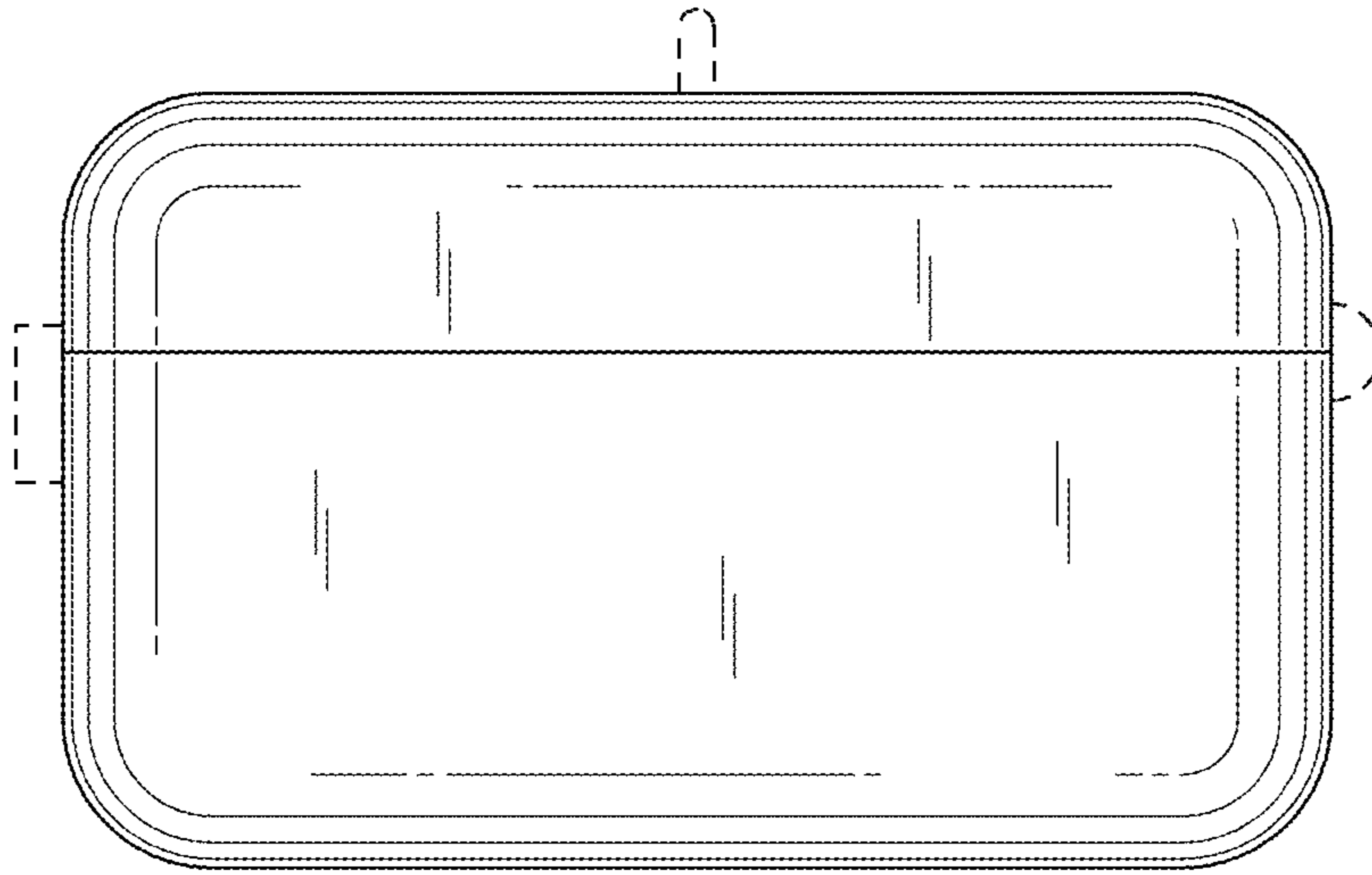

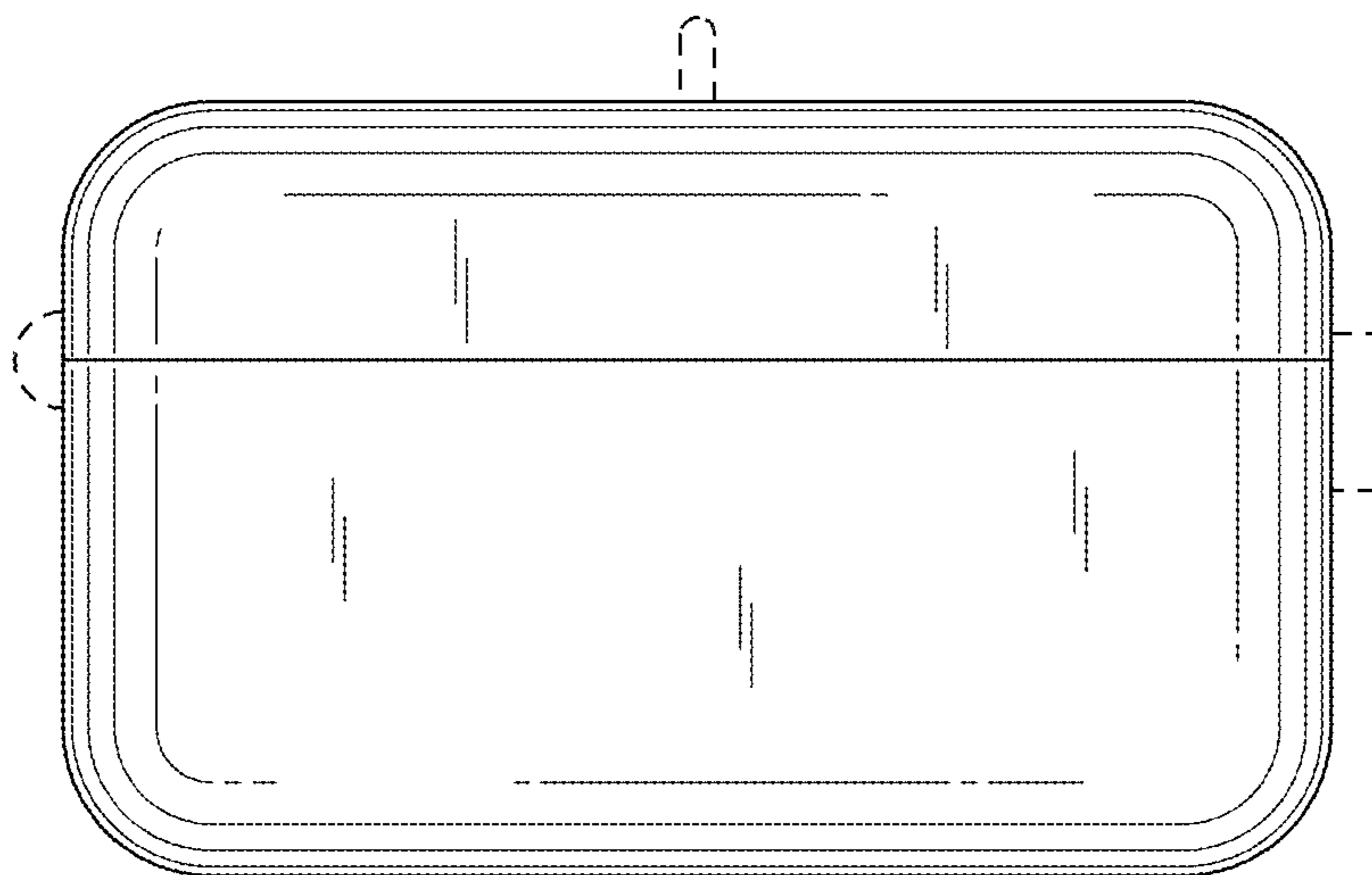

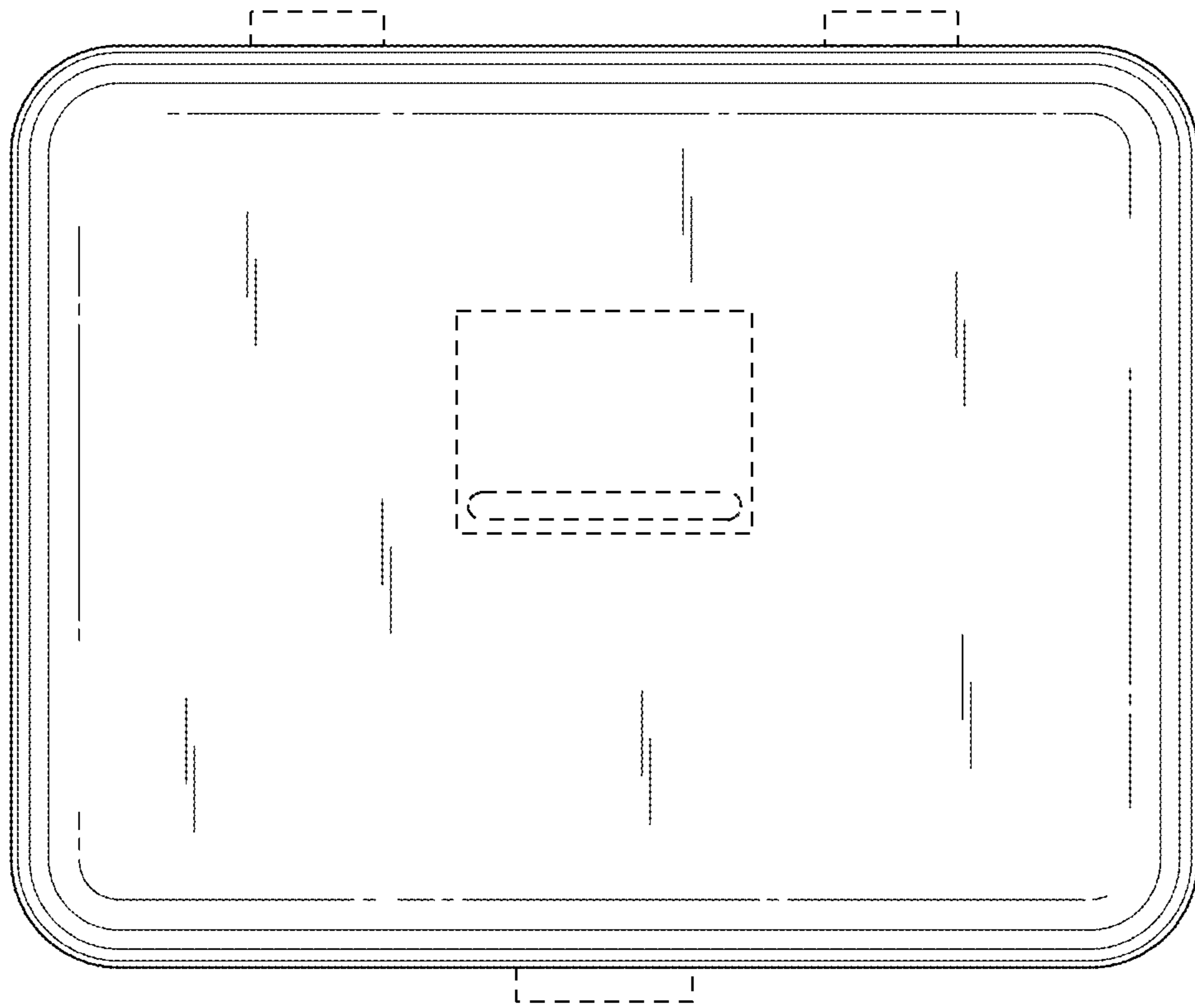

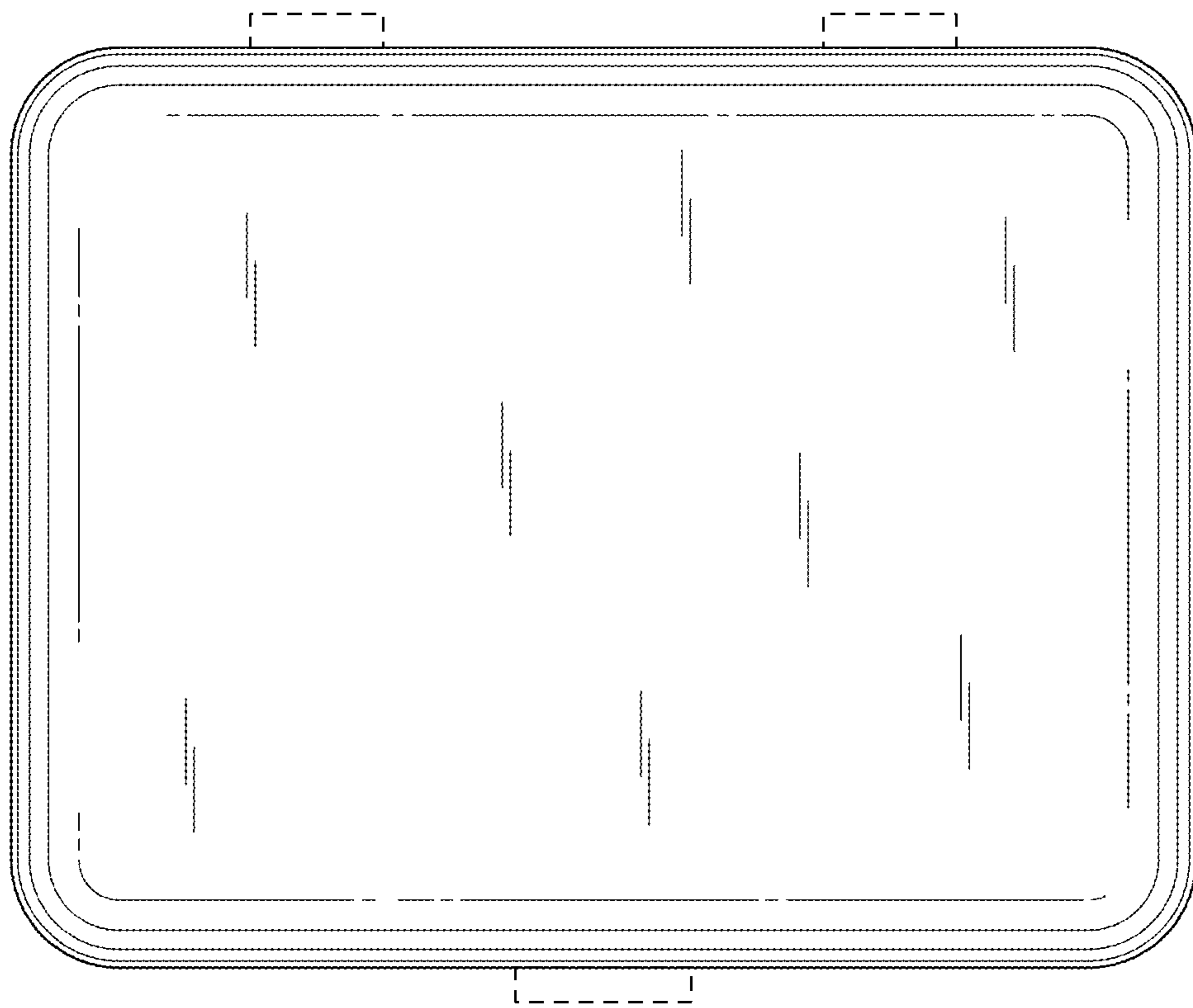

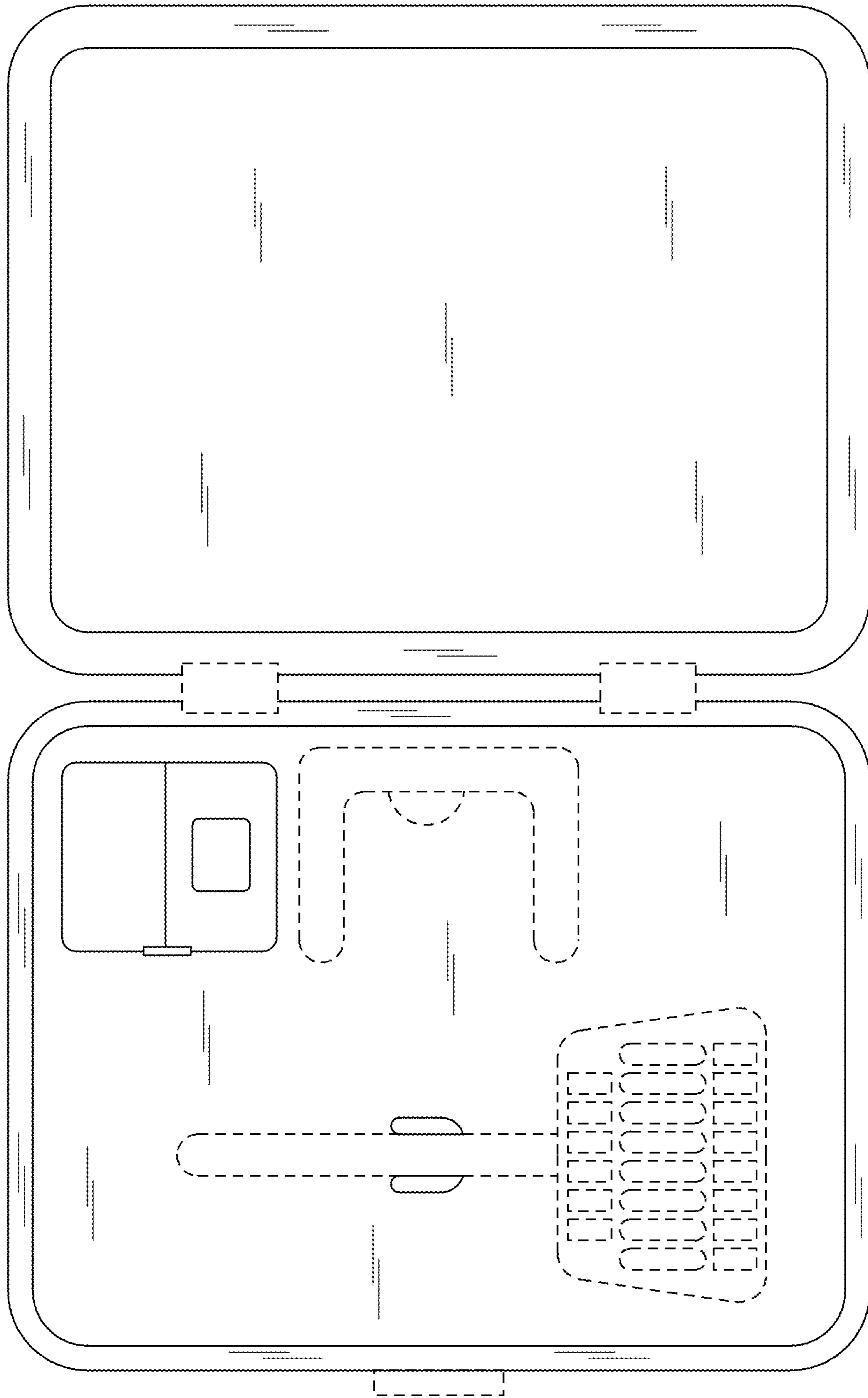

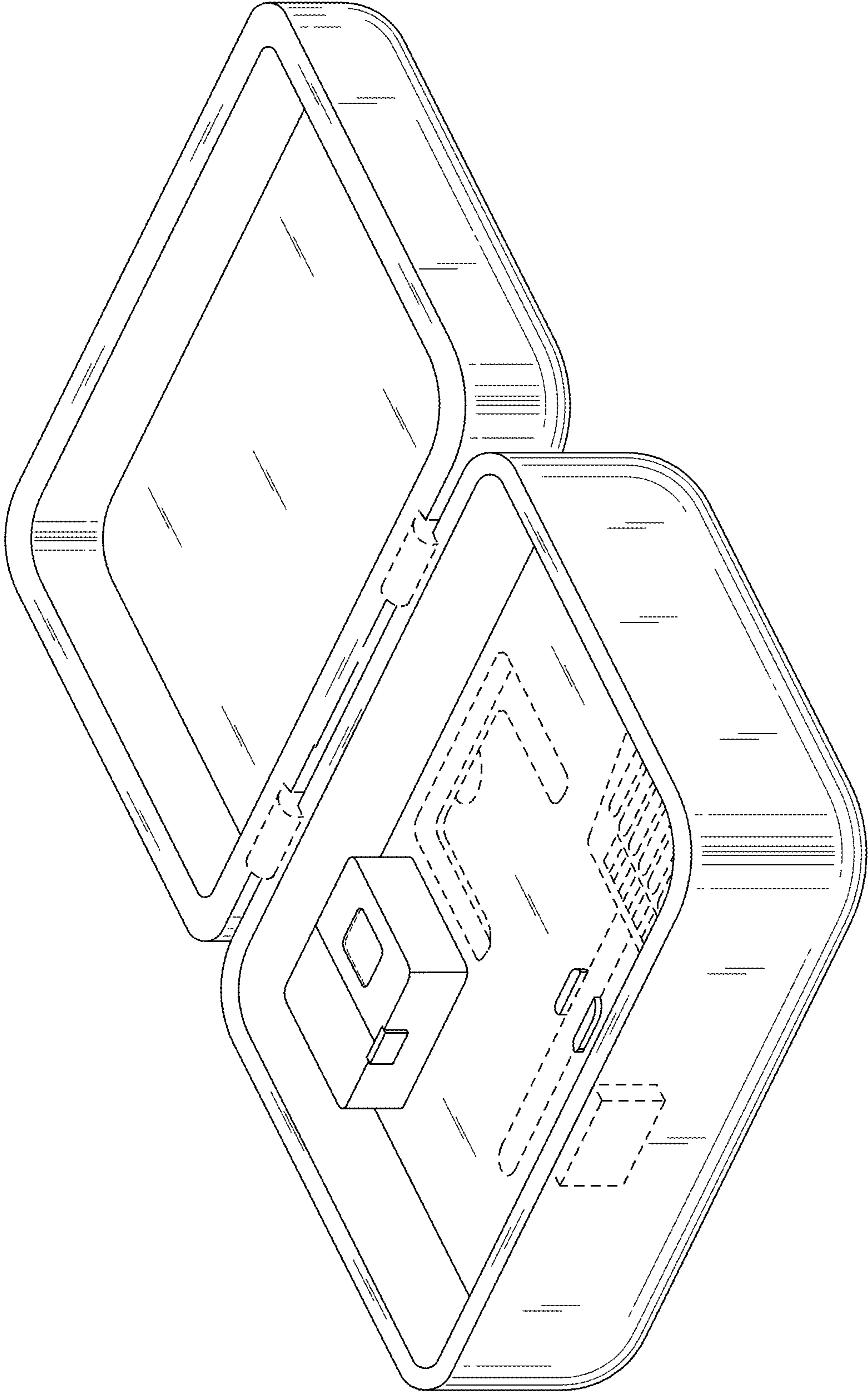
