described.

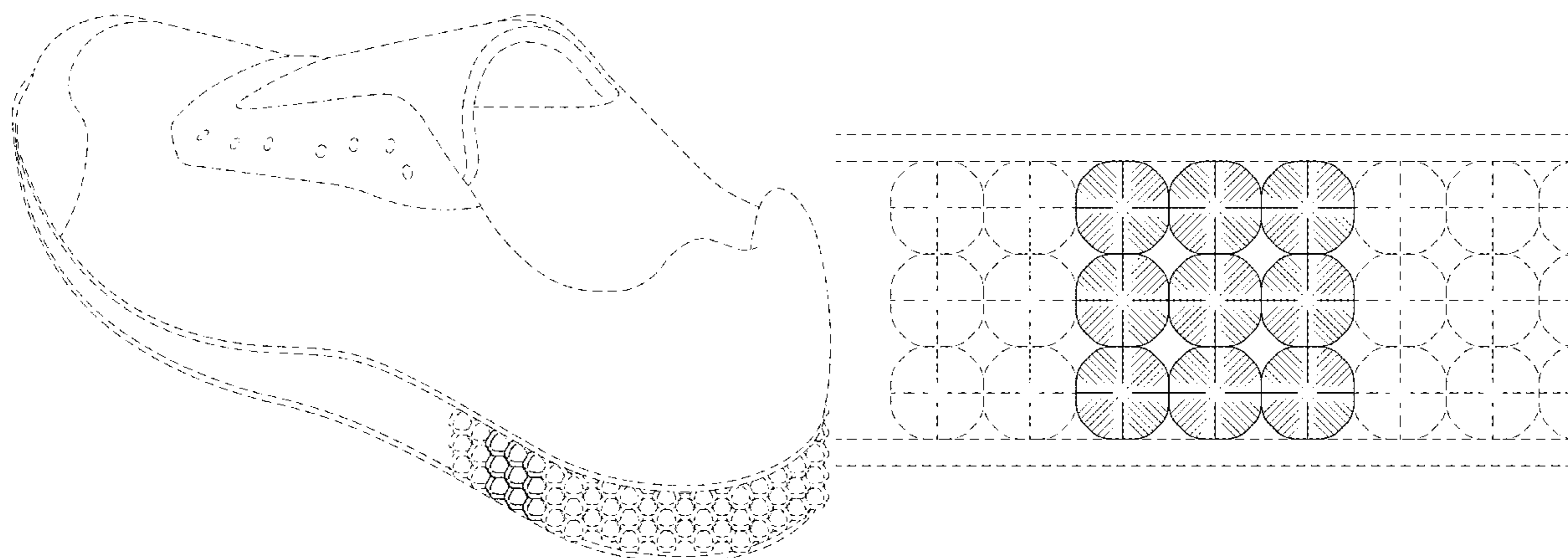
DESCRIPTION

FIG. 1 is a perspective view of a shoe midsole showing a
first embodiment of our new design;

FIG. 6 is an enlarged front view of FIG. 2 thereof;

FIG. 8 is a perspective view of a shoe midsole showing a
second embodiment of our new design;
FIG. 9 is a front view thereof;
FIG. 10 is a top view thereof;
FIG. 11 is a bottom view thereof;
FIG. 12 is an enlarged perspective view of FIG. 8 thereof;
FIG. 13 is an enlarged front view of FIG. 9 thereof; and,
FIG. 14 is an enlarged top view of FIG. 10 thereof.

form no part of the claimed design. Additionally, broken
lines also depict environmental structures in the form of a
shoe upper and outsole that form no part of the claimed
design.

The dash-dot lines show a boundary between the claimed
design and portions forming no part of the claimed design.

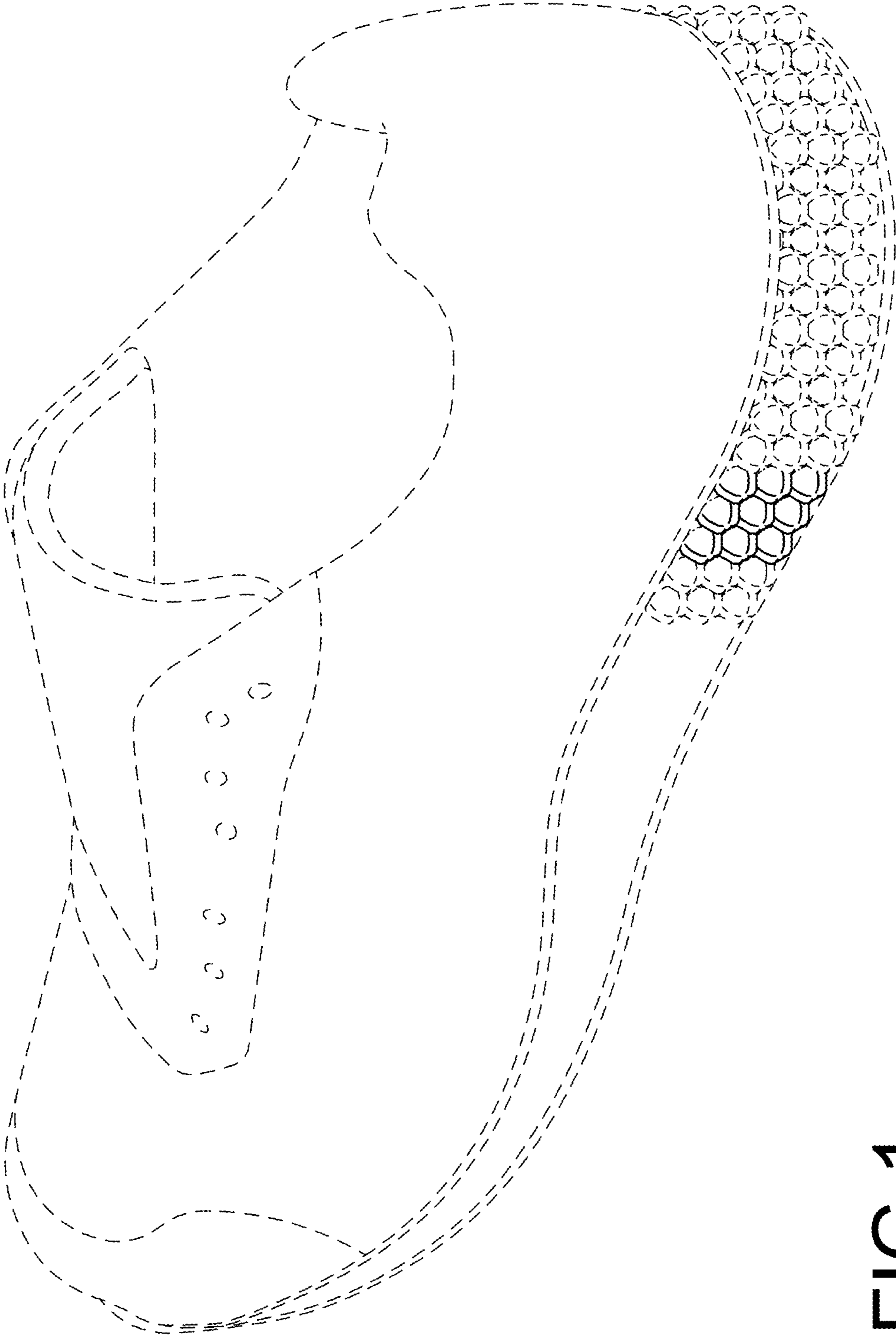

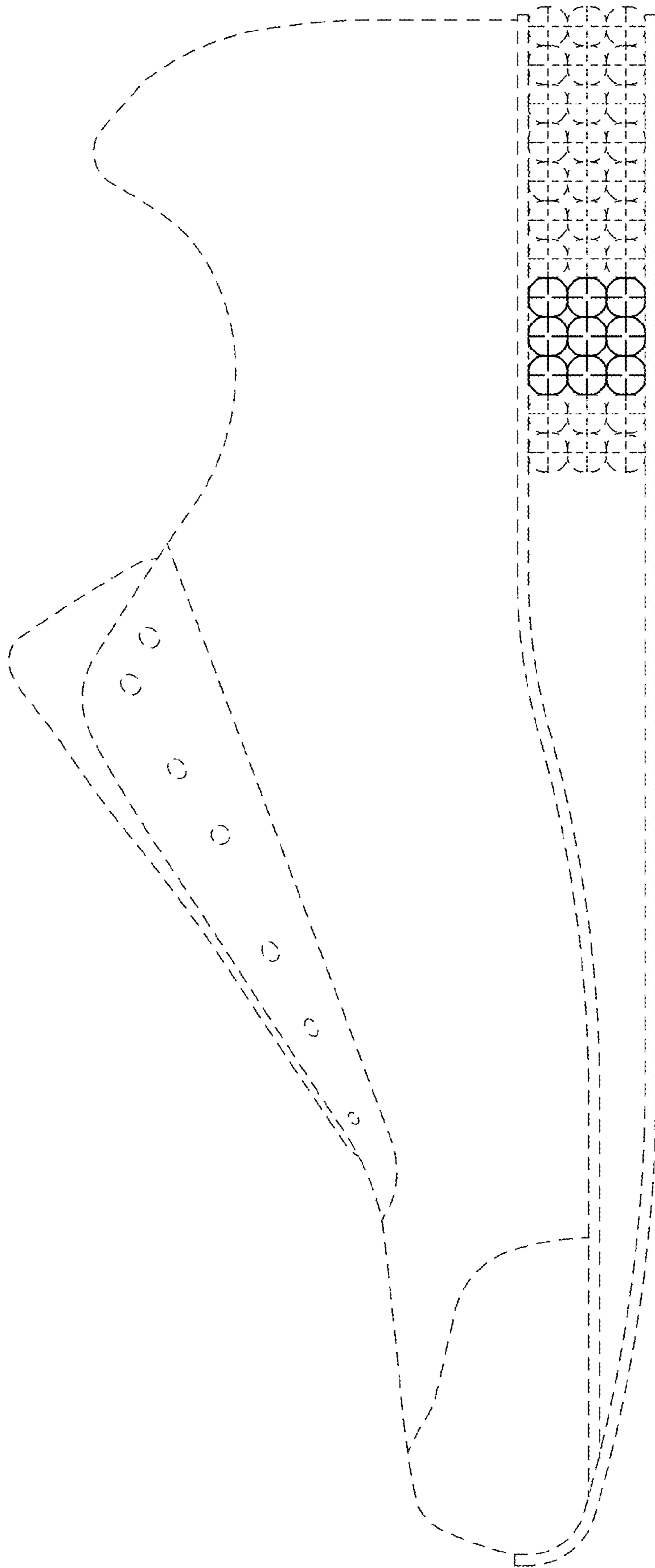

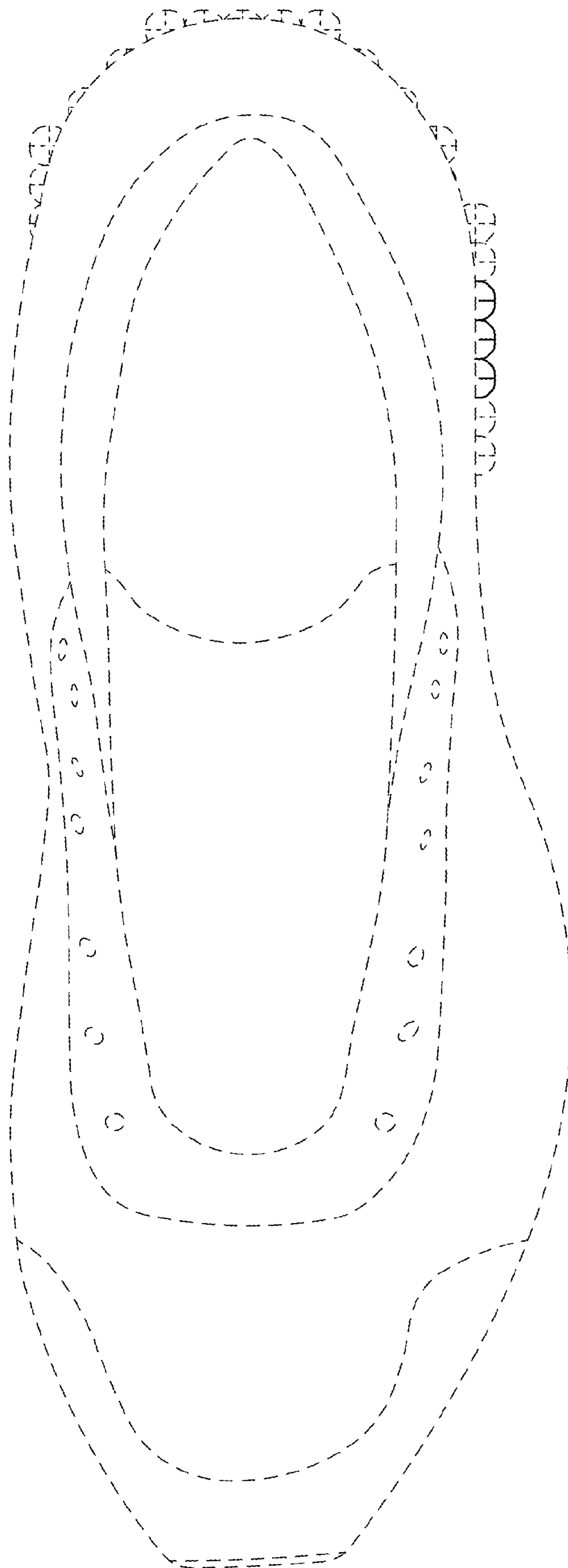

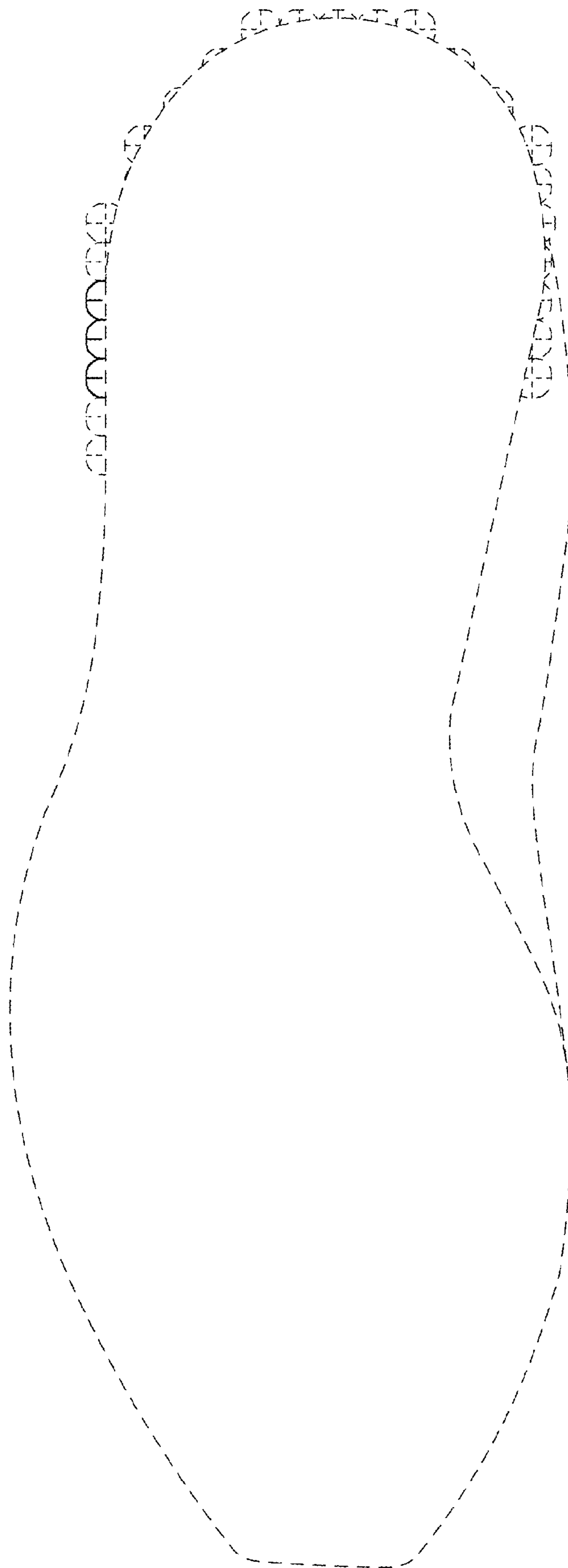

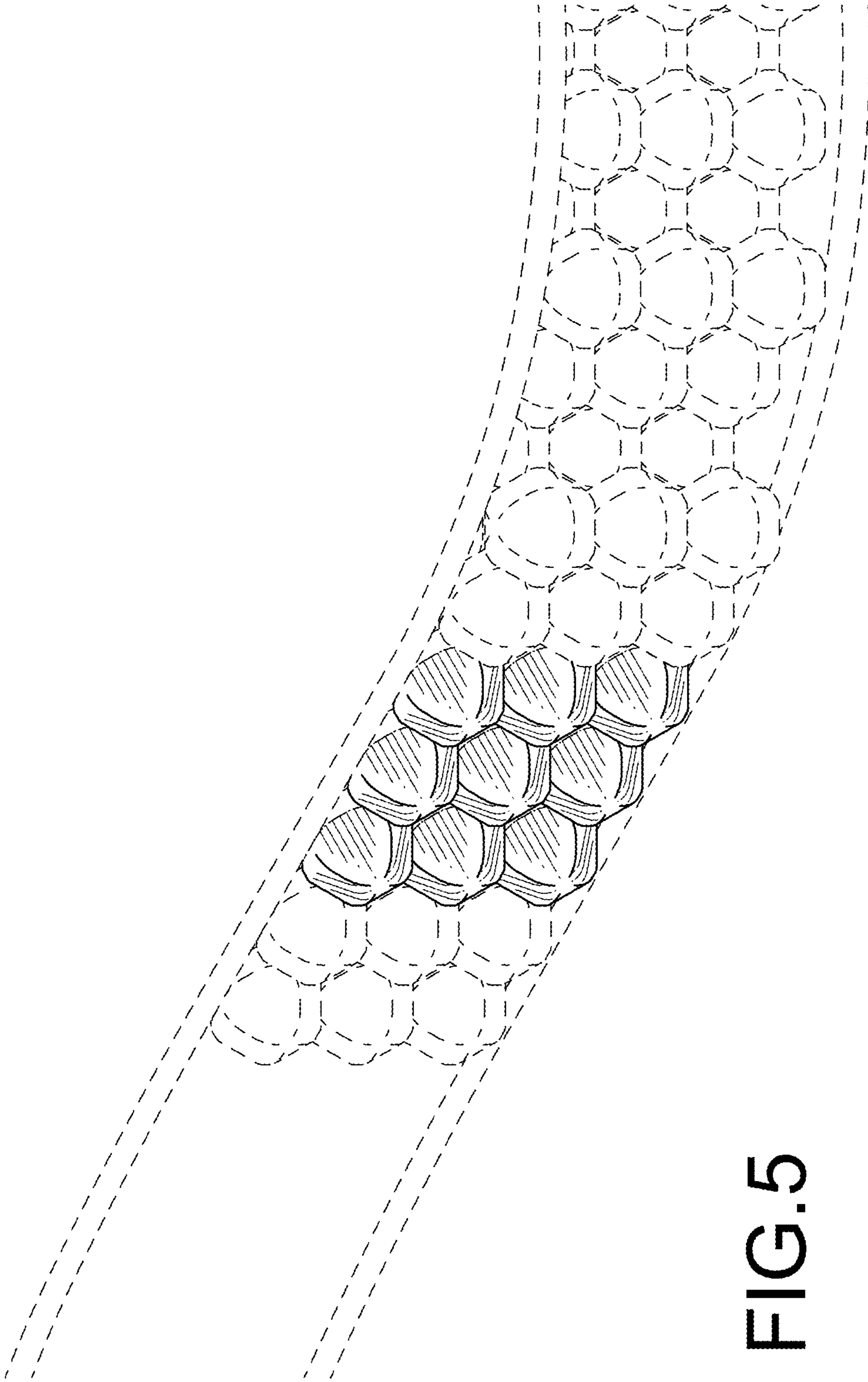

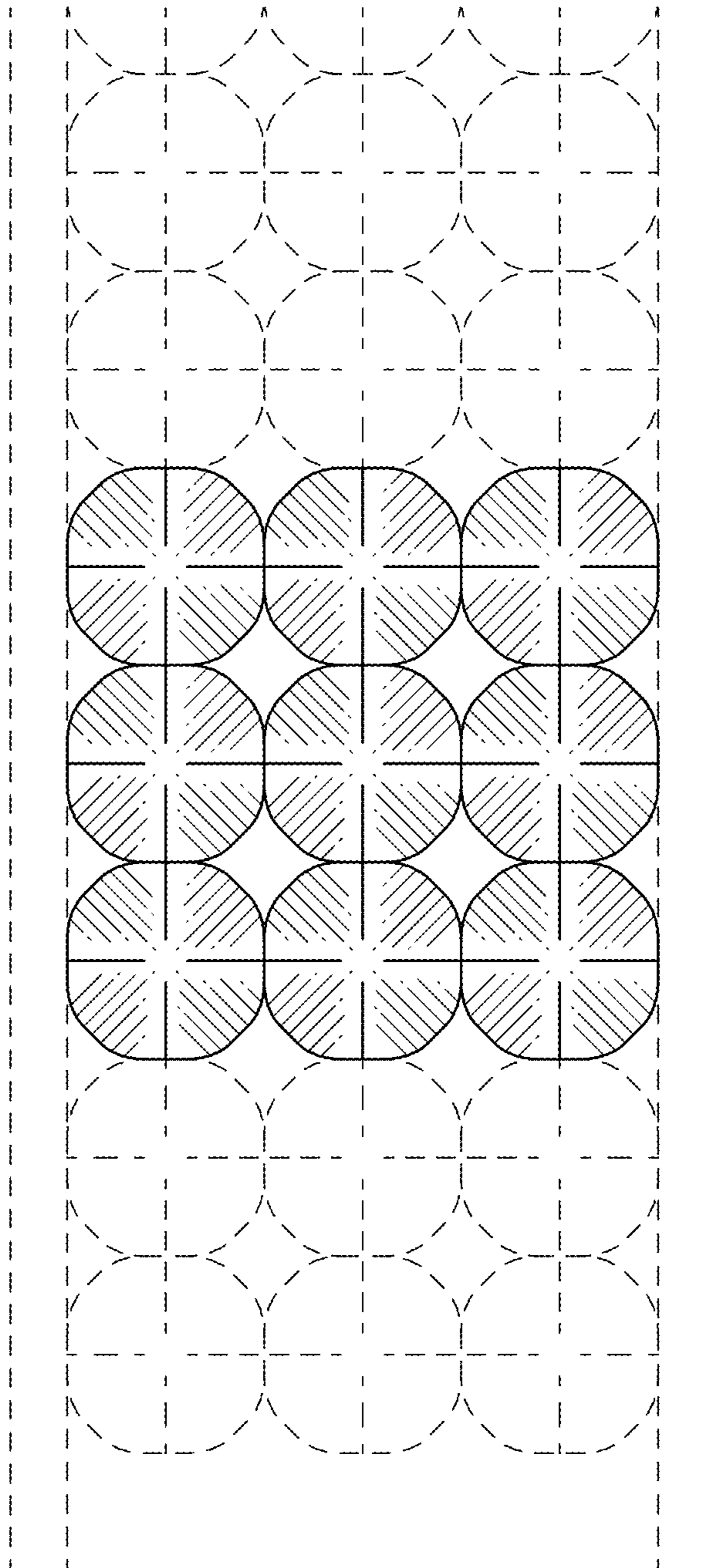

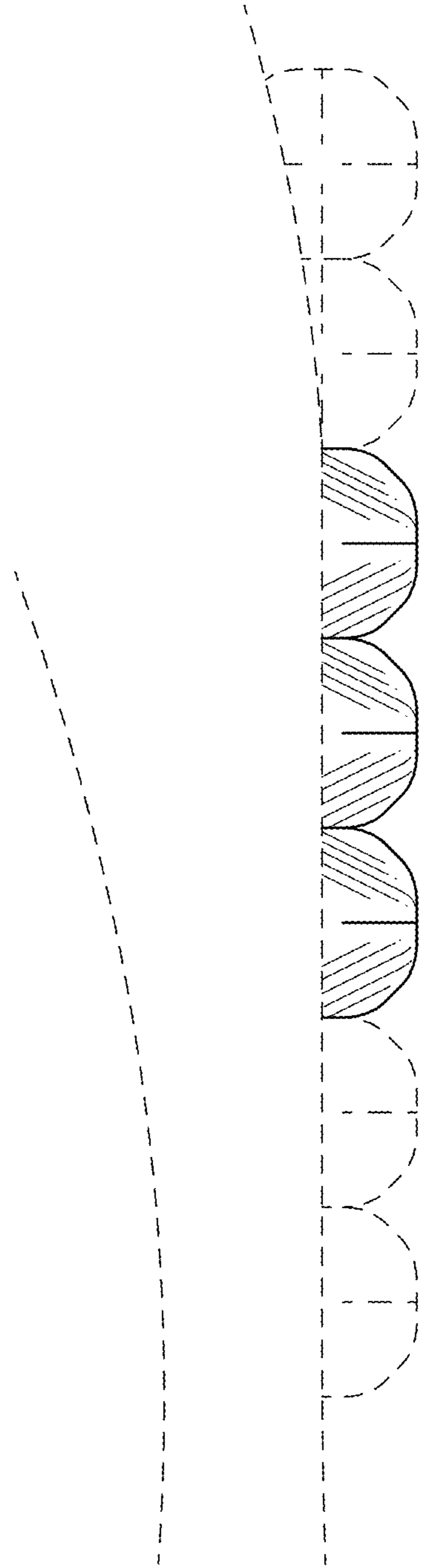

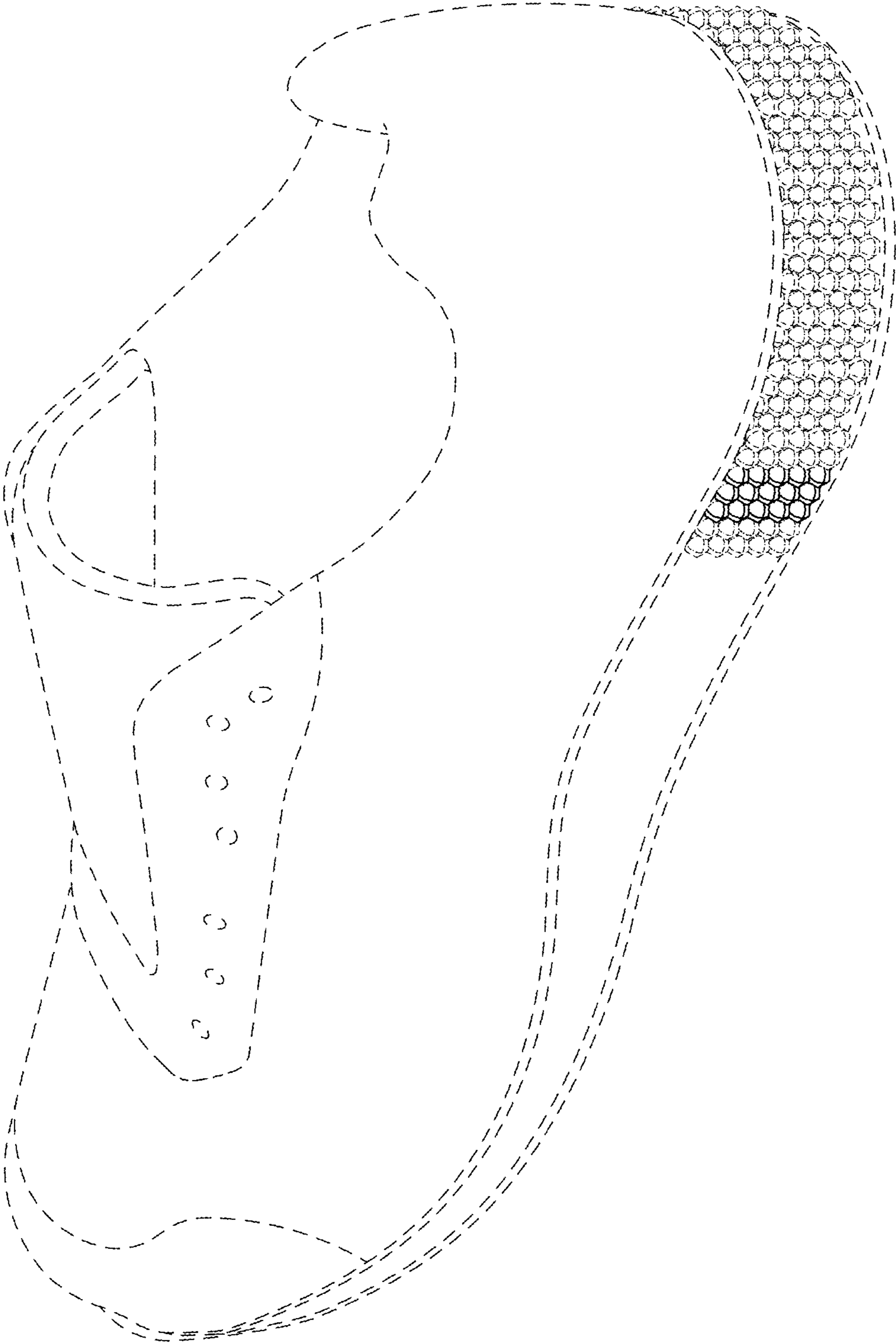

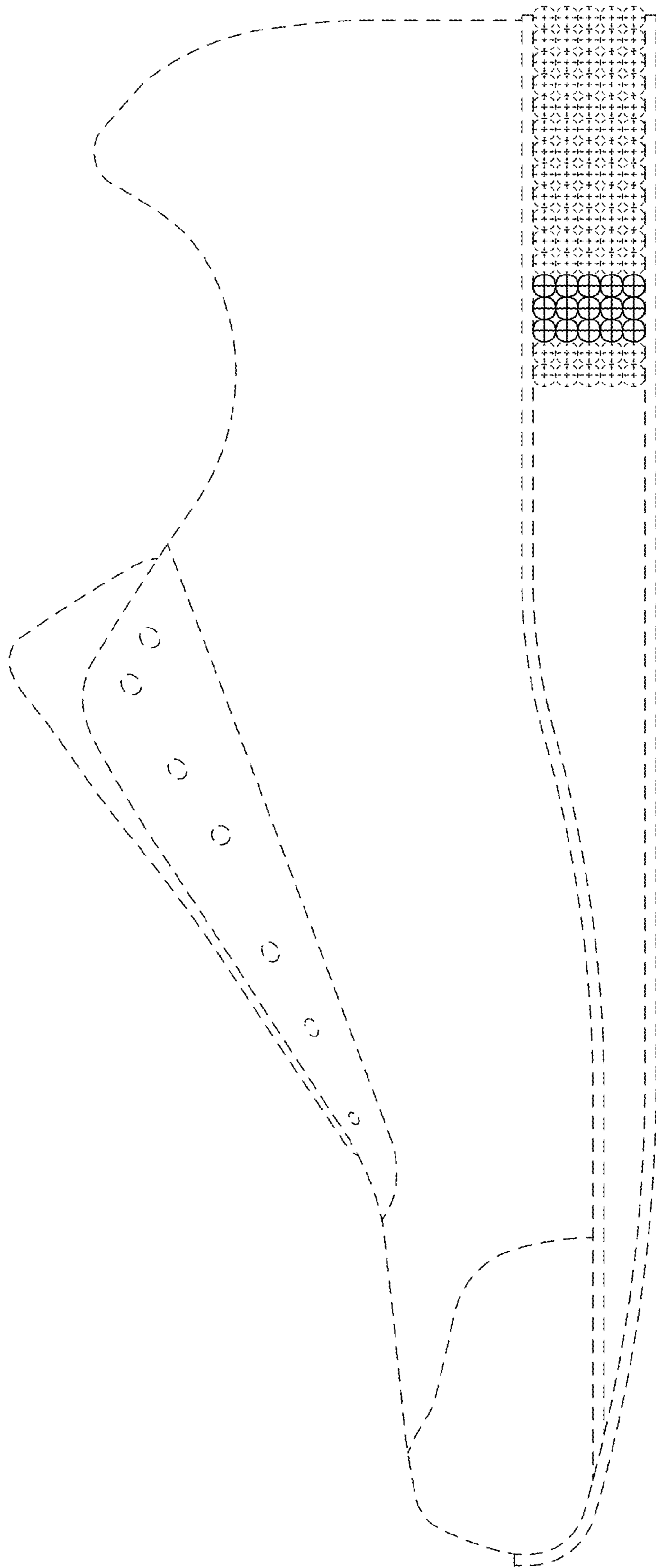

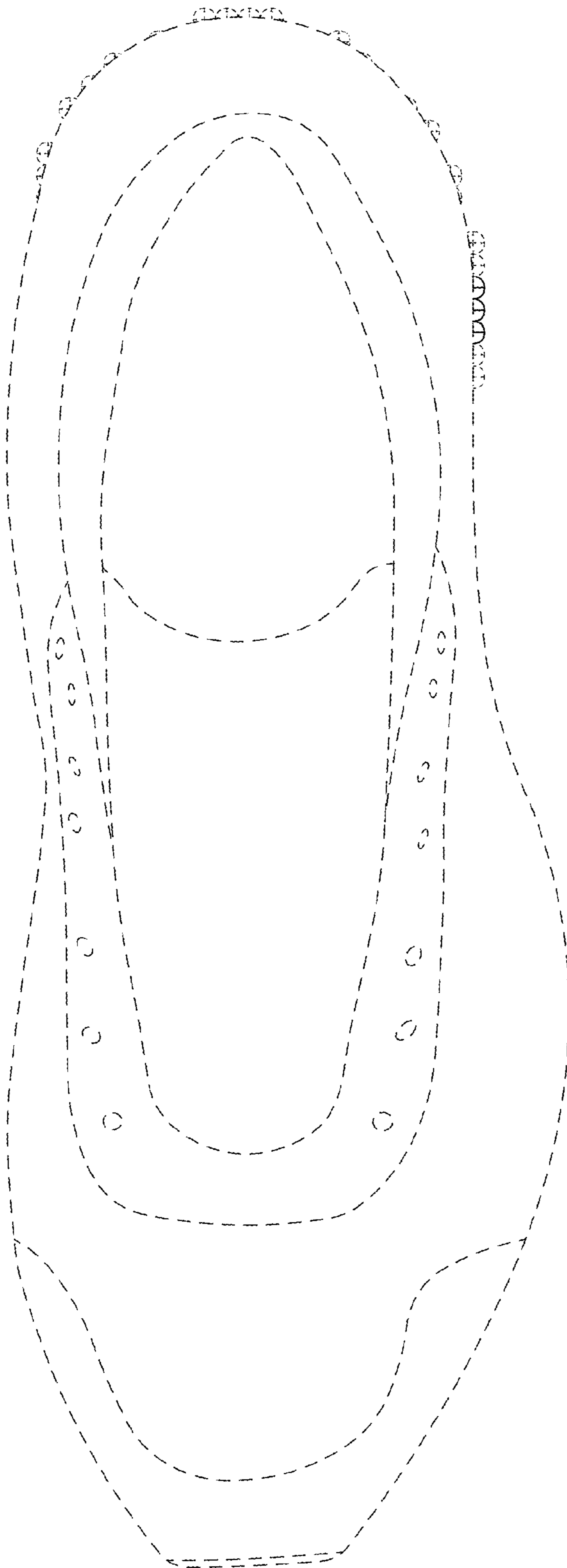

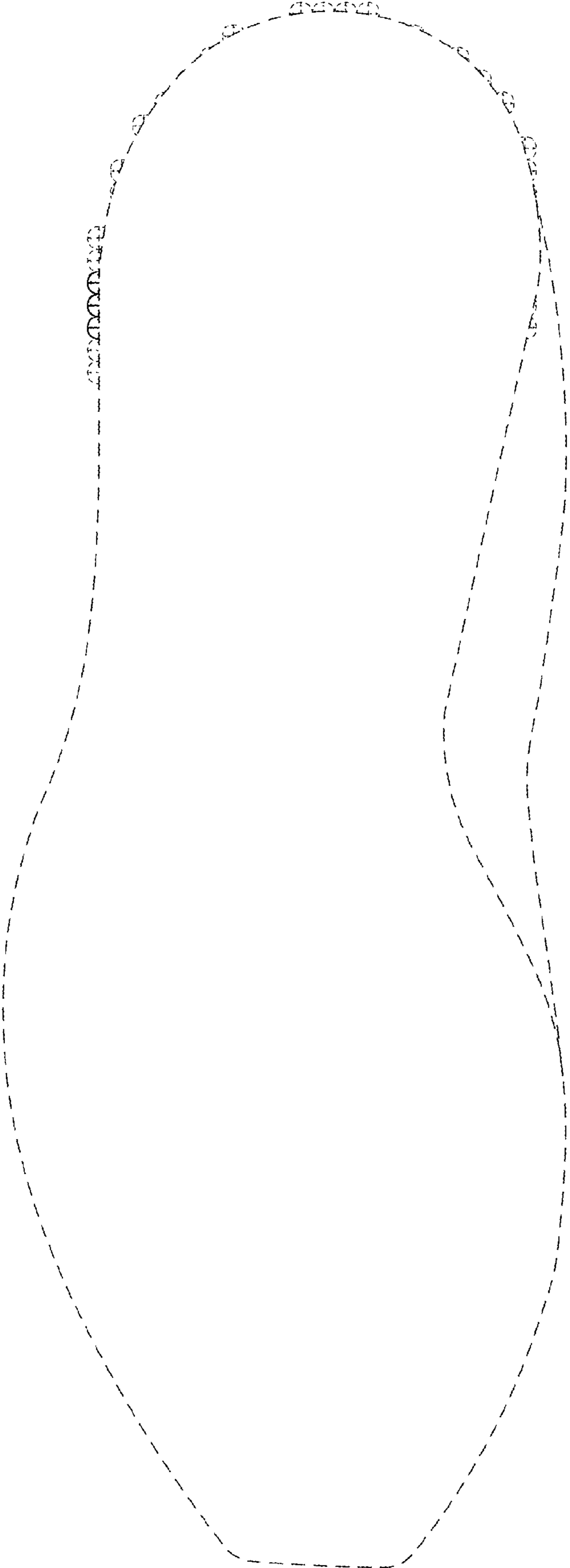

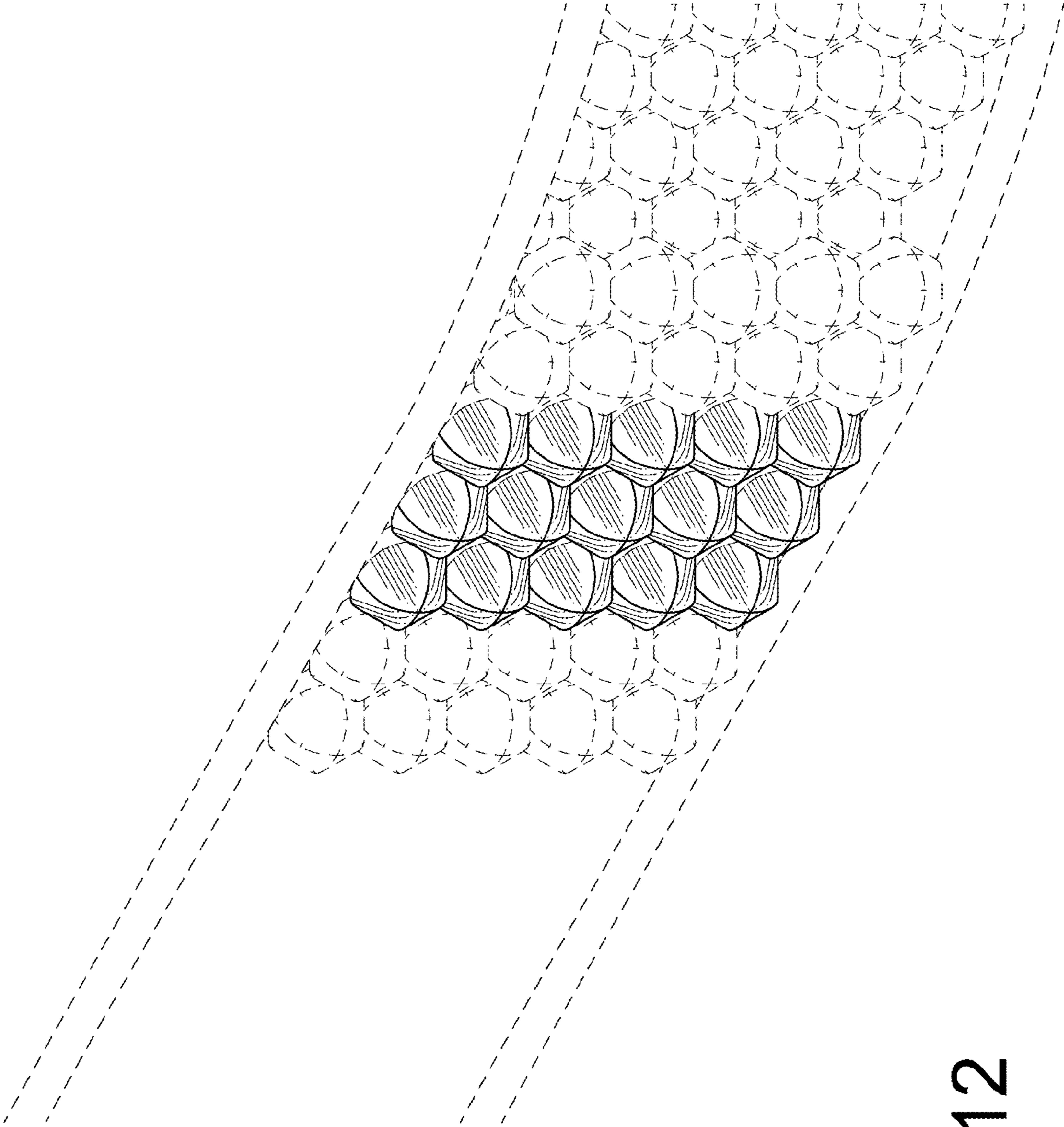

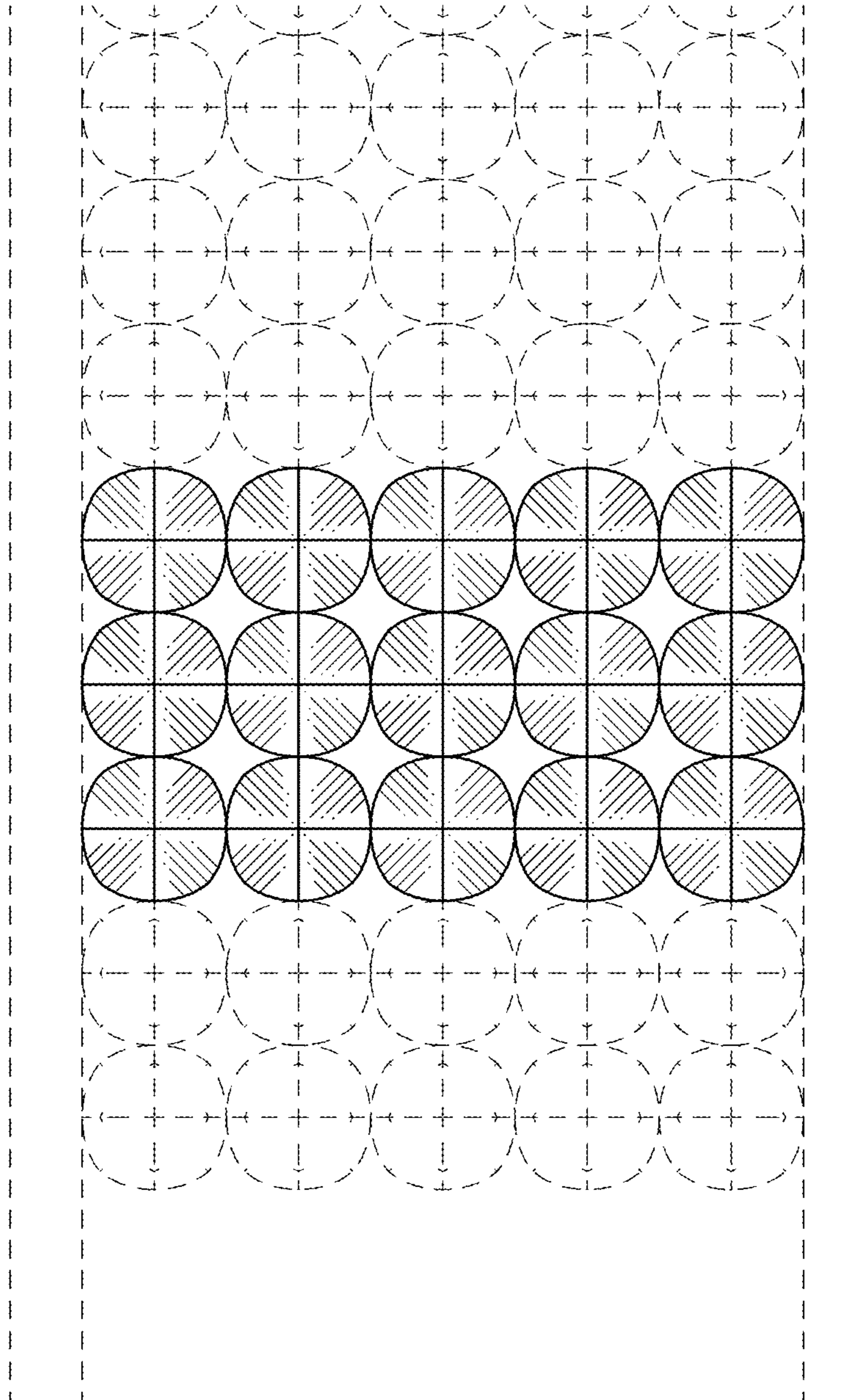

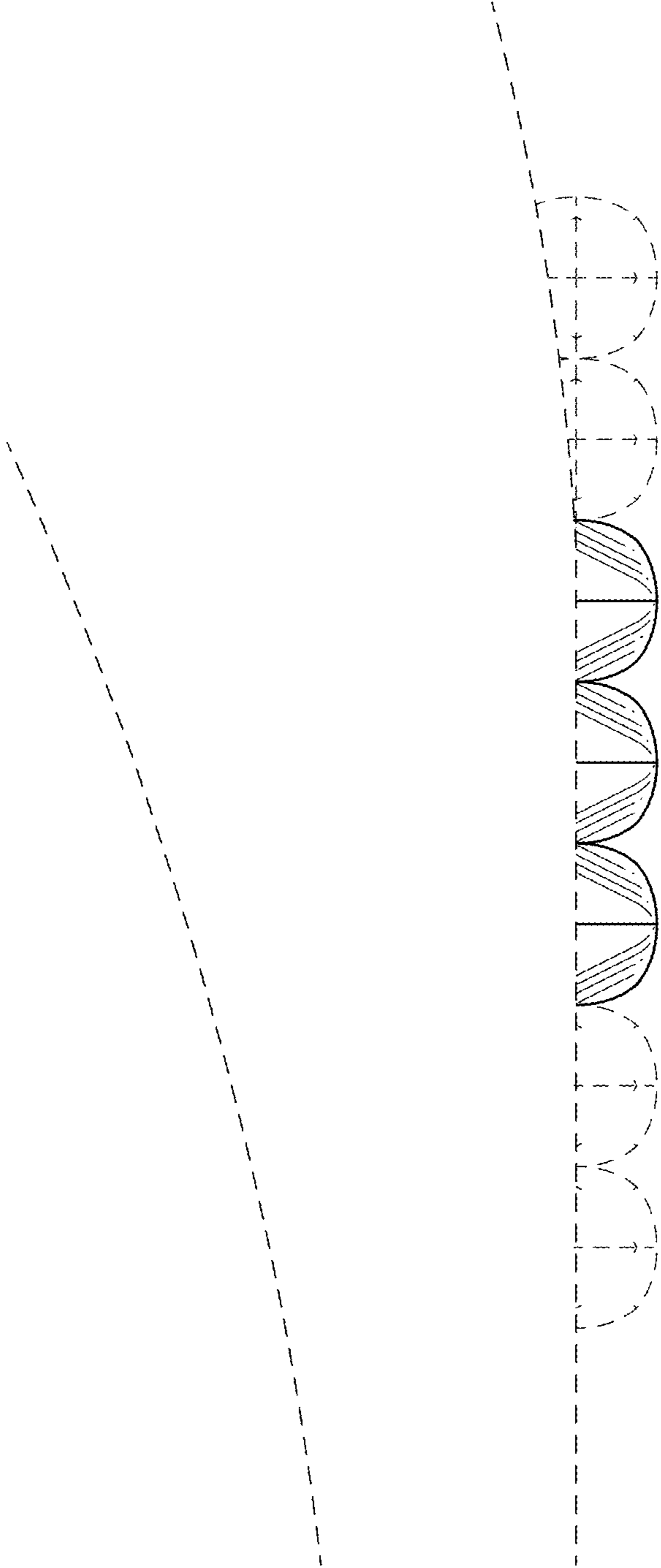
