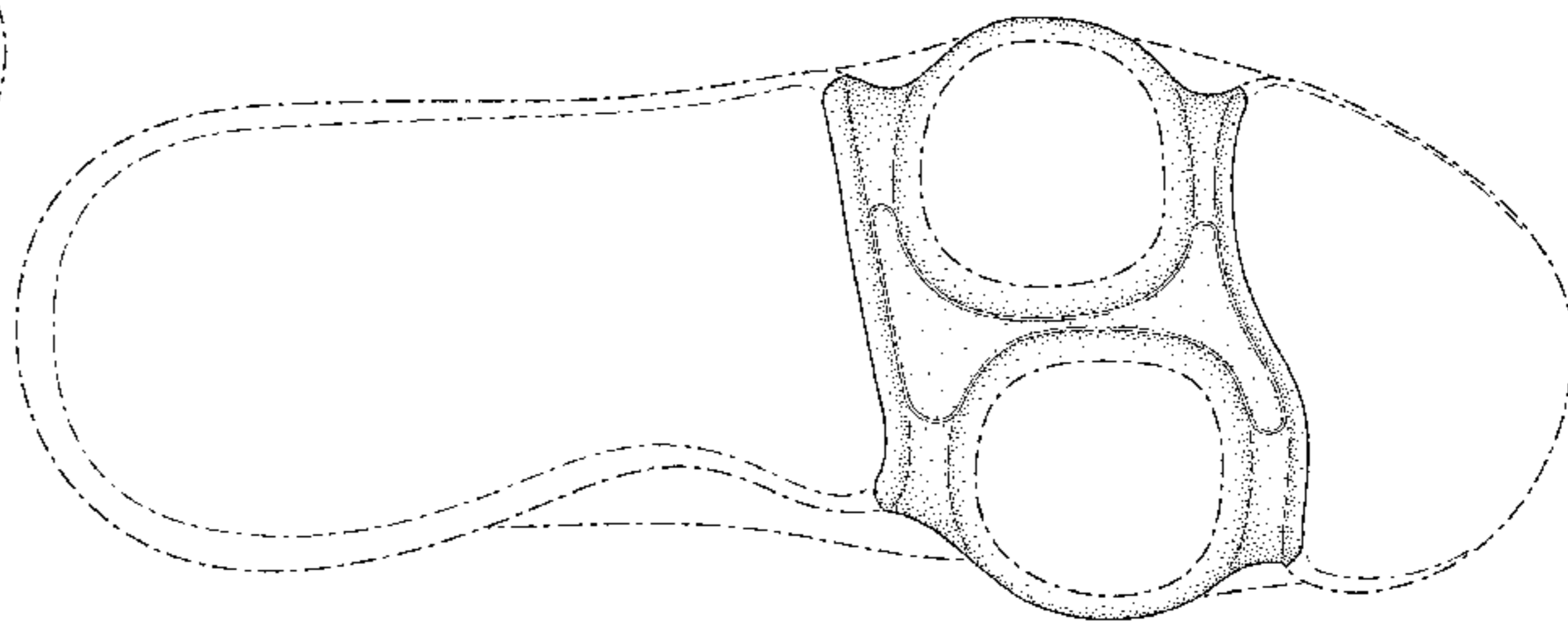
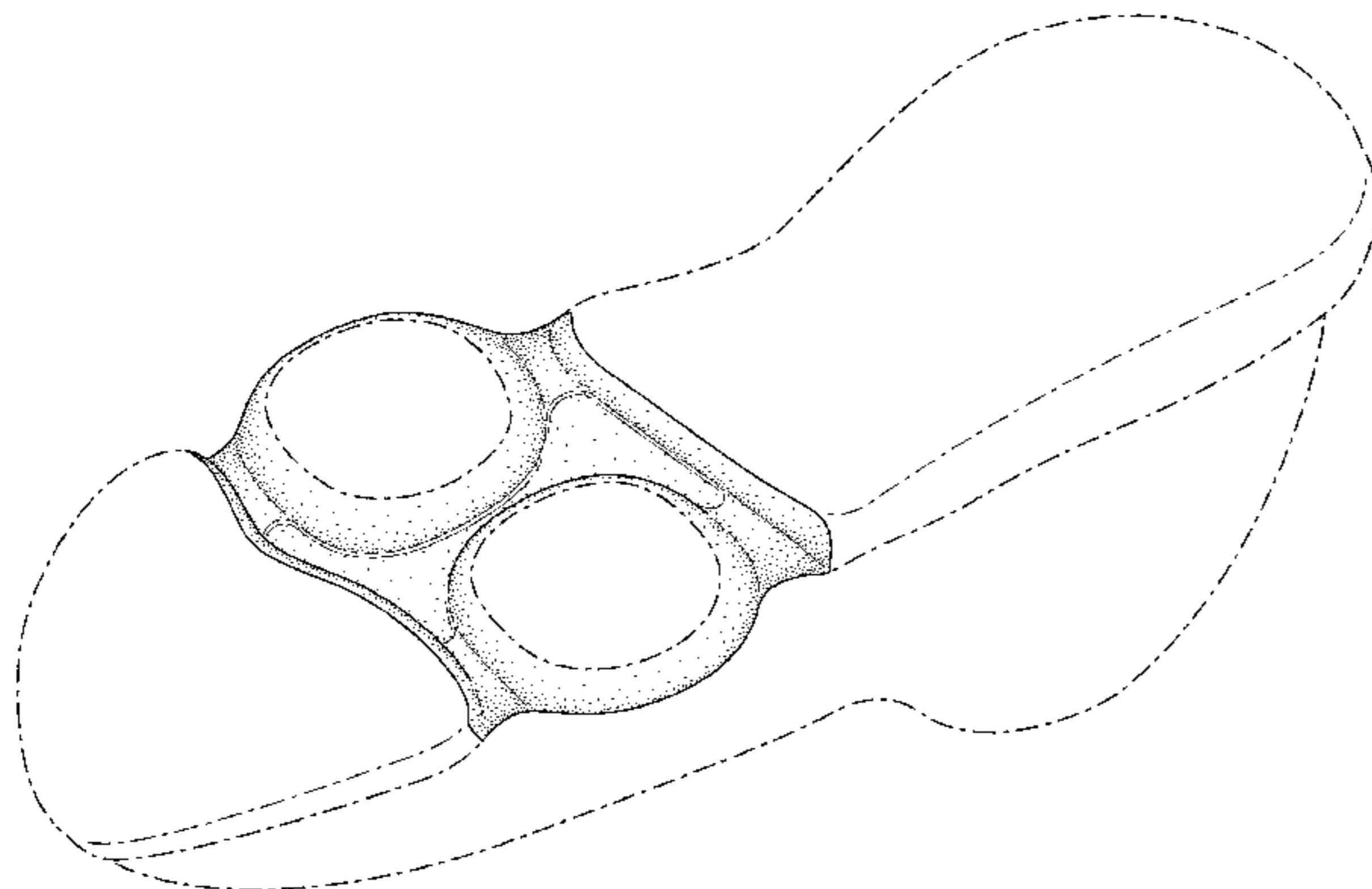
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing our new design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is an opposite side front perspective view thereof;  
FIG. 4 is a front perspective of a shoe showing our new design with disclaimed tread elements depicted;  
FIG. 5 is a bottom view thereof; and,  
FIG. 6 is an opposite side front perspective view thereof.  
The two unshaded generally circular elements shown in broken lines within the shaded area form no part of the claimed design. The broken lines in the shaded area in FIGS. 4-6 represent tread elements which form no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

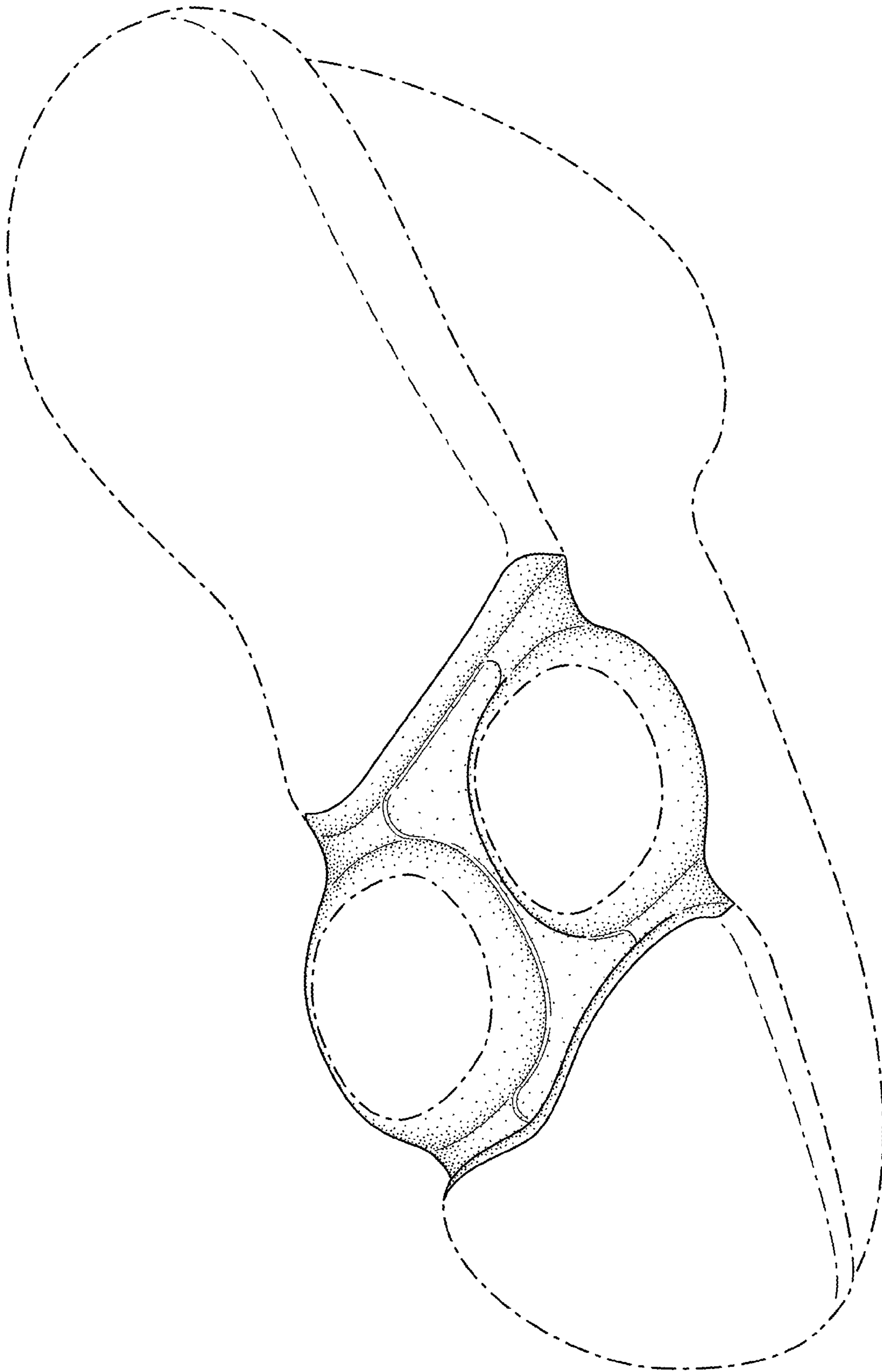

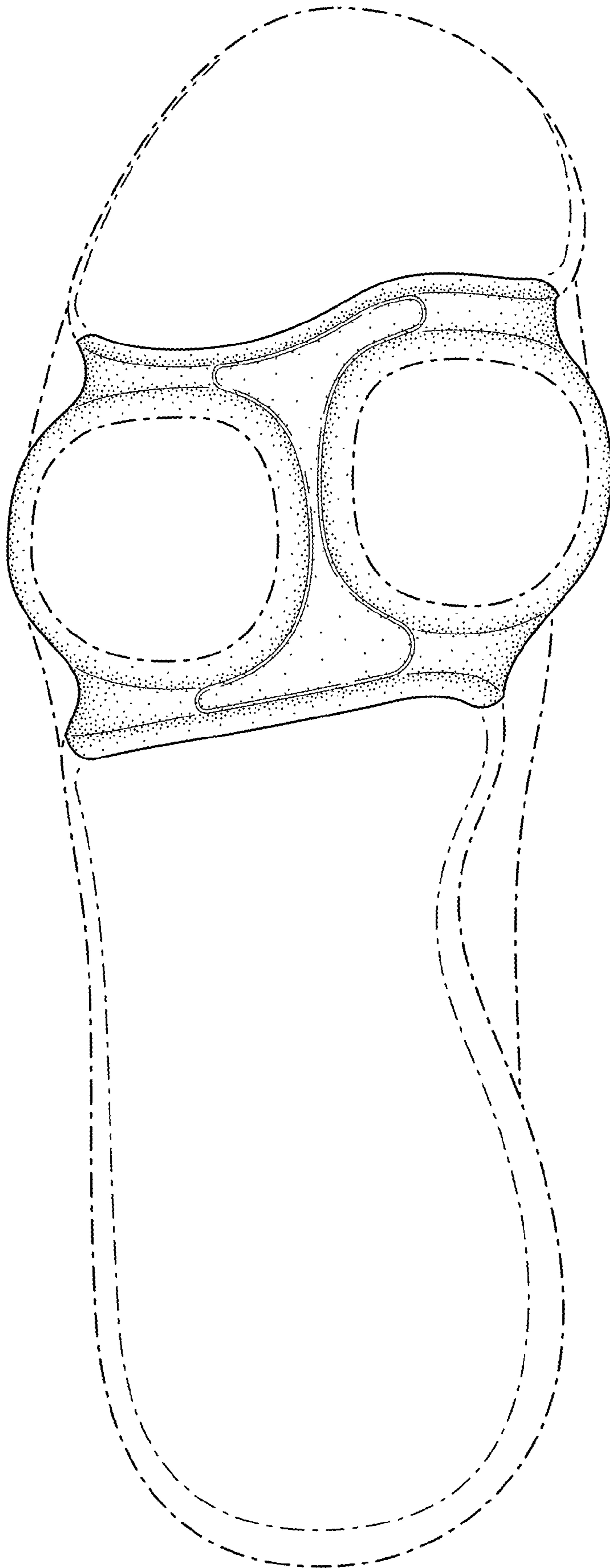

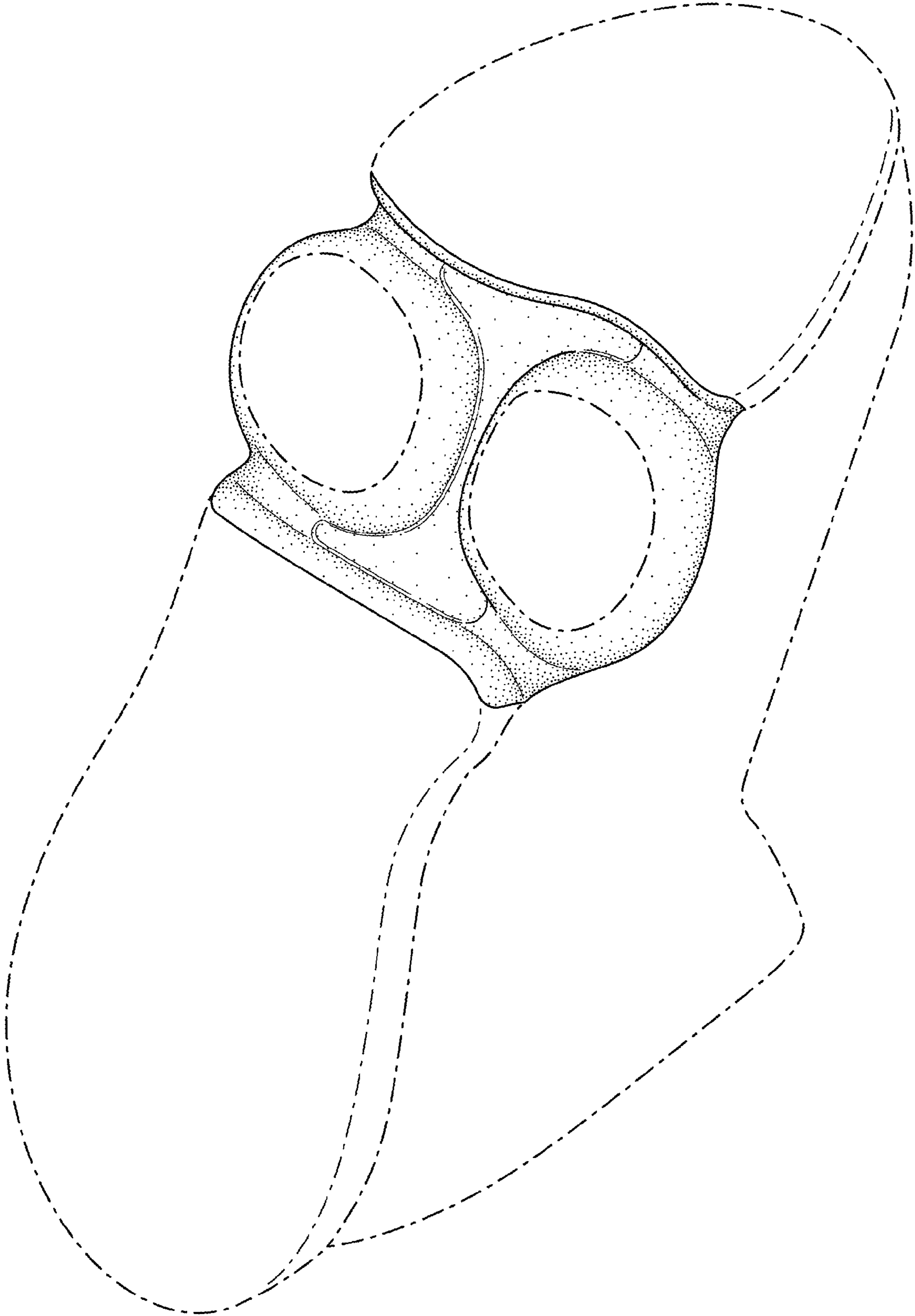

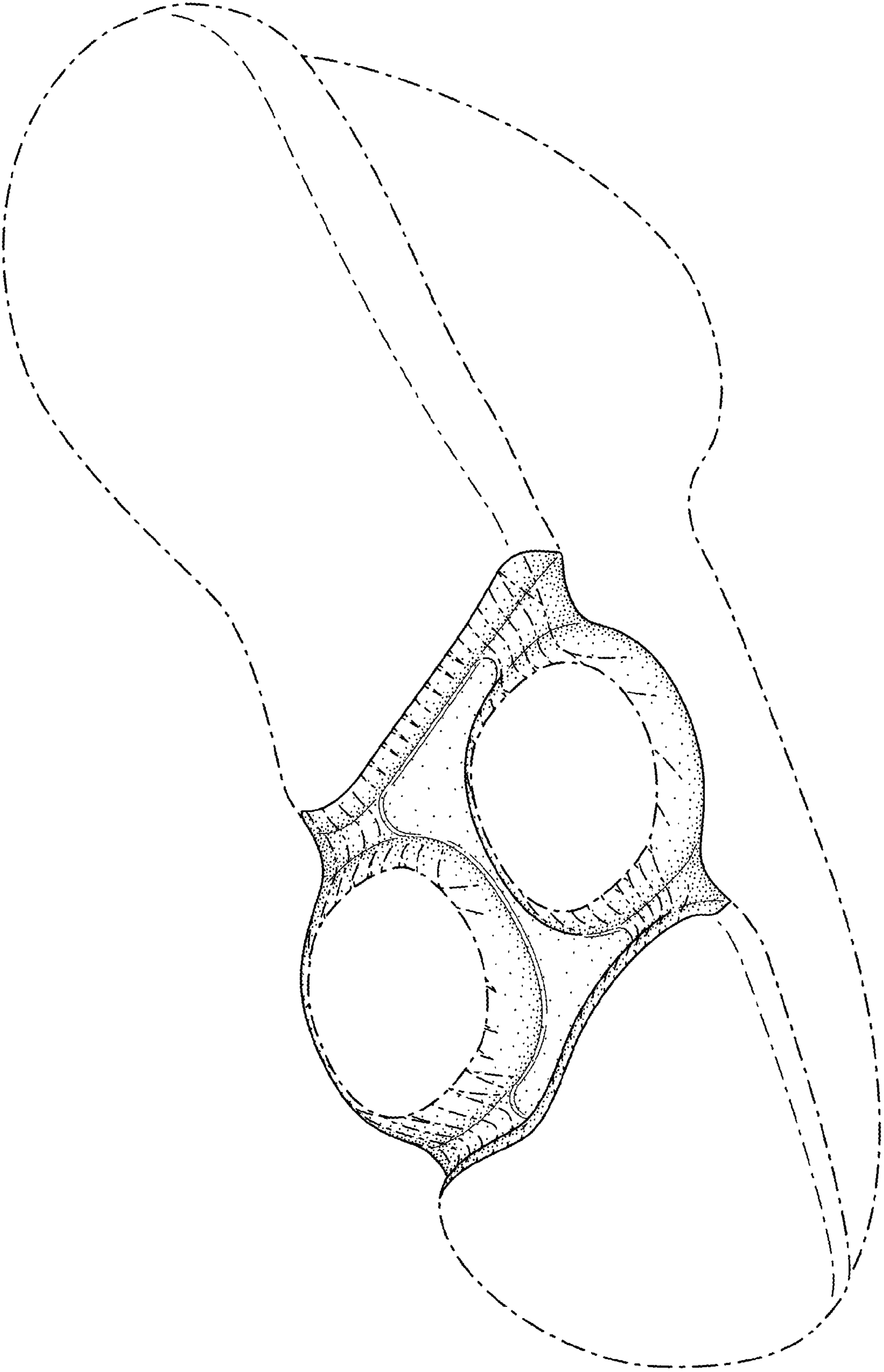

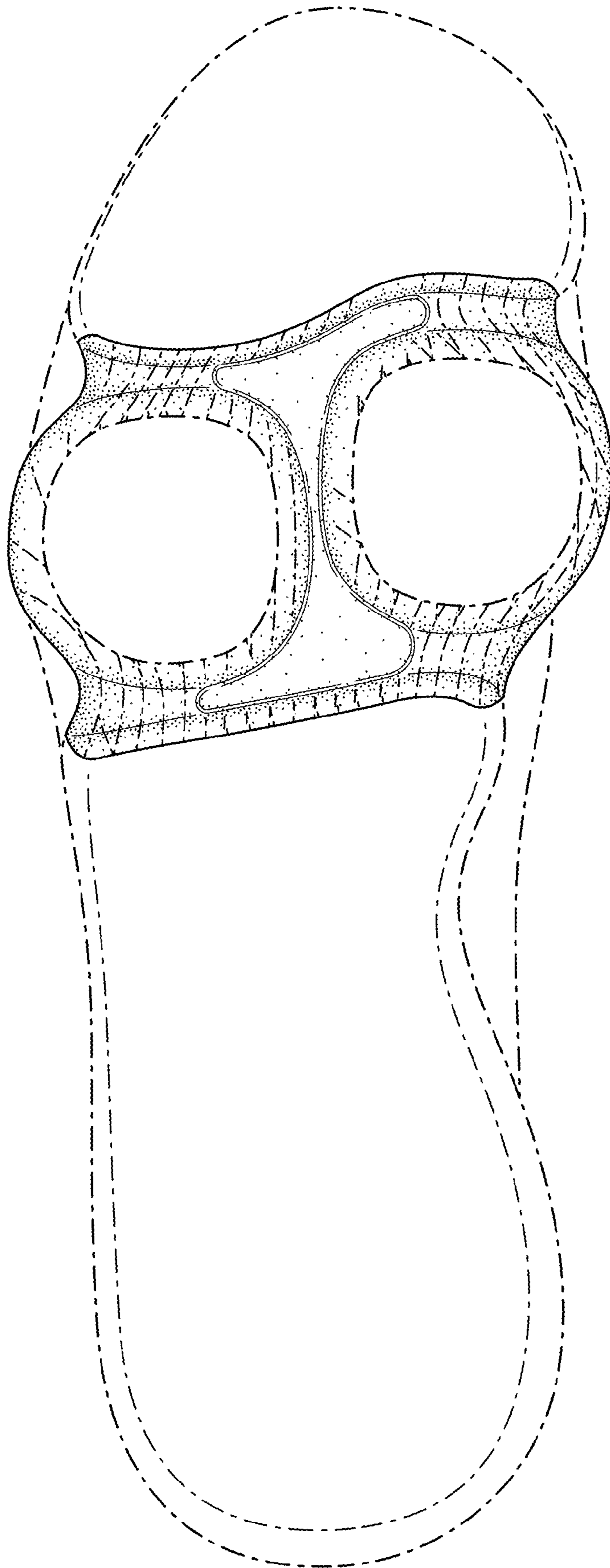

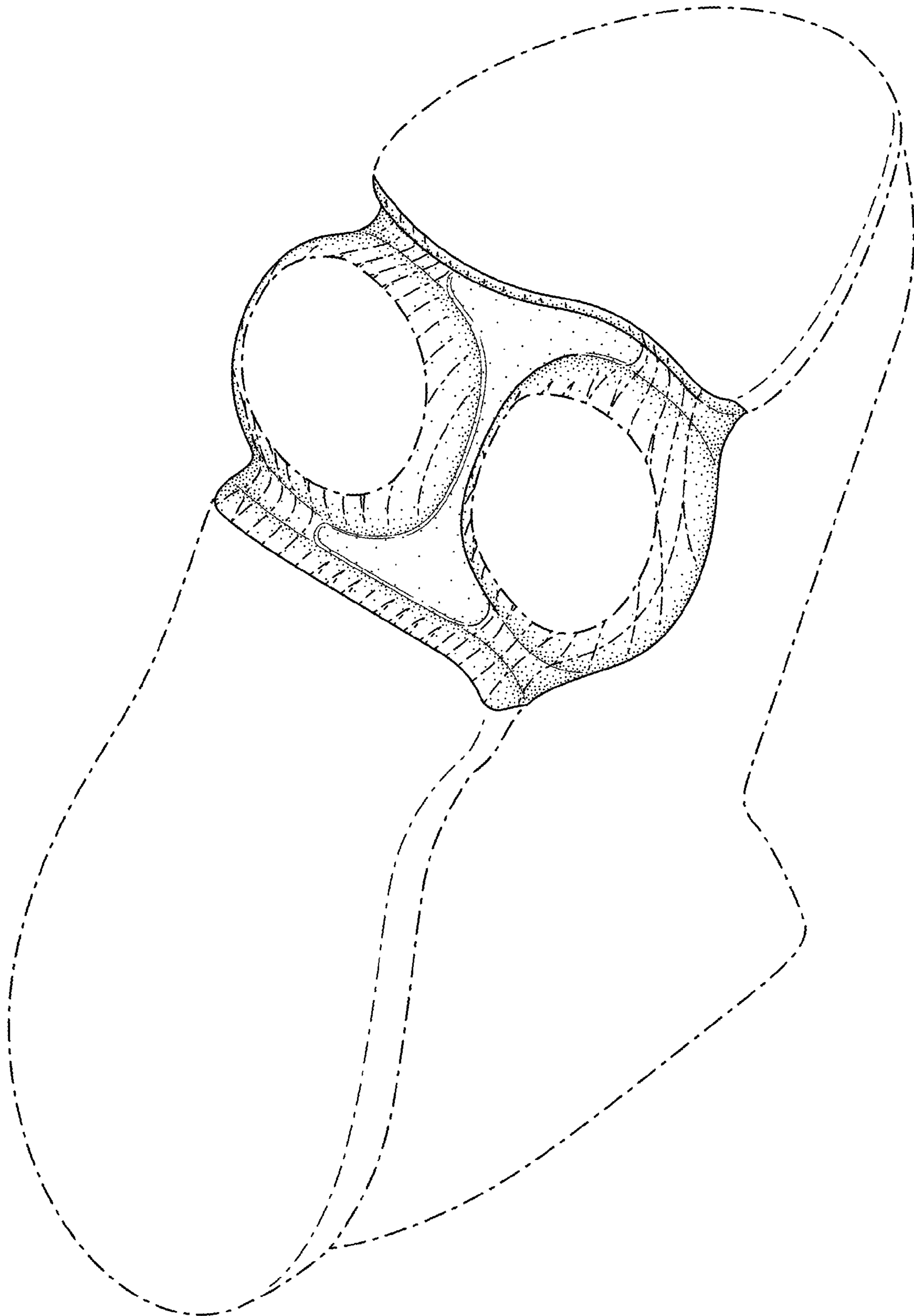
