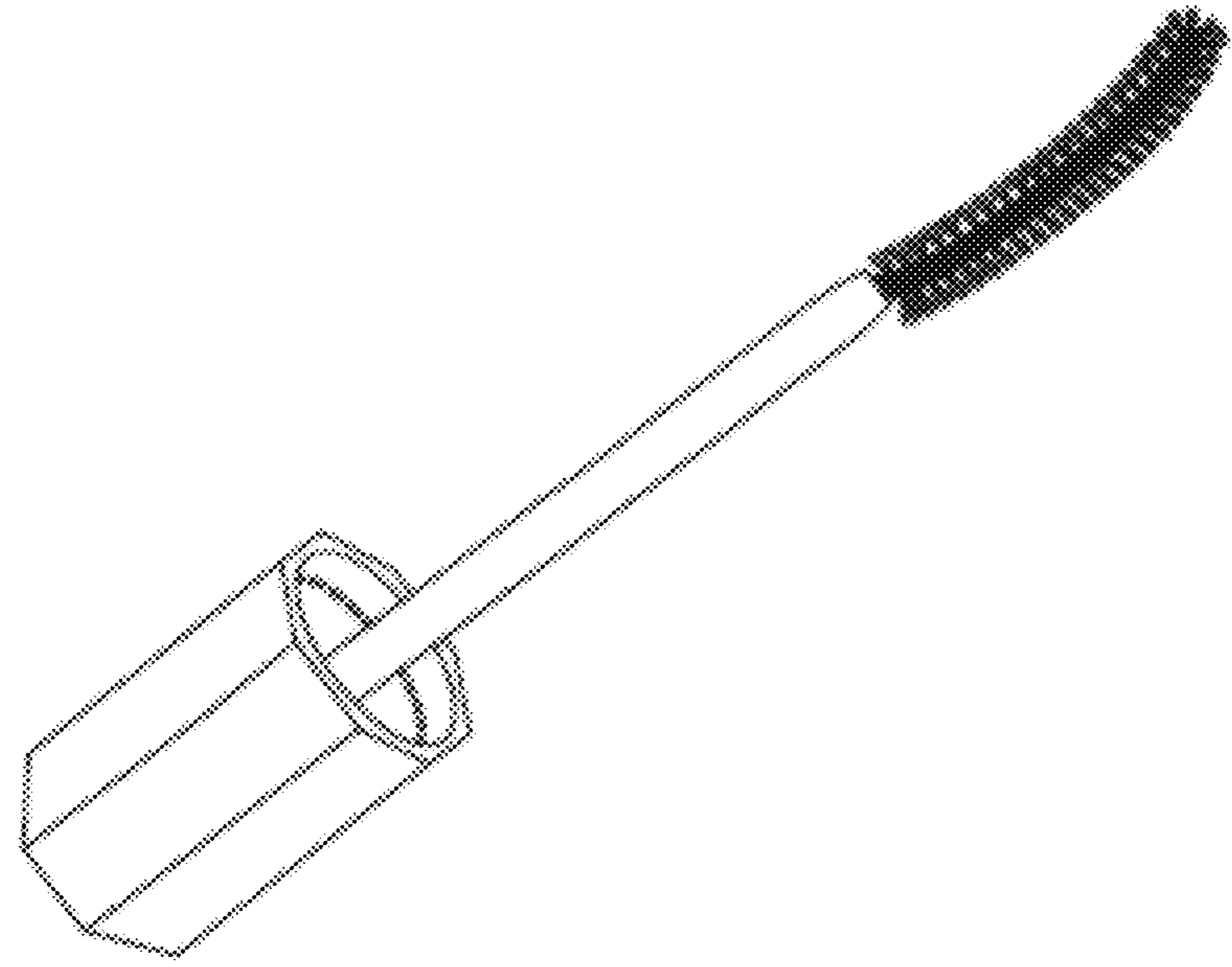
(57) **CLAIM**

The ornamental design for a cosmetic brush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cosmetic brush in accordance with the new design;
 FIG. 2 is a right perspective view of the cosmetic brush of FIG. 1;
 FIG. 3 is a left perspective view of the cosmetic brush of FIG. 1;

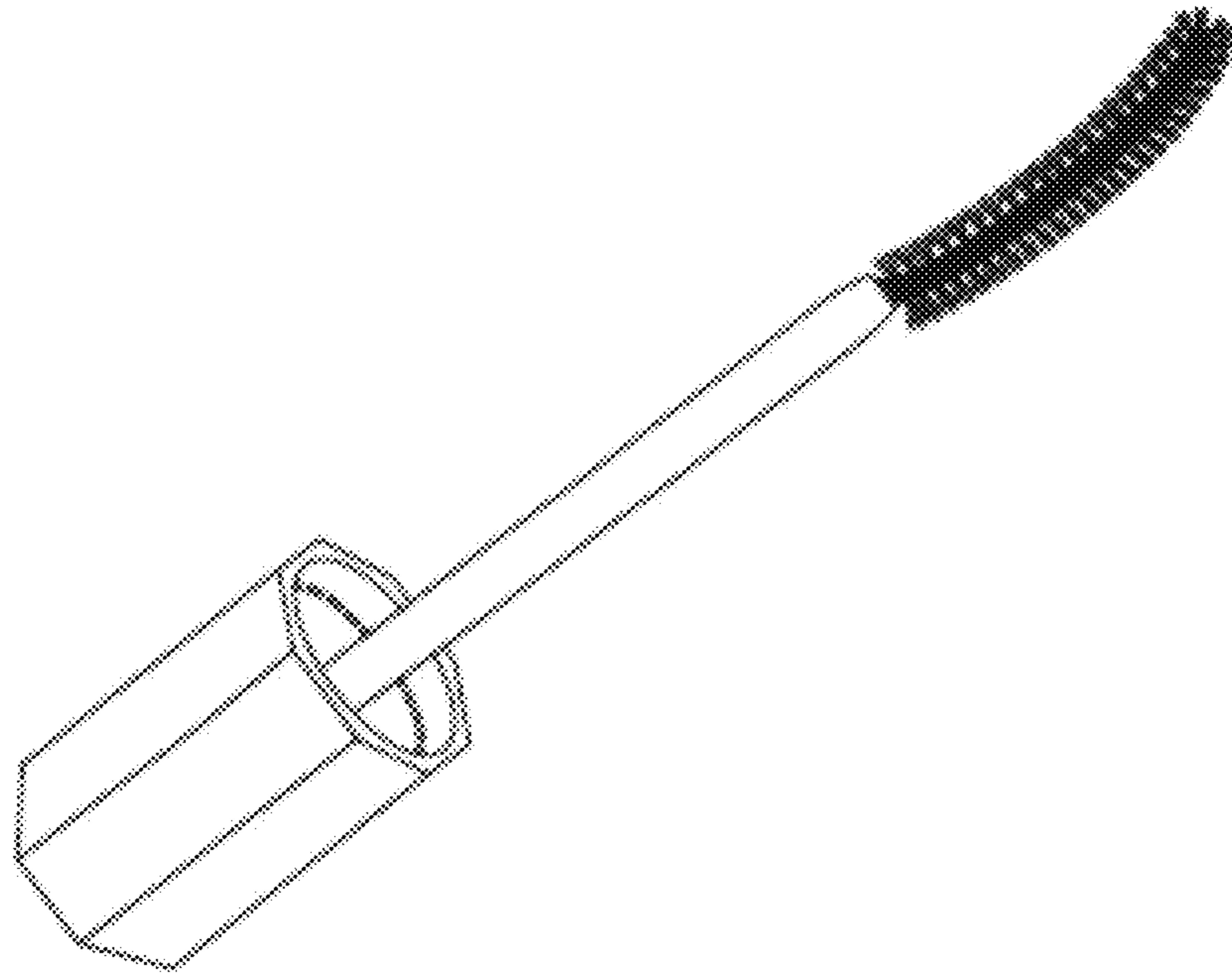

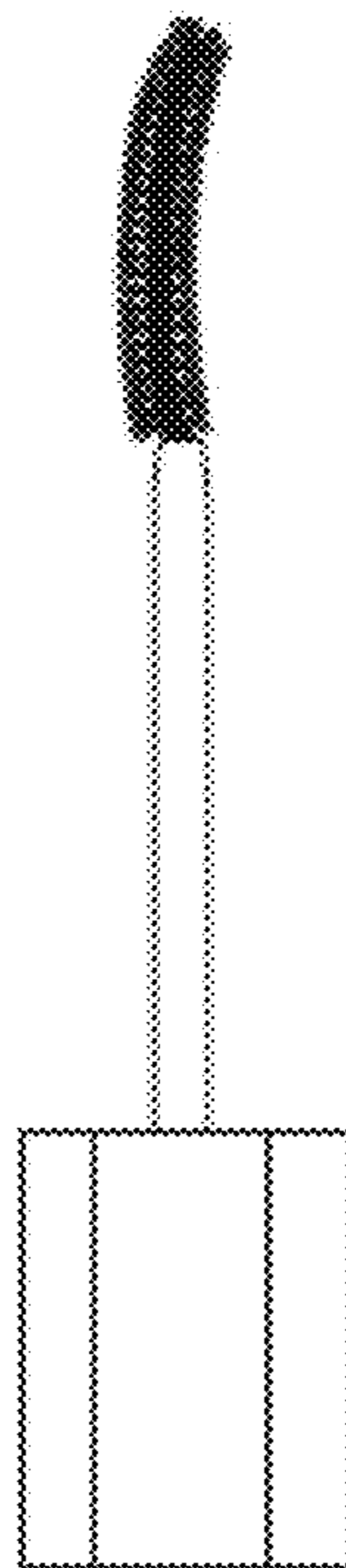

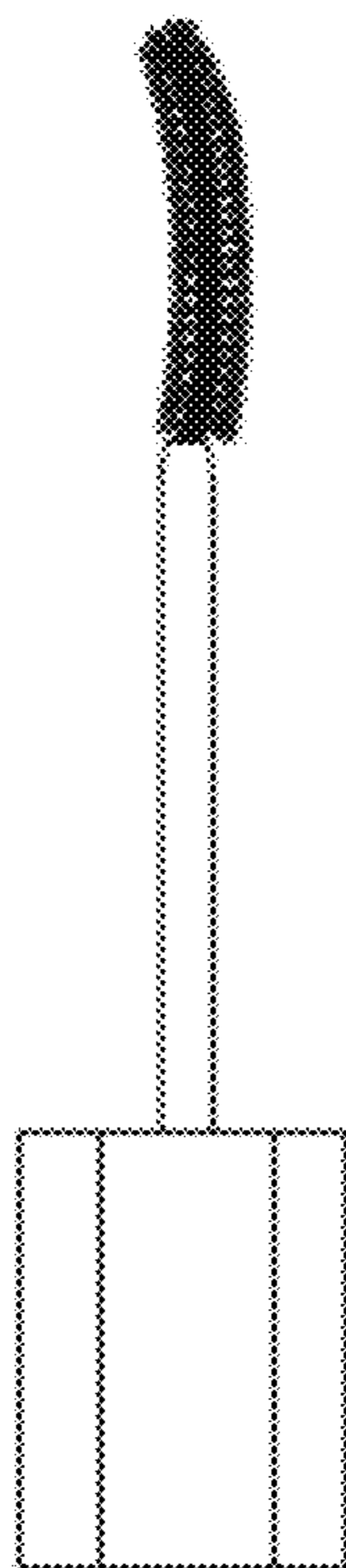

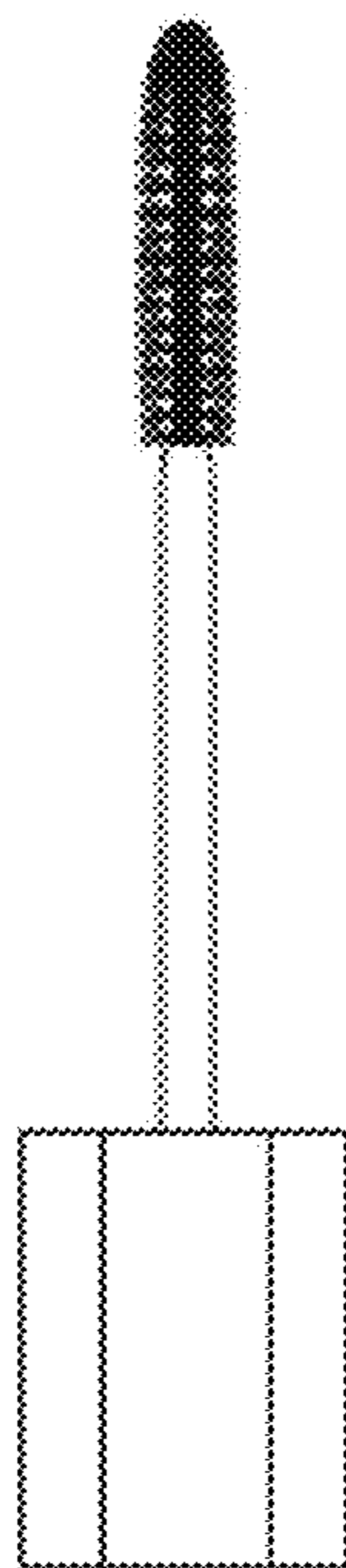

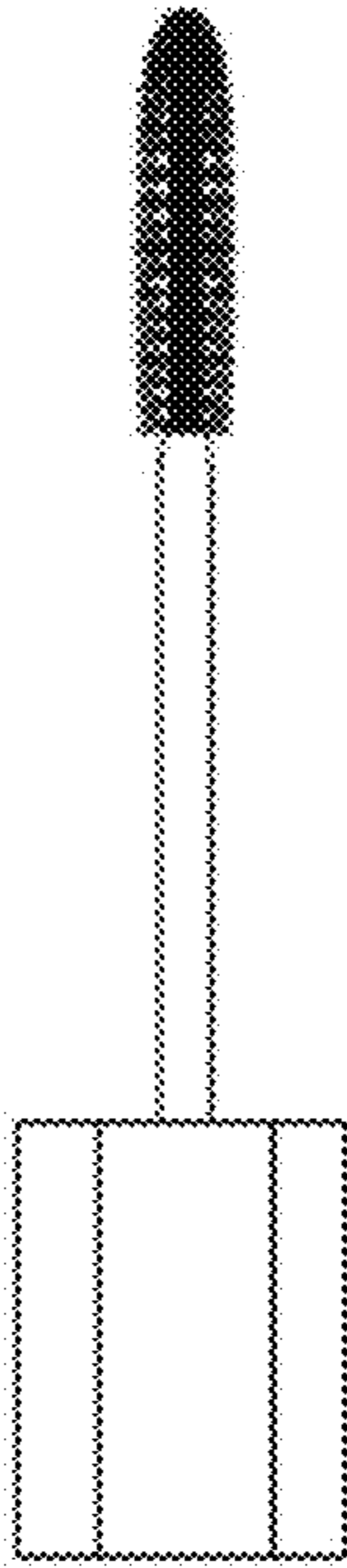

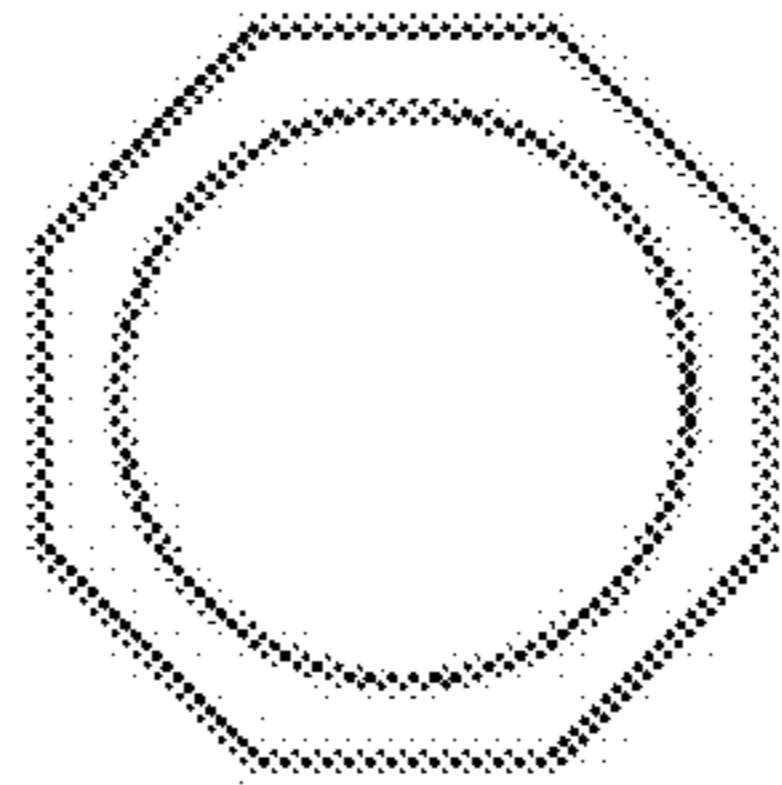

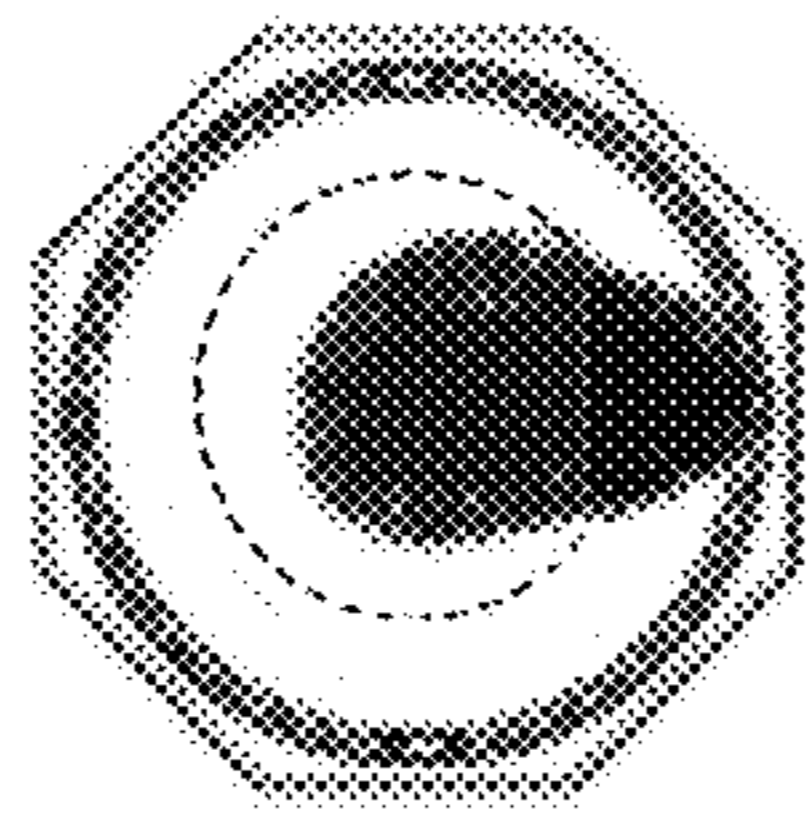
