The ornamental design for a fabric, as shown and described.

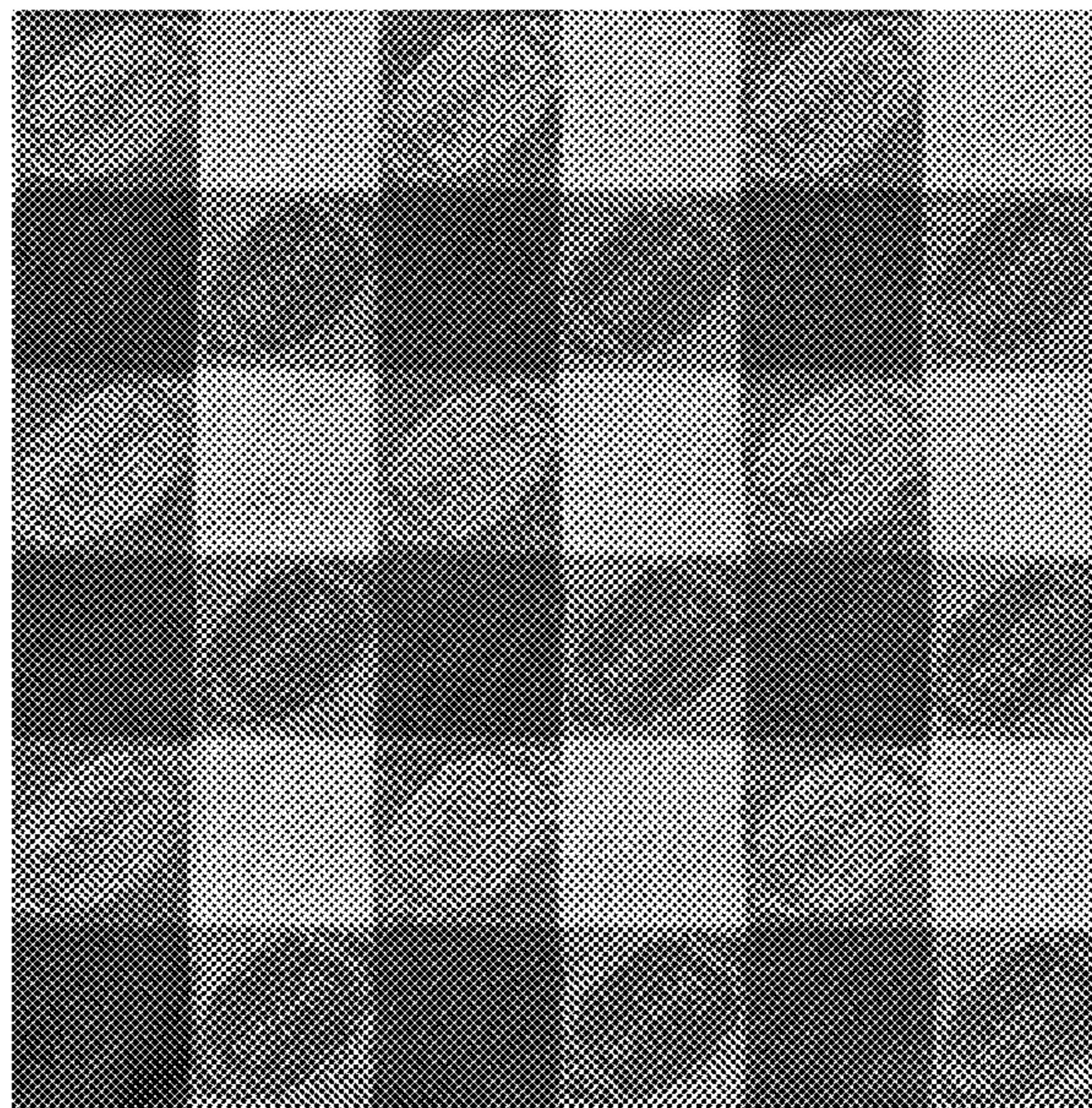
DESCRIPTION
