Applicant claims the ornamental design for a chair or stool, as shown and described.

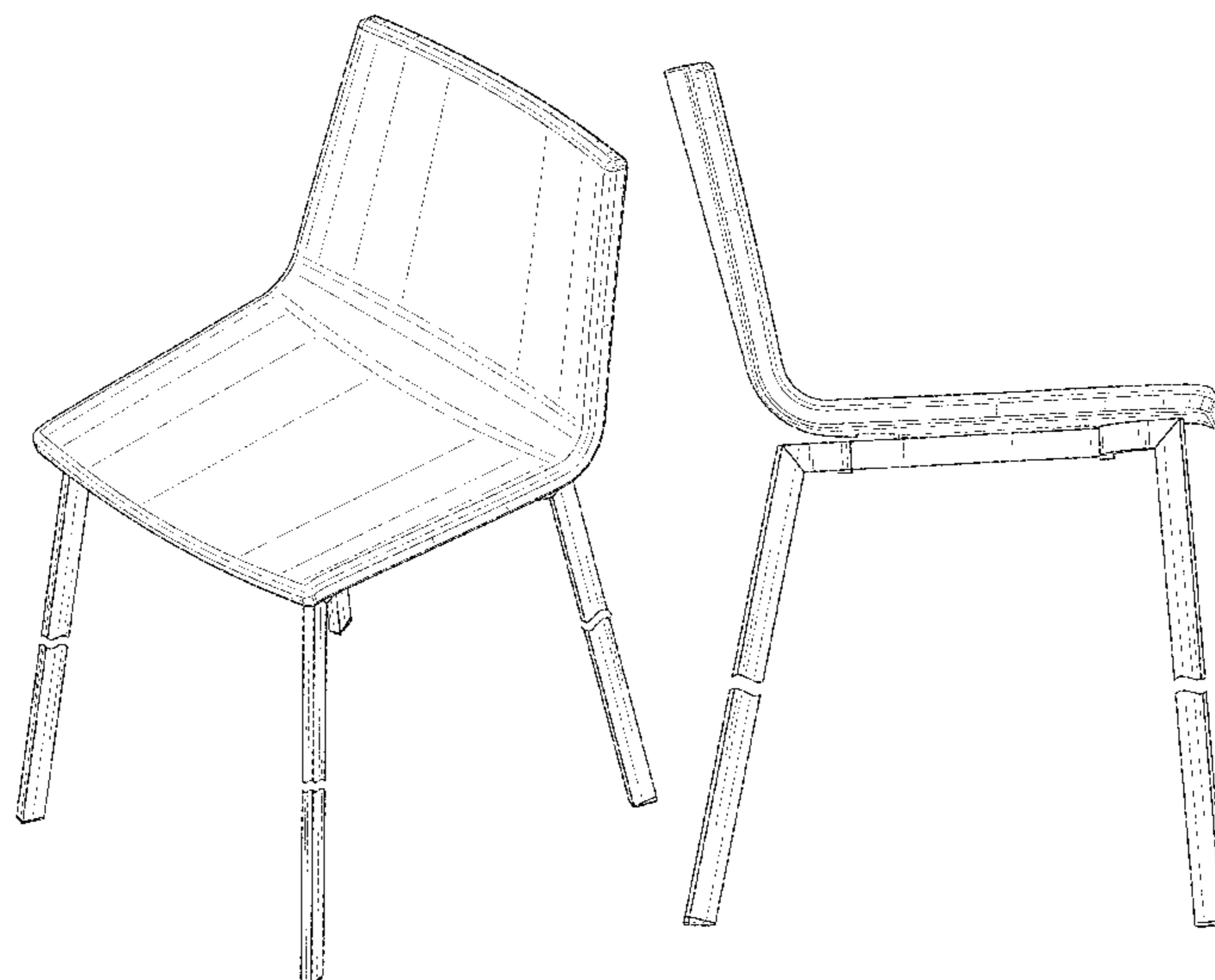
DESCRIPTION

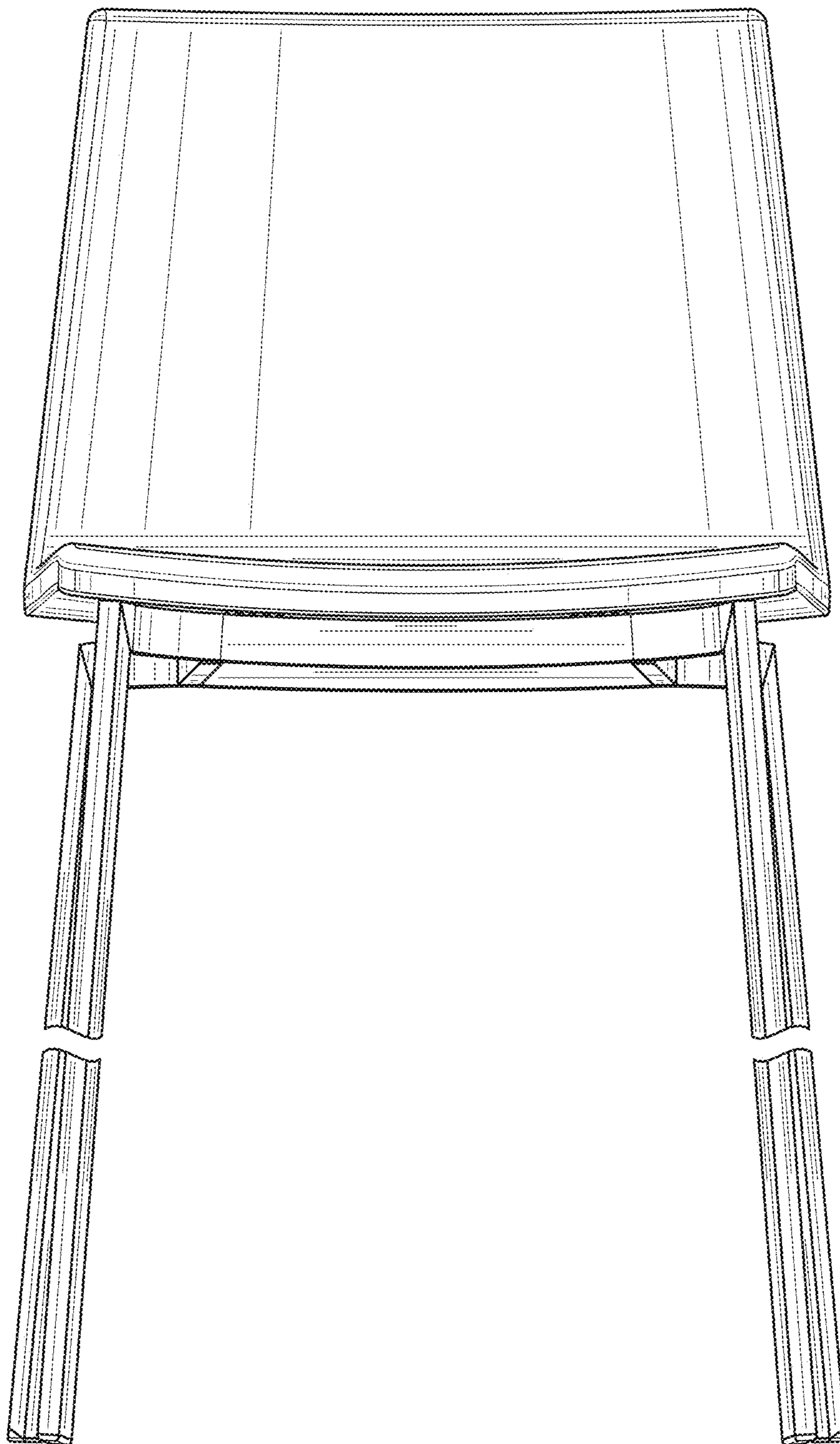

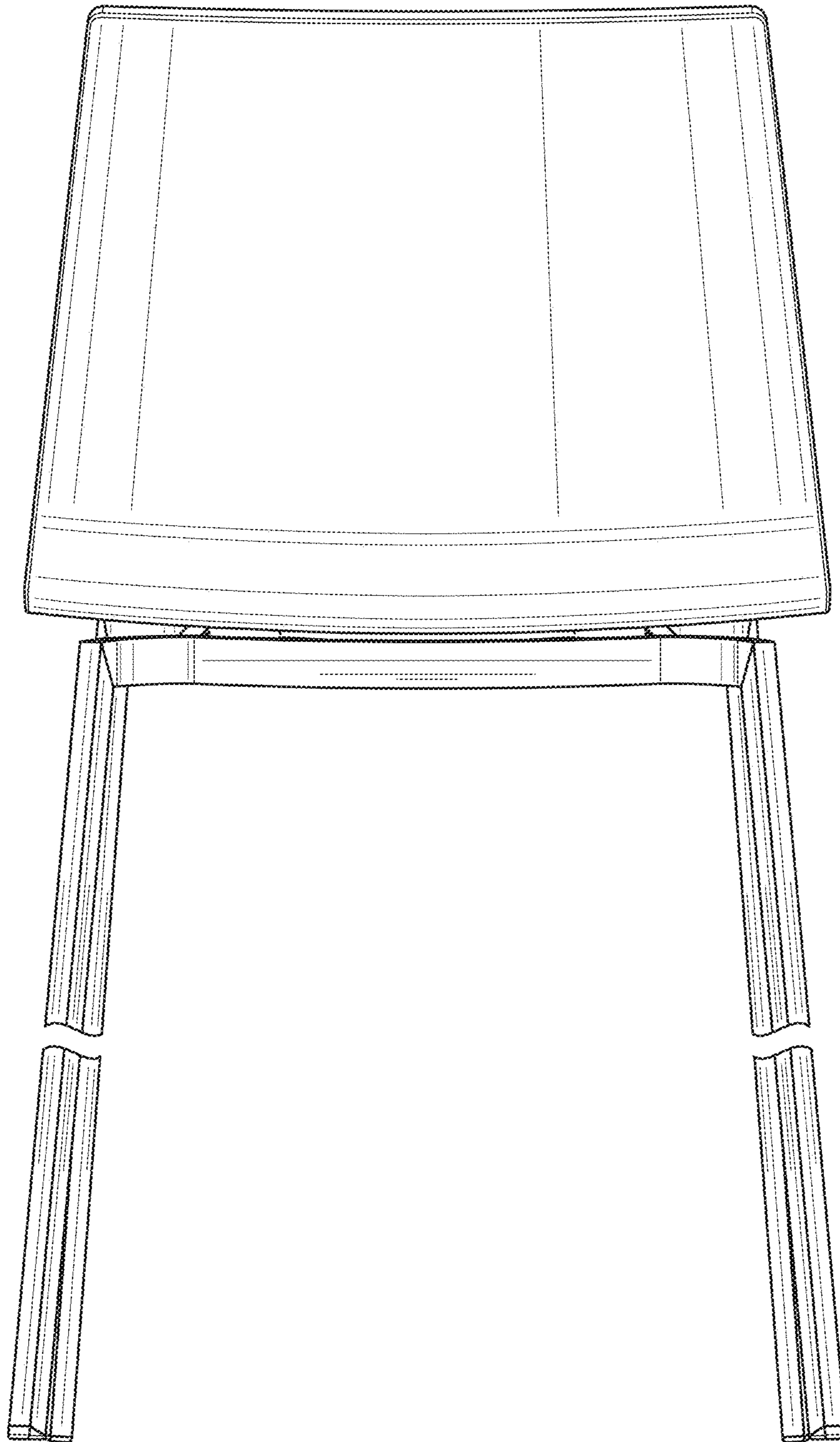

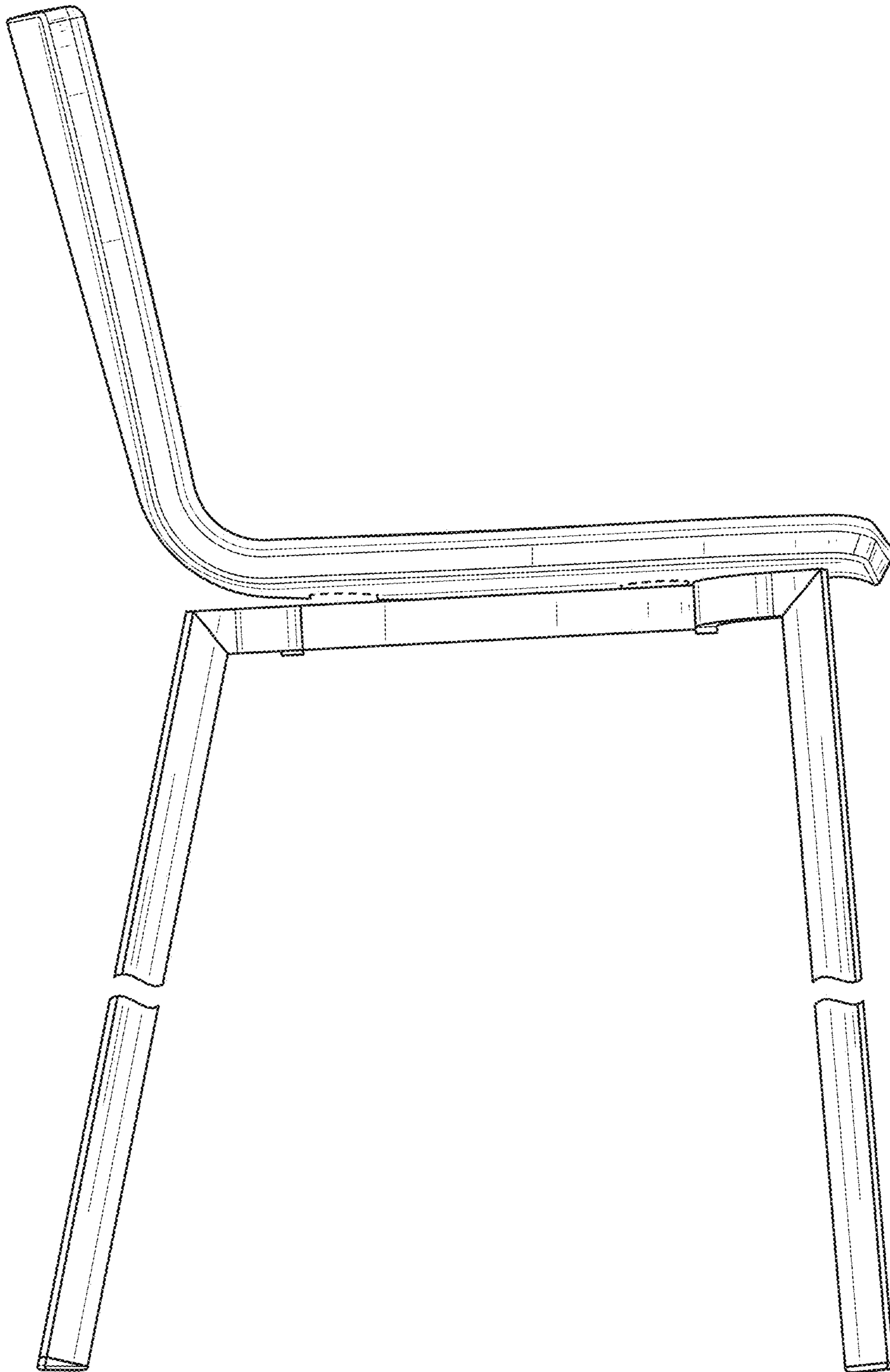

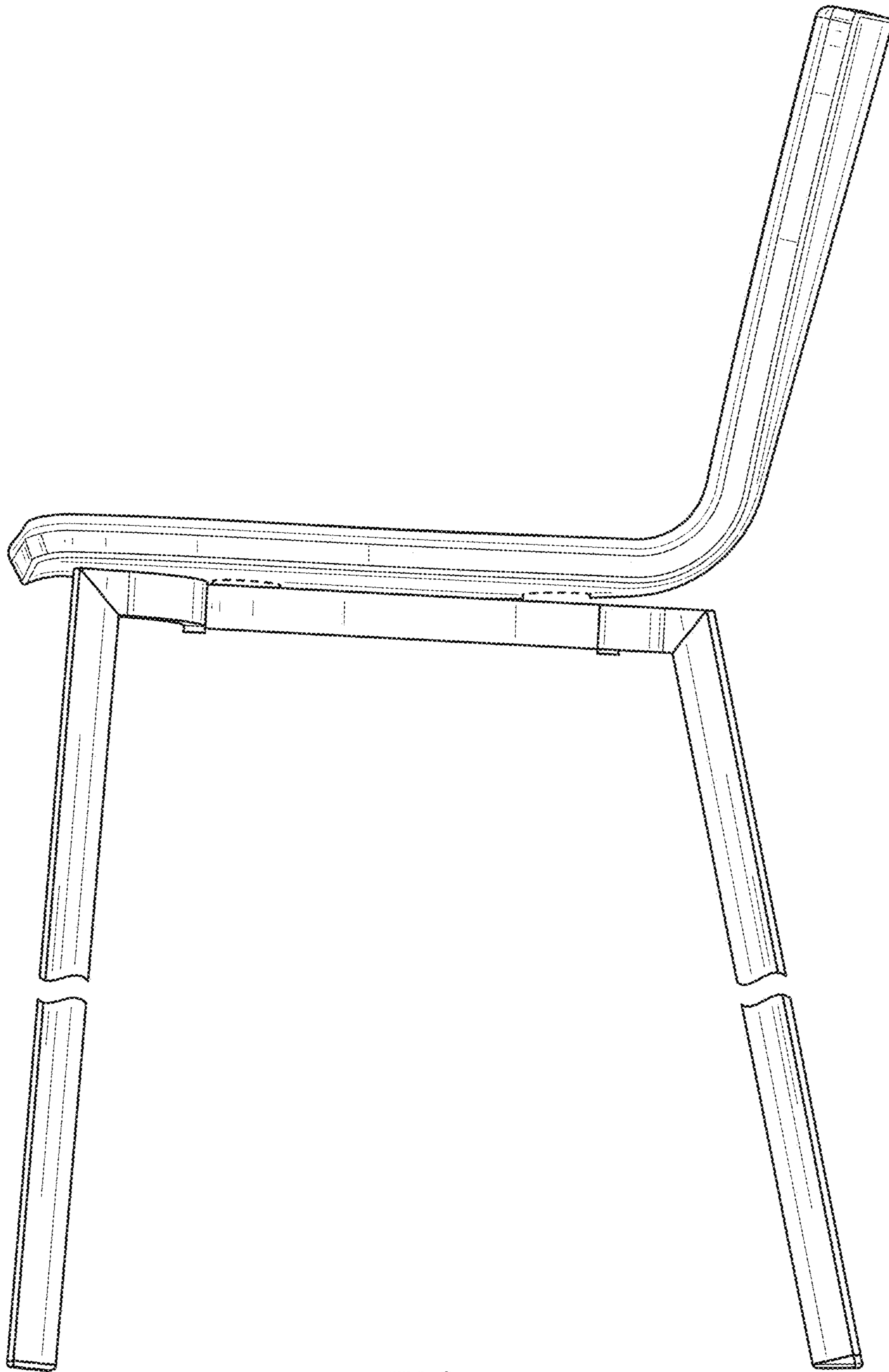

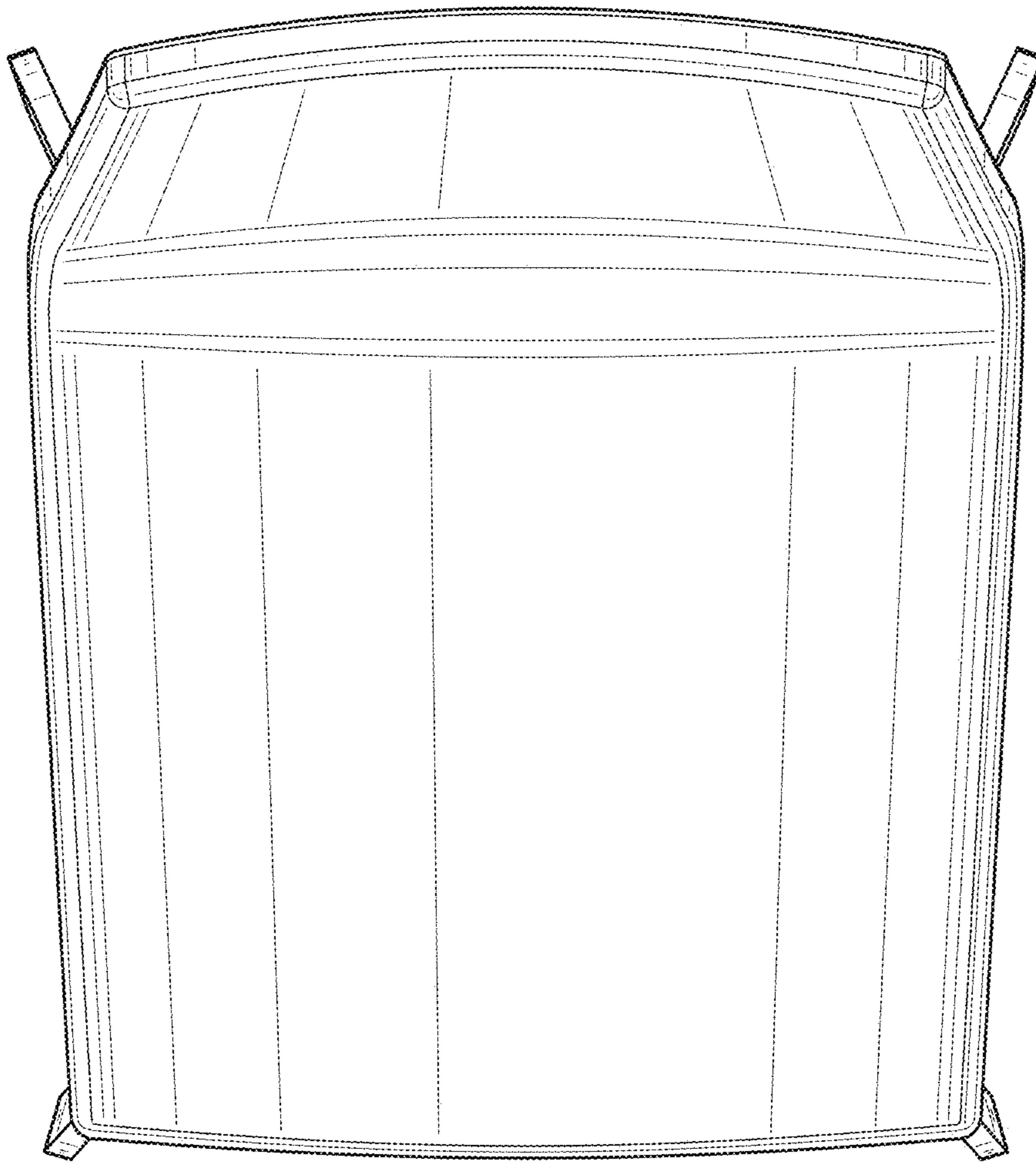

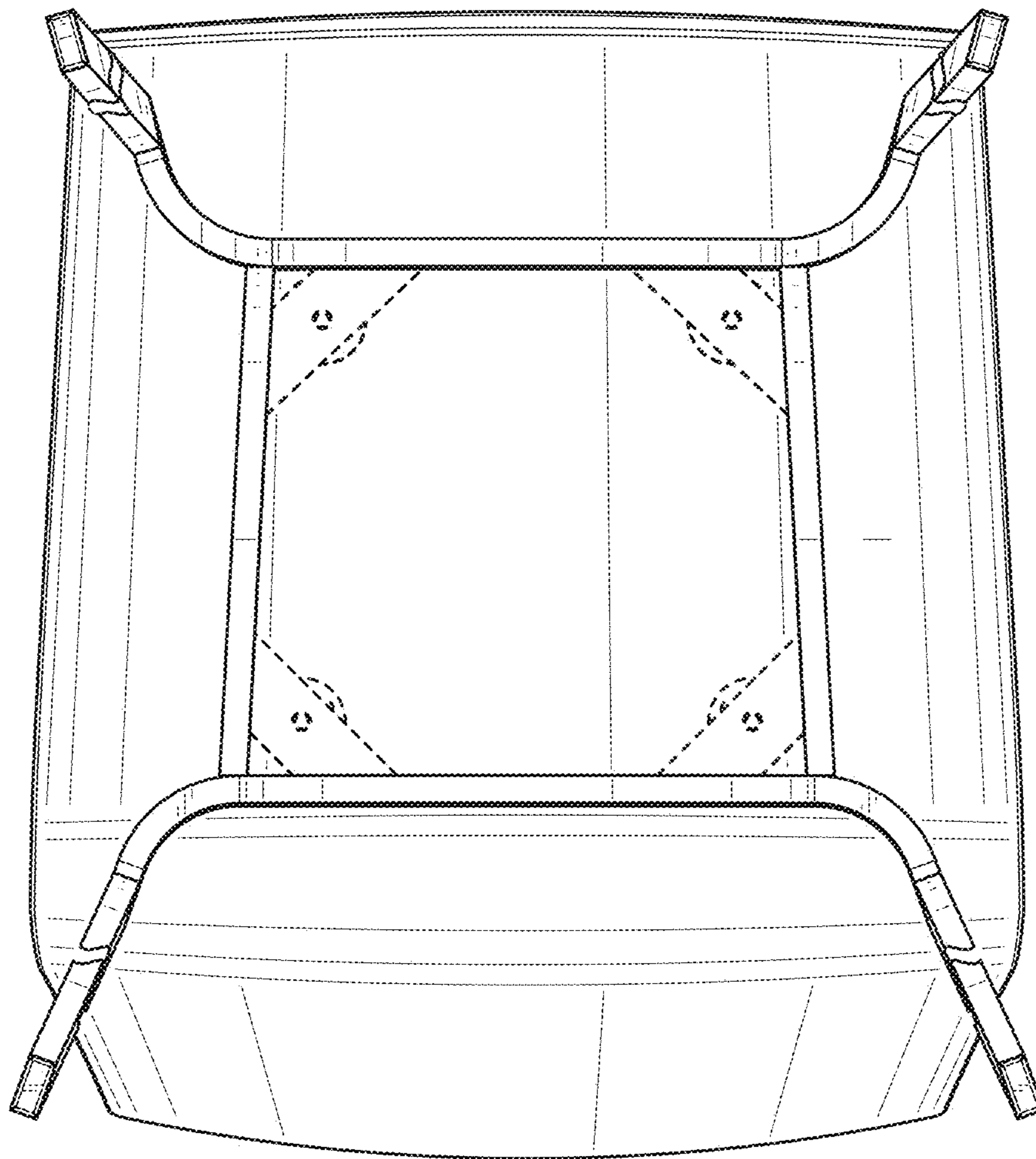
