(57) **CLAIM**

I claim the ornamental design for a multiple container package, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multiple container package in a blank, unassembled condition, according to a new design.

FIG. 2 is a top view of the multiple container package of FIG. 1.

FIG. 3 is a perspective view of the multiple container package of FIG. 1 in an assembled.

FIG. 4 is a front view of the multiple container package of FIG. 3.

FIG. 5 is a rear view of the multiple container package of FIG. 3.

FIG. 6 is a left side view of the multiple container package of FIG. 3.

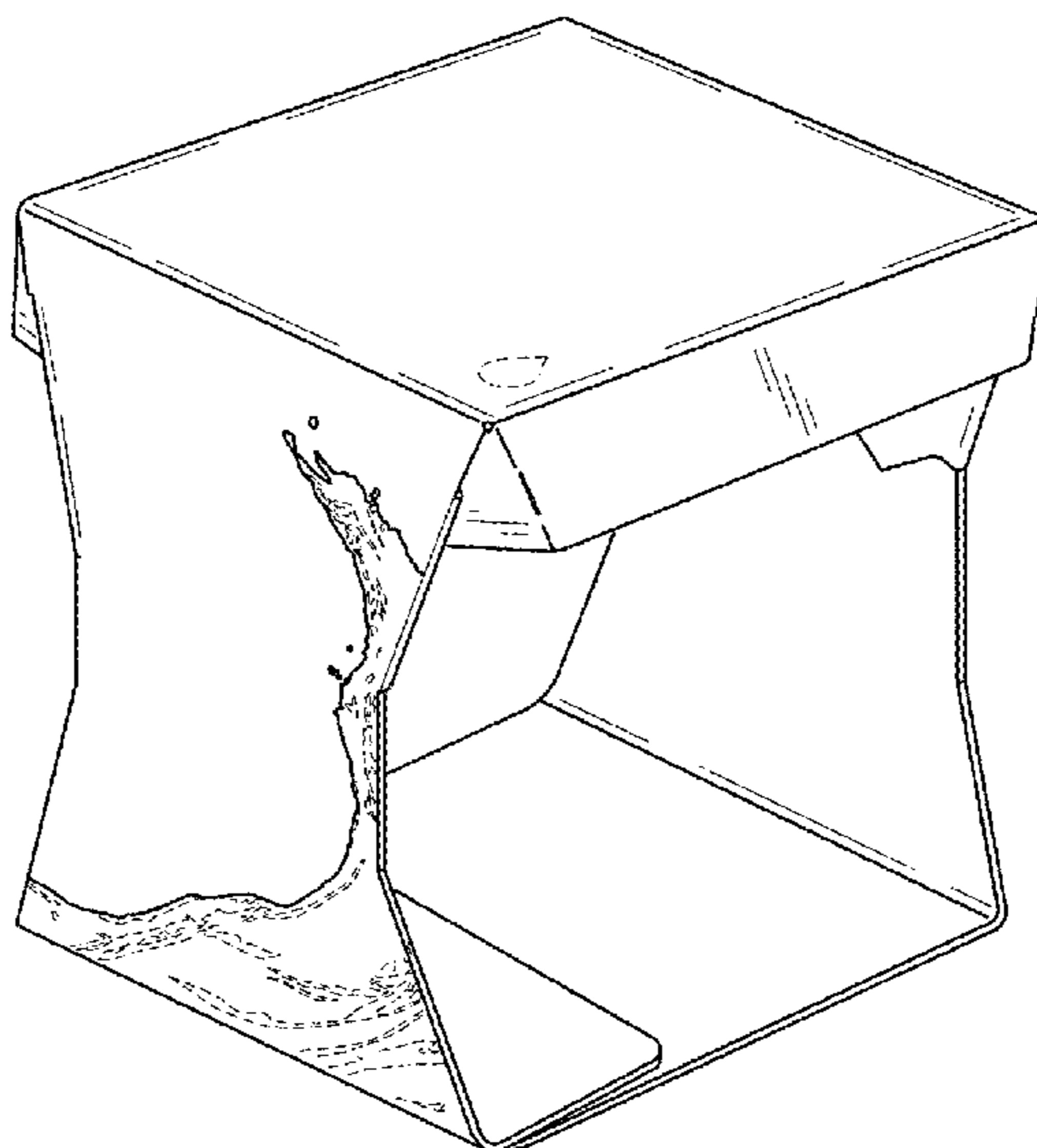
FIG. 7 is a right side view of the multiple container package of FIG. 3.

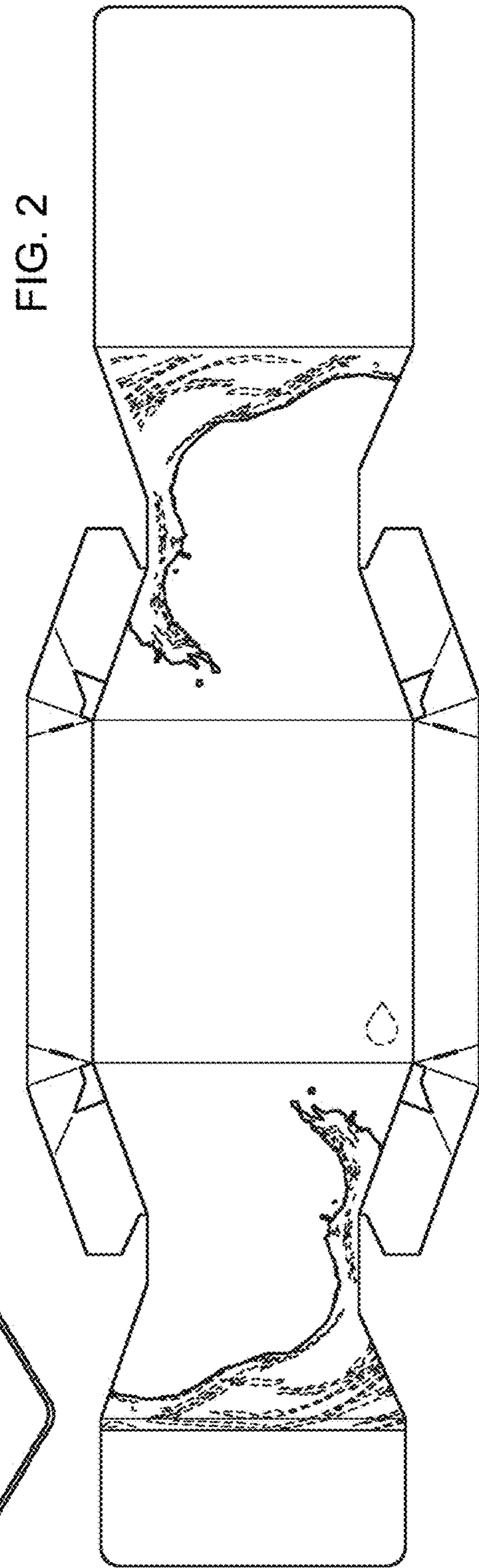
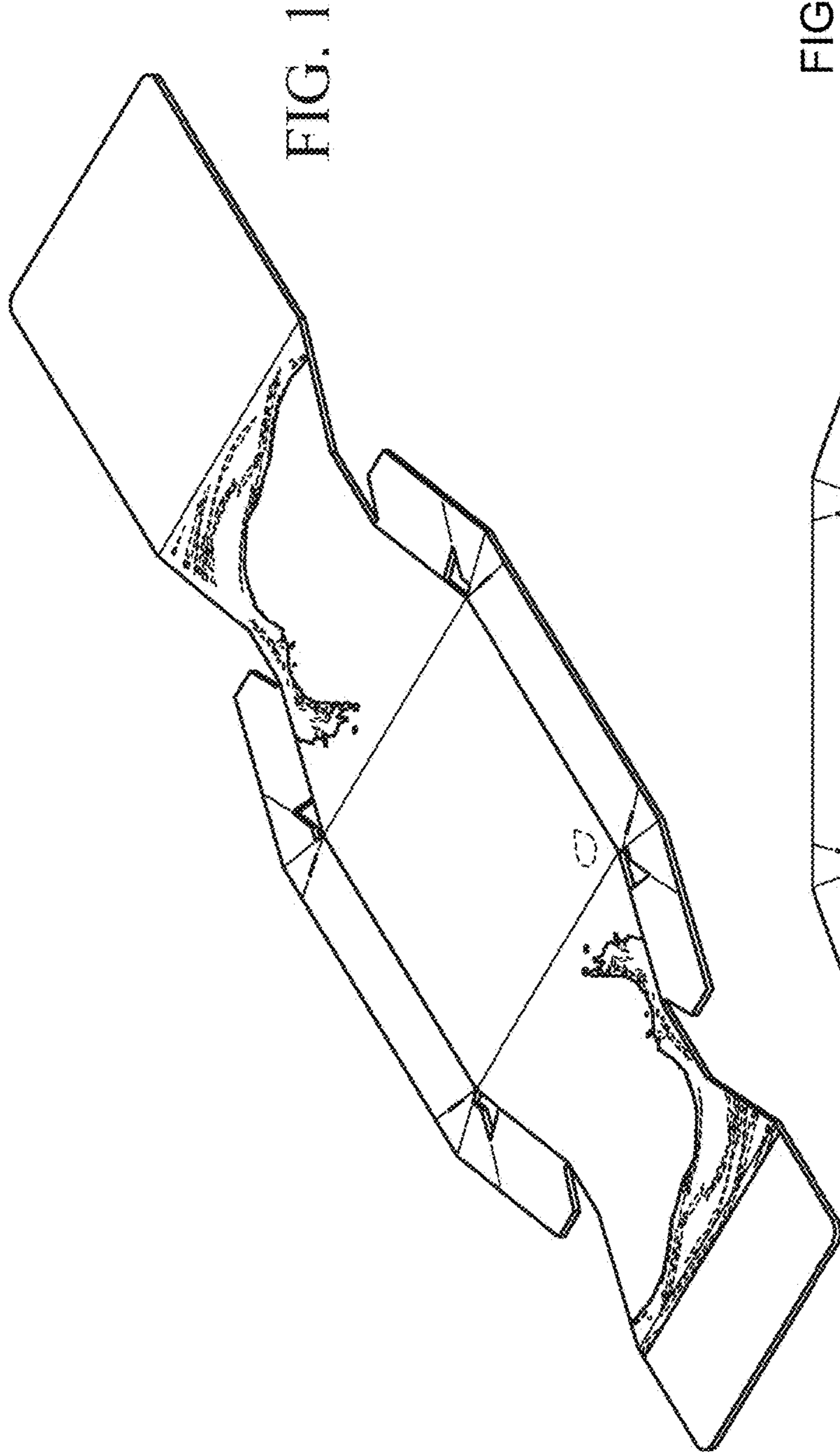

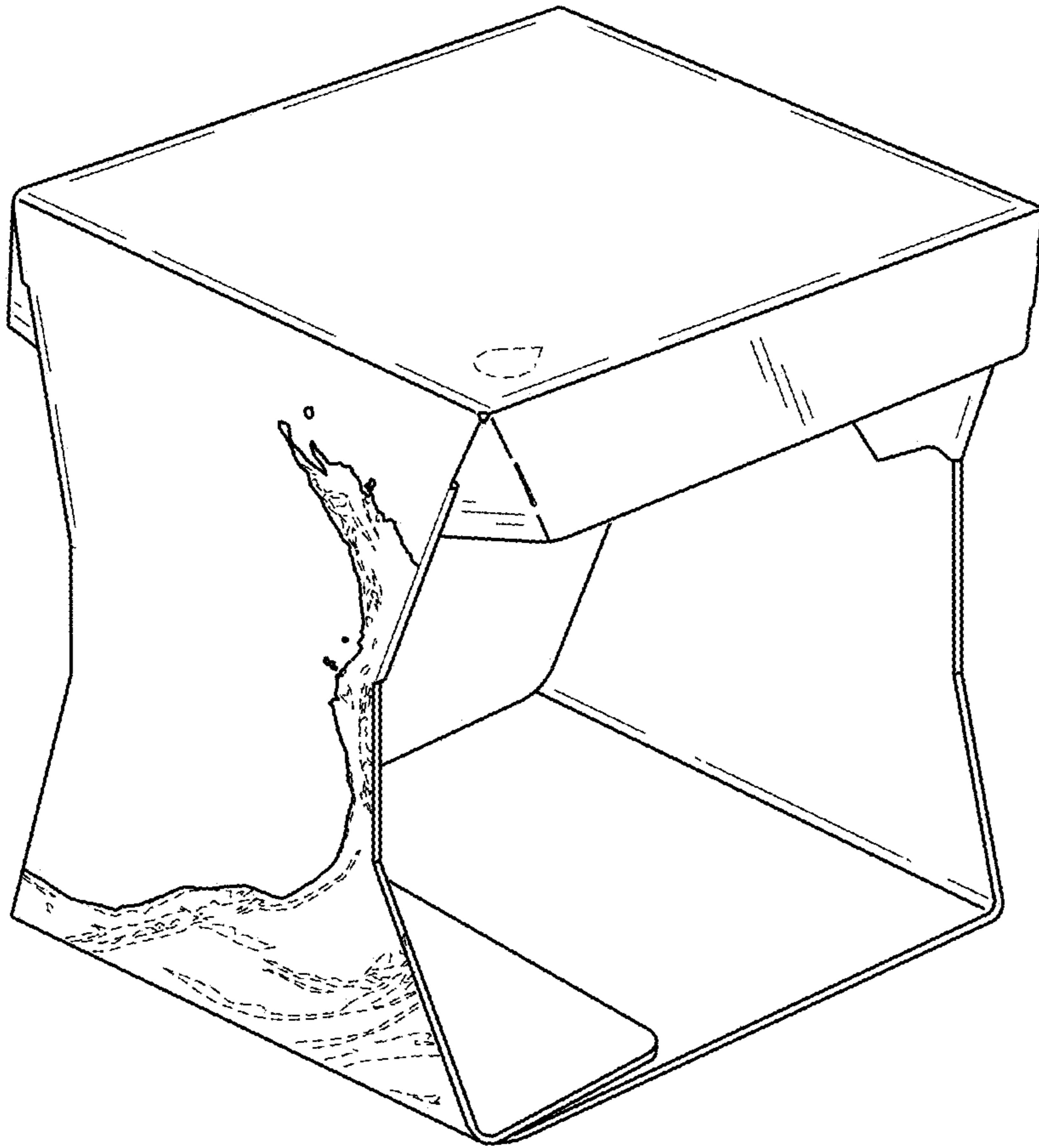

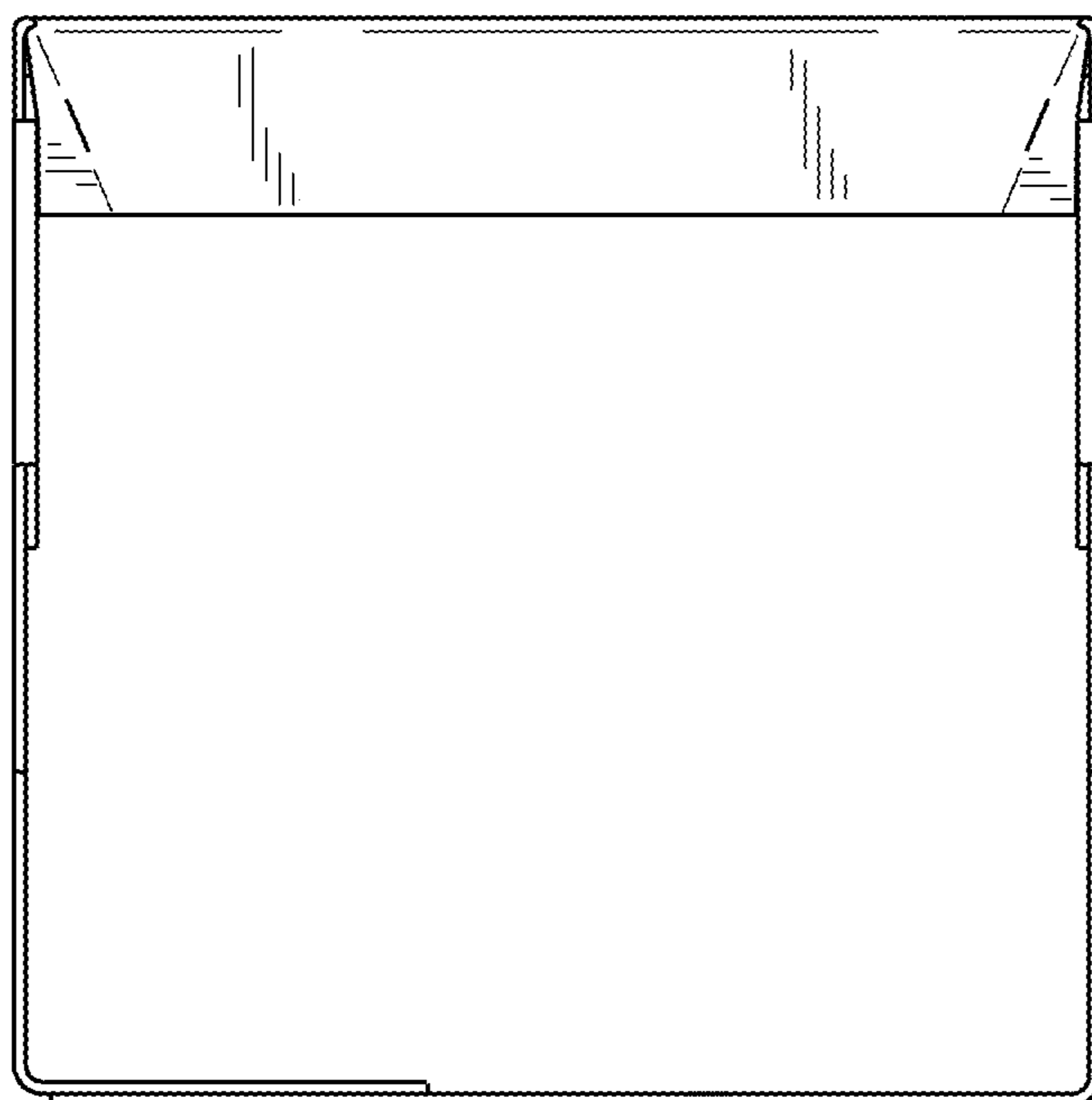

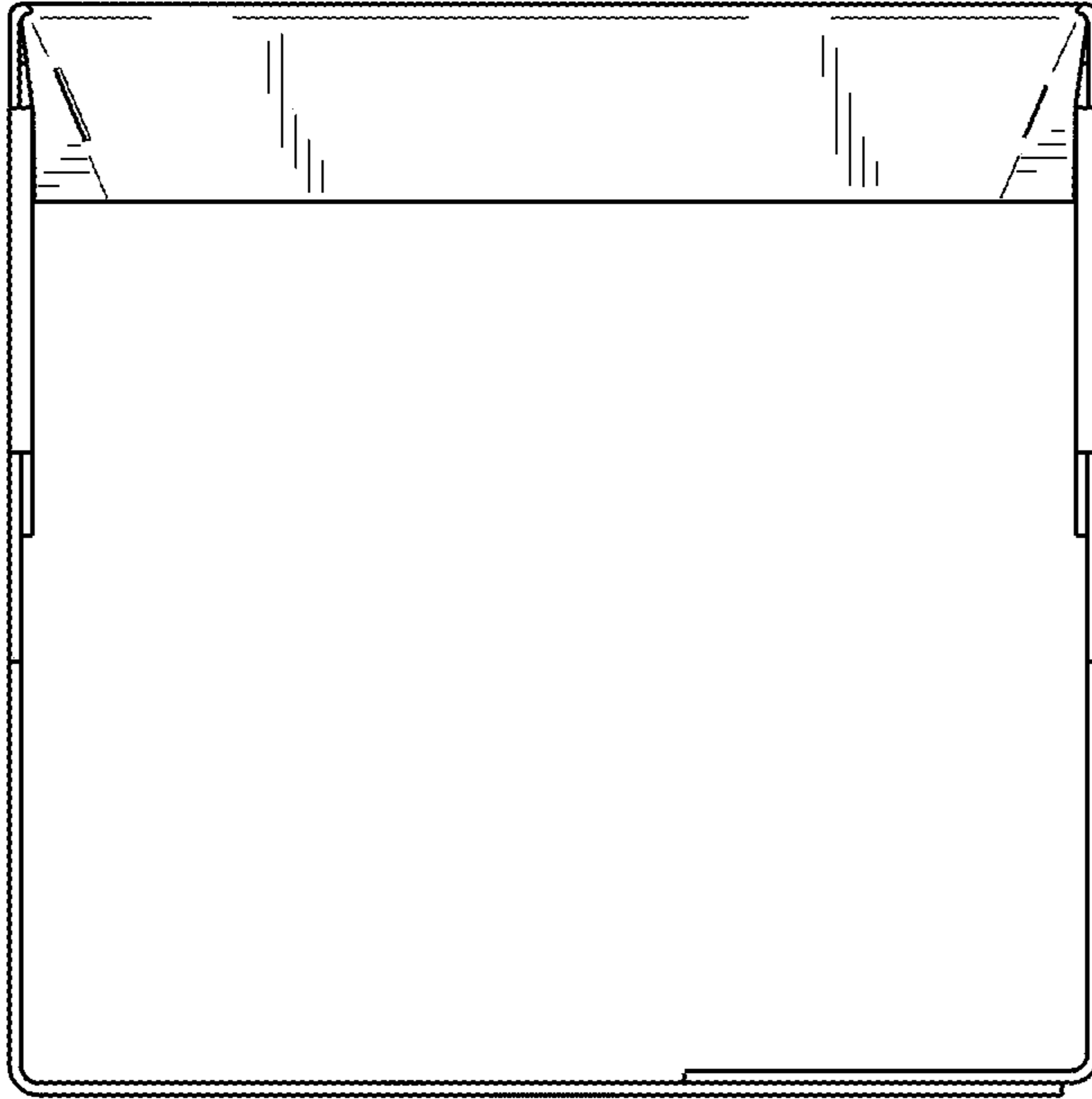

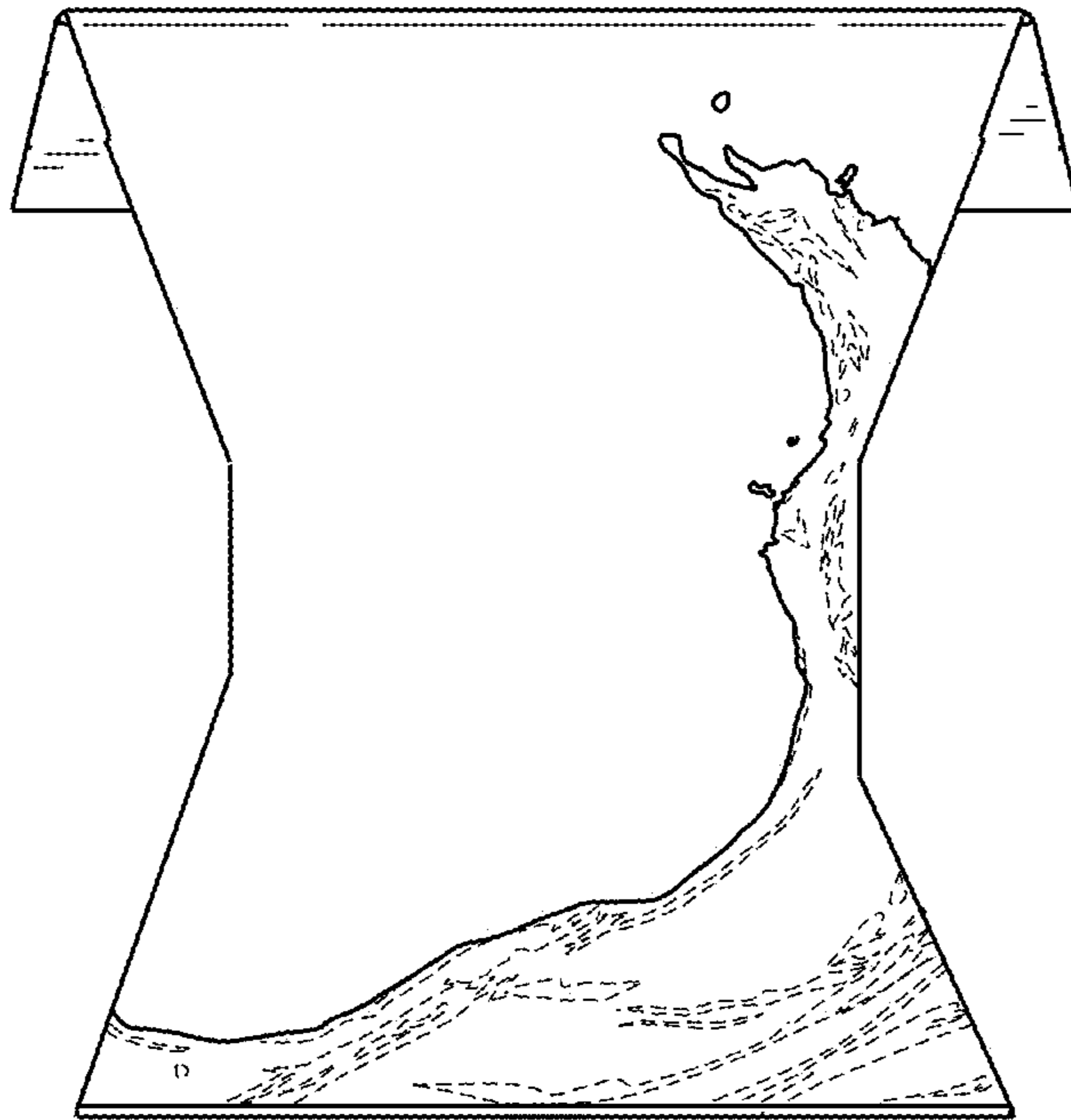

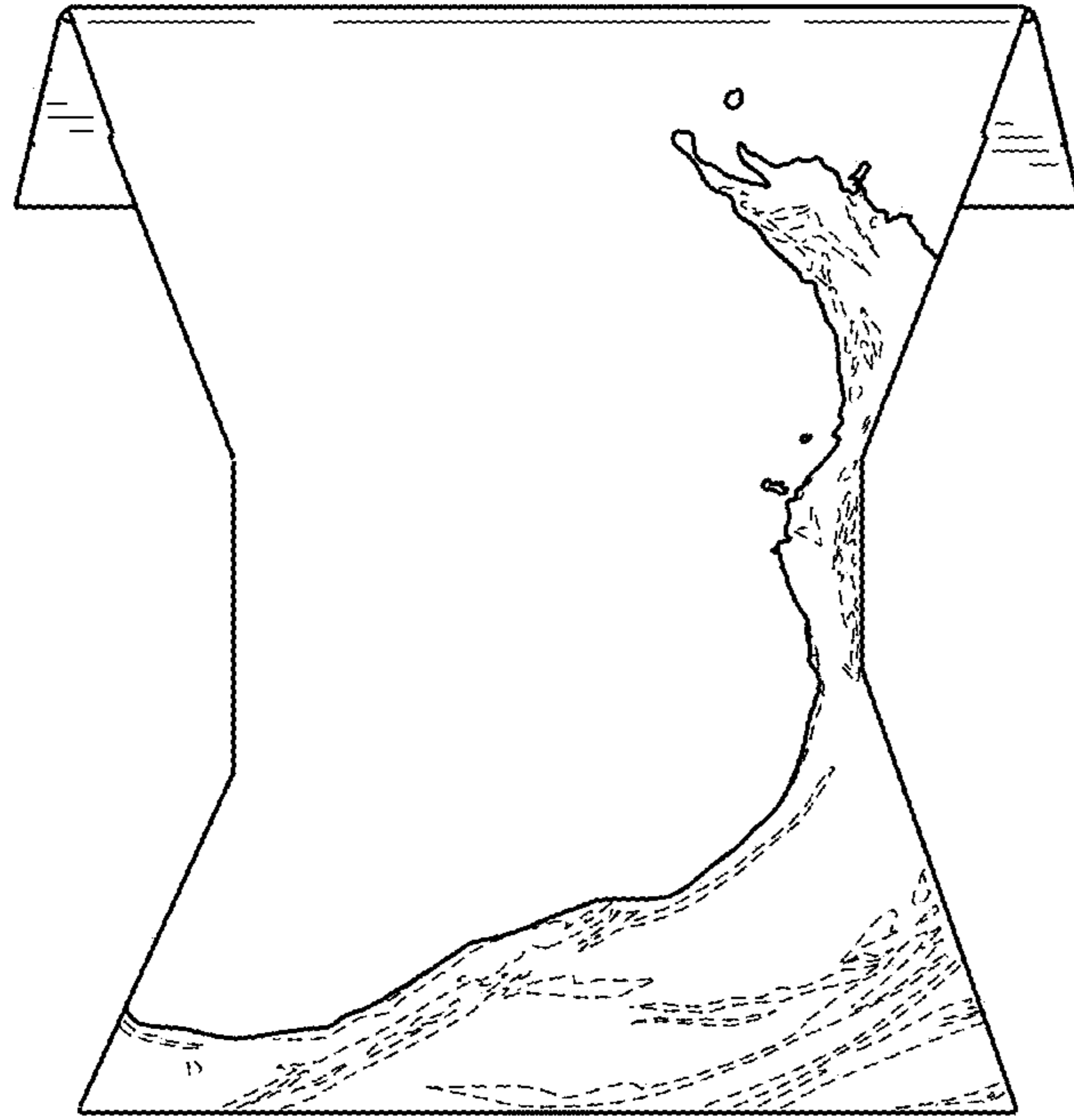

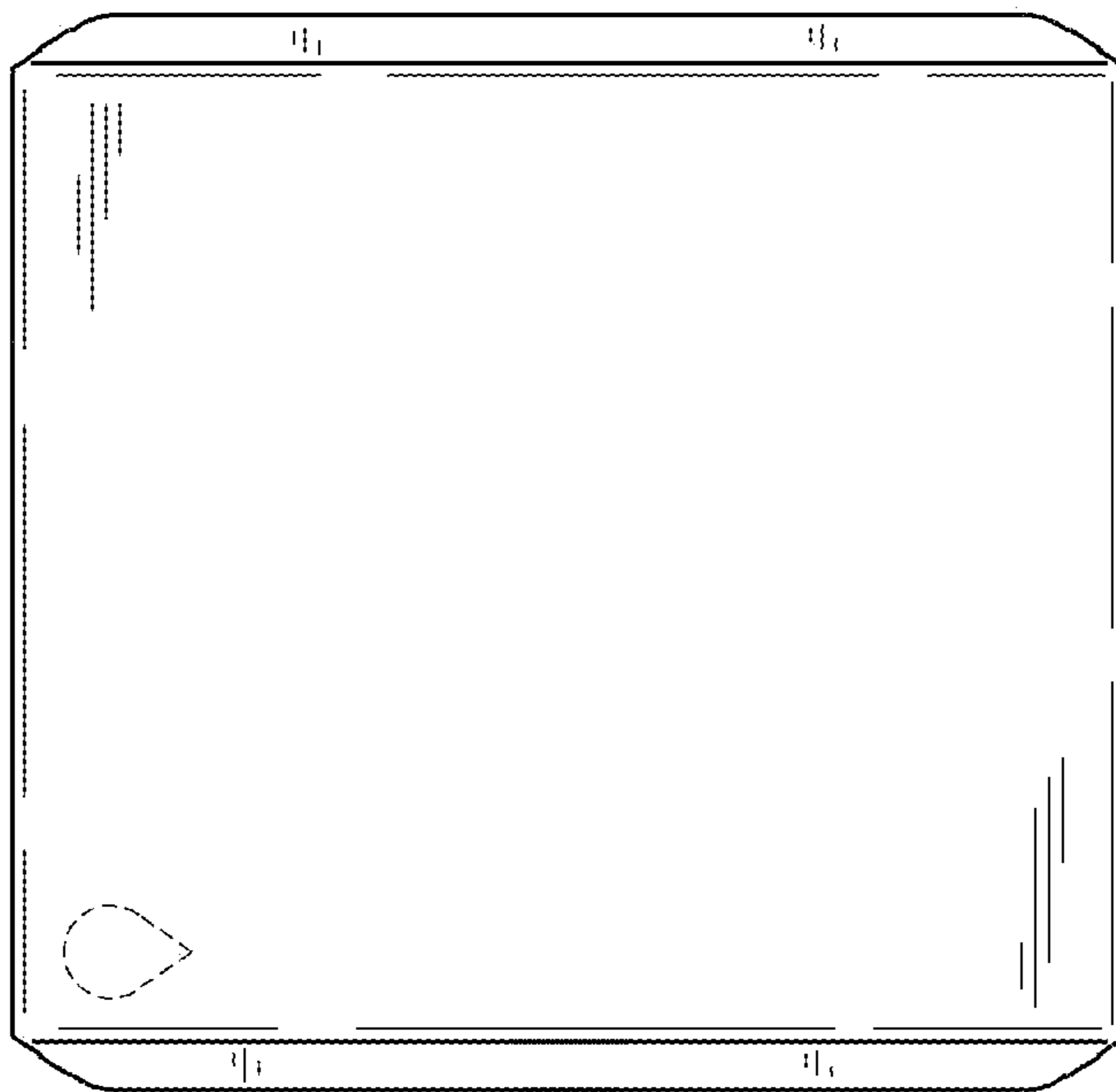

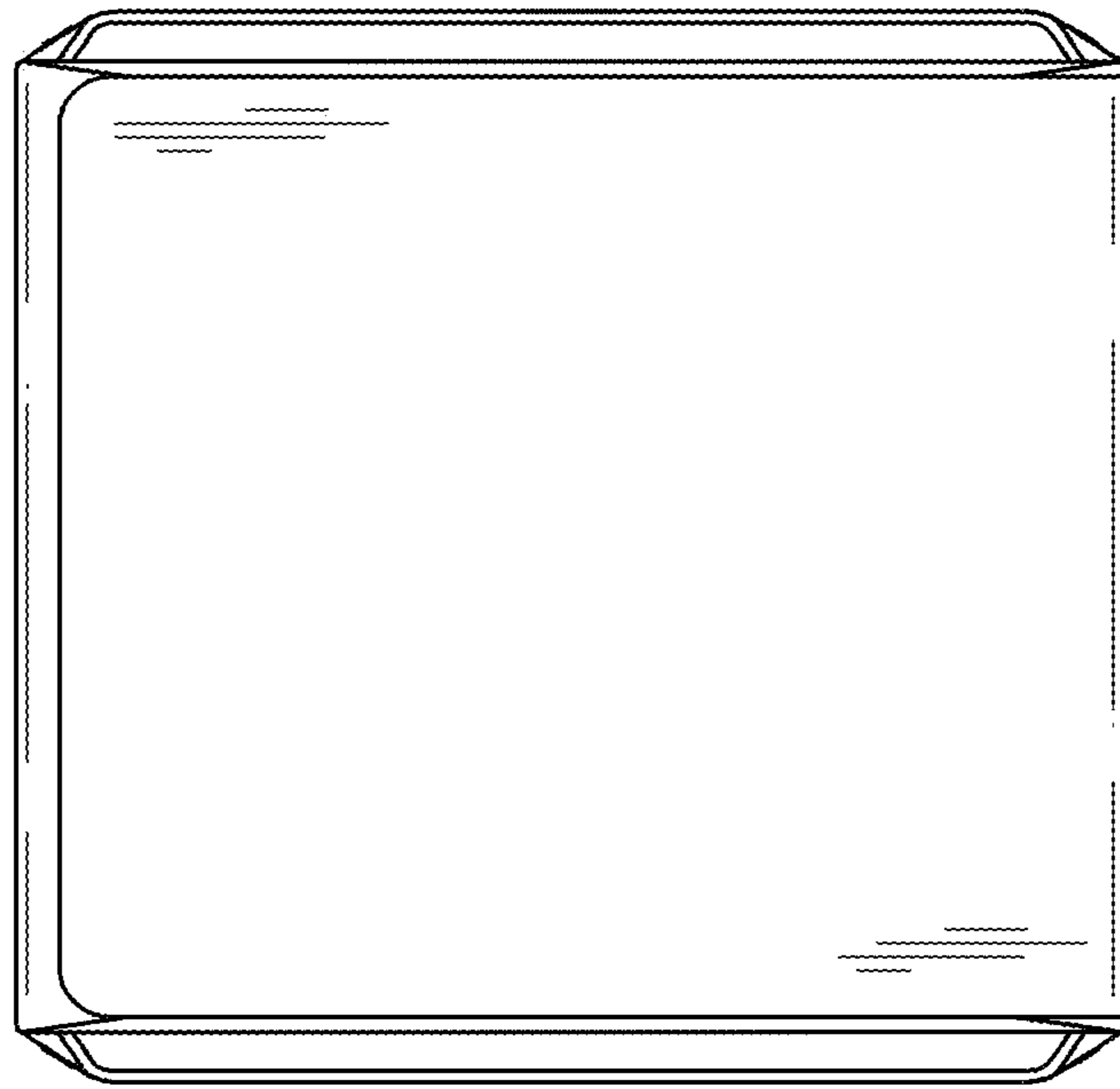
