(57) **CLAIM**

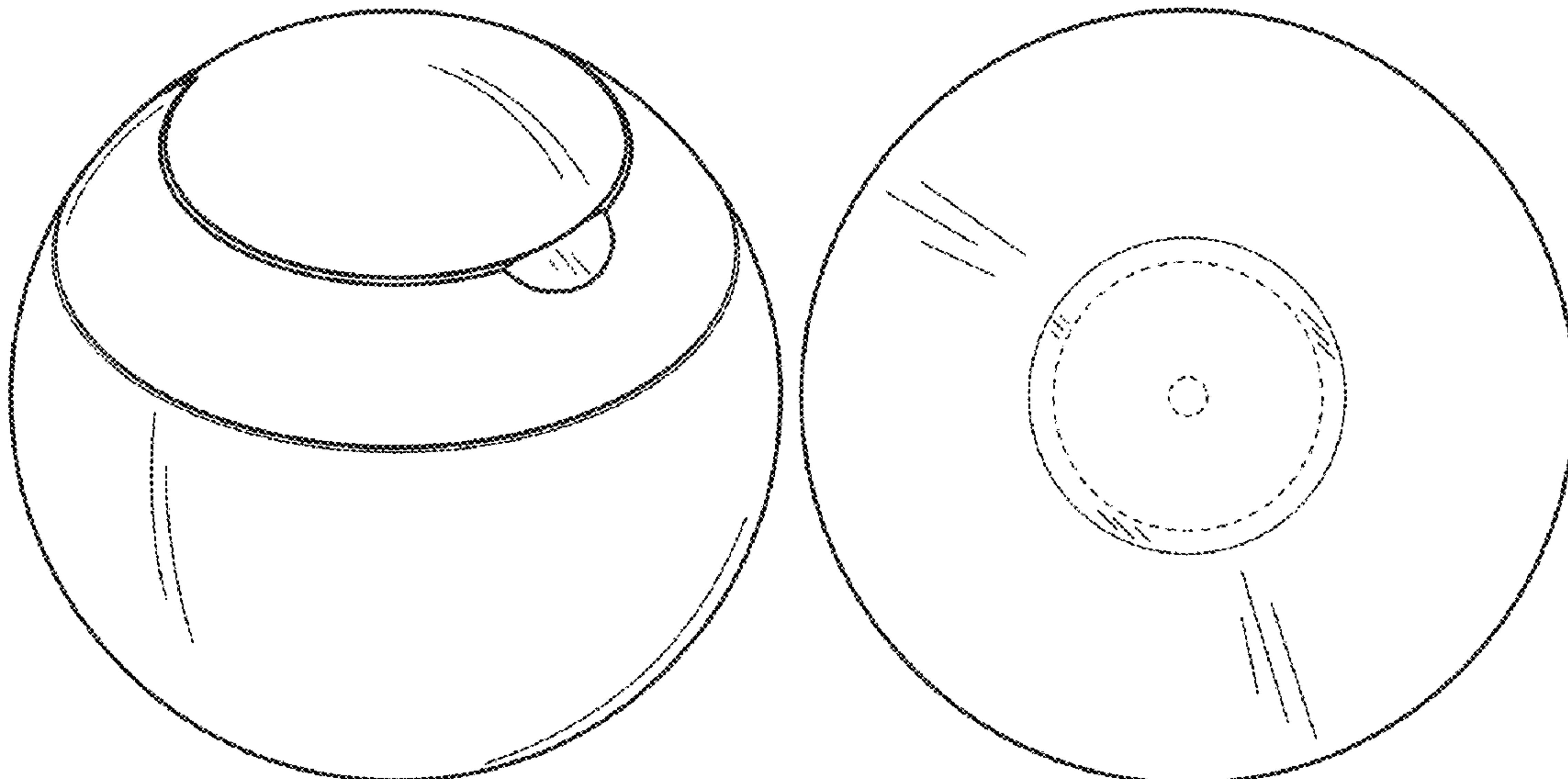
I claim the ornamental design for the spherical bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a spherical bottle; FIG. 2 is a front view of the spherical bottle shown in FIG. 1; FIG. 3 is a top view of the spherical bottle shown in FIG. 1; and, FIG. 4 is a bottom view of the spherical bottle shown in FIG. 1.

The broken lines in the drawings showing the spherical bottle illustrate the portions of the spherical bottle that form no part of the claimed design.

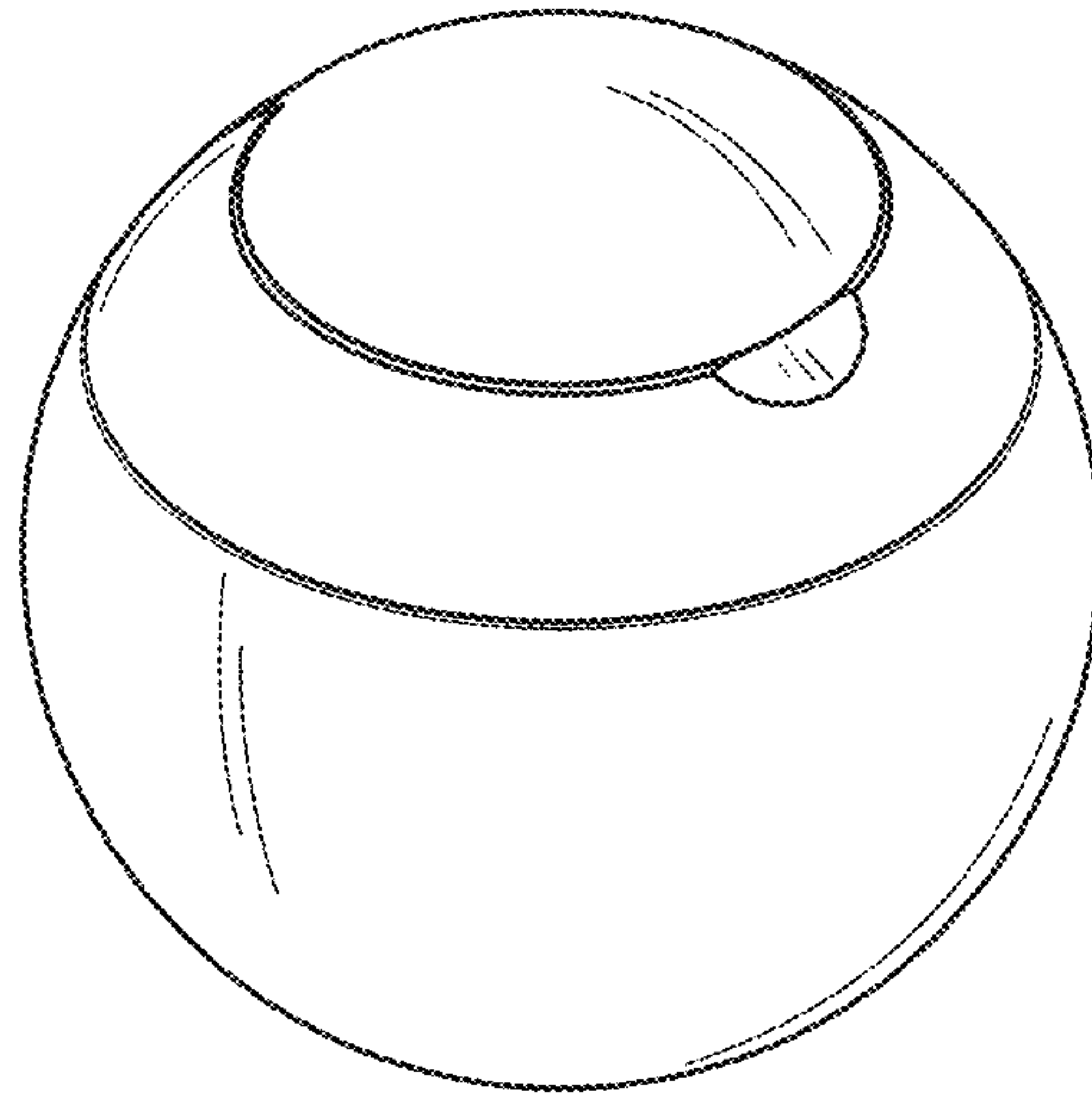

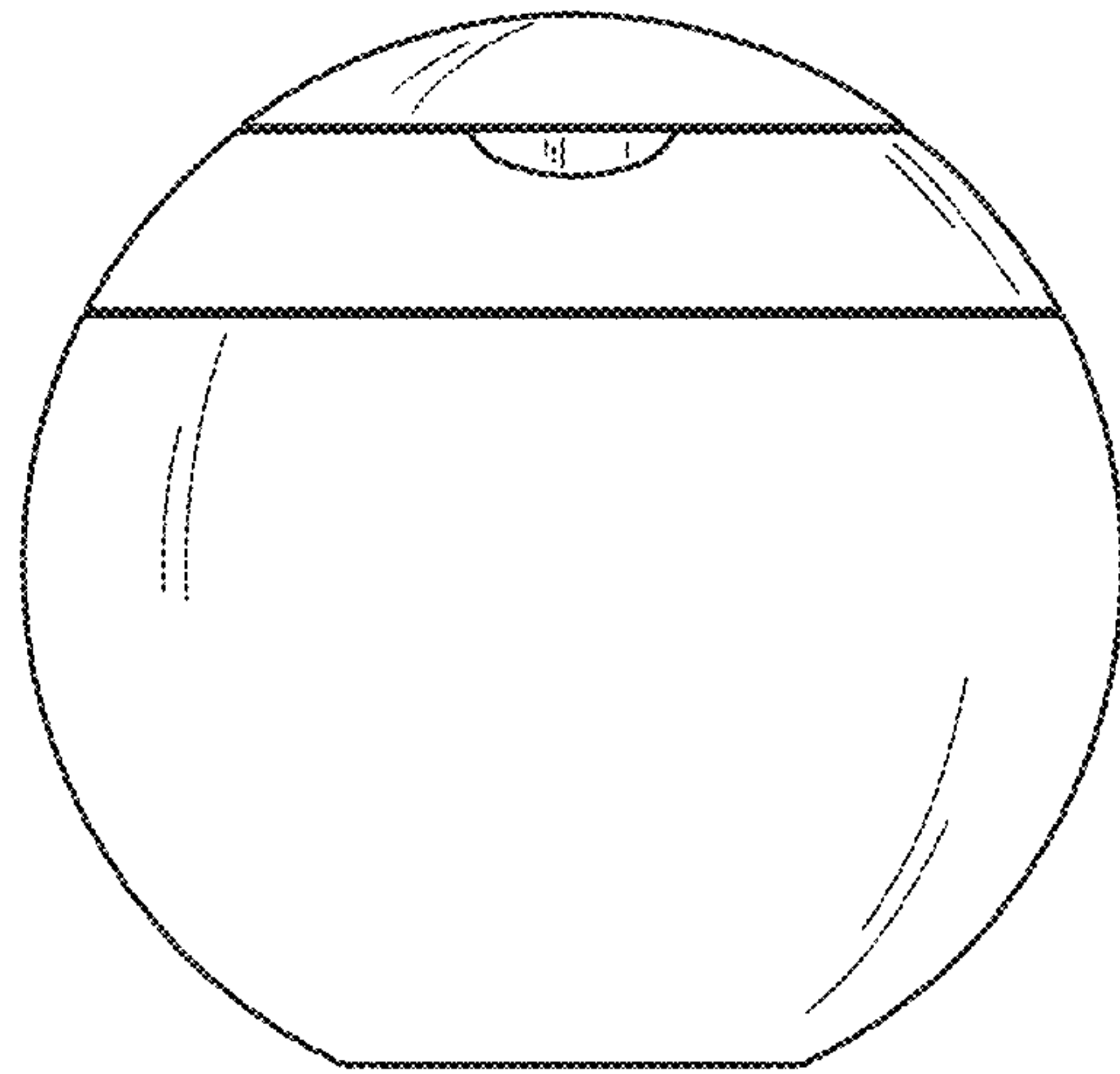

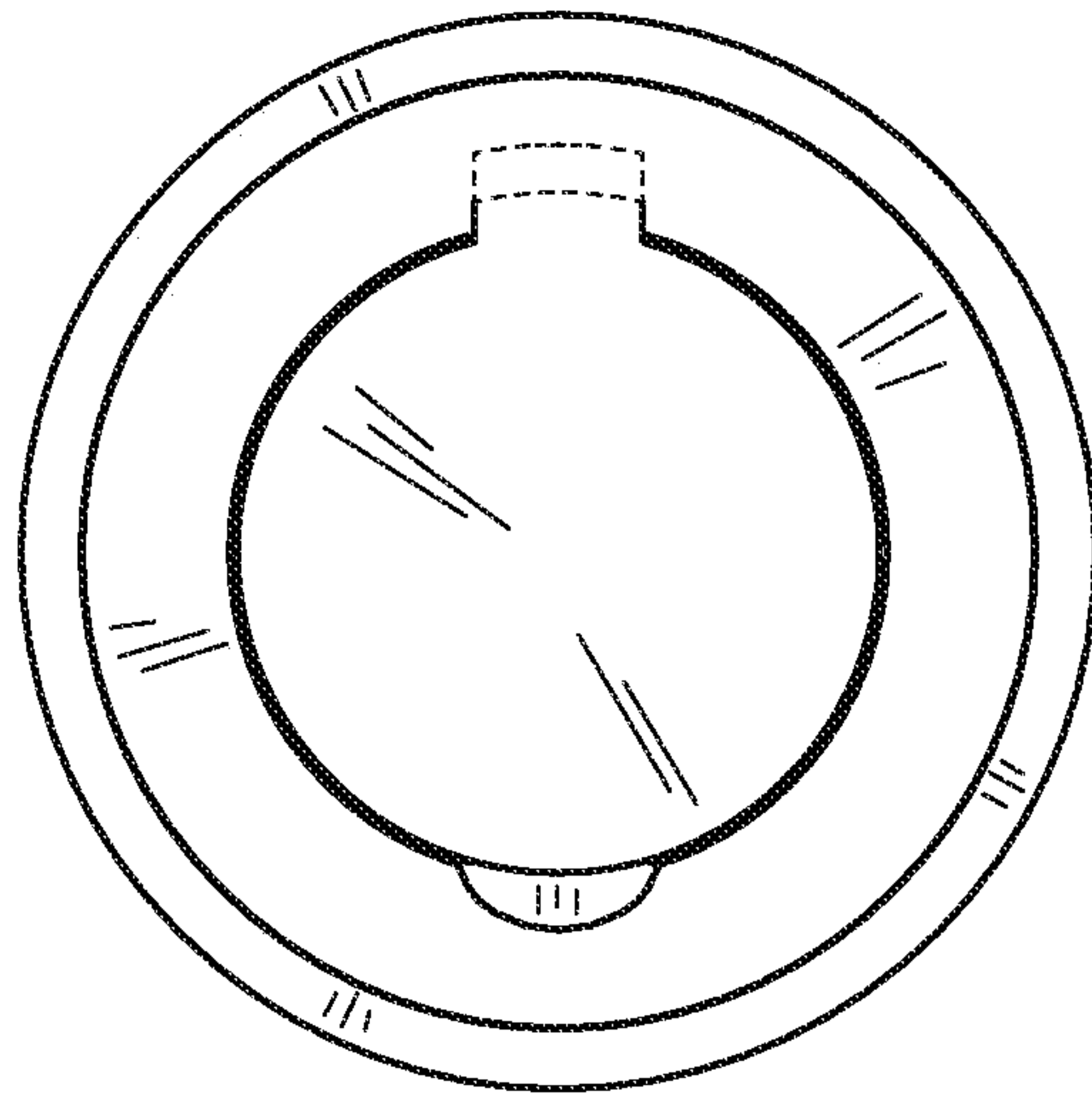

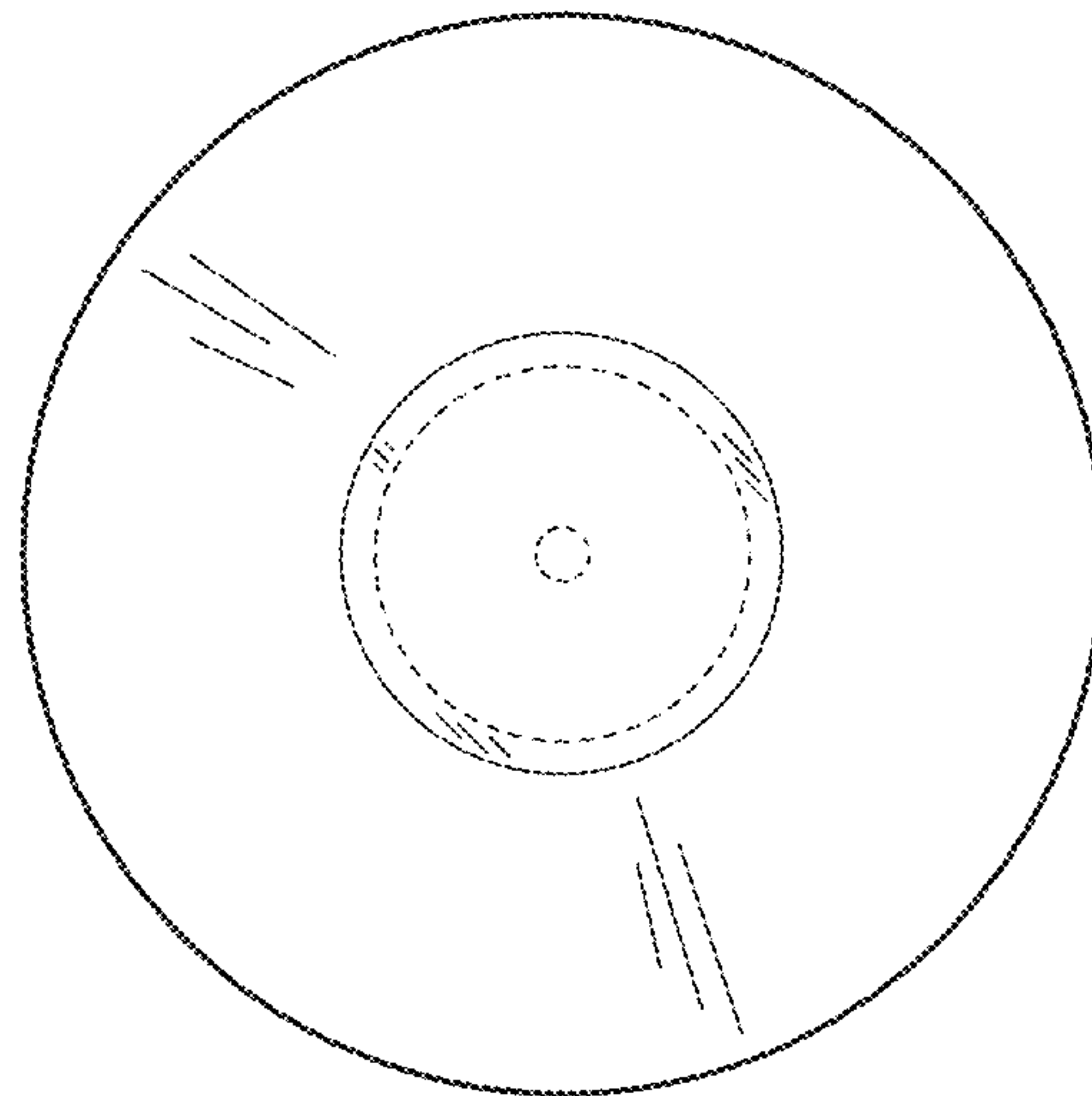
