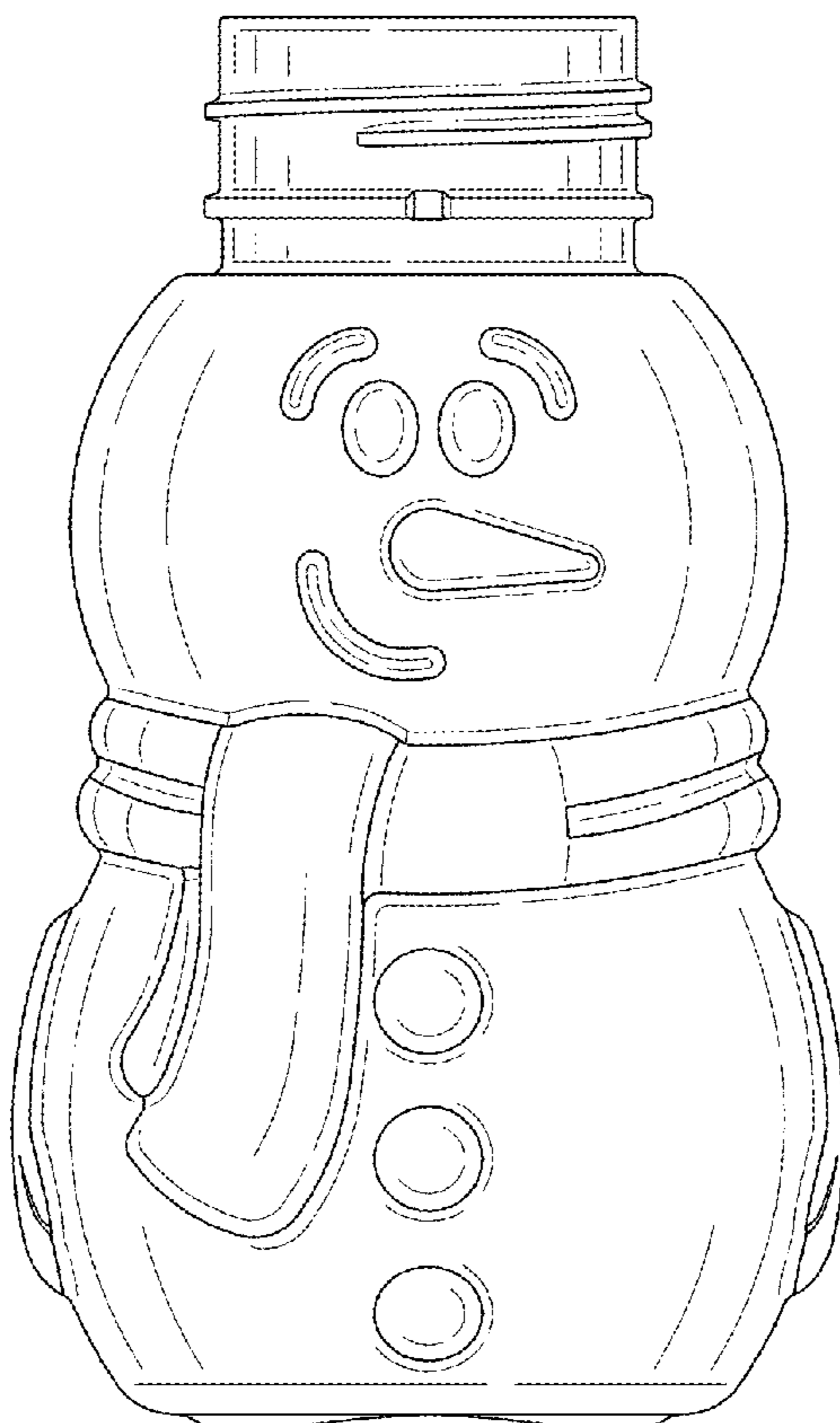

DESCRIPTION

FIG. 1 is a top, front and left side isometric view of a bottle with snowman shape showing my new design;

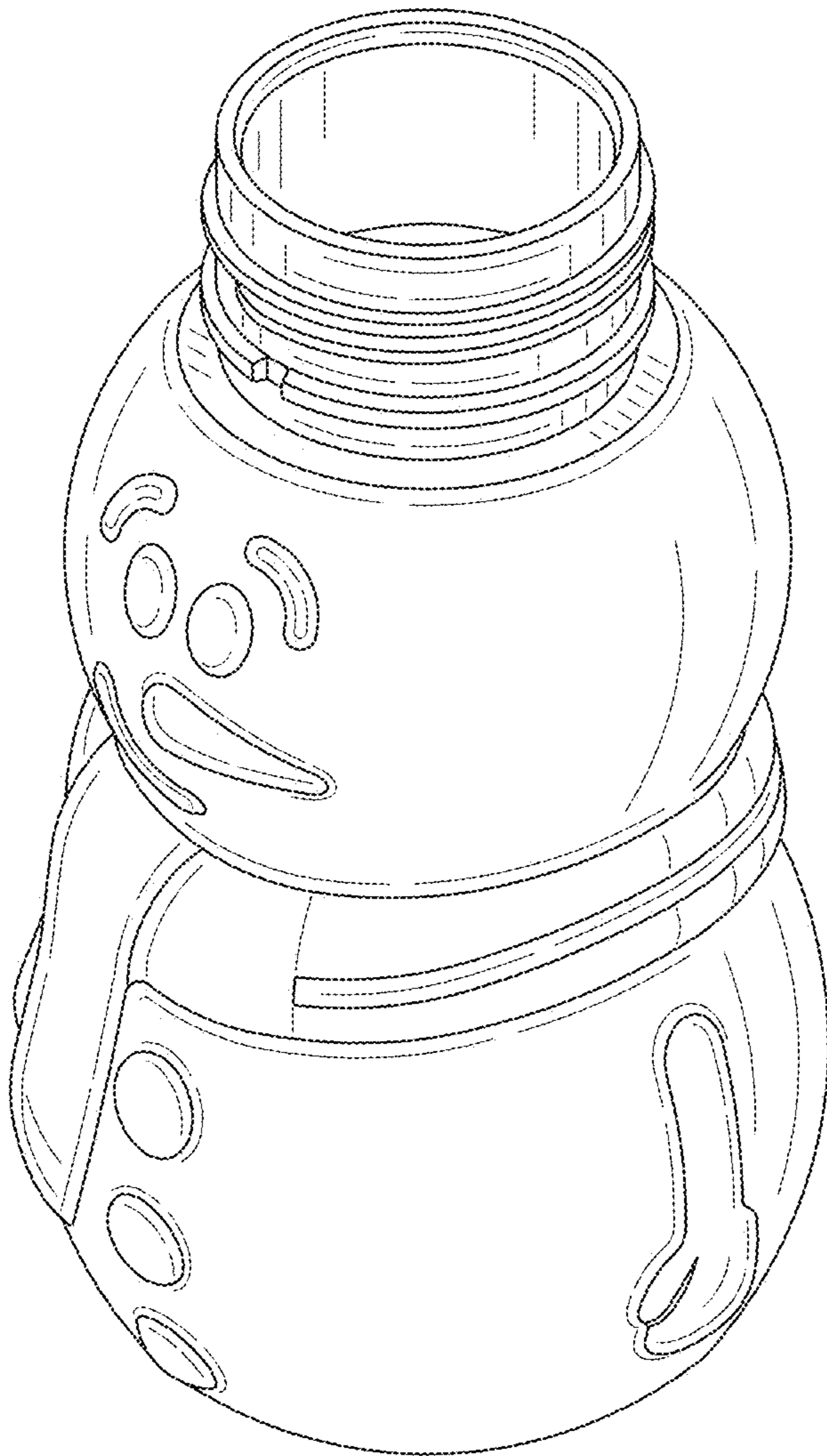
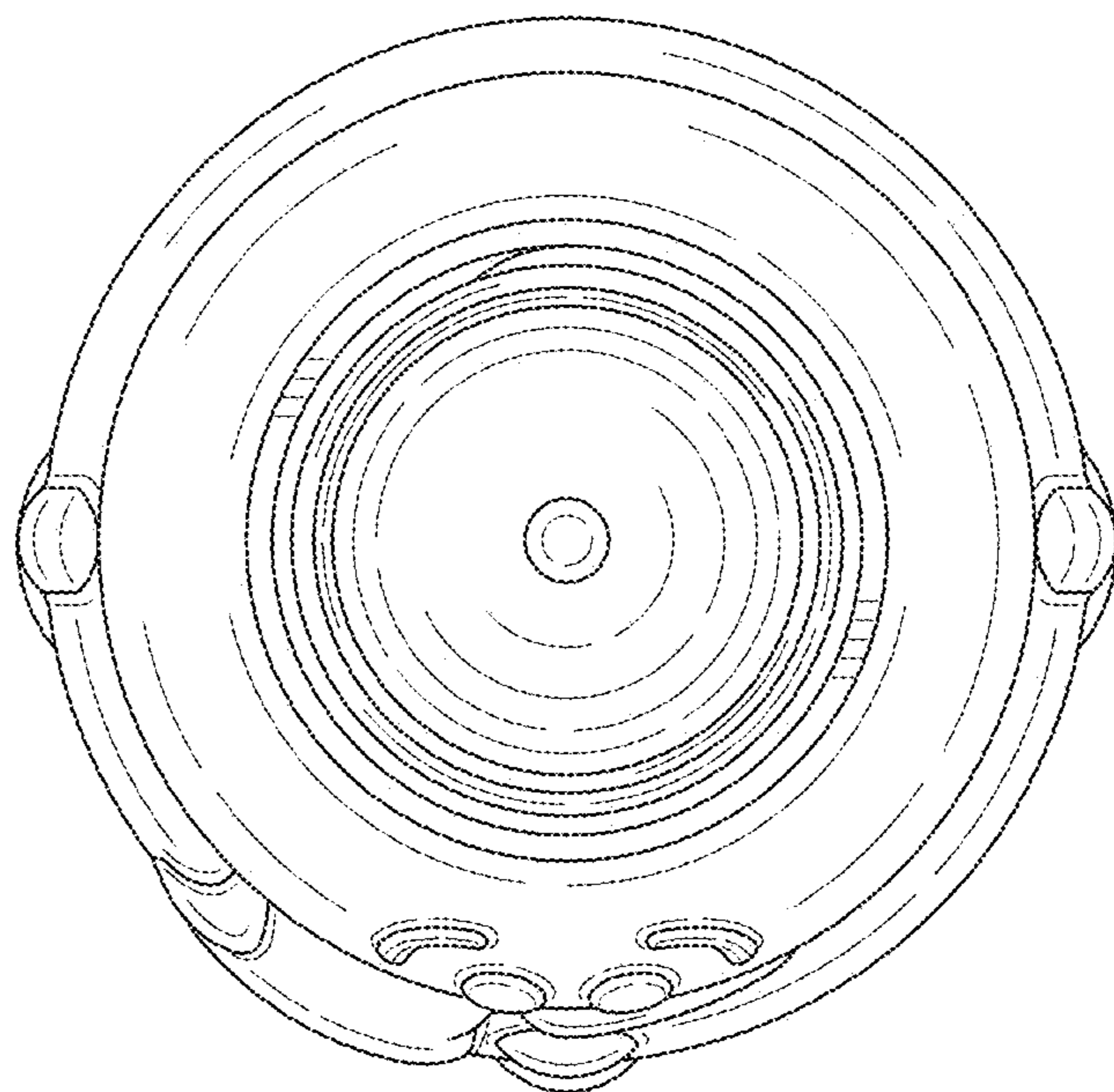

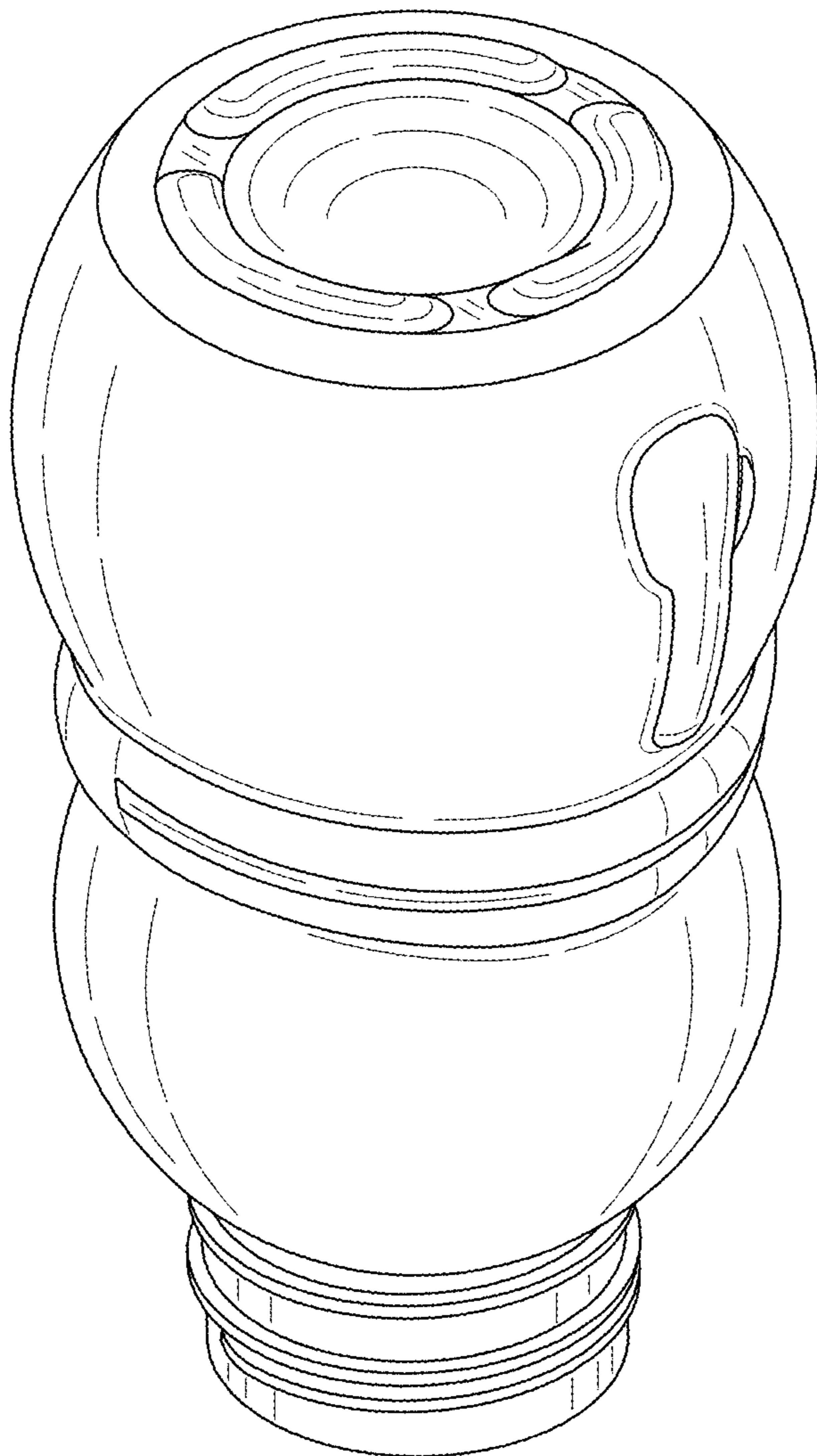
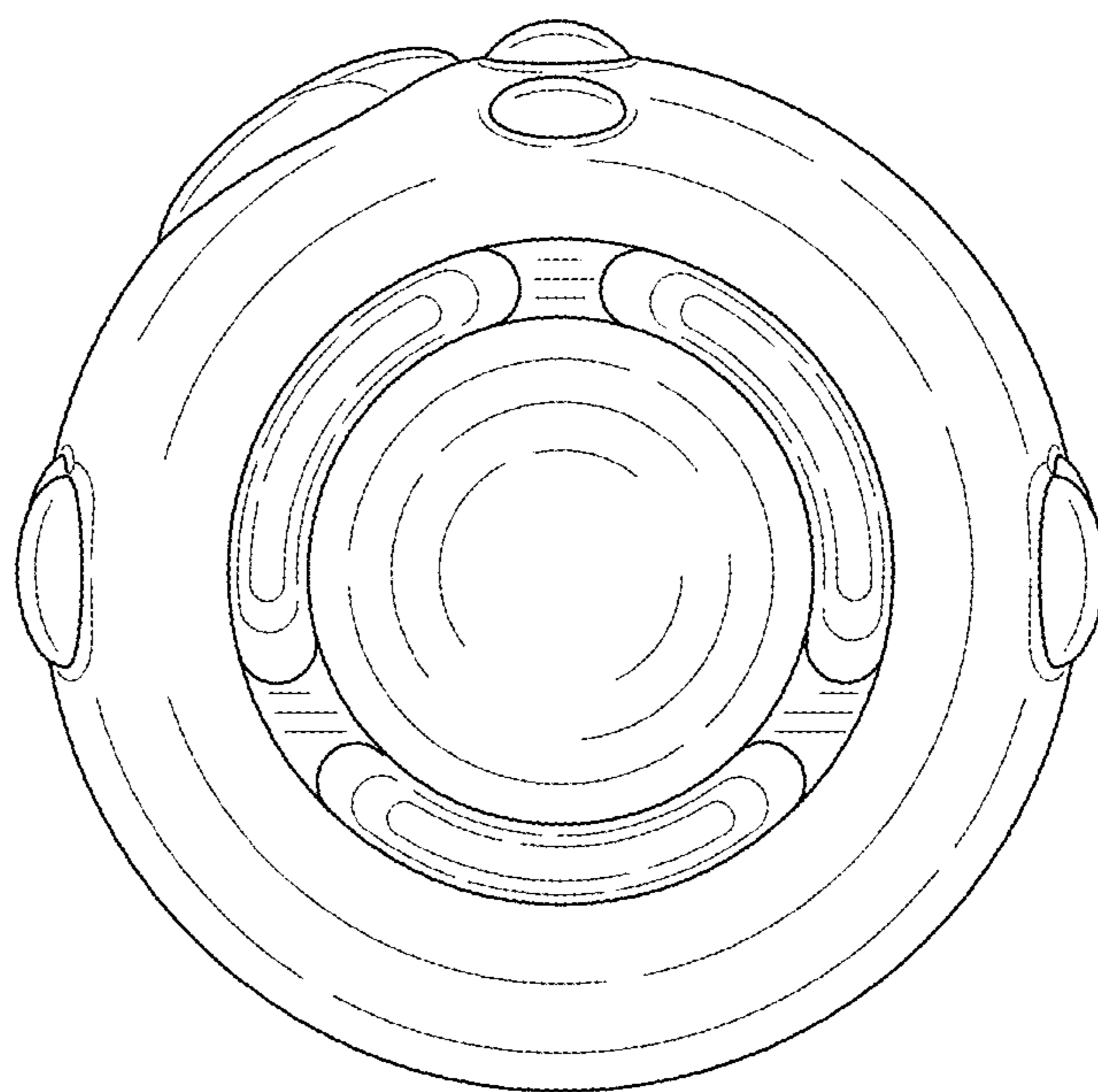

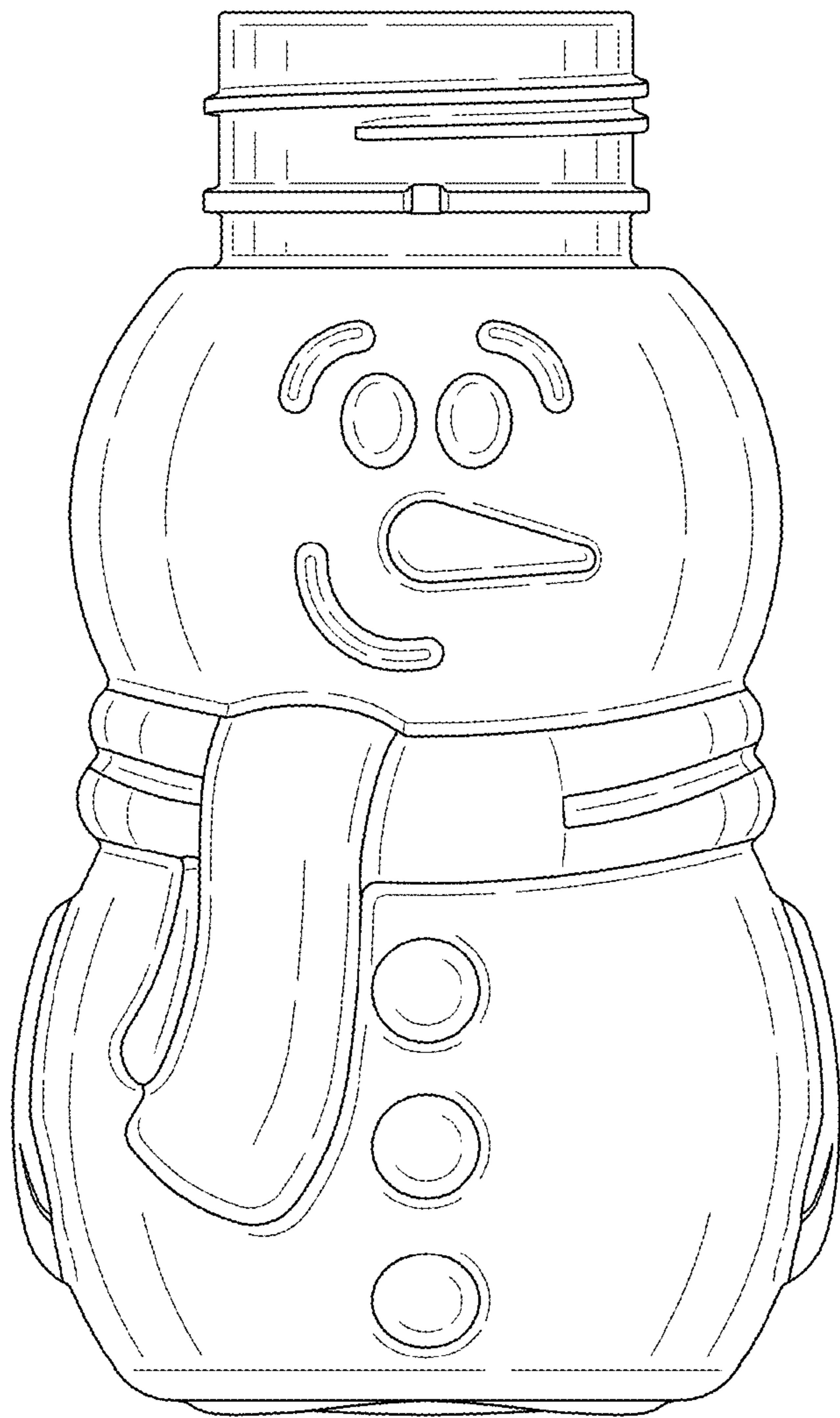

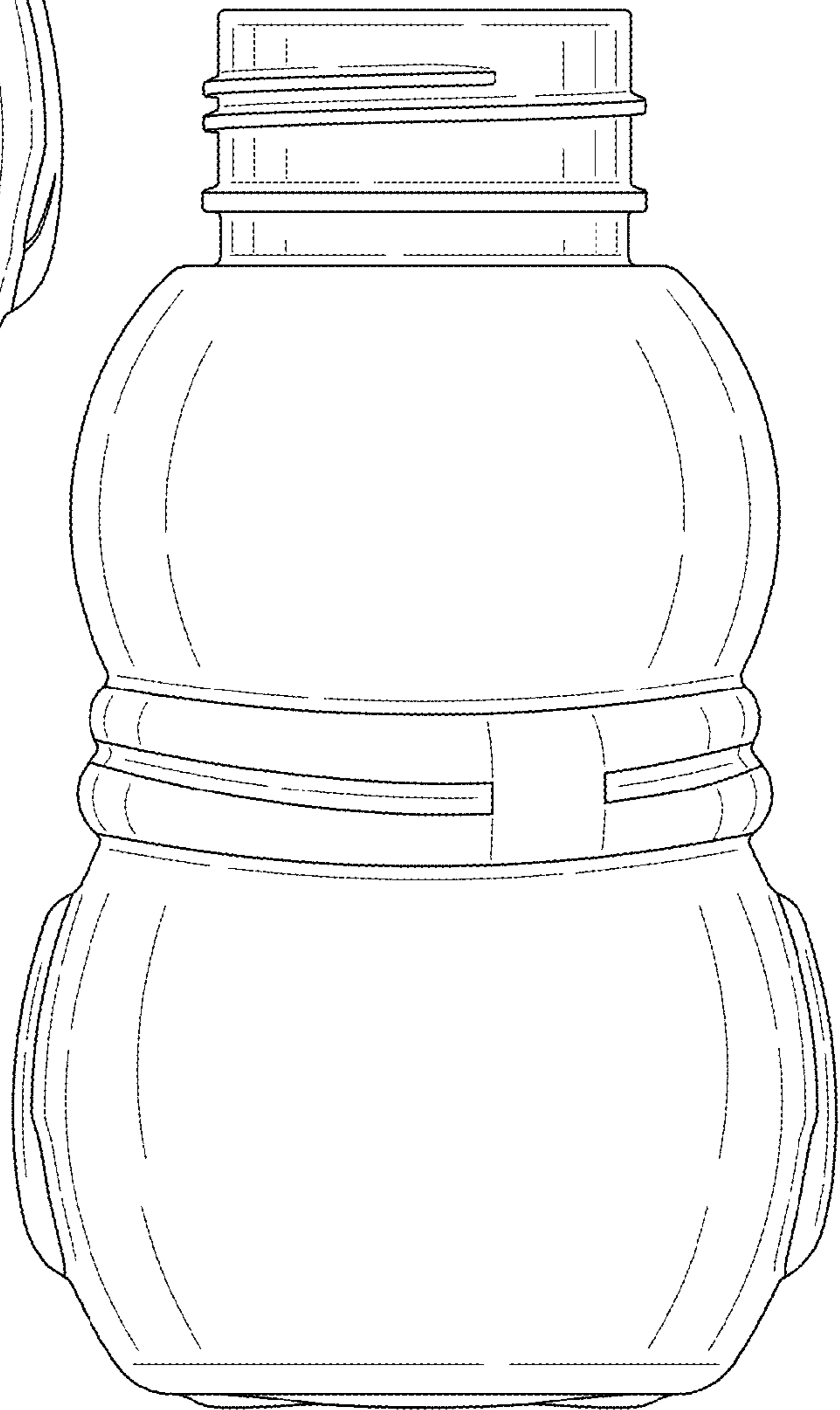

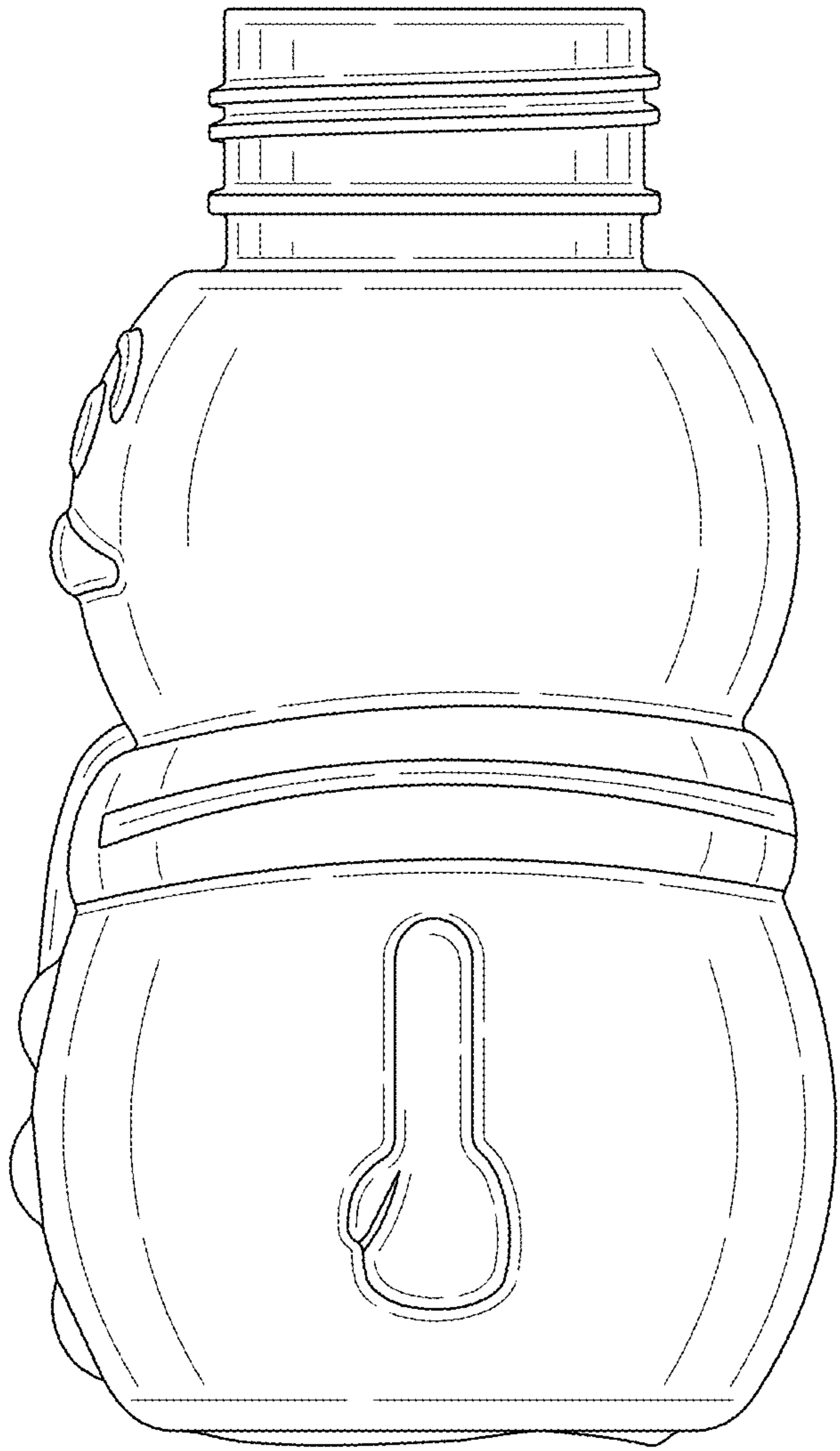
