**DESCRIPTION**

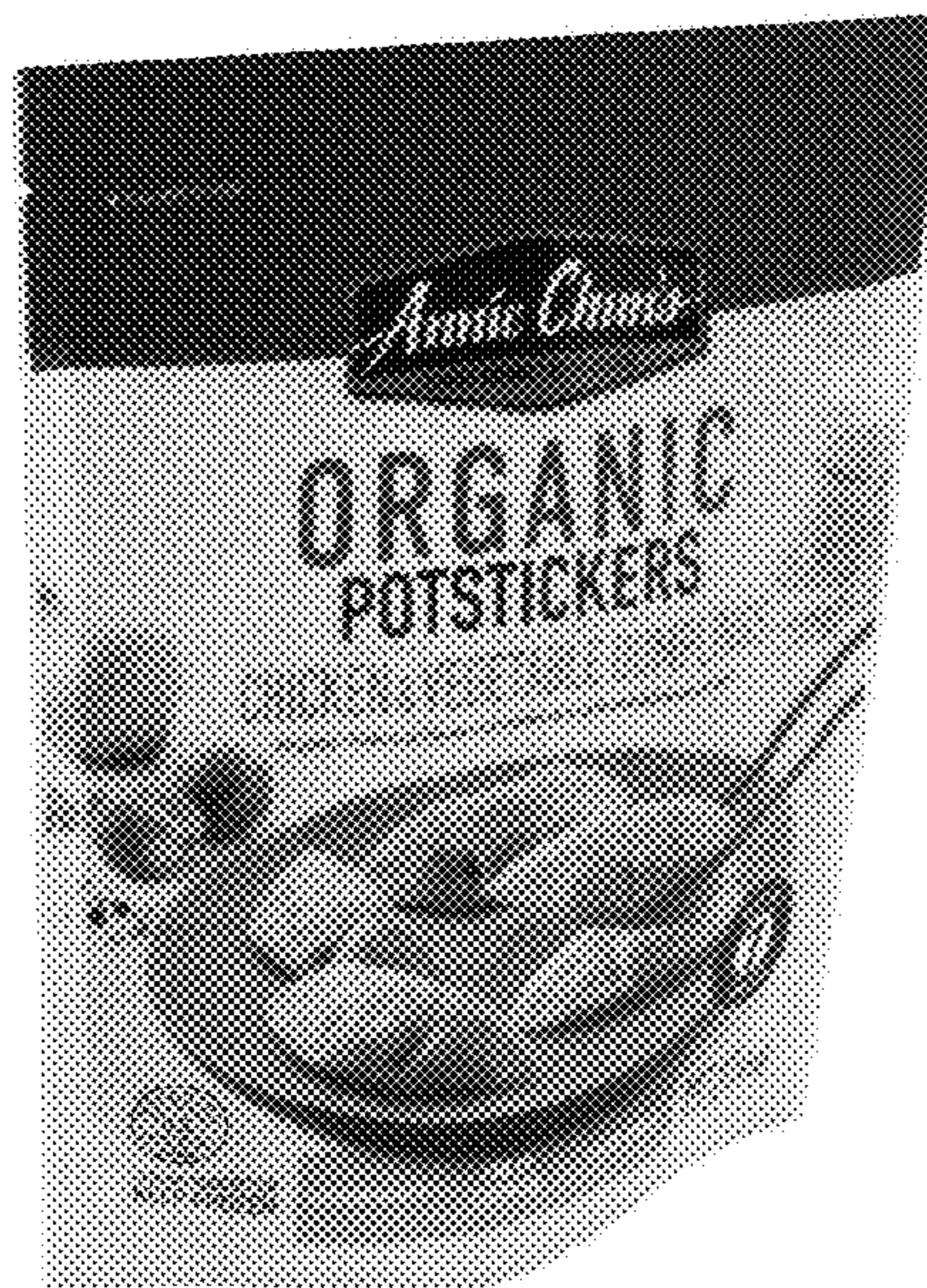

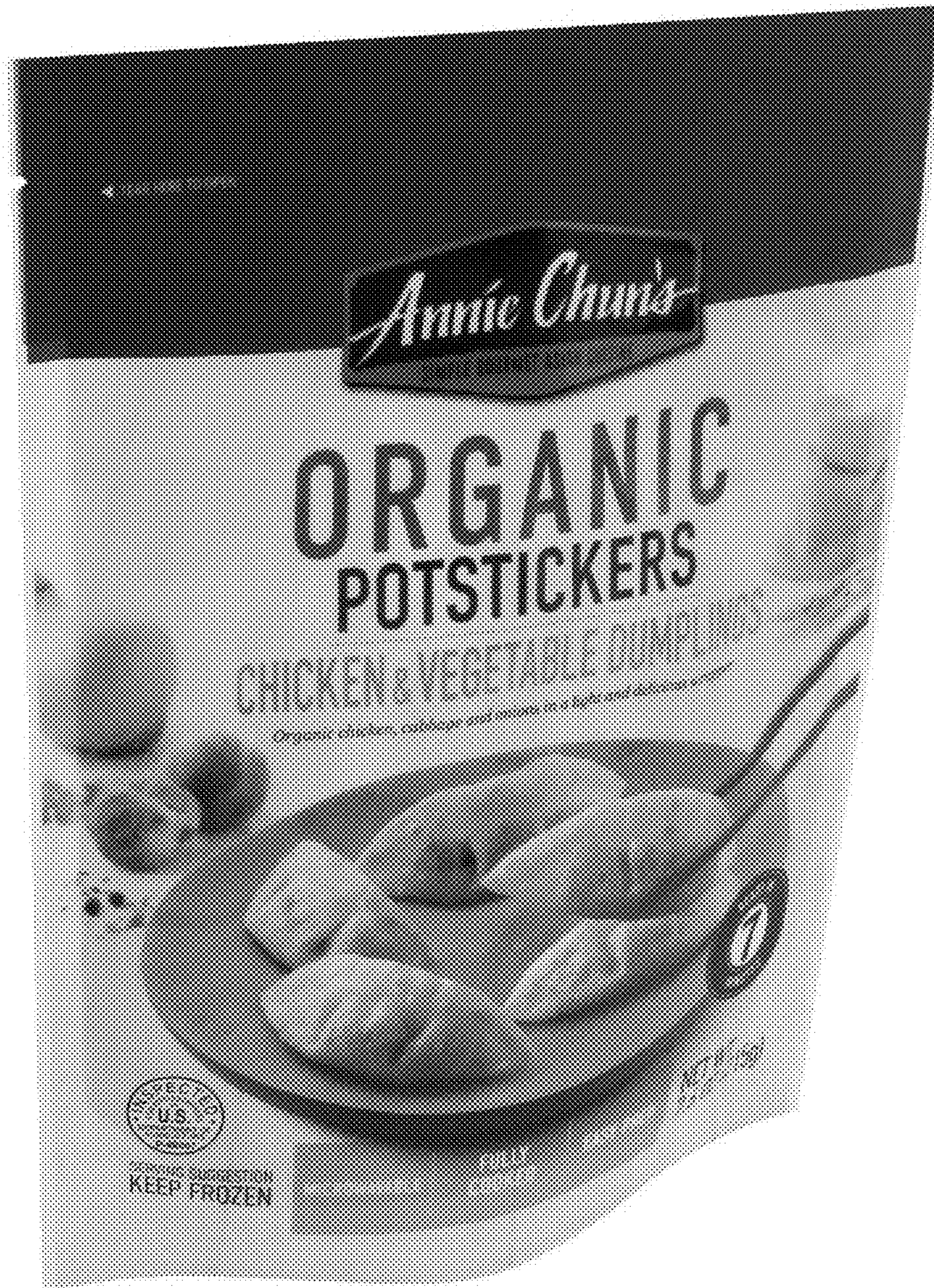

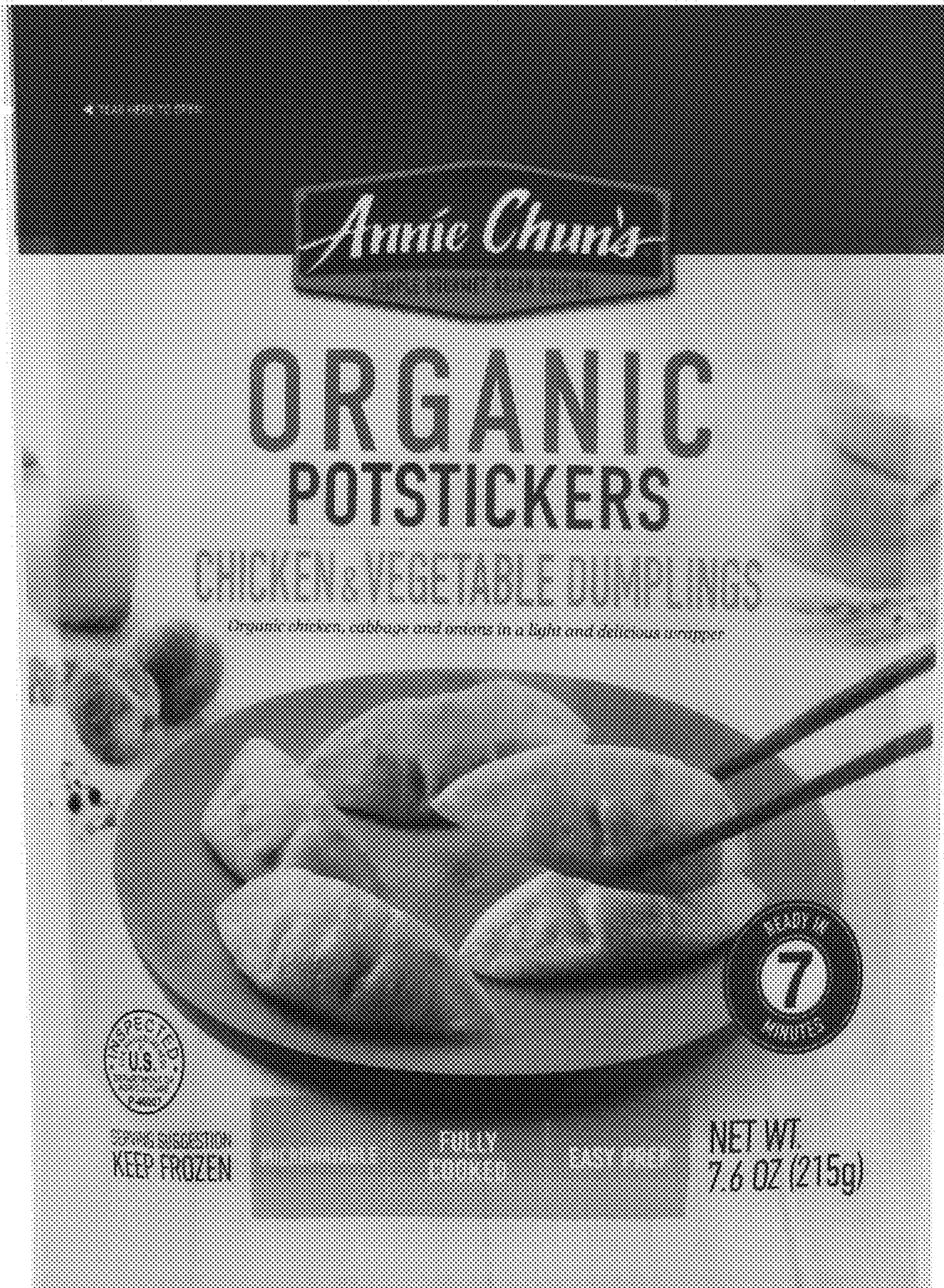

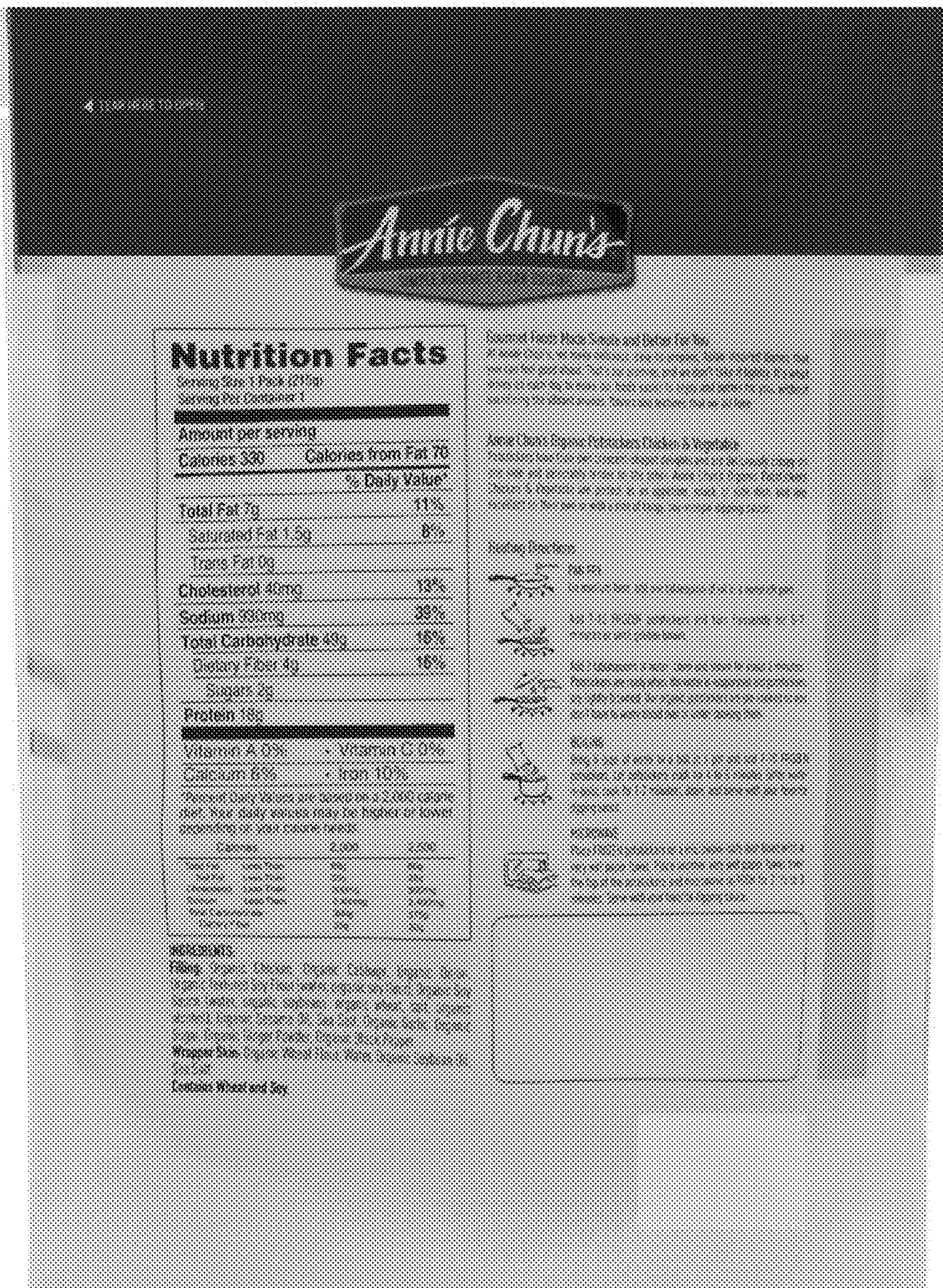

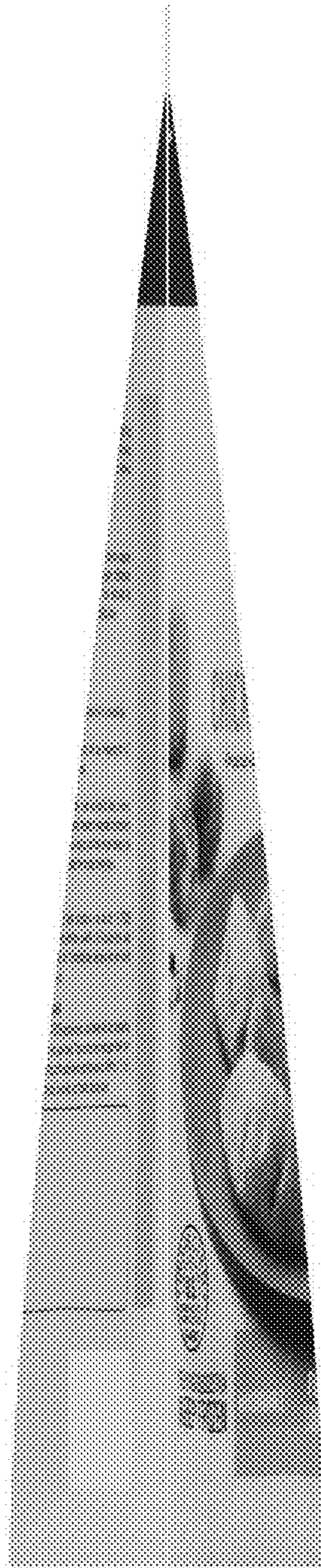

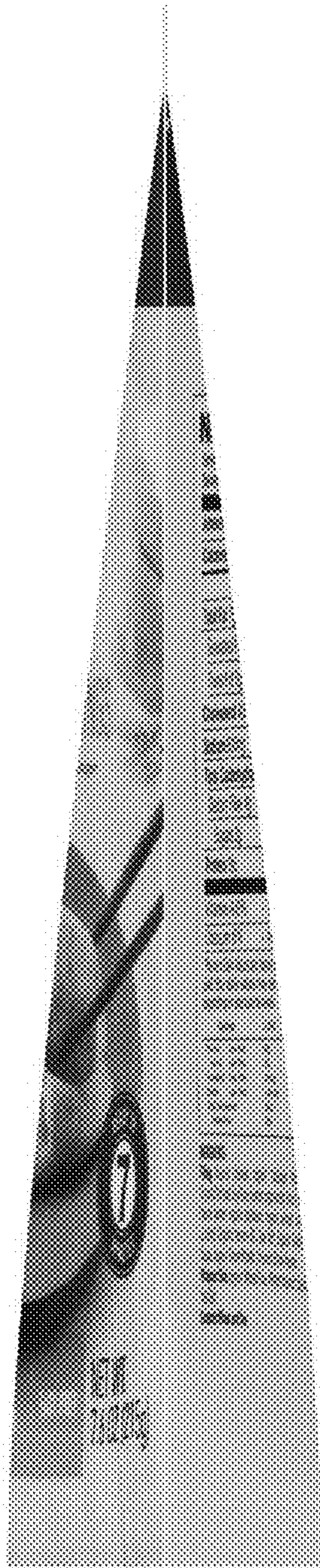

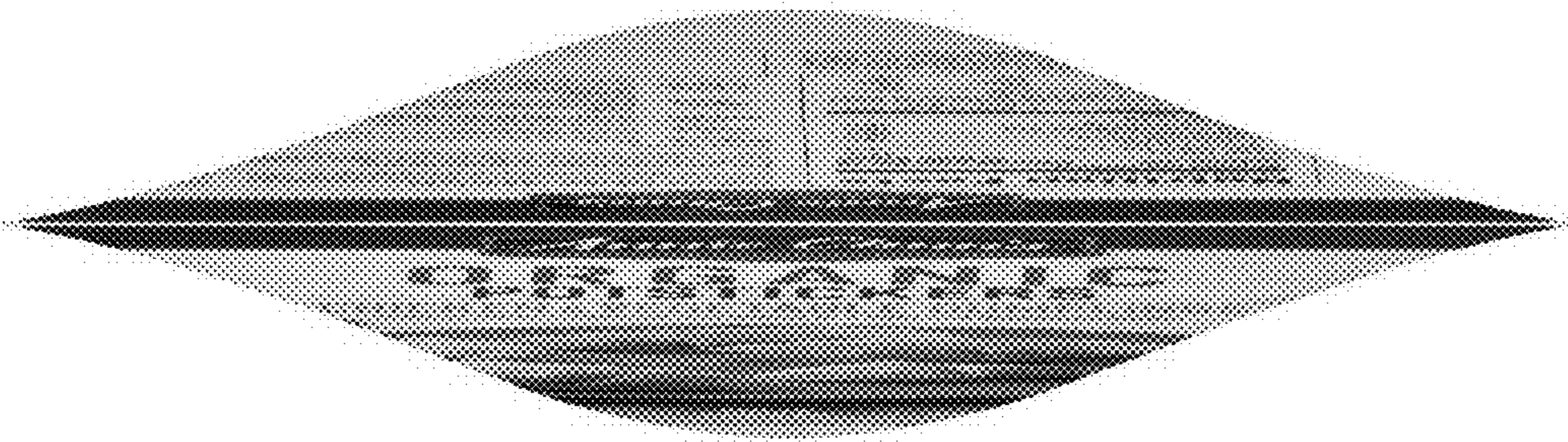
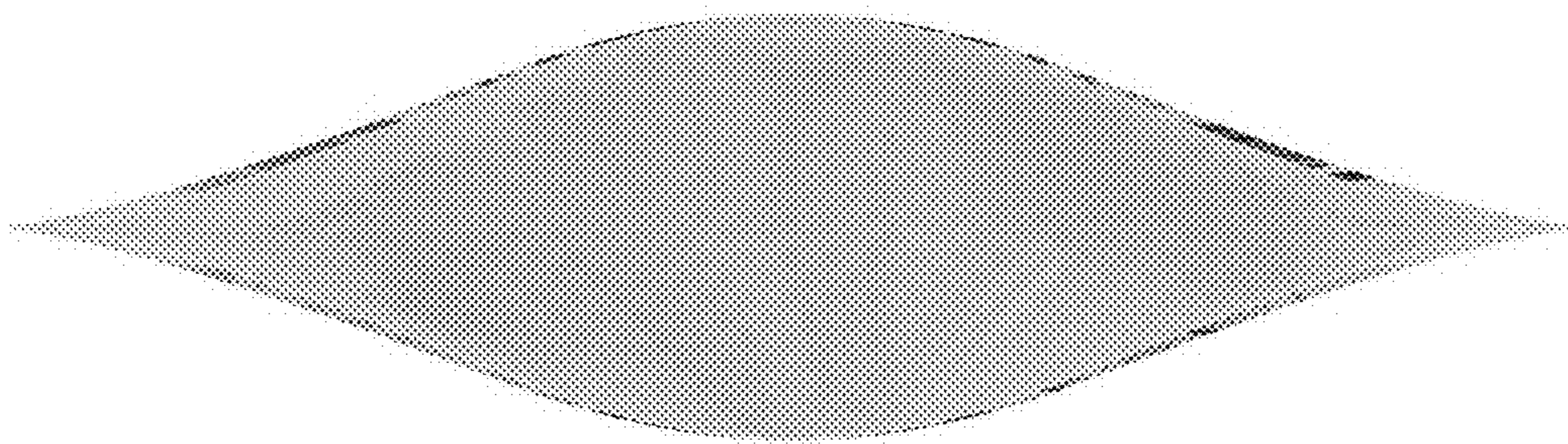
