FIG. 1 is a top perspective view of the can of the present design;

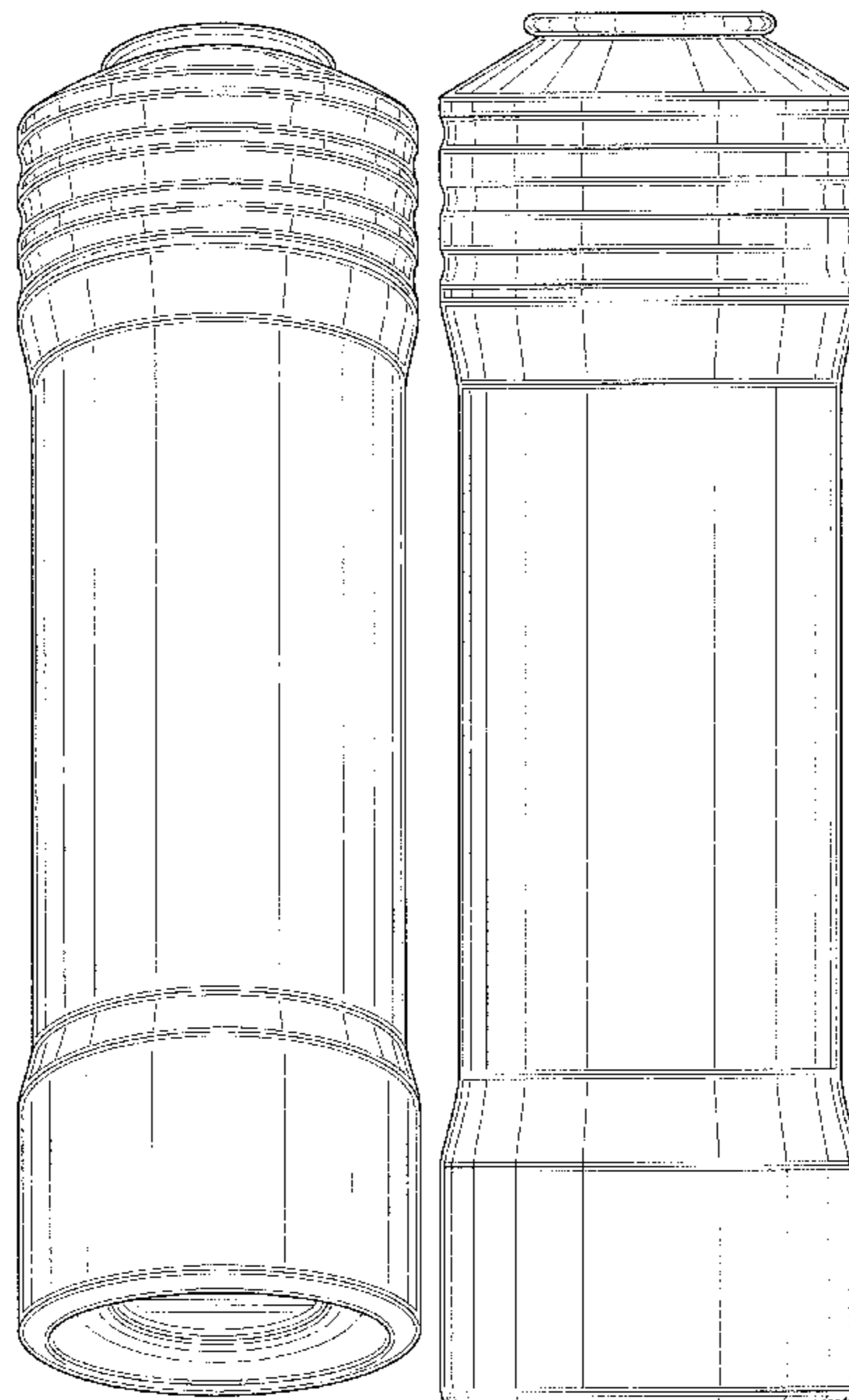
FIG. 2 is a bottom perspective view thereof;

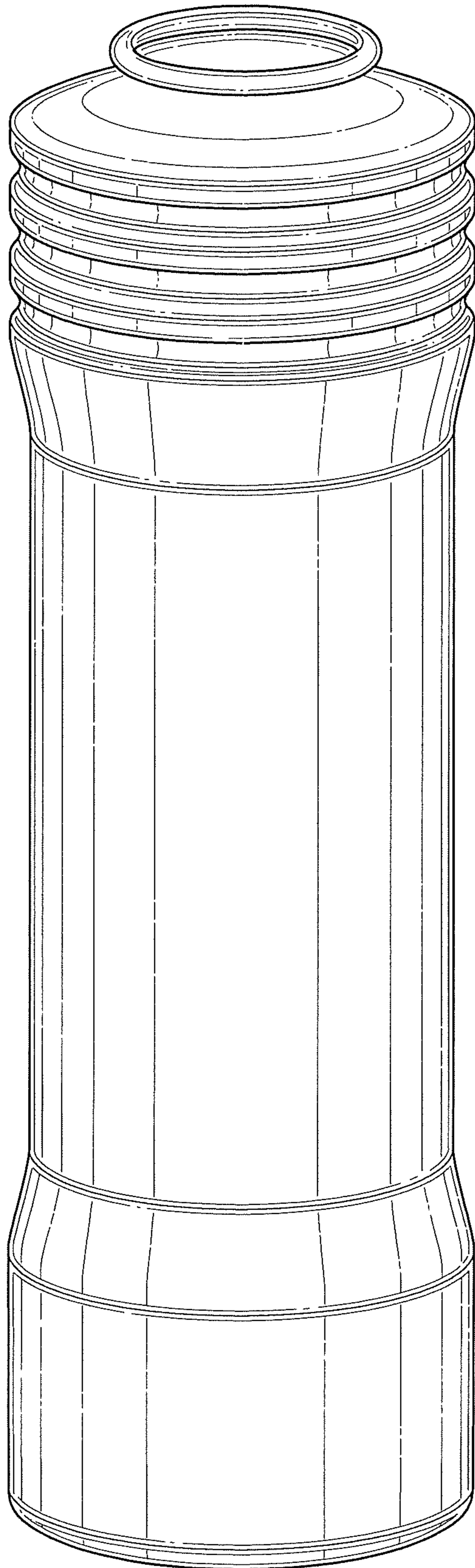

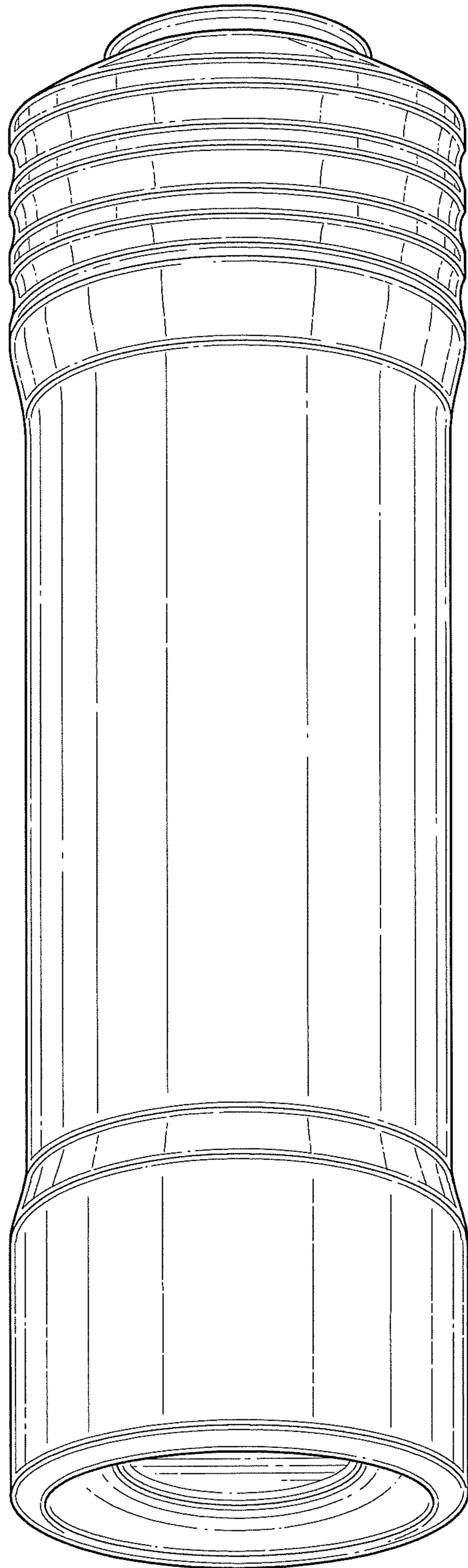

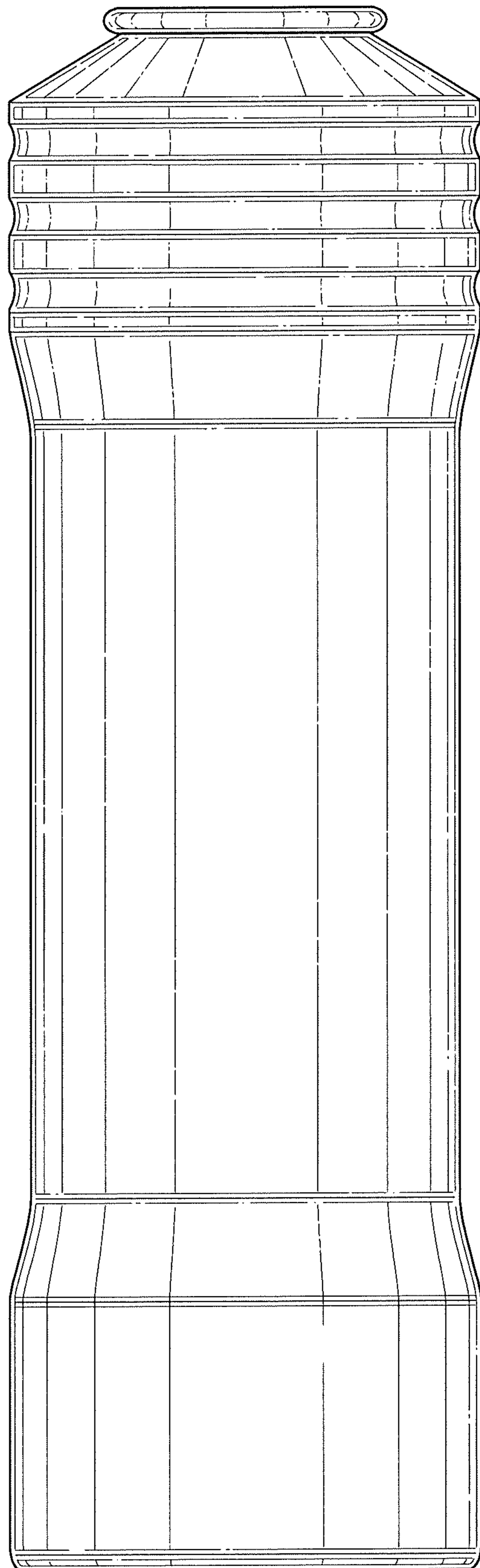

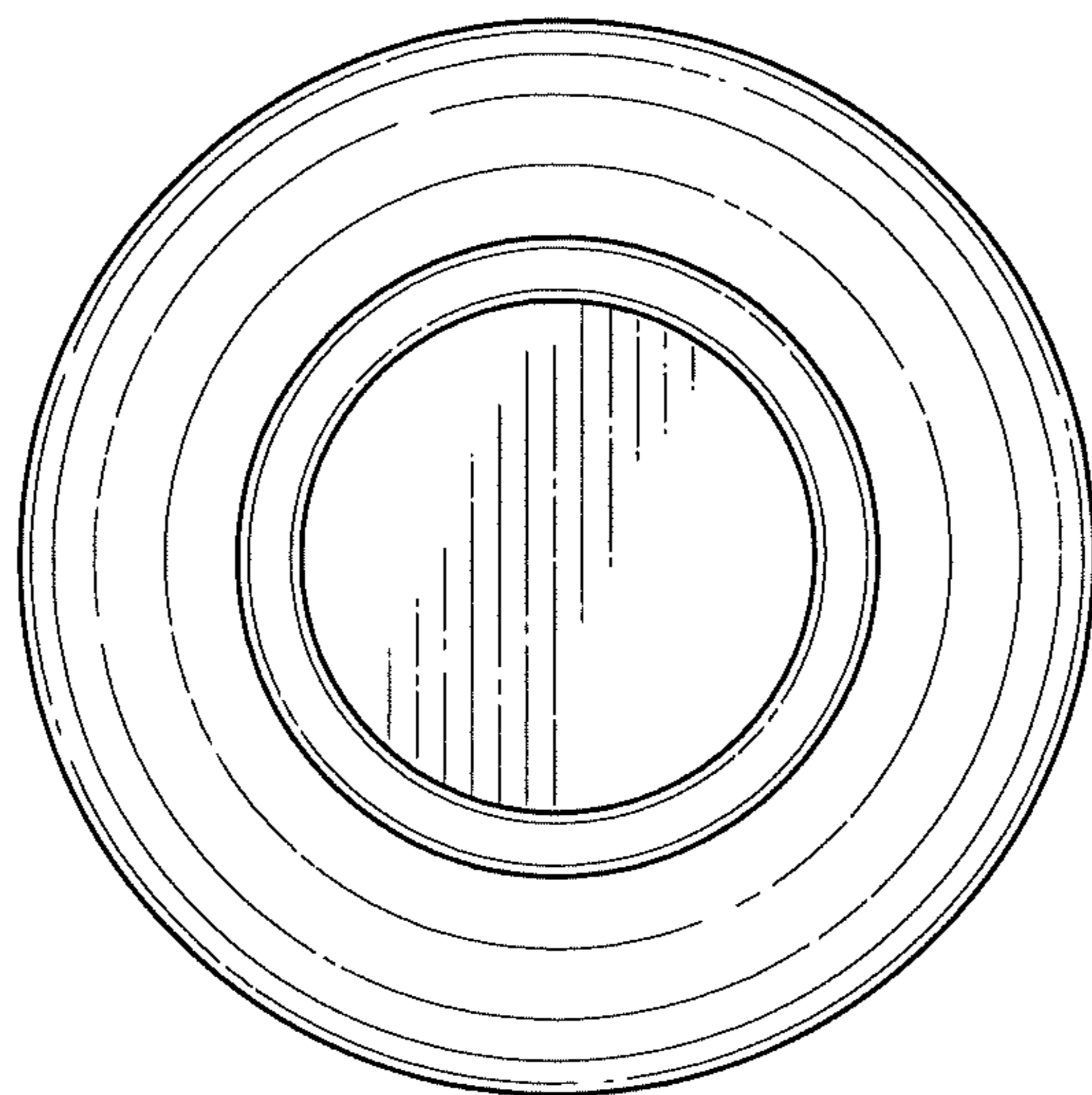

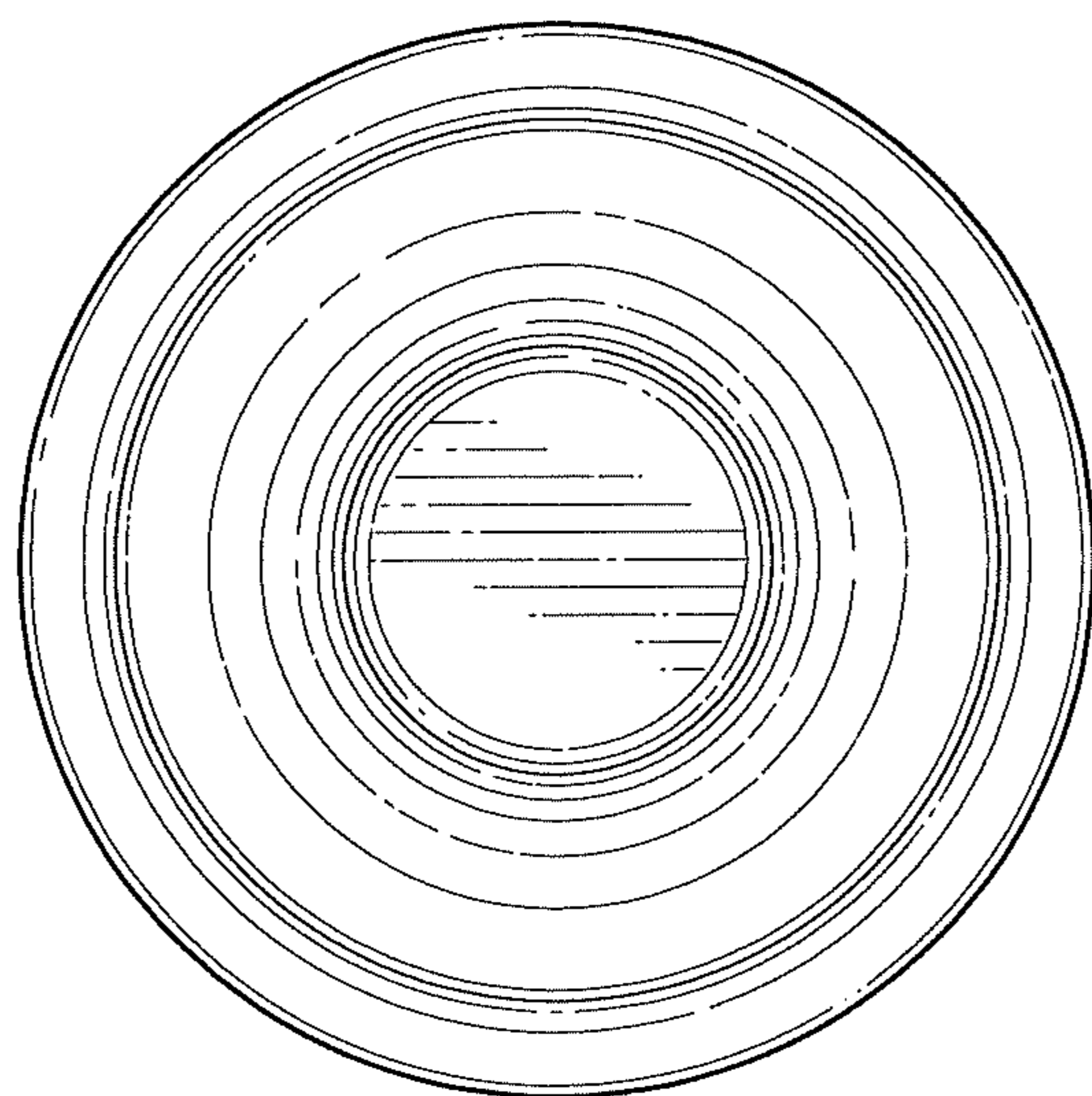
