(57) **CLAIM**

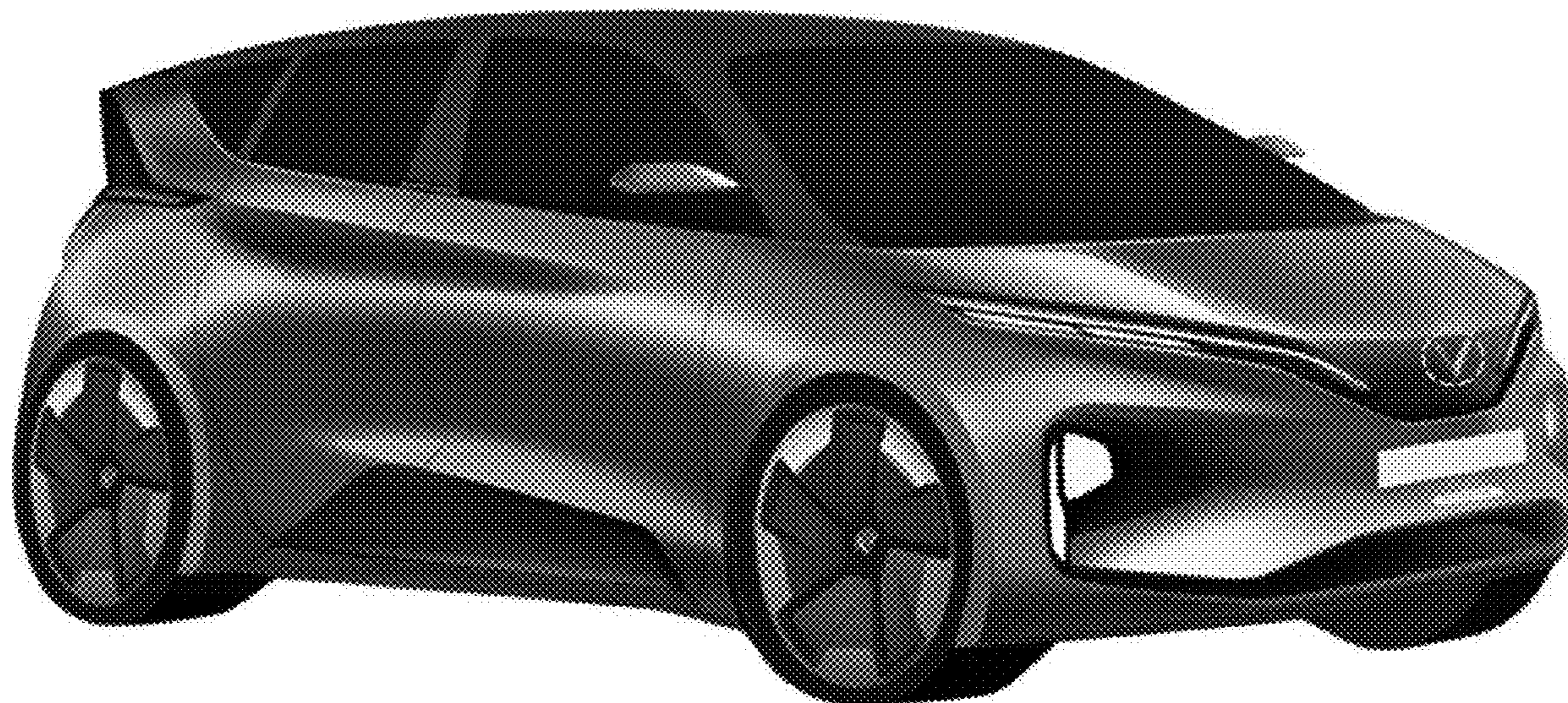
We claim the ornamental design for an electric car, as shown and described.

DESCRIPTION

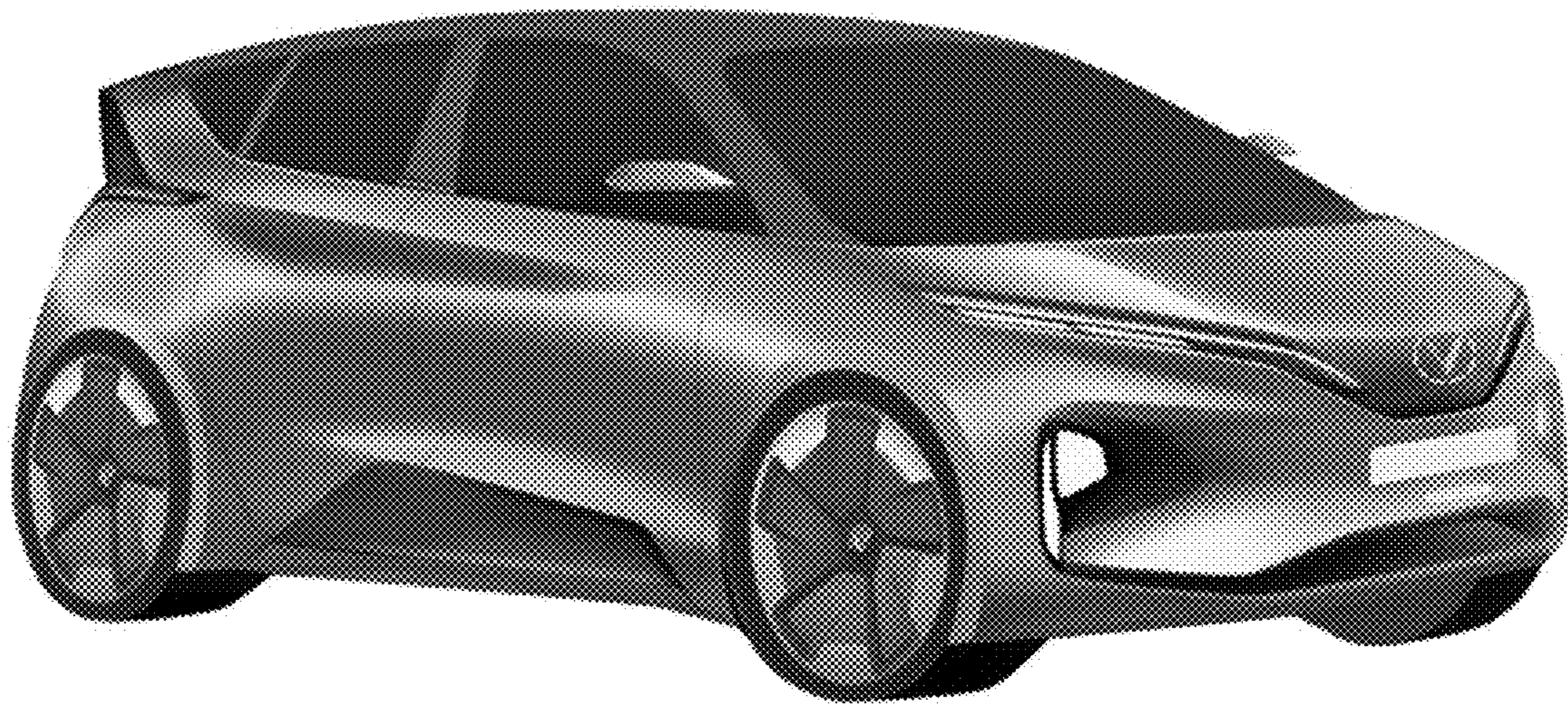

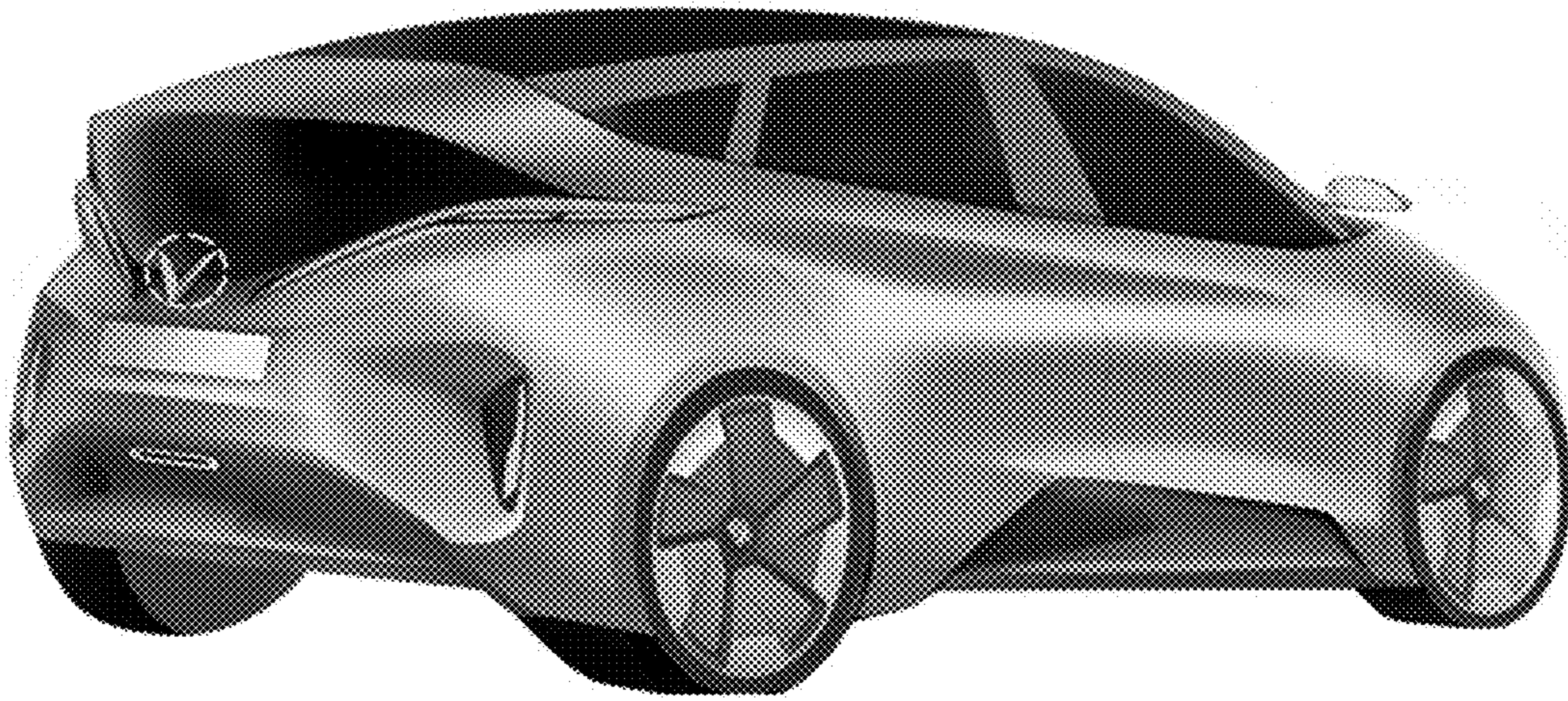

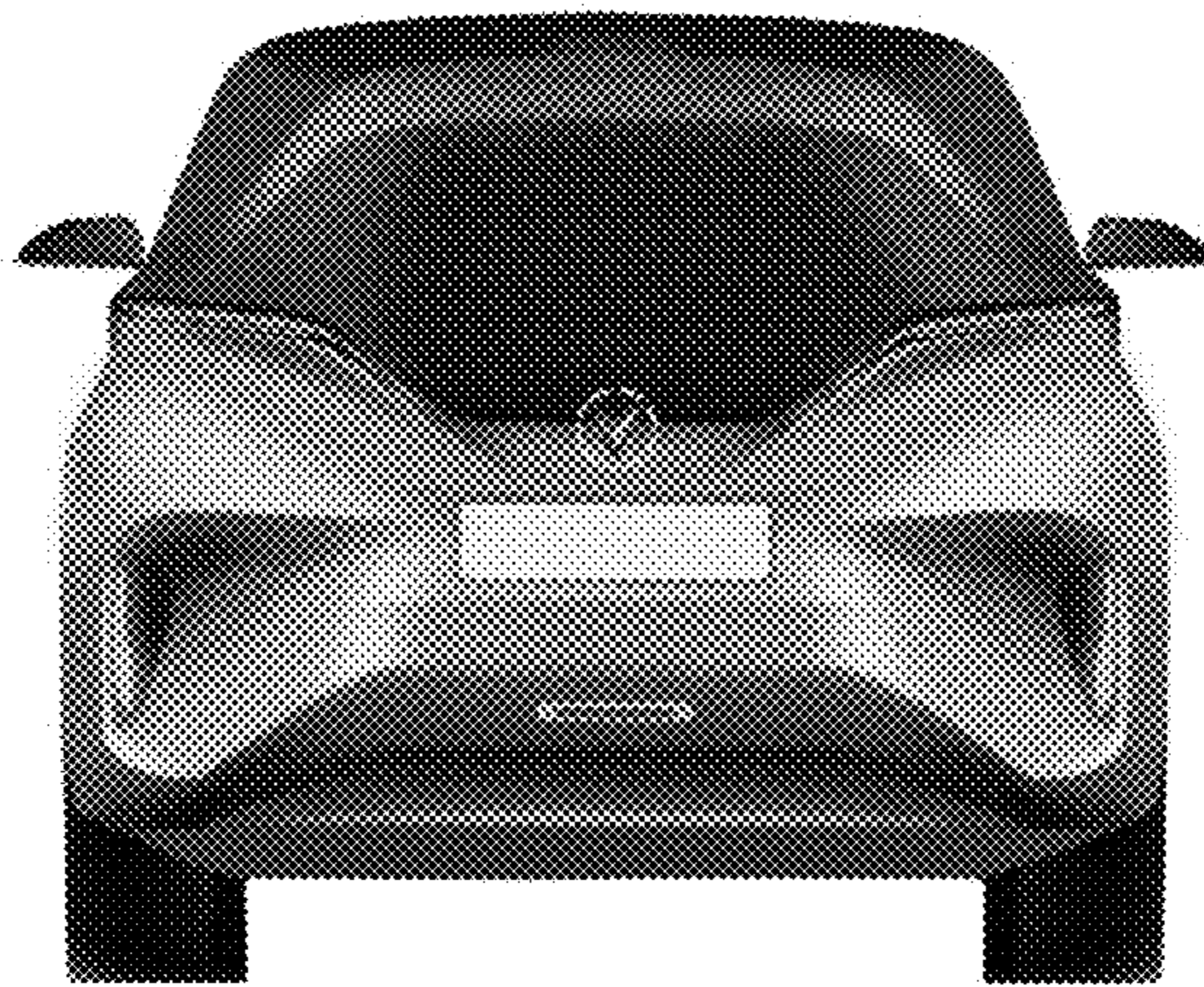

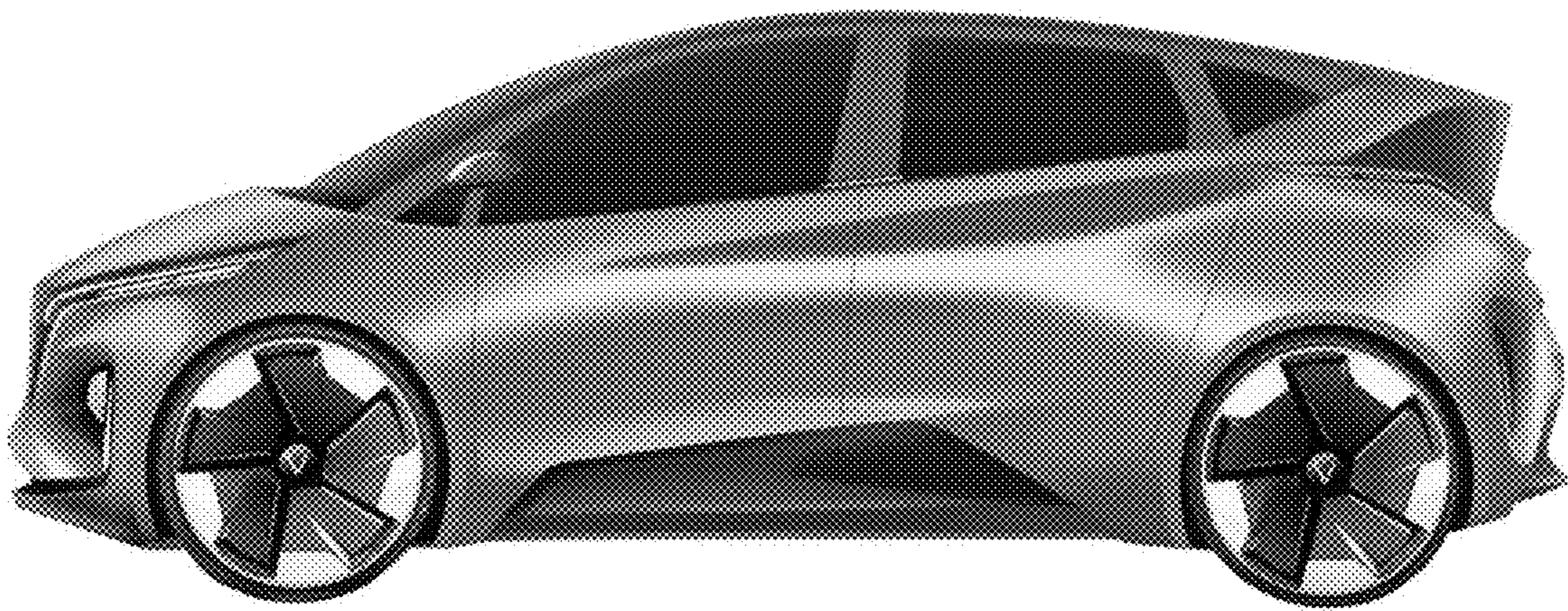

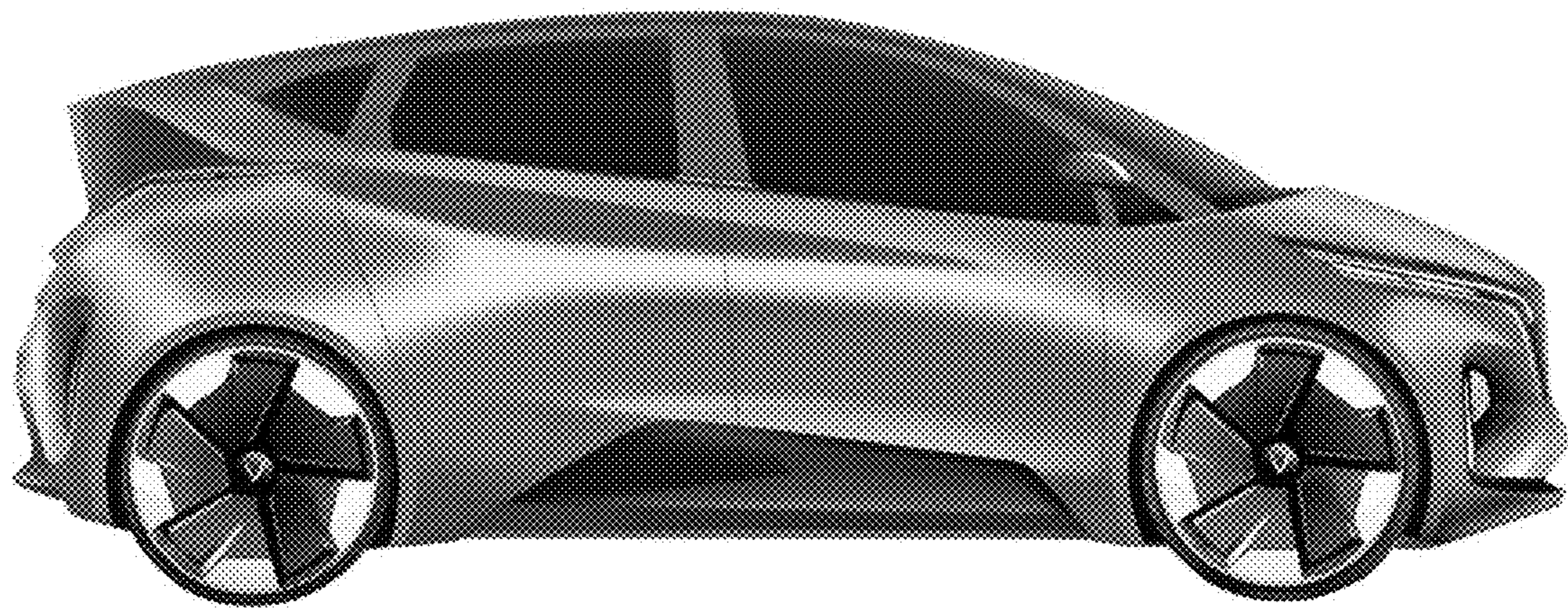

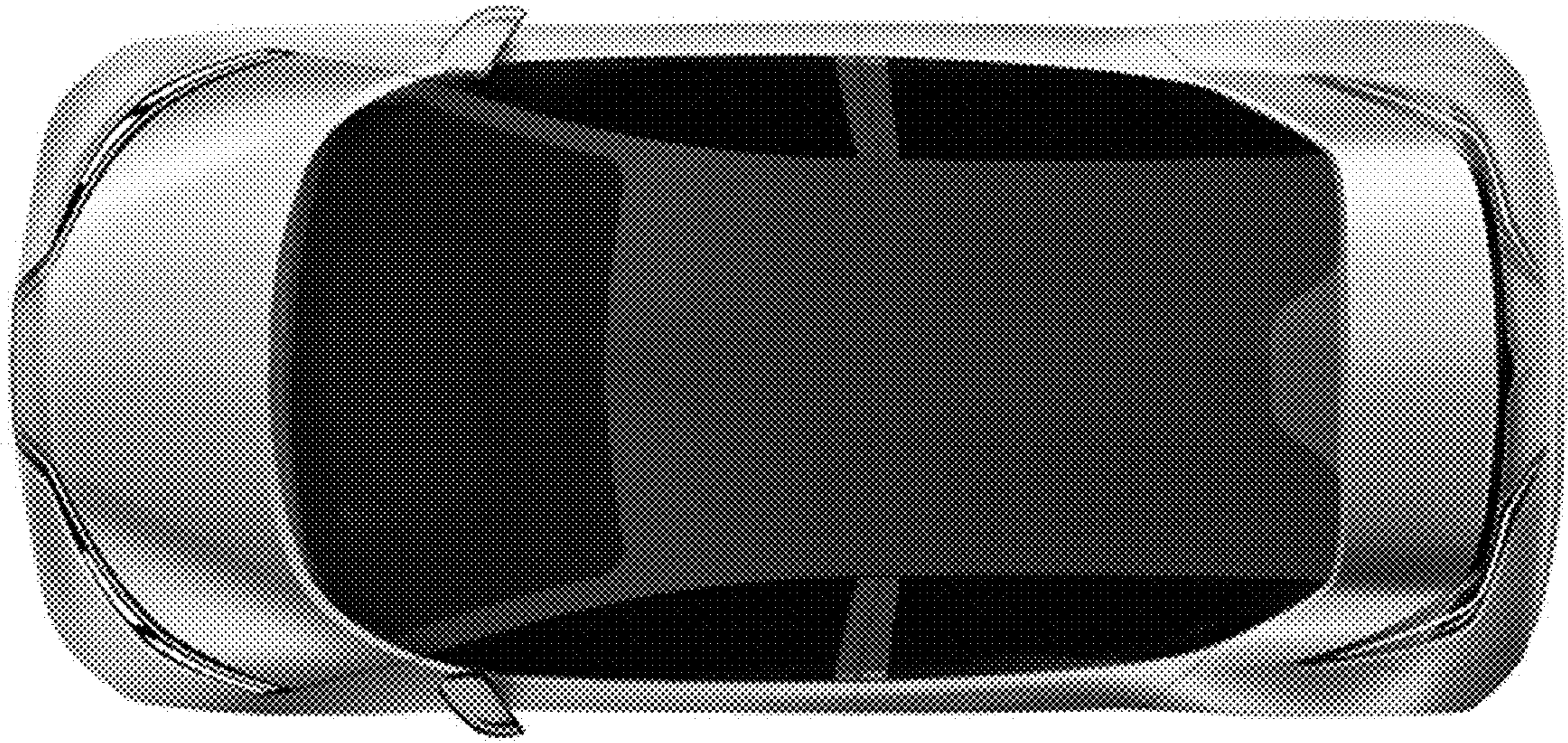
