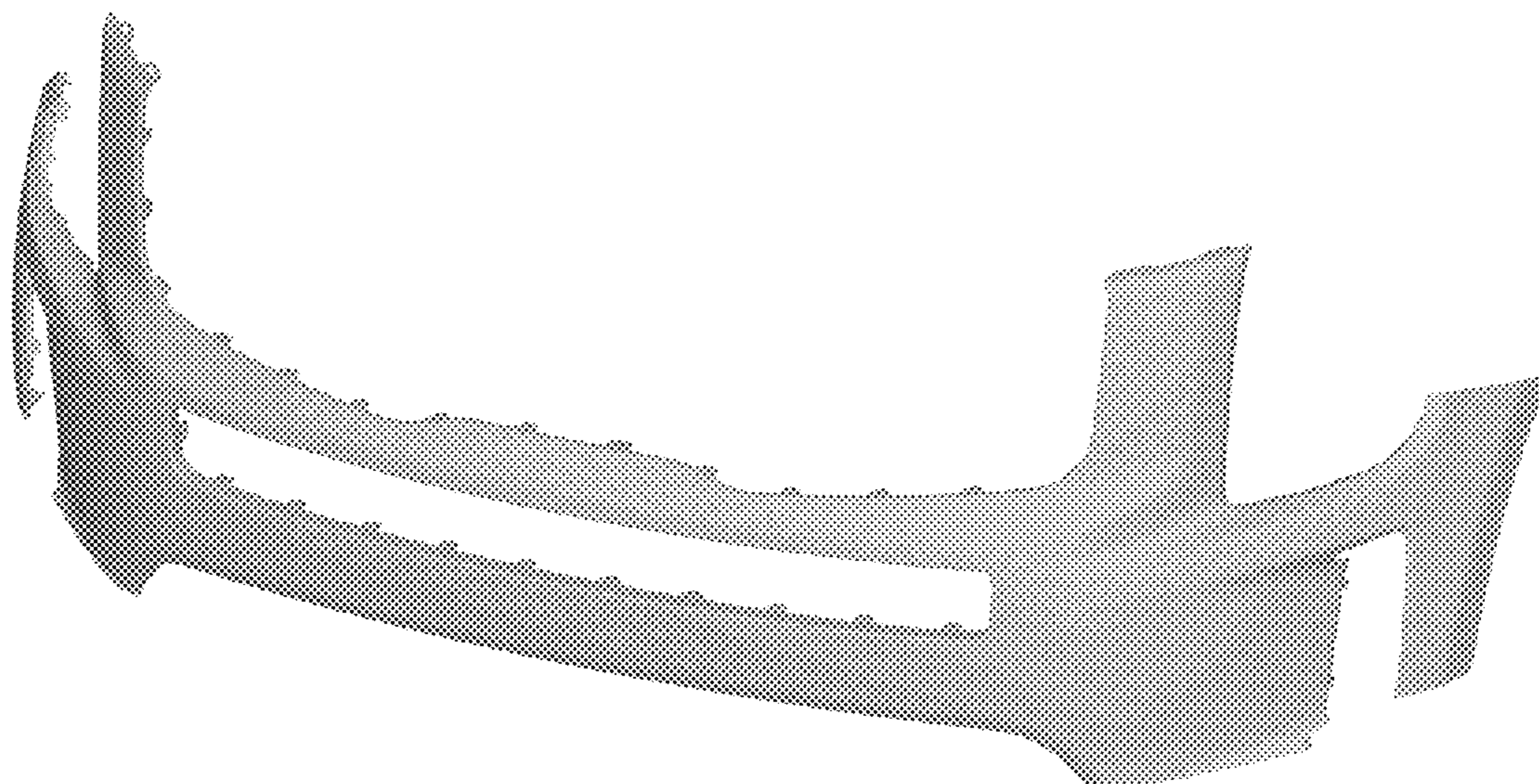
(57) **CLAIM**

The ornamental design for a front bumper upper cover for an automobile, as shown and described.

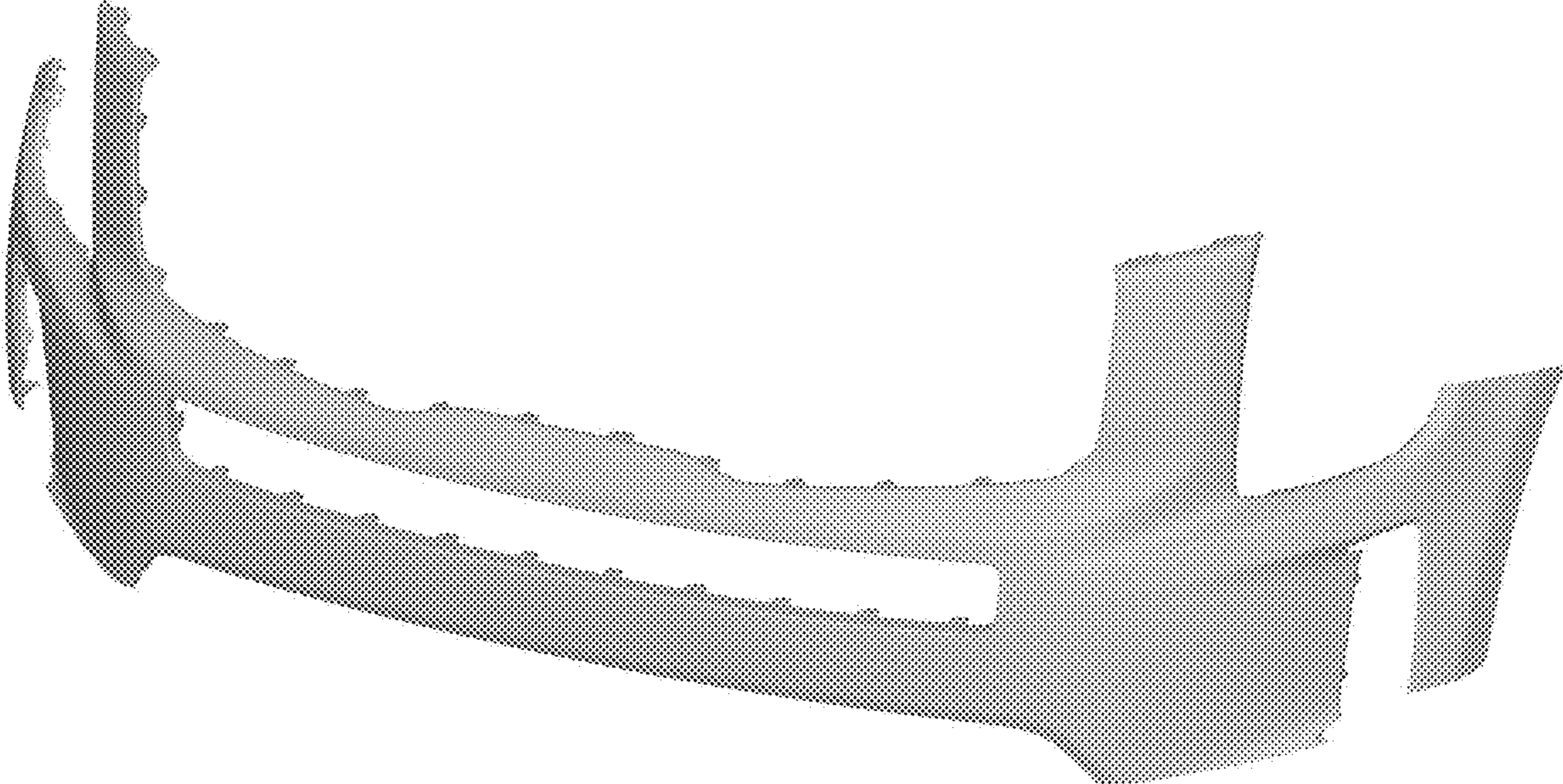
DESCRIPTION

- 1.7 is a bottom plan view thereof.

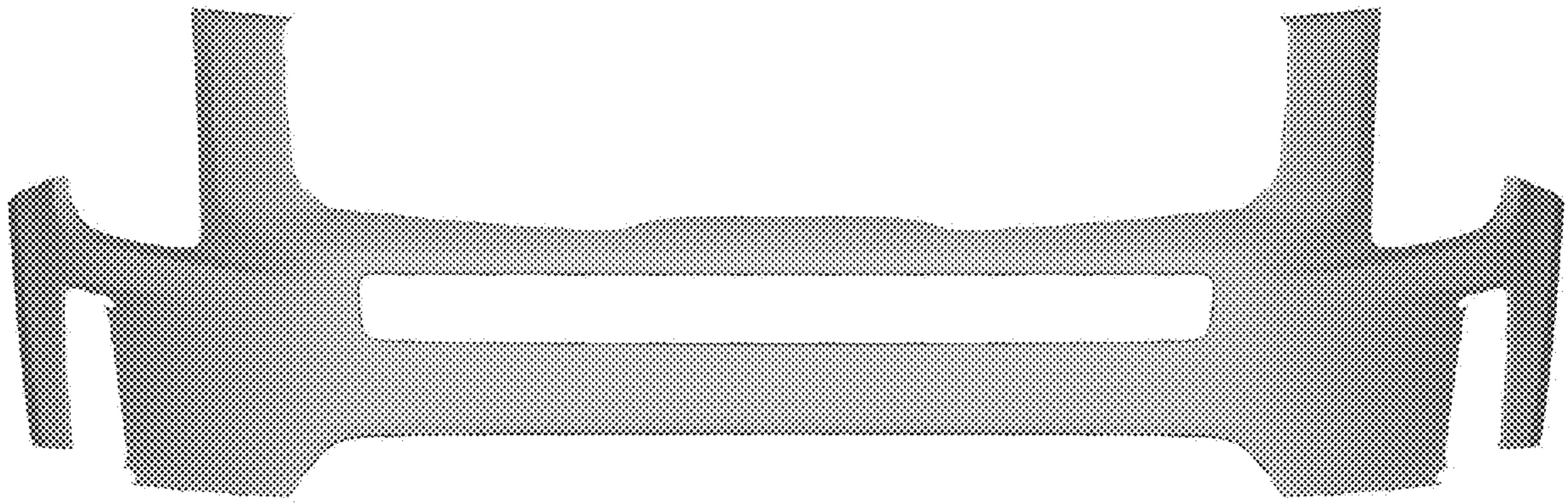

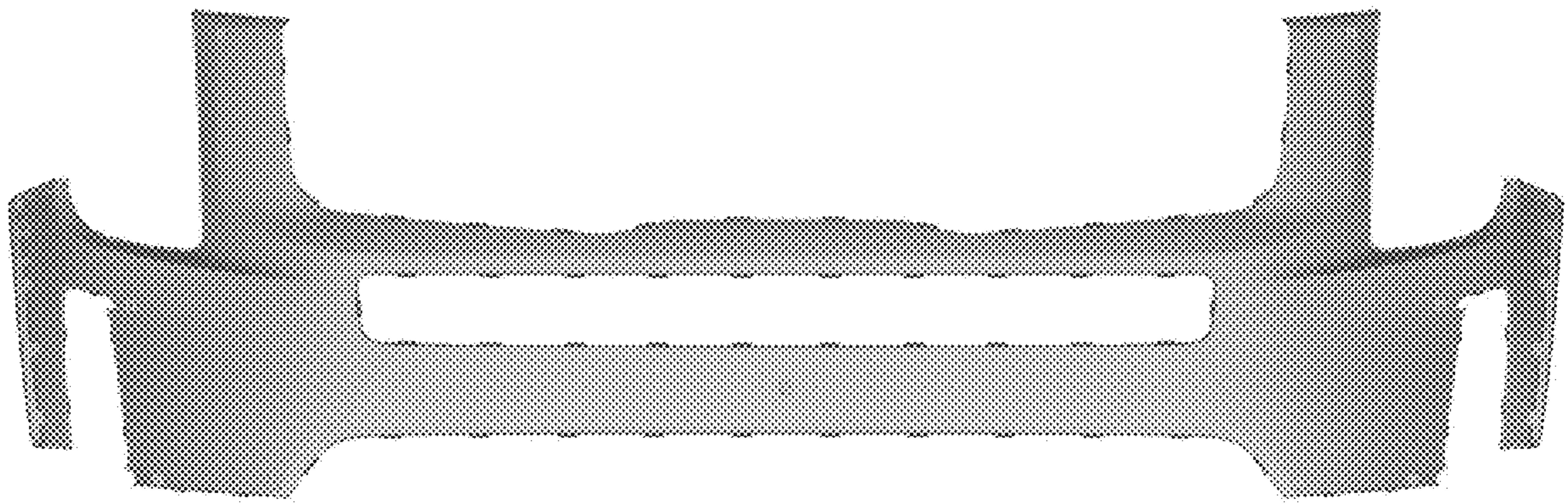

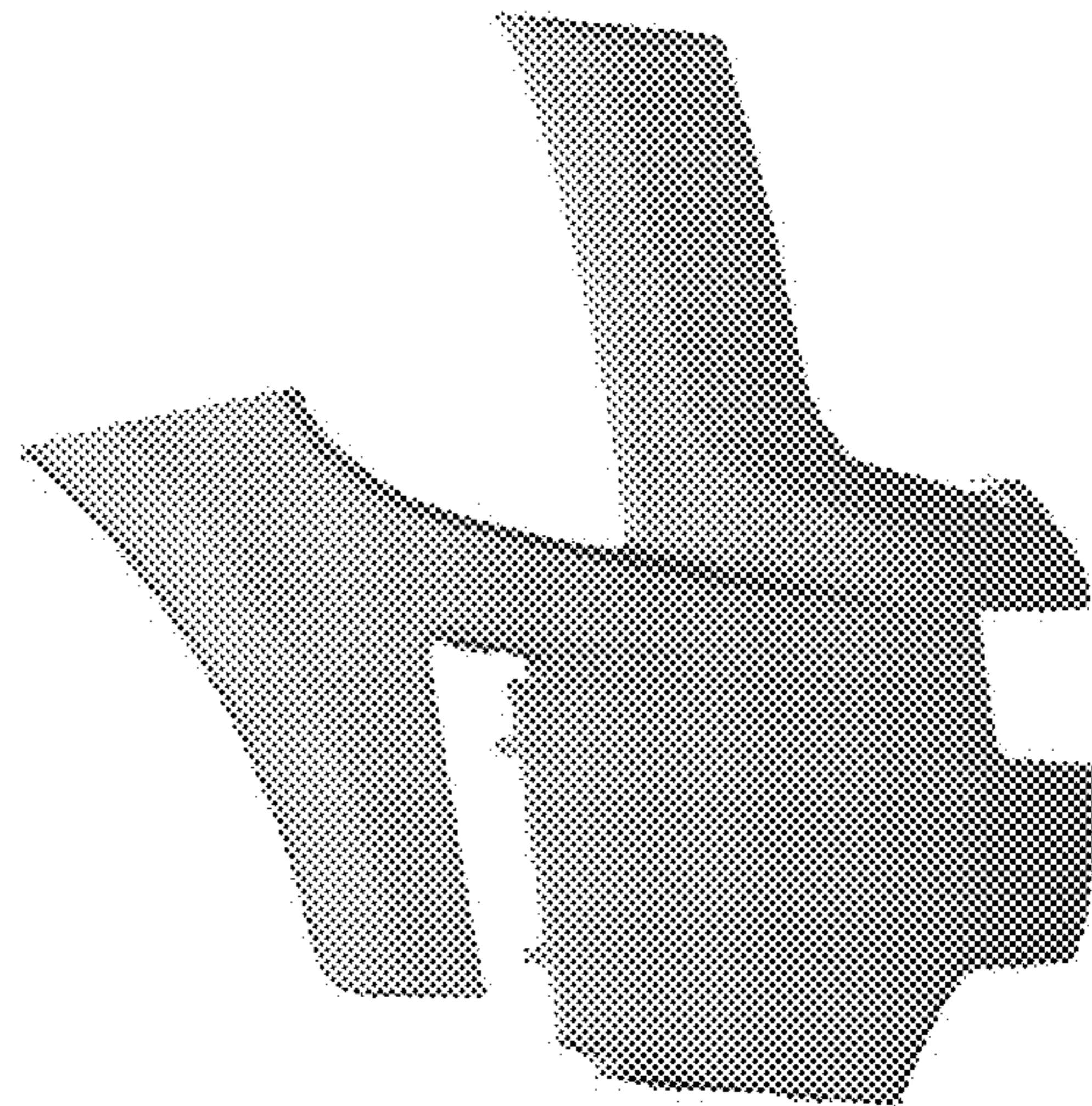

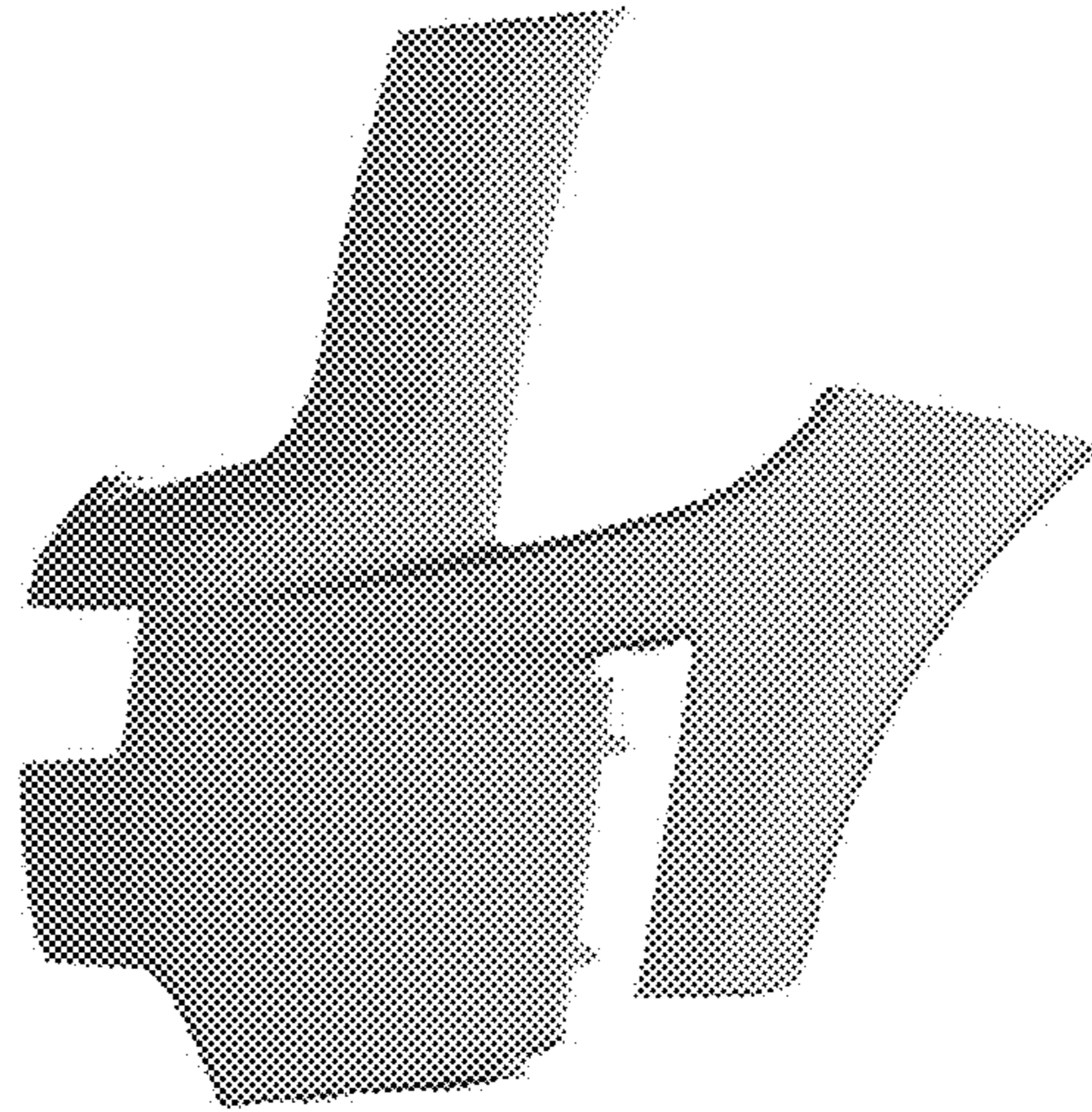

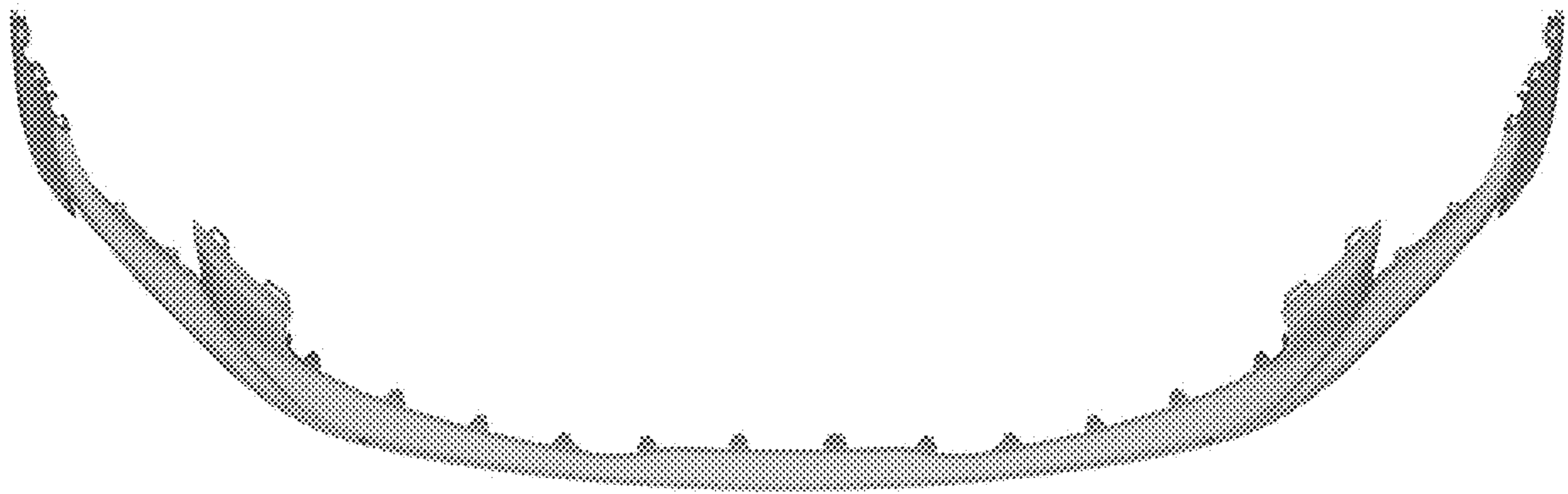
