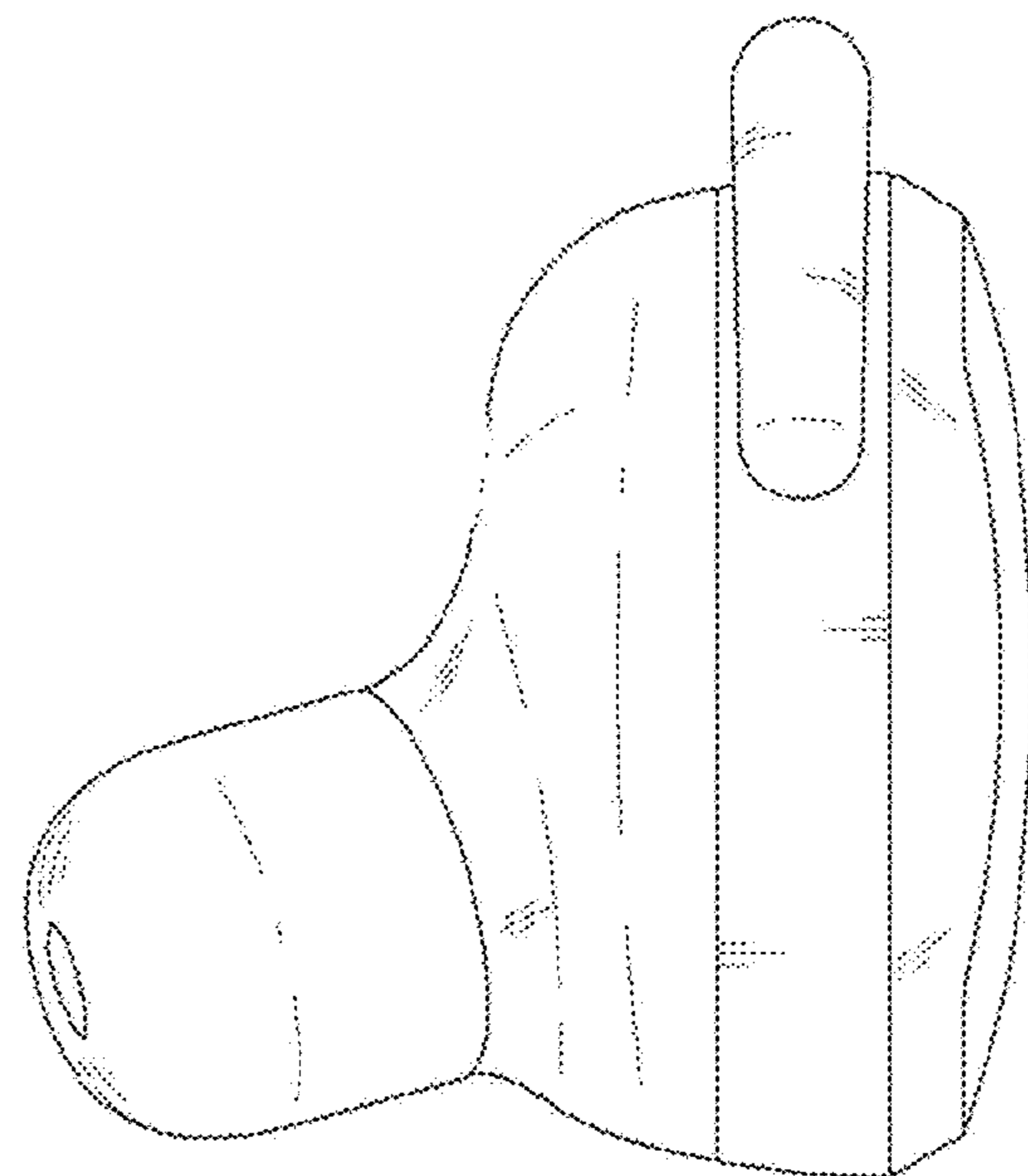
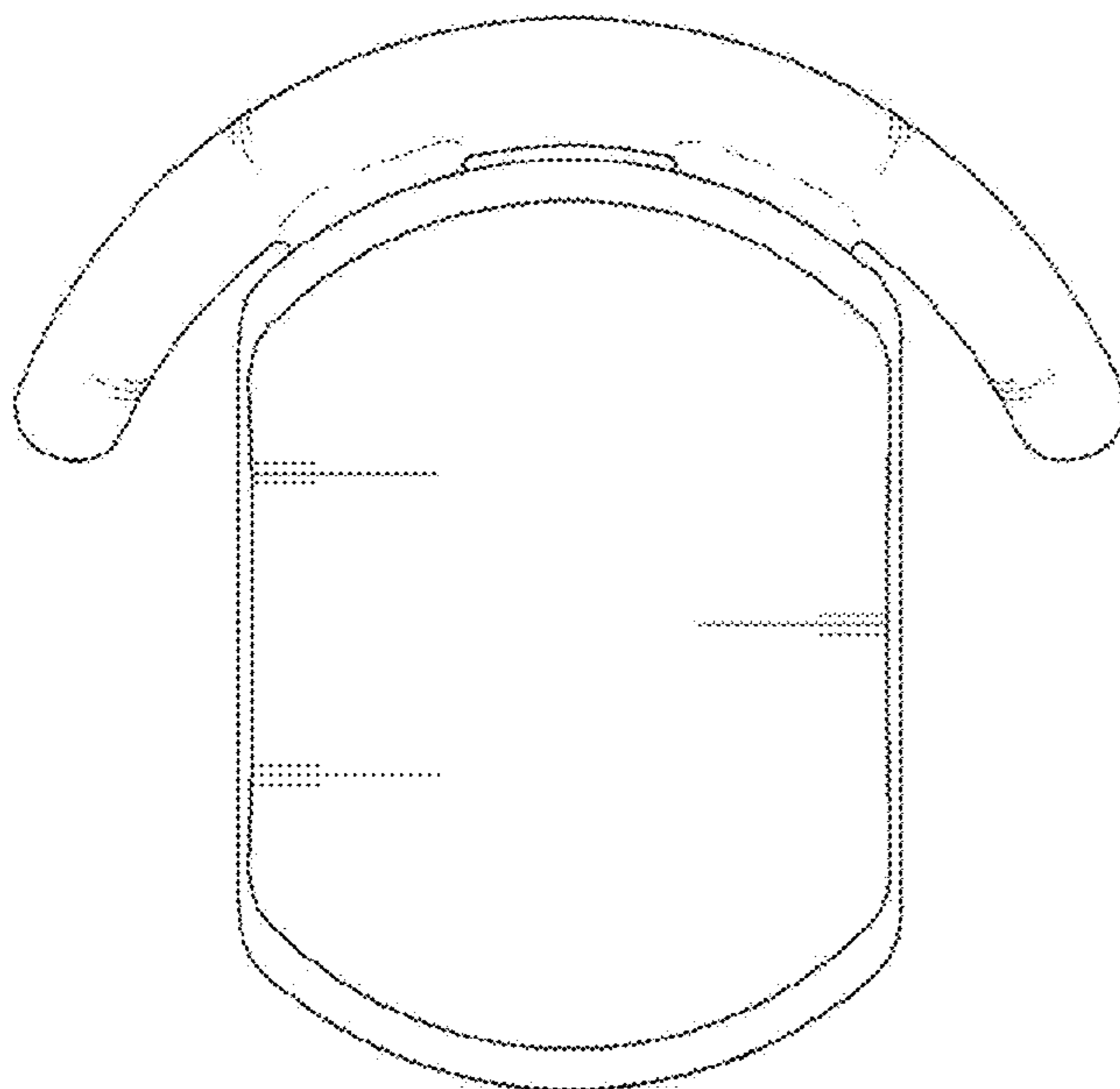

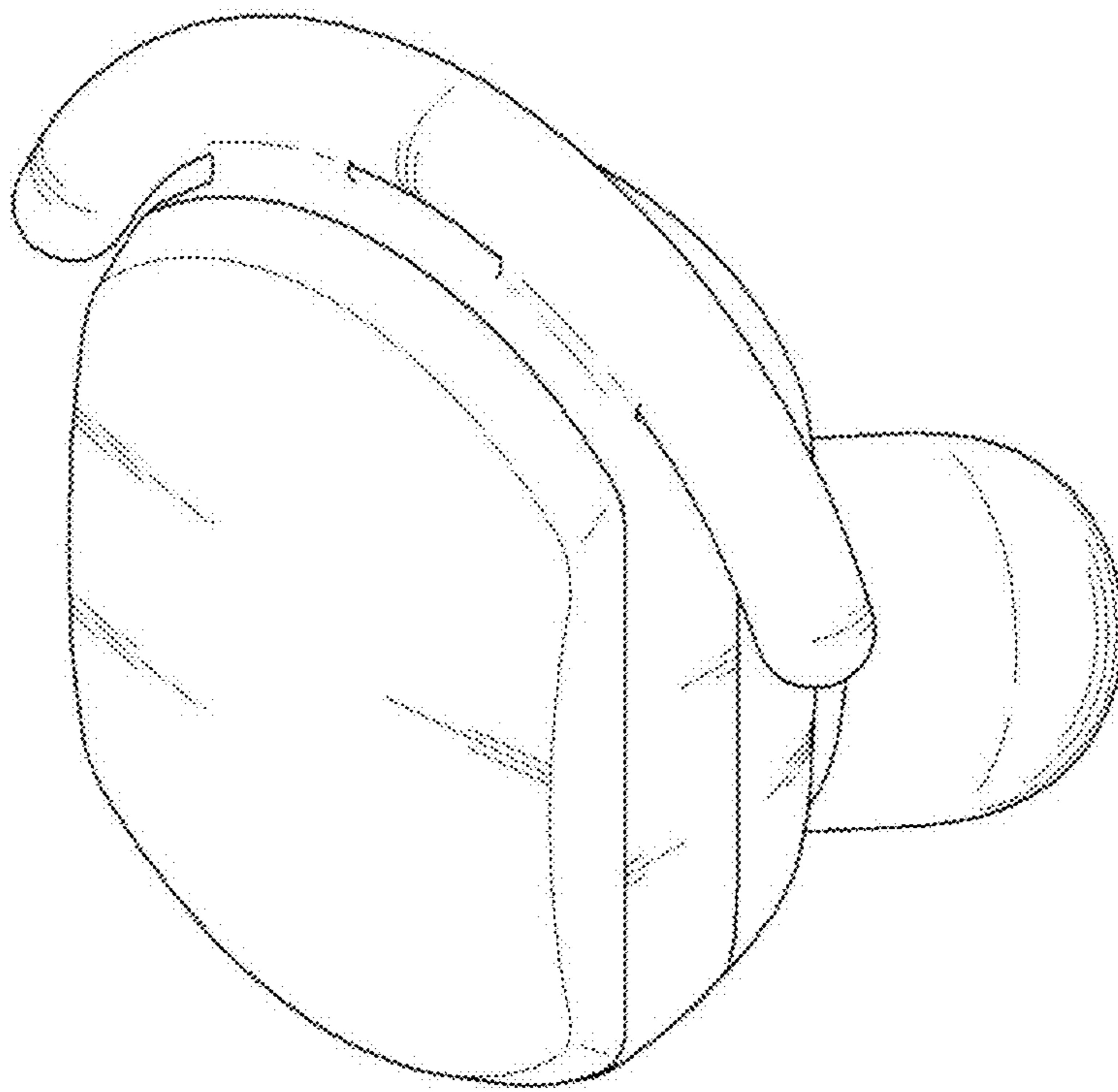

The broken lines depict portions of wireless earbud that form no part of the claimed design.

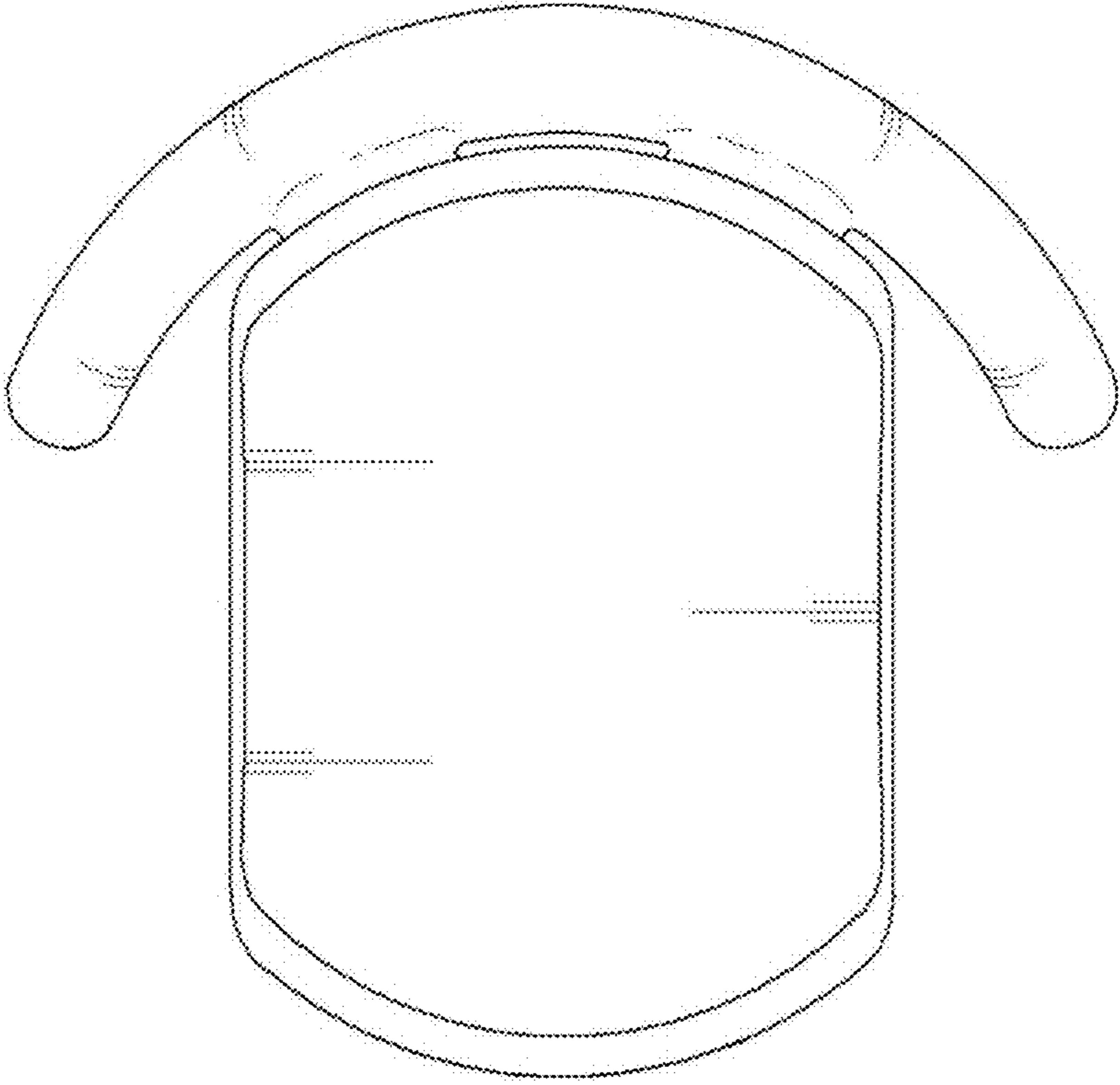

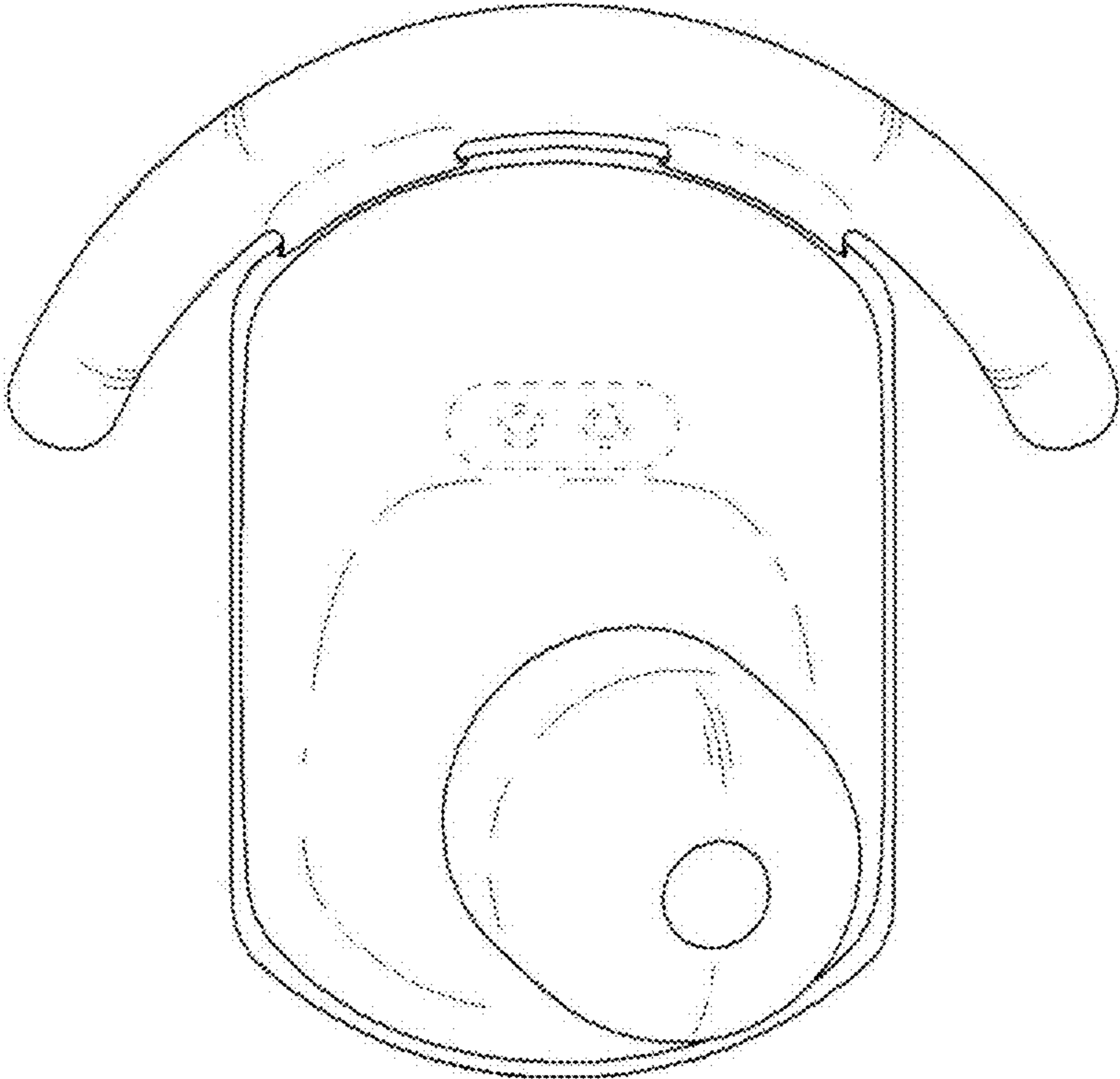

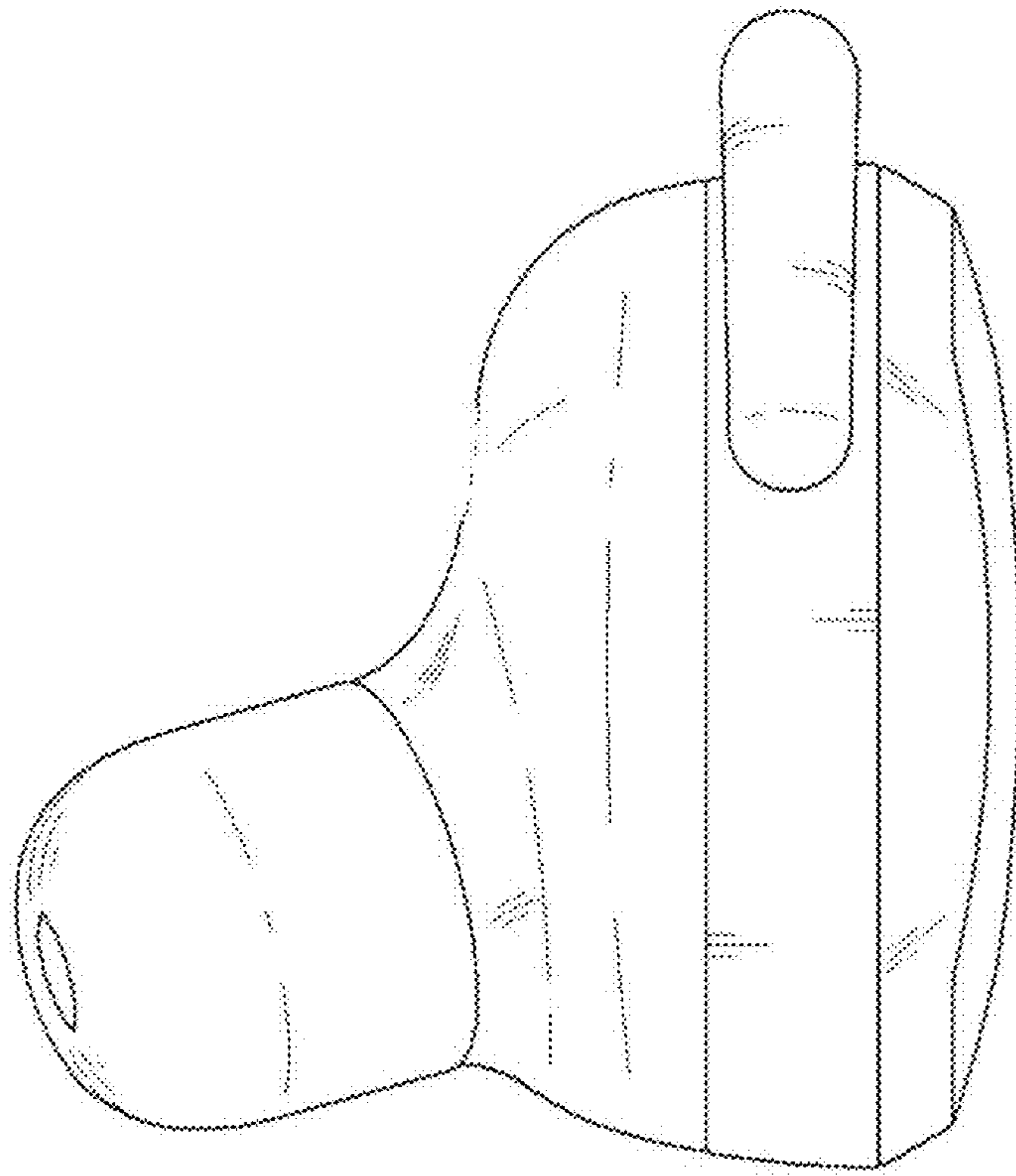

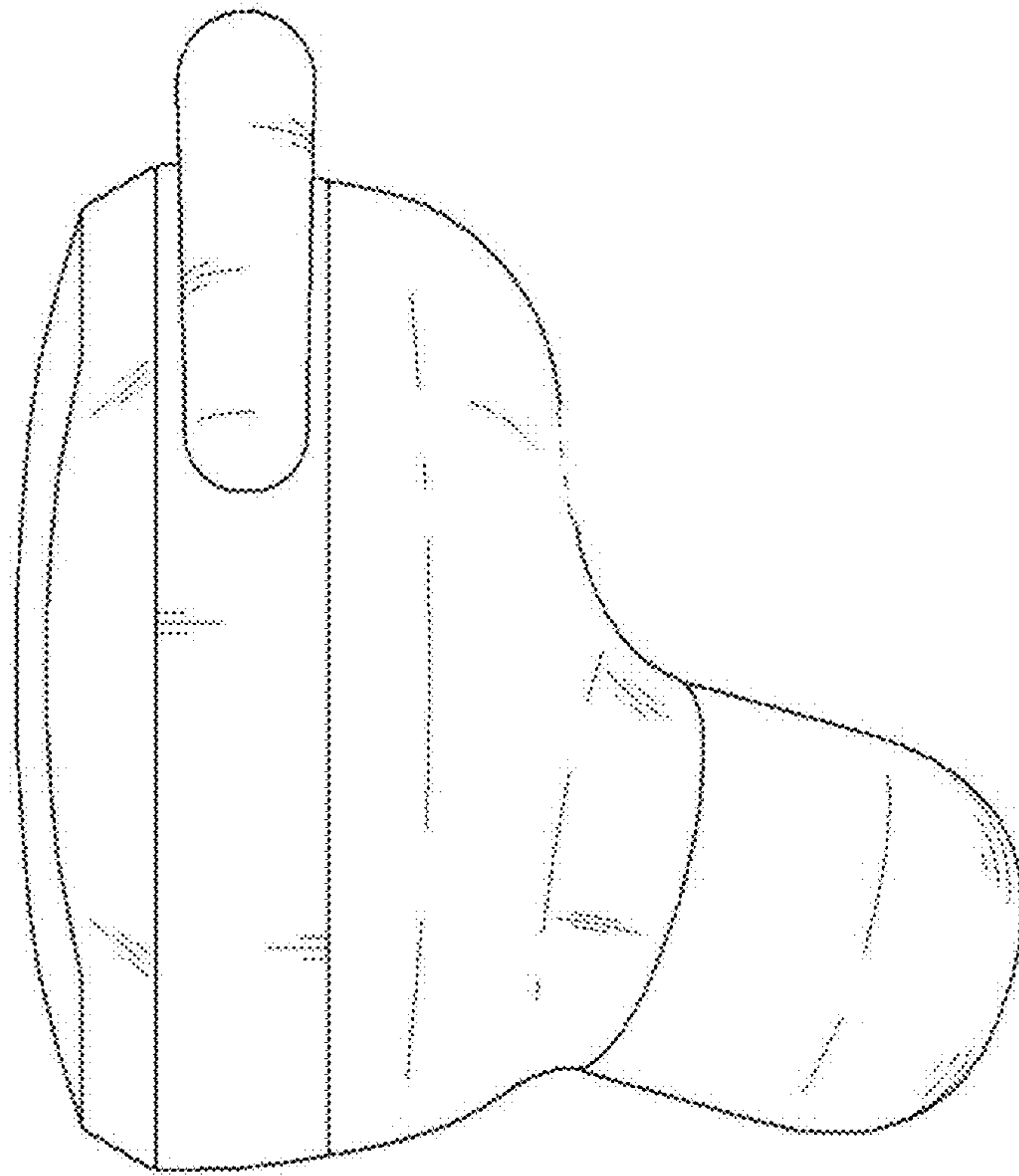

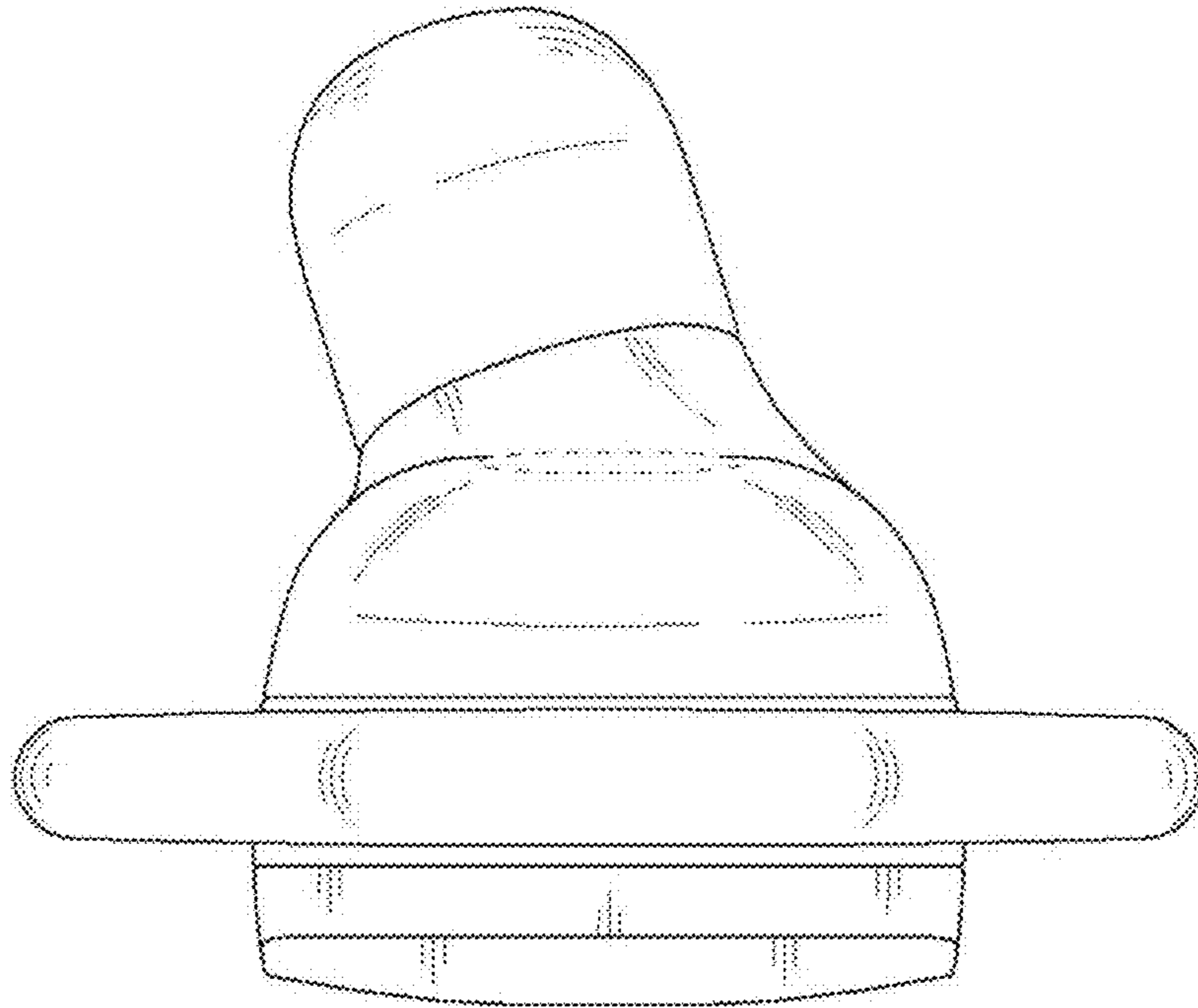
