The ornamental design for a display screen or portion thereof with transitional computer graphical user interface, as shown and described.

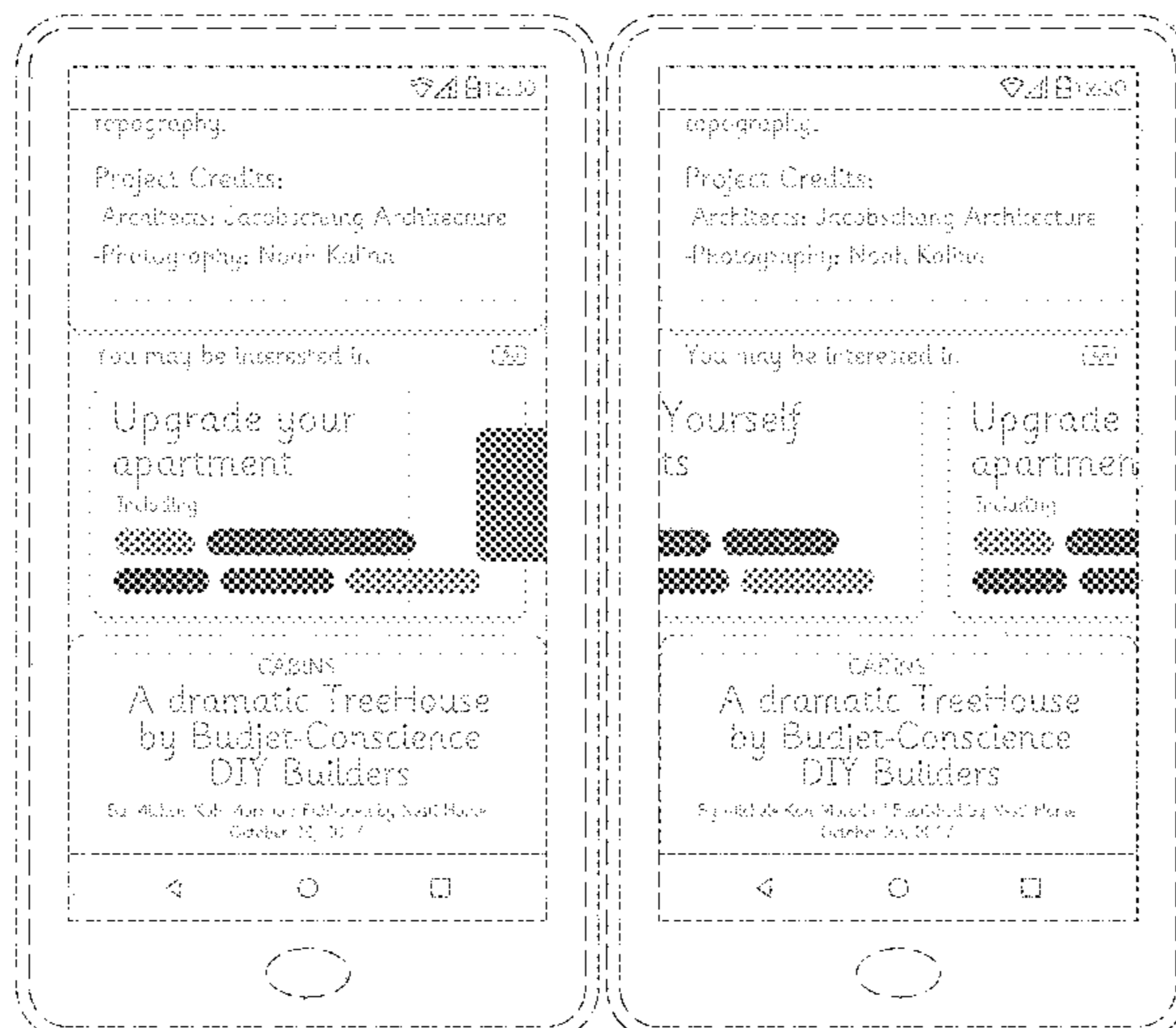
FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with transitional computer graphical user interface according to the claimed design; and, FIG. 2 is a second image thereof.

The appearance of the transition is sequential from FIG. 1 to FIG. 2. The process or period in which an image transitions to another image forms no part of the claimed design.

The grey shading in the rectangle which contains the broken-line arrow in FIGS. 1 and 2 depicts a contrast in appearance.

The outermost long-dashed broken lines illustrate an electronic device, which constitutes the environment of the design and forms no part of the claim. The intermediate-length dashed broken line illustrates a display screen and the boundary of the design and forms no part of the claim. The remaining short-dashed broken lines illustrate portions of the graphical user interface that form no part of the claimed design.

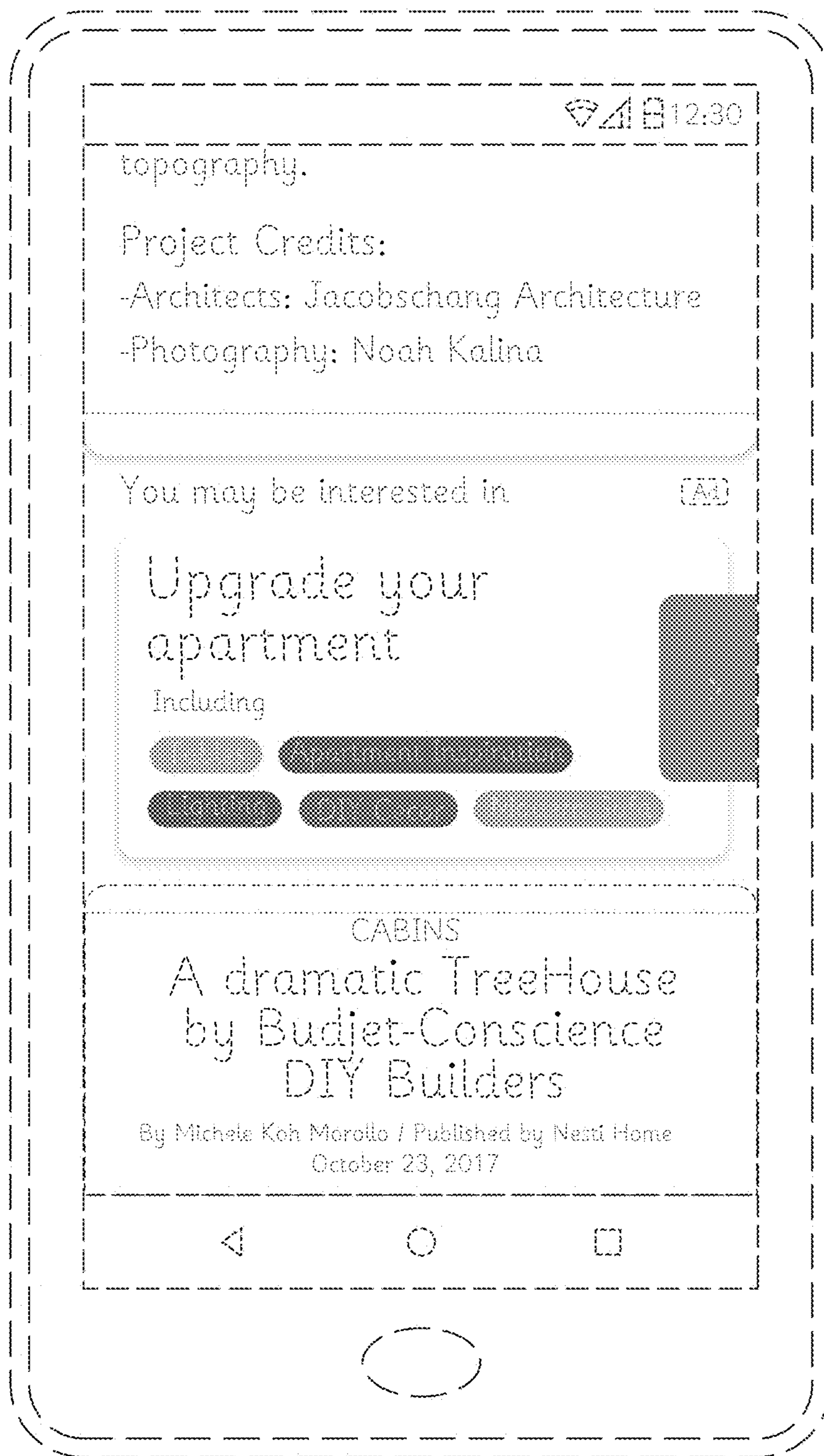

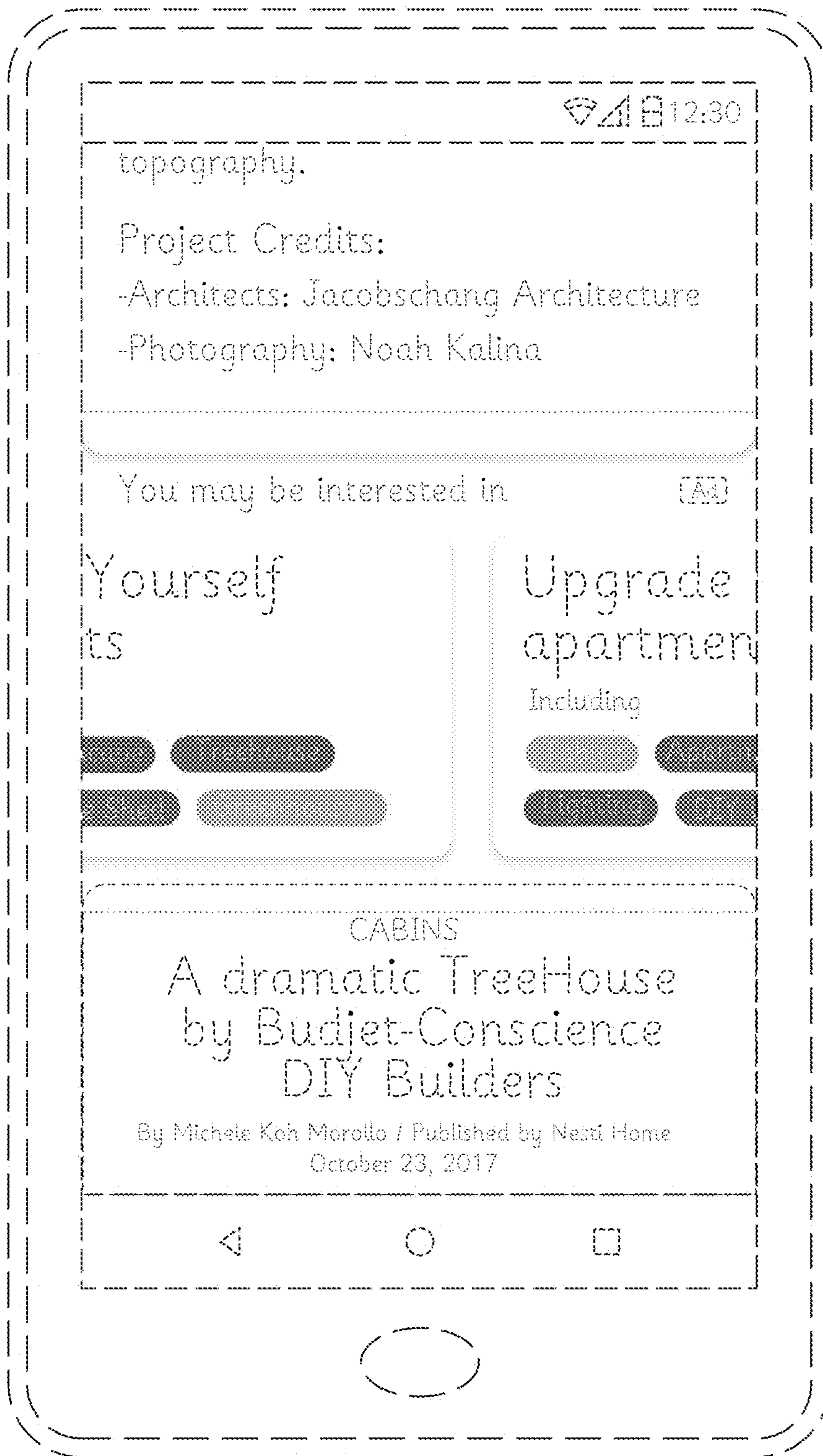
