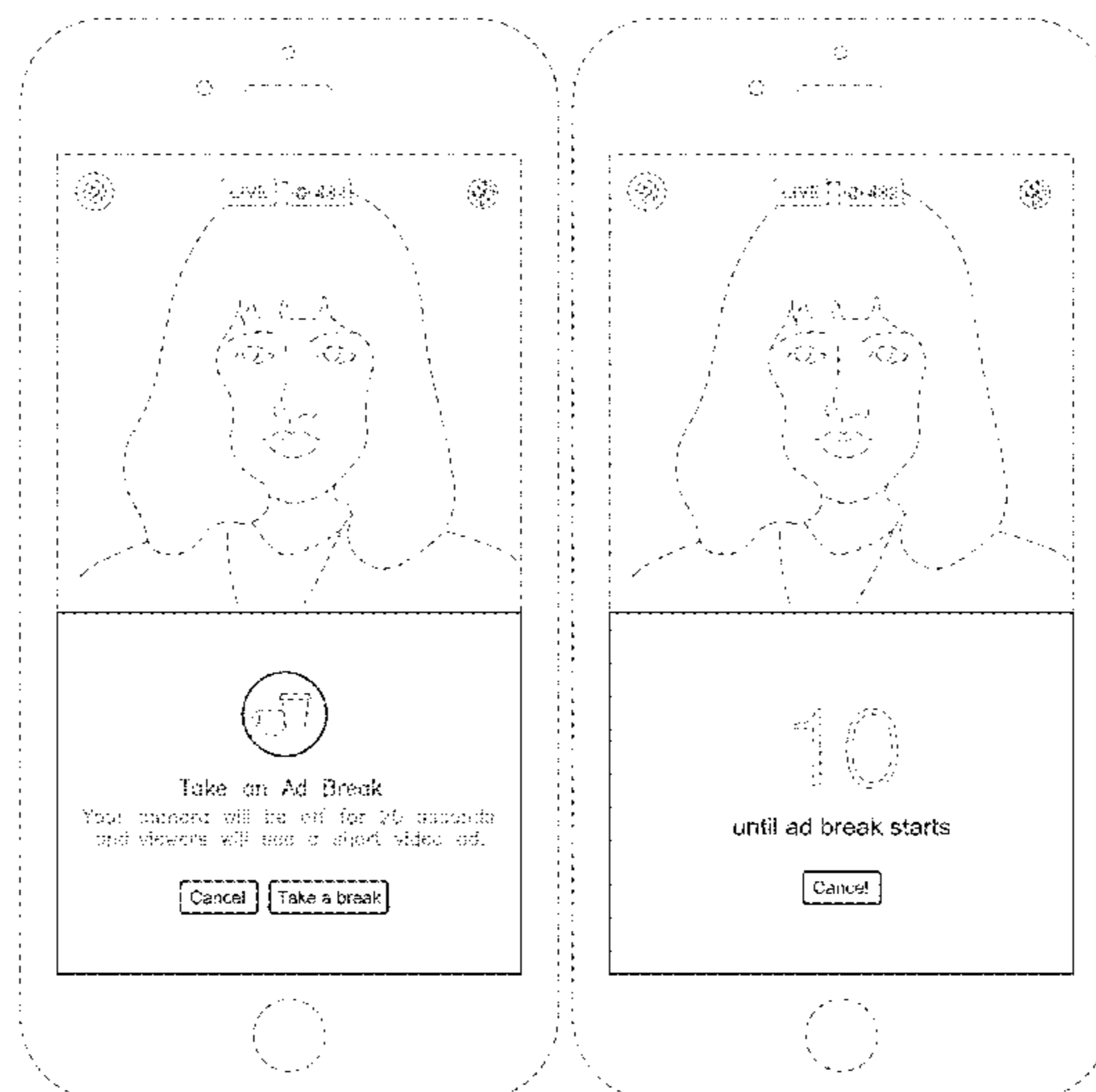
(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with graphical user interface, showing the new design; and, FIG. 2 is a front view of a second embodiment of the display screen with graphical user interface. The outermost broken lines illustrate a mobile device, which is the environment of the design and form no part of the claim. The remaining broken lines illustrate a display screen and portions of the graphical user interface and form no part of the claimed design.

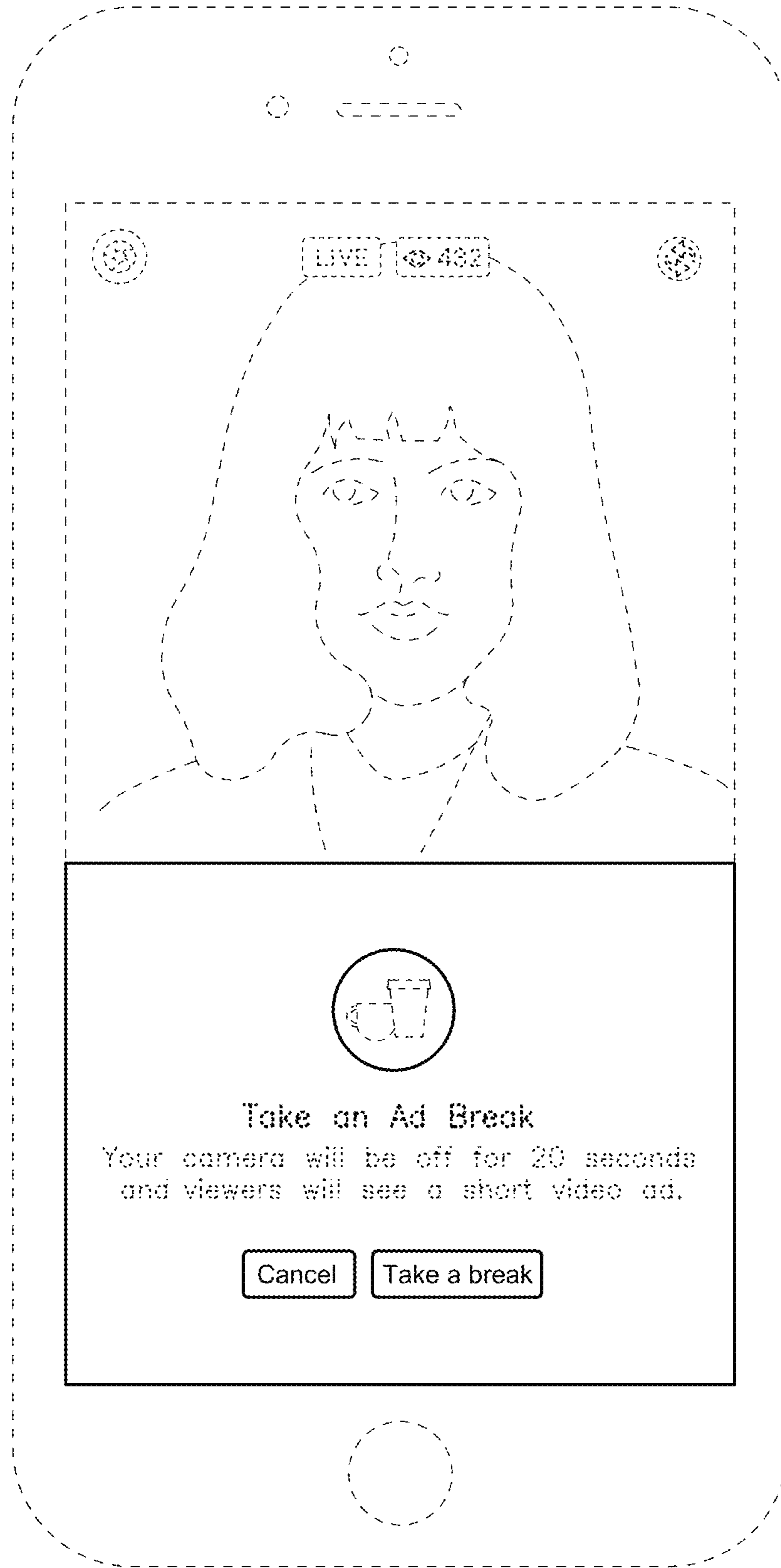

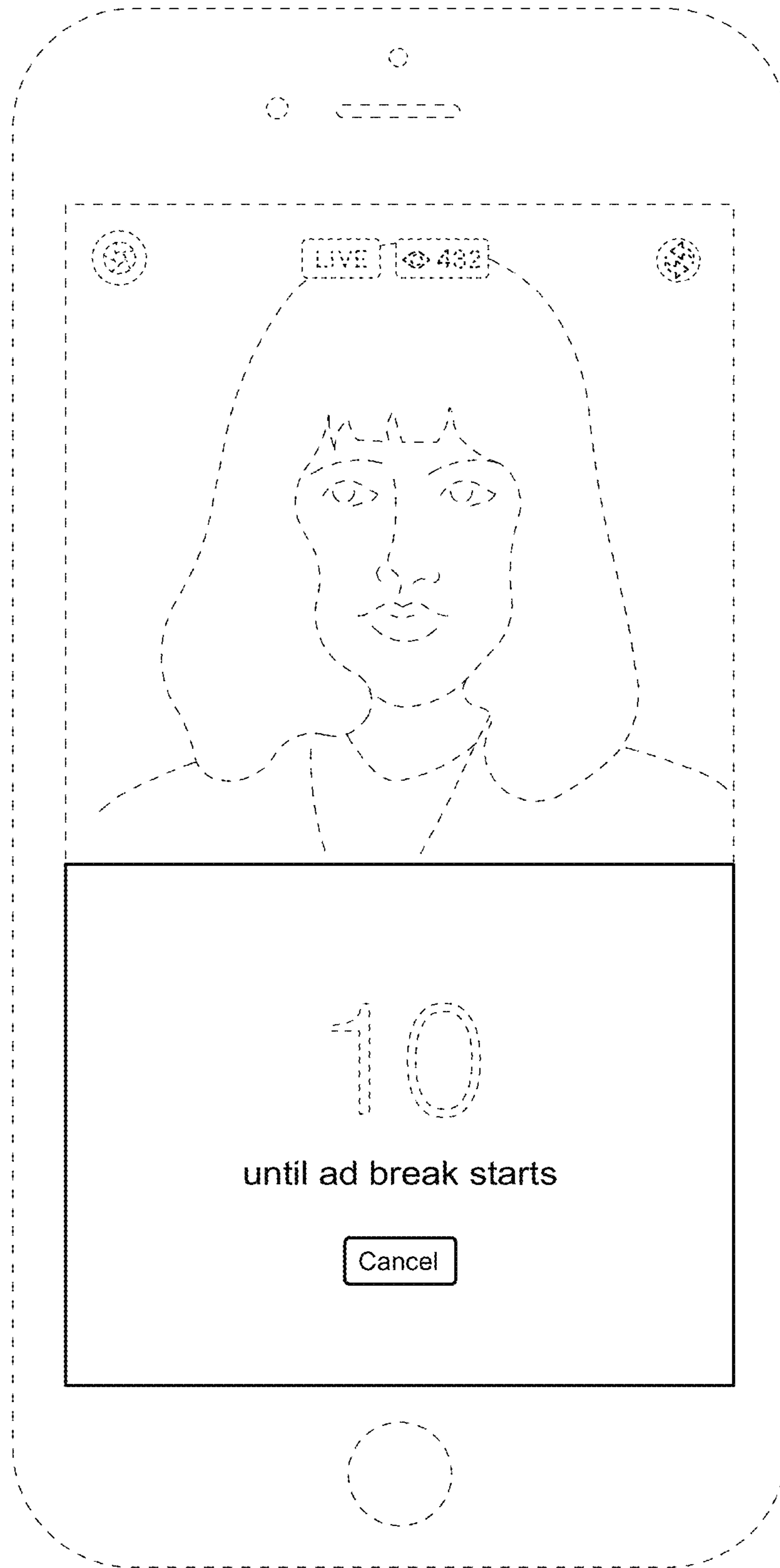
