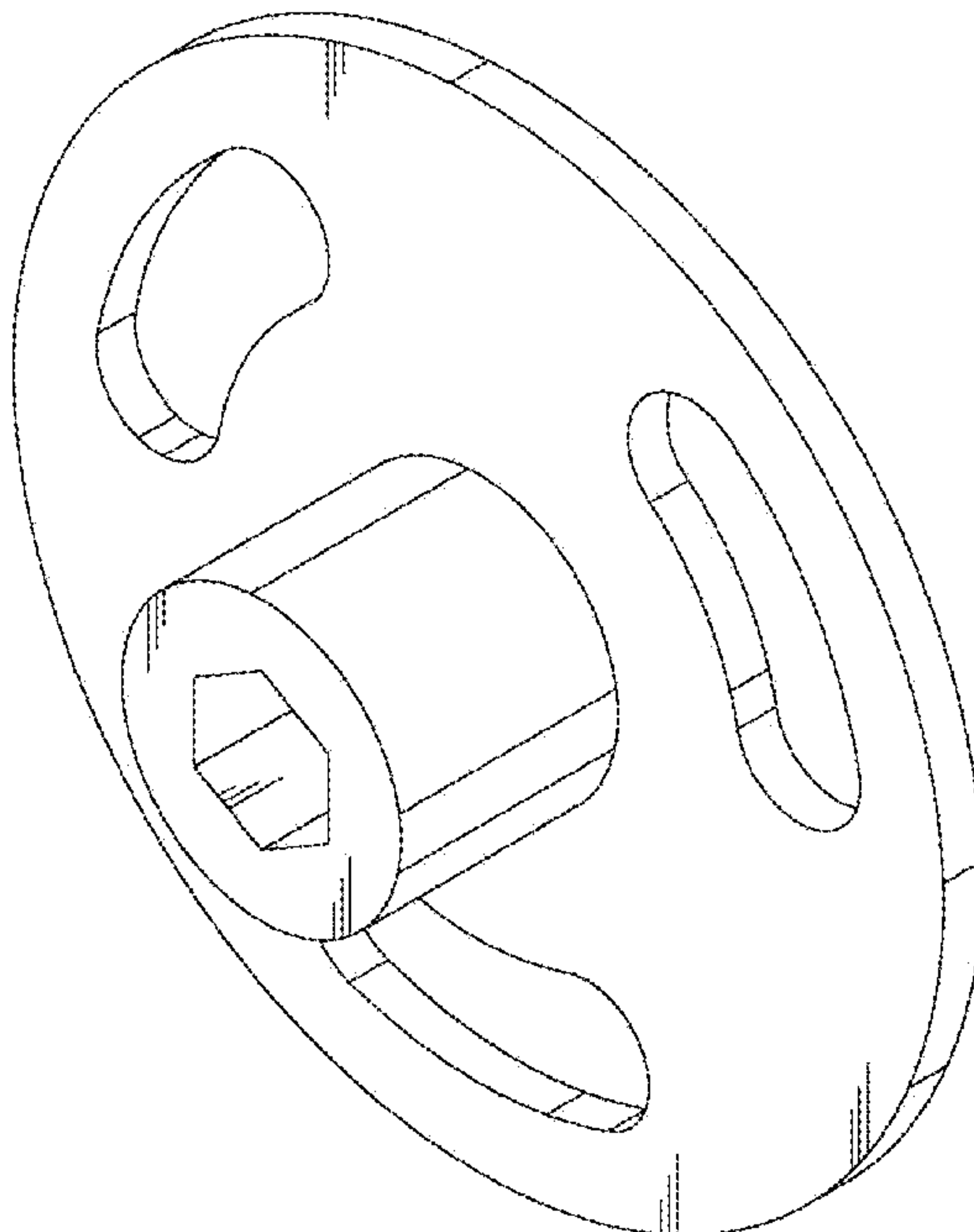
(57) **CLAIM**

The ornamental design for a compressor front plate locking member, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and upper perspective view of a compressor front plate locking member showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a right side elevational view thereof; FIG. 8 is a rear perspective view thereof; and, FIG. 9 is a front and bottom perspective view thereof.

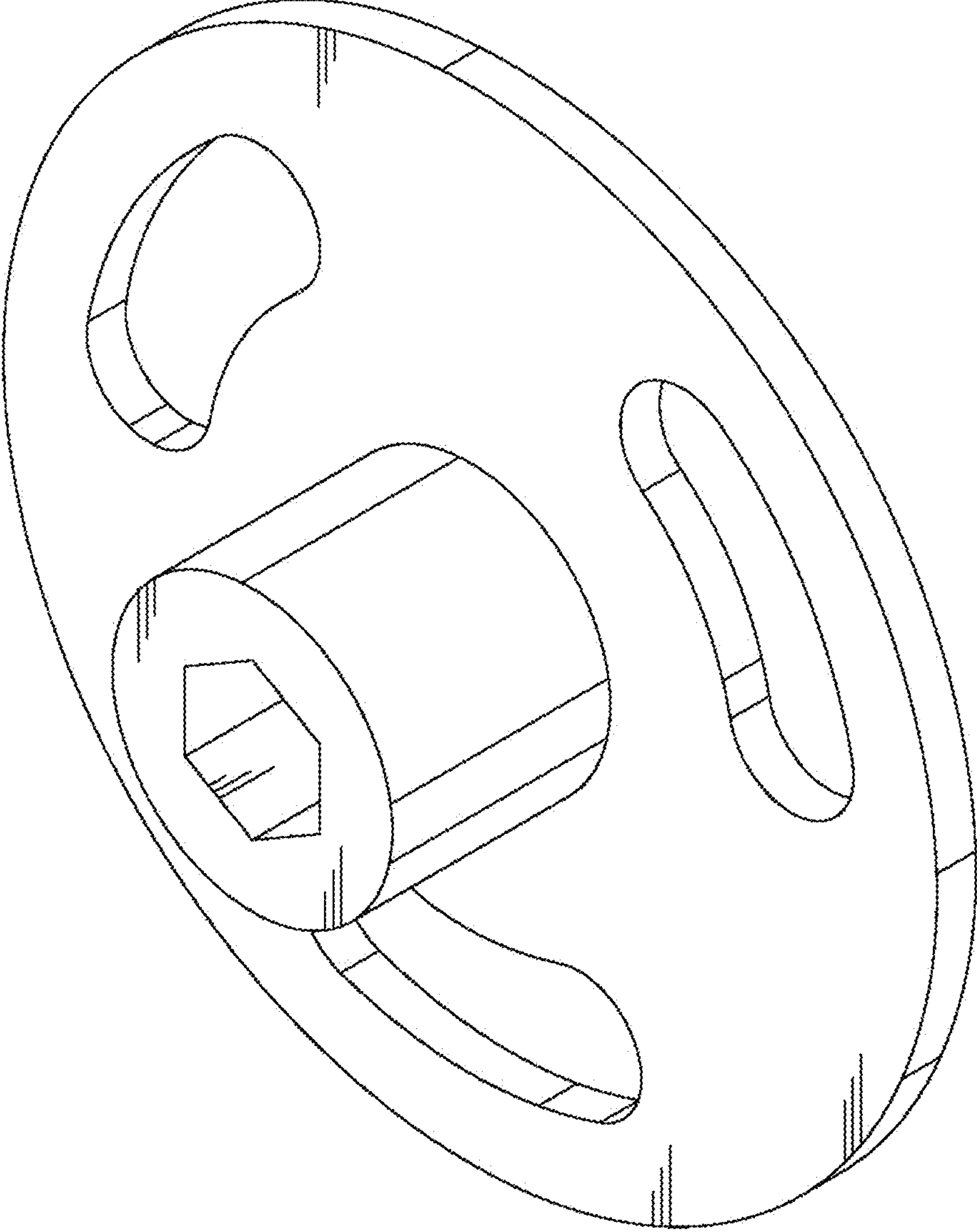

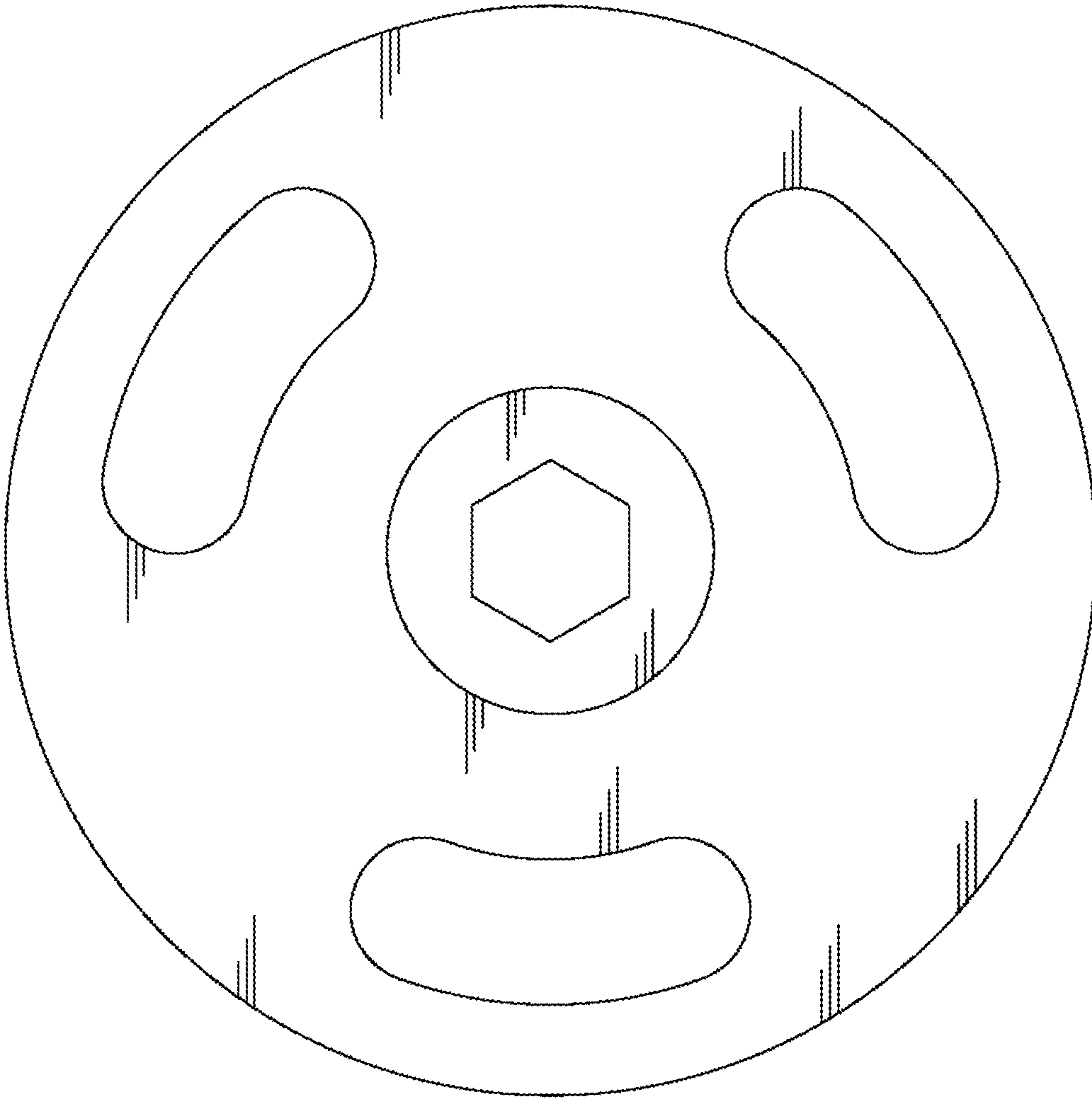

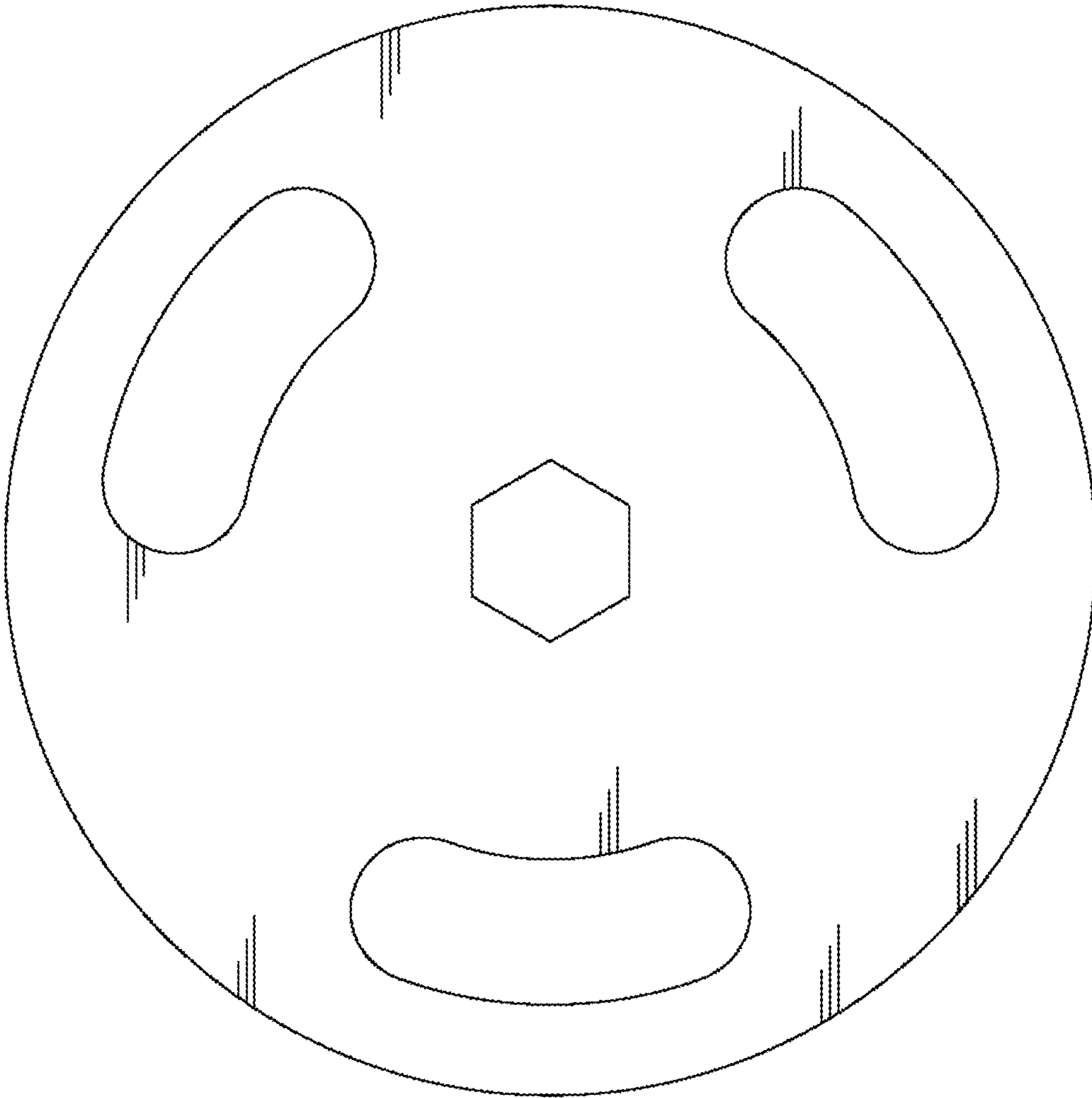

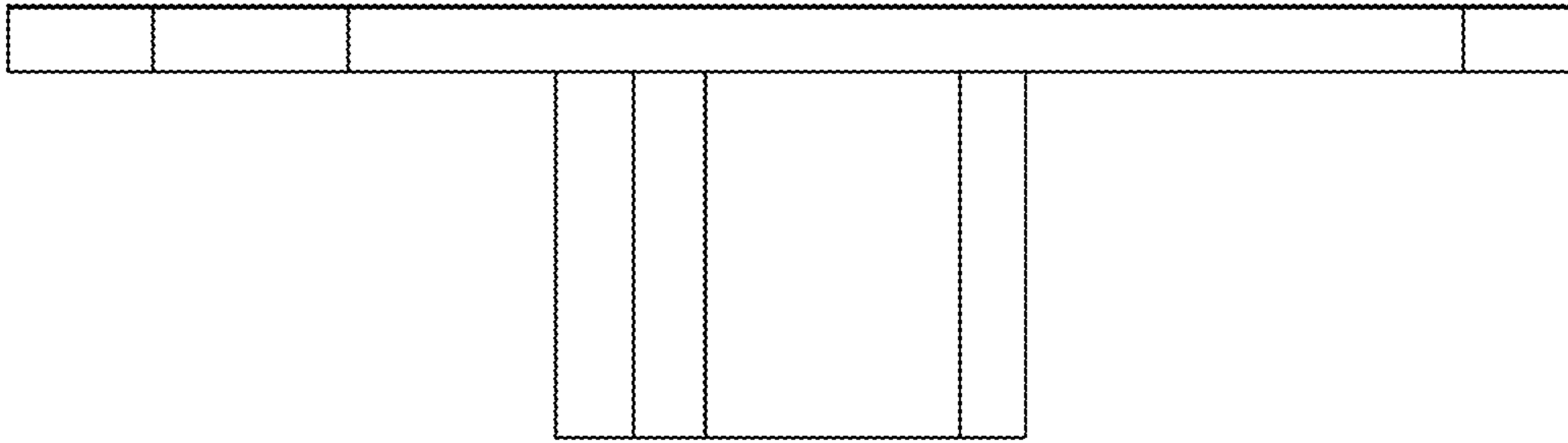

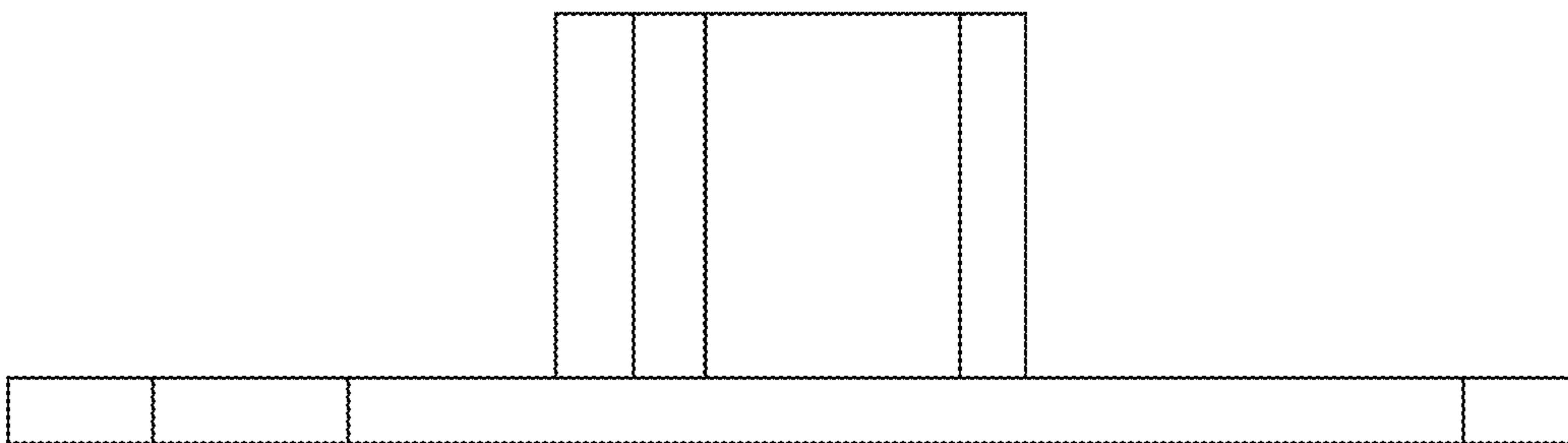

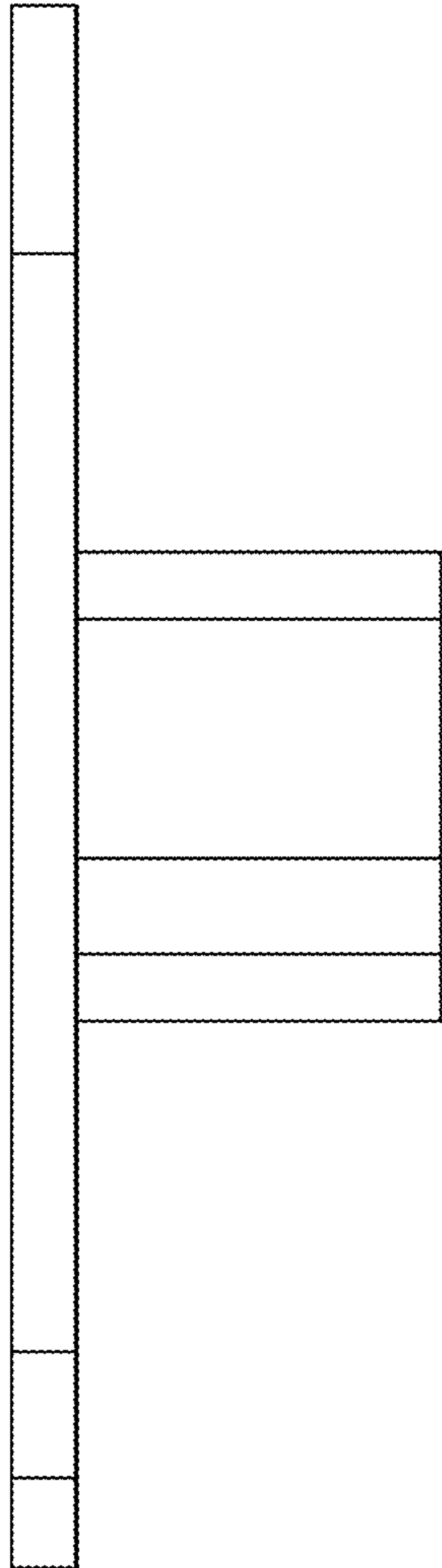

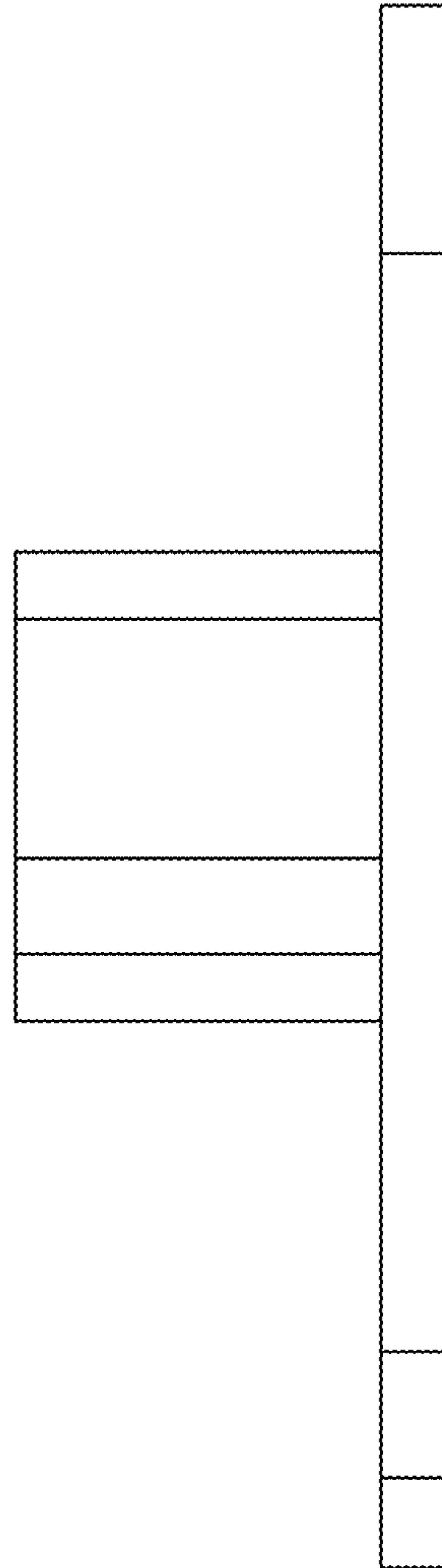

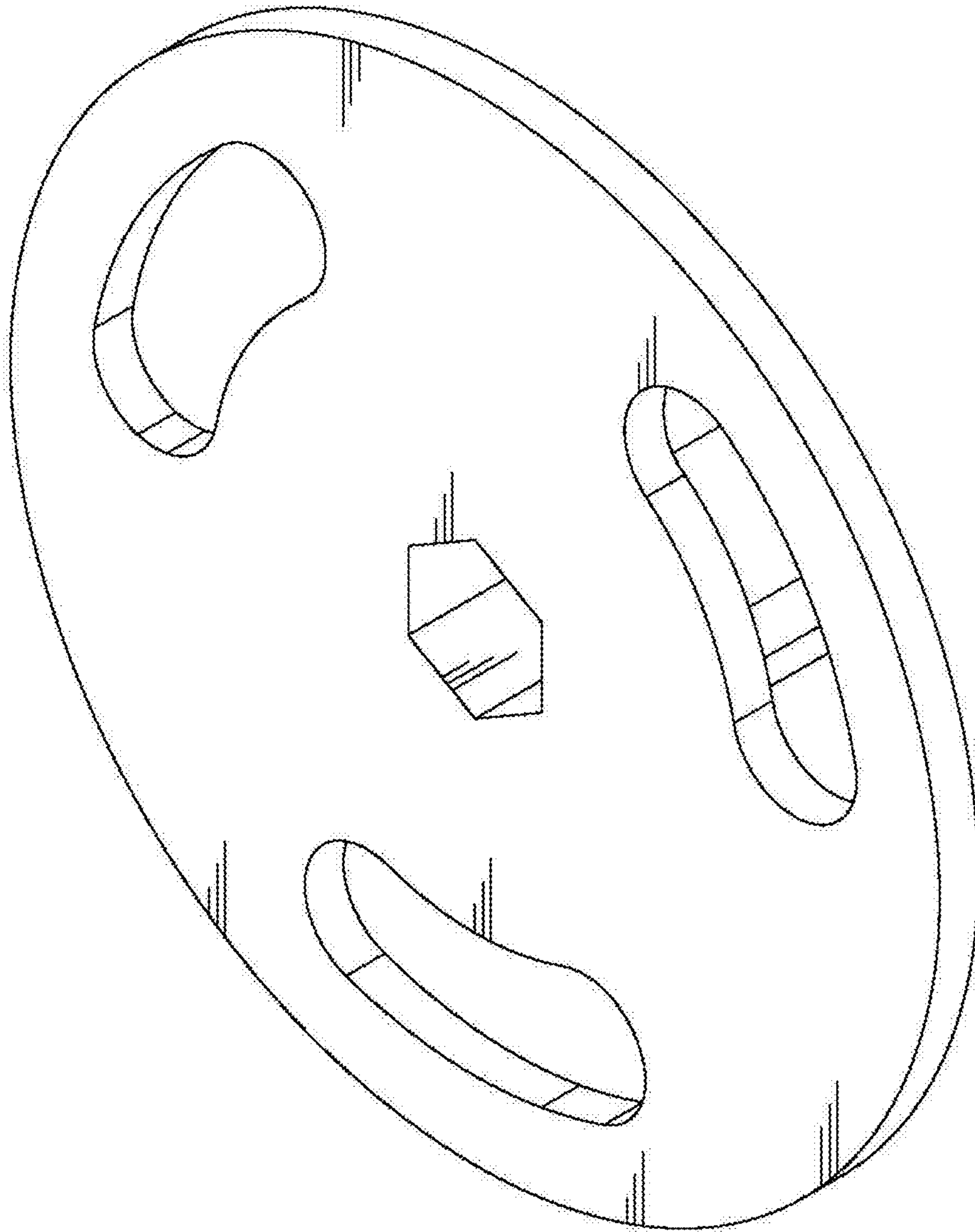

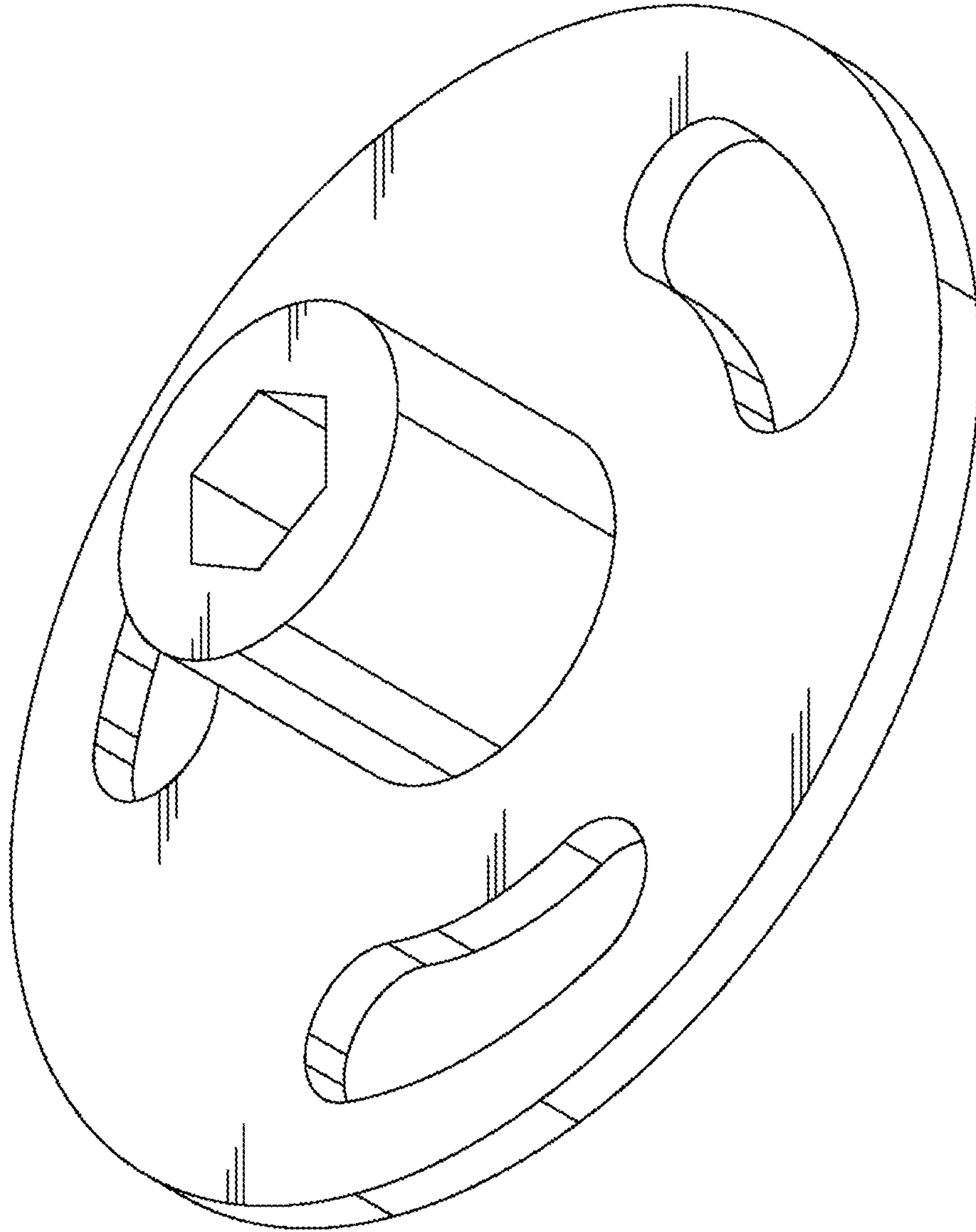
