We claim the ornamental design for a pair of paddles for swim training, as shown and described.

FIG. 3 is a bottom plan view of a pair of paddles for swim training thereof;

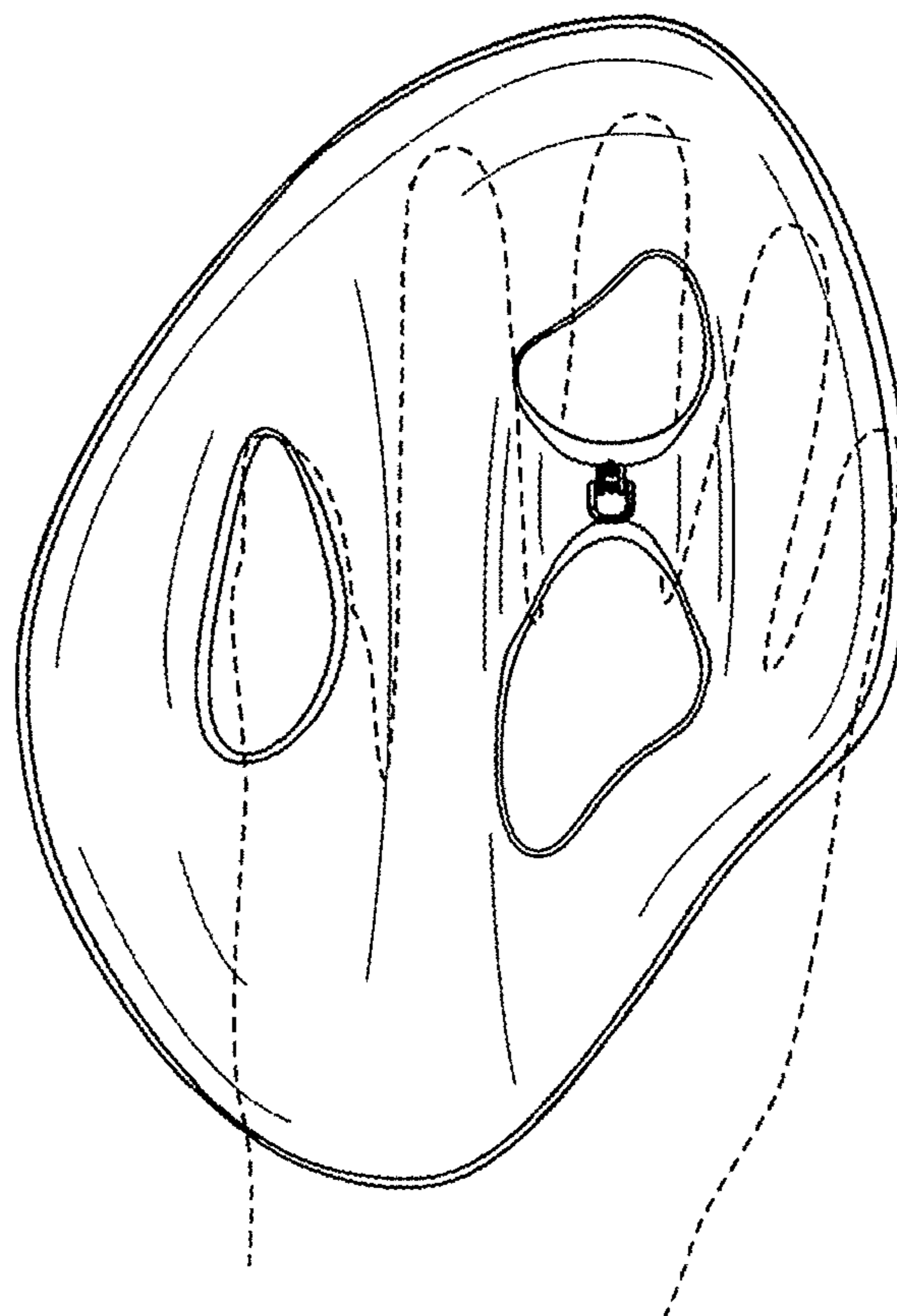
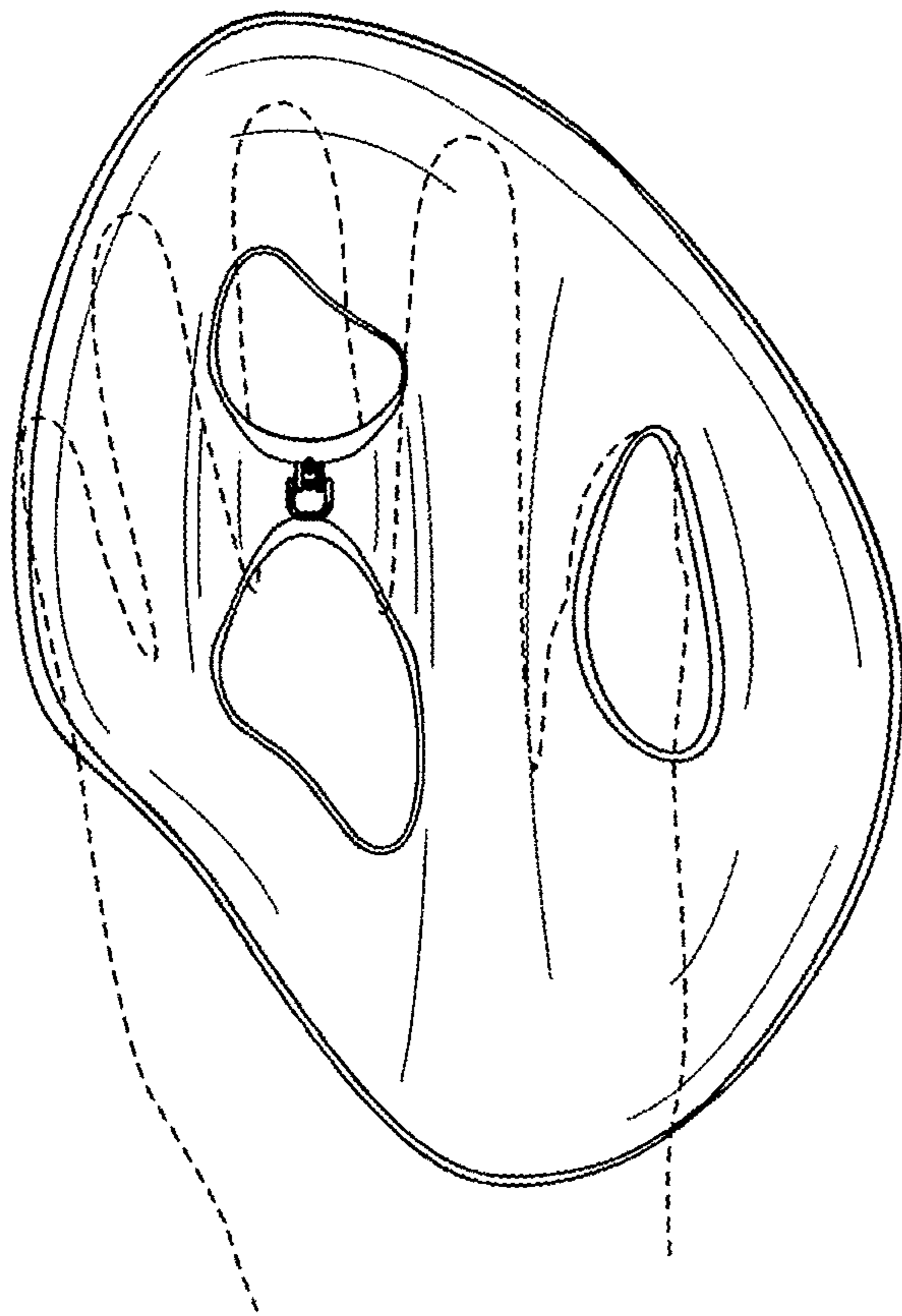
FIG. 4 is an outer or inner side view of a pair of paddles for swim training thereof;

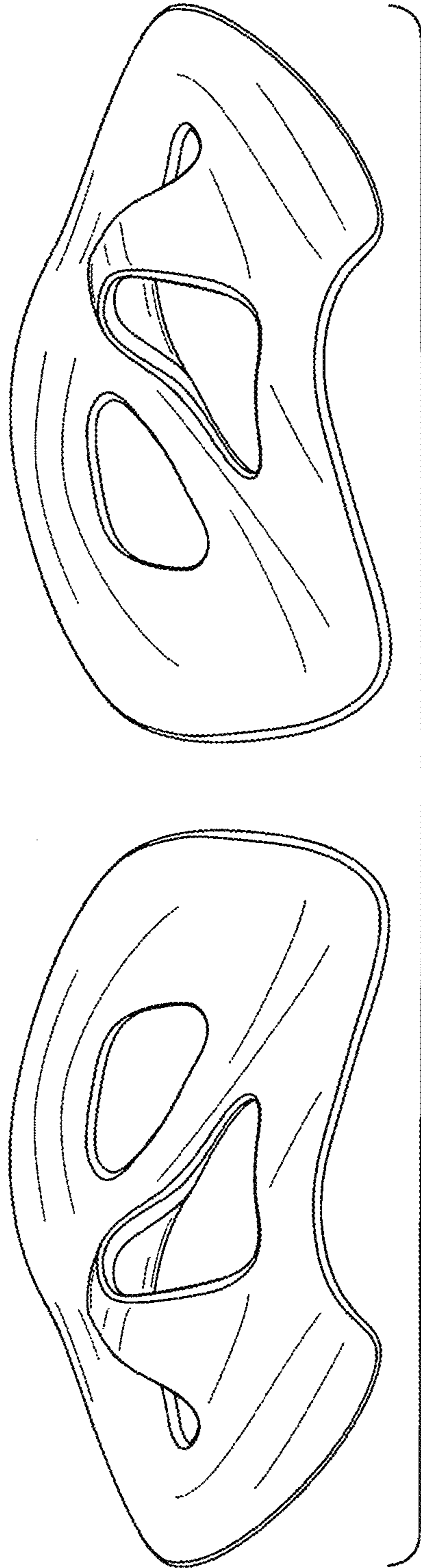

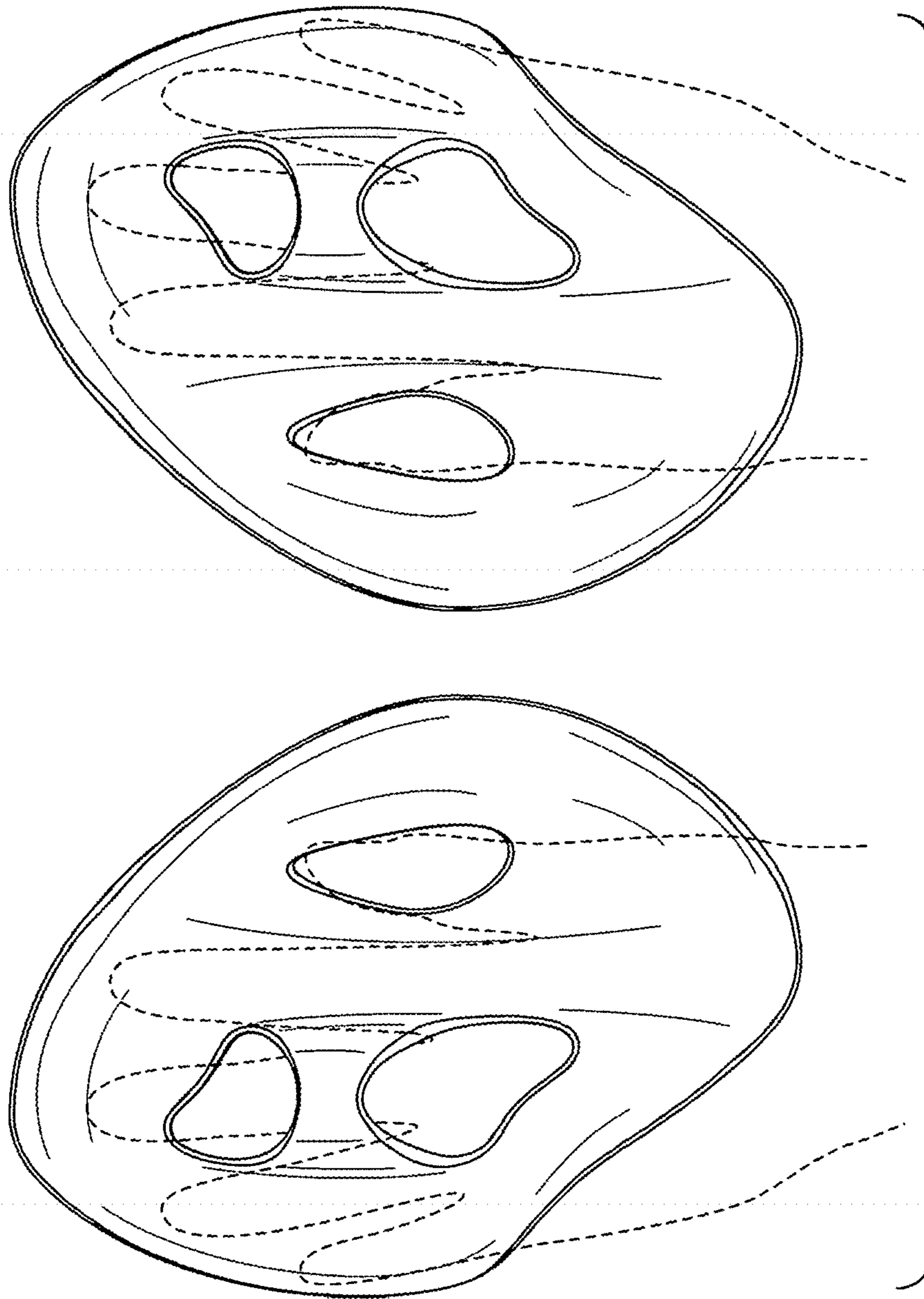

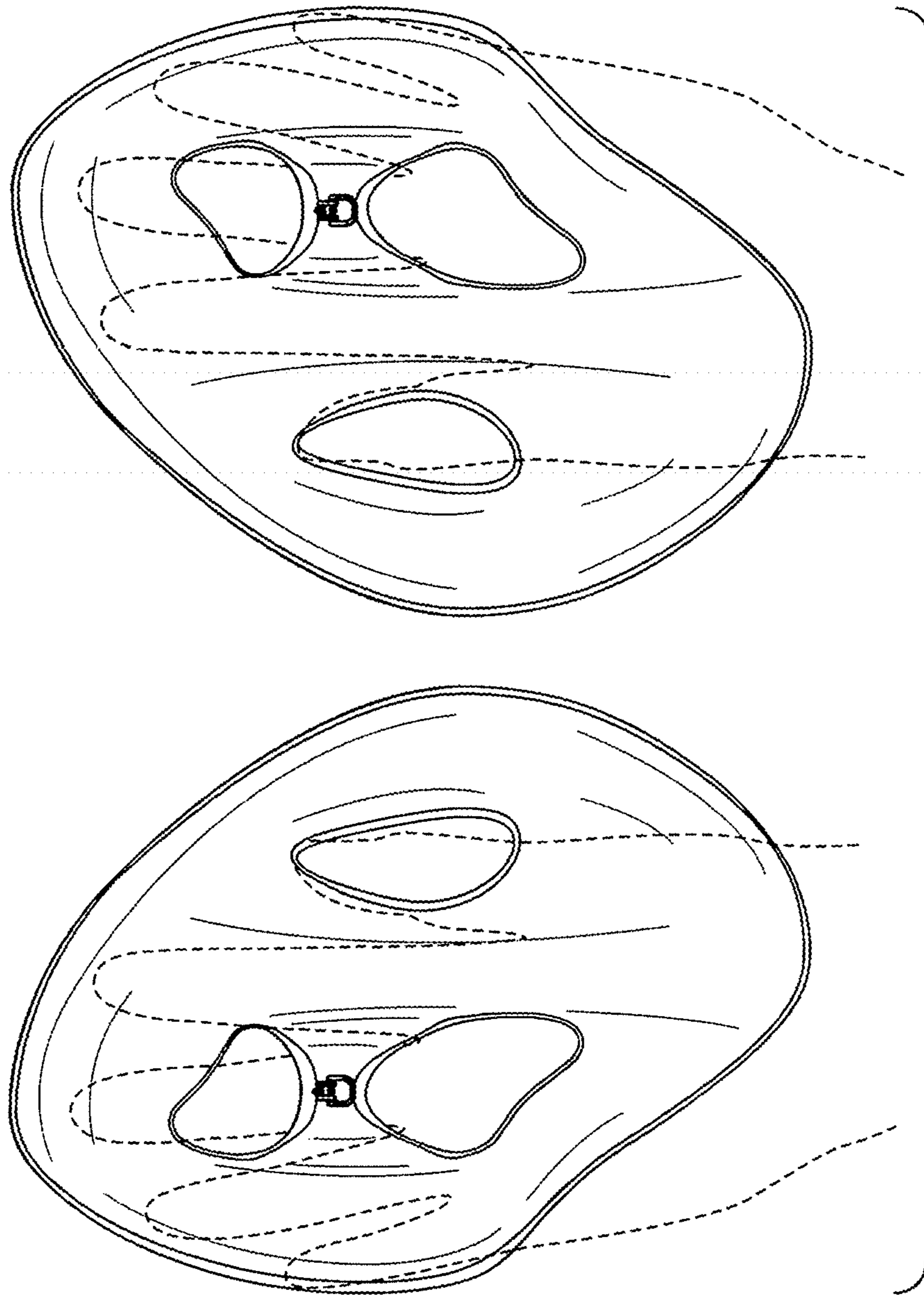

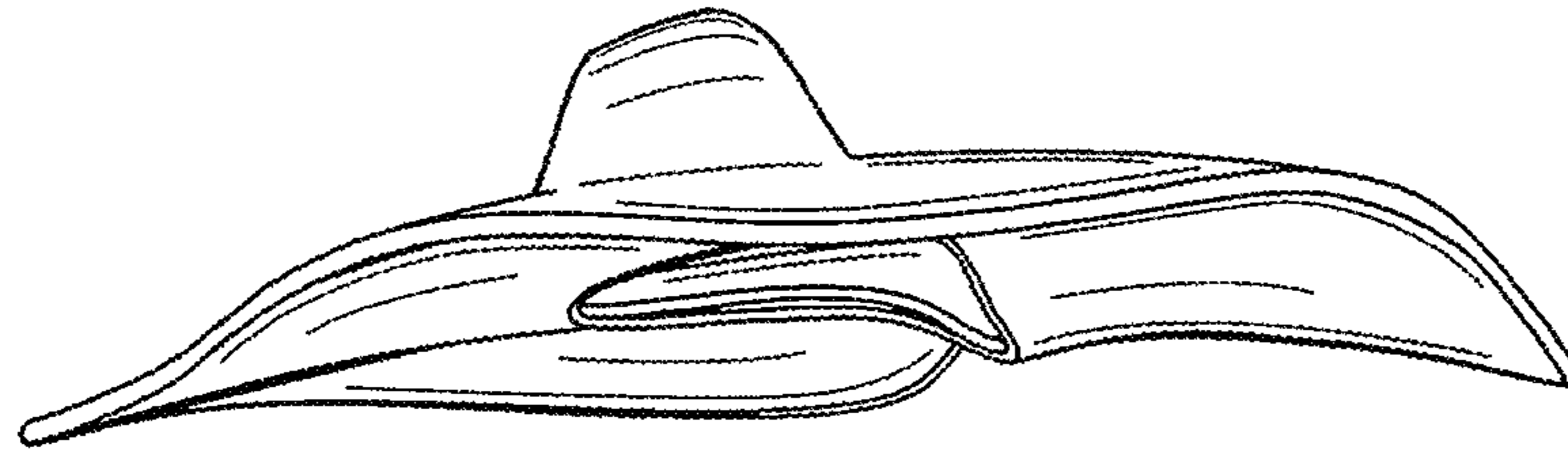

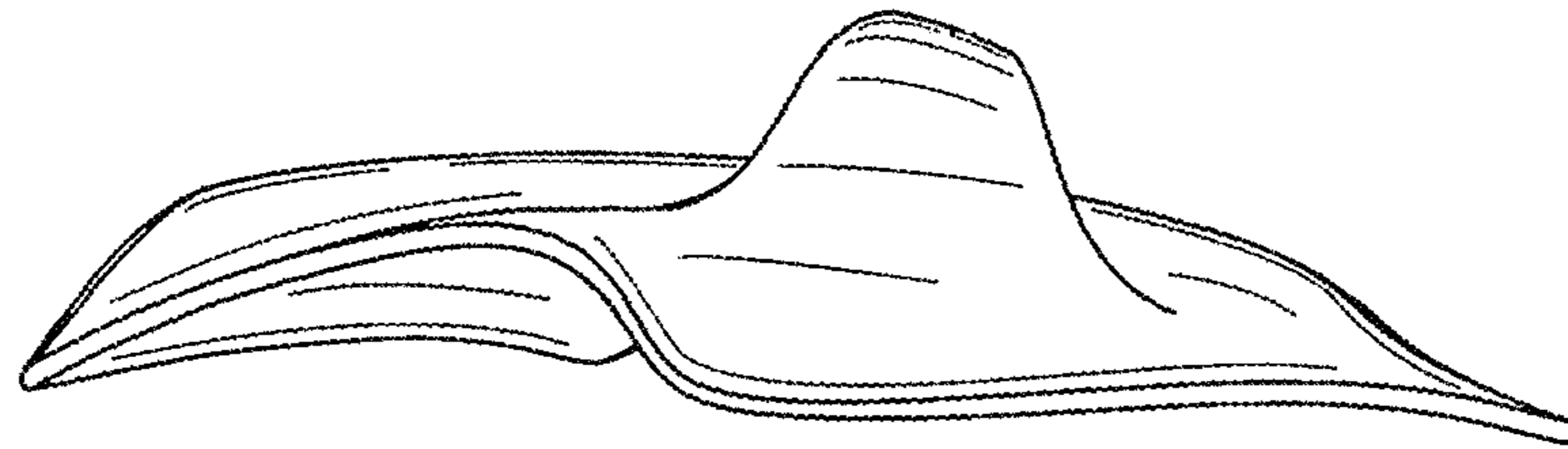

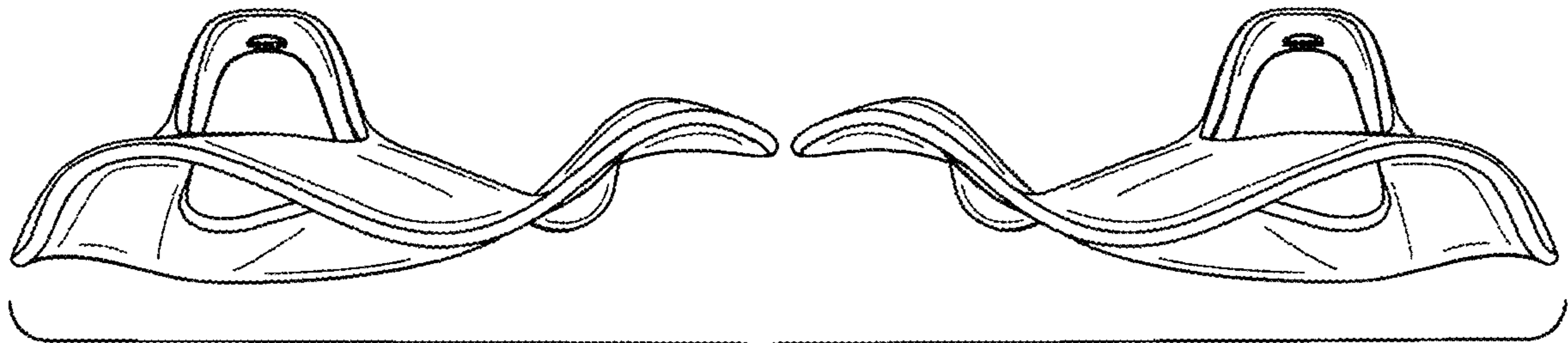

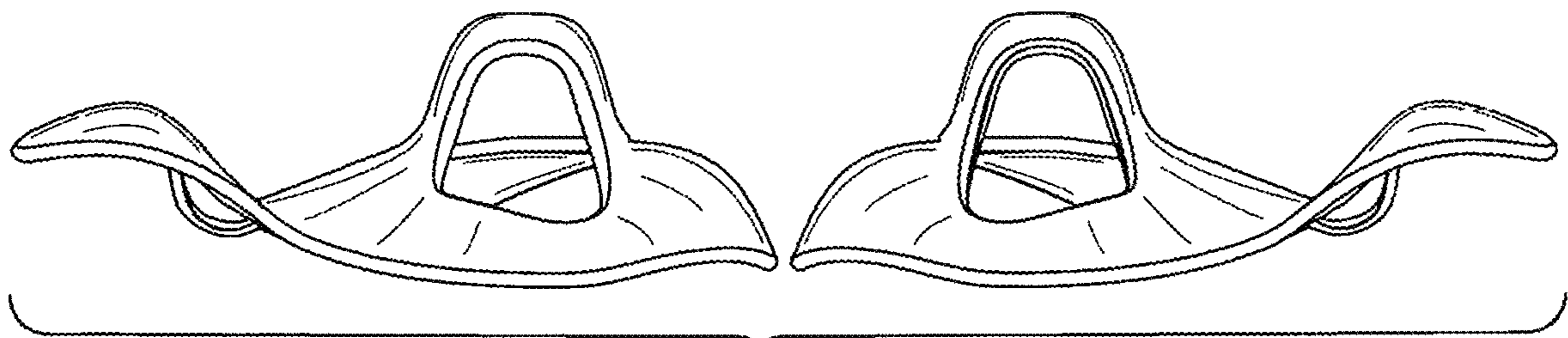
