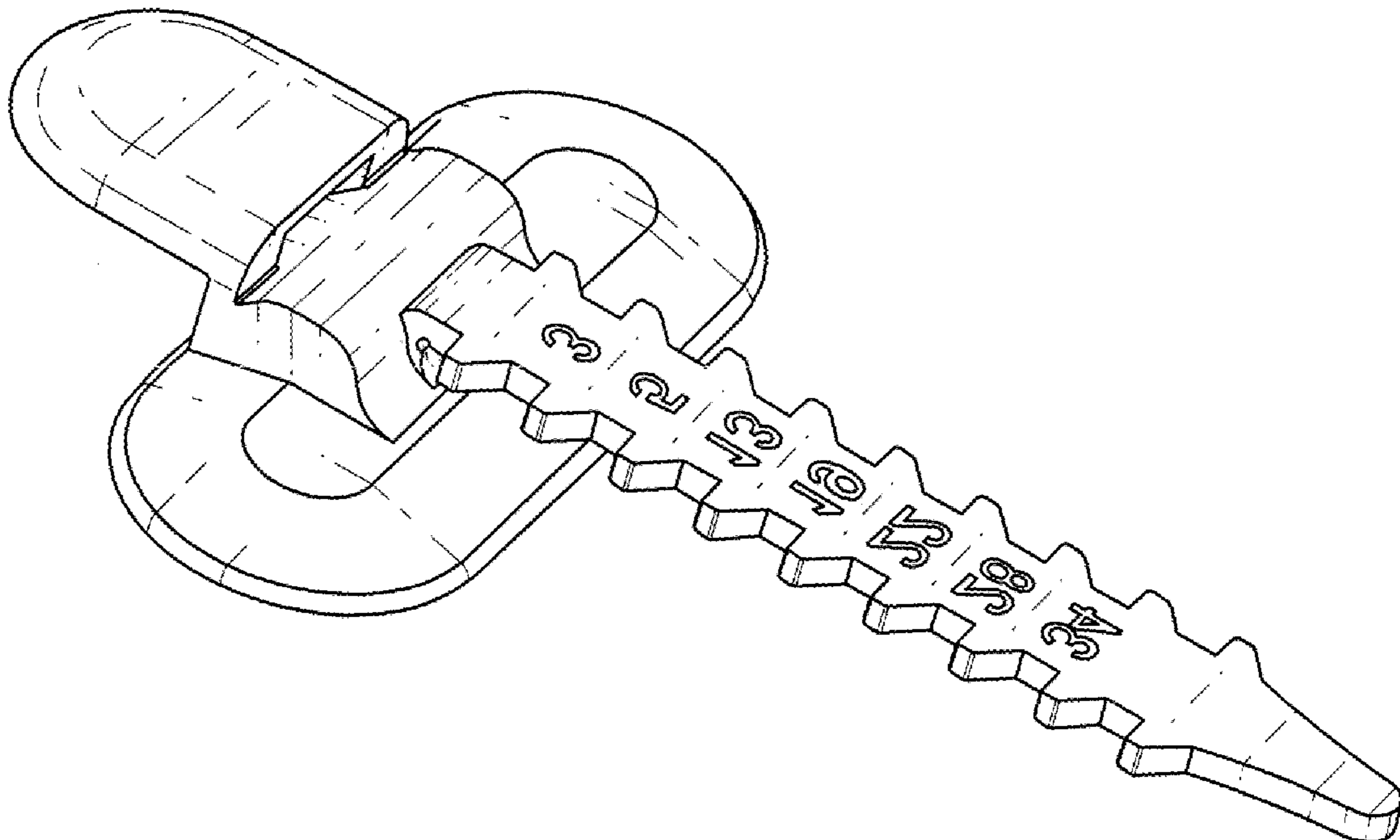
The ornamental design for a single strap low profile gripping device, as shown and described.

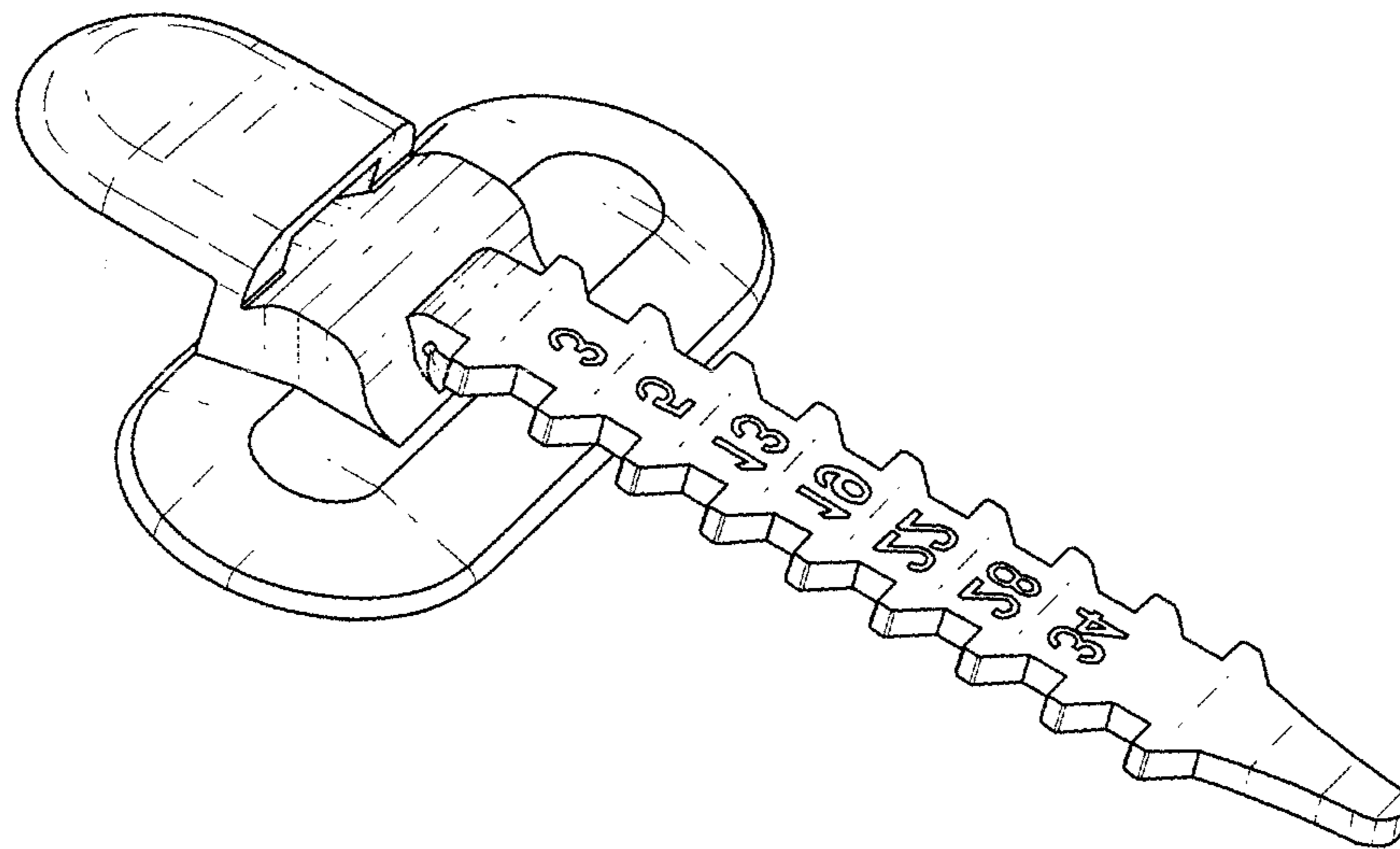

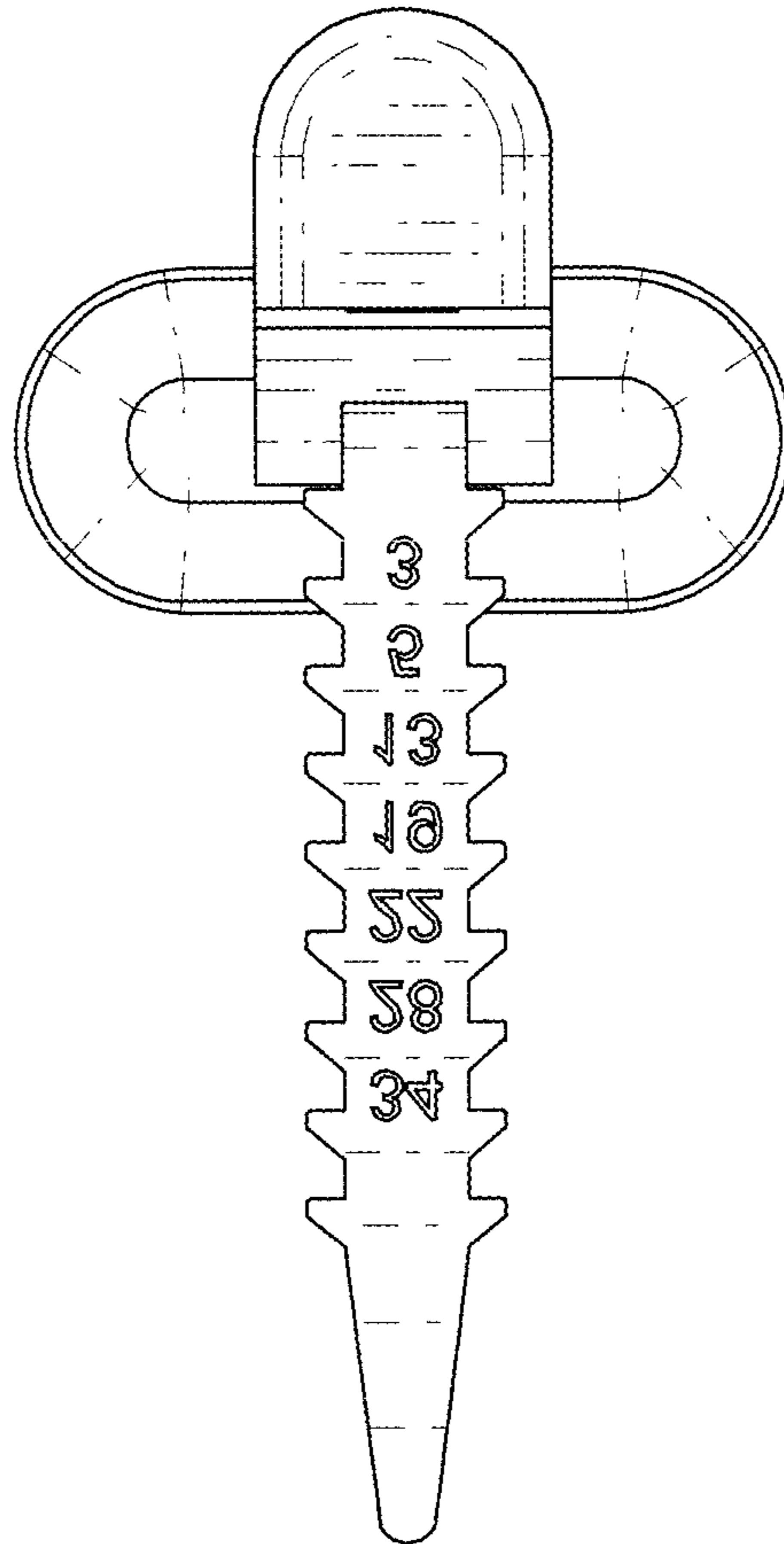

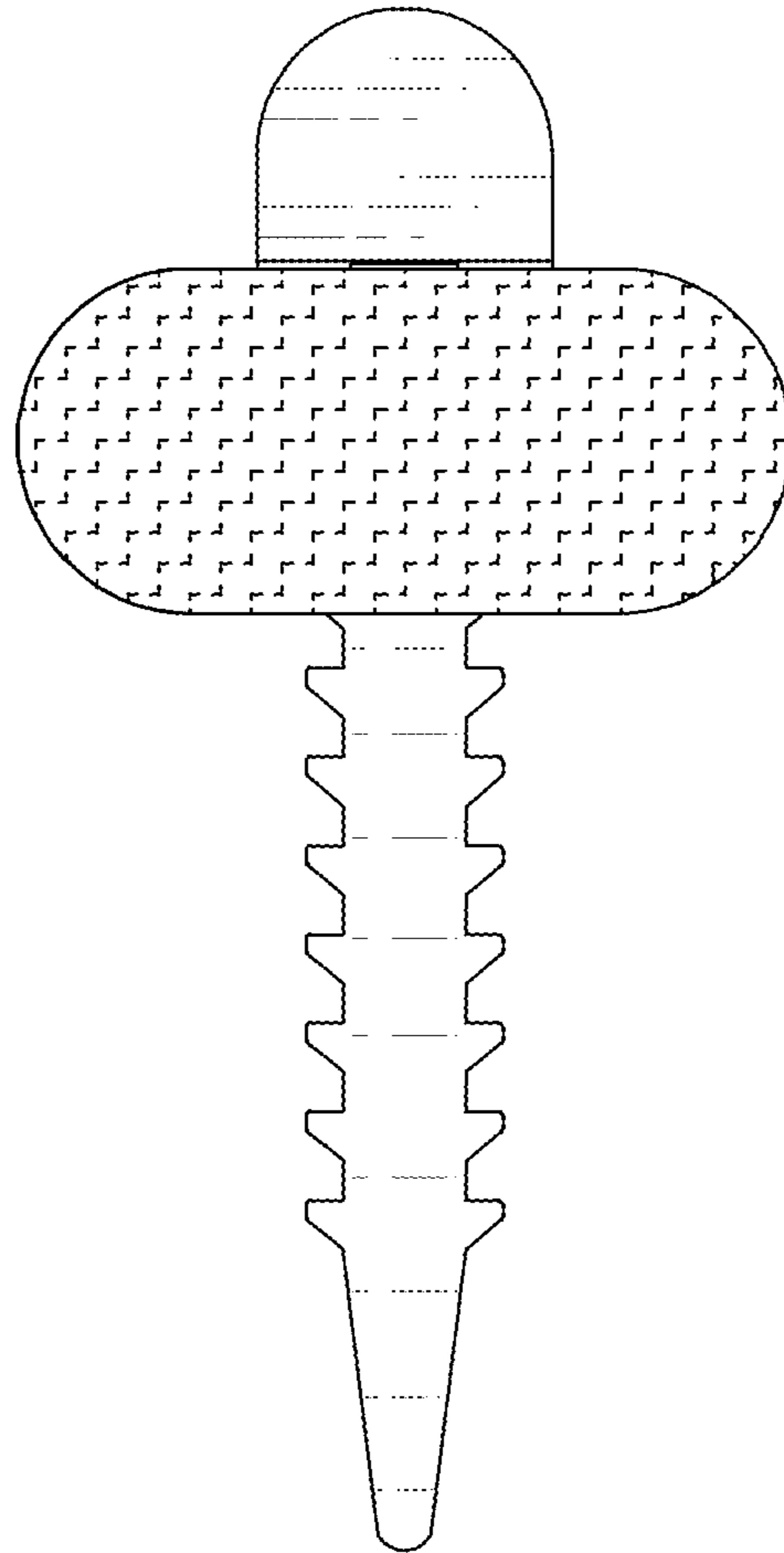

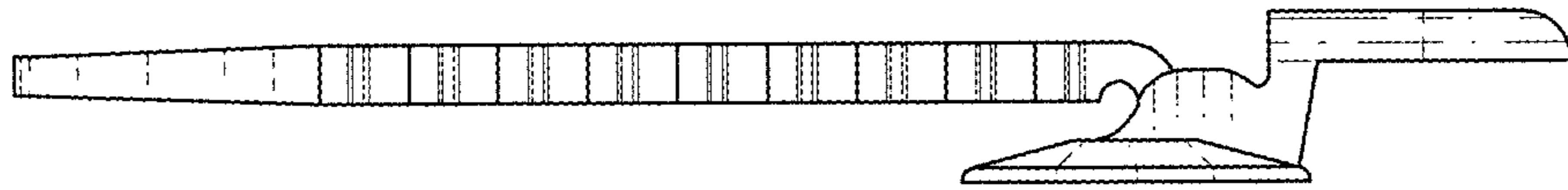

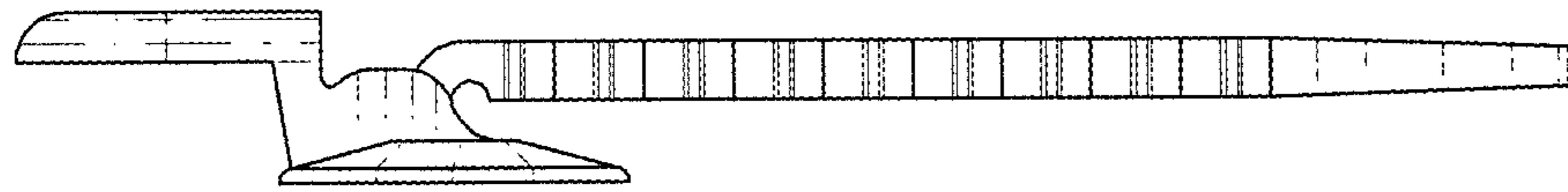

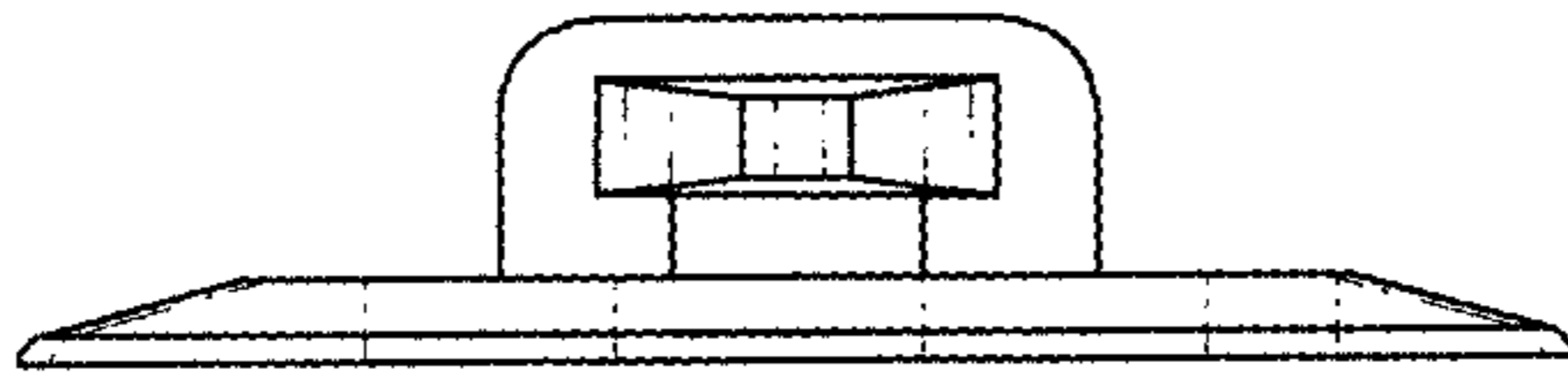
