1.4 : Left

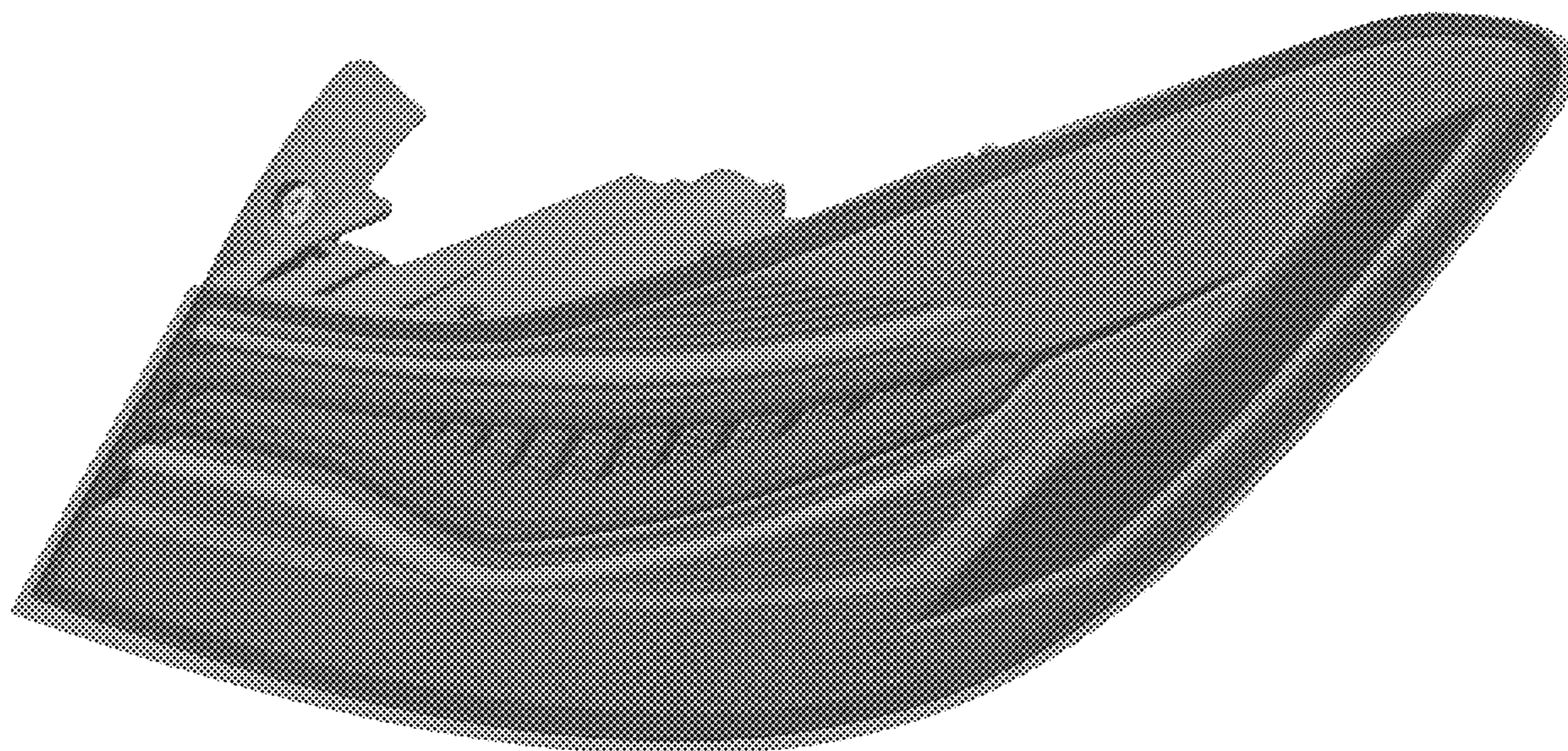

1.6 : Top

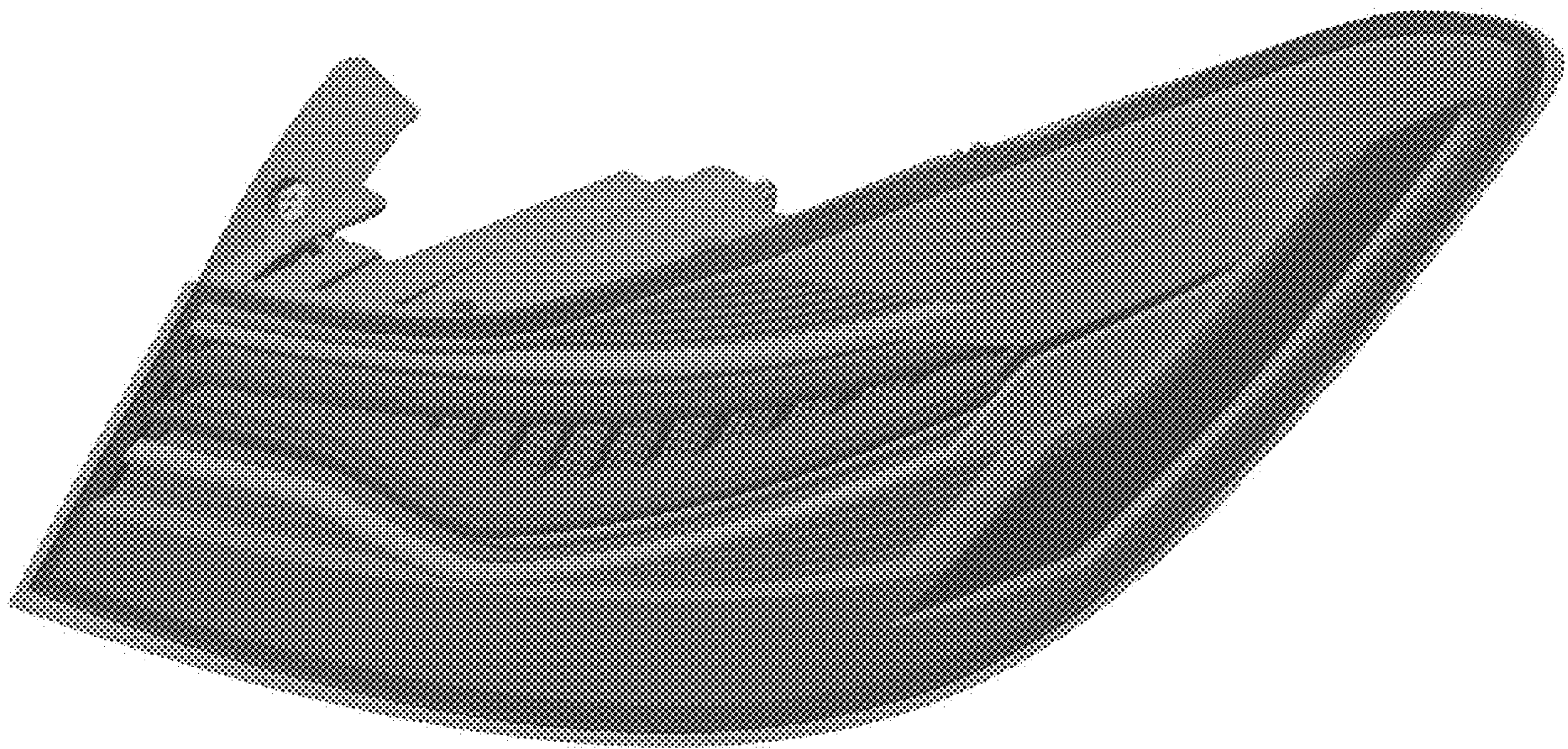
1.7 : Bottom

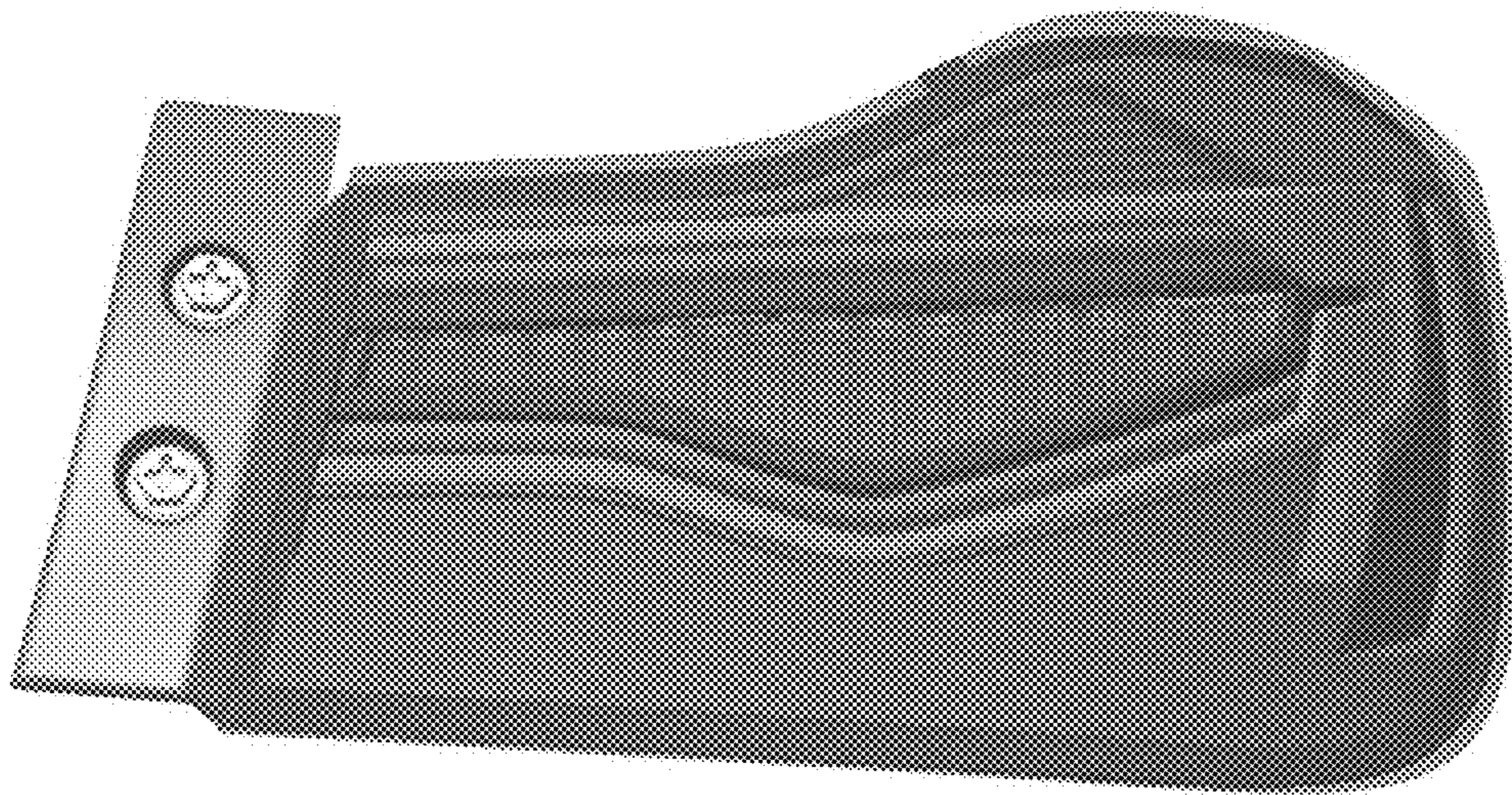

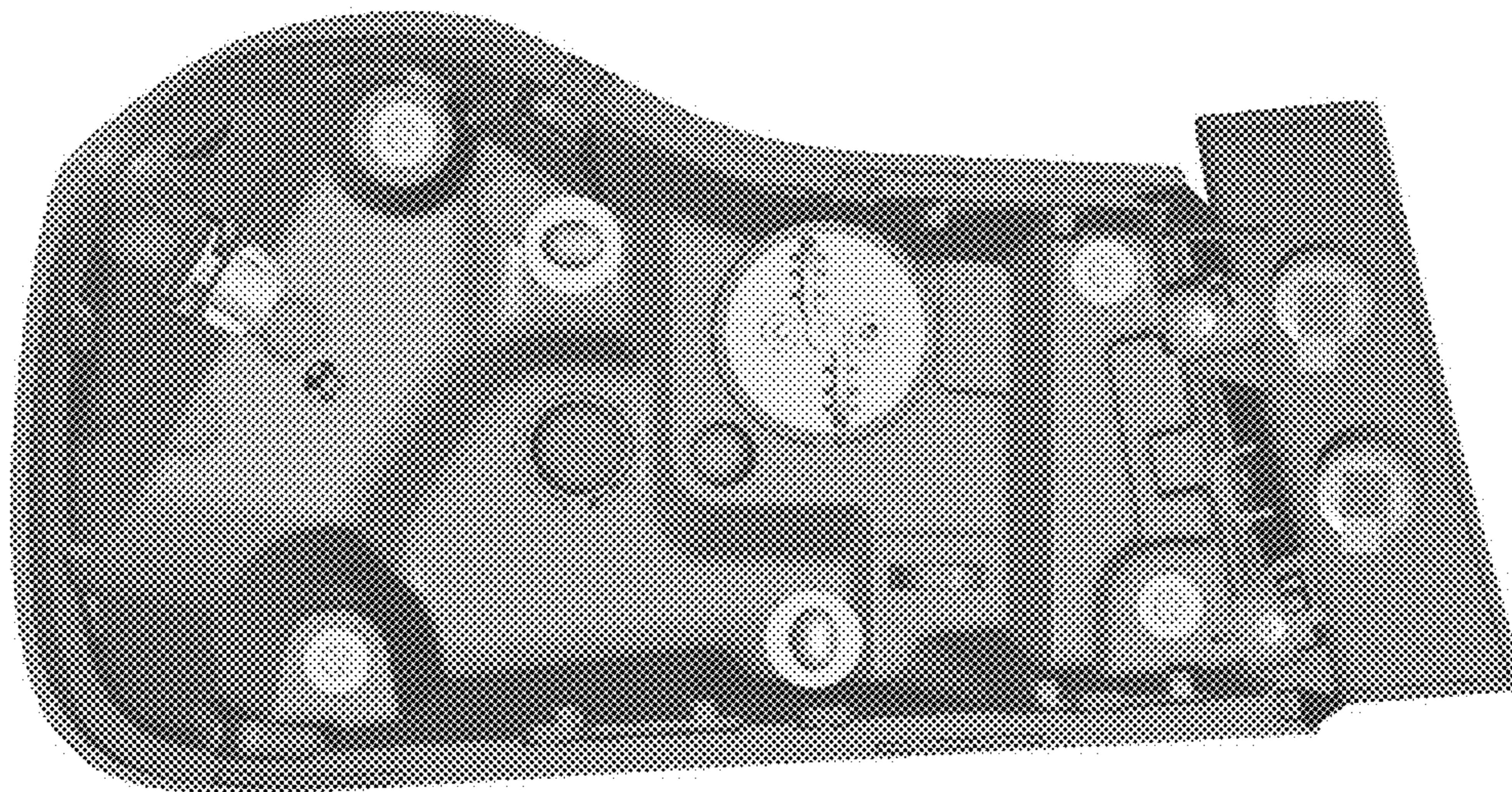

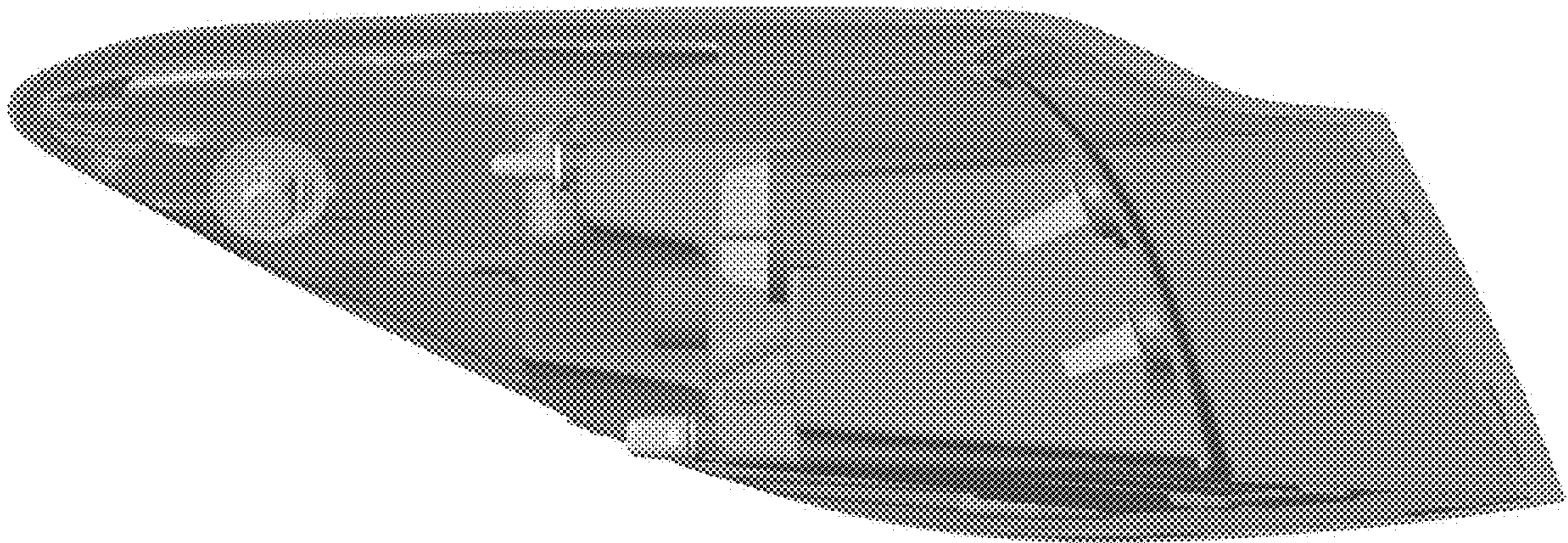

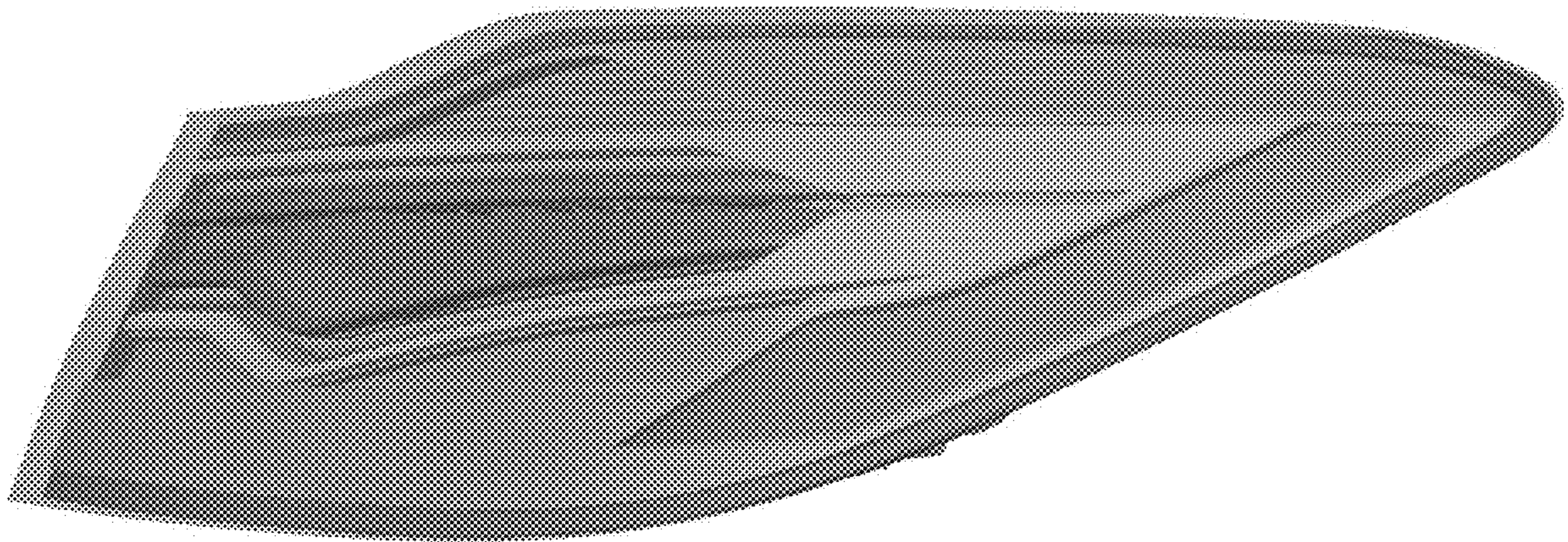

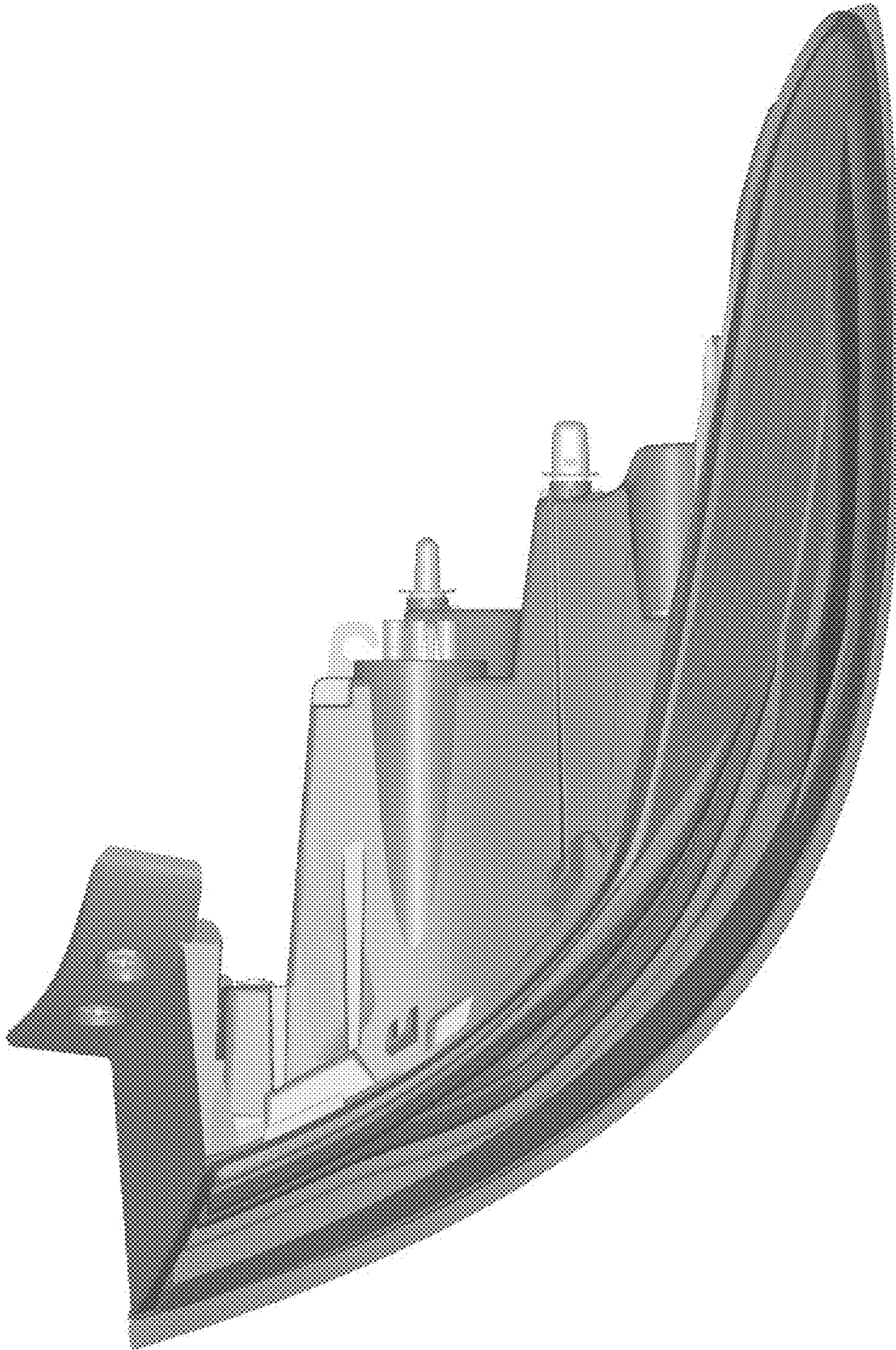
