DESCRIPTION

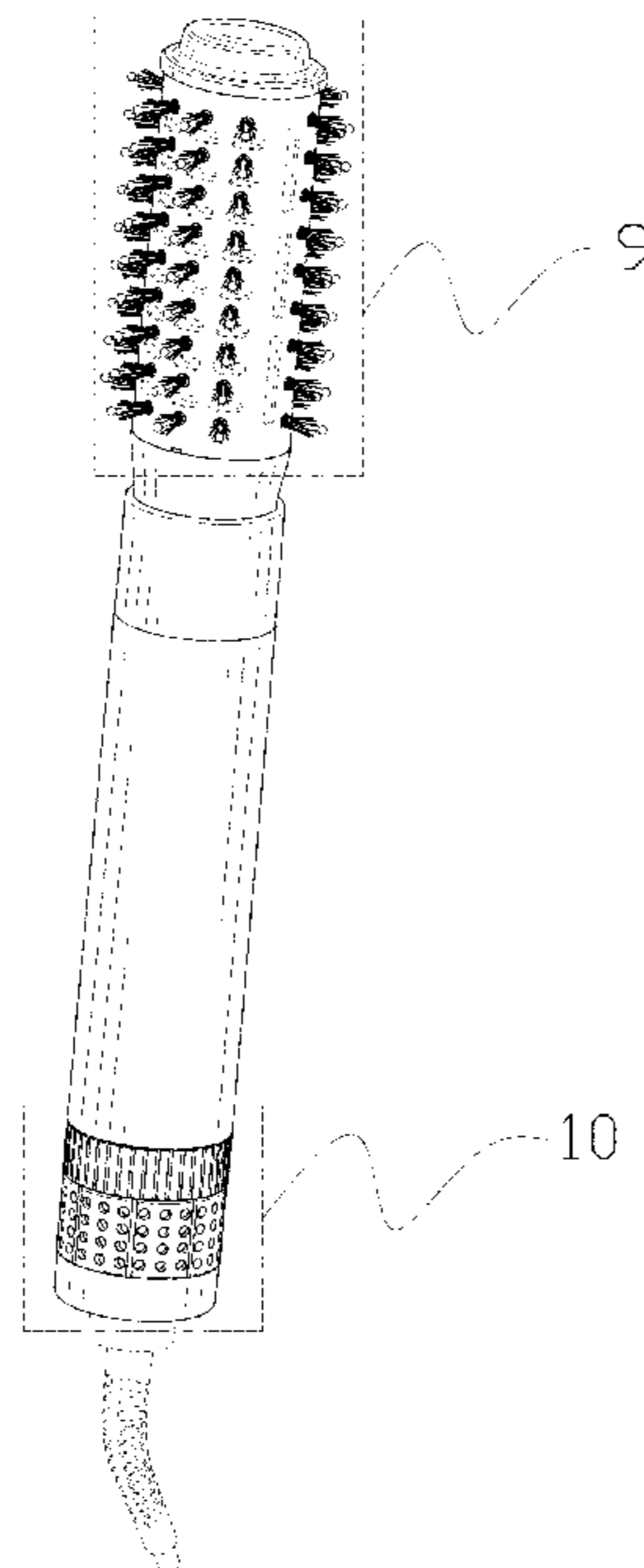
FIG. 1 is a perspective view of a hair dryer comb showing my new design;

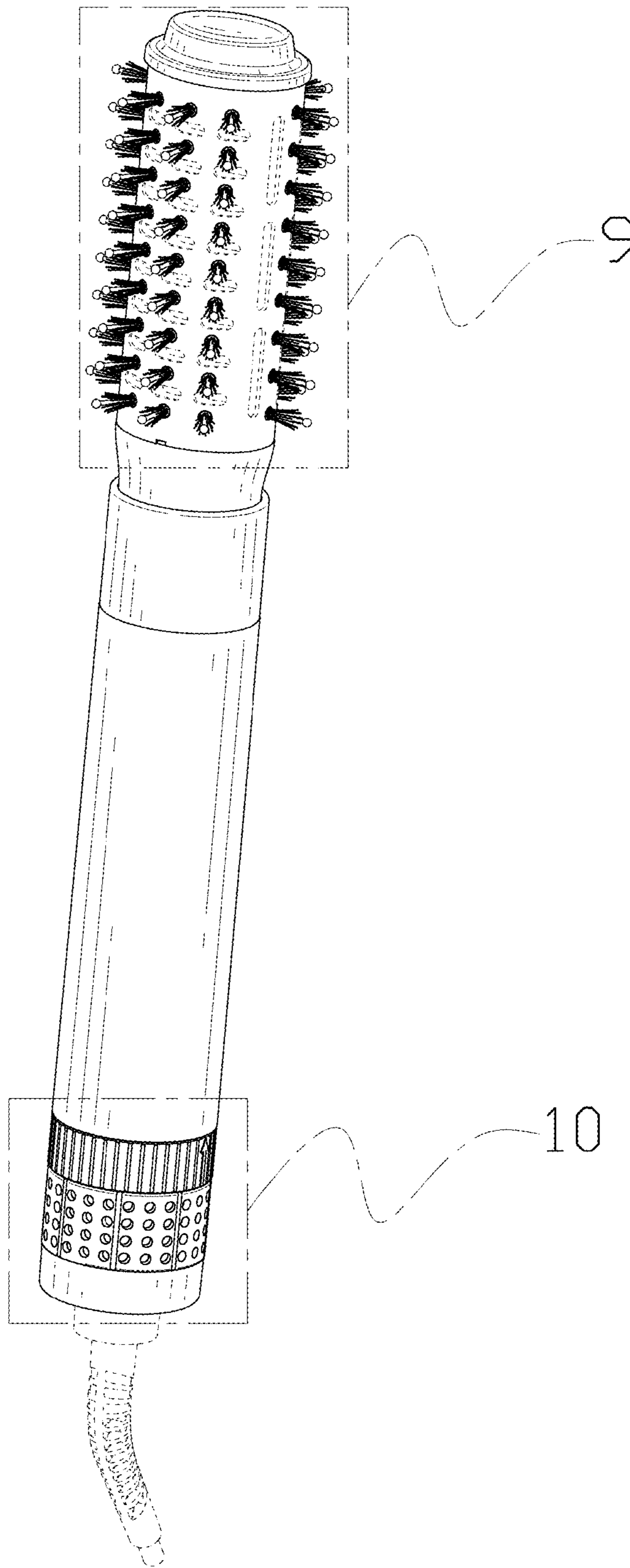

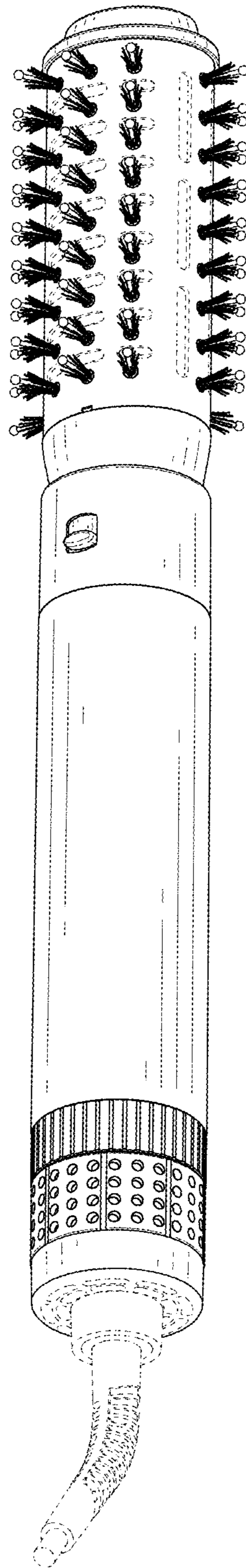

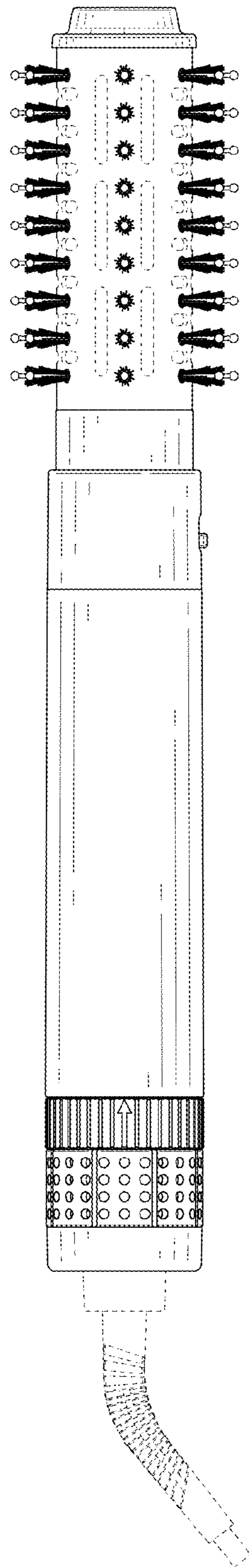

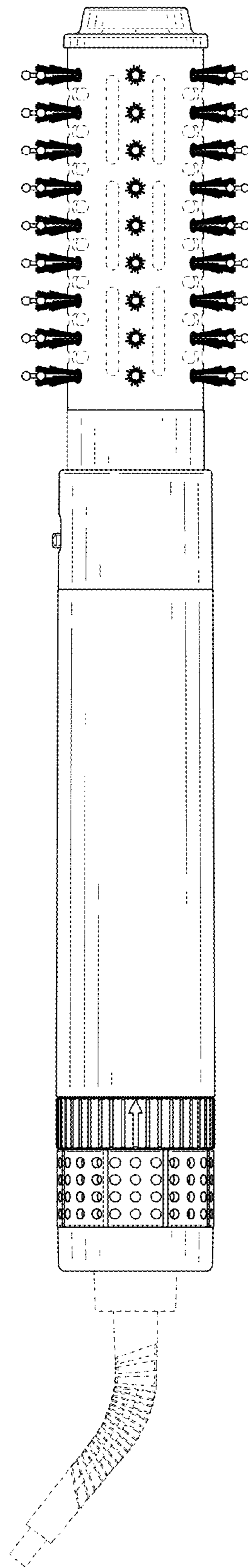

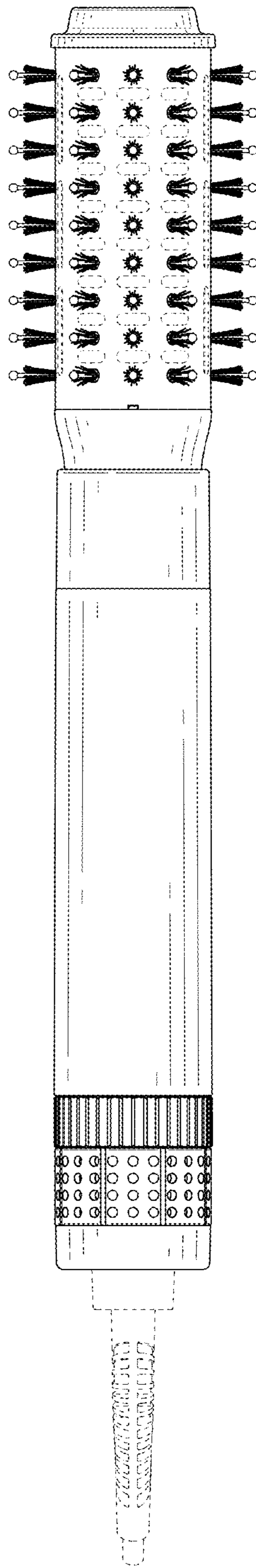

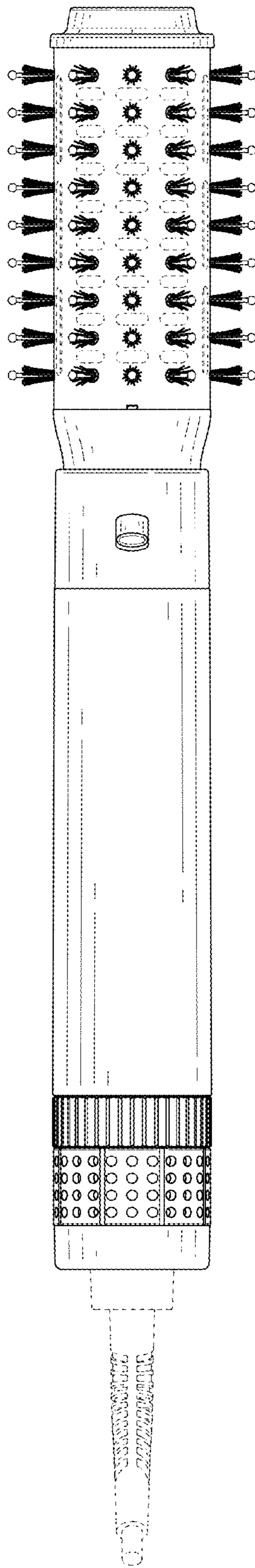

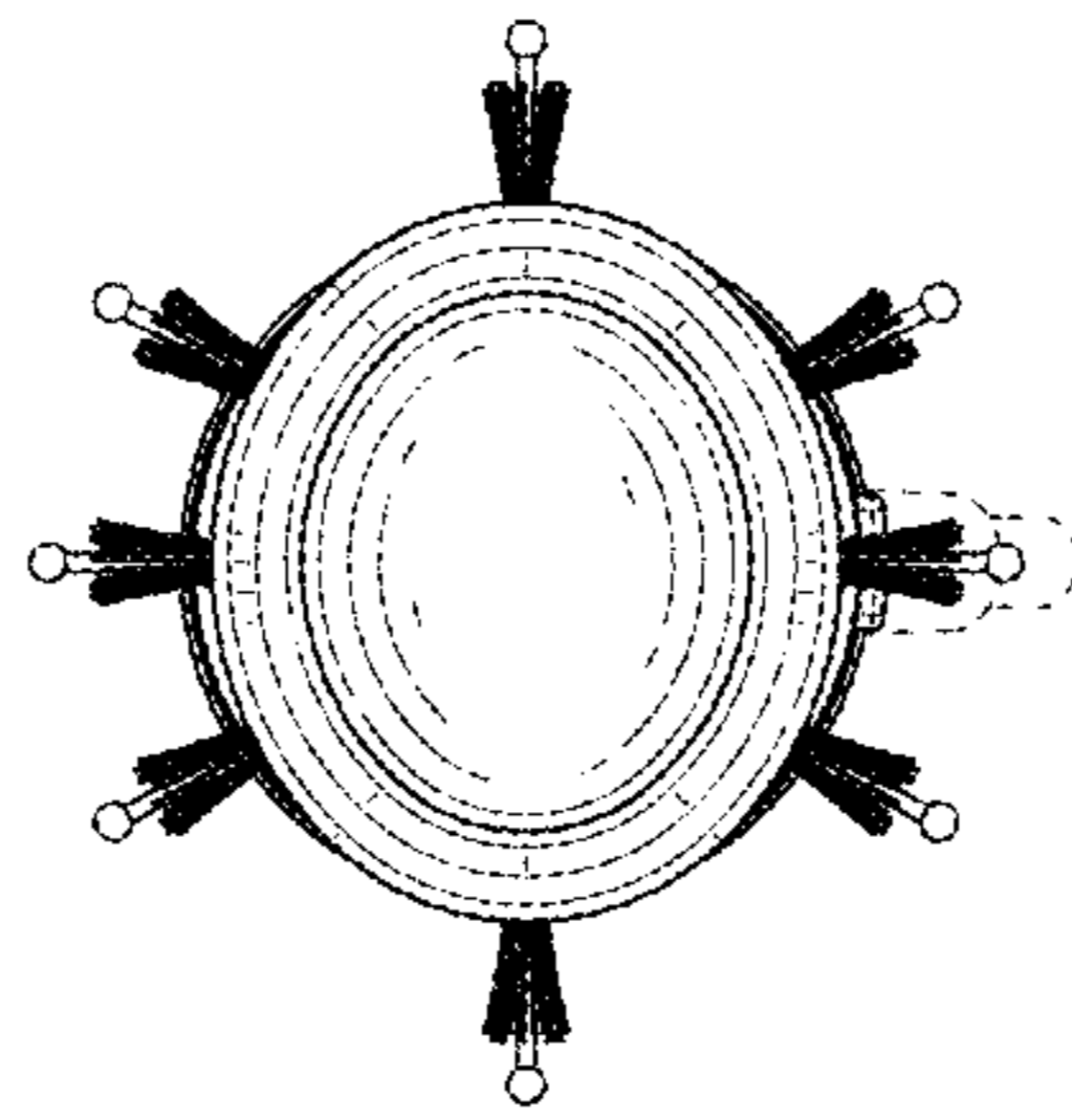

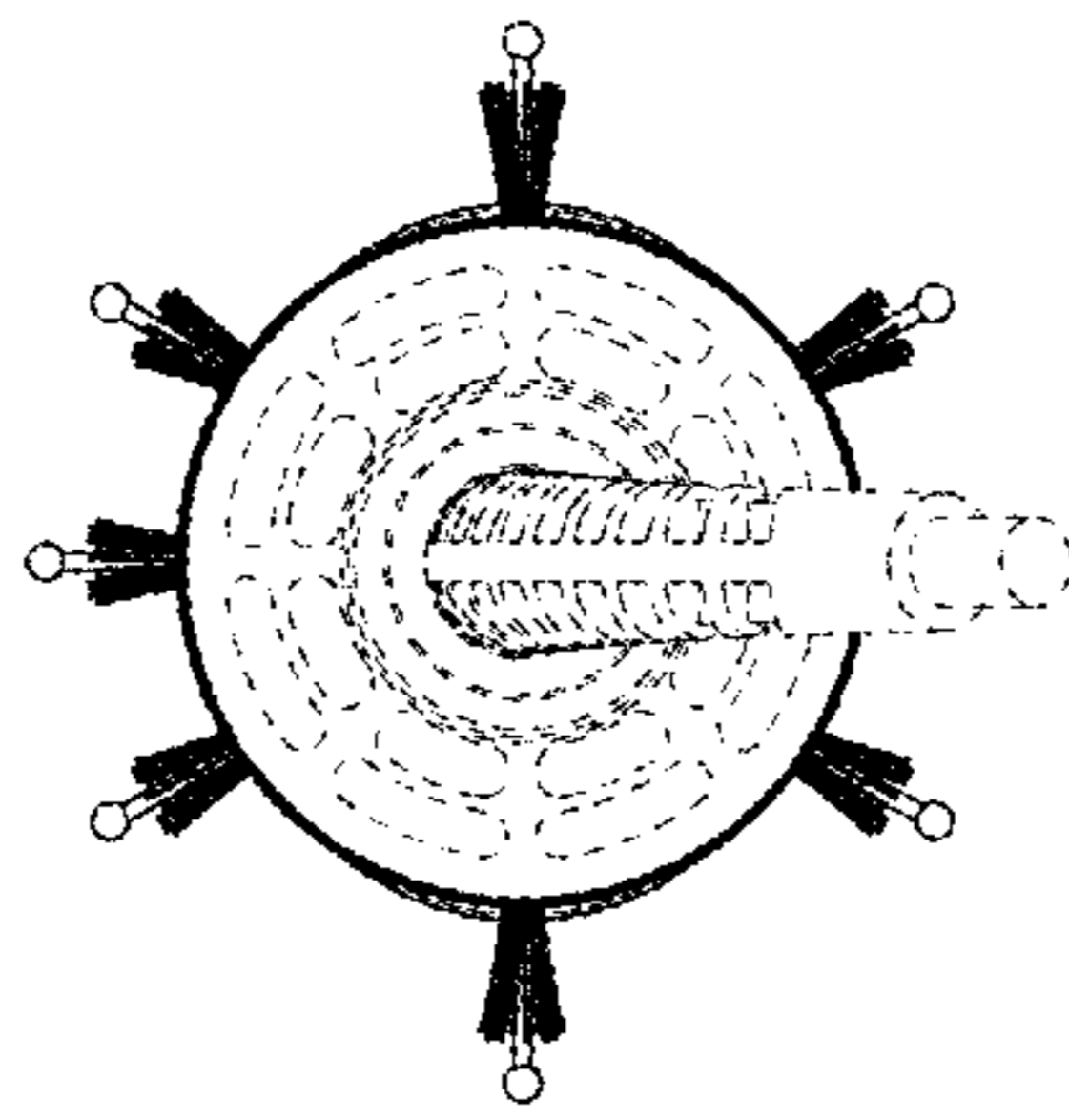

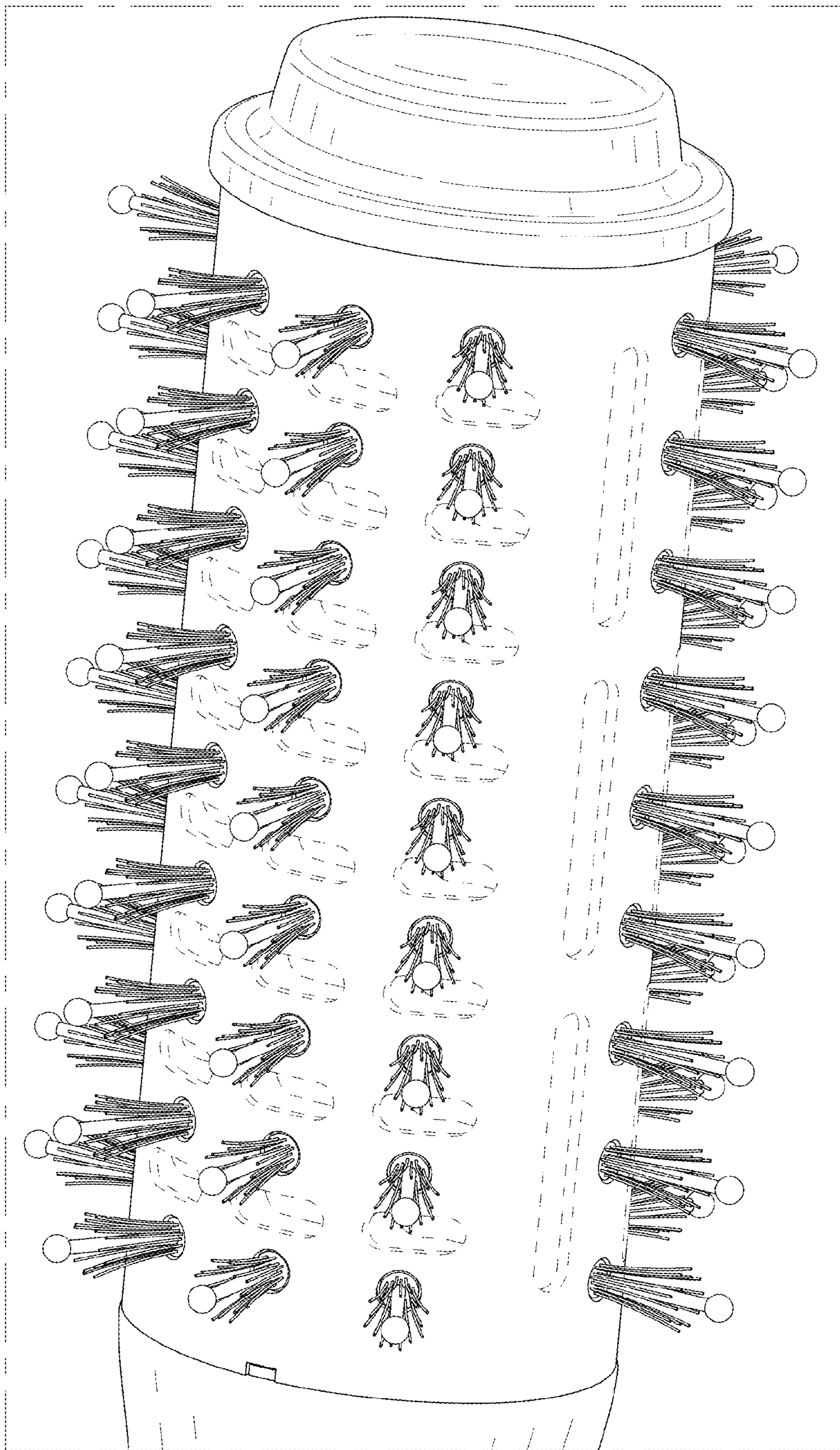

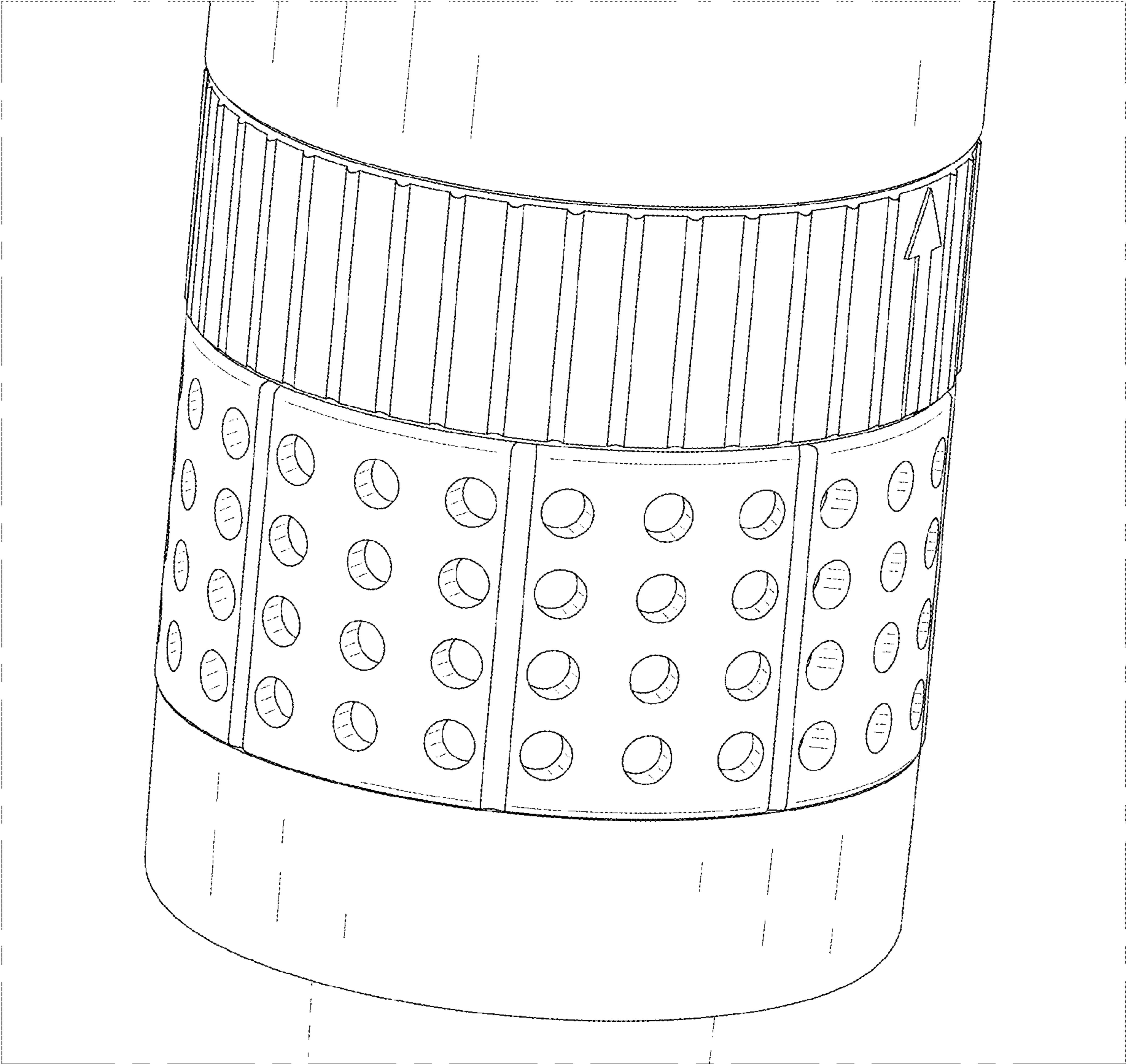

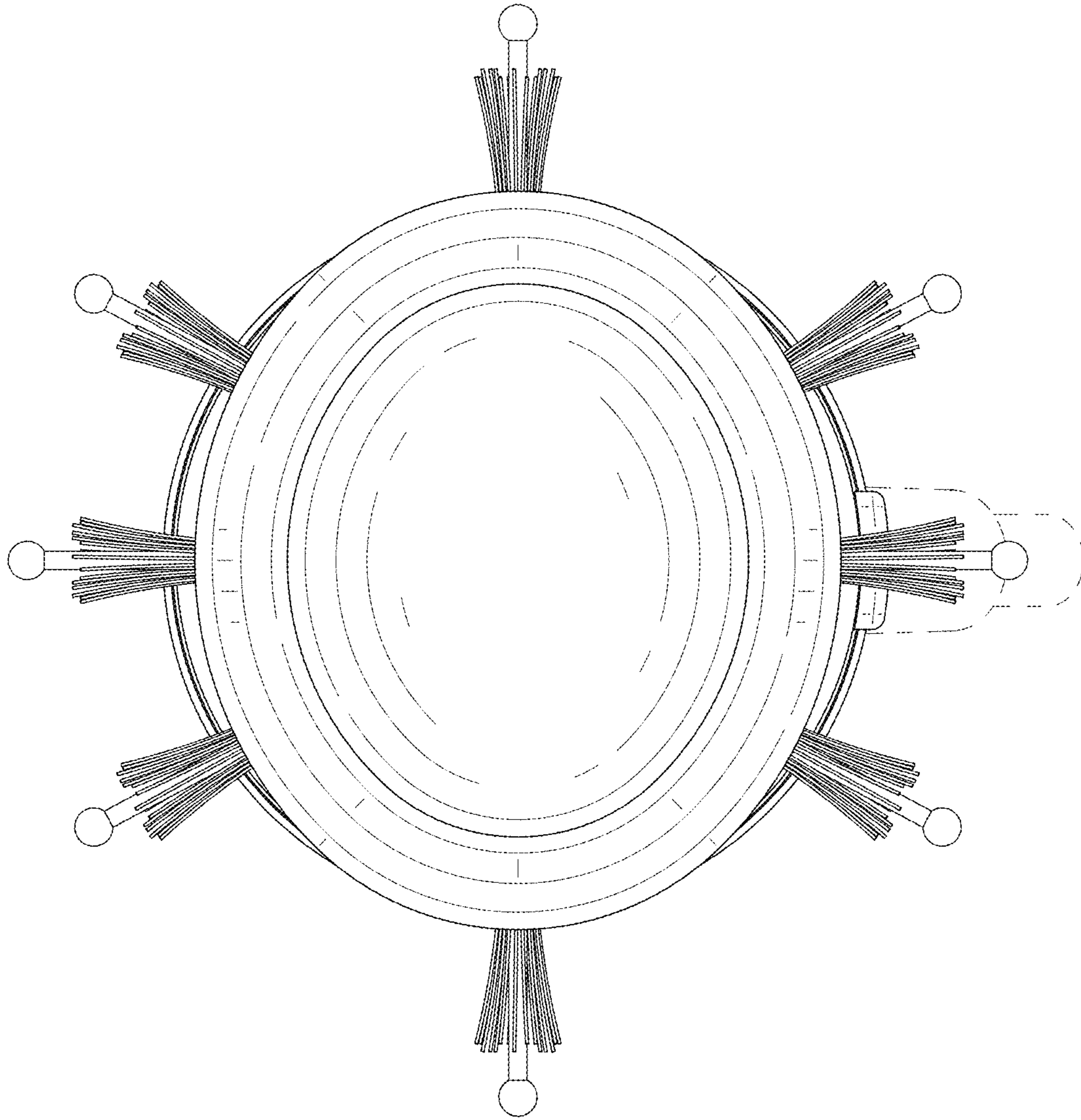

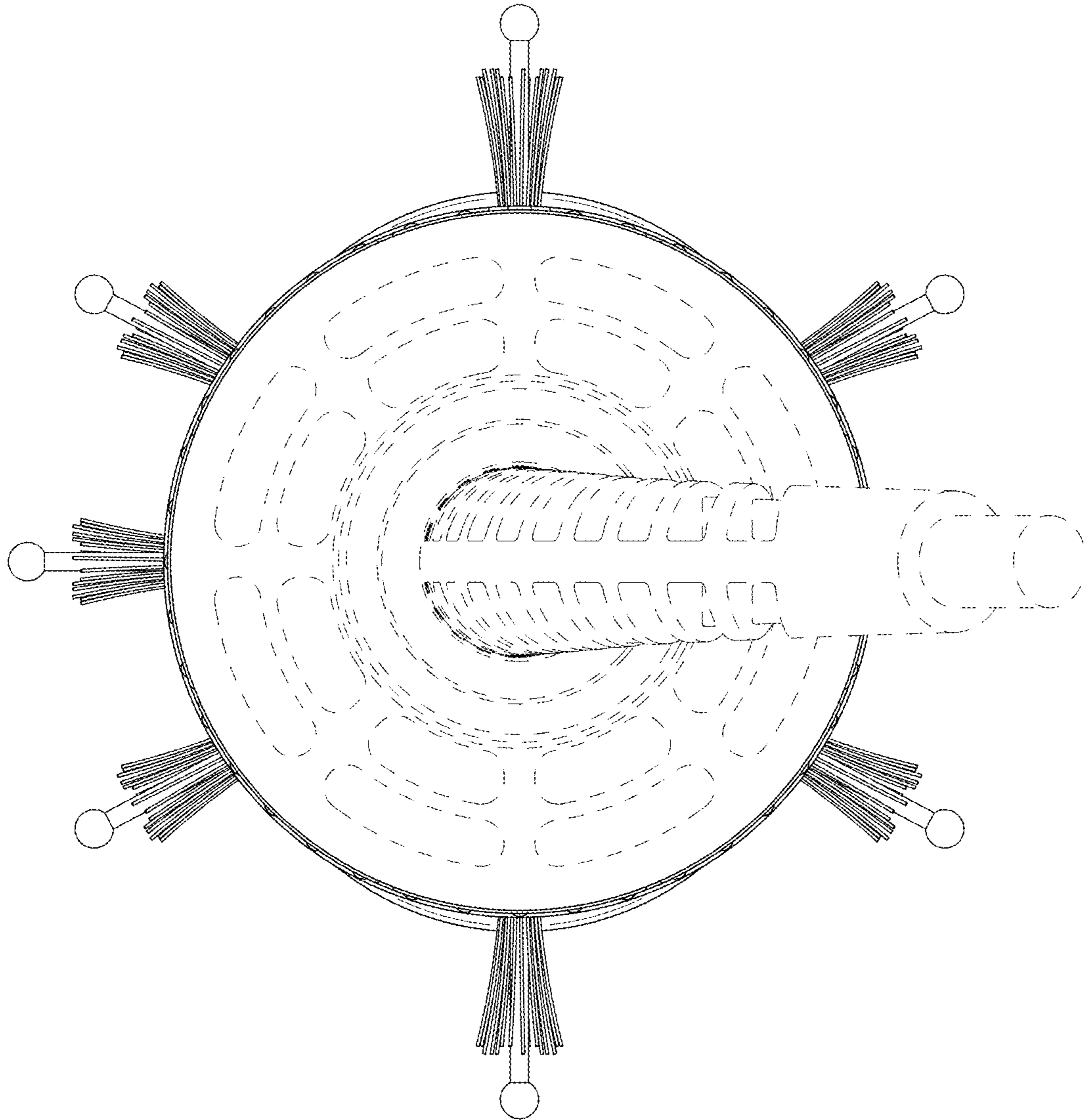
